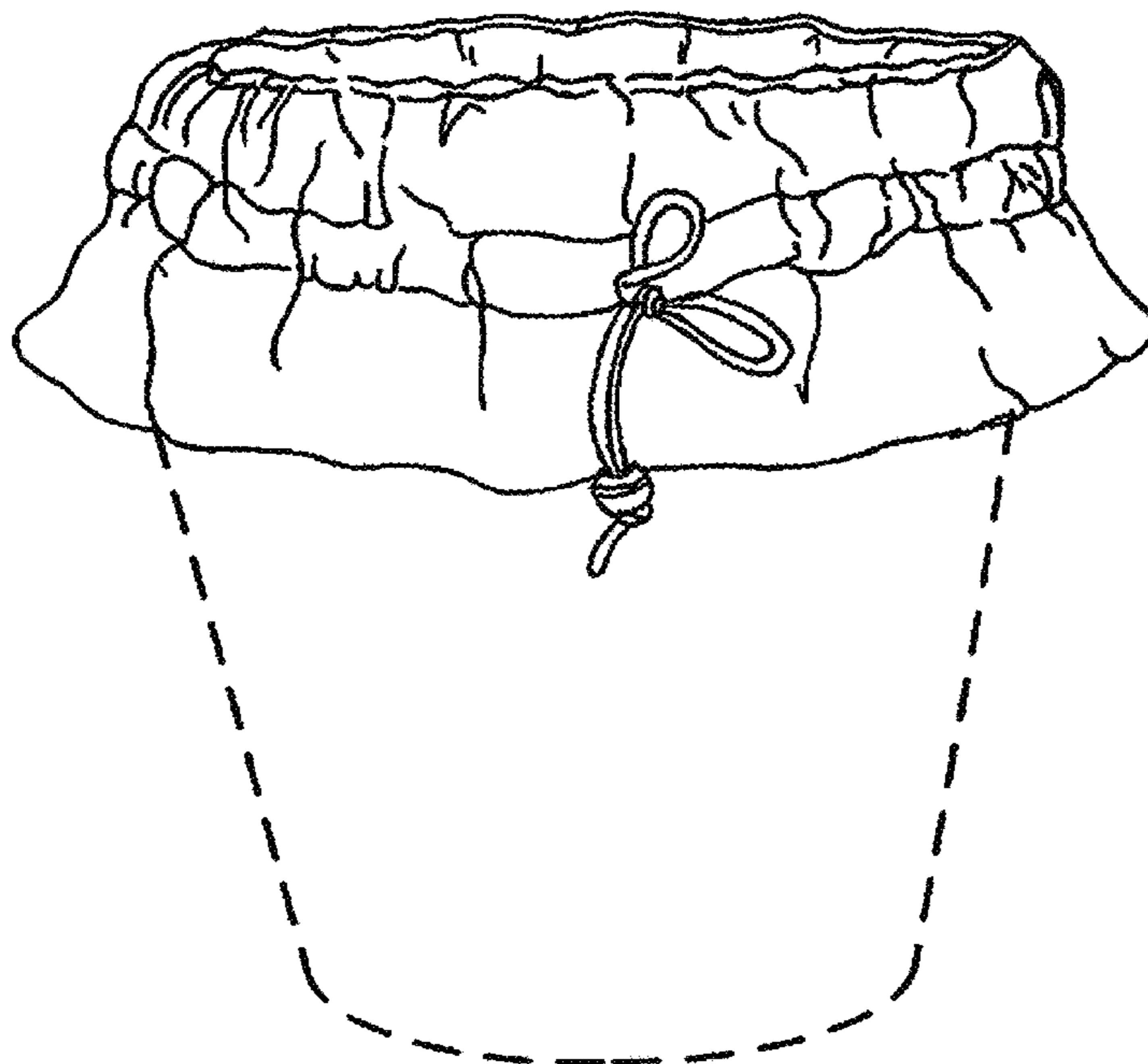
(57) **CLAIM**

The ornamental design for a wastebasket collar, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the wastebasket collar showing my new design;

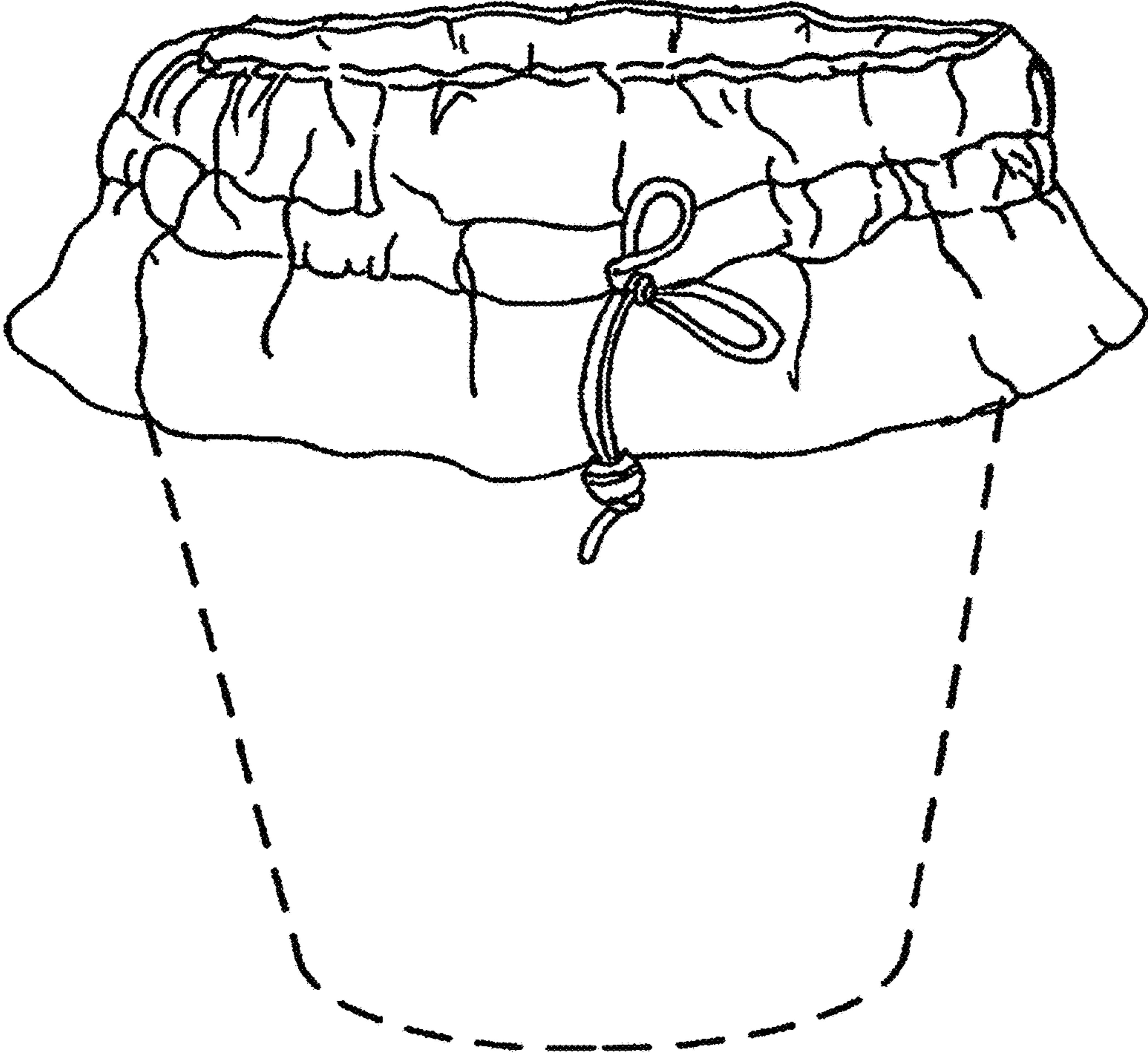

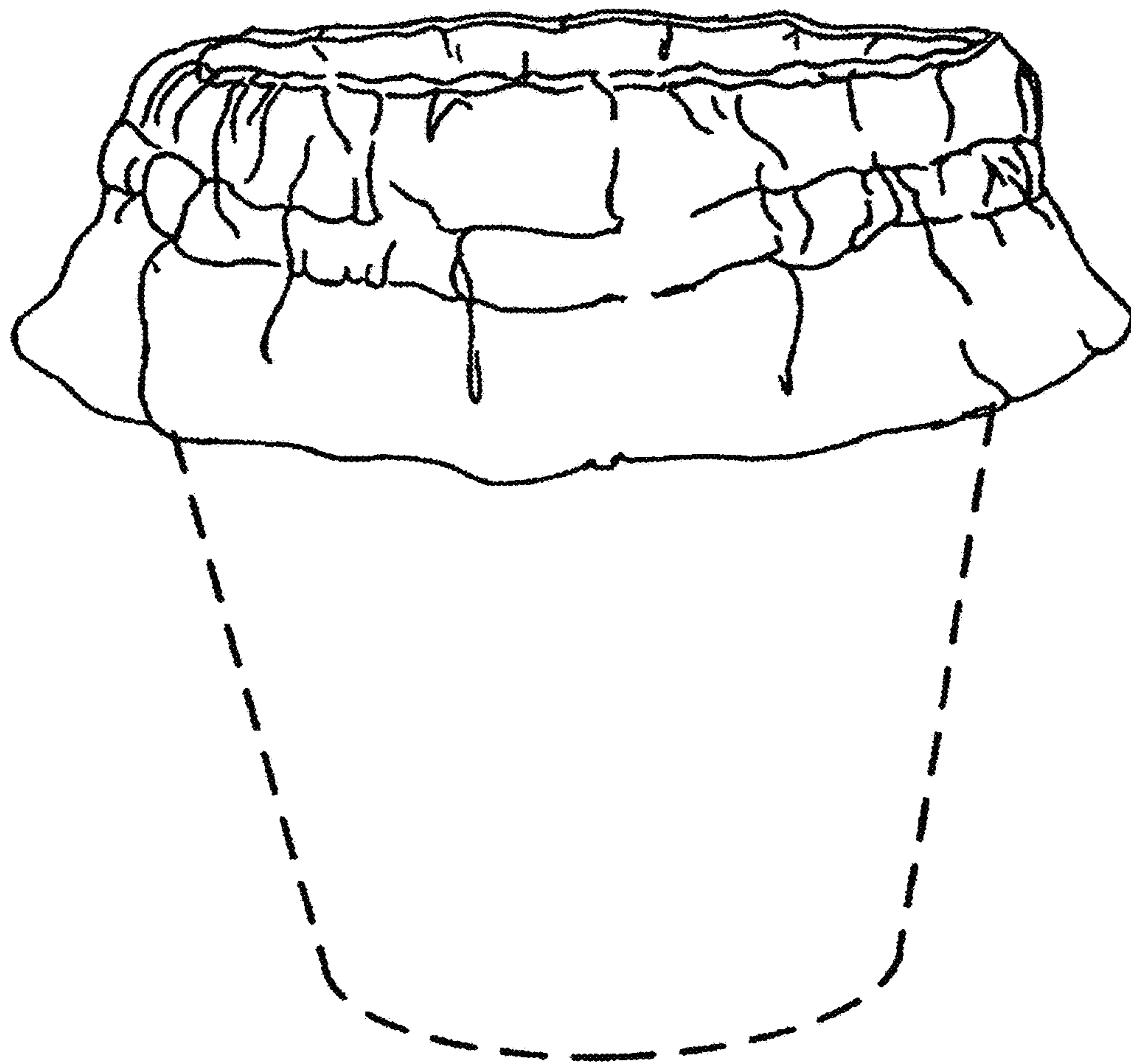

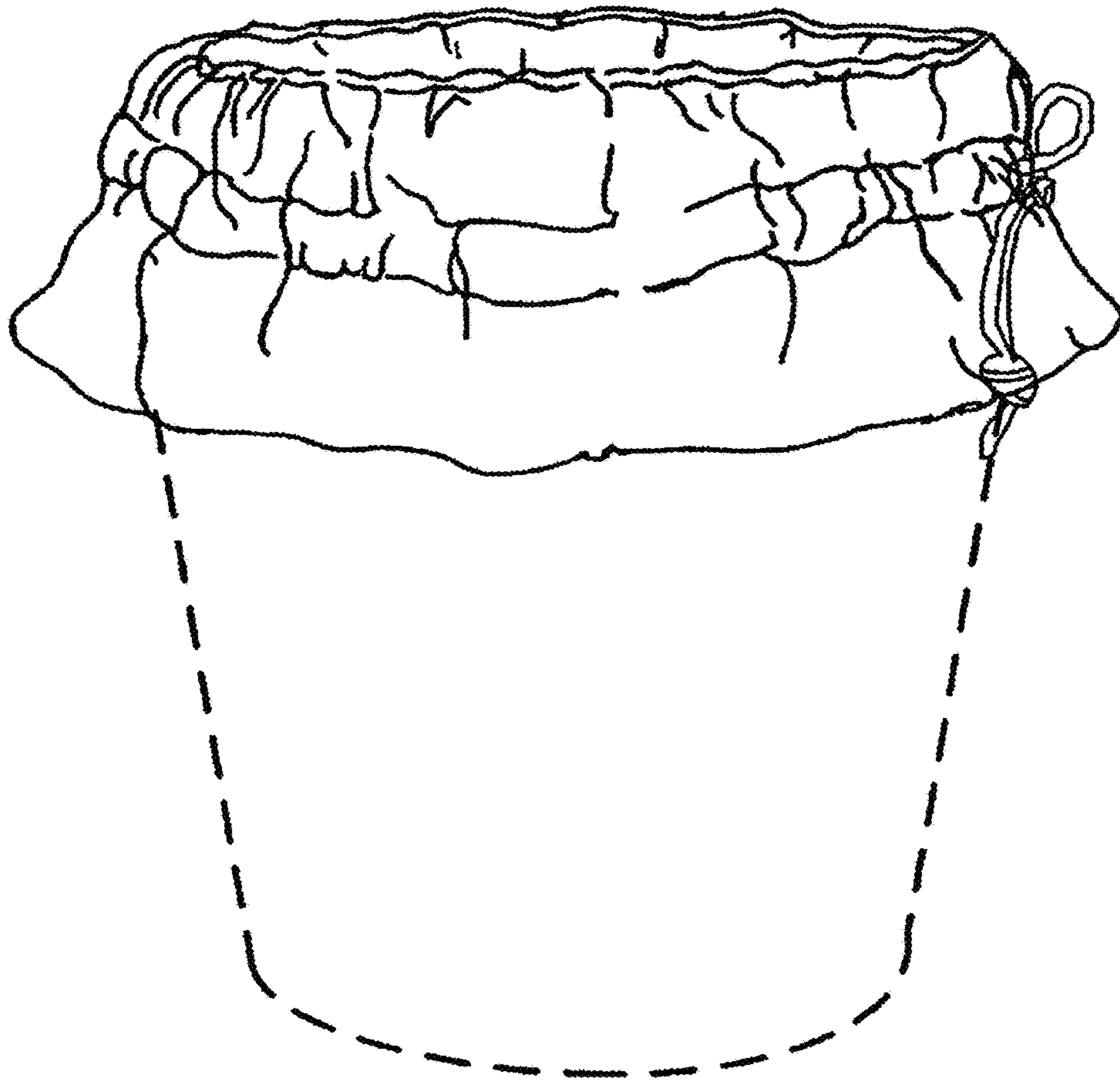
