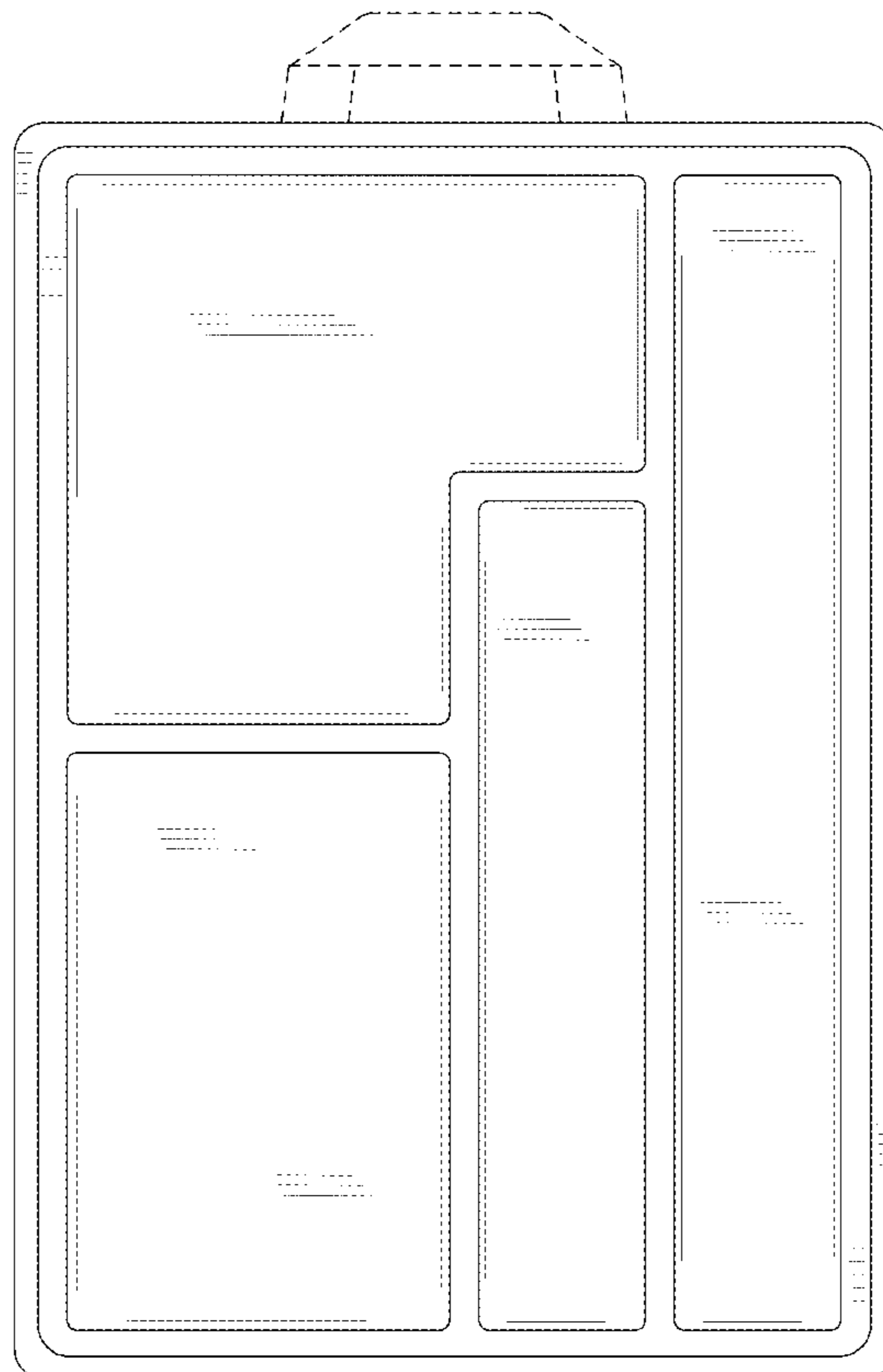

**DESCRIPTION**  
FIG. 1 is a front elevation view of the luggage panel of the present invention showing the Applicant's new design; FIG. 2 is a back elevation view of the luggage panel of FIG. 1; FIG. 3 is a right side view of the luggage panel of FIG. 1; FIG. 4 is a left side view of the luggage panel of FIG. 1; FIG. 5 is a top plan view of the luggage panel of FIG. 1; and, FIG. 6 is a bottom plan view of the luggage panel of FIG. 1.

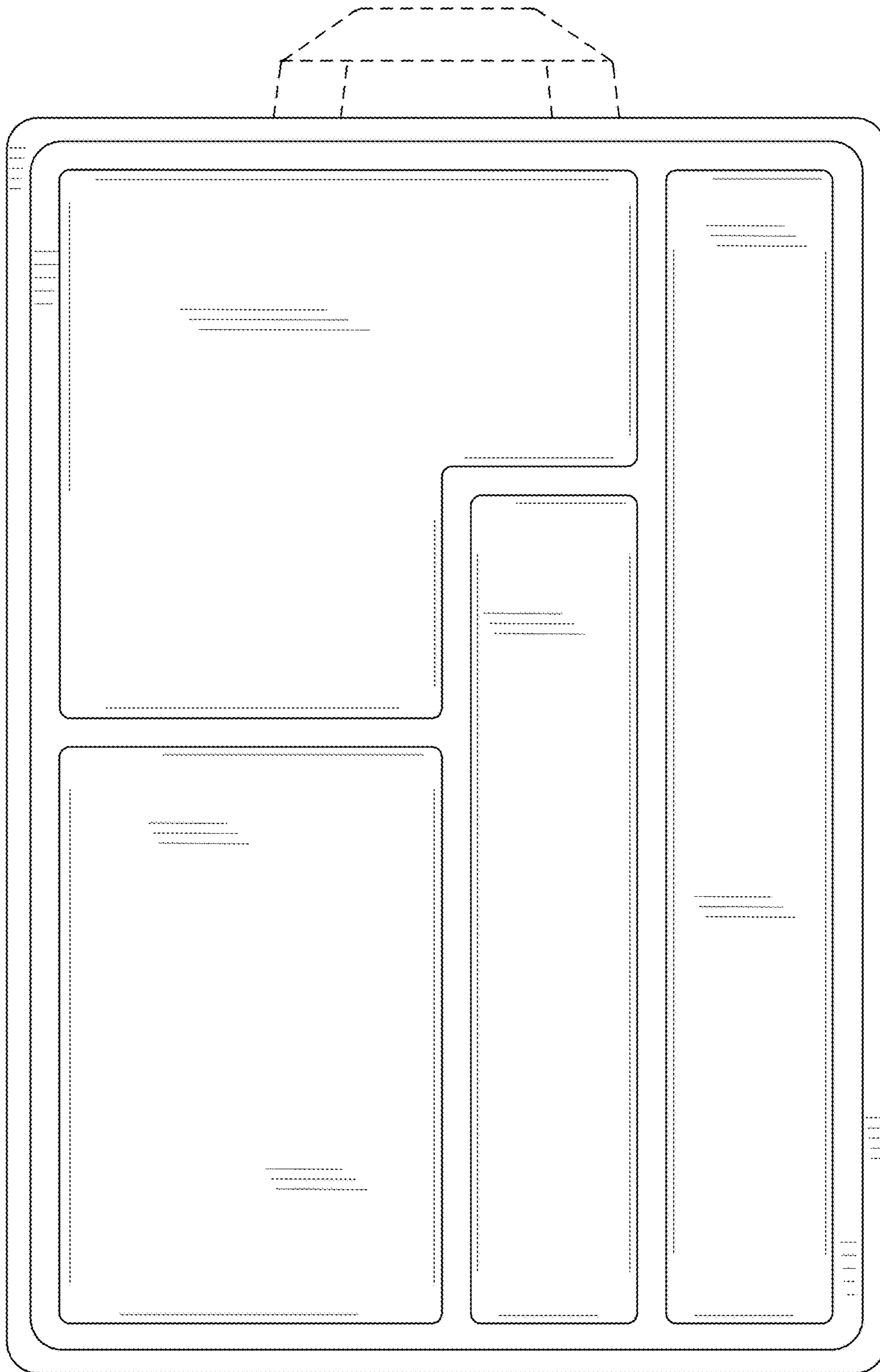
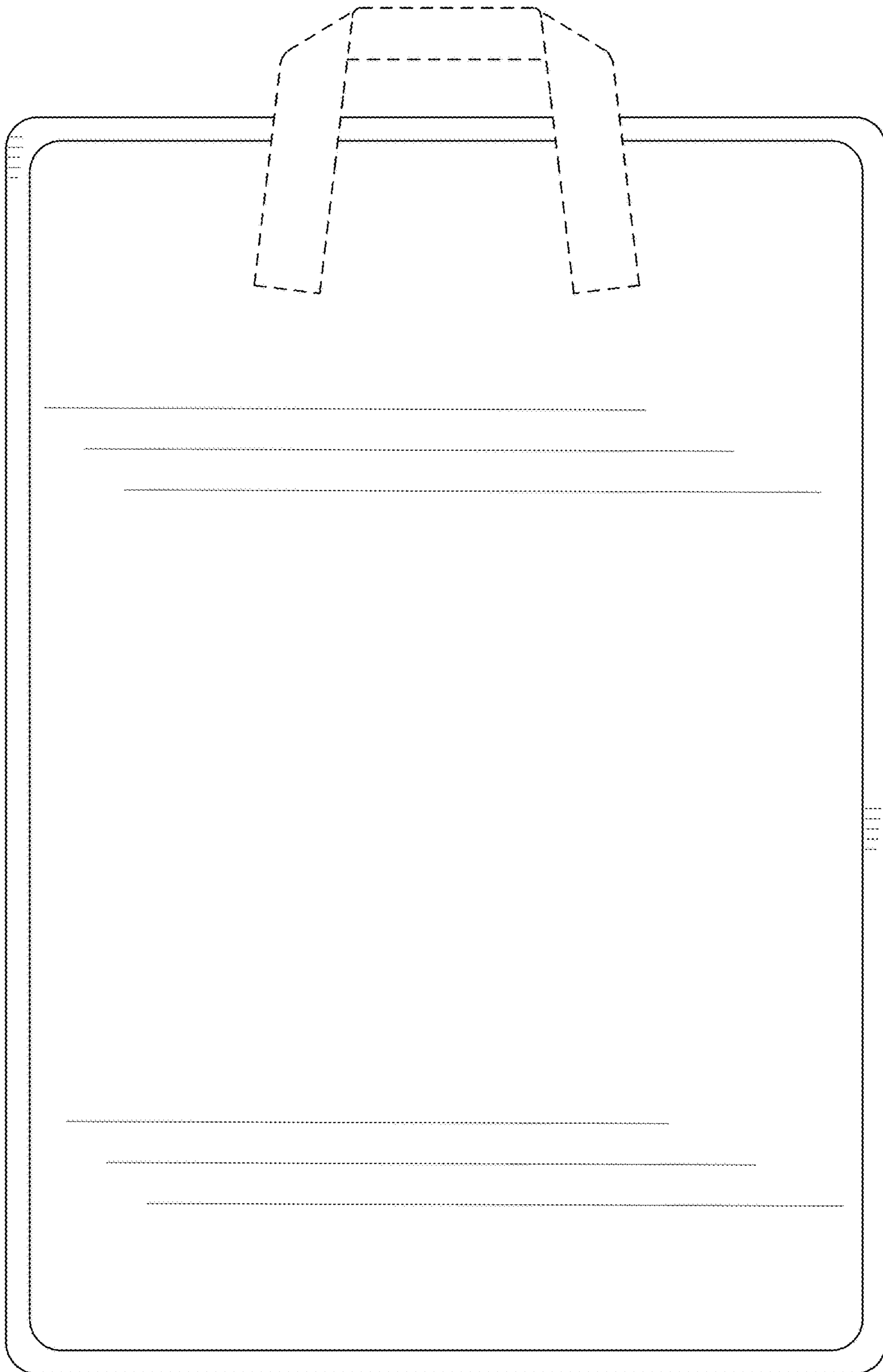

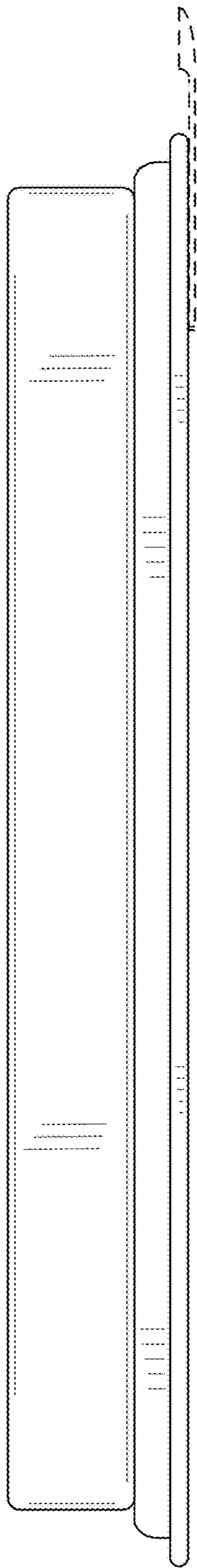

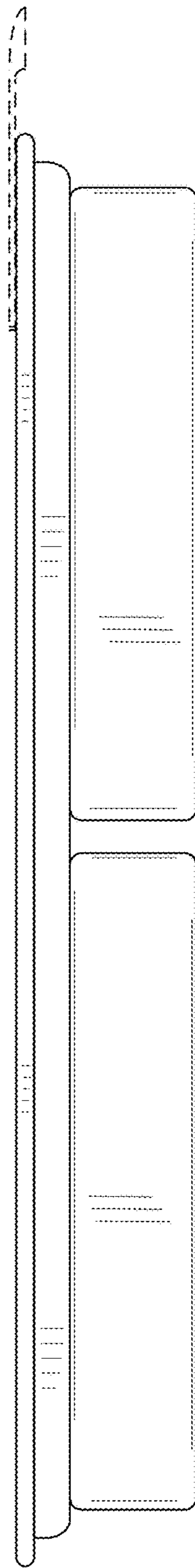
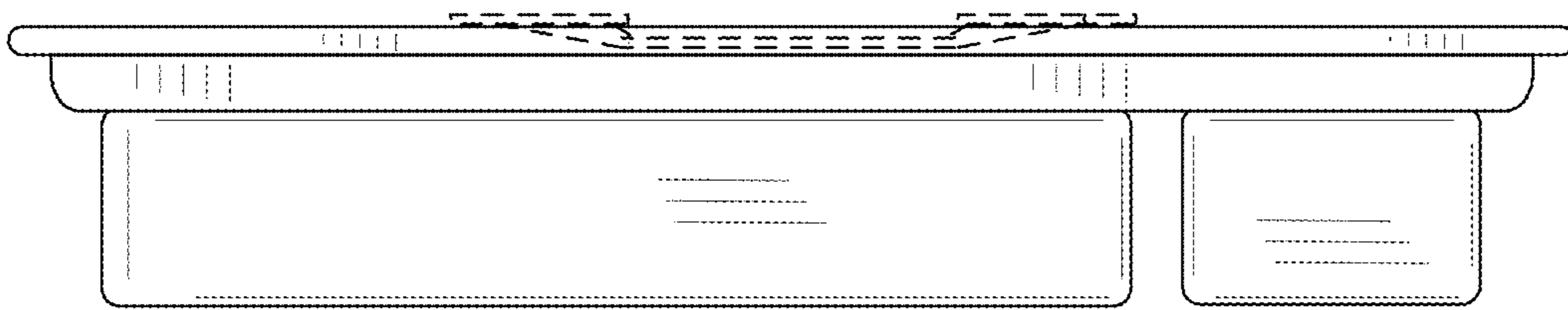
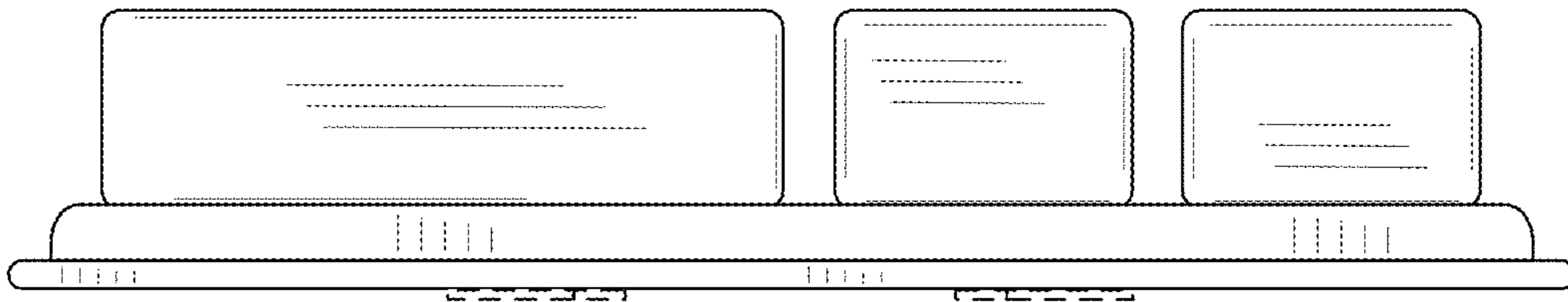
