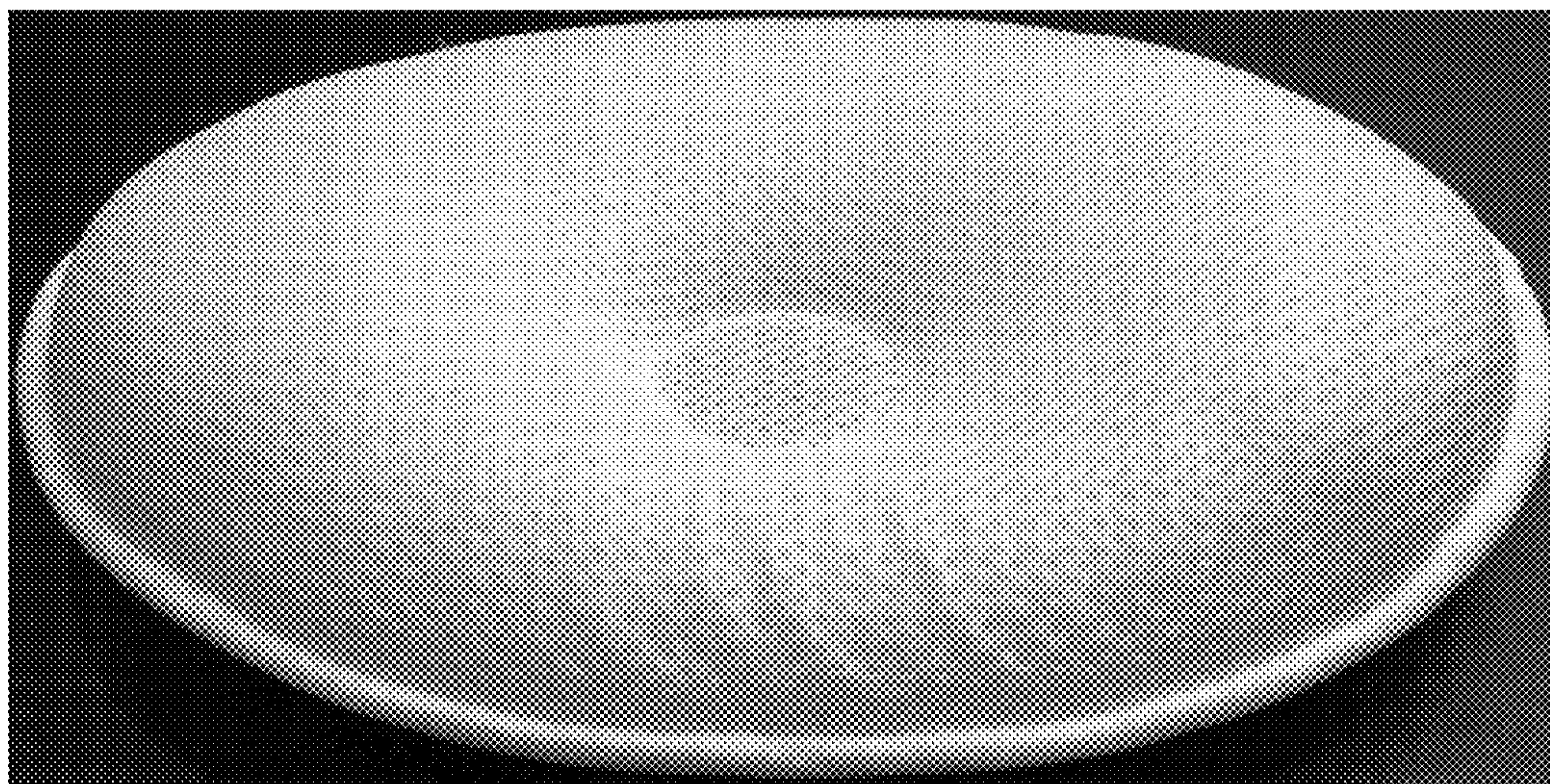

as shown and described.

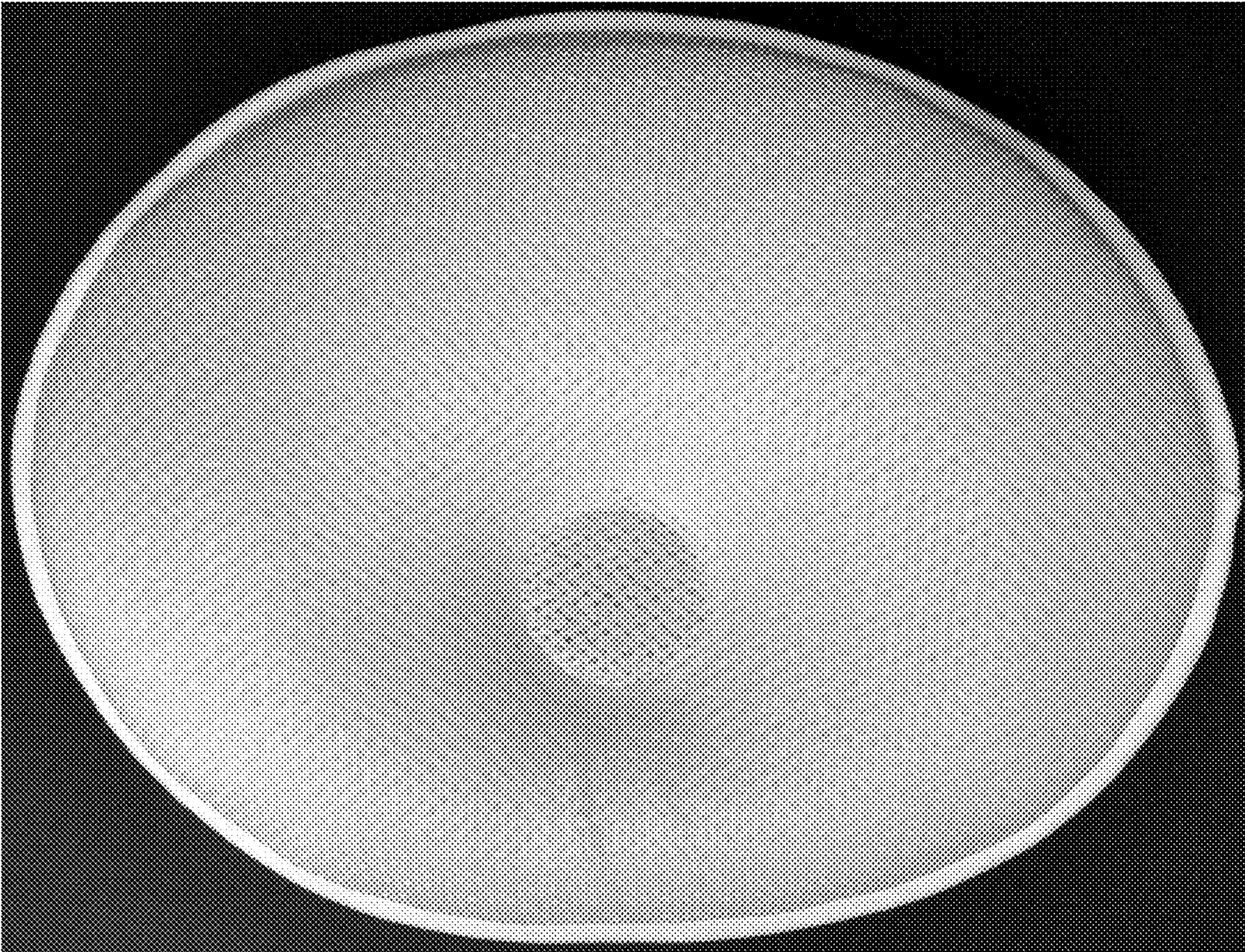
DESCRIPTION

- 1.4 is a left side perspective view.

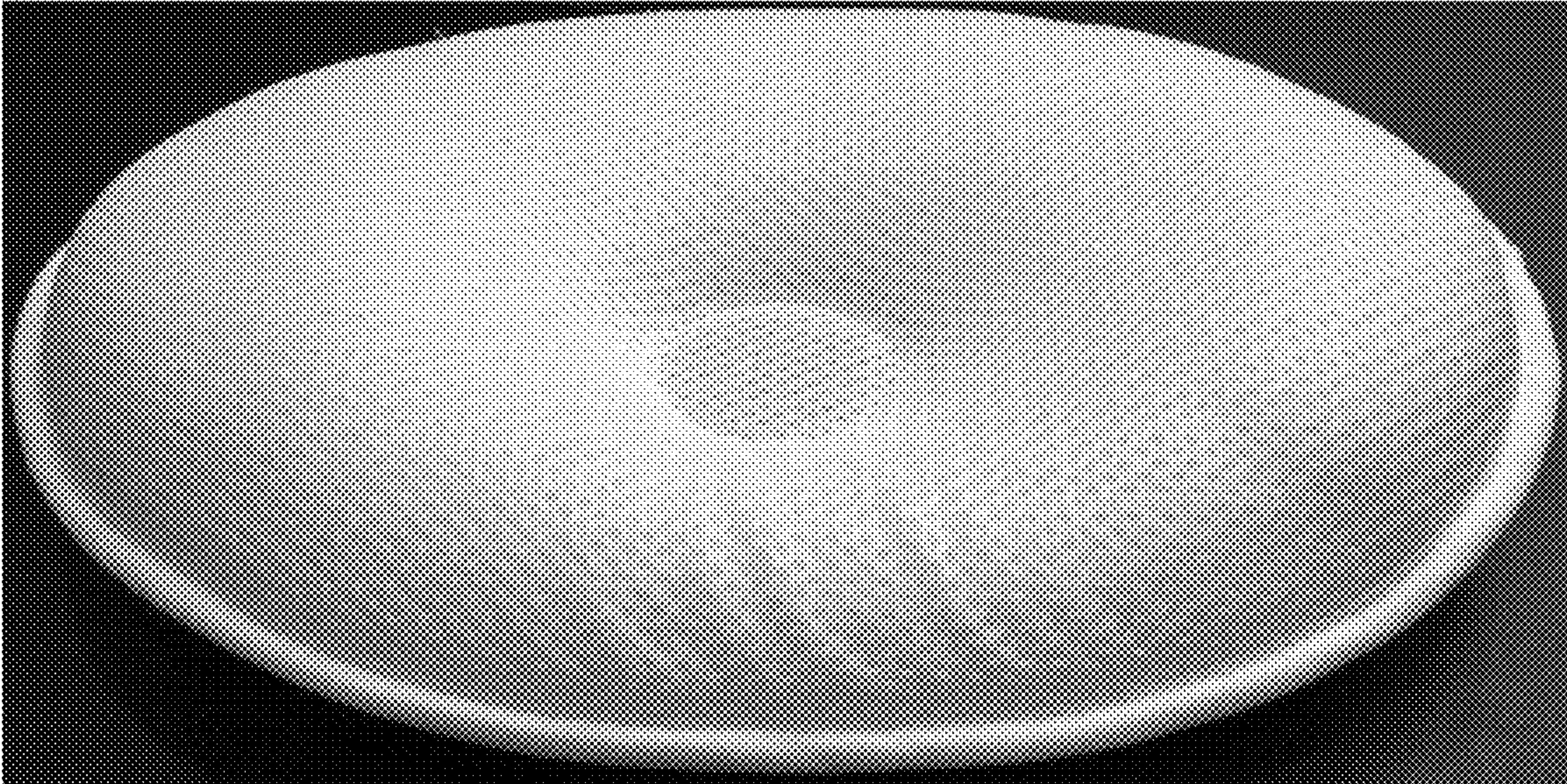

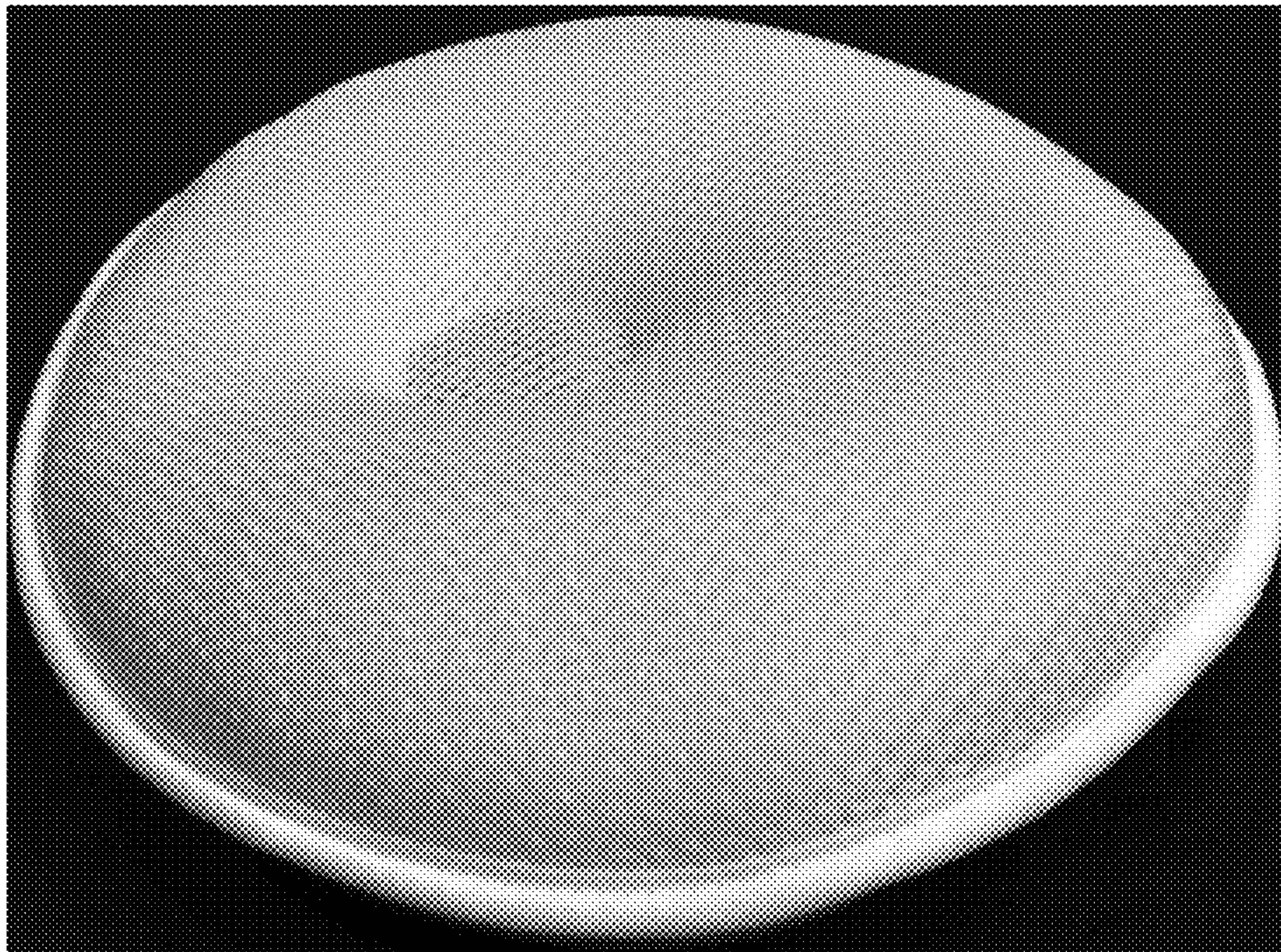
