in FIG. 1.

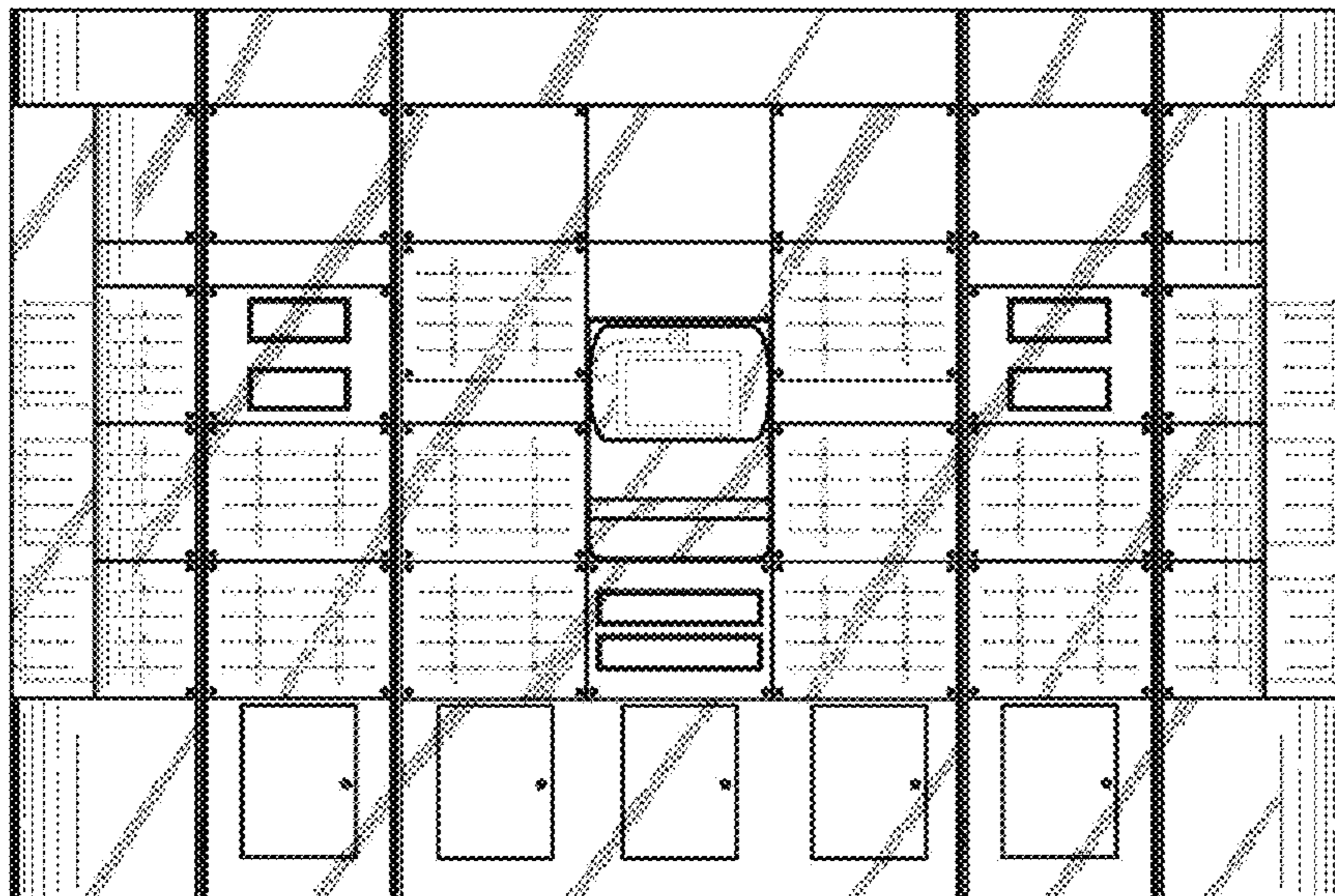

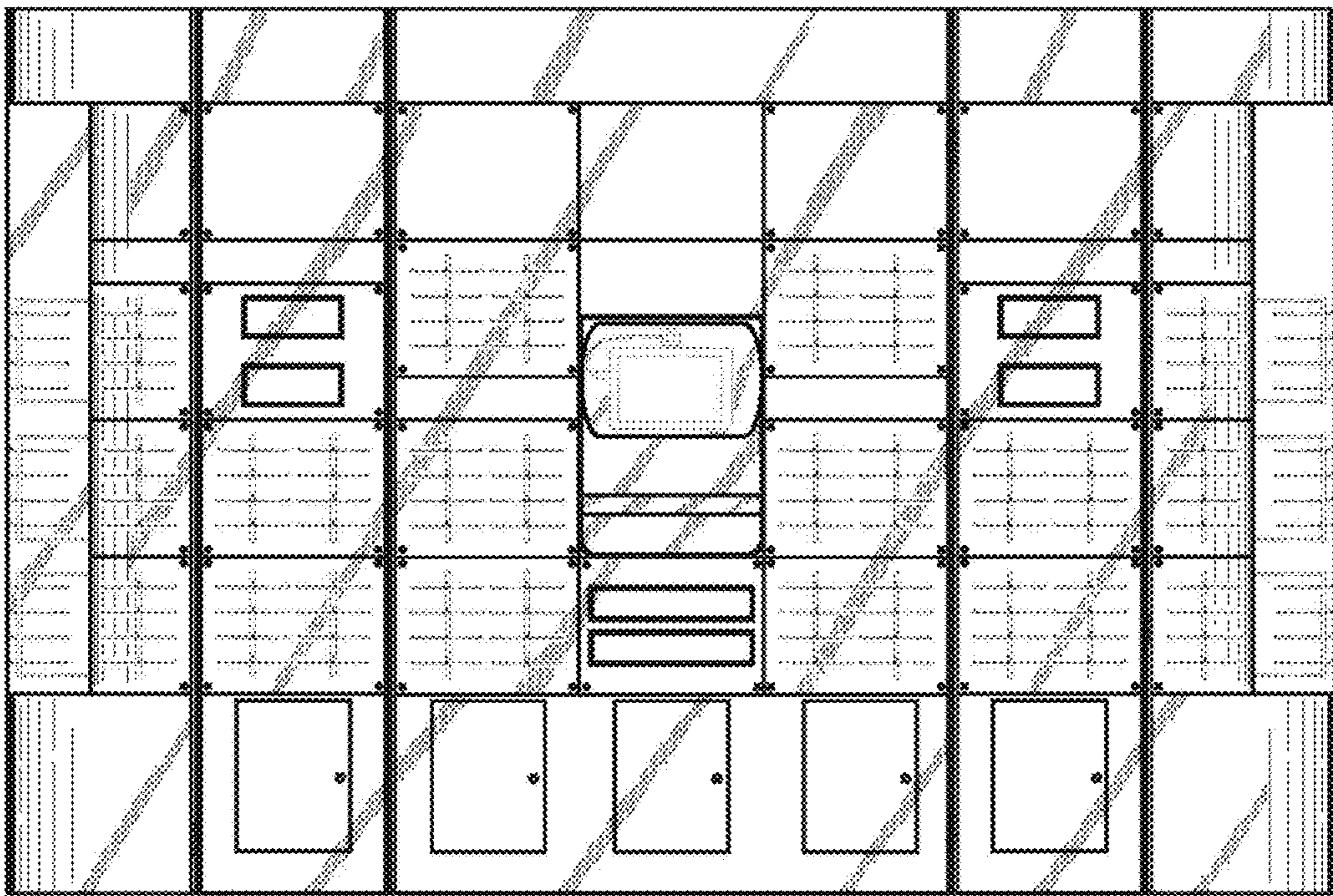

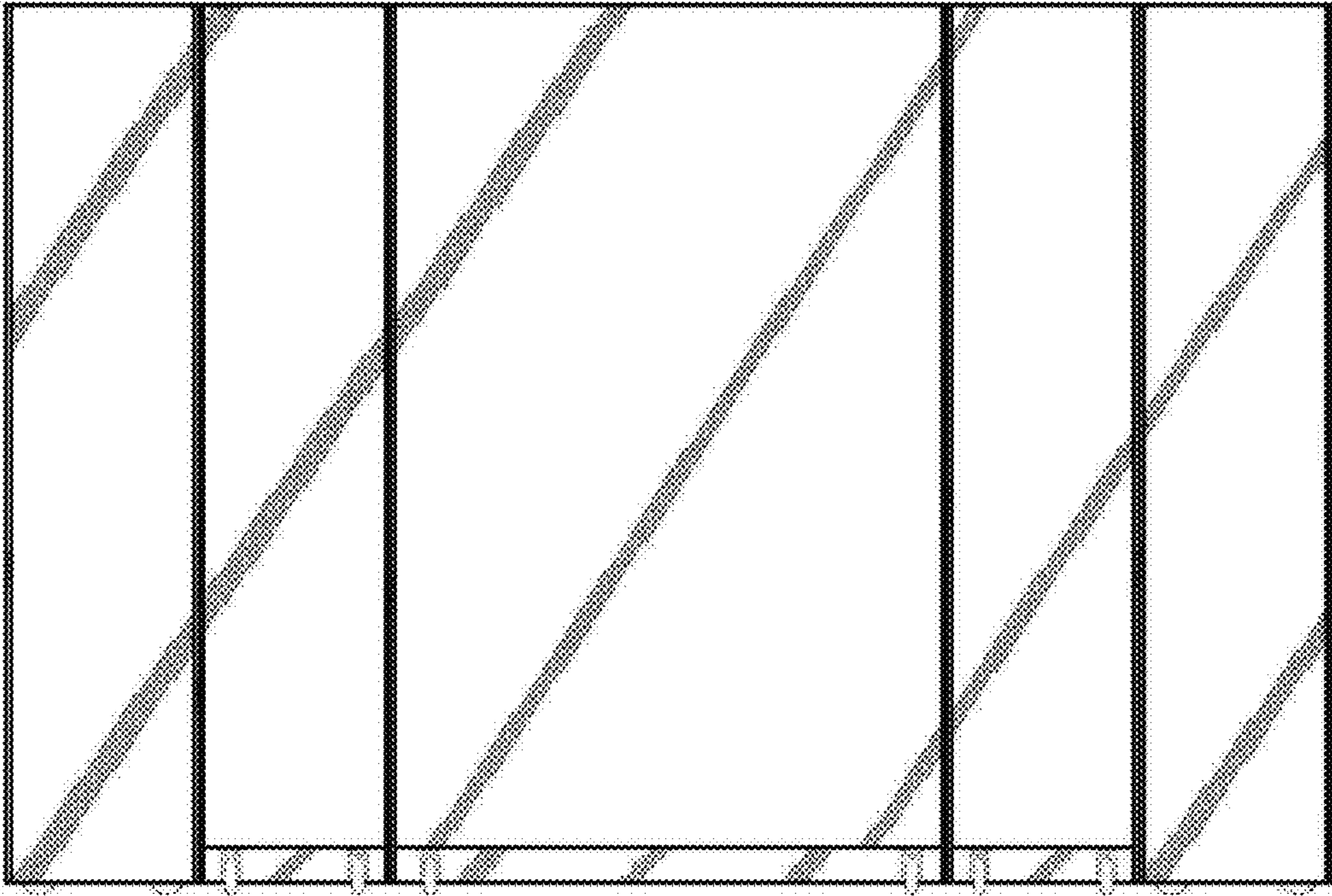

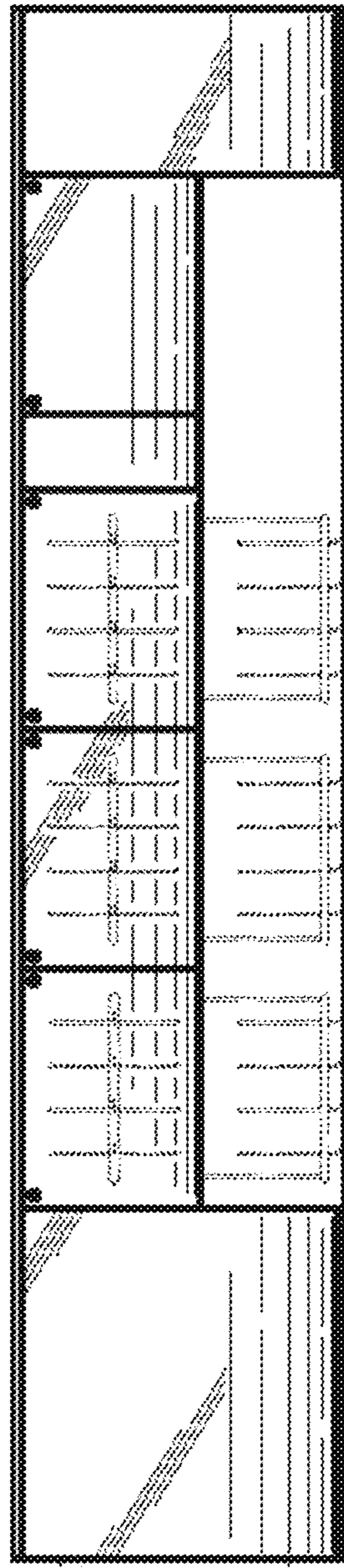

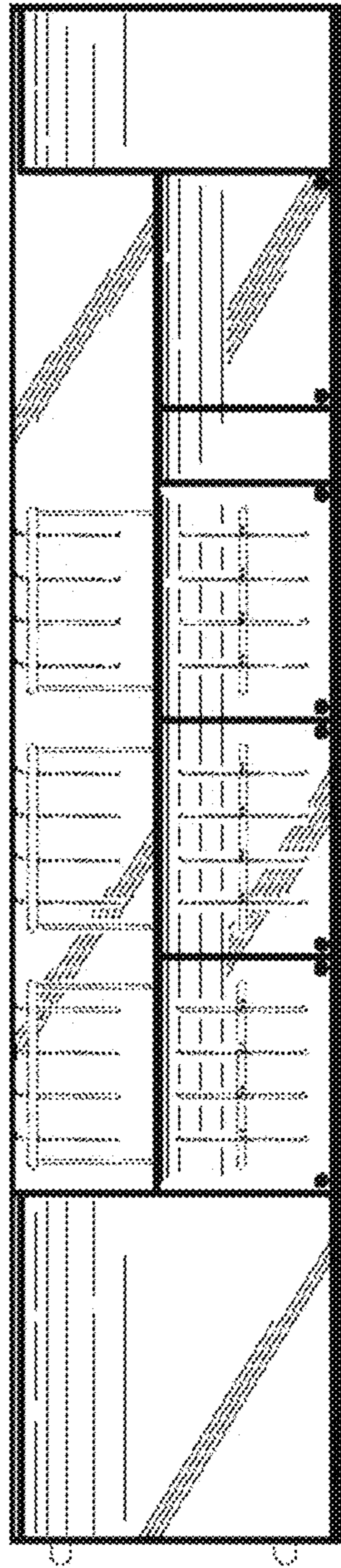

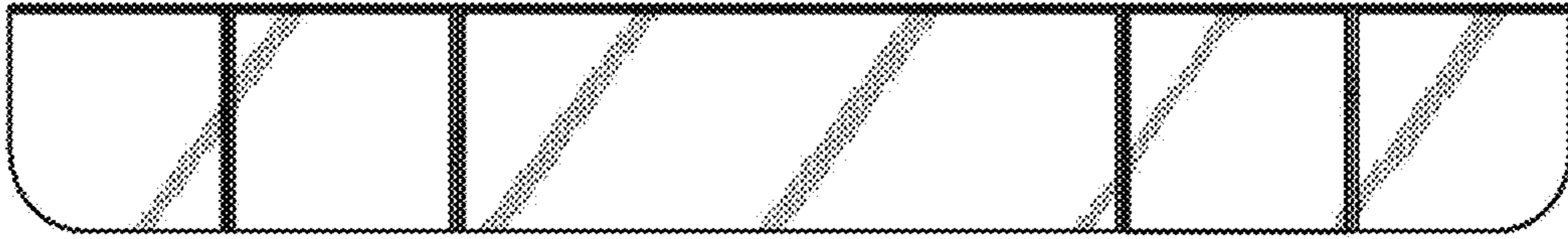

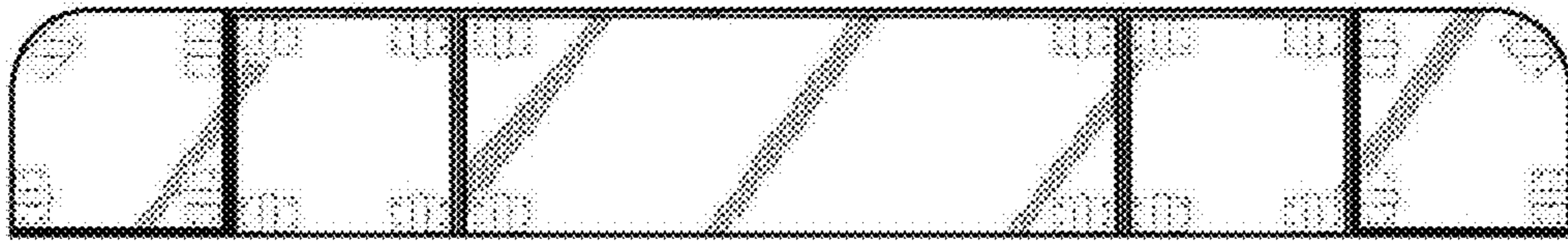
