DESCRIPTION

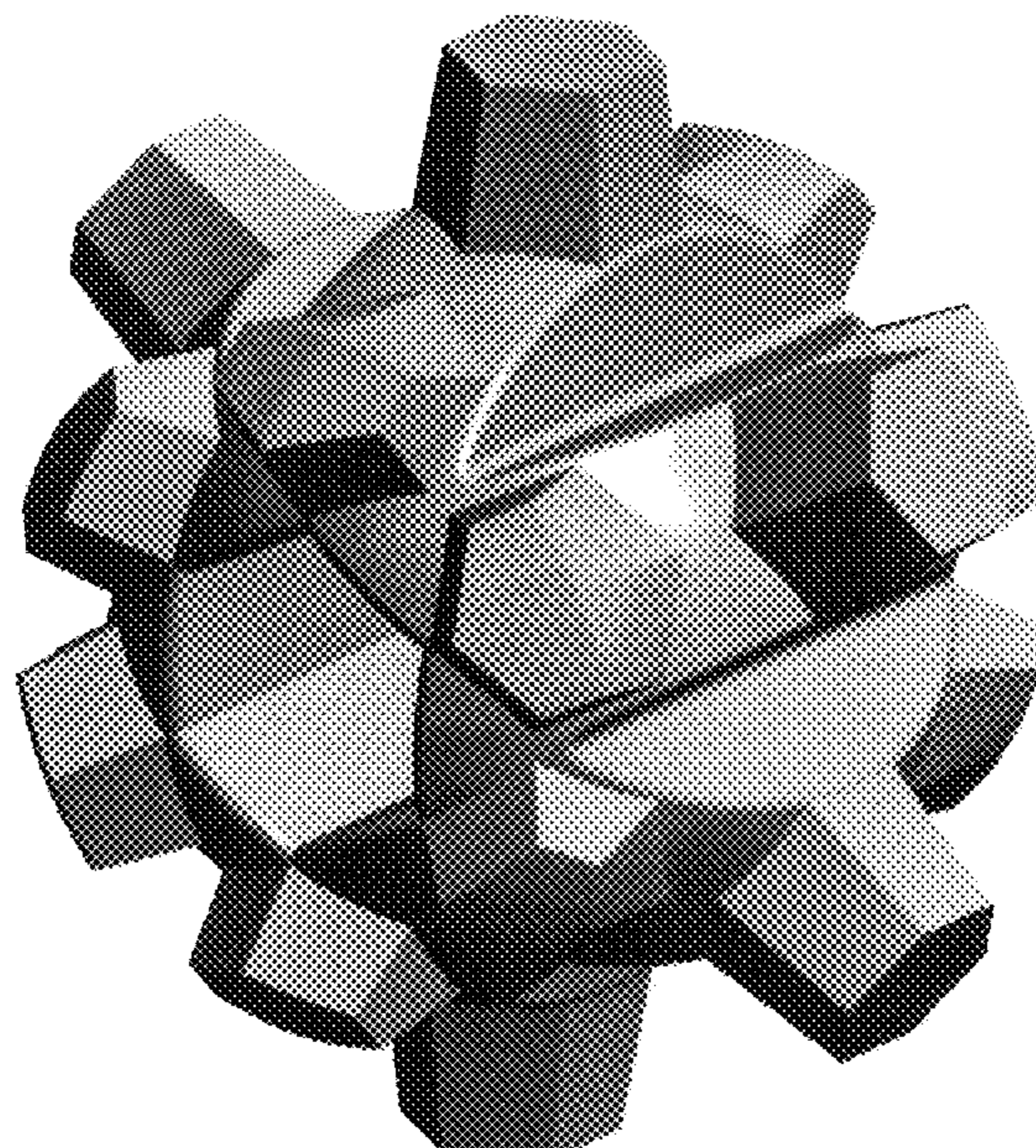

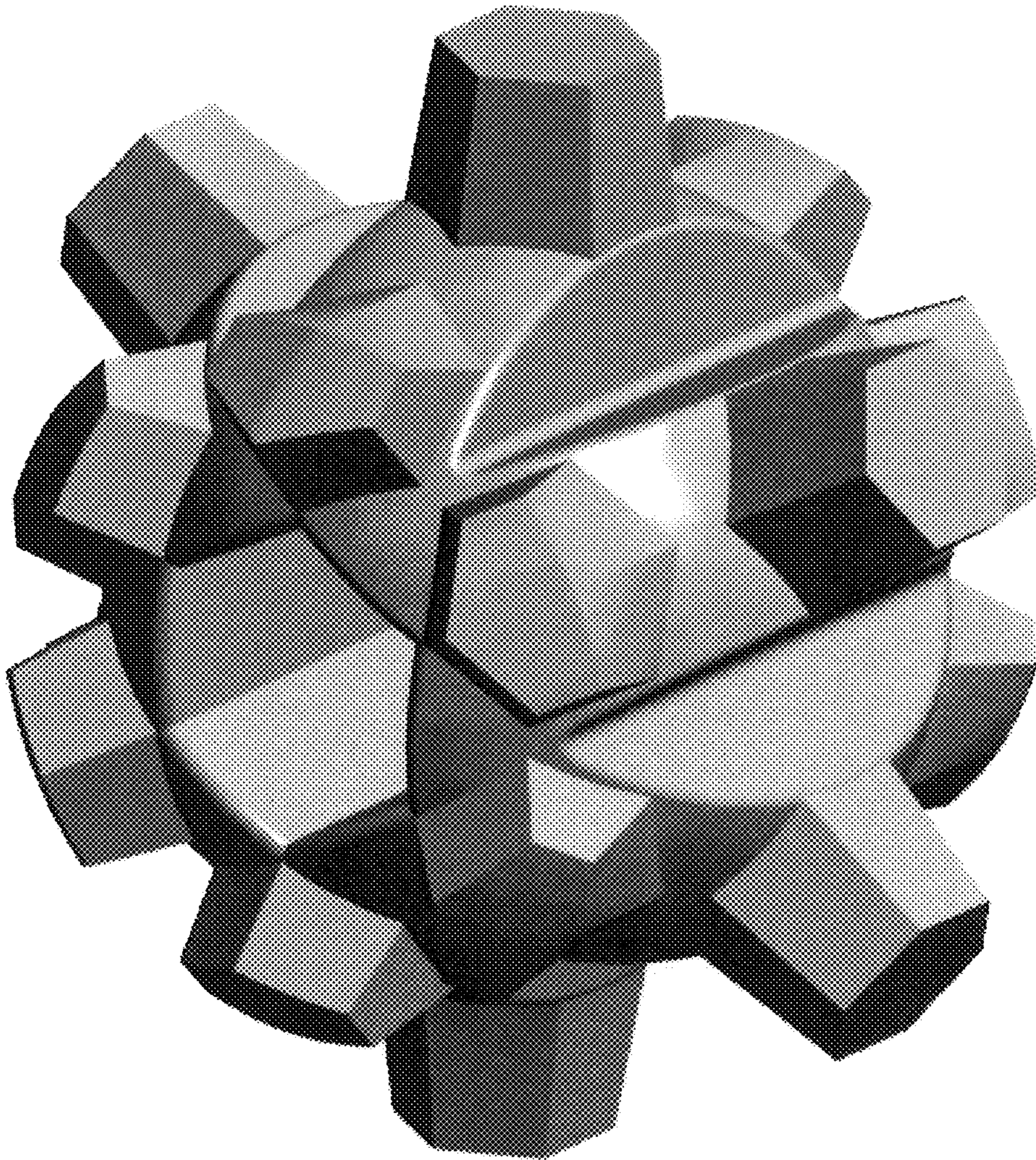

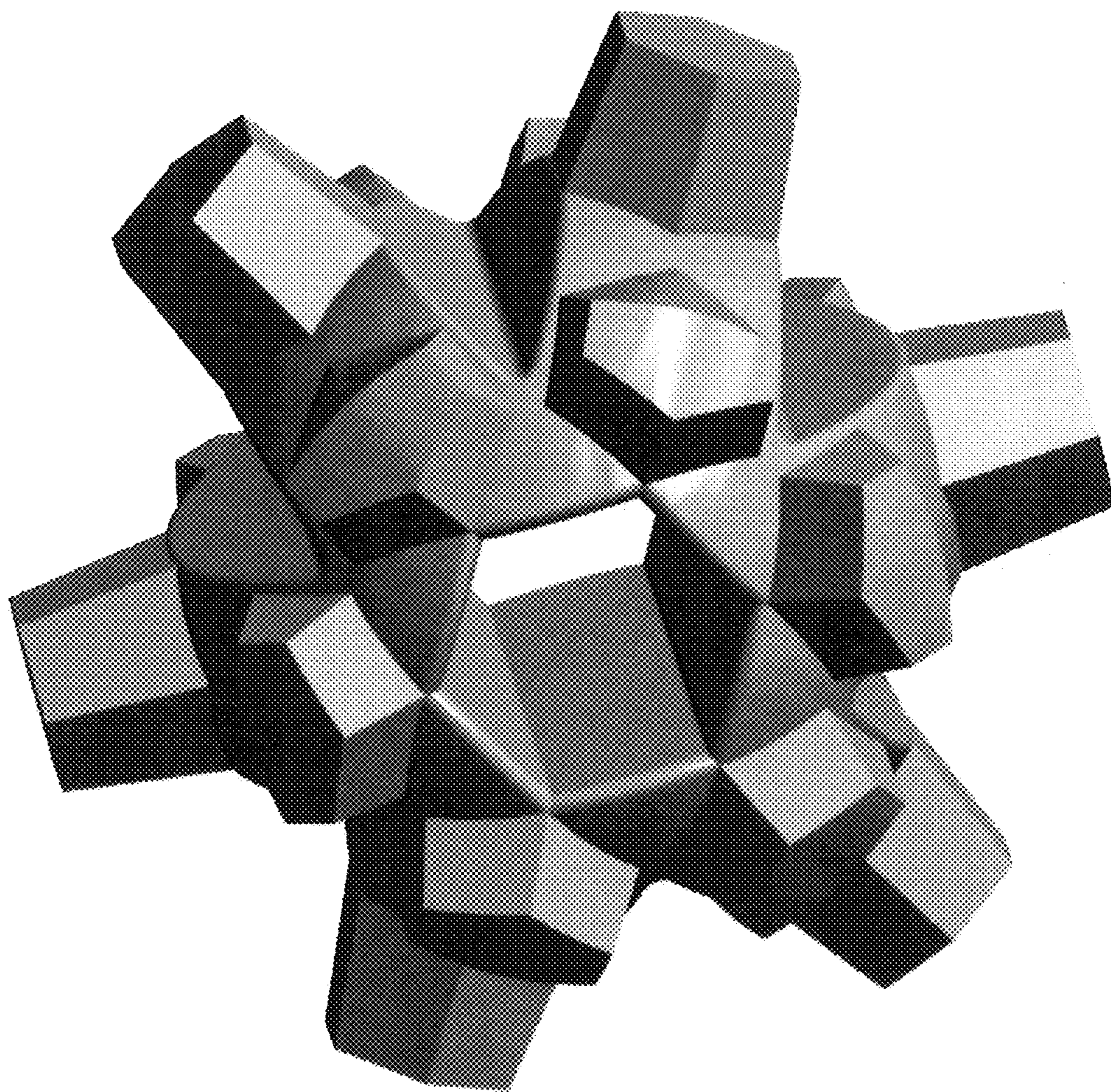

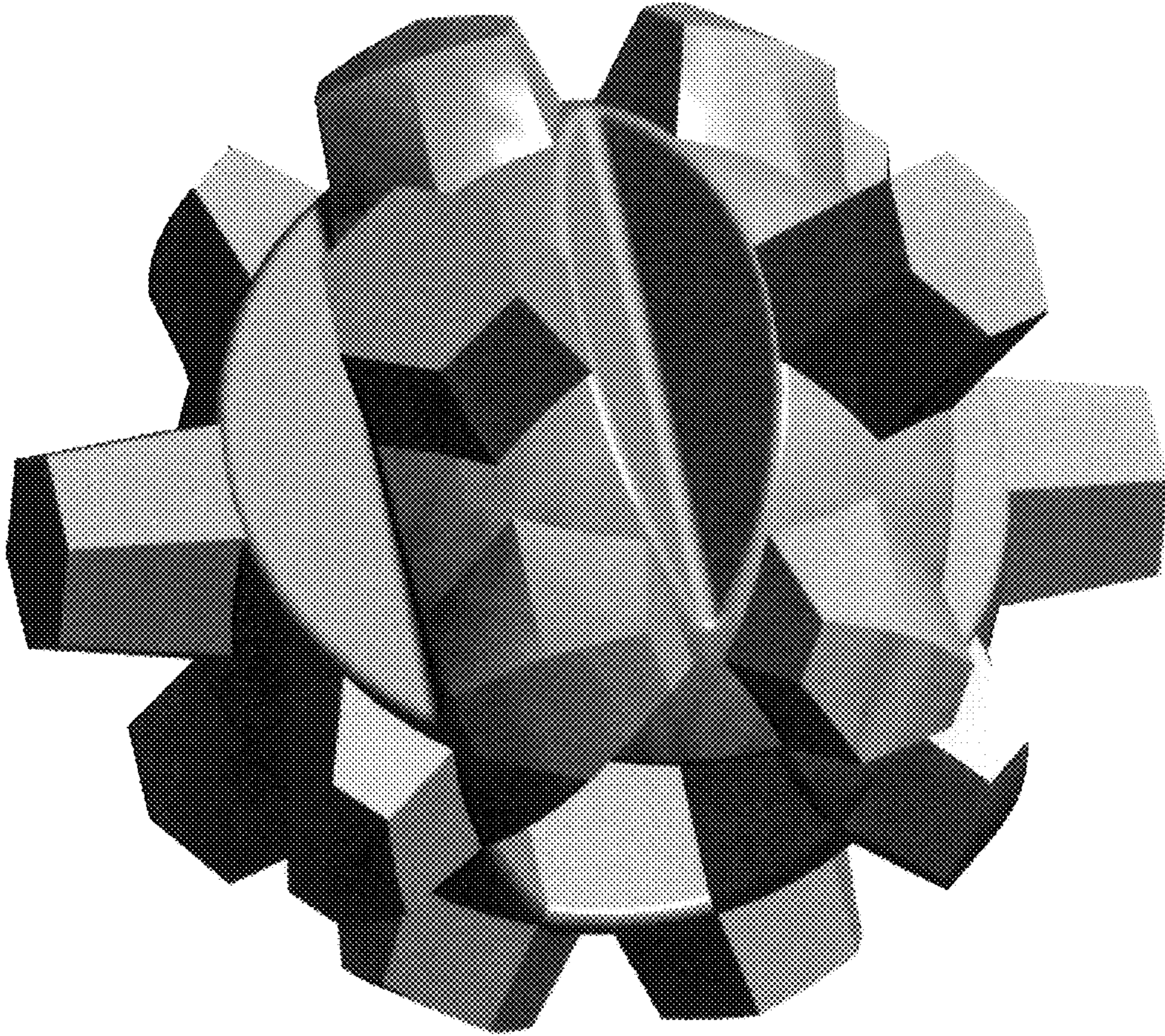

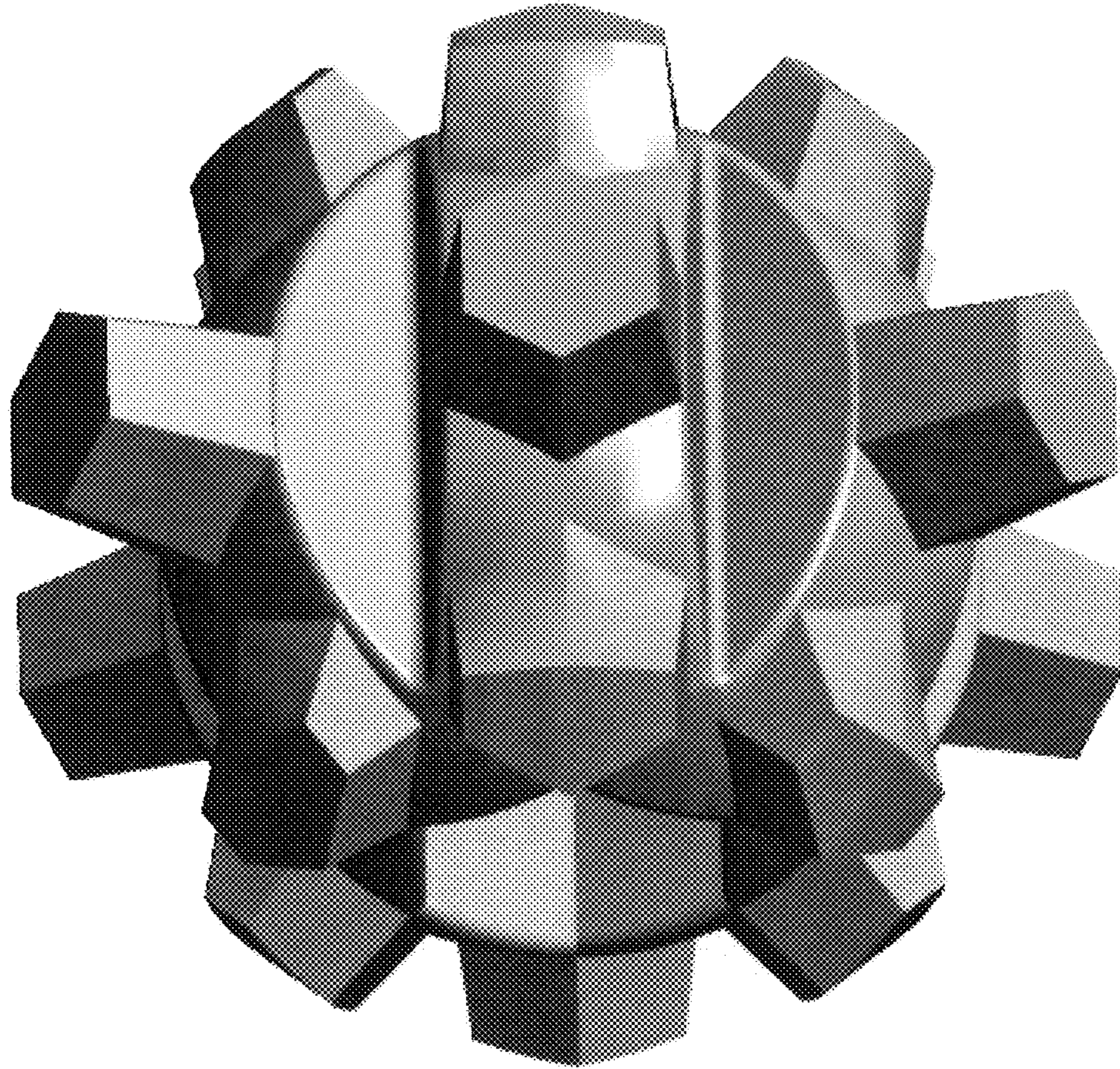

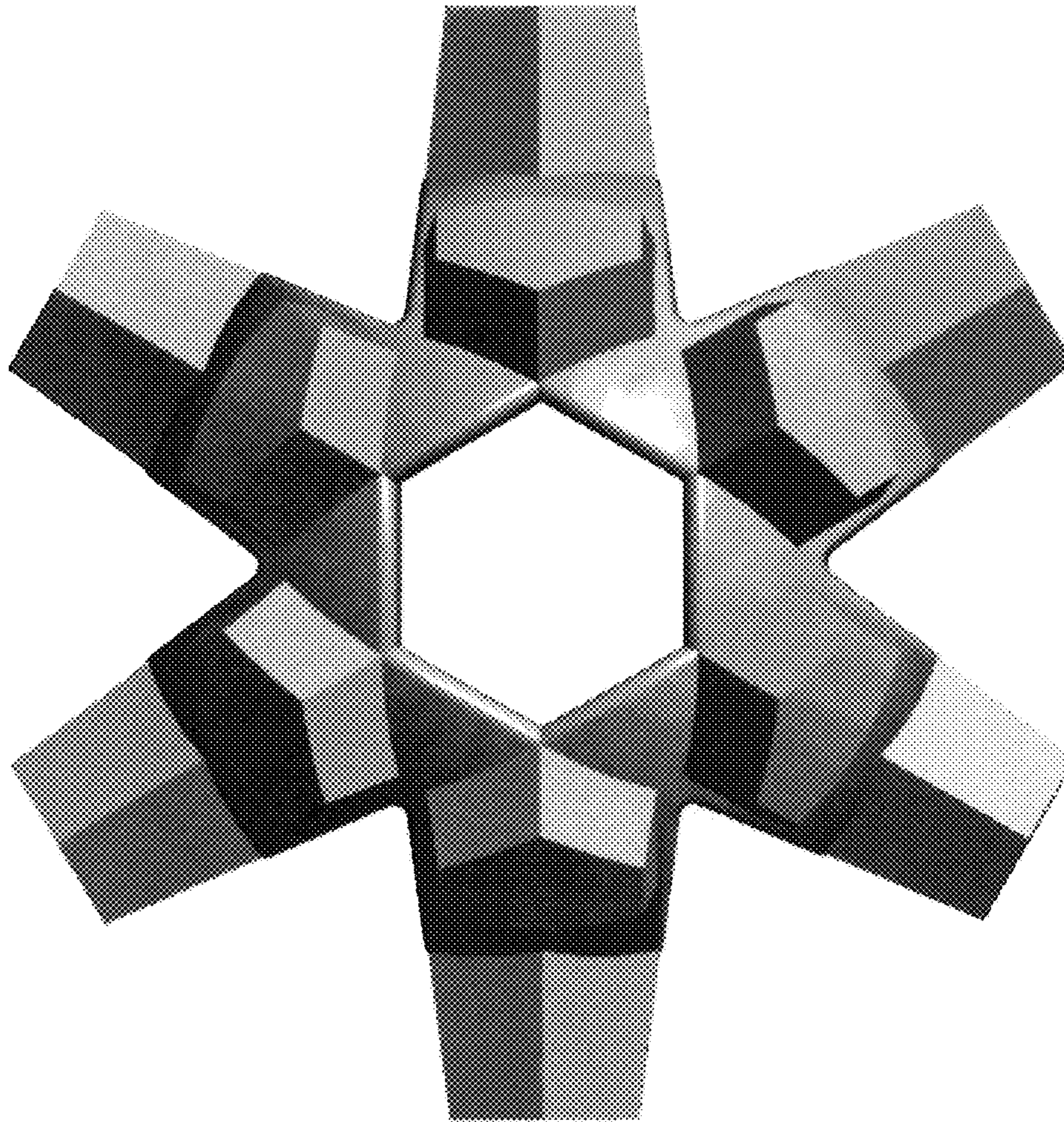

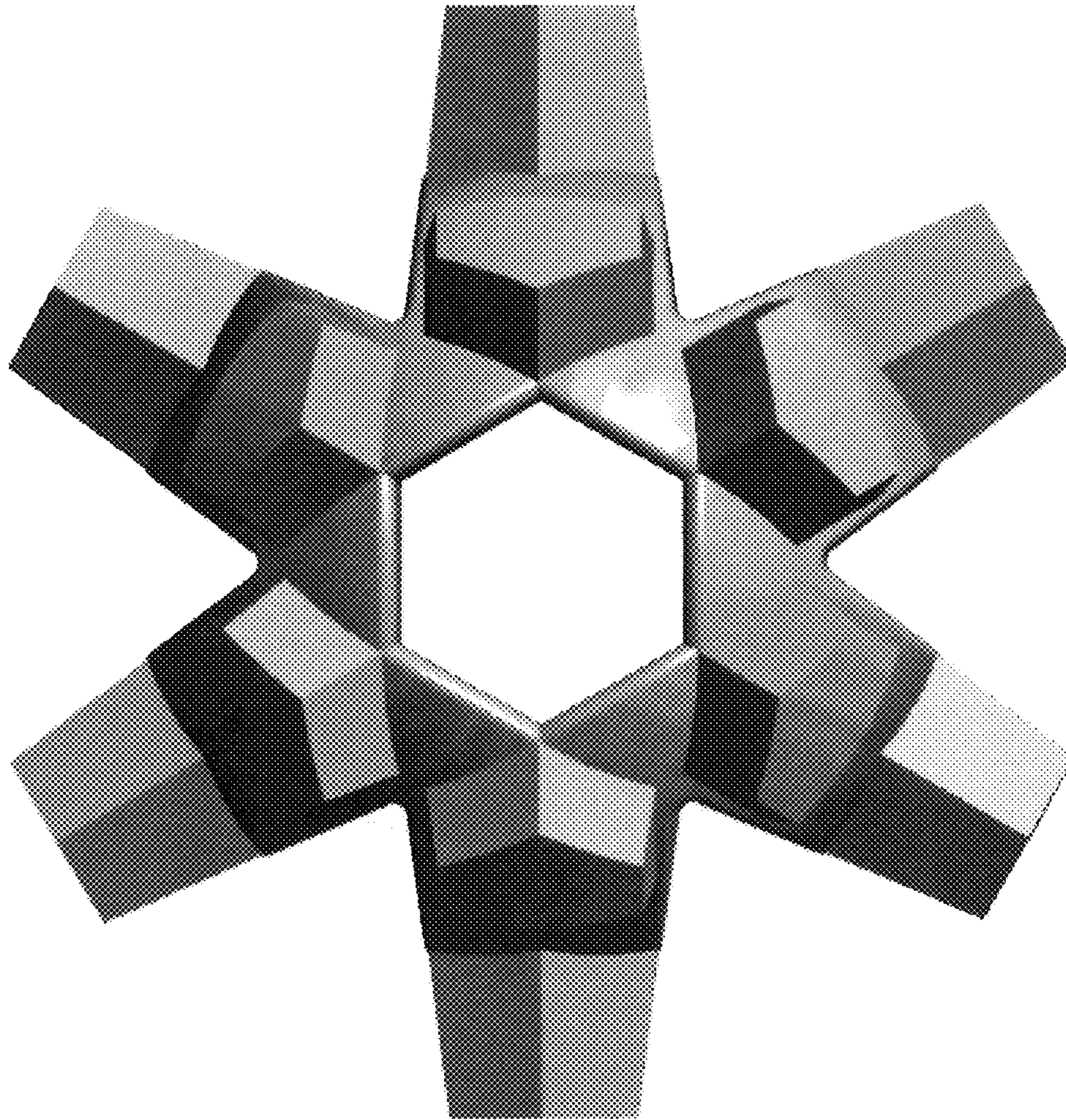

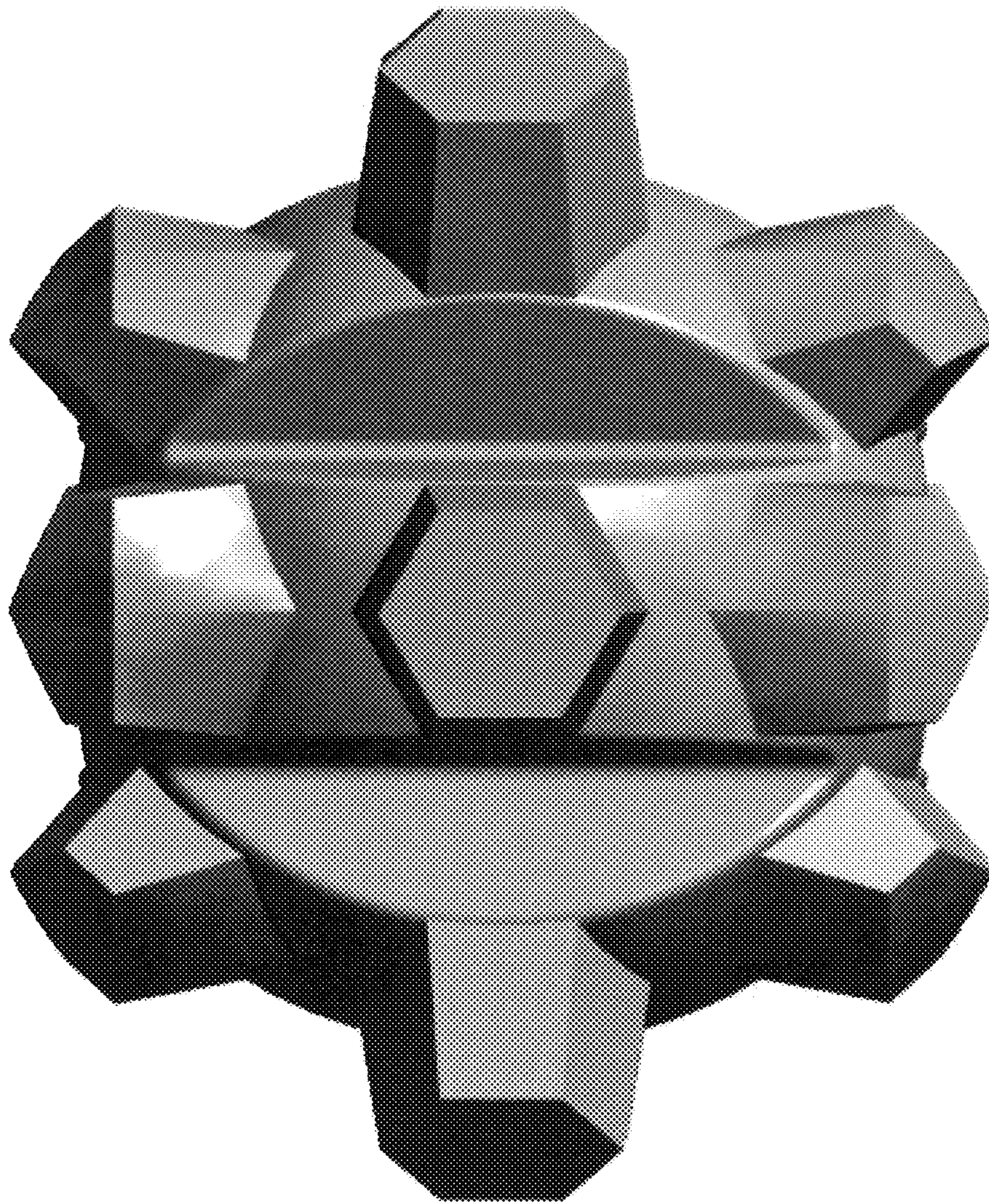

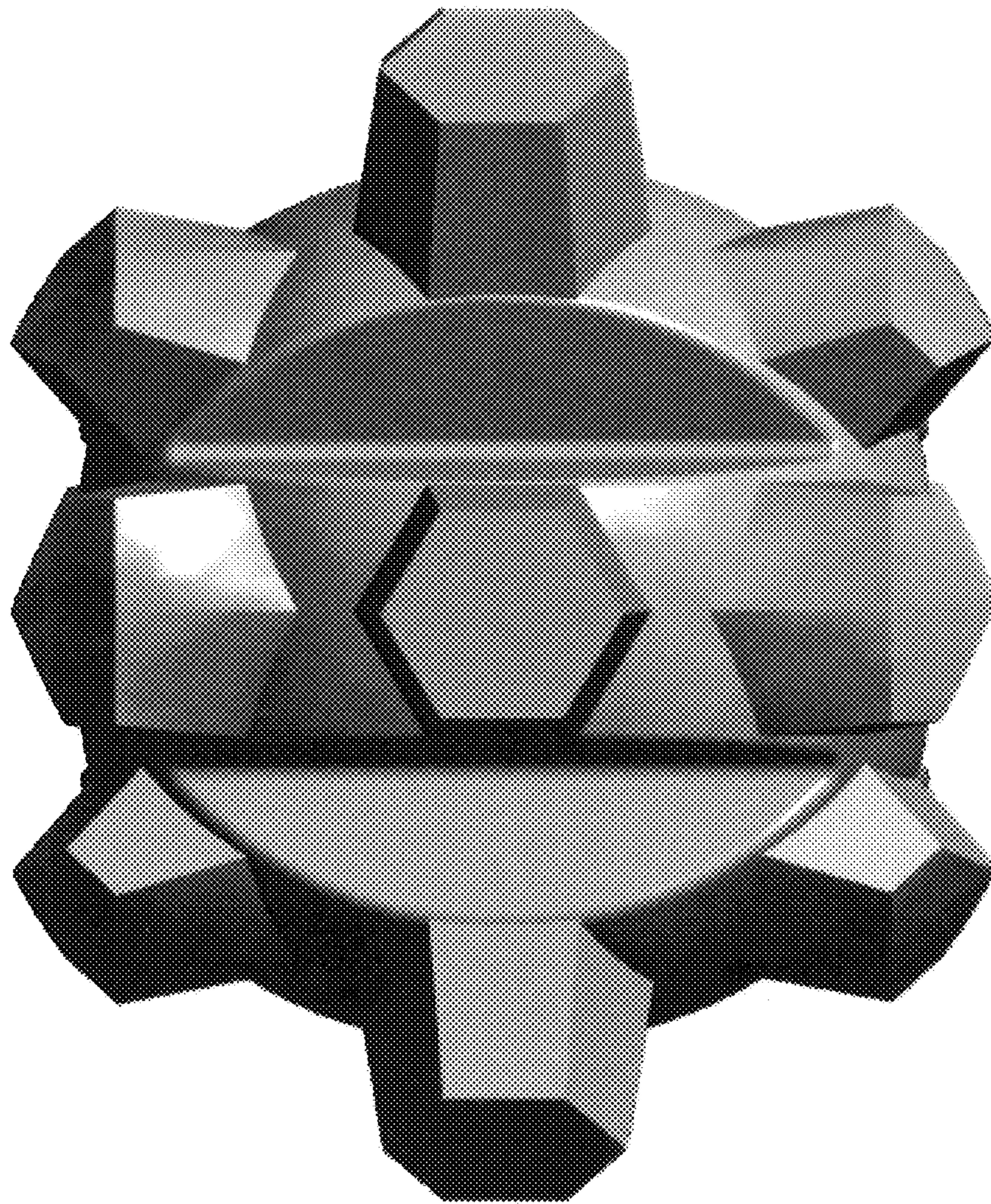

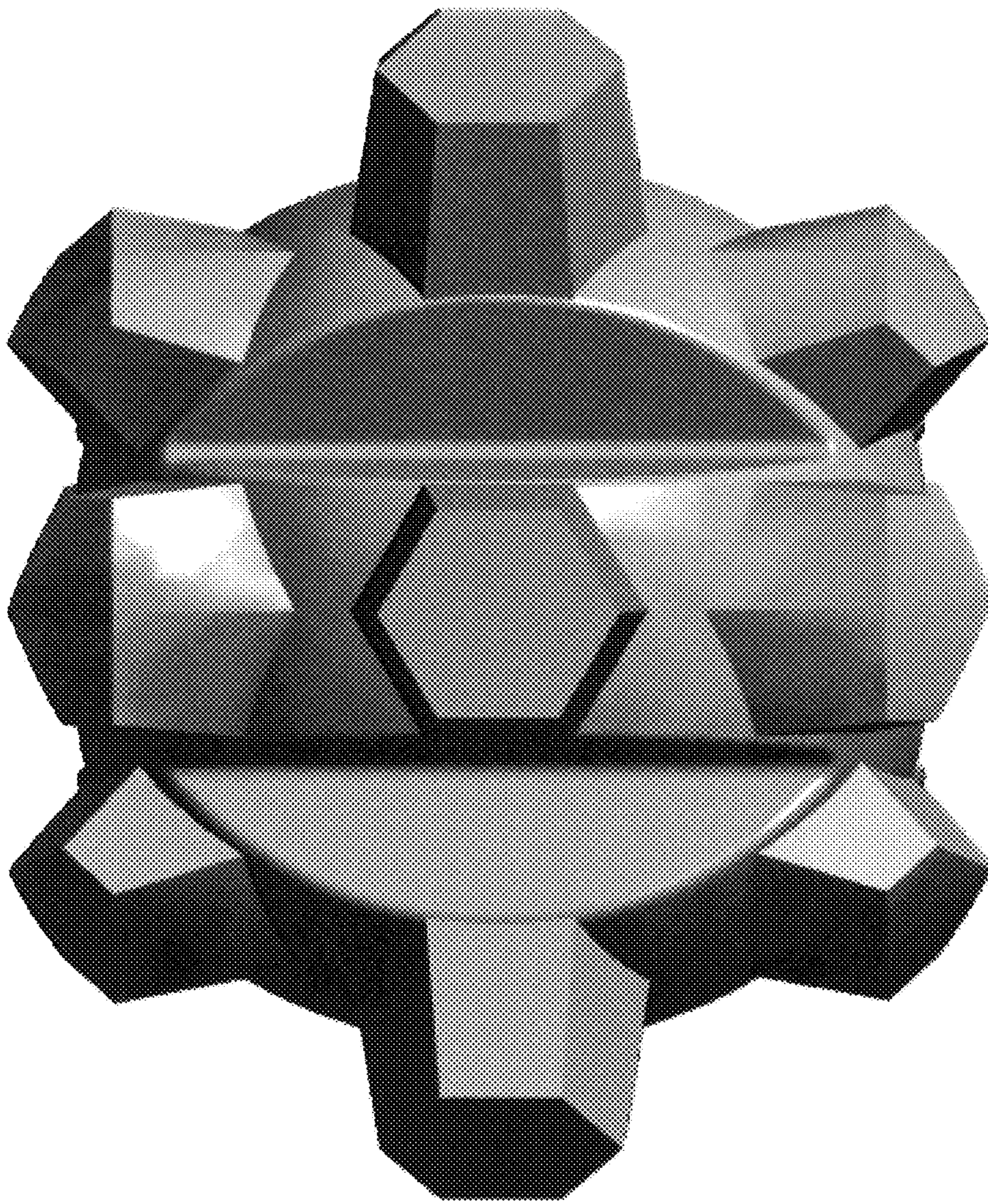

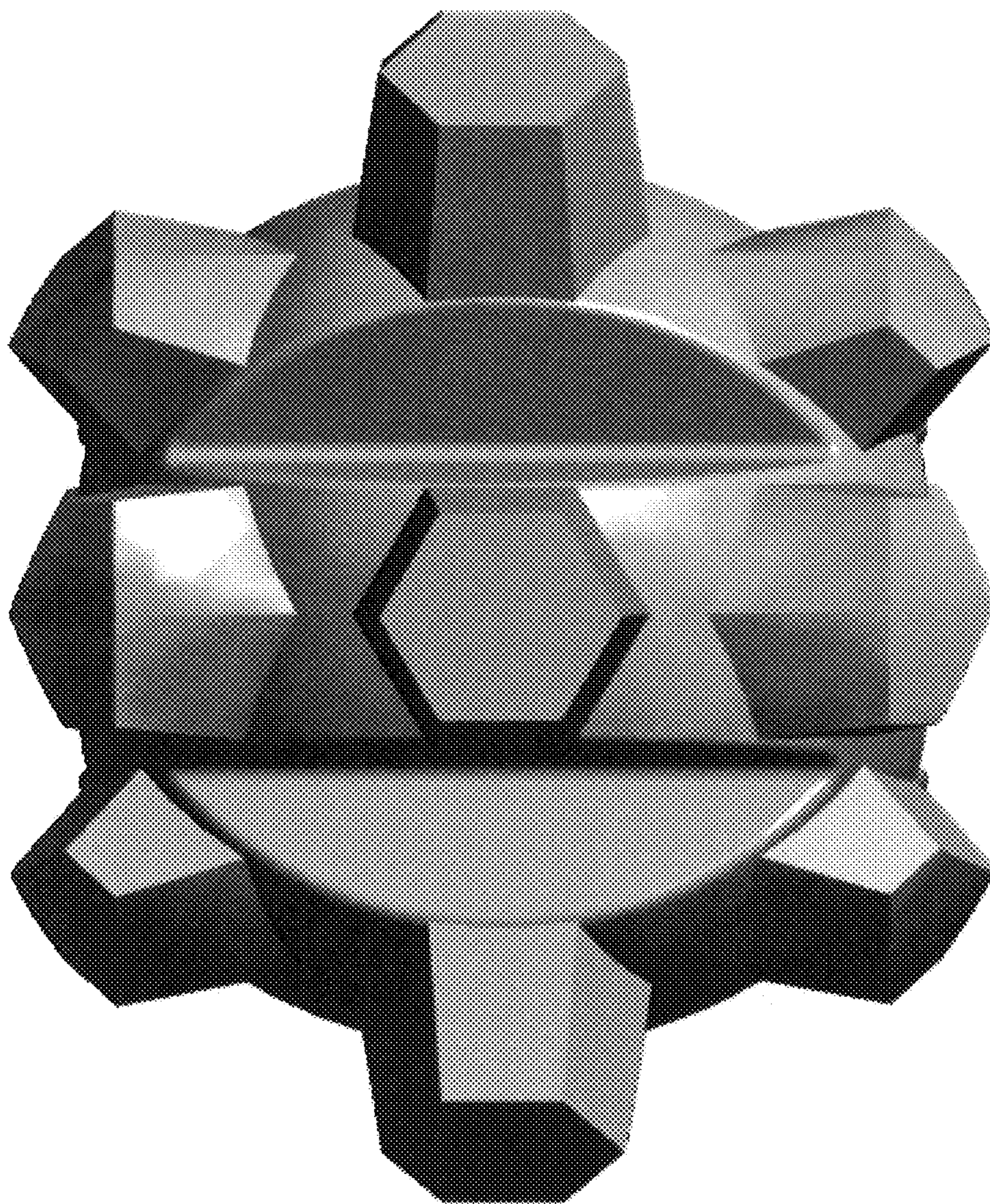
