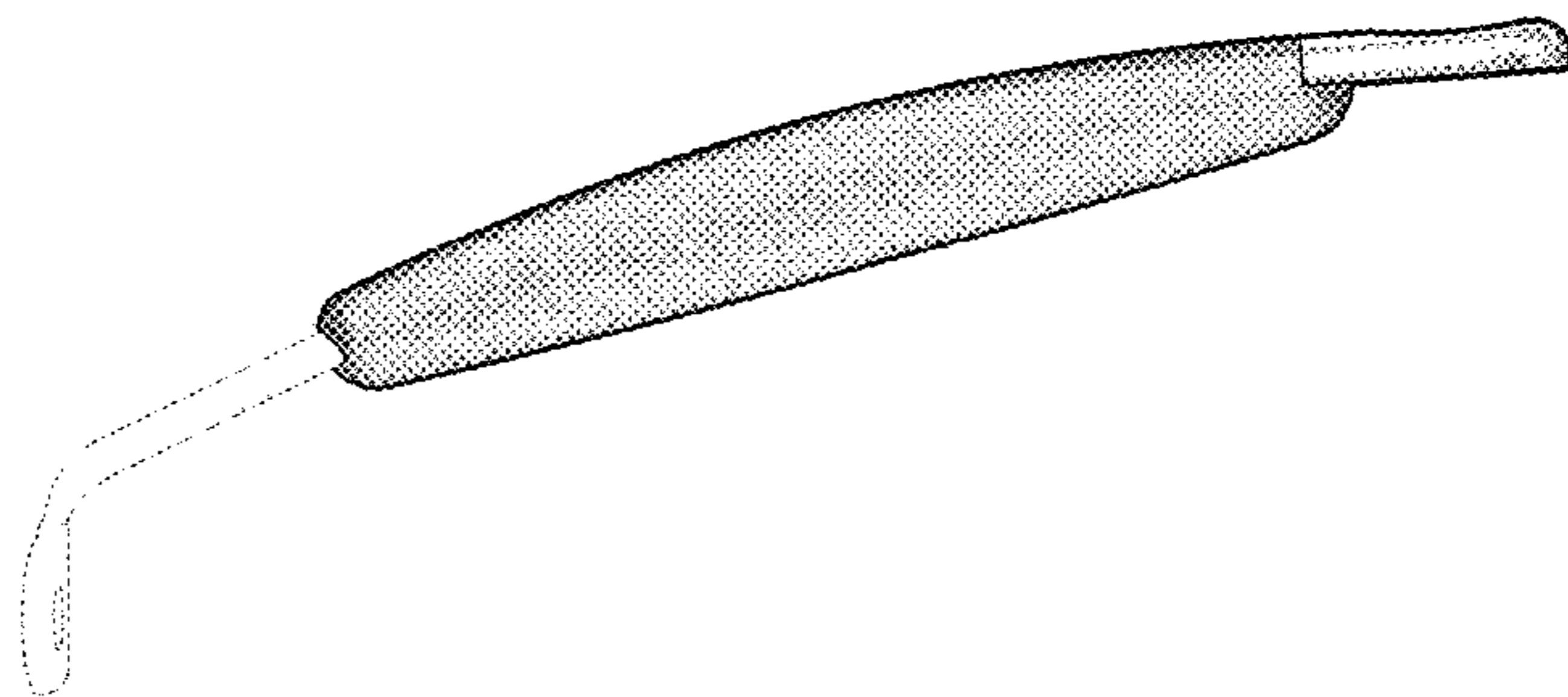
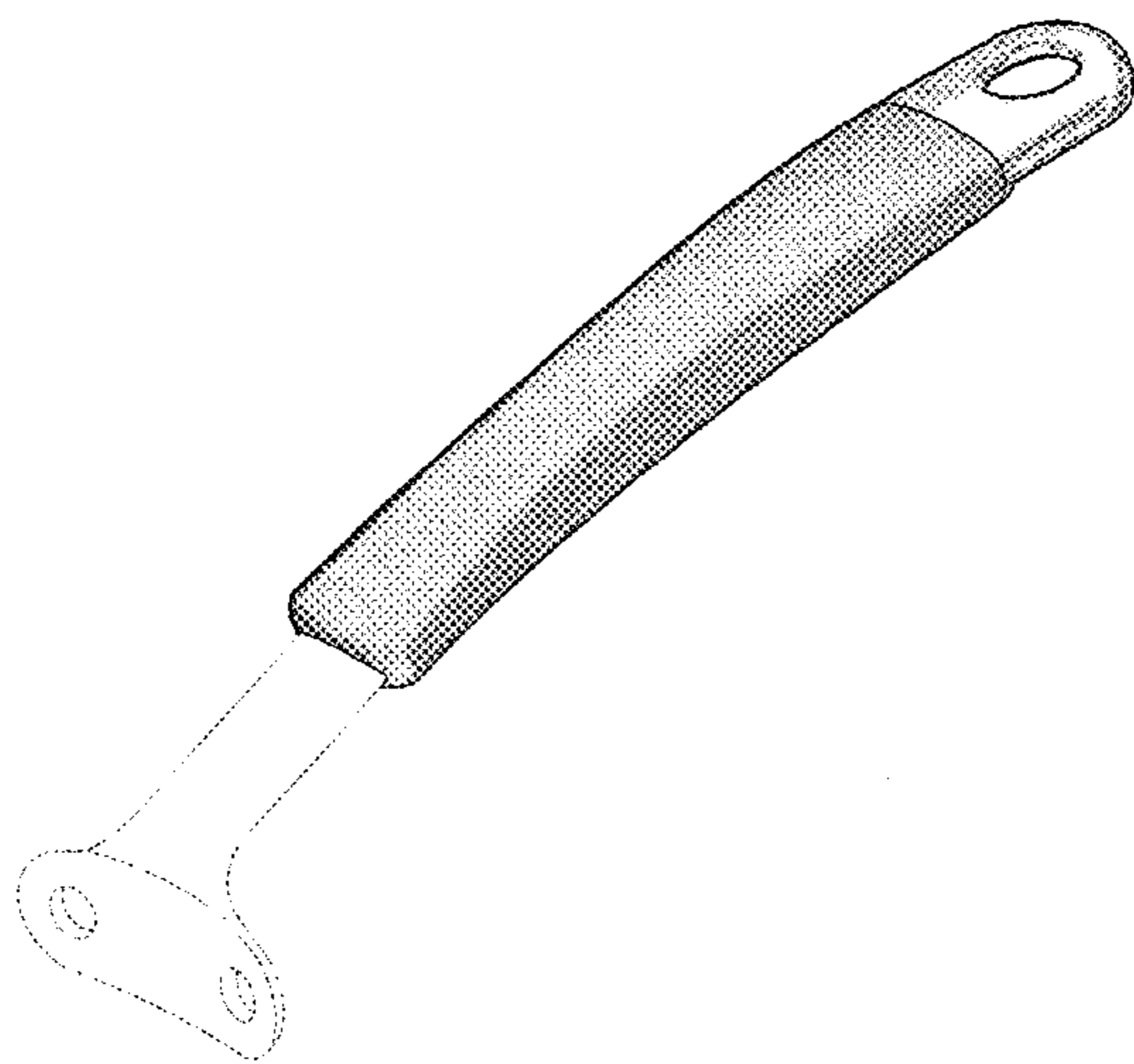
The ornamental design for an elongated side handle for cookware, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the “elongated side handle for cookware”, showing my new design; FIG. 2 is a right side view thereof; the left side elevation view being the mirror image thereof; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a front view thereof; and, FIG. 6 is a rear view thereof.

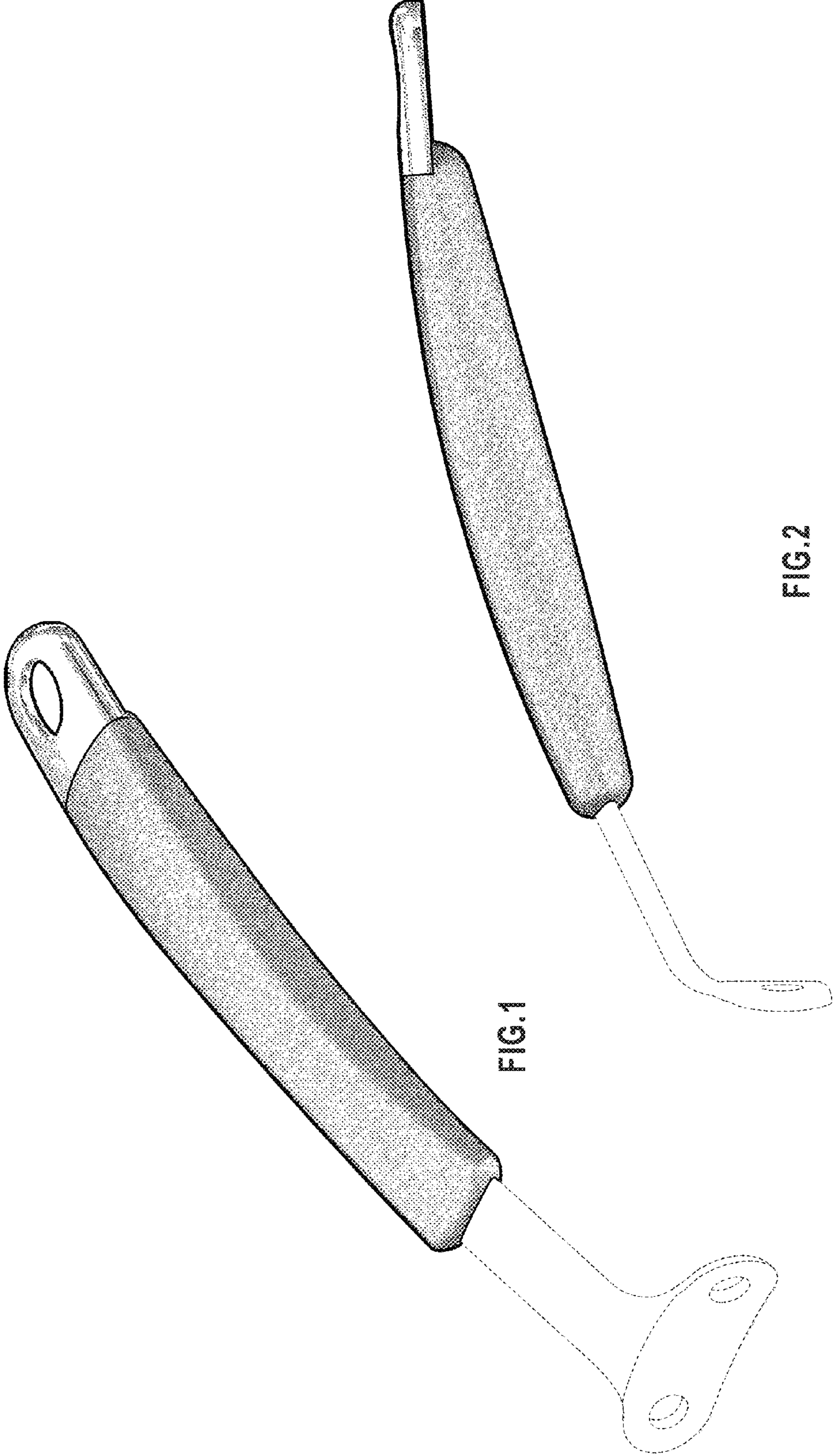

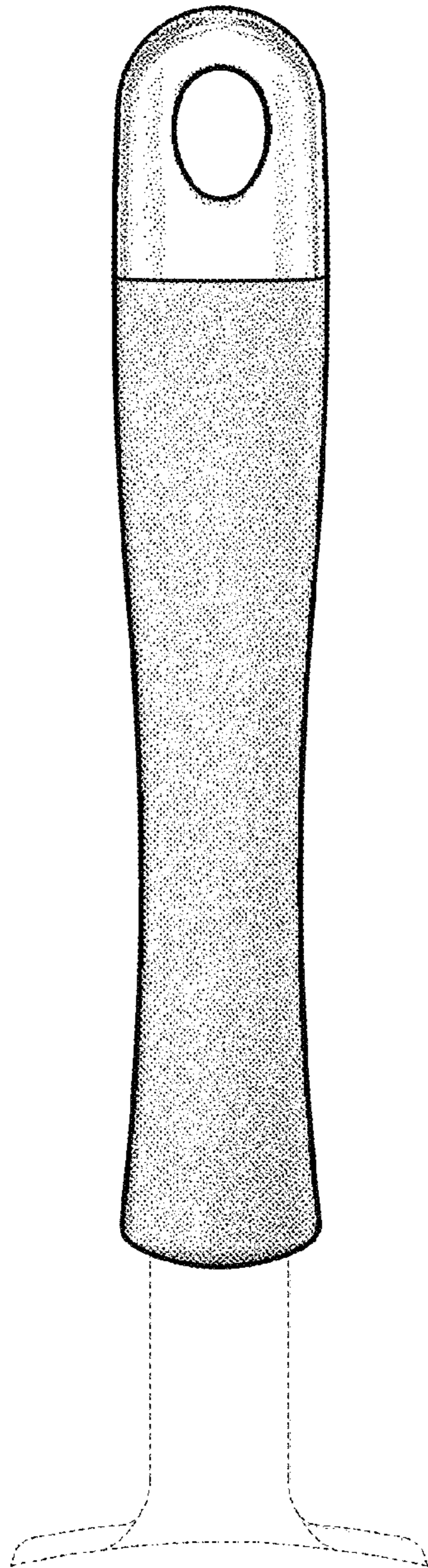

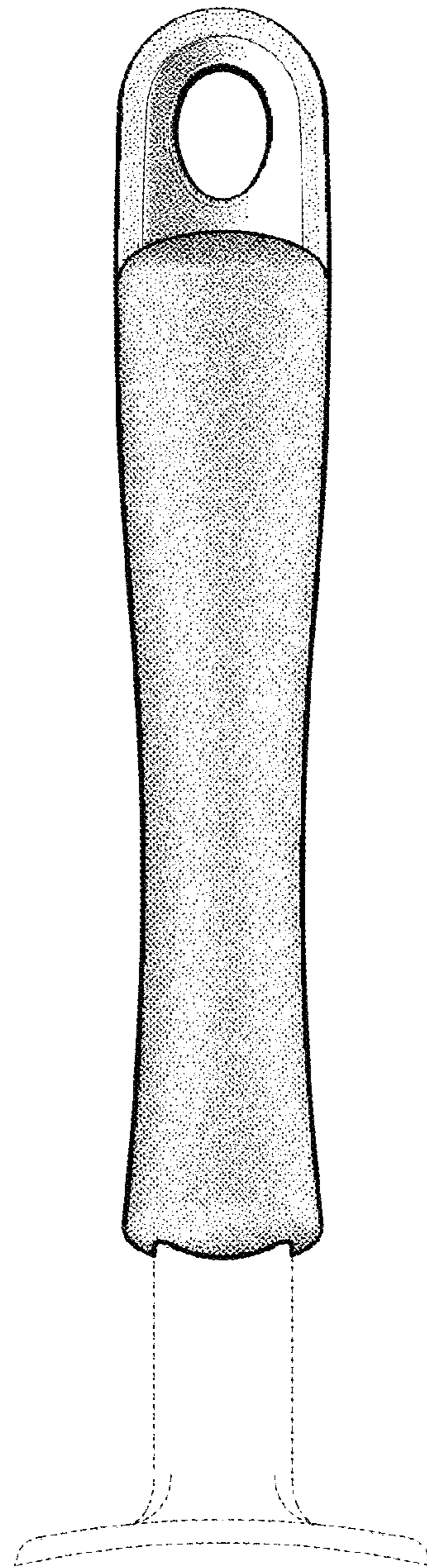

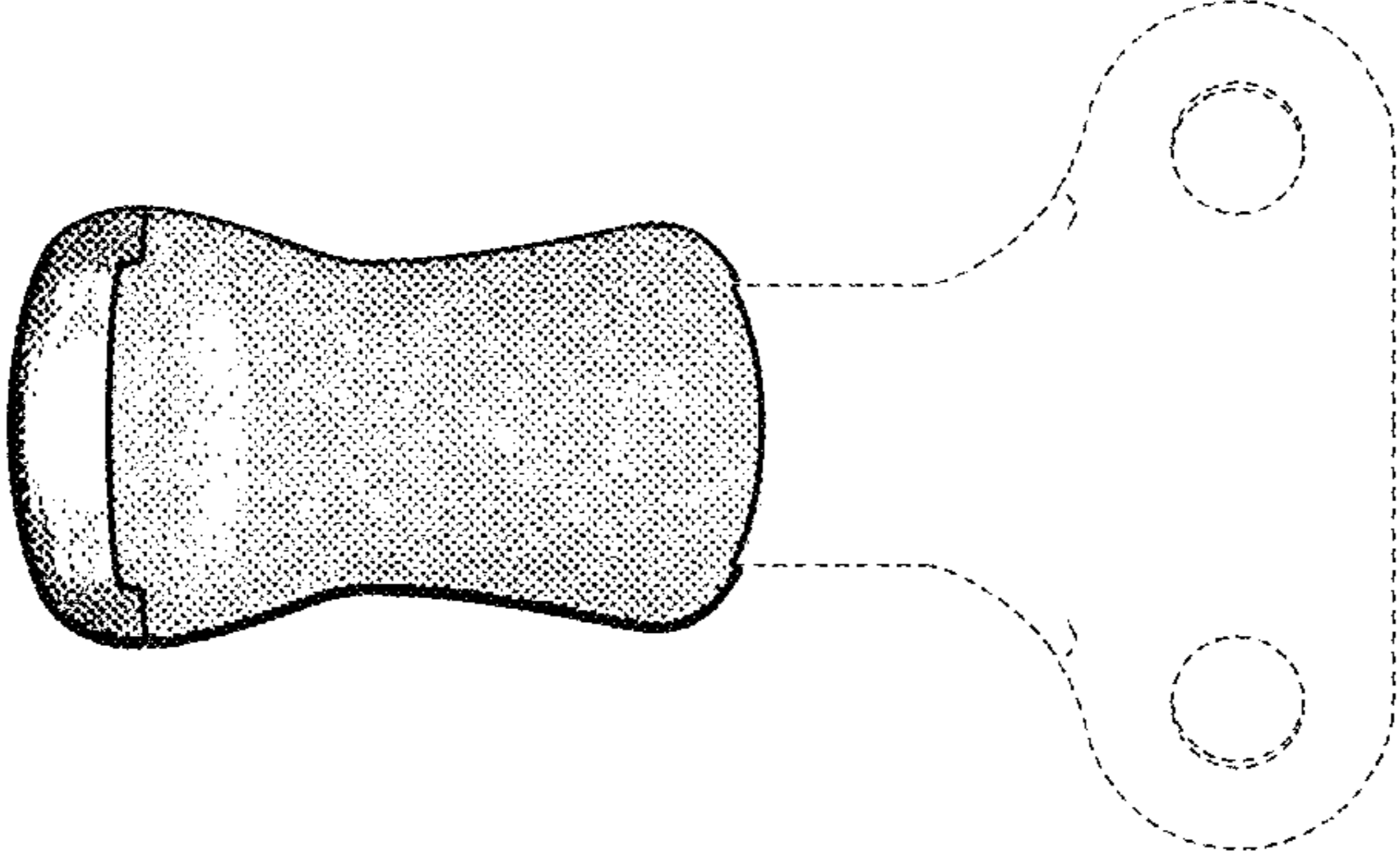

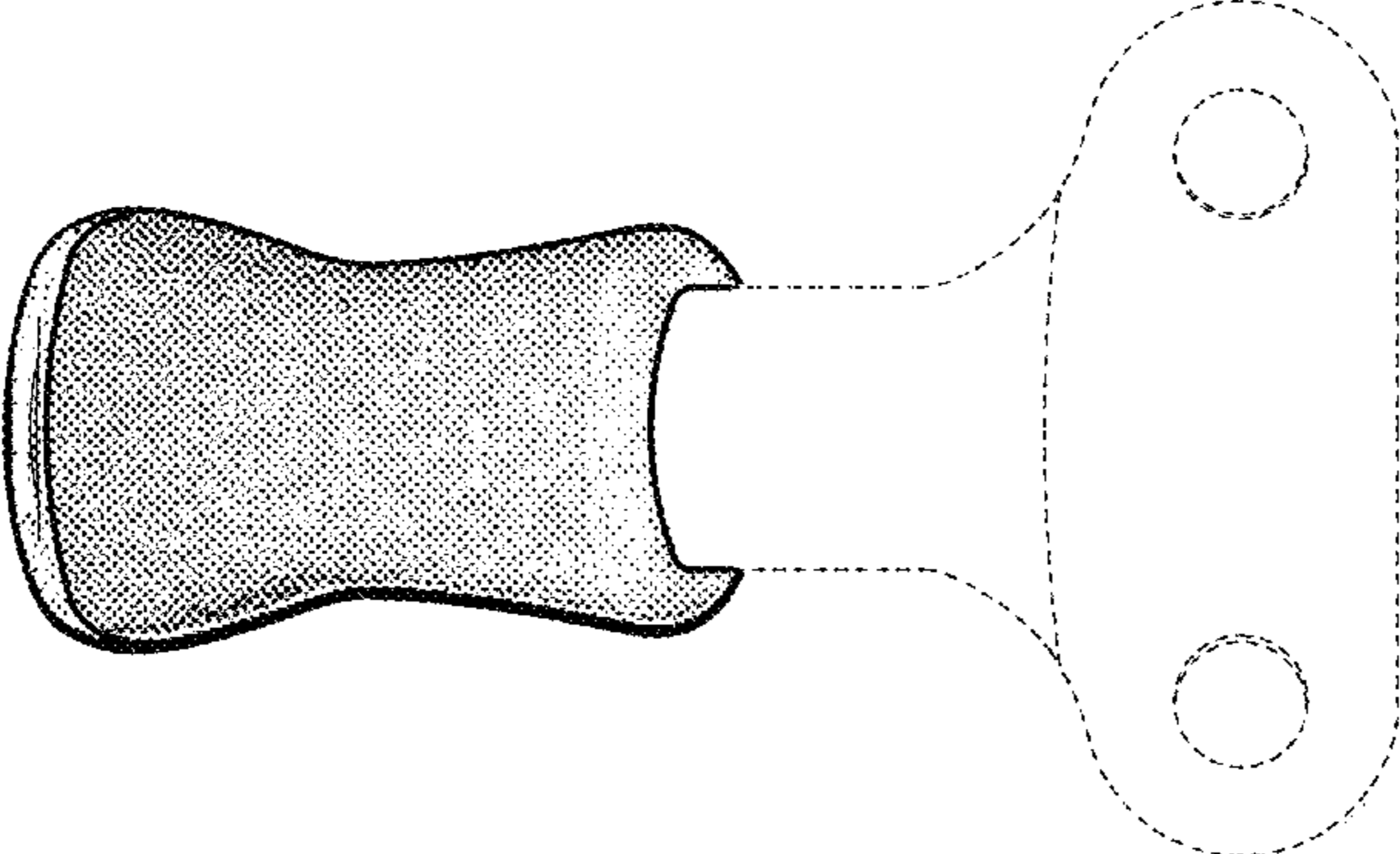
