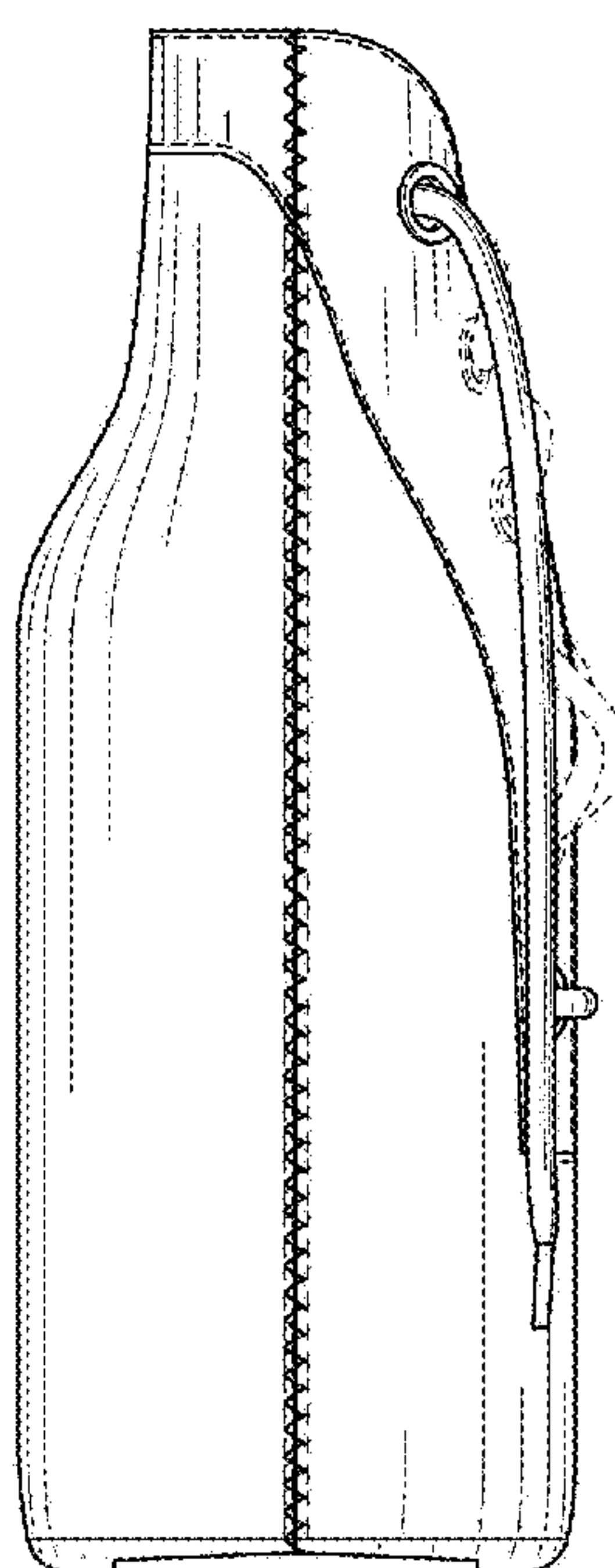
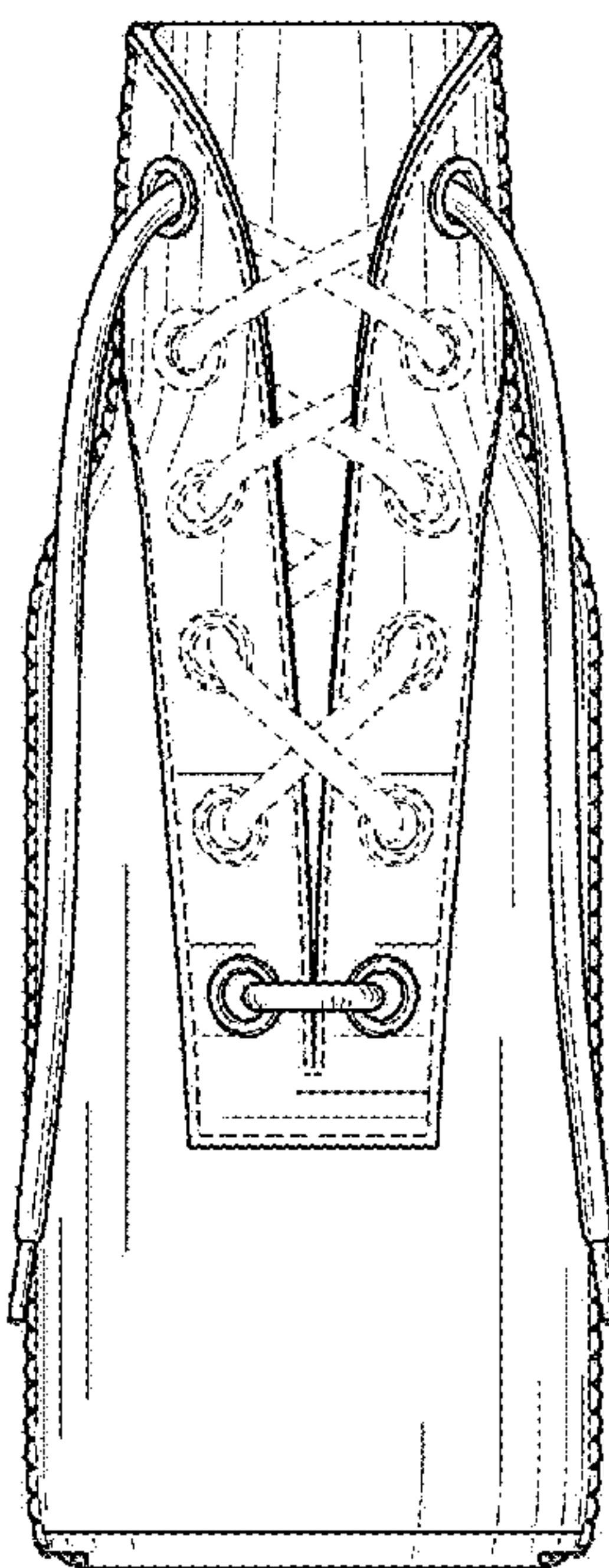
The ornamental design for a bottle cover, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a bottle cover showing the design. FIG. 2 is a rear view thereof. FIG. 3 is a right side view thereof. FIG. 4 is a top view thereof. FIG. 5 is a bottom view thereof; and, FIG. 6 is a front view thereof showing an enclosed bottle as environment.

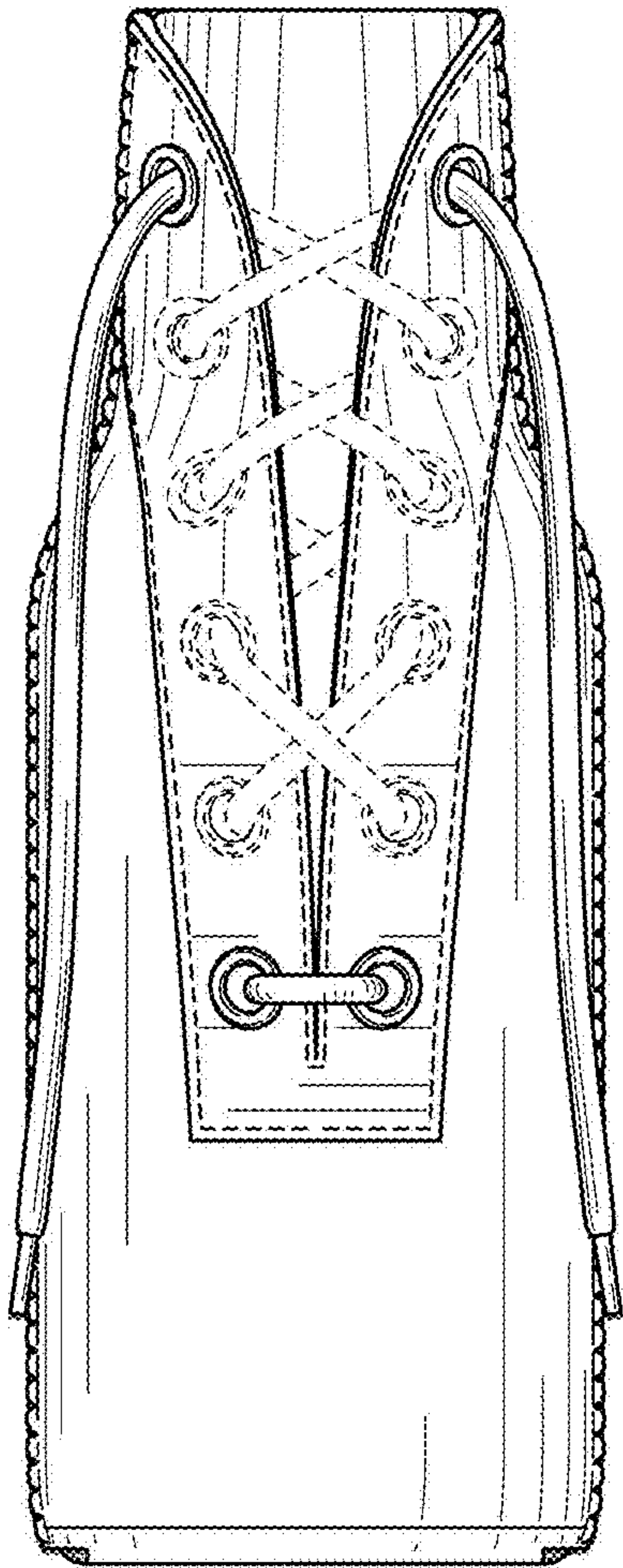

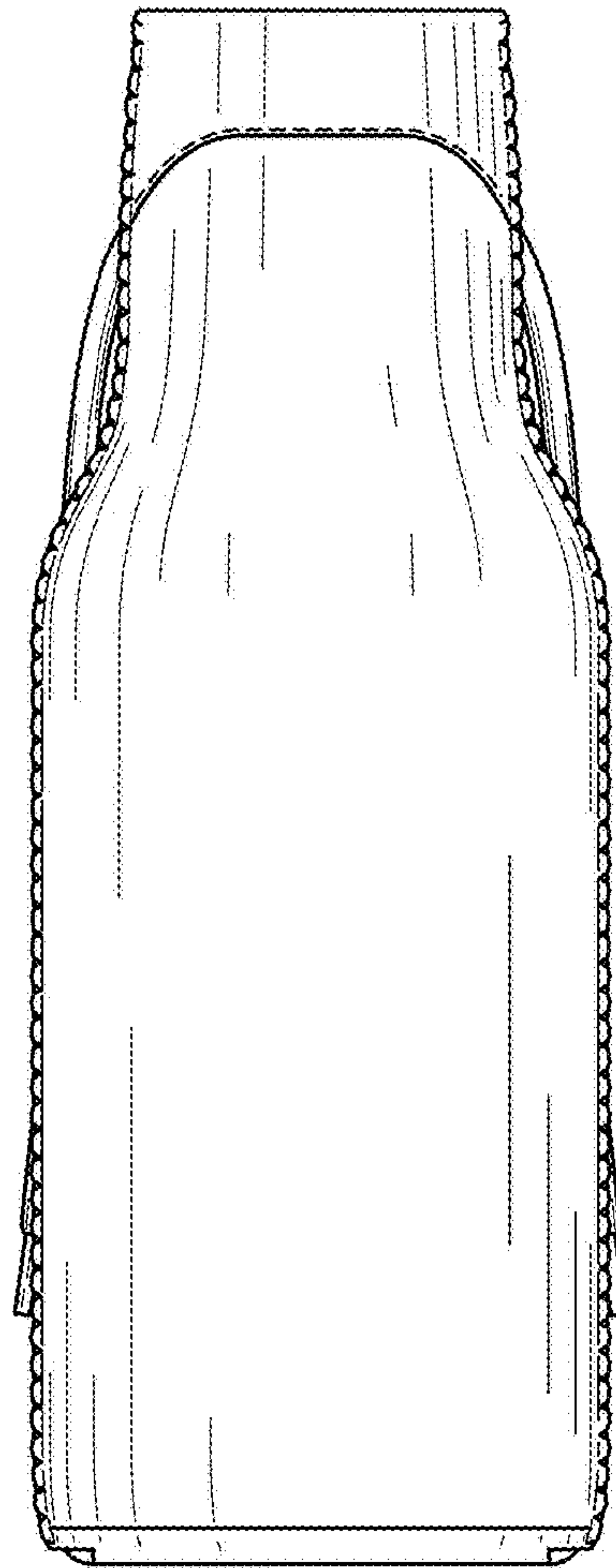

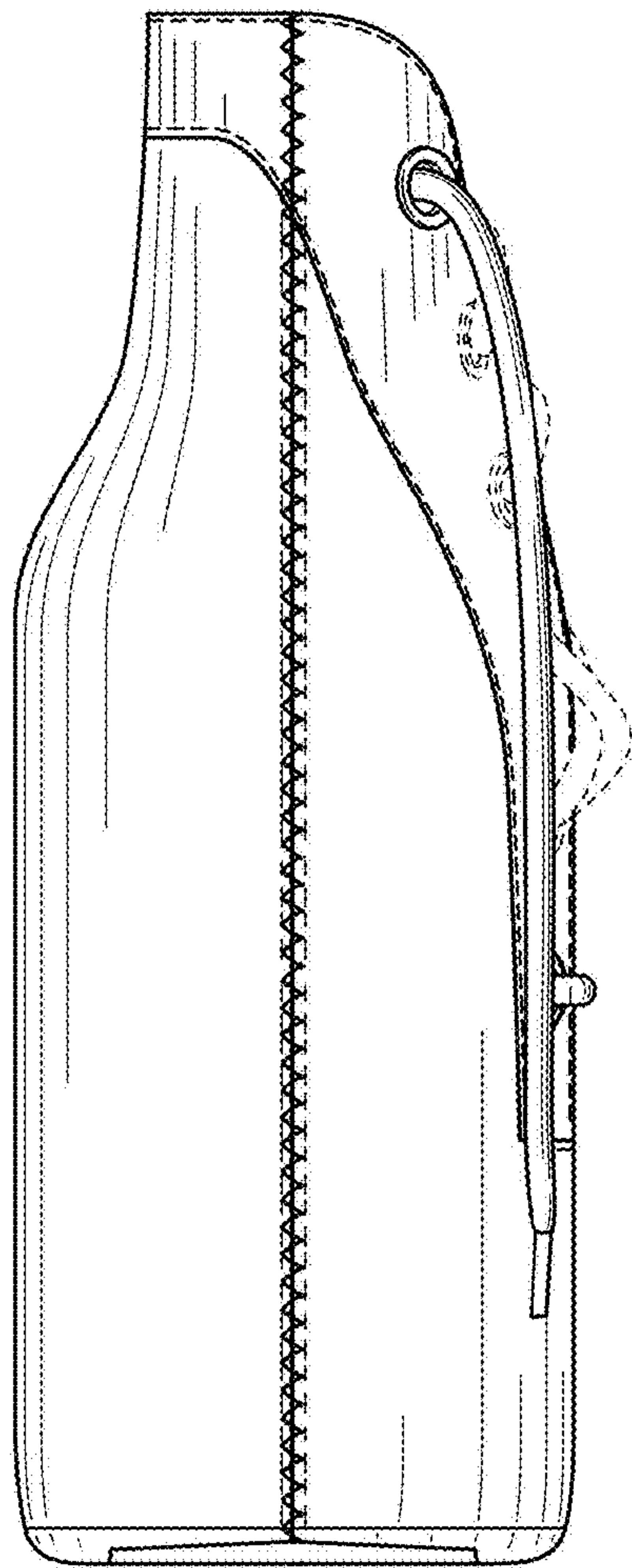

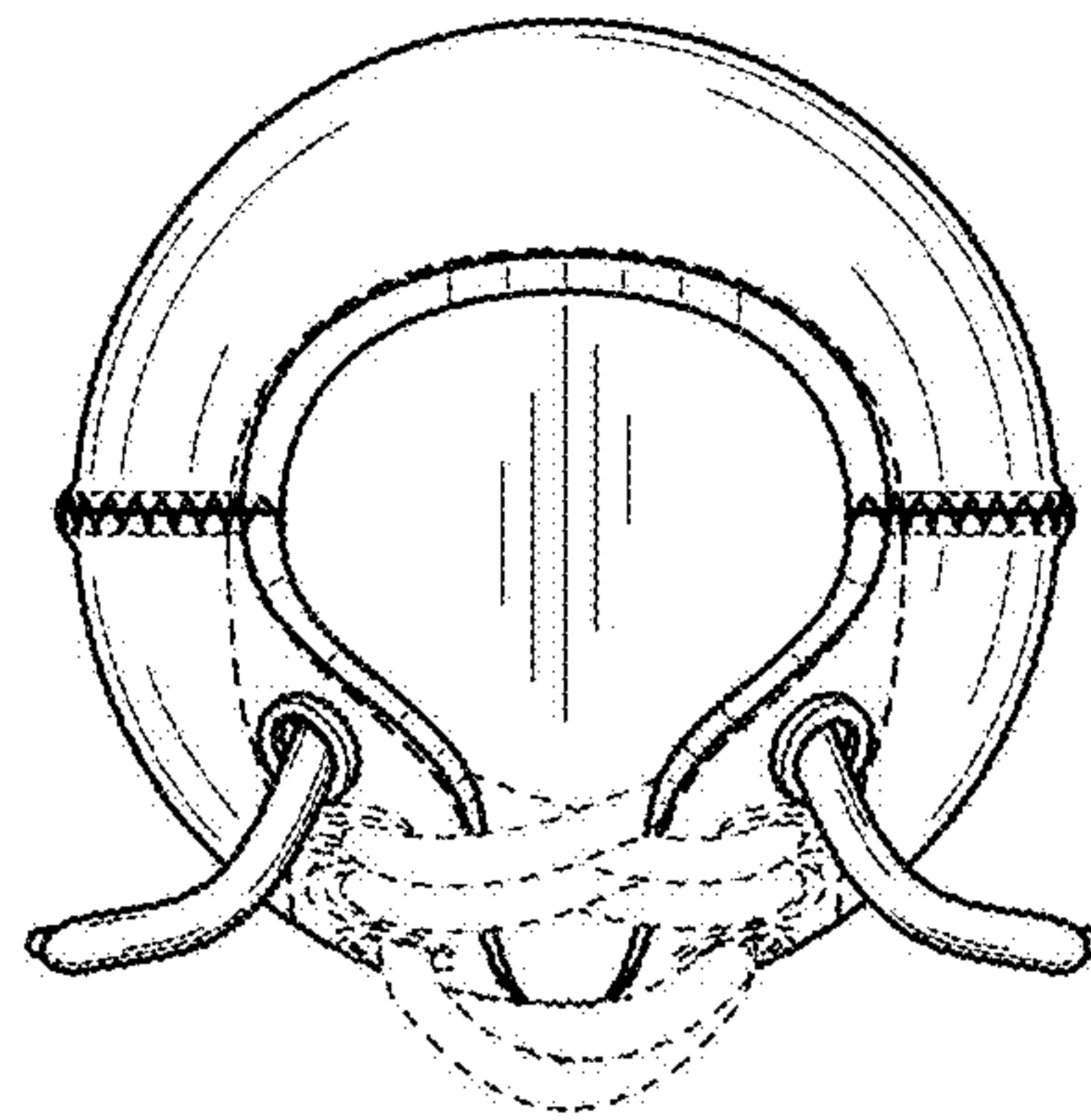

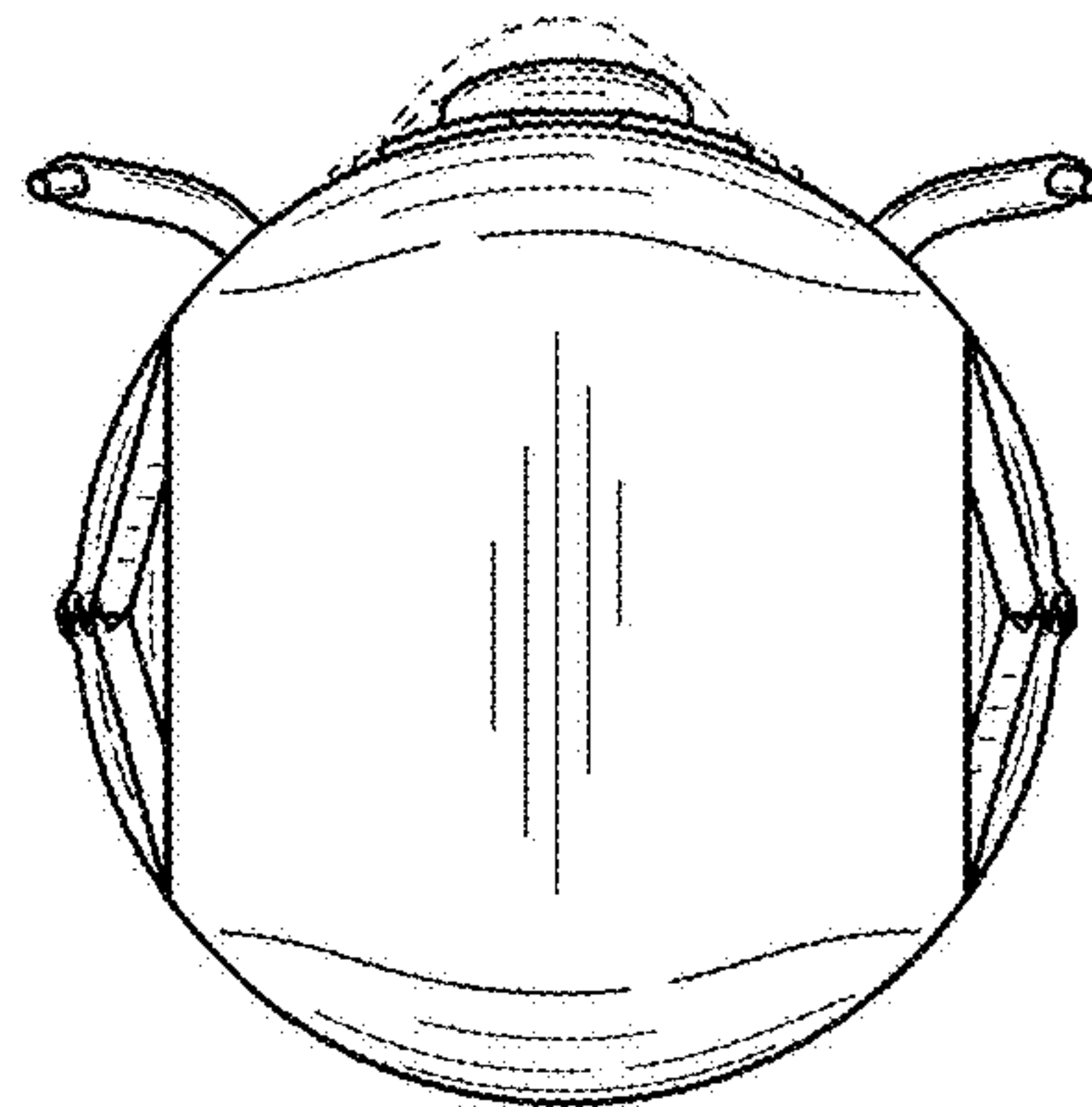

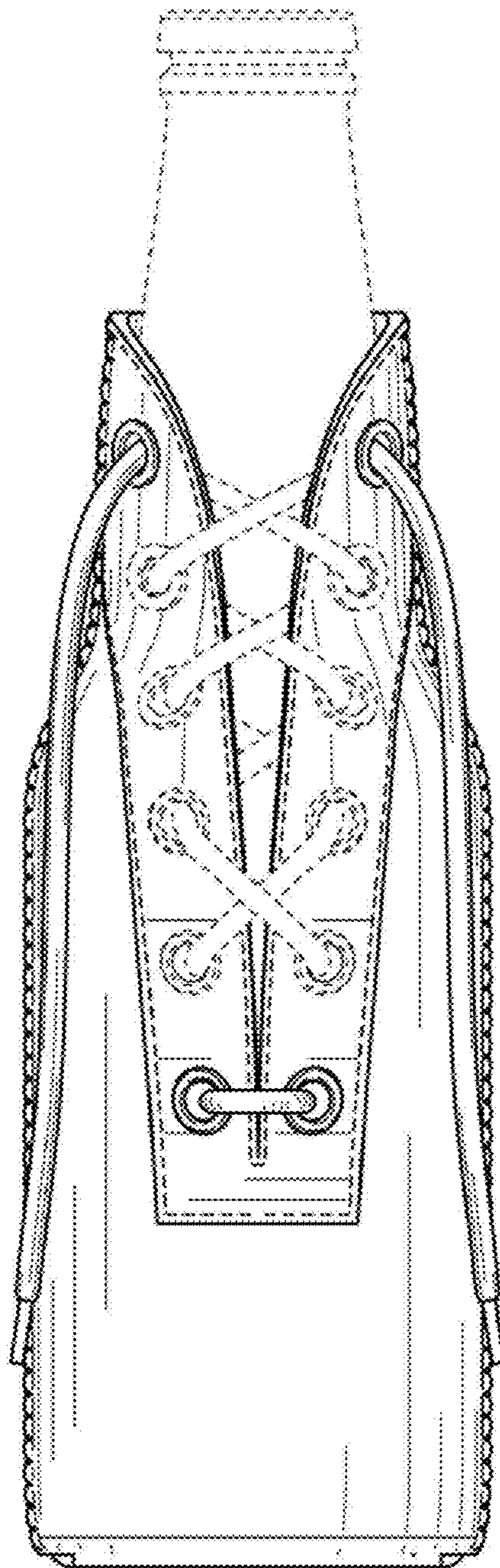
