**DESCRIPTION**

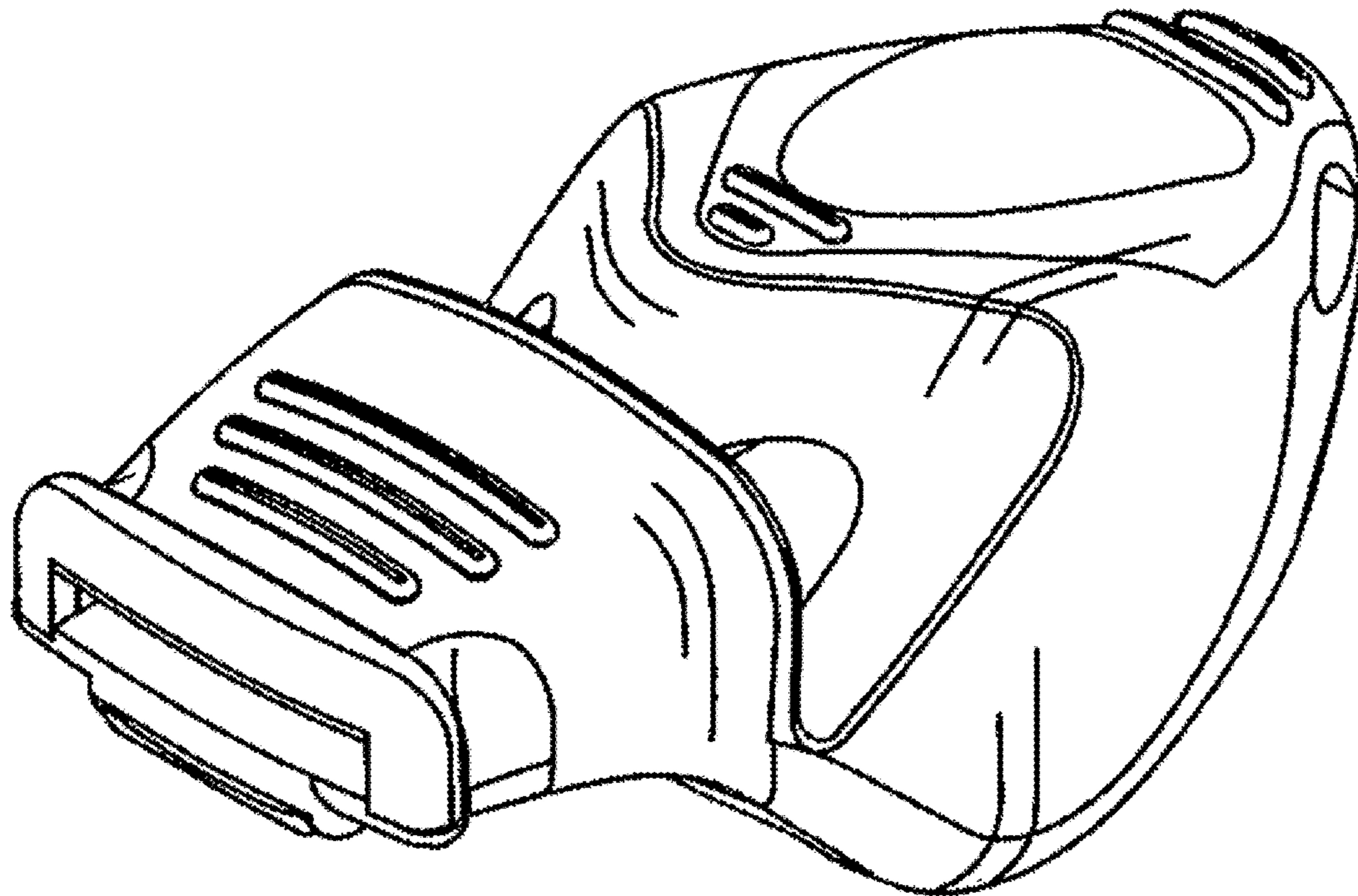
FIG. 1 is a top right side perspective view of the present design a whistle.

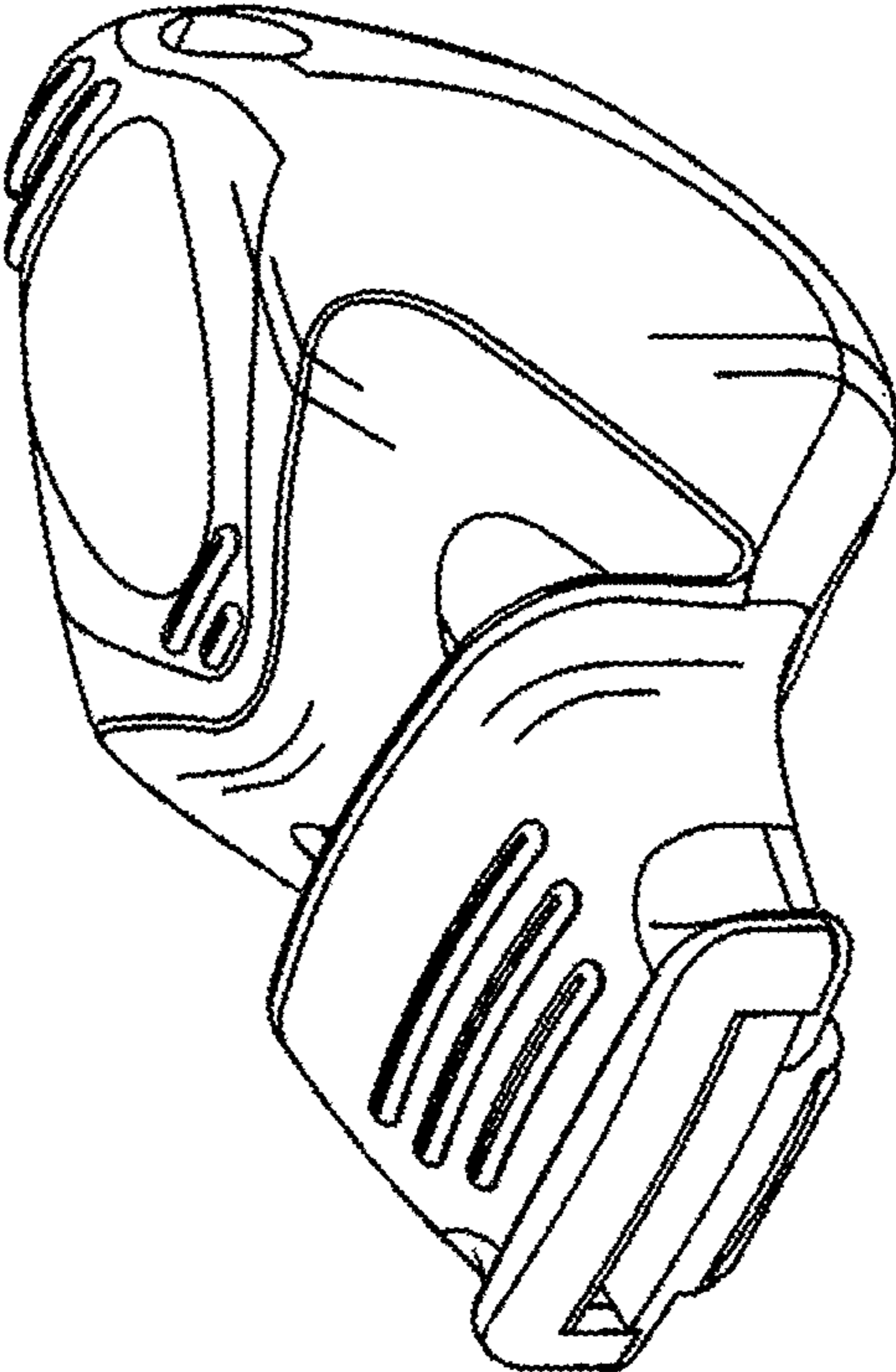

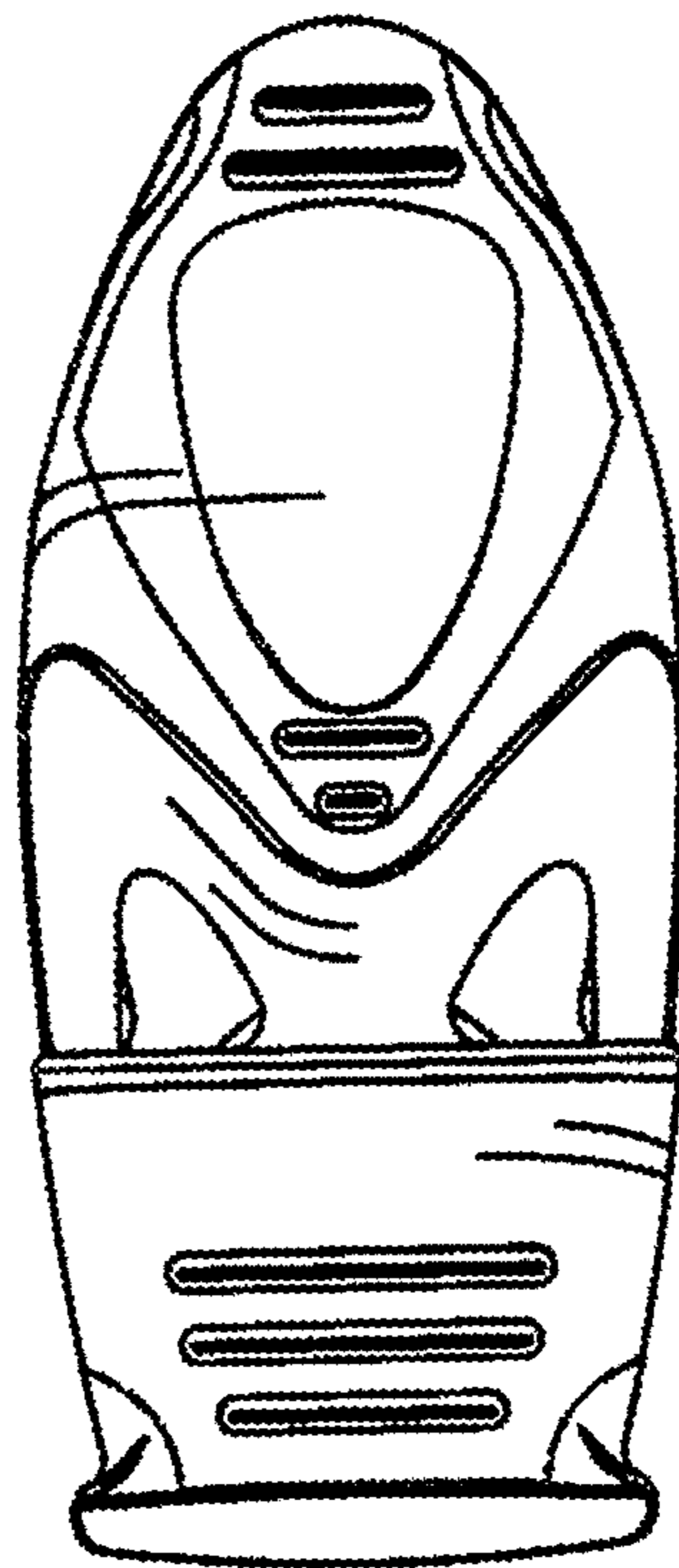

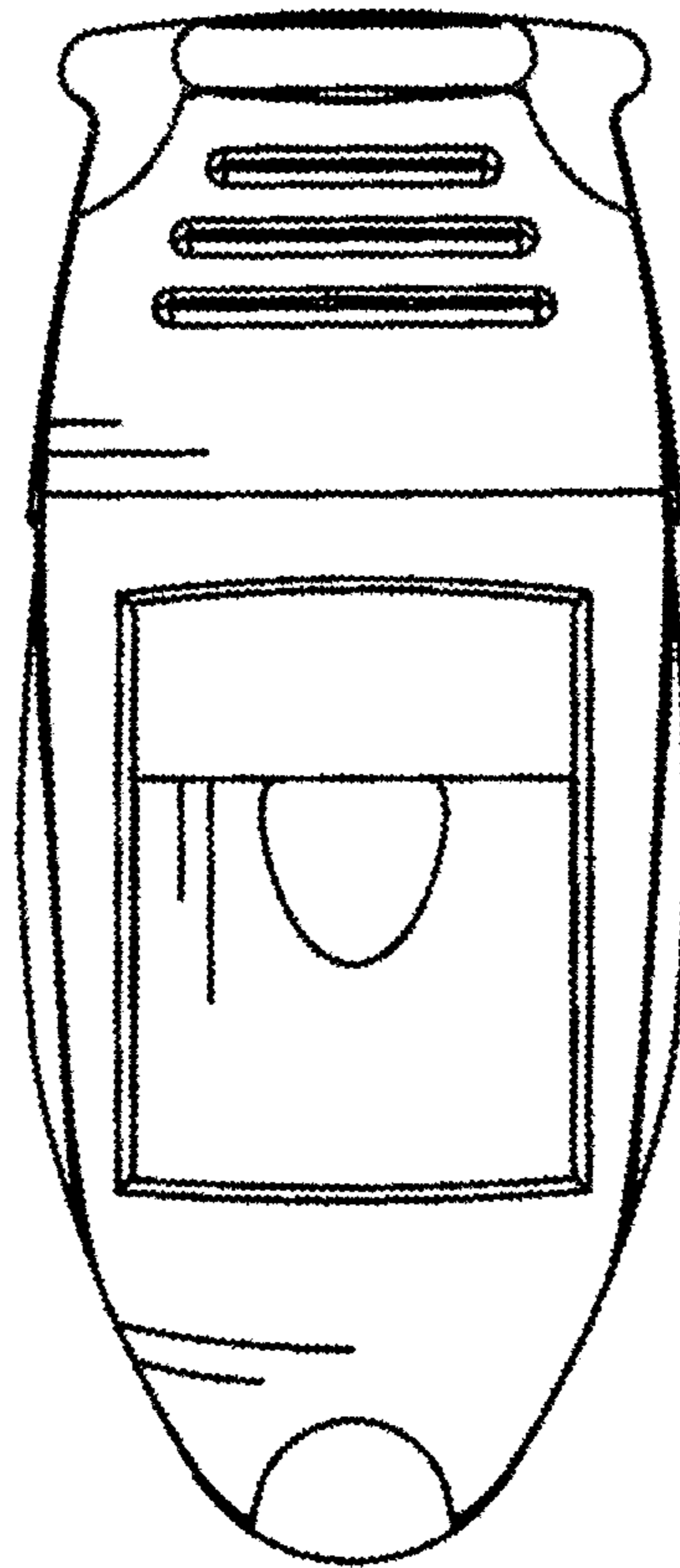

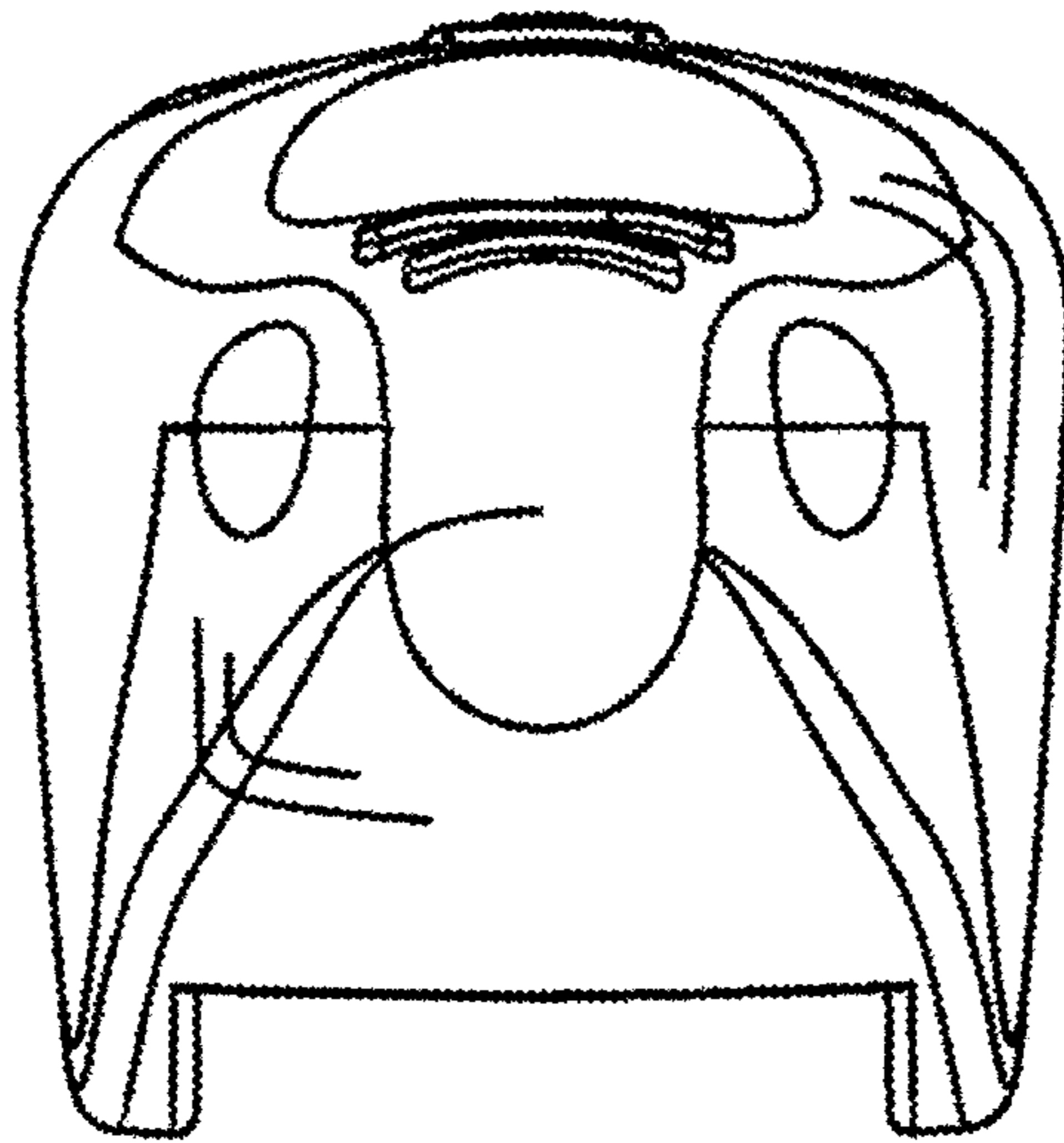

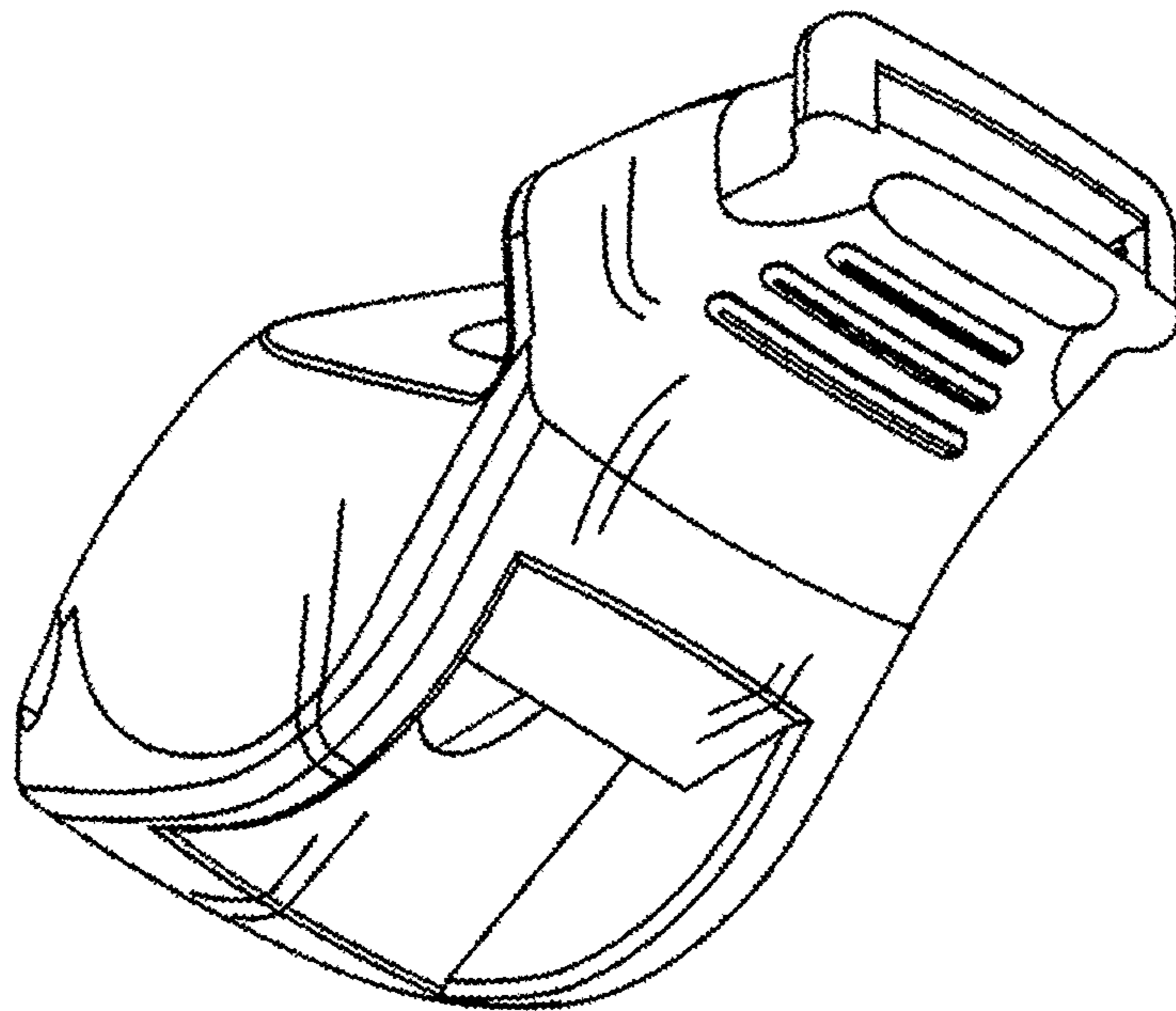

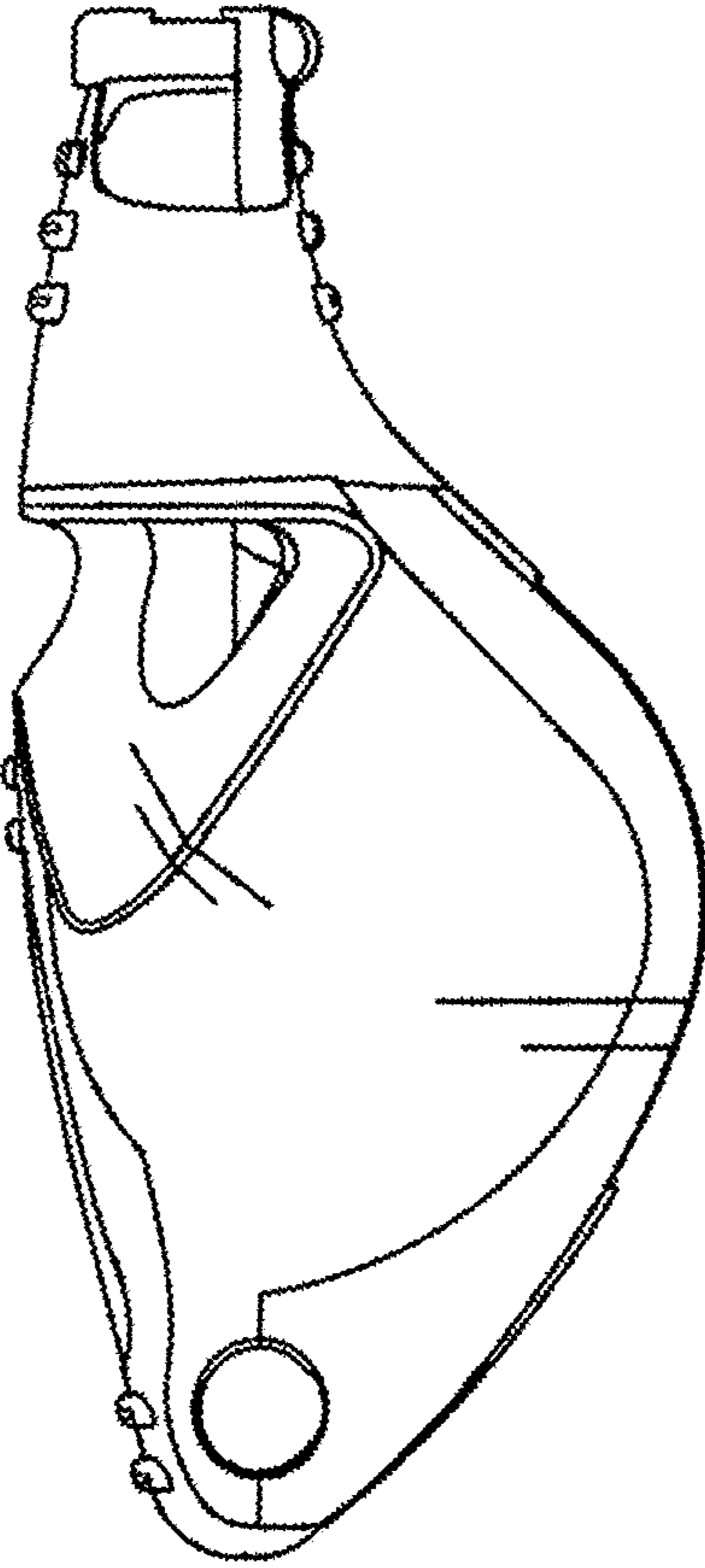

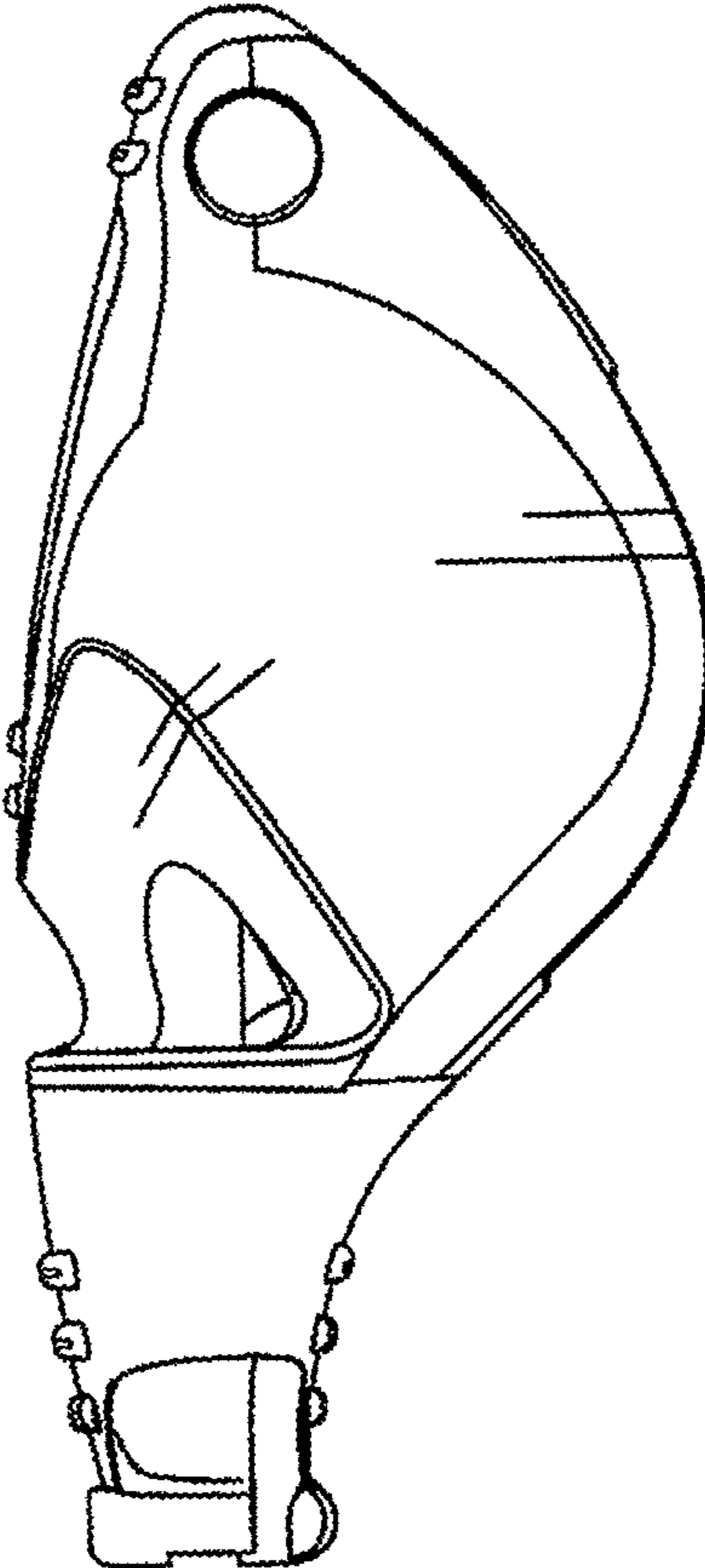
