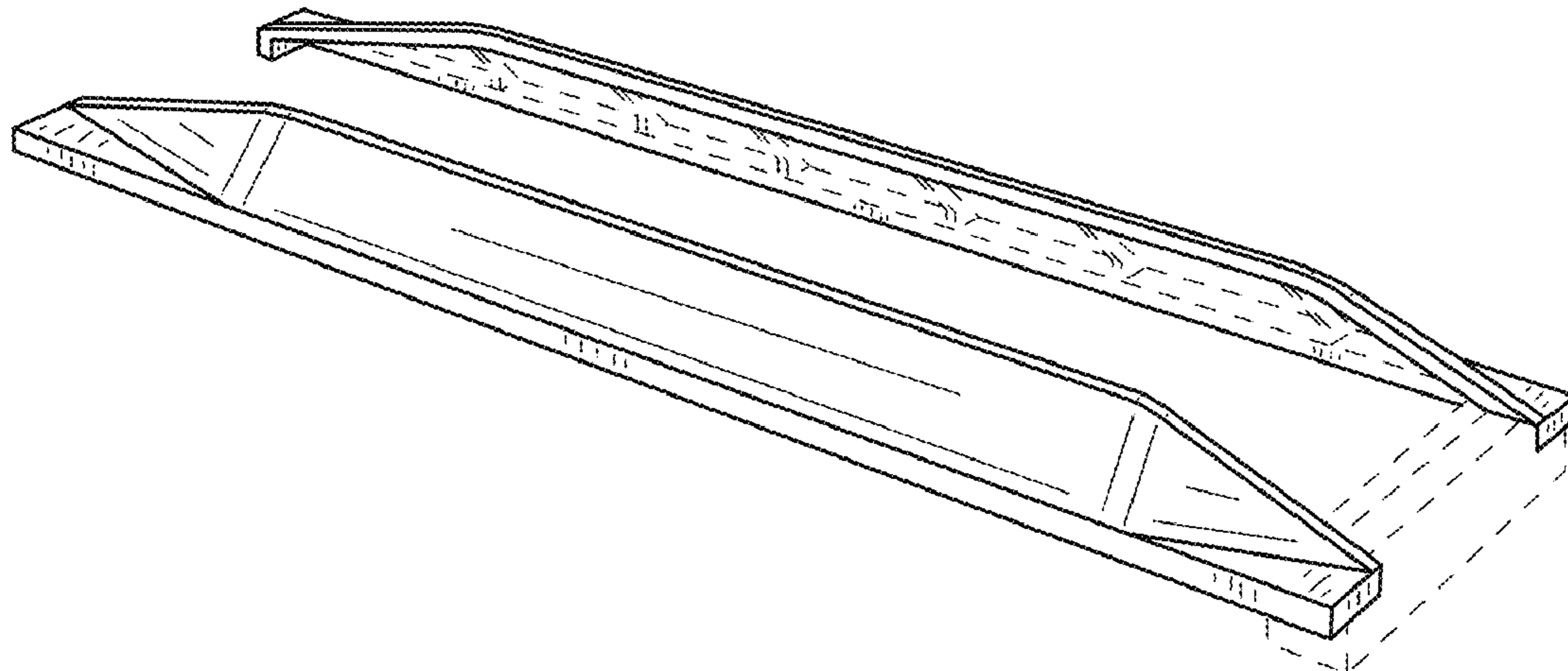
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a rail car cover;
FIG. 2 is front view of the rail car cover of FIG. 1;

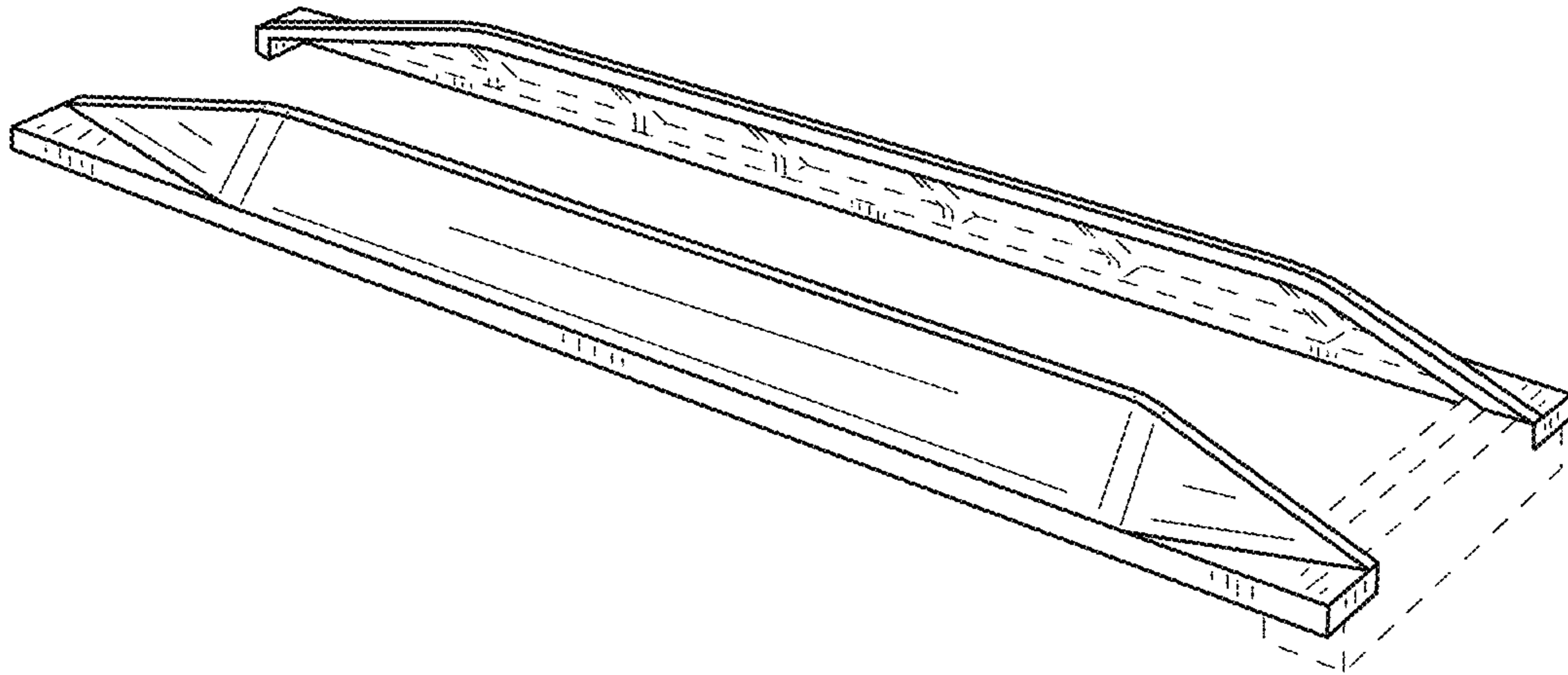

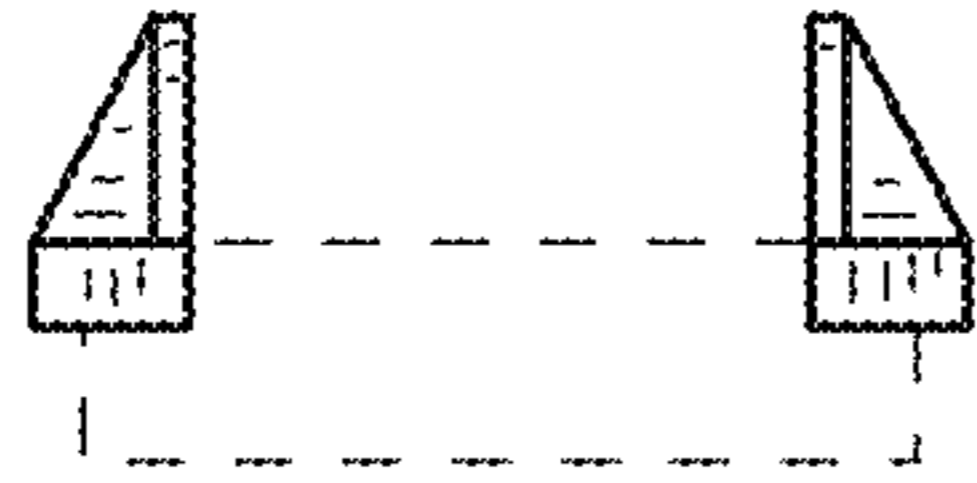

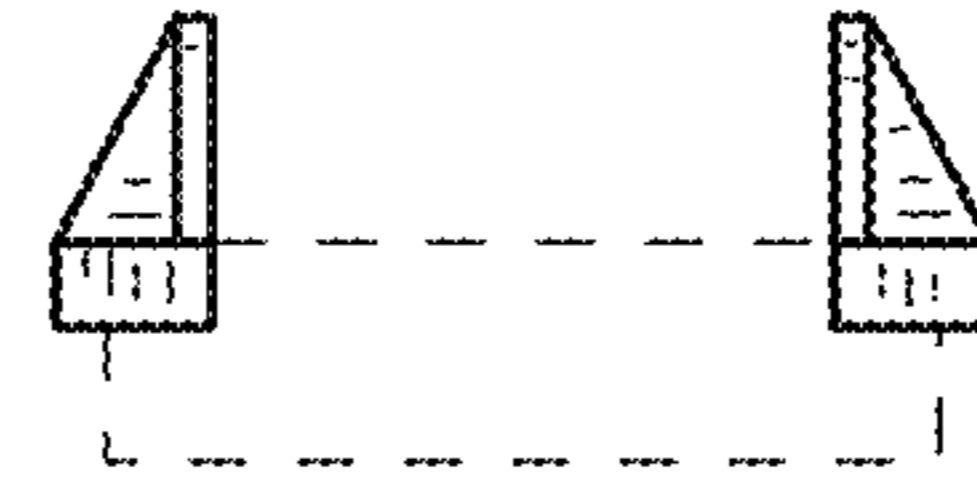

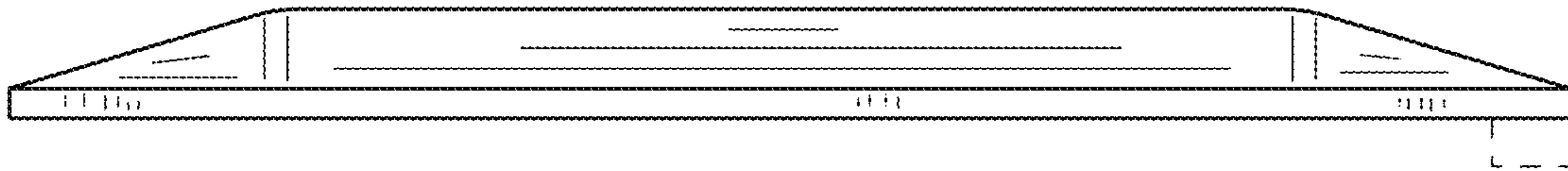

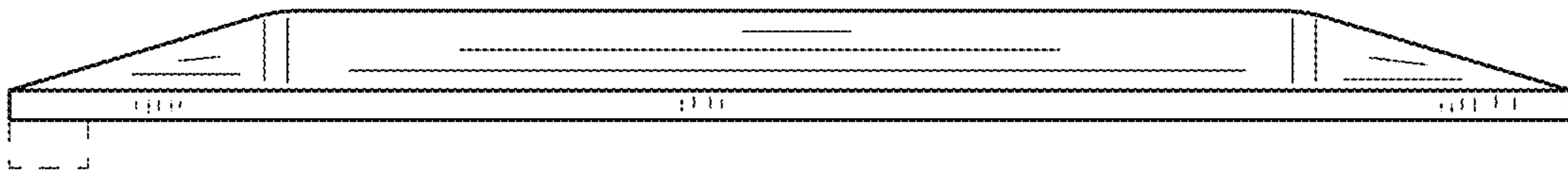

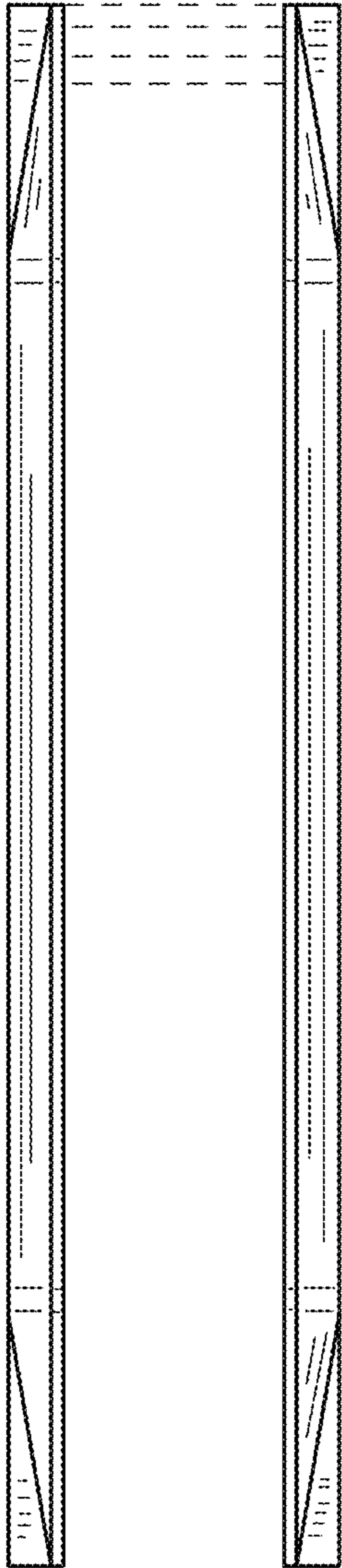

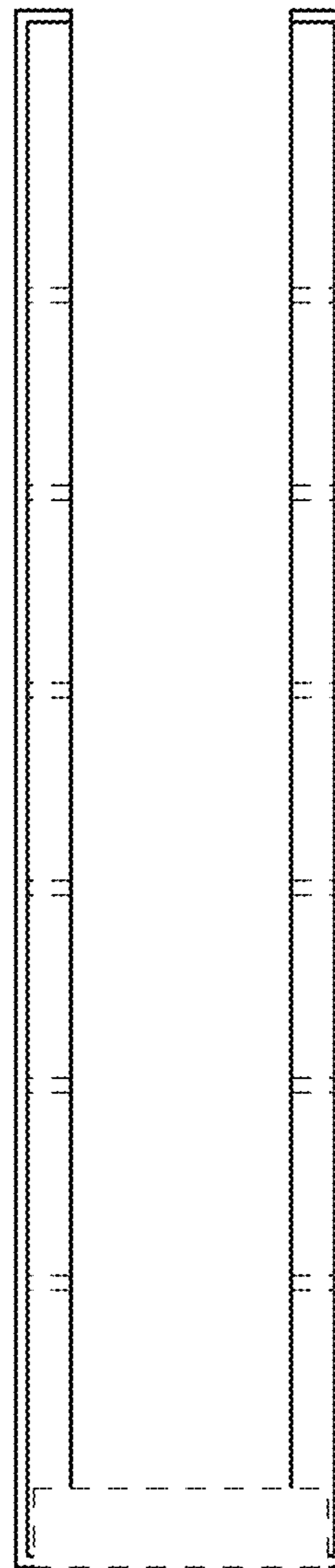

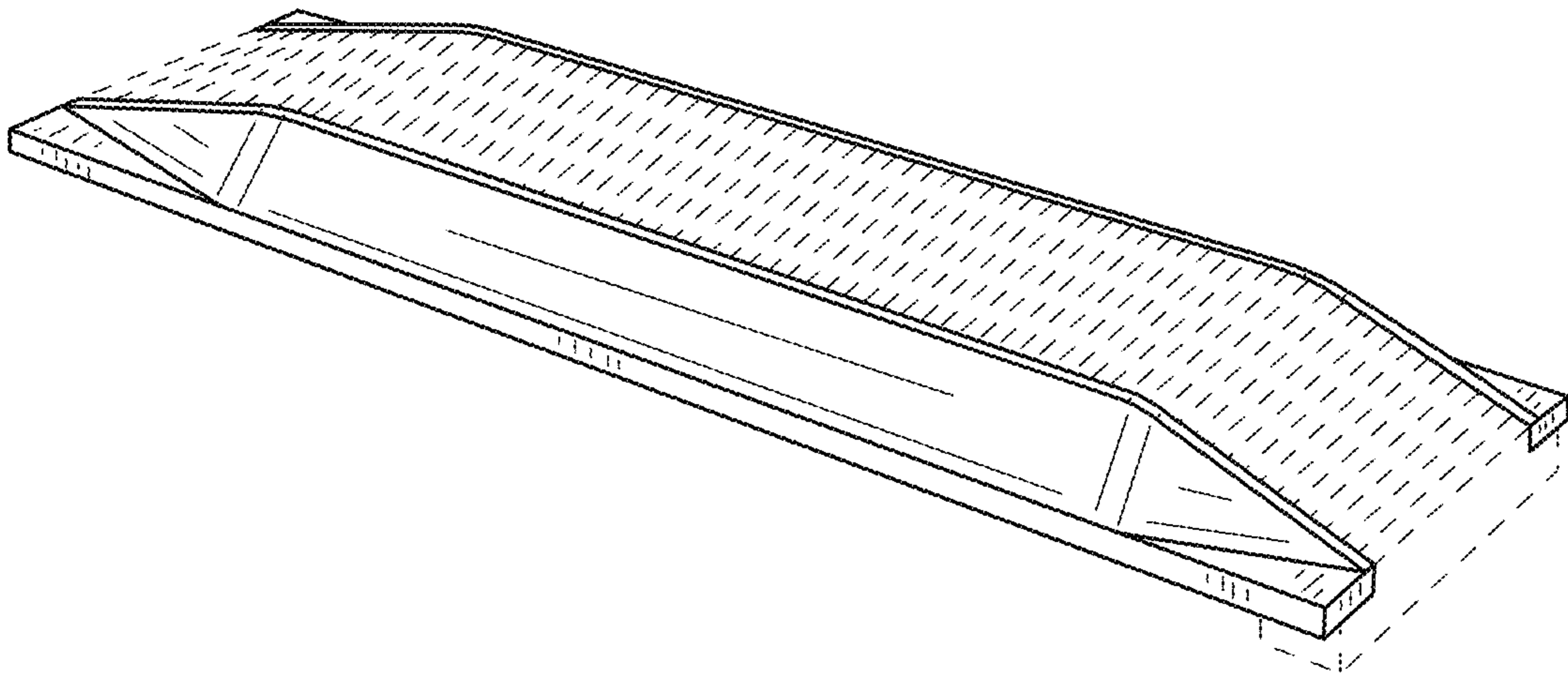

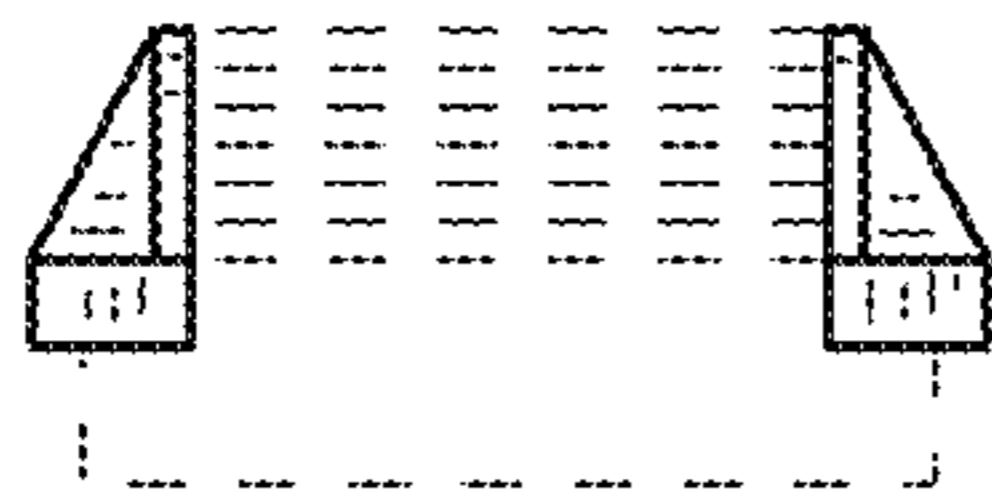

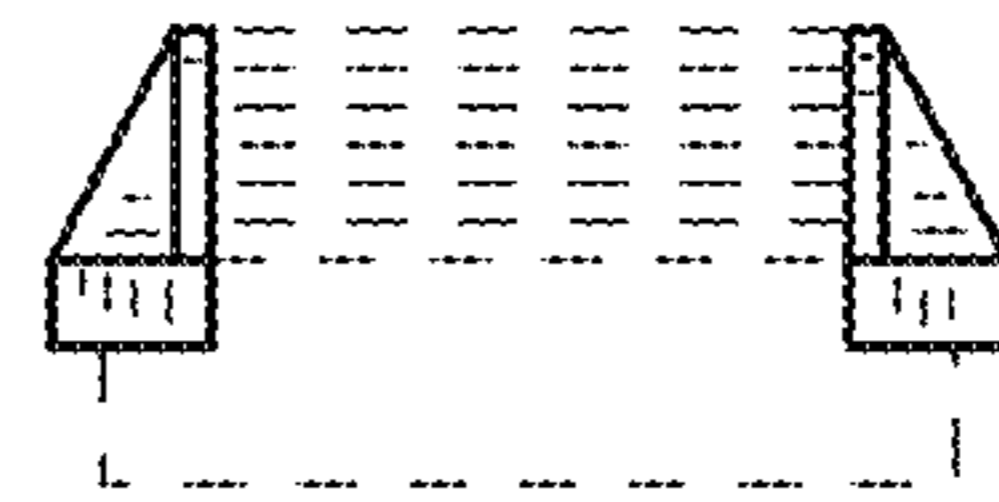

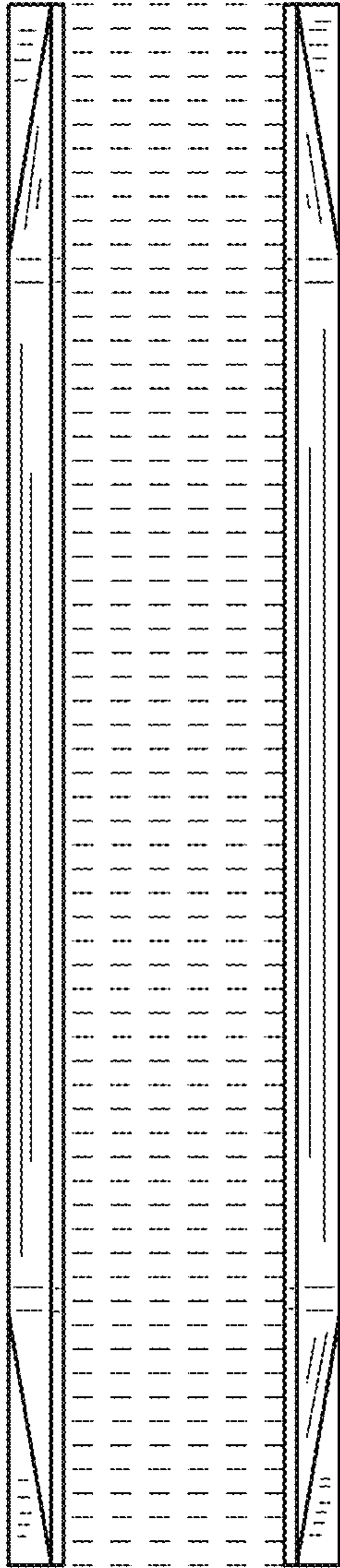

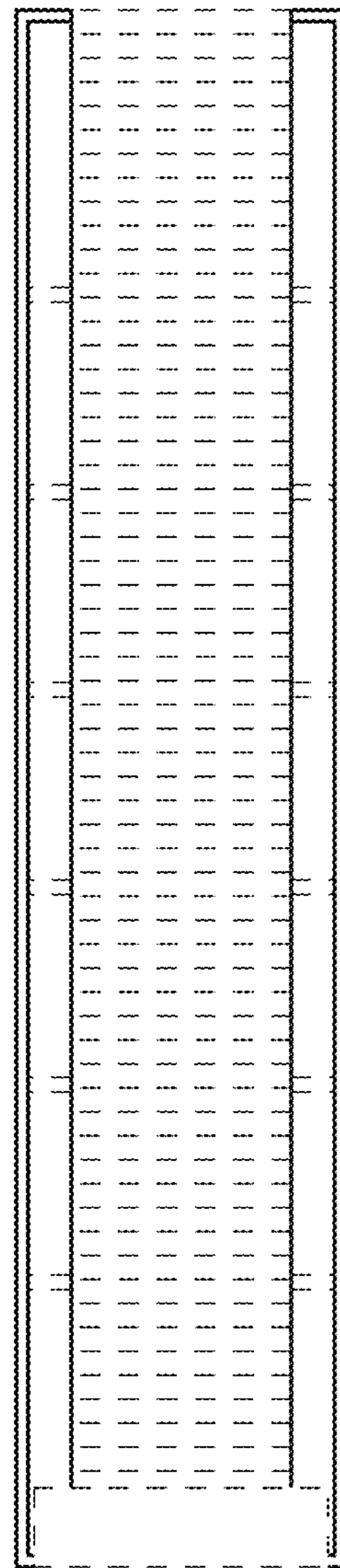

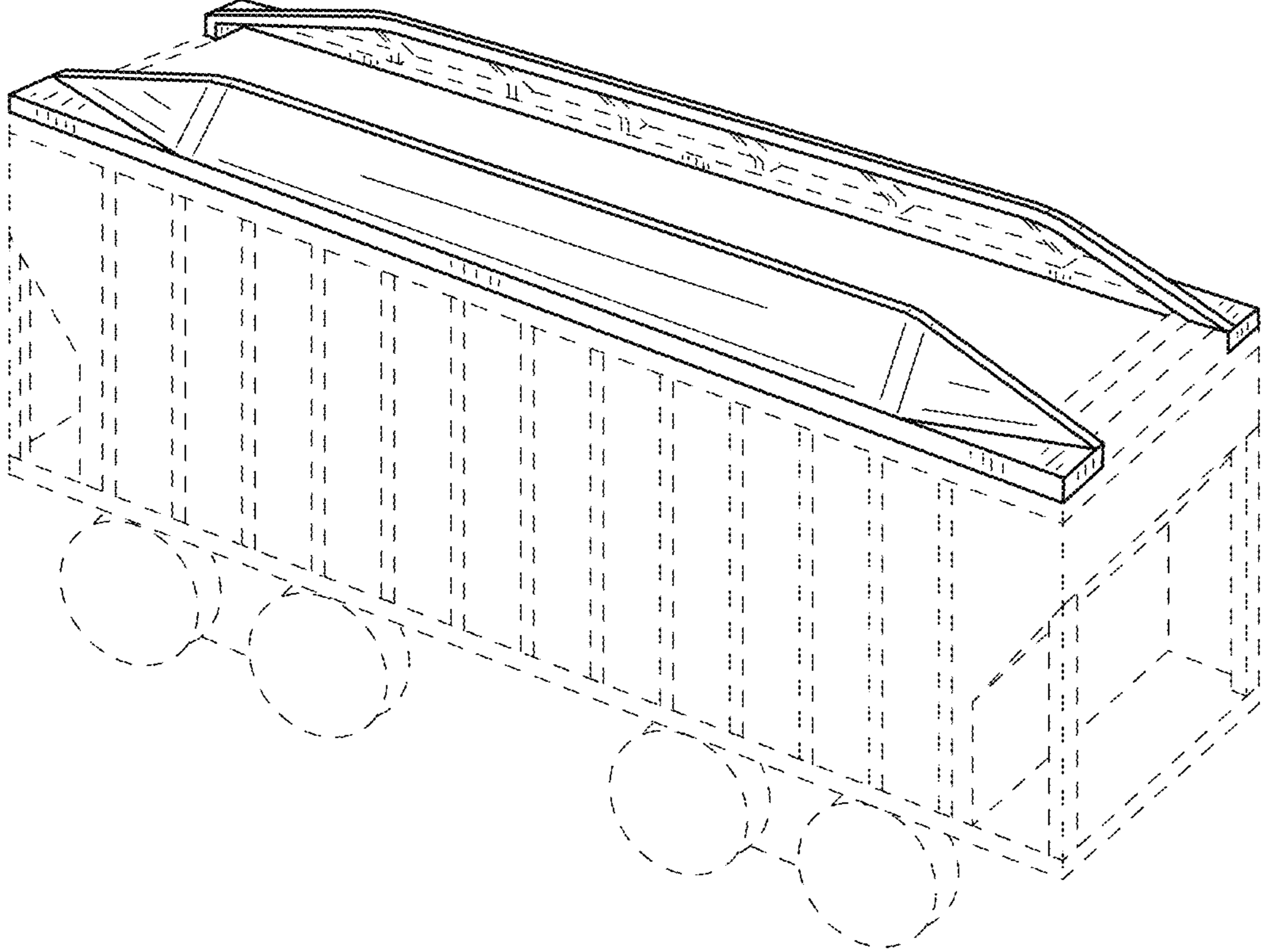

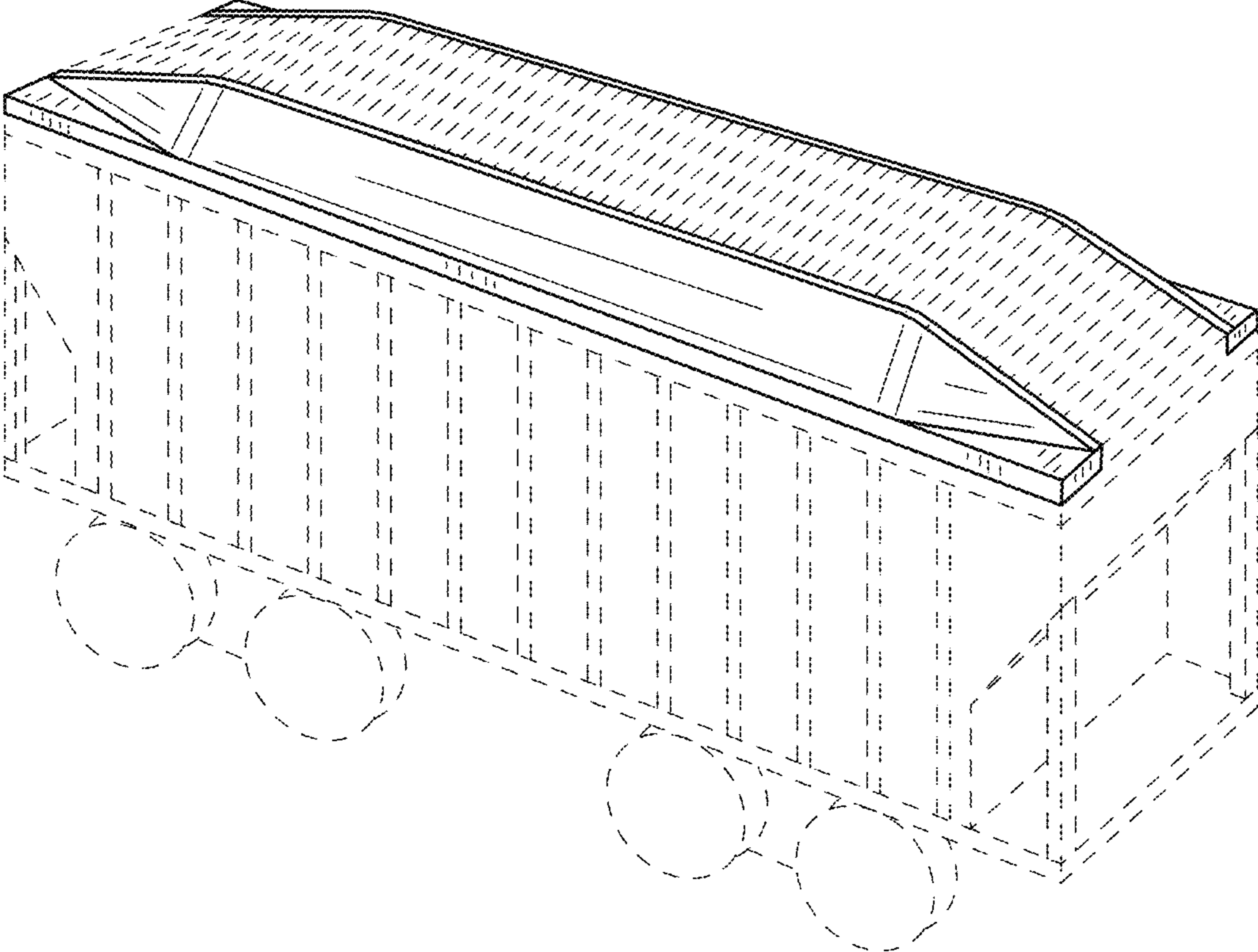
