(57) **CLAIM**

The ornamental design for a license plate frame with basketball motif, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a license plate frame with basketball motif according to the present invention, showing the frame attached to a vehicle and holding a license plate.

FIG. 7 is a left side elevation thereof.

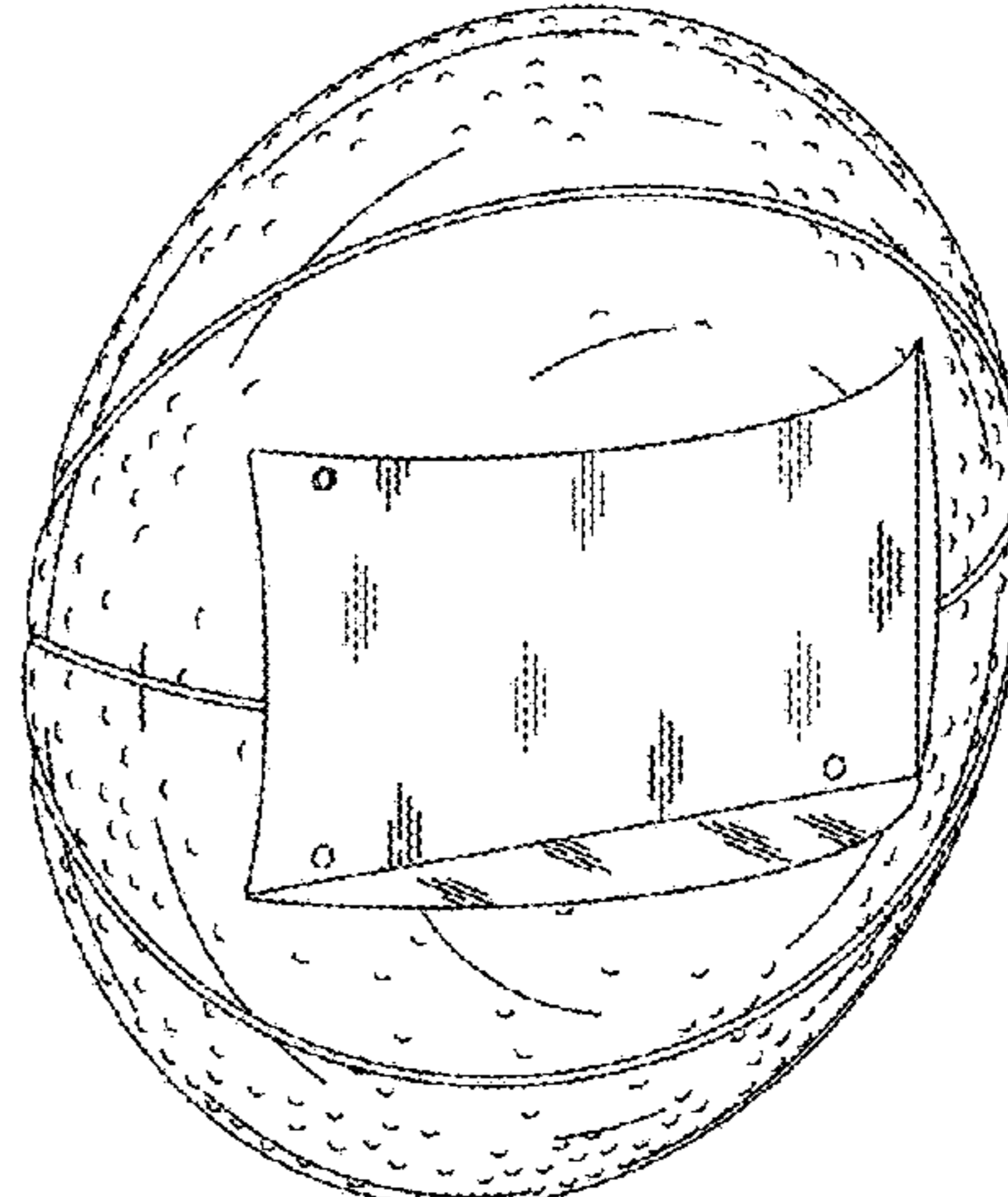
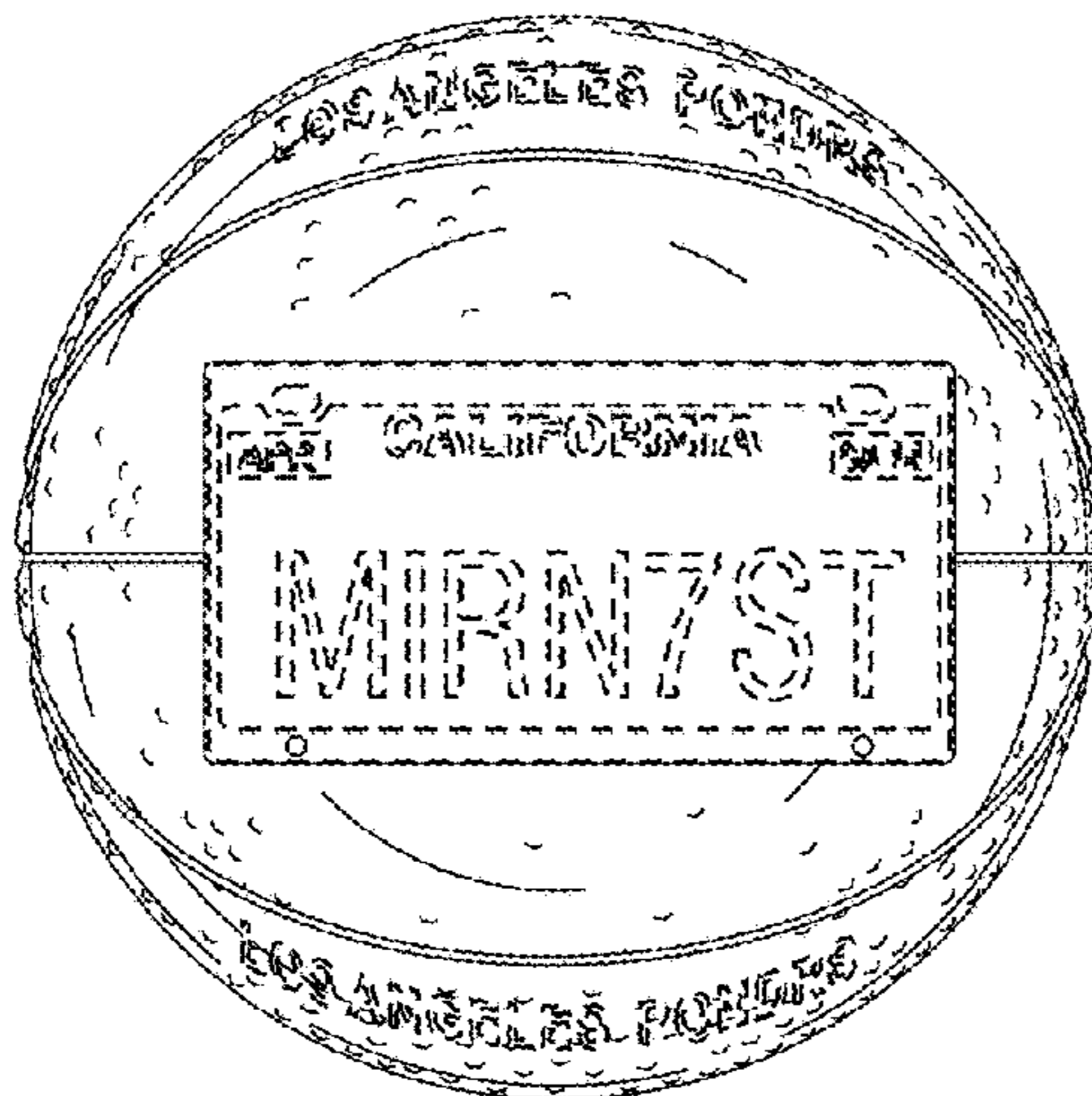
FIG. 8 is a right side elevation view thereof.

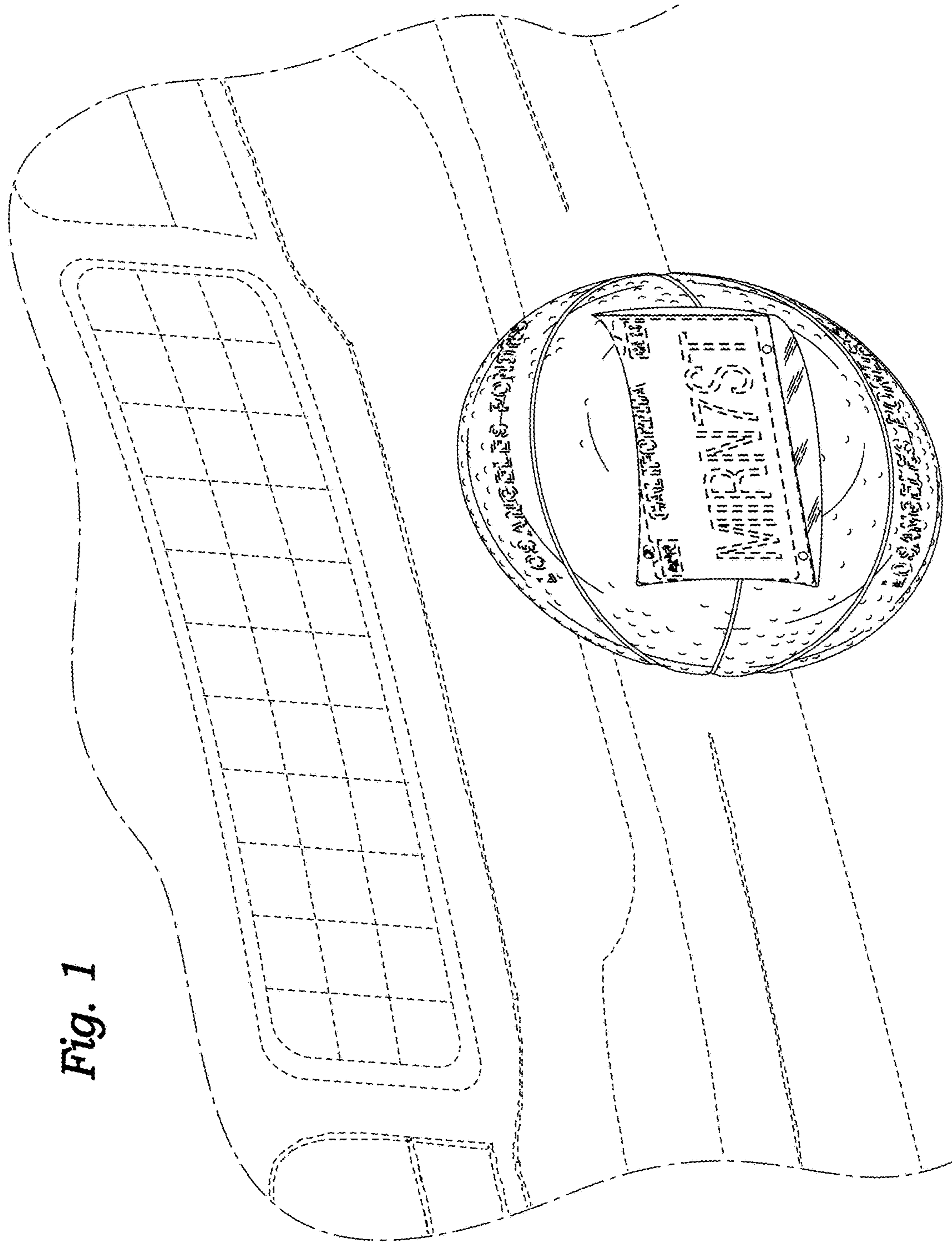

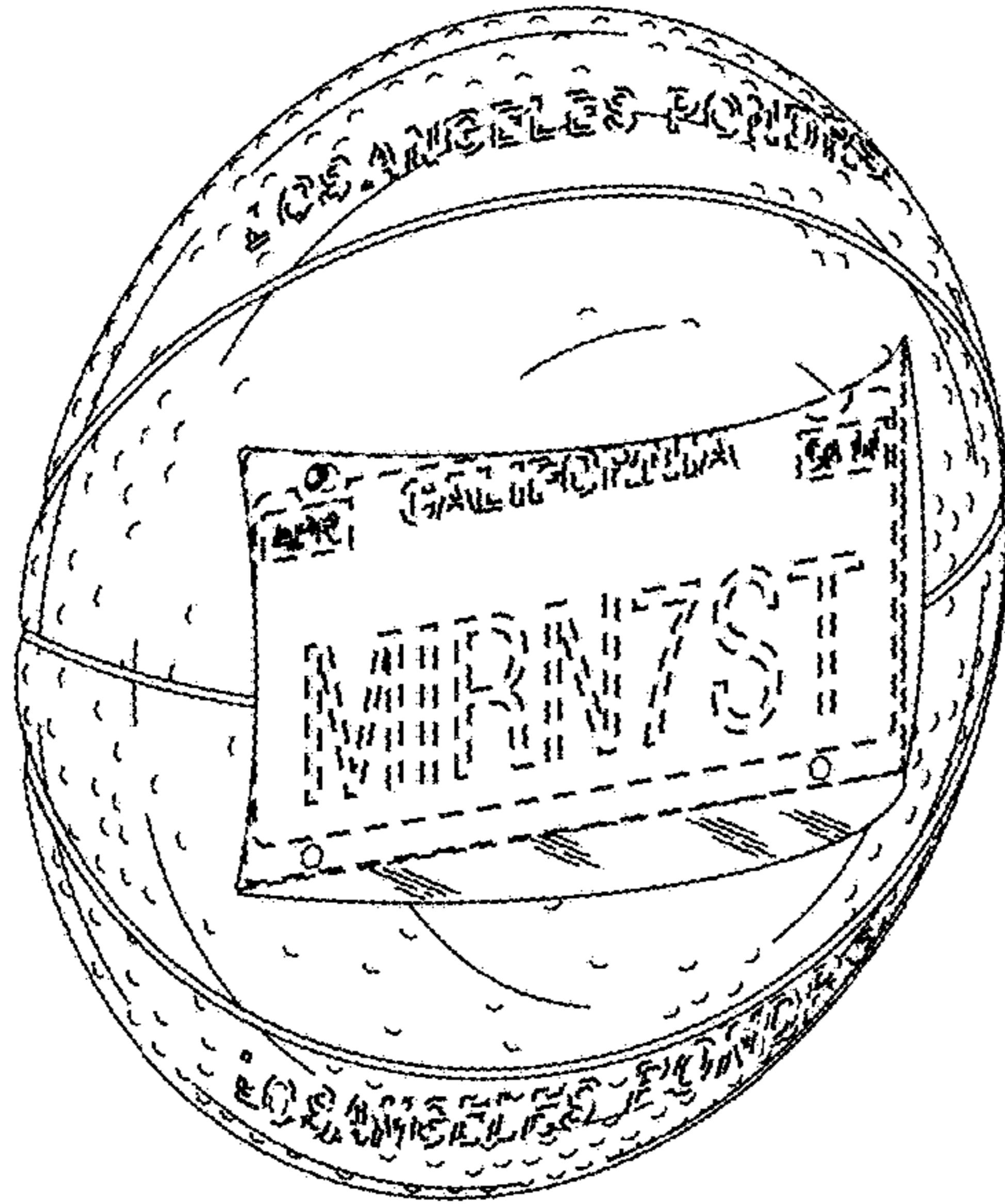

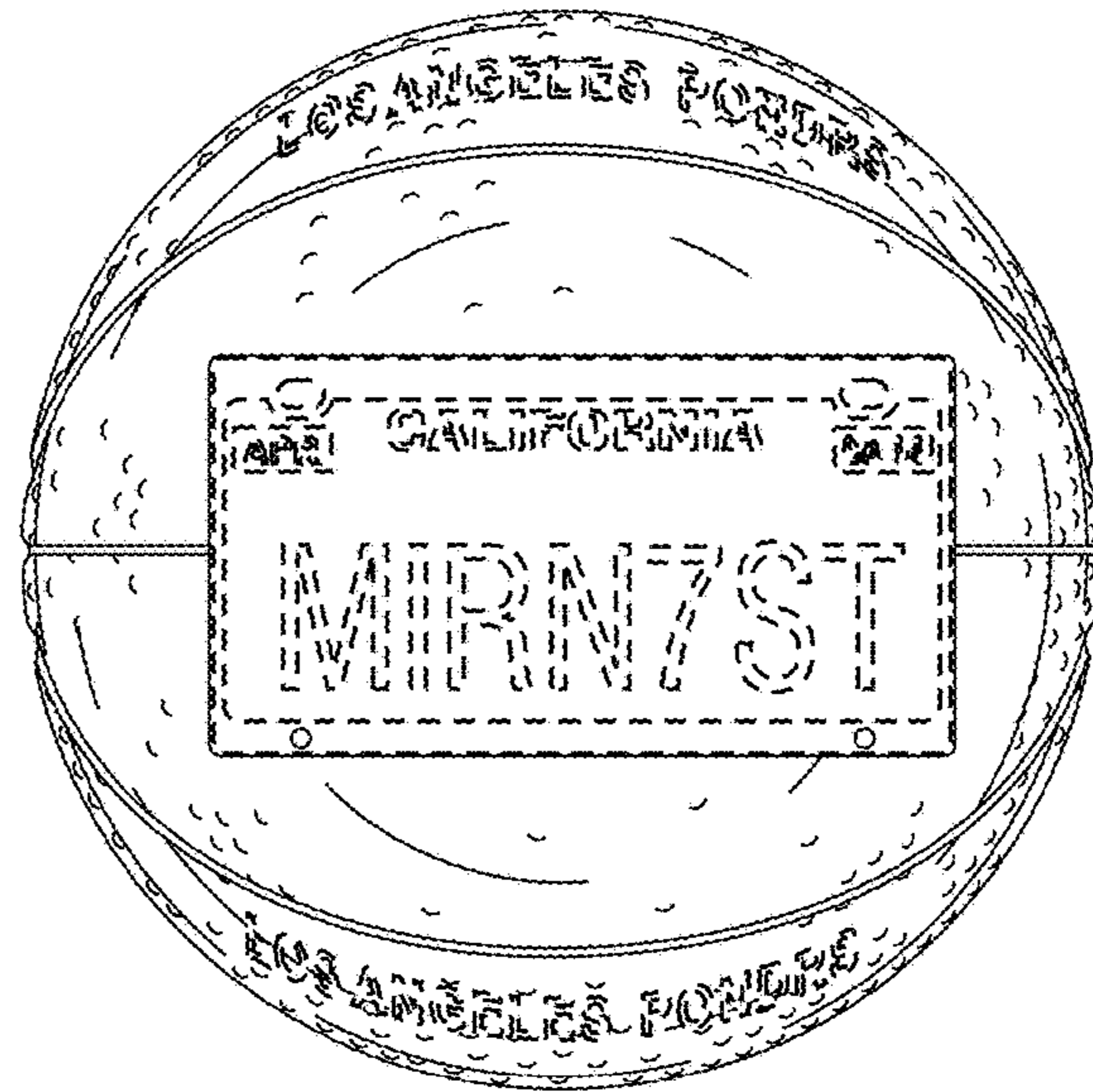
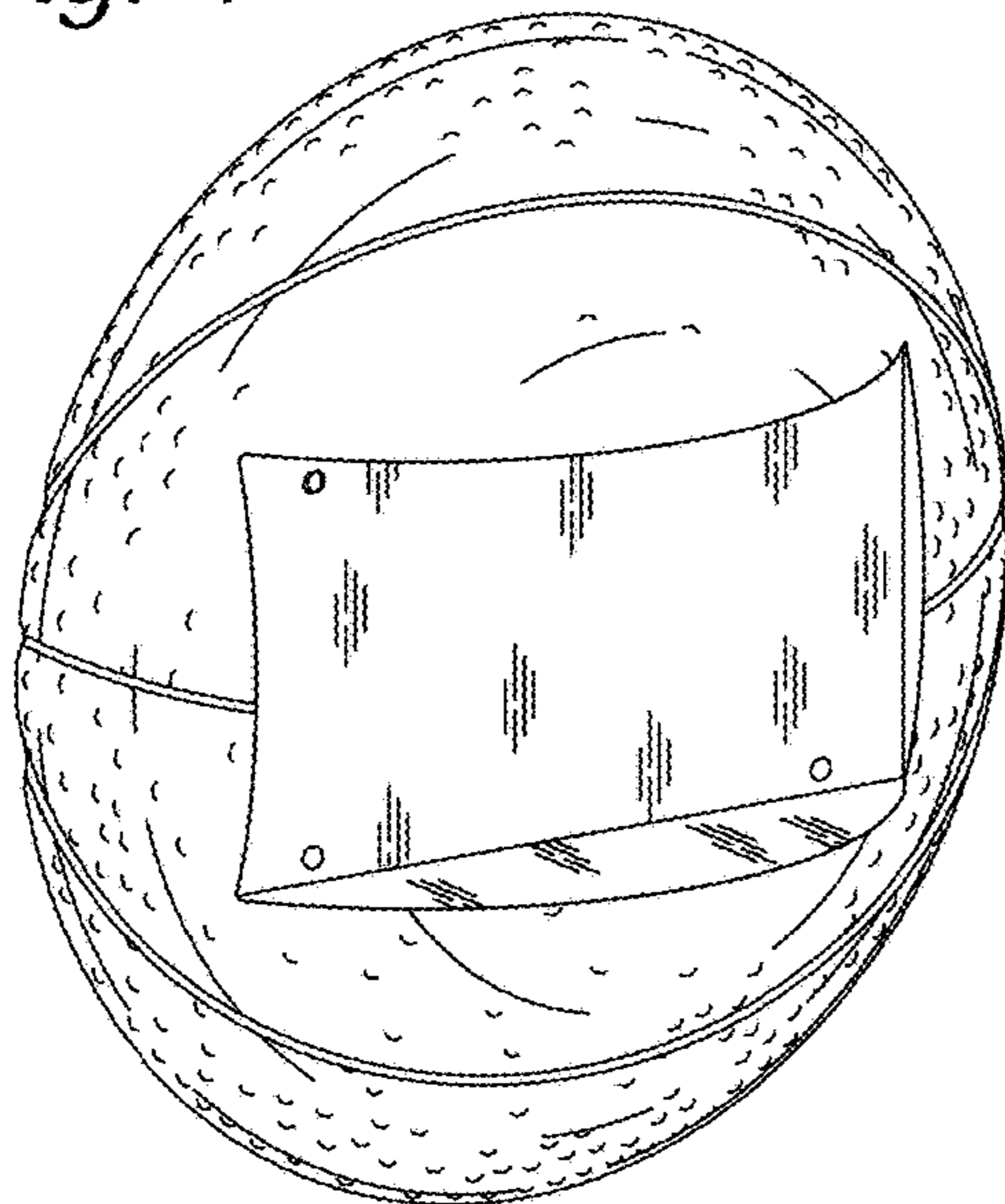
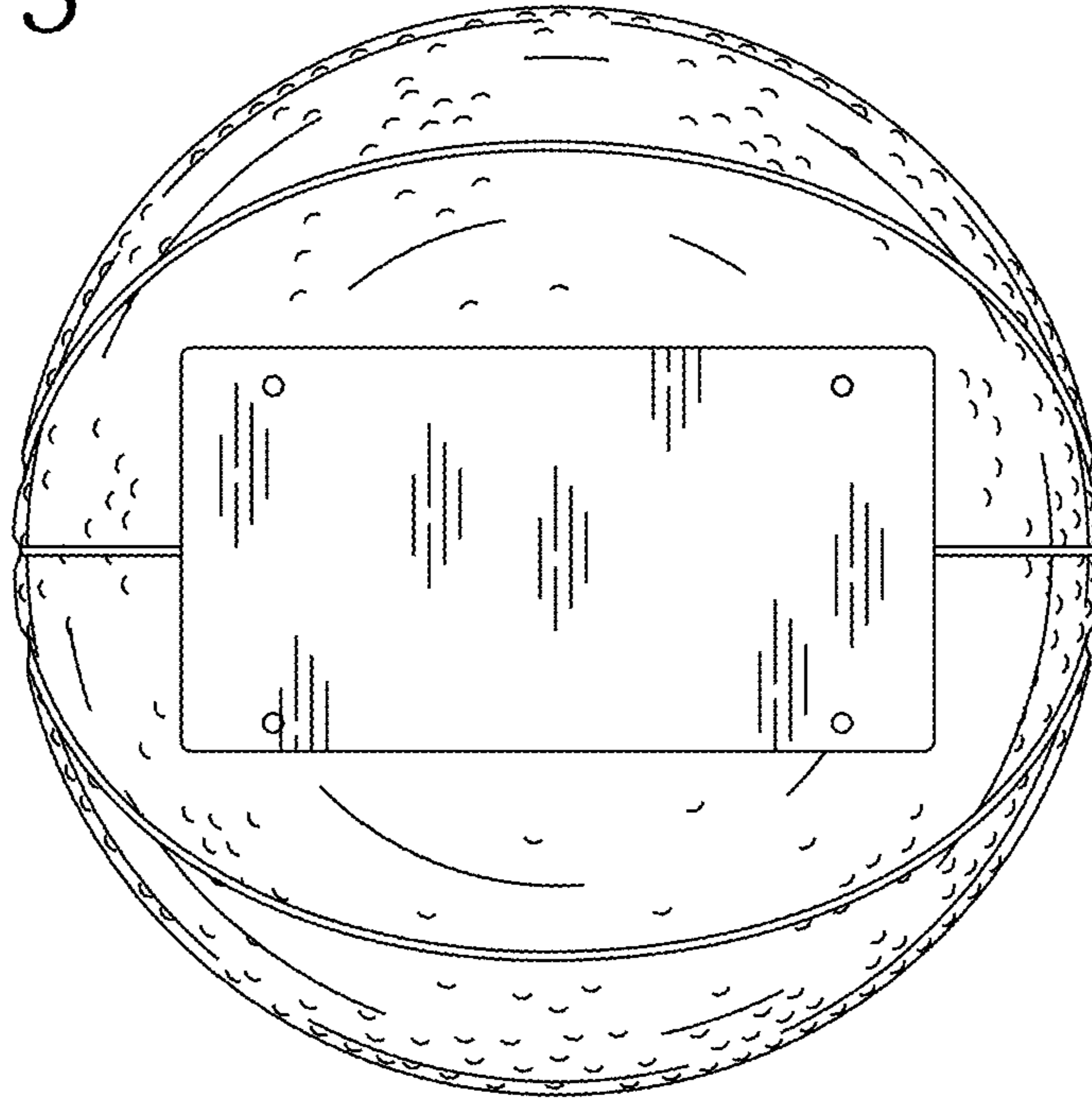


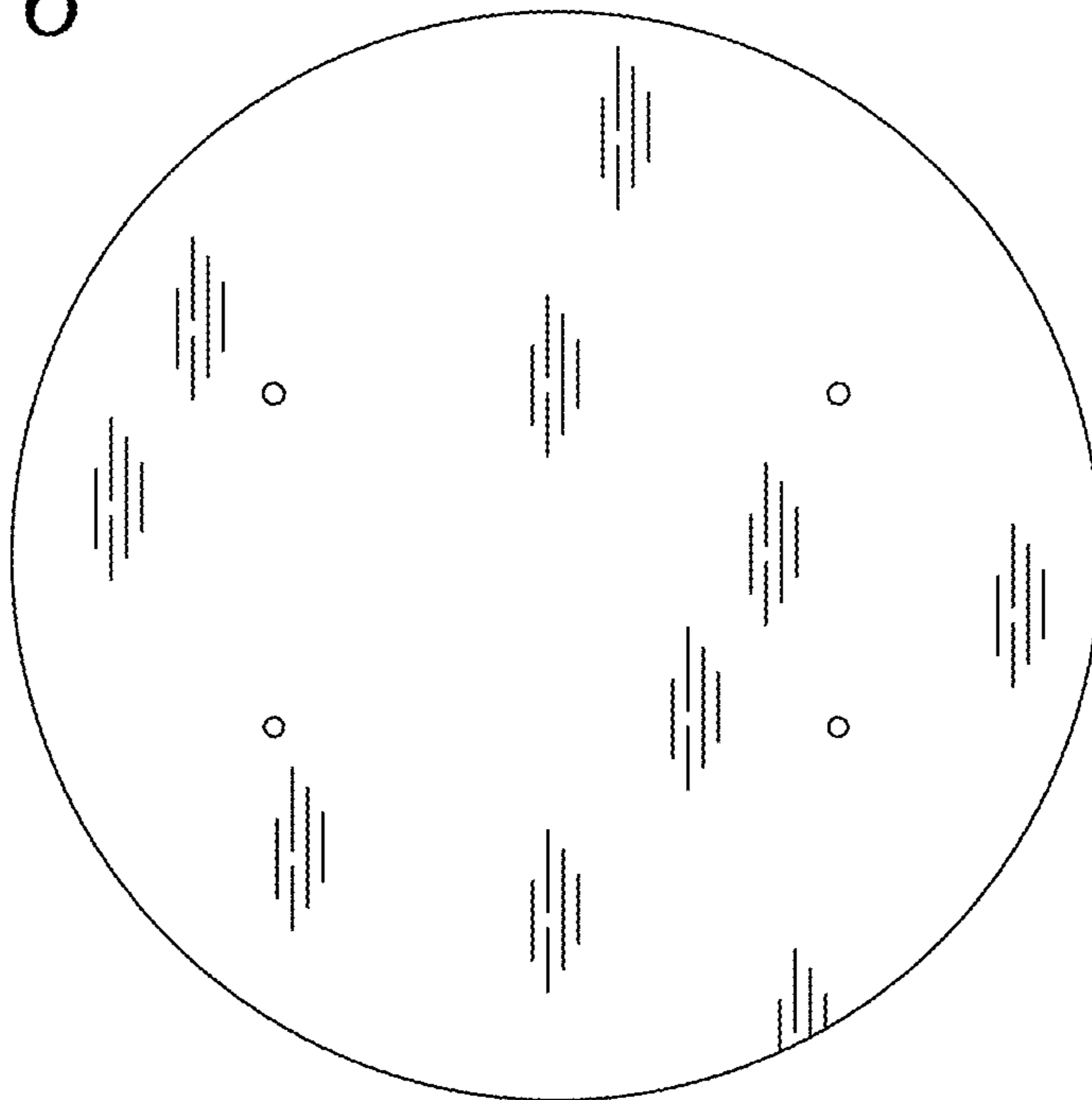

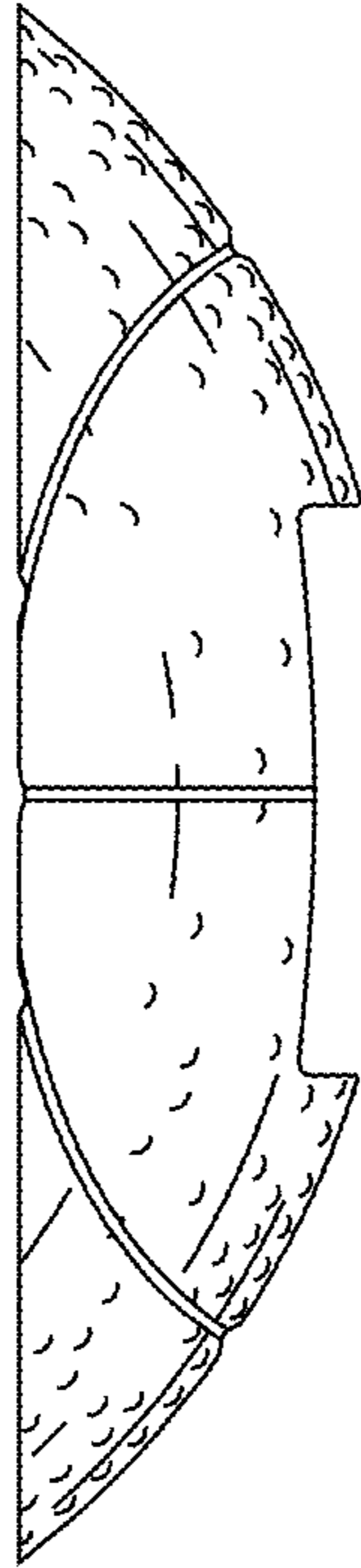

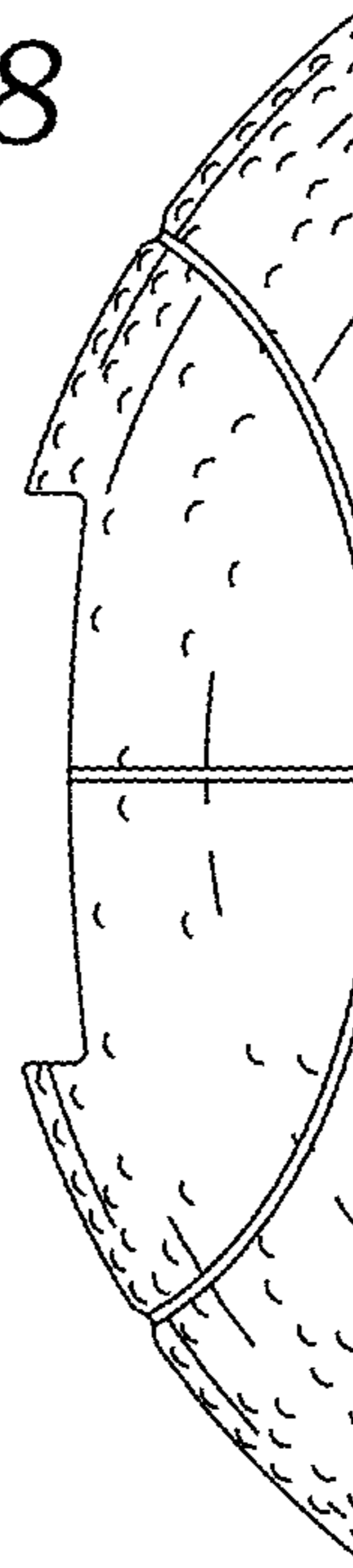

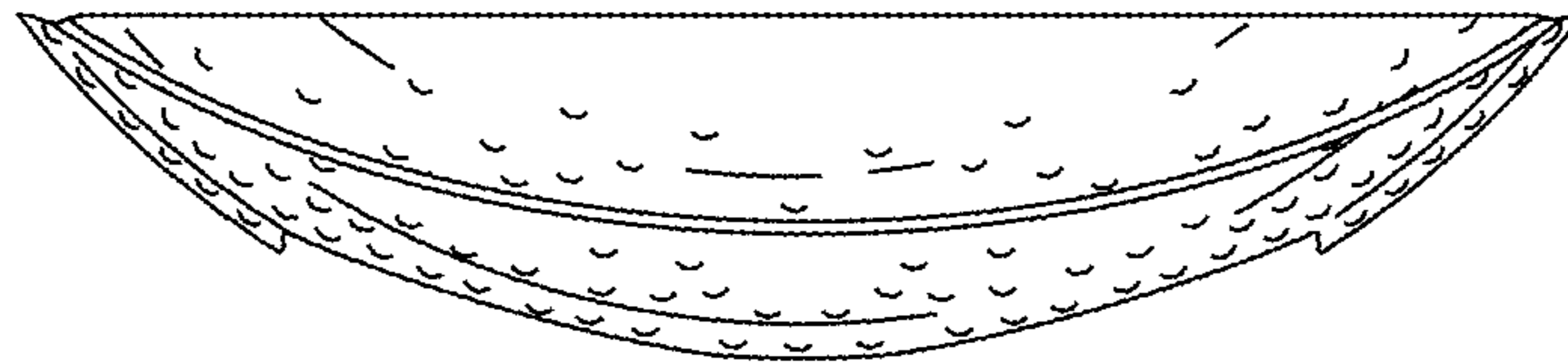
