The ornamental design for a case for an electronic device, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an embodiment of a case for an  
electronic device with a front cover in a closed position.  
FIG. 2 is a top view of the embodiment thereof.  
FIG. 3 is a left side view the embodiment thereof.  
FIG. 4 is a right side view of the embodiment thereof.  
FIG. 5 is a bottom view of the embodiment thereof.

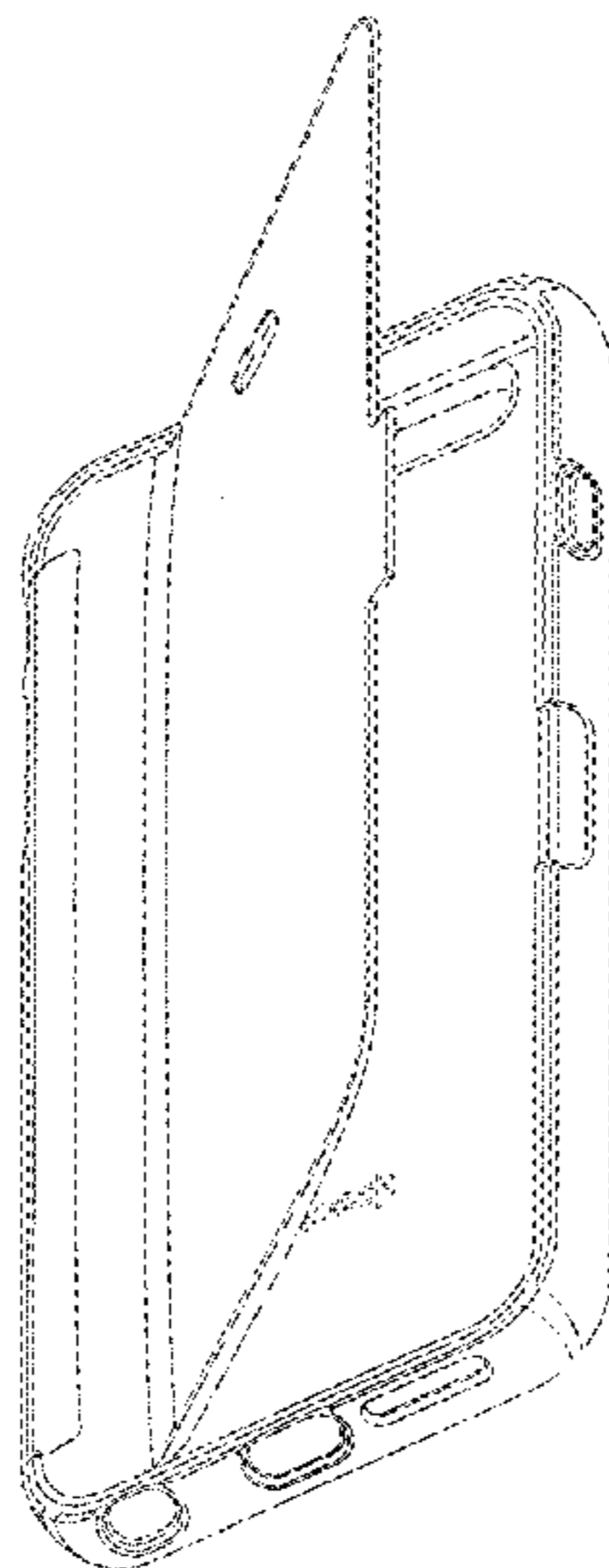

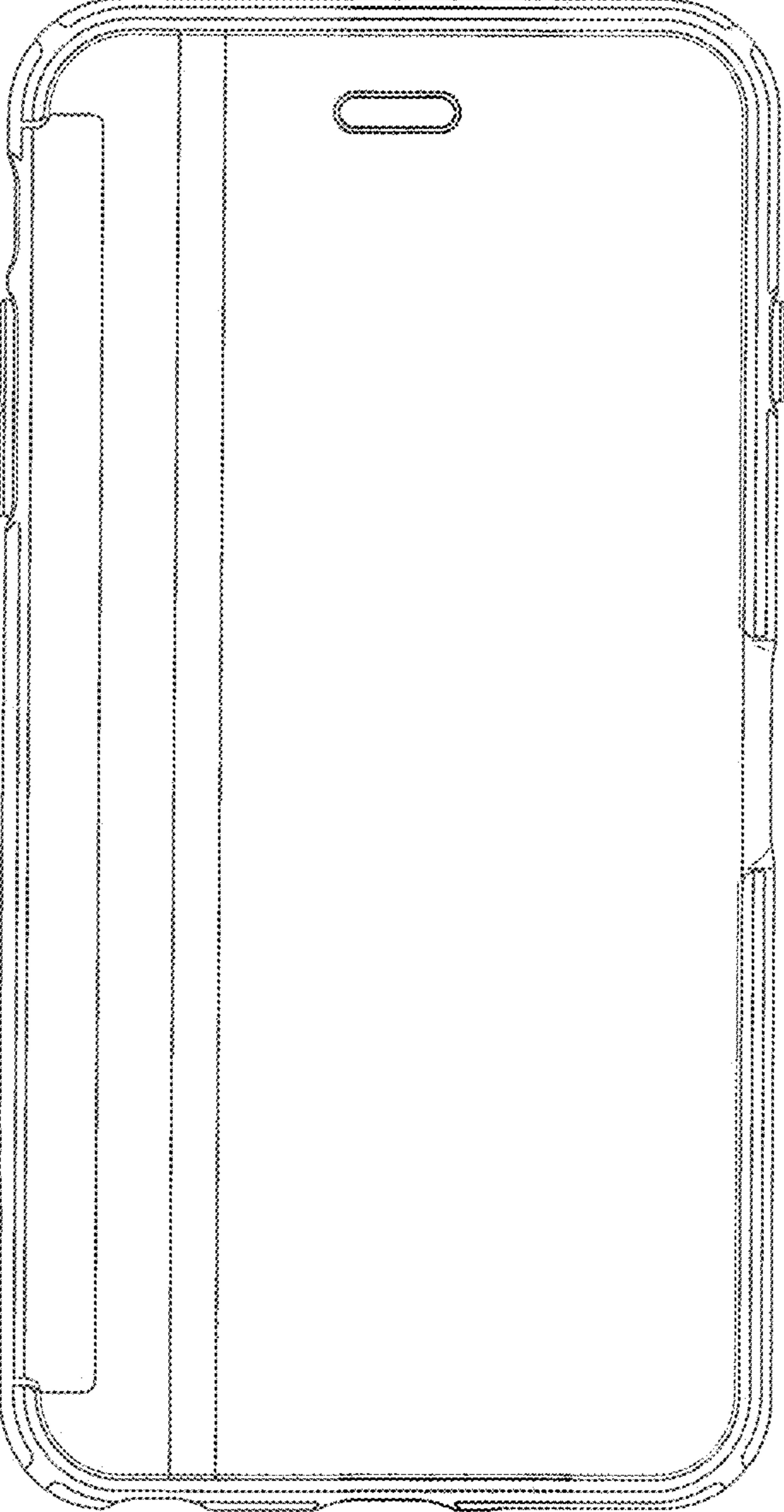
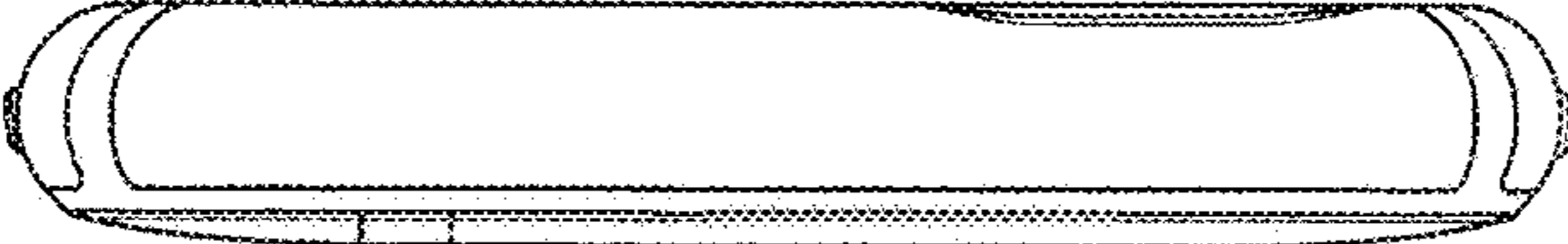

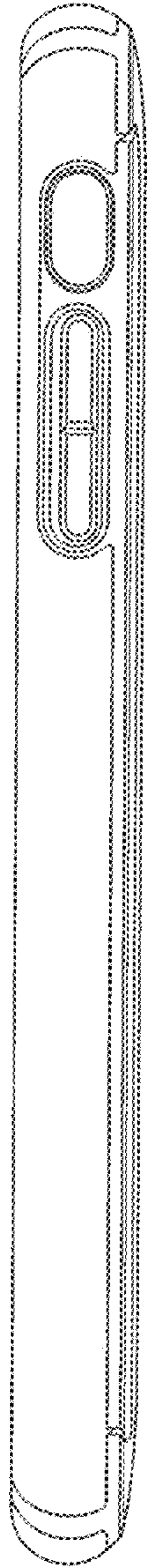

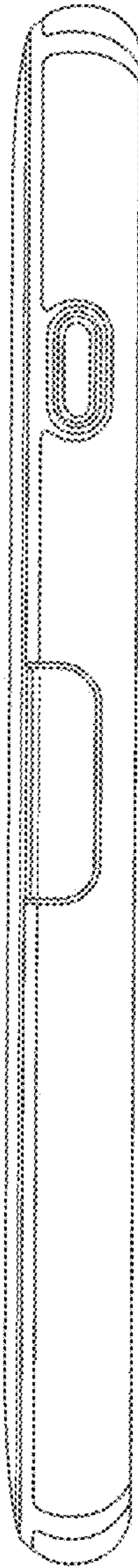

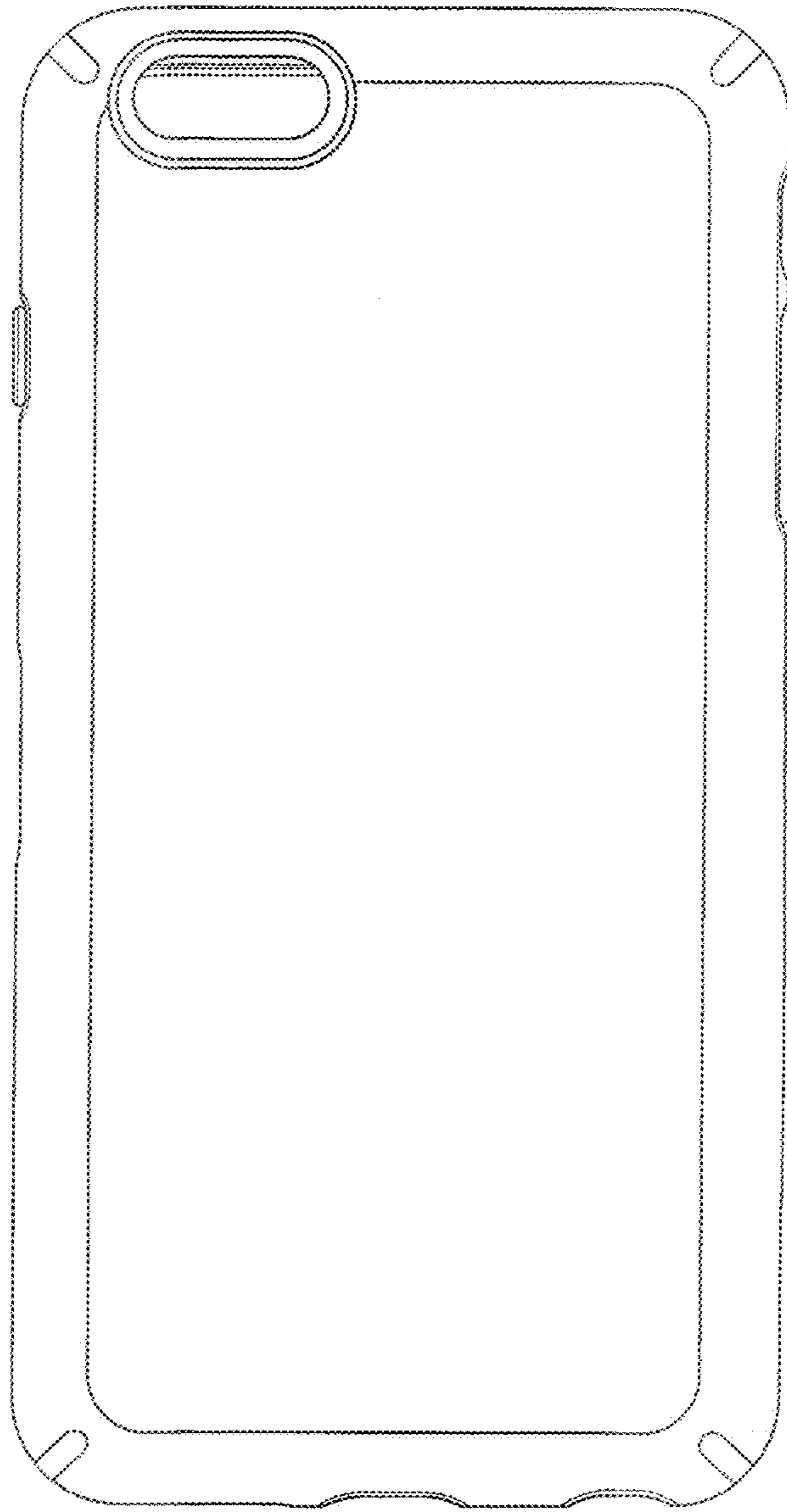

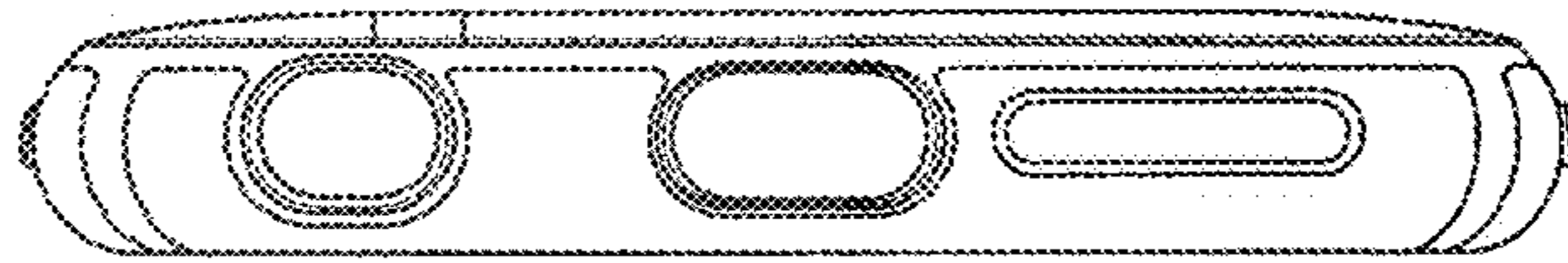

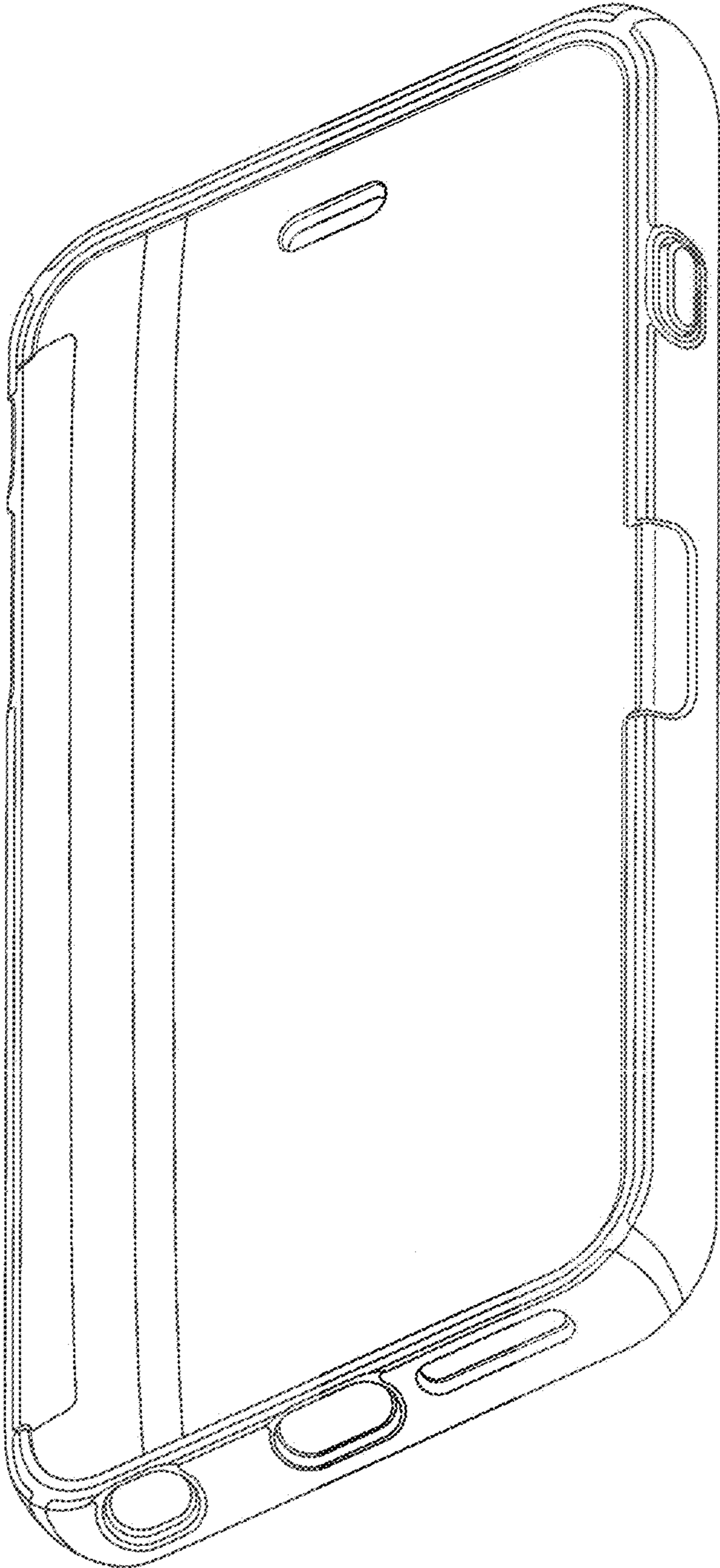

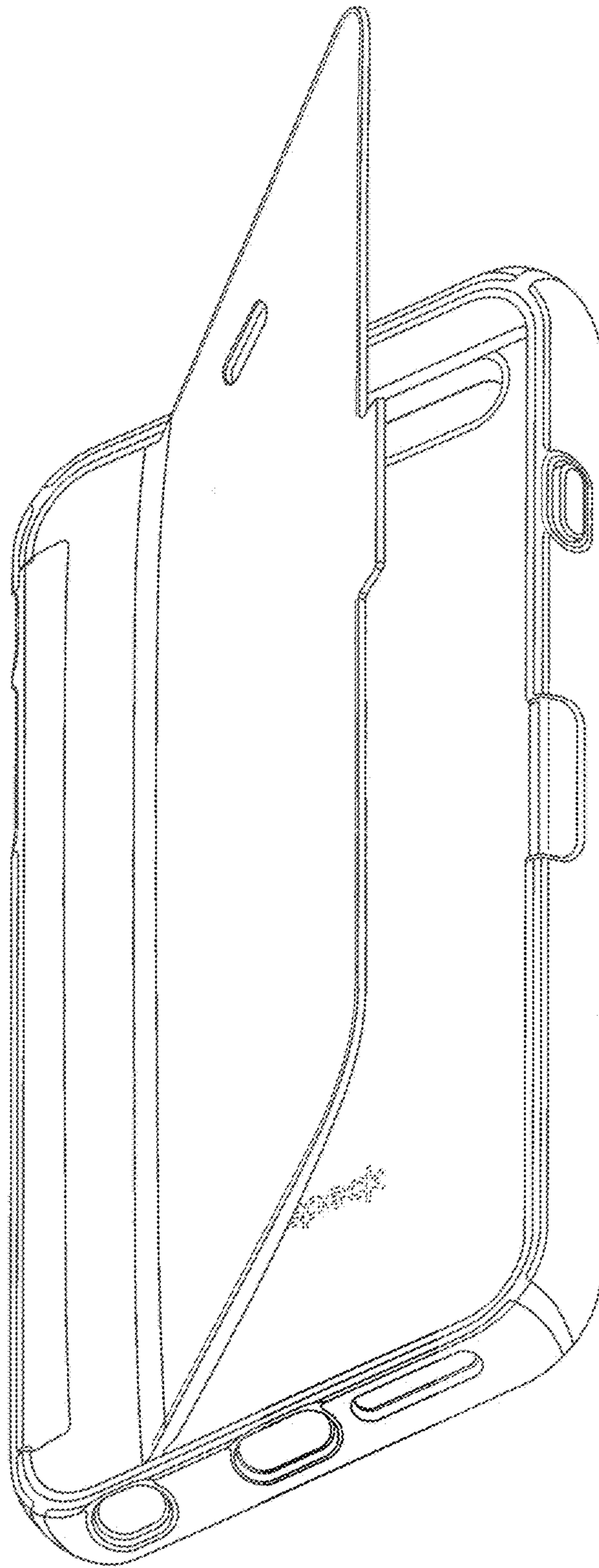

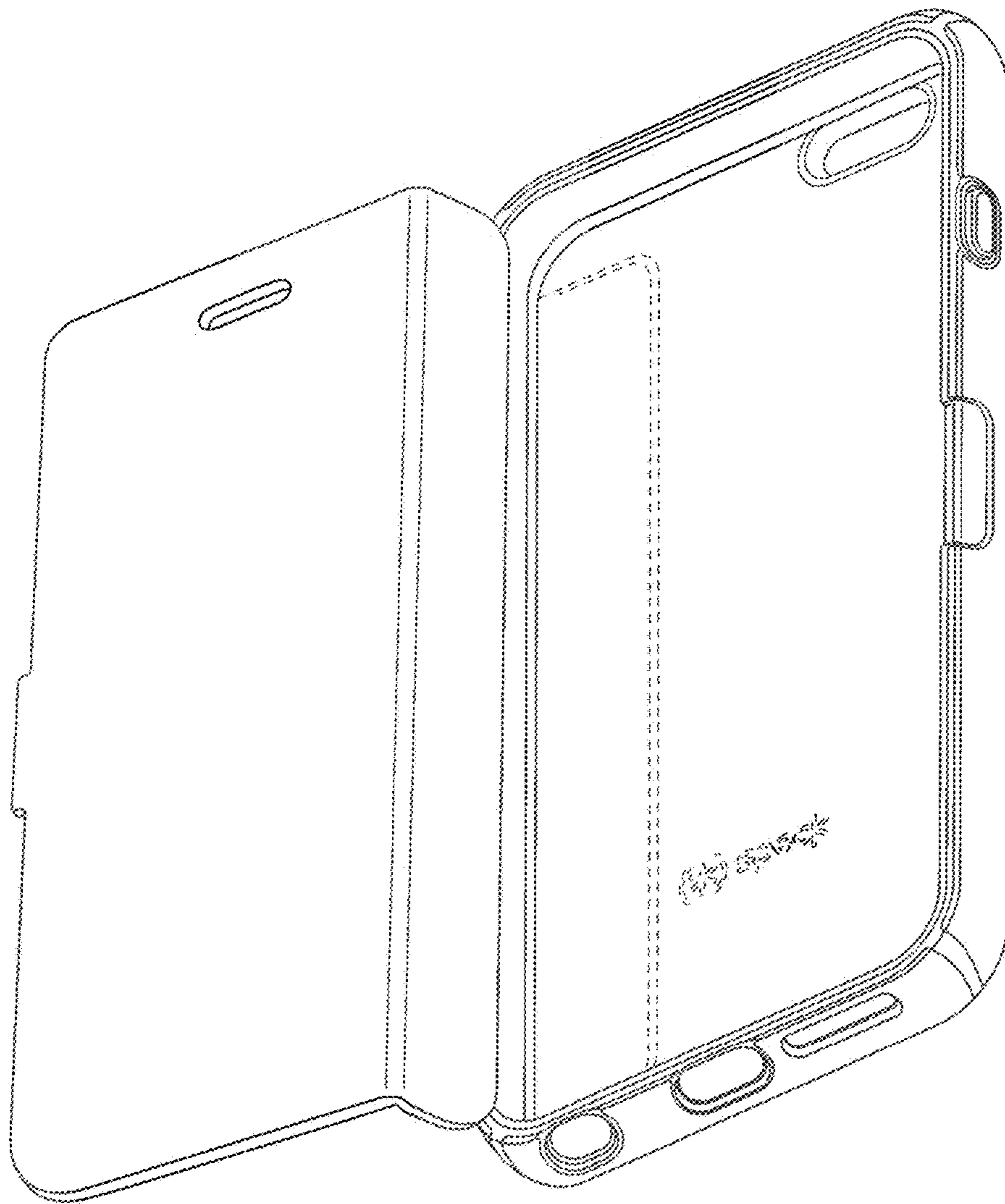
