FIG. 2 is a front view of a second embodiment of our new design for a display screen or portion thereof with graphical user interface.

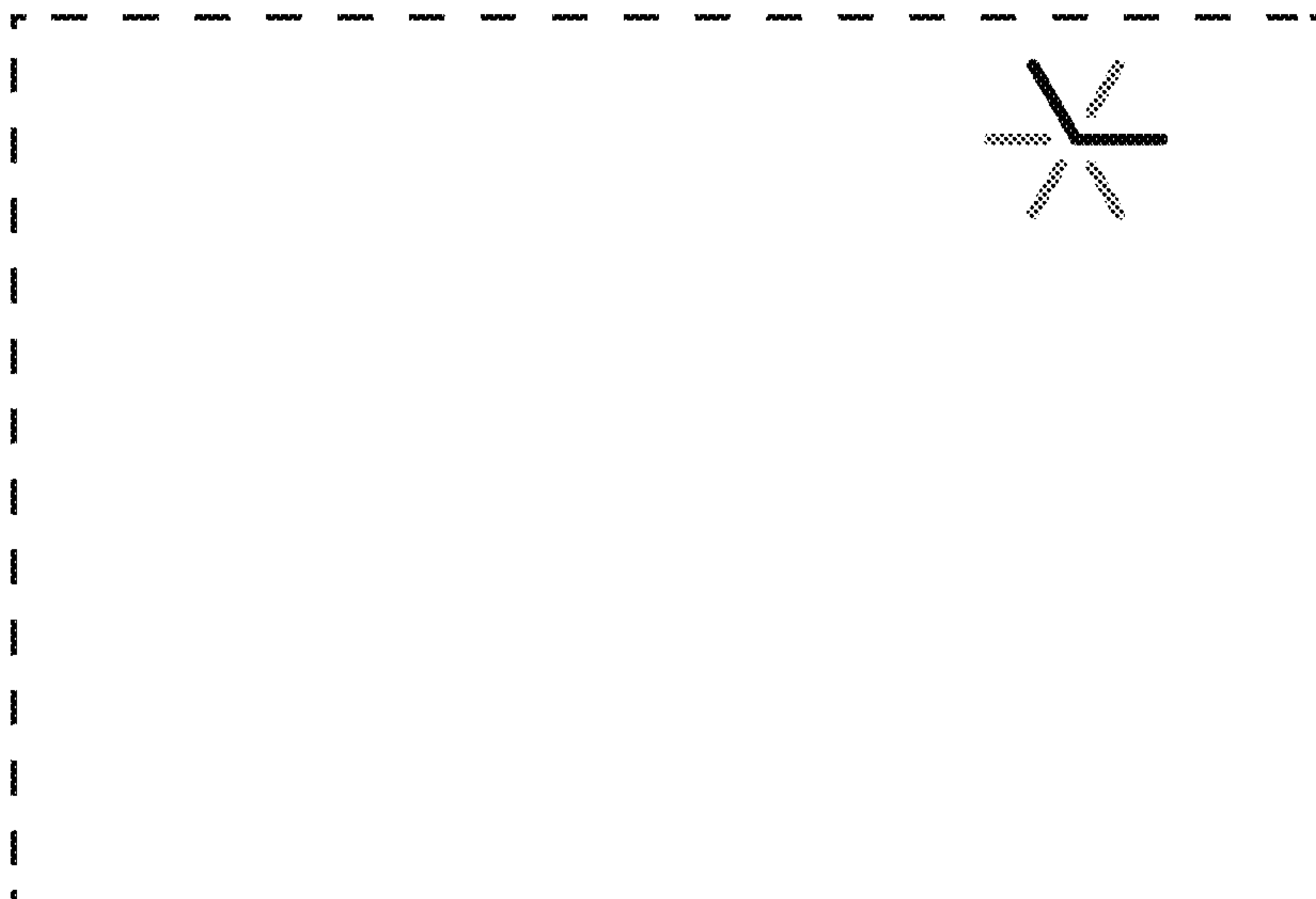
FIG. 3 is a front view of a third embodiment of our new design for a display screen or portion thereof with graphical user interface.

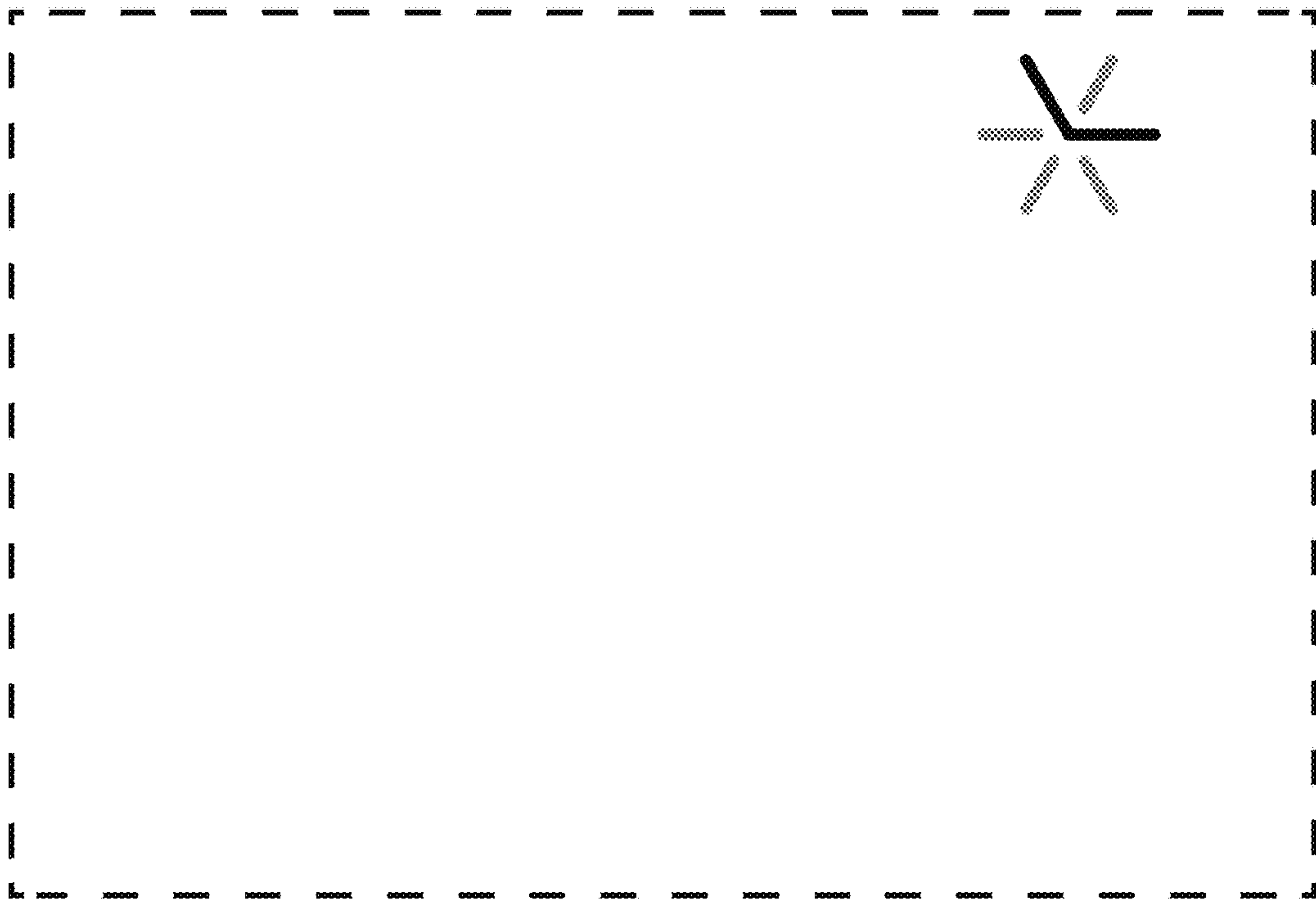

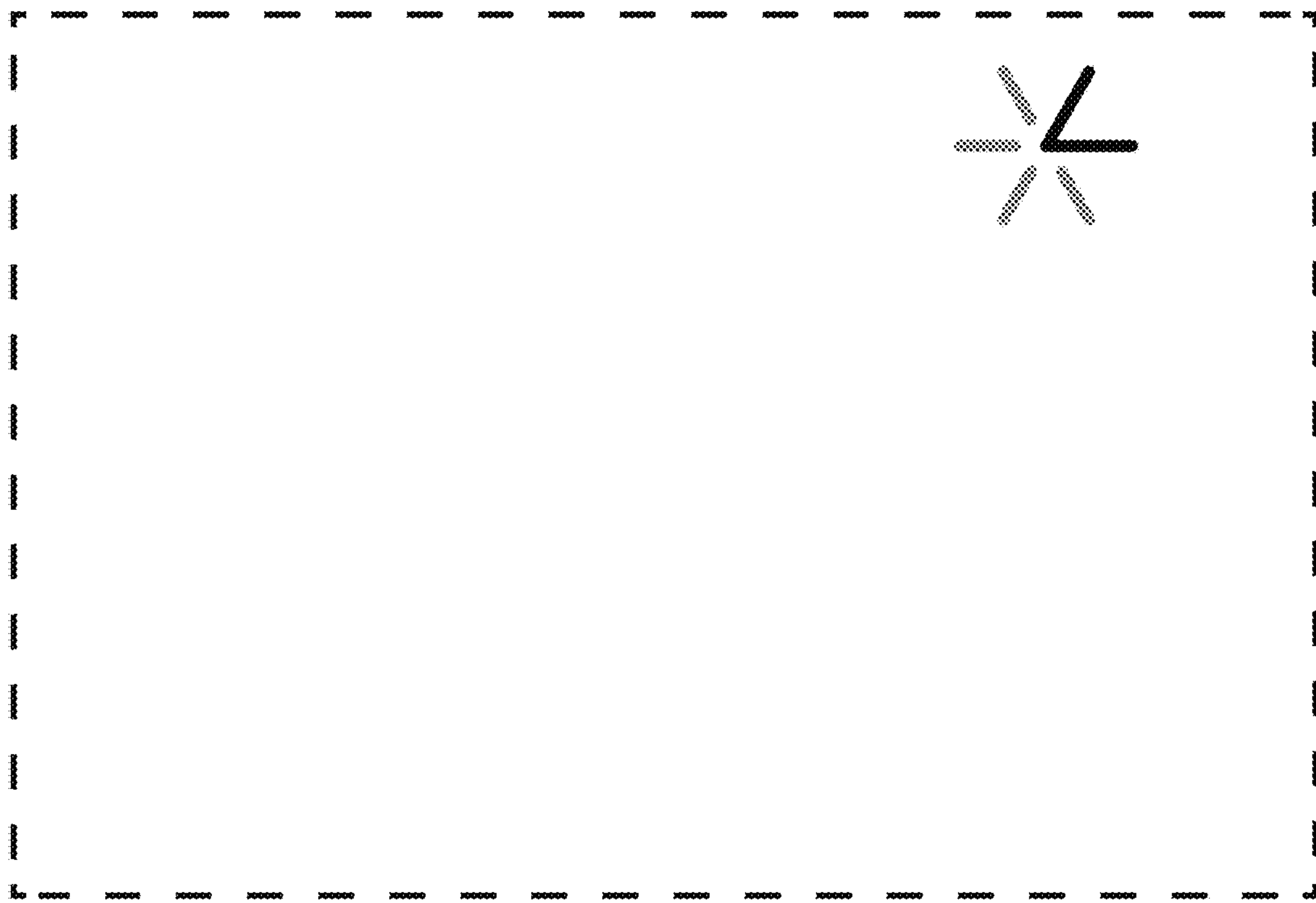

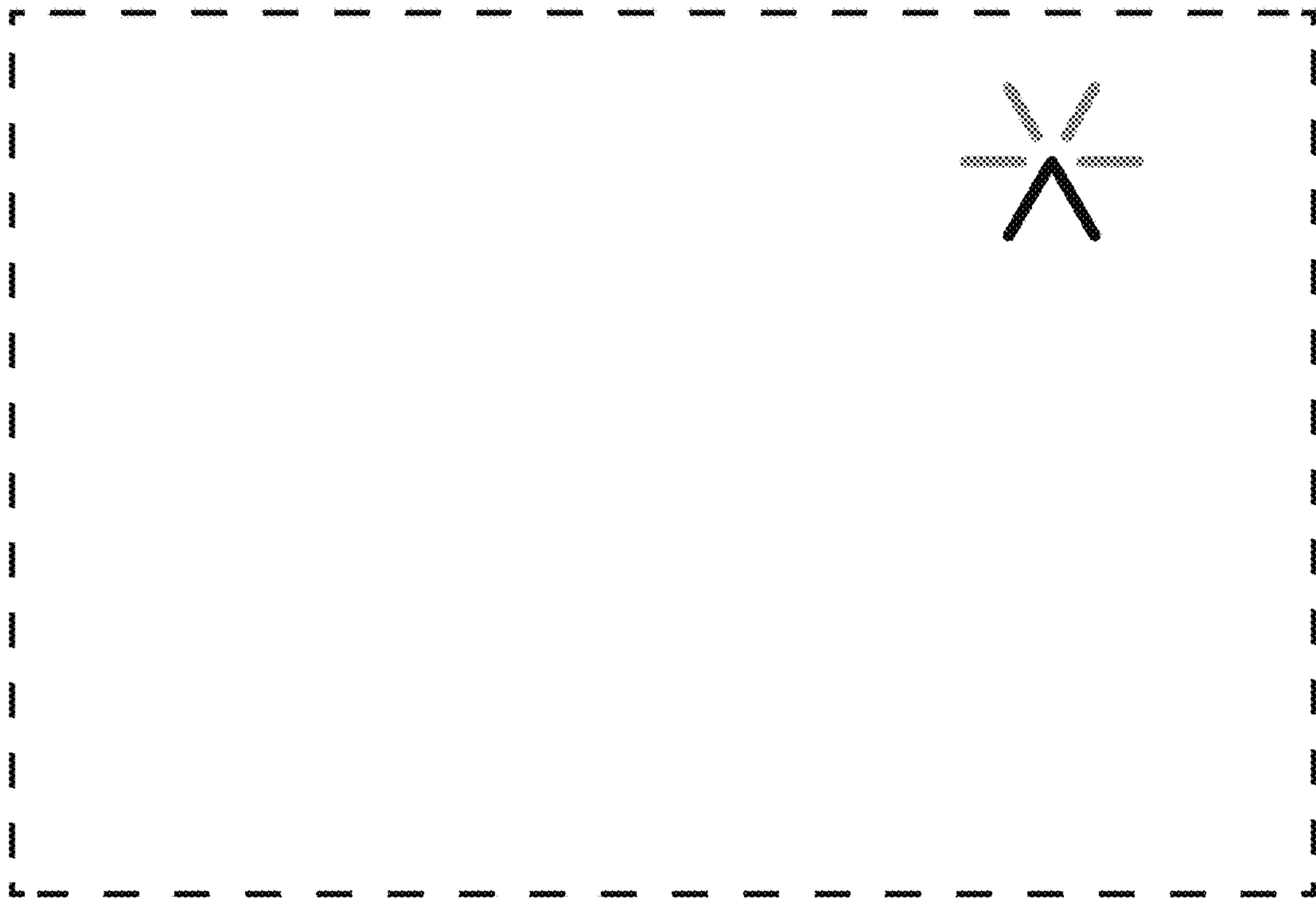
