We claim the ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

The stippled shading of the display screen or portion thereof with animated graphical user interface shown in figures forms part of the claimed design.

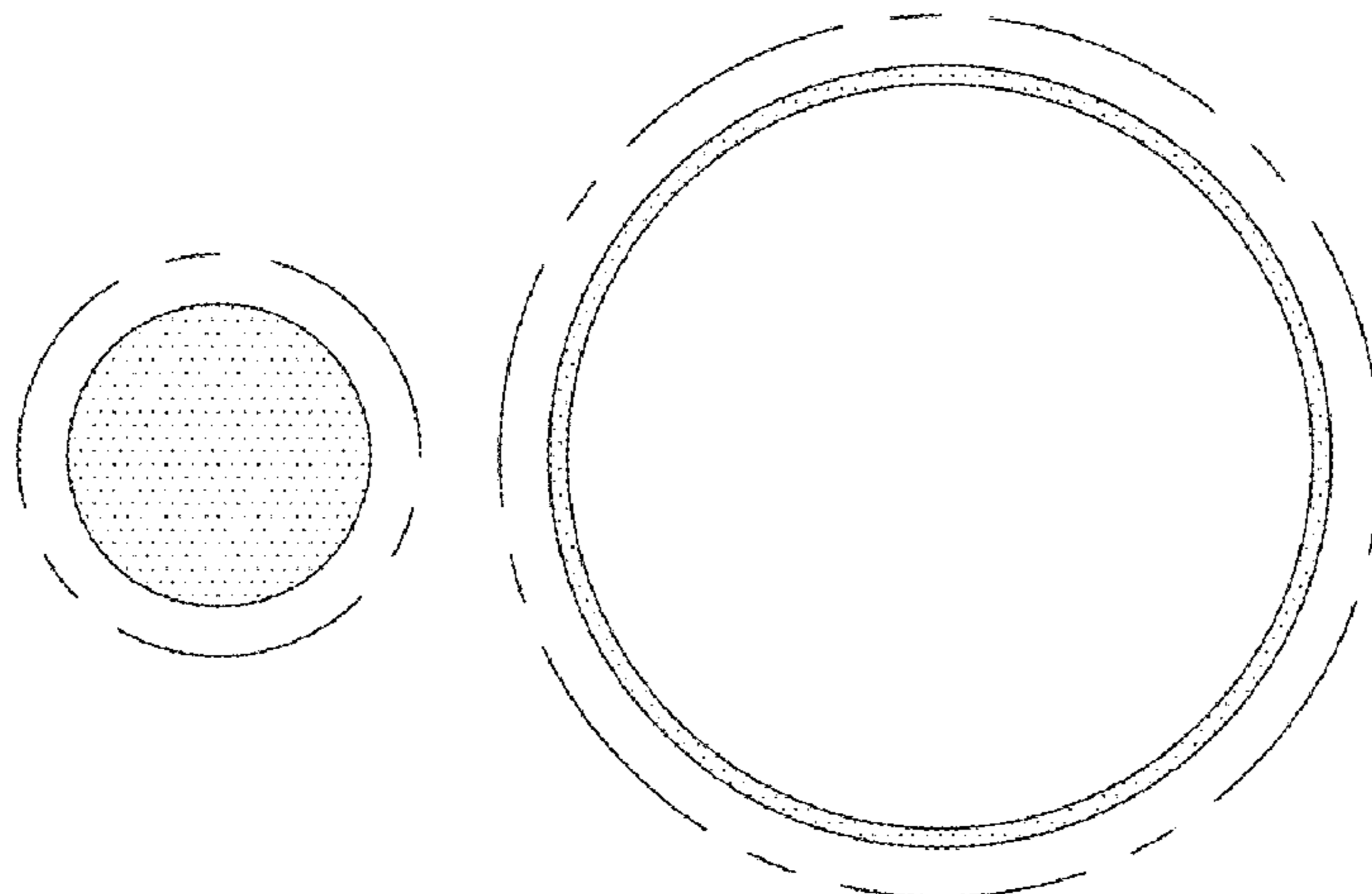
The broken lines in the figures show portions of the display screen or portion thereof with animated graphical user interface which form no part of the claimed design.

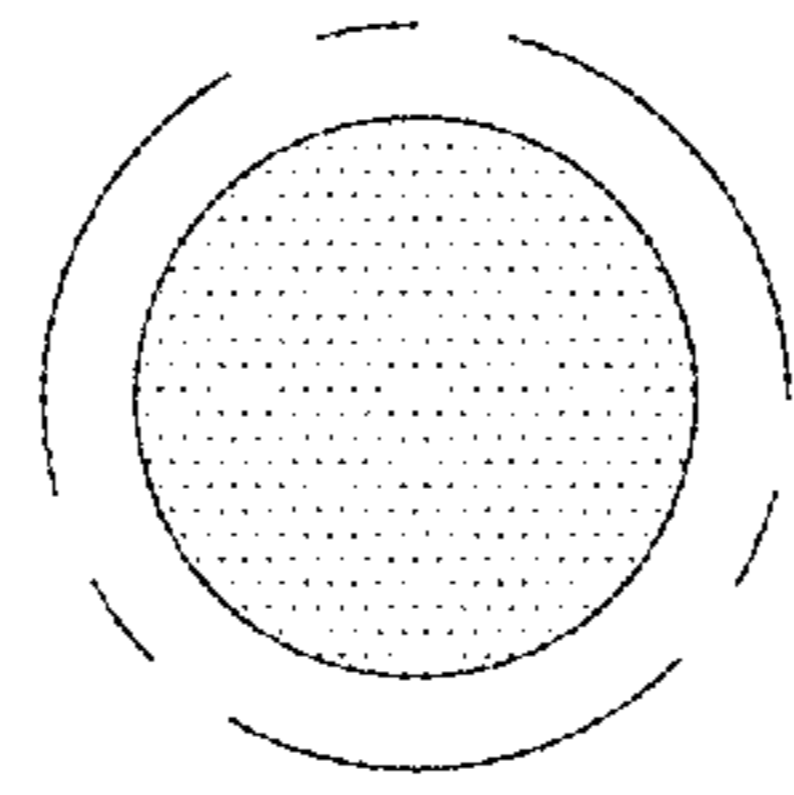

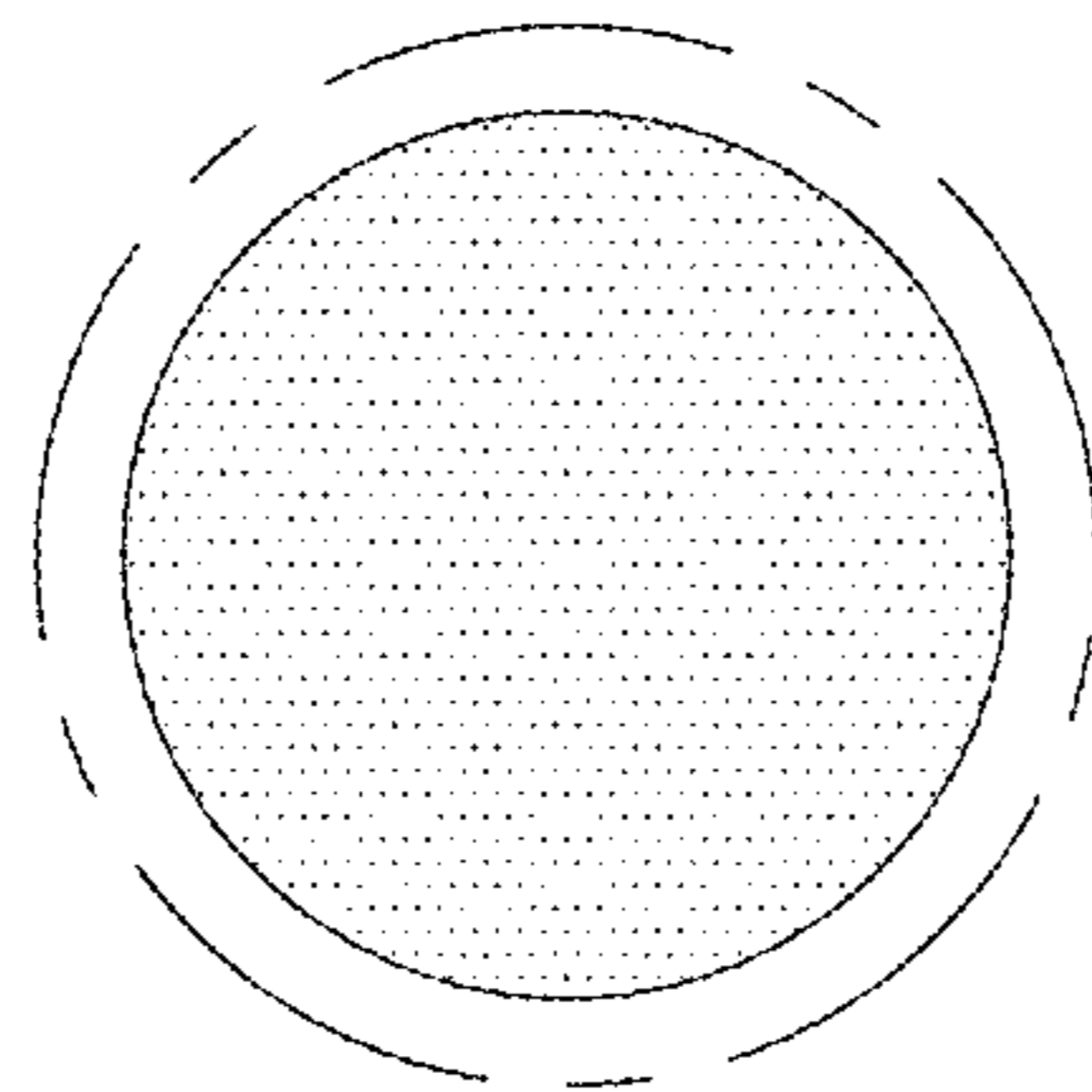

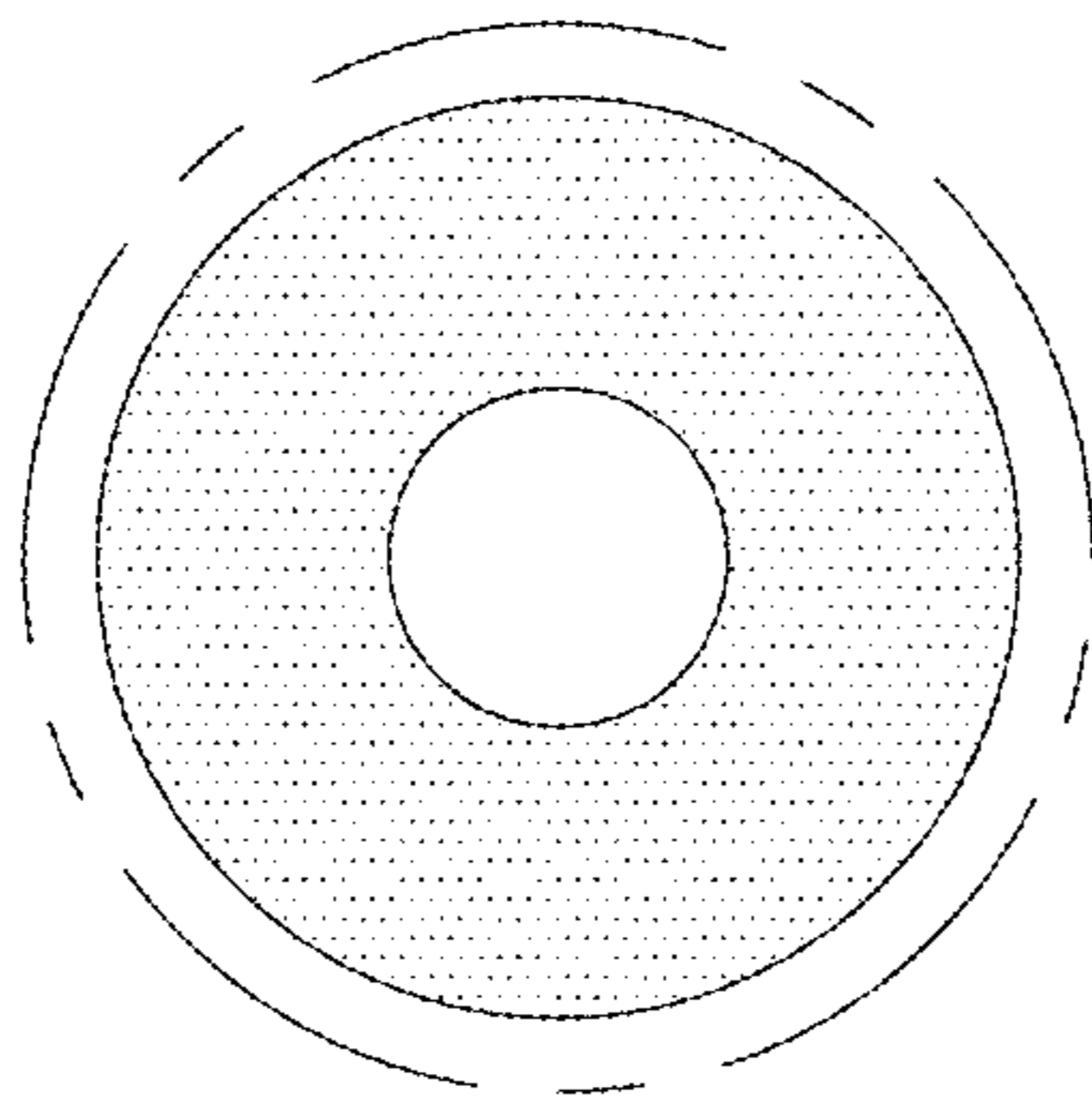

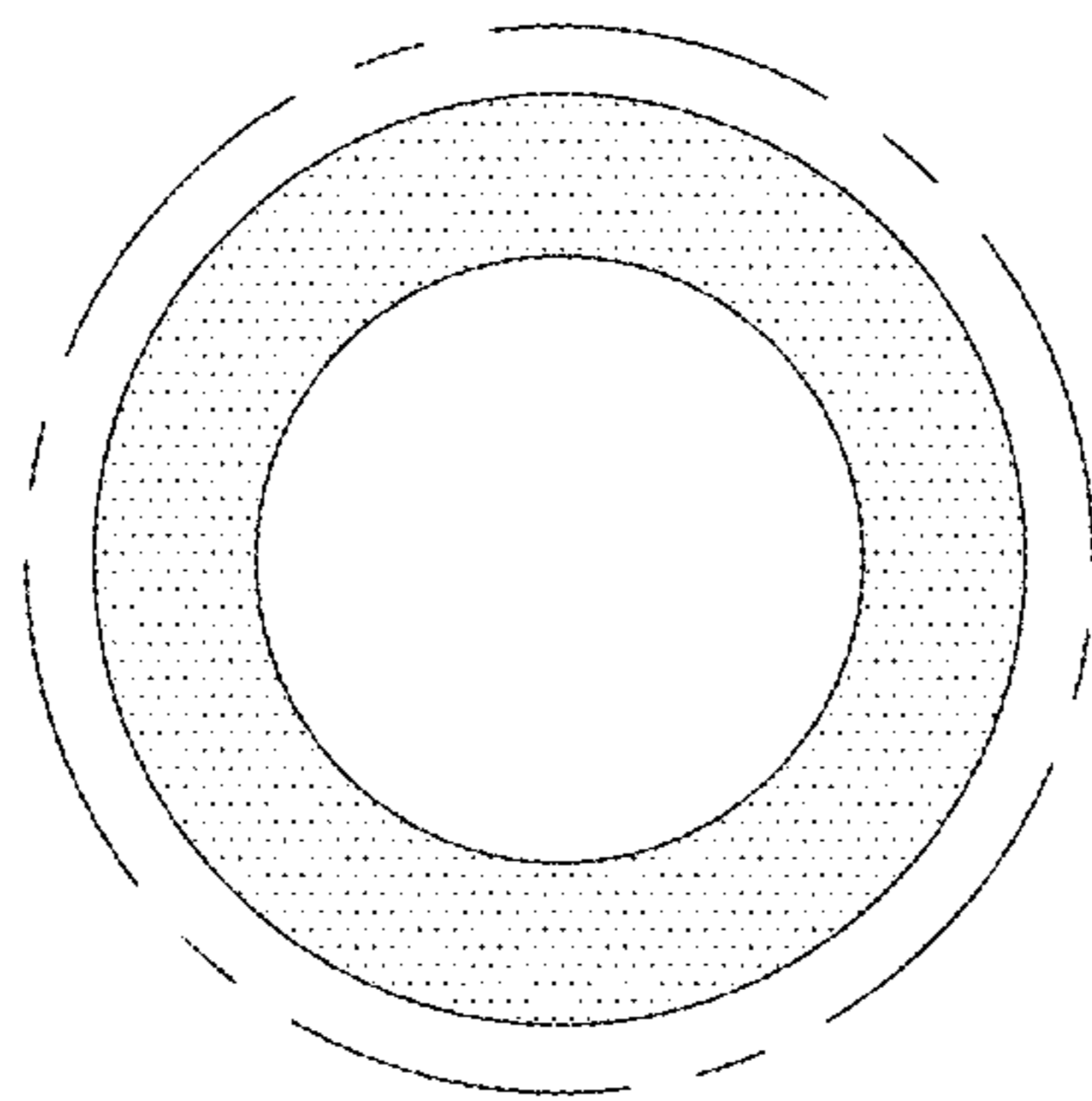

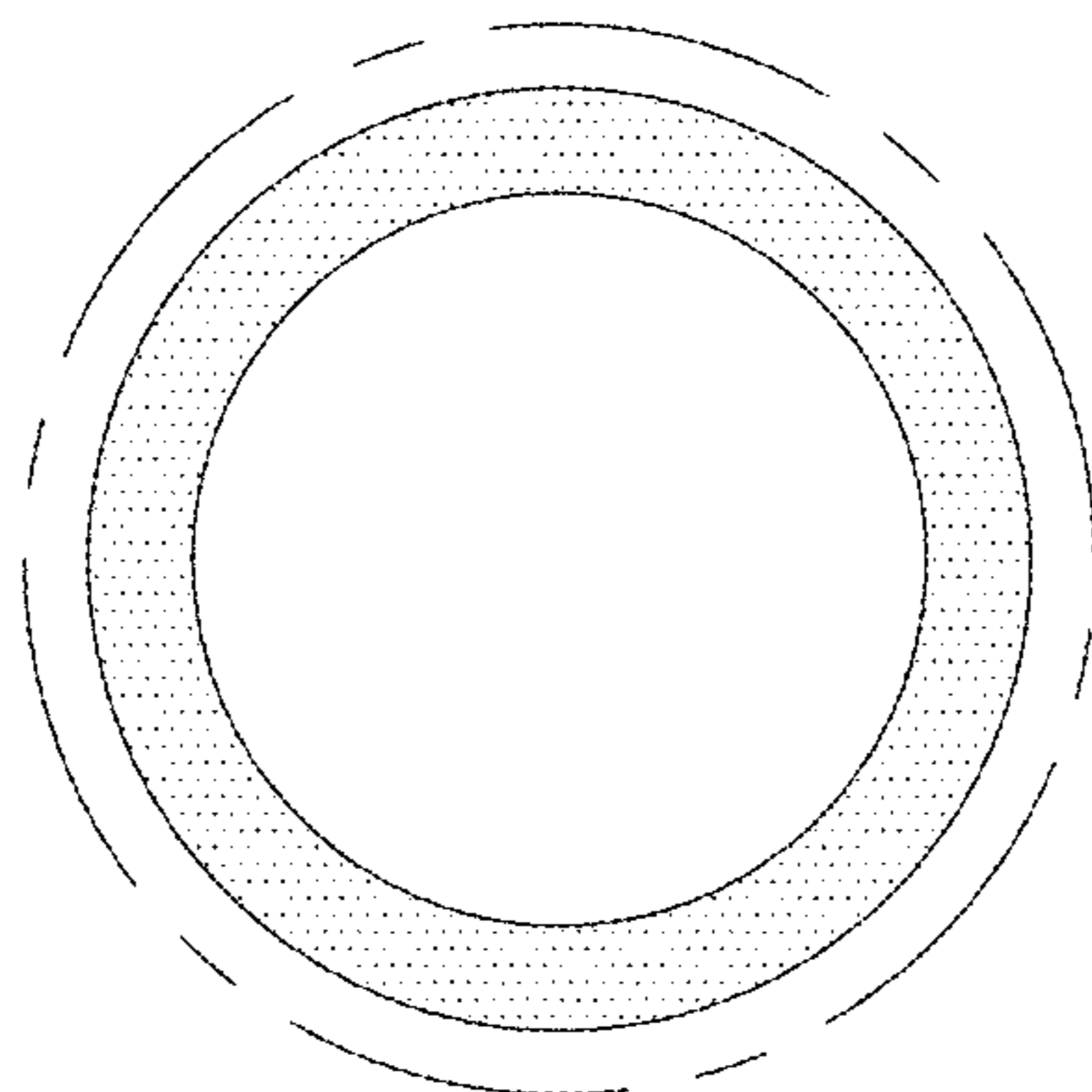

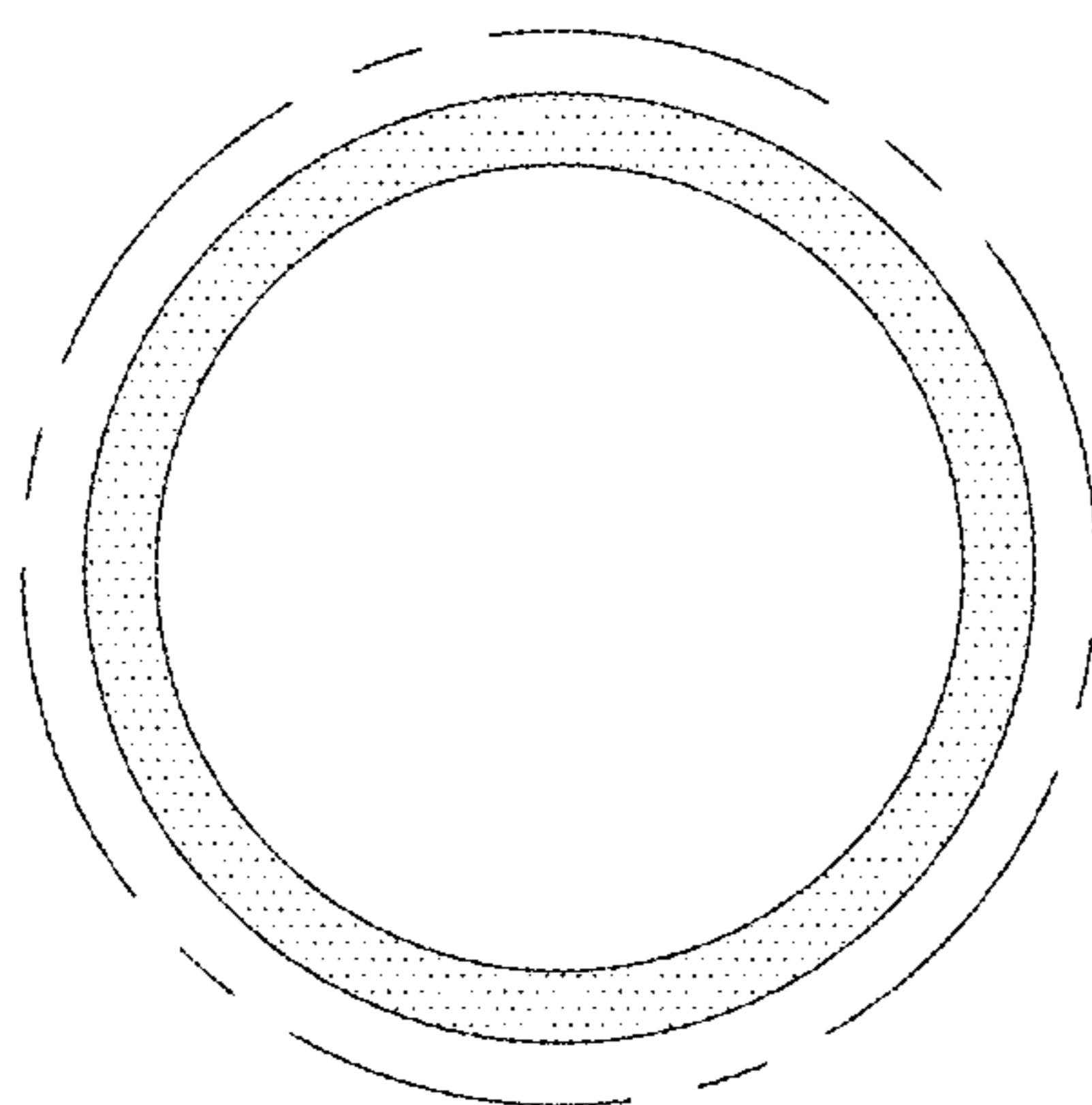

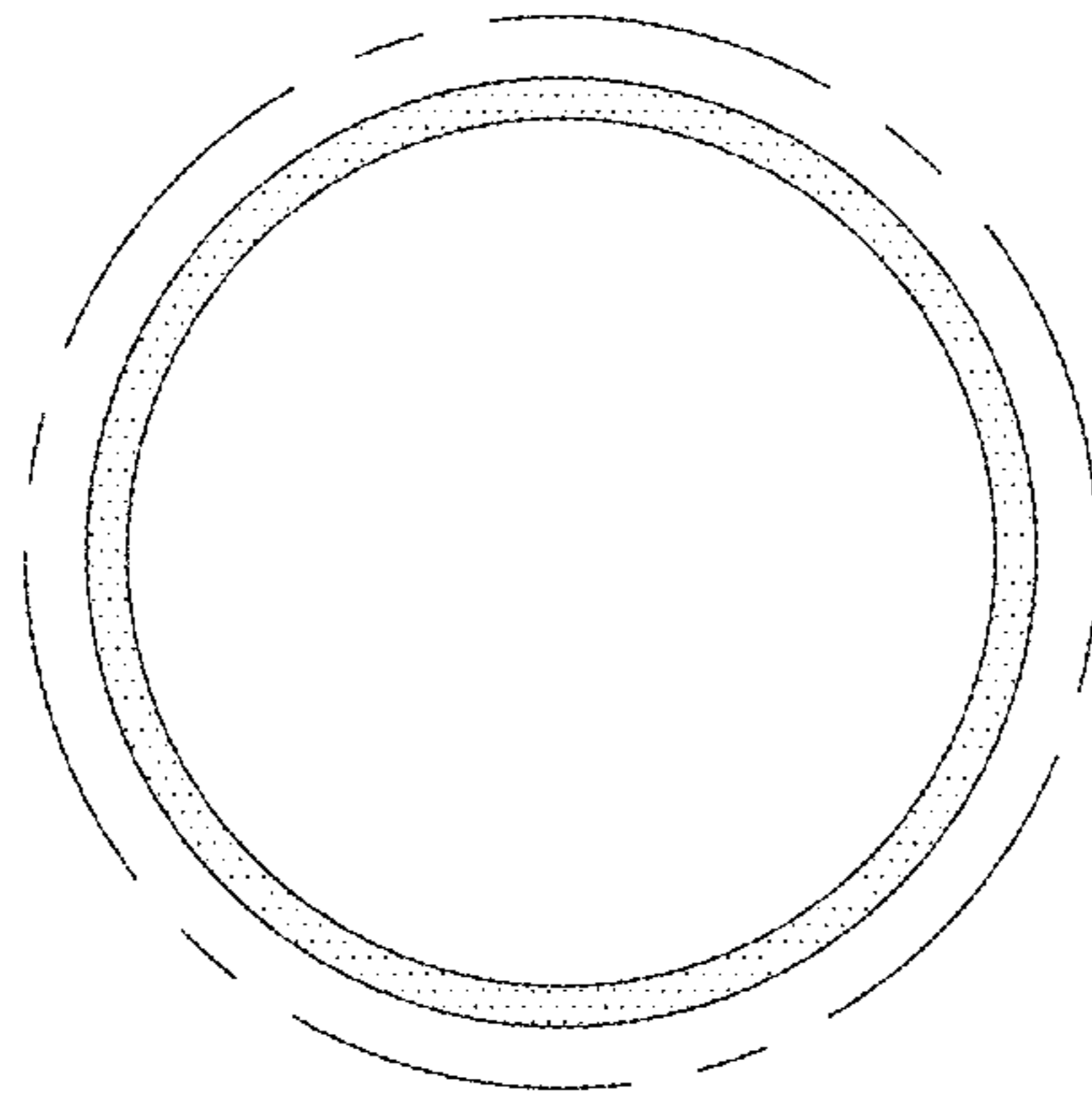

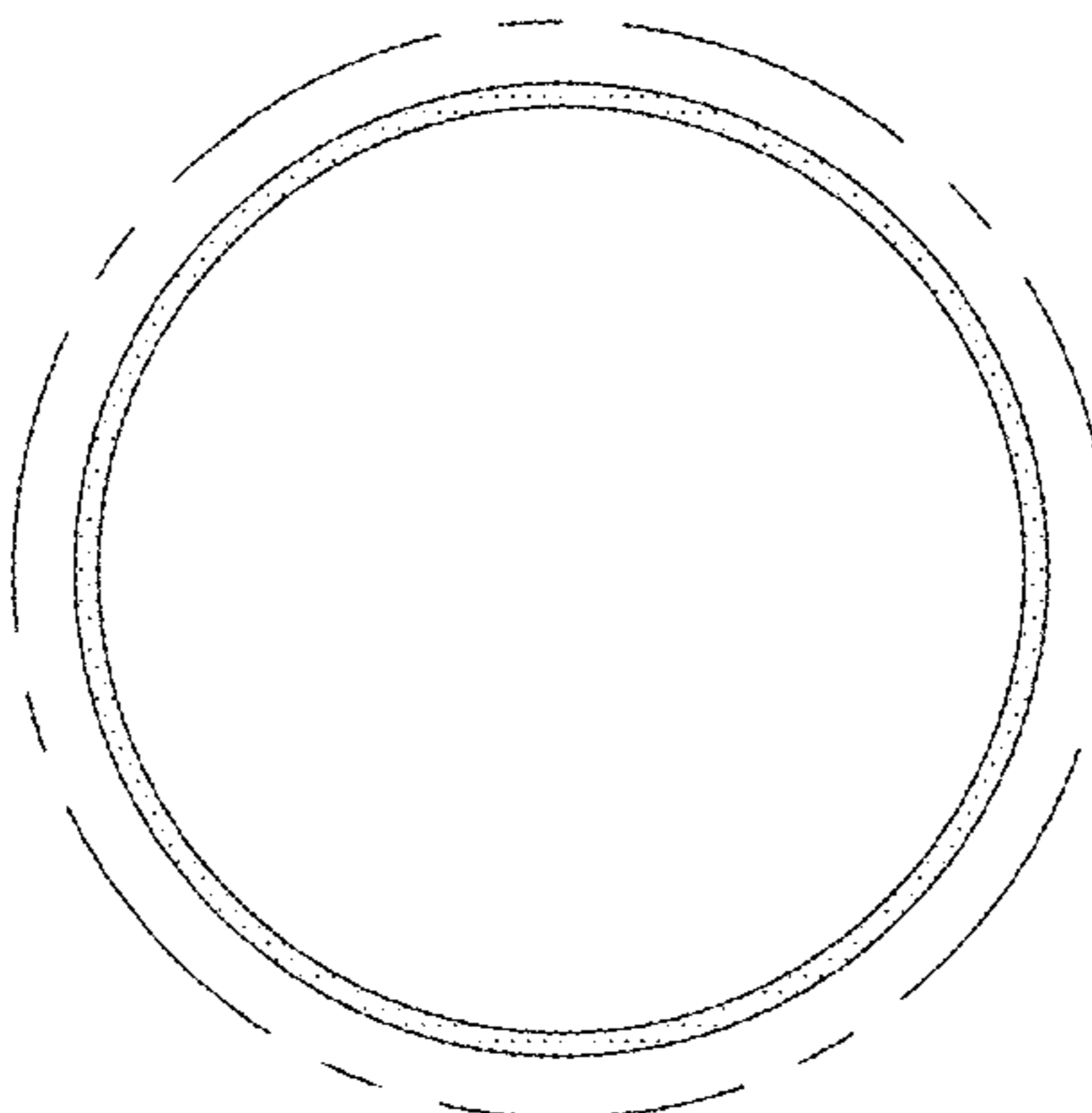

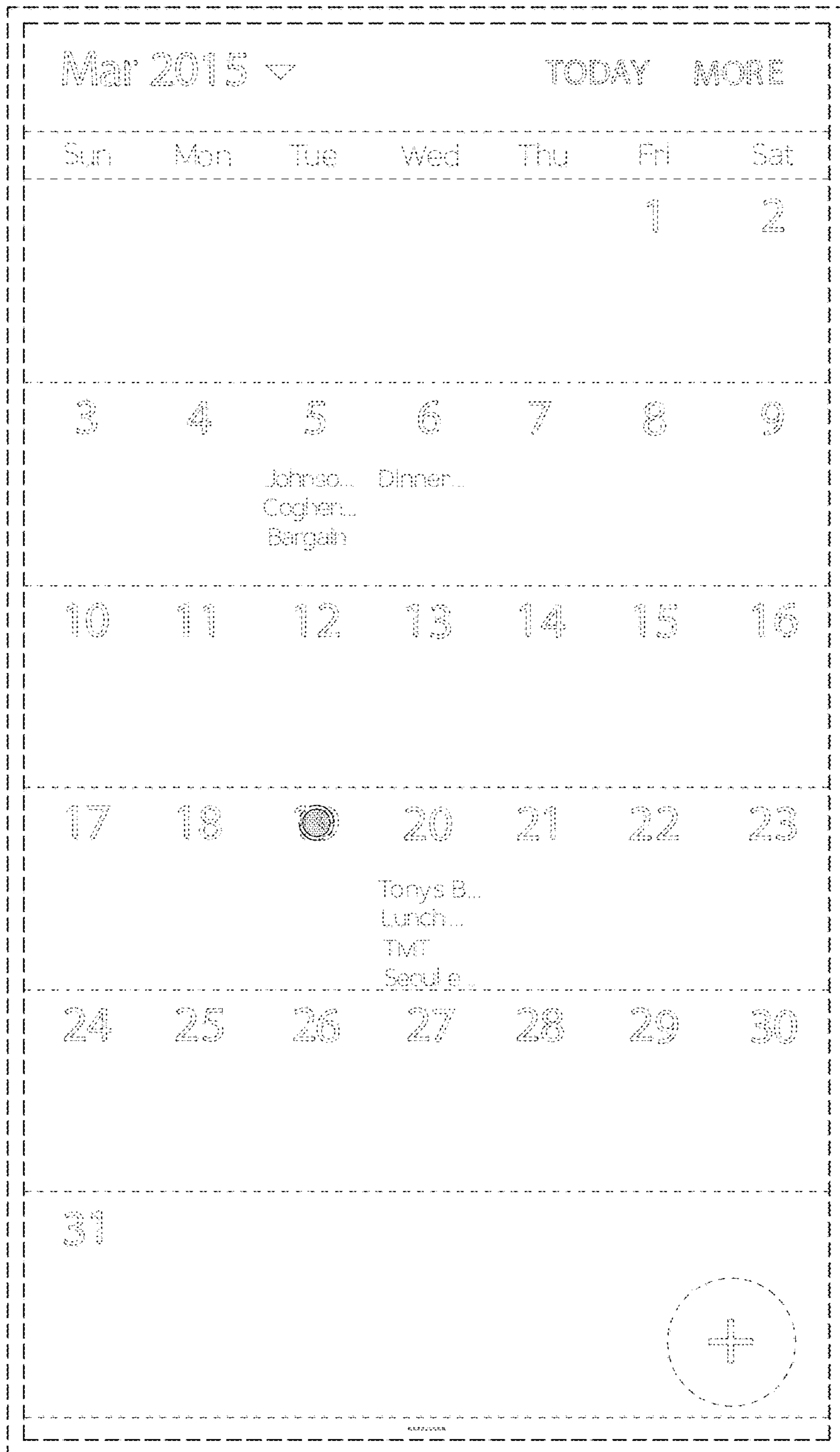

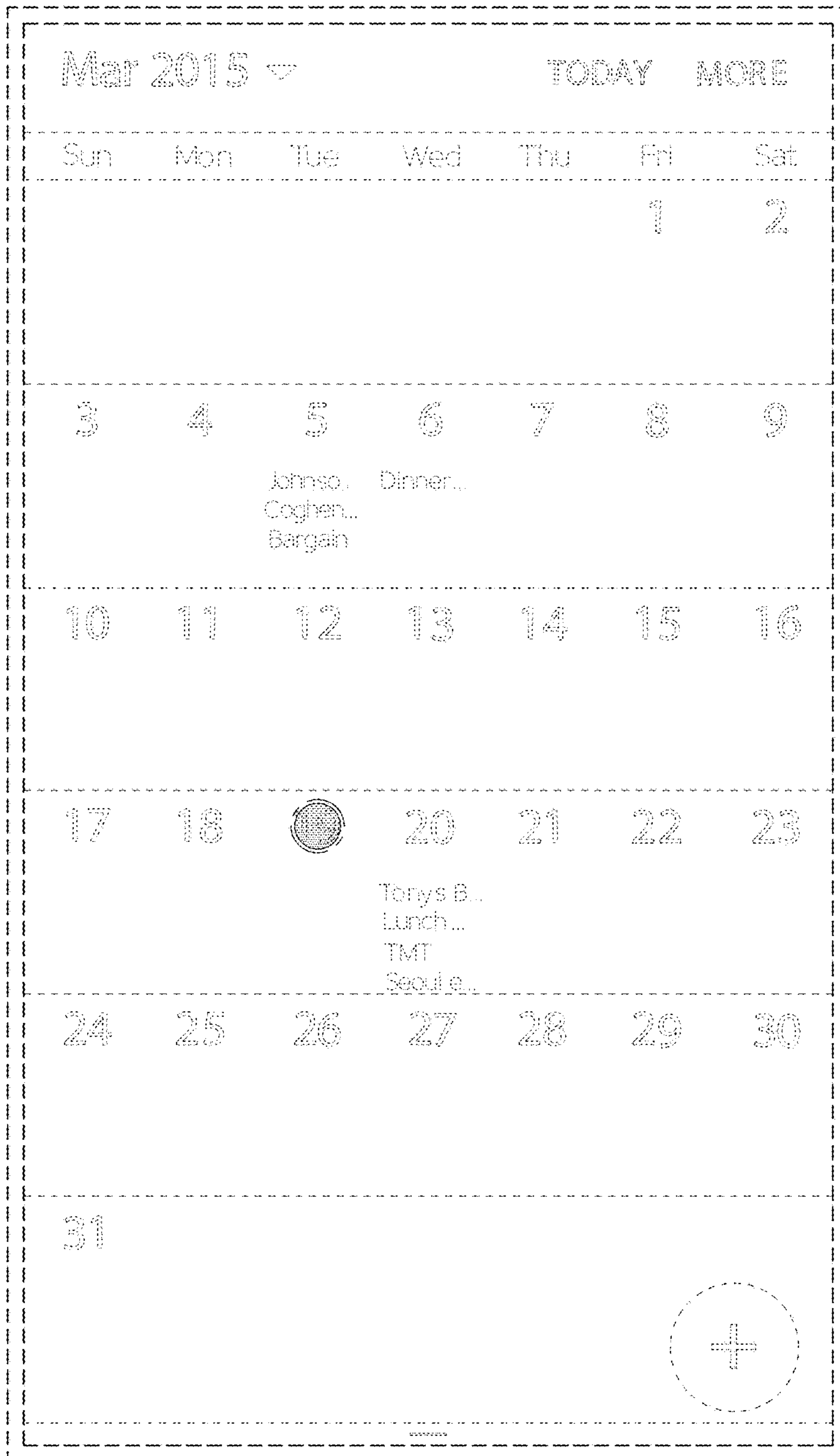

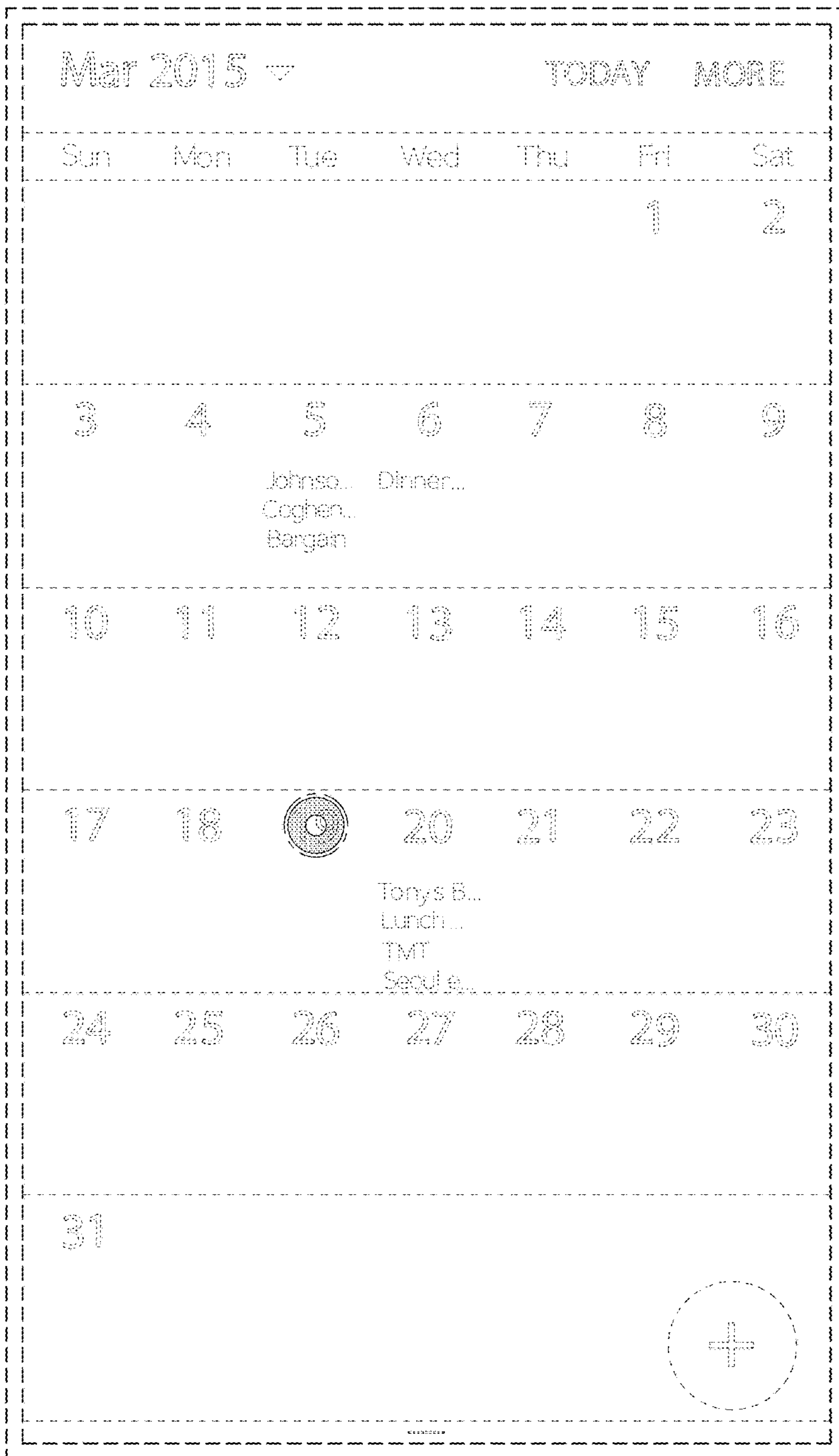

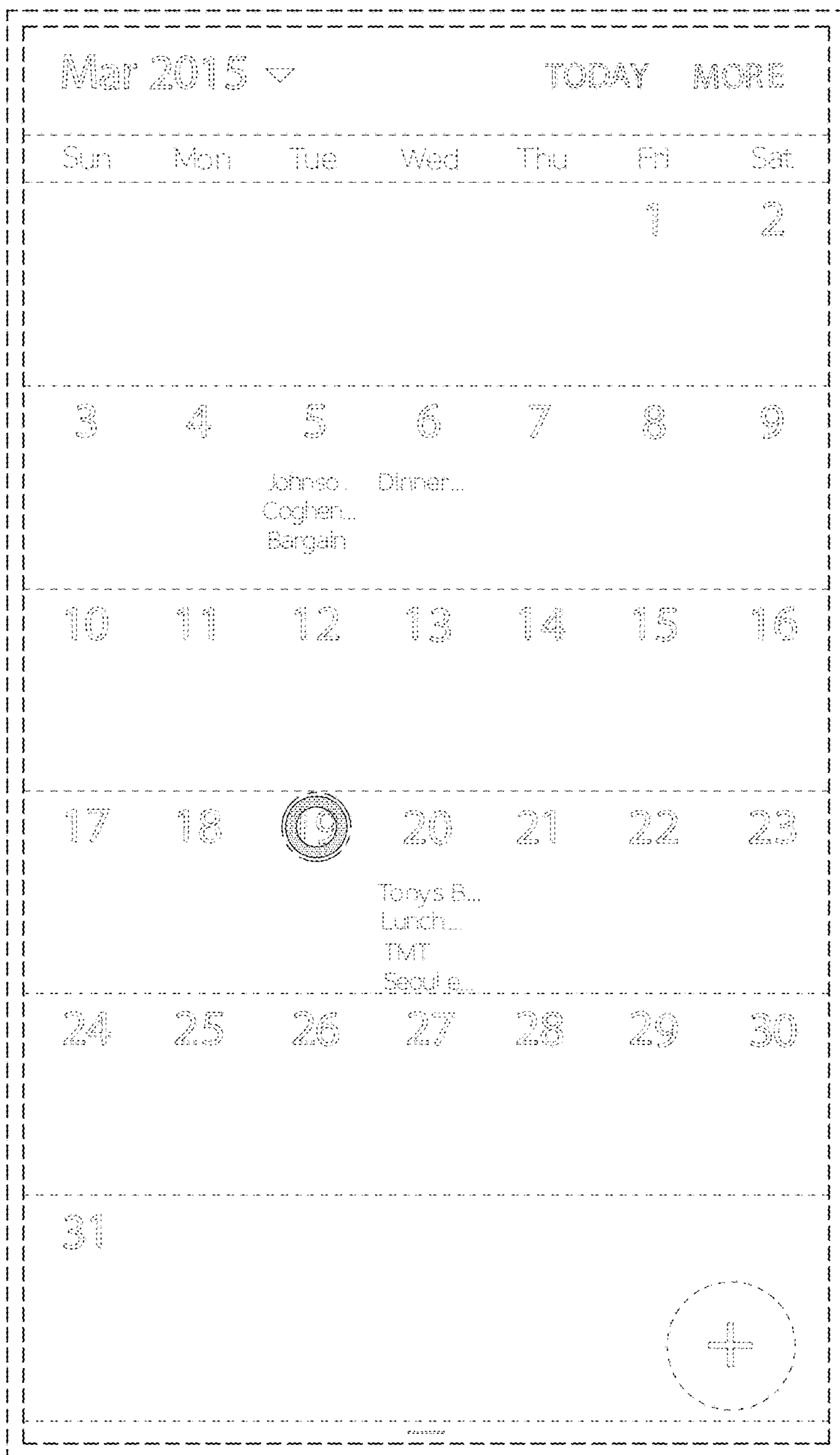

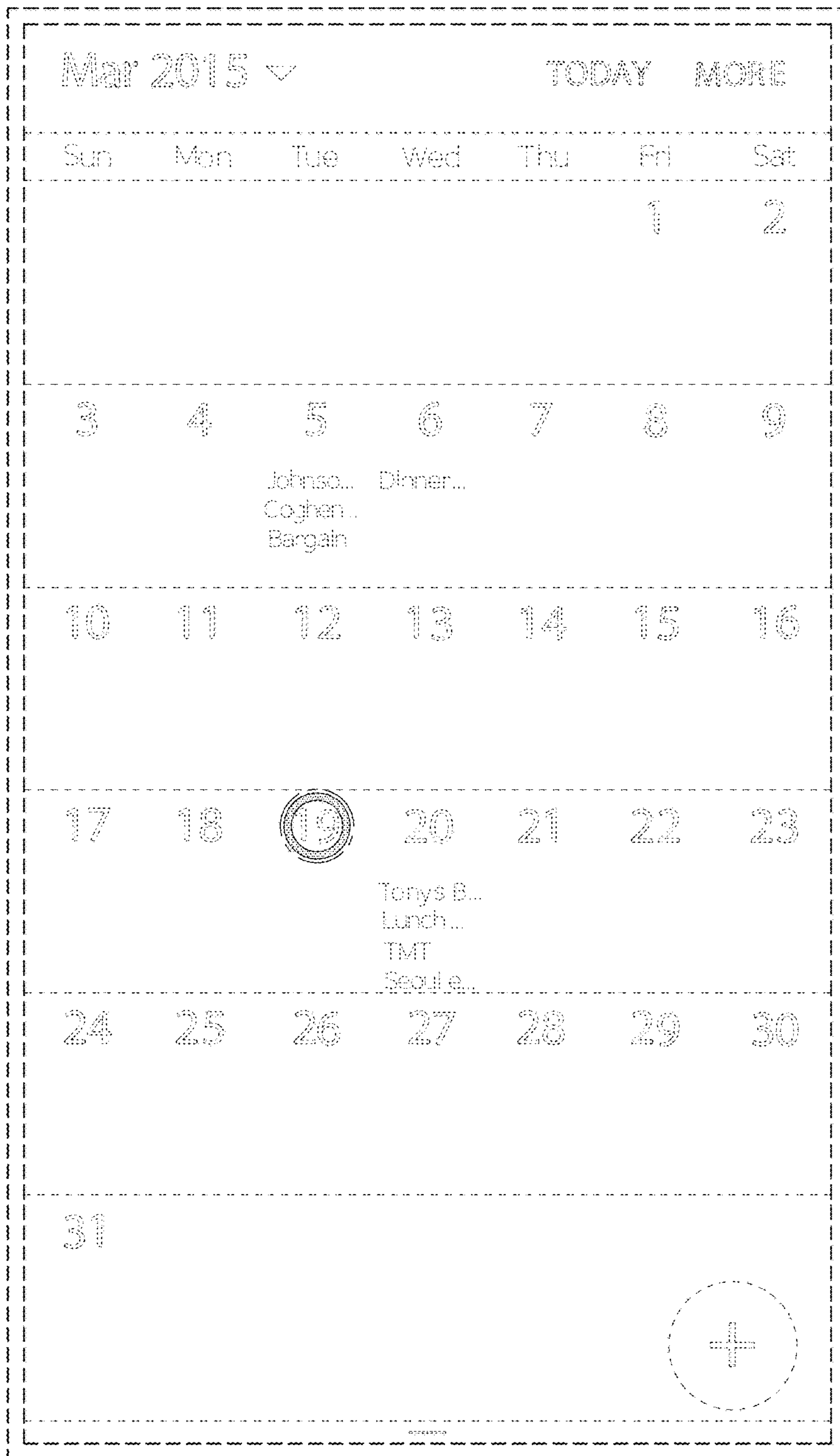

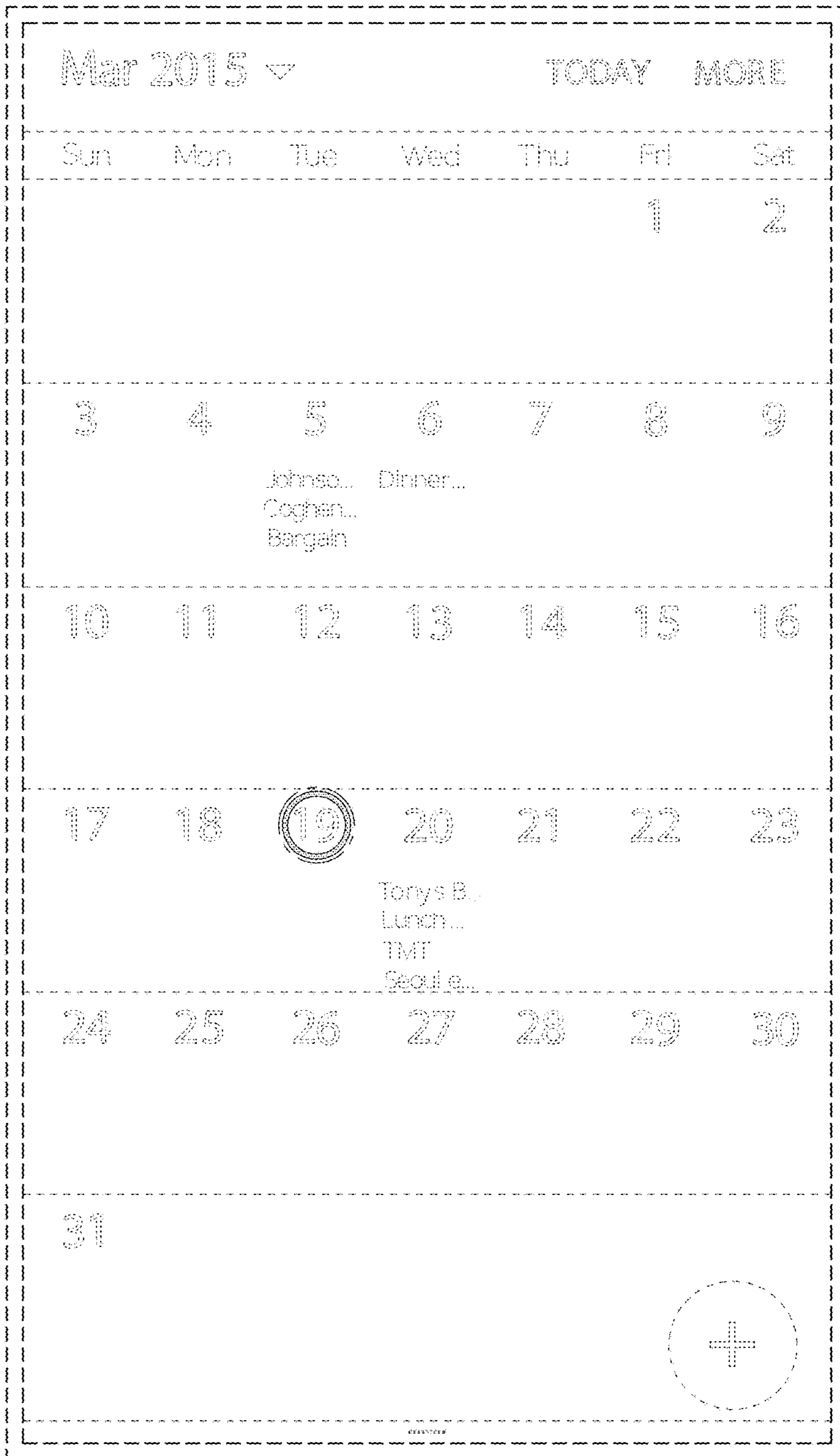

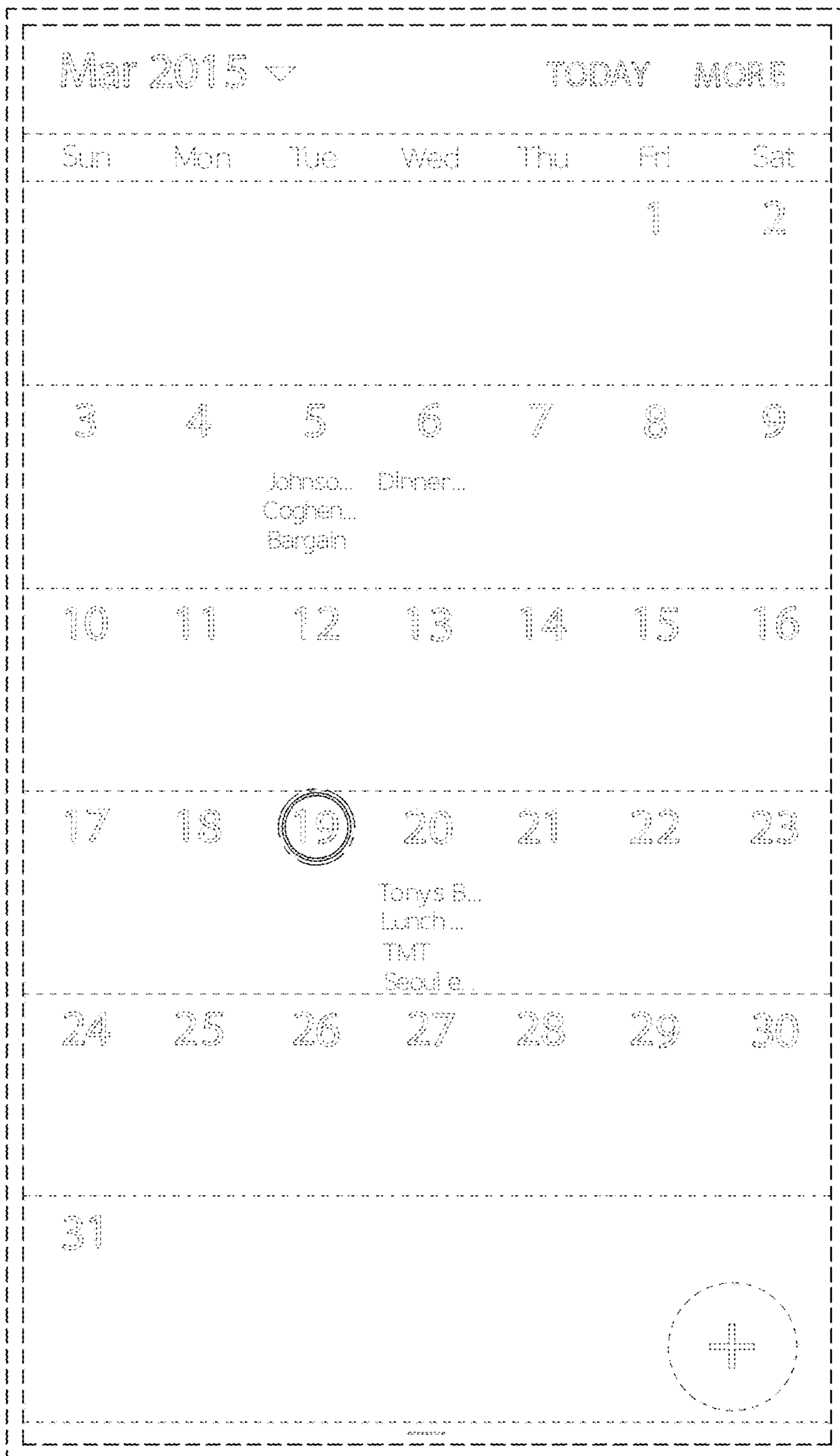
