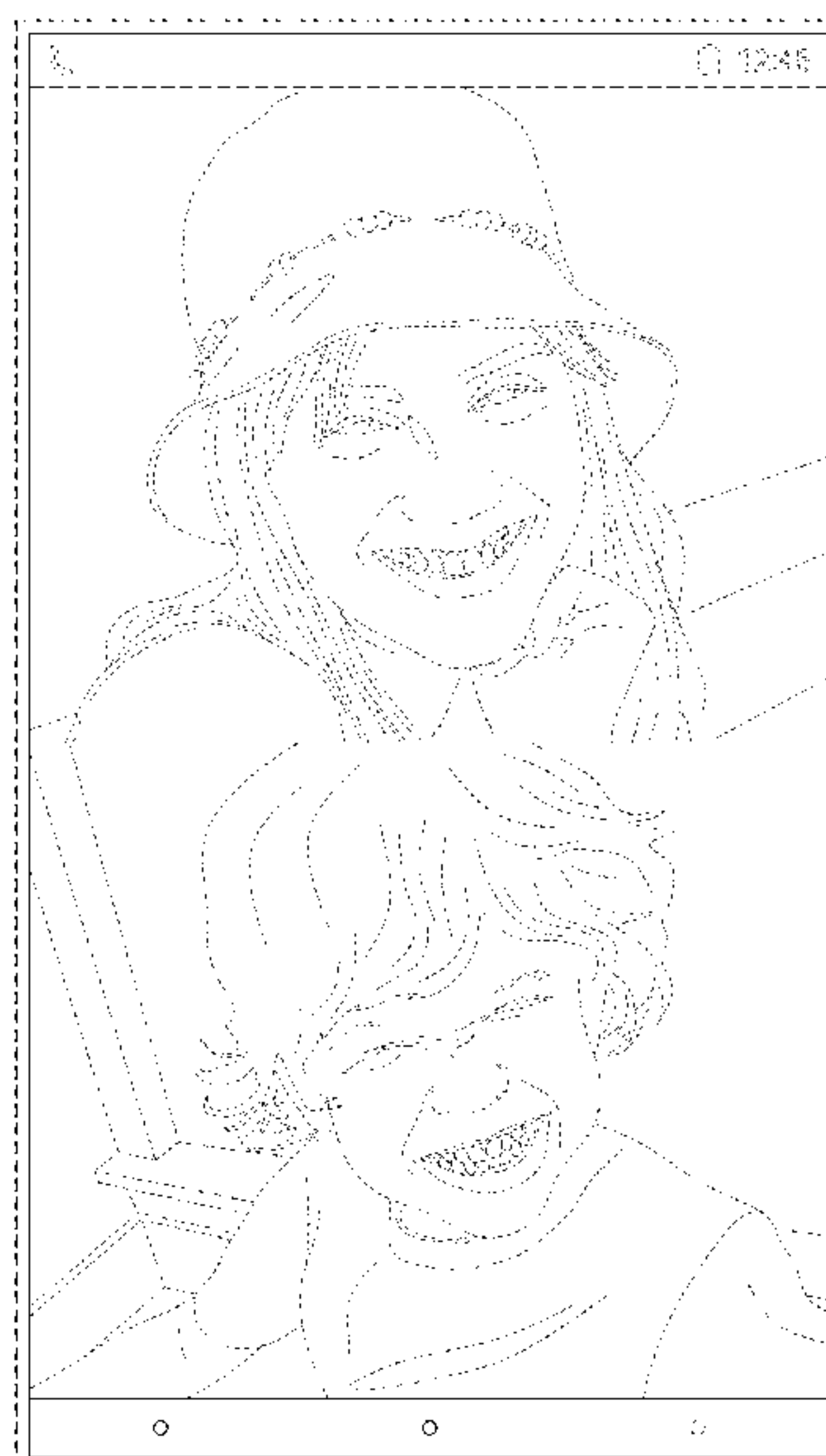
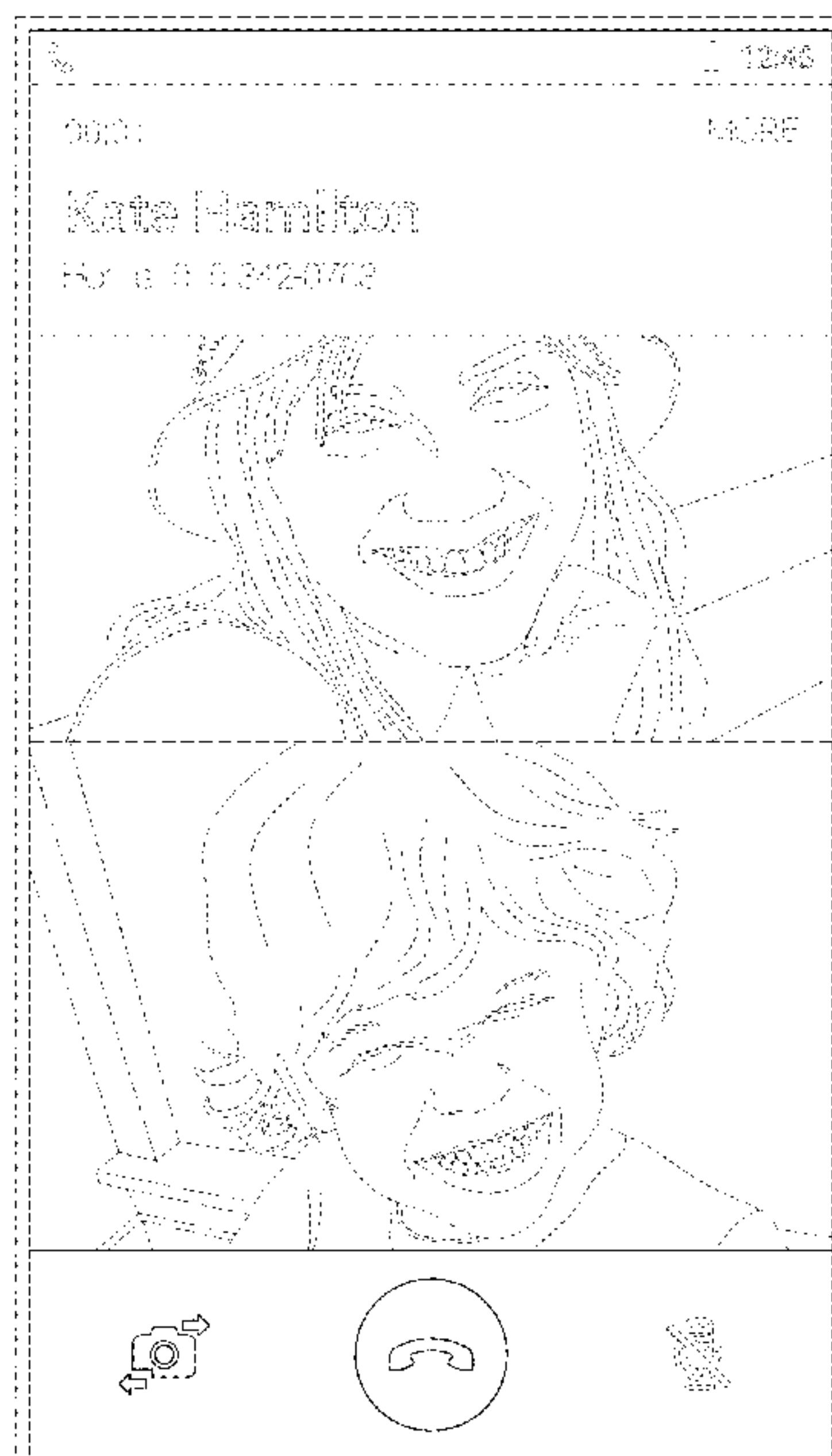
The broken lines in the figures show portions of the display screen or portion thereof with animated graphical user interface which form no part of the claimed design.

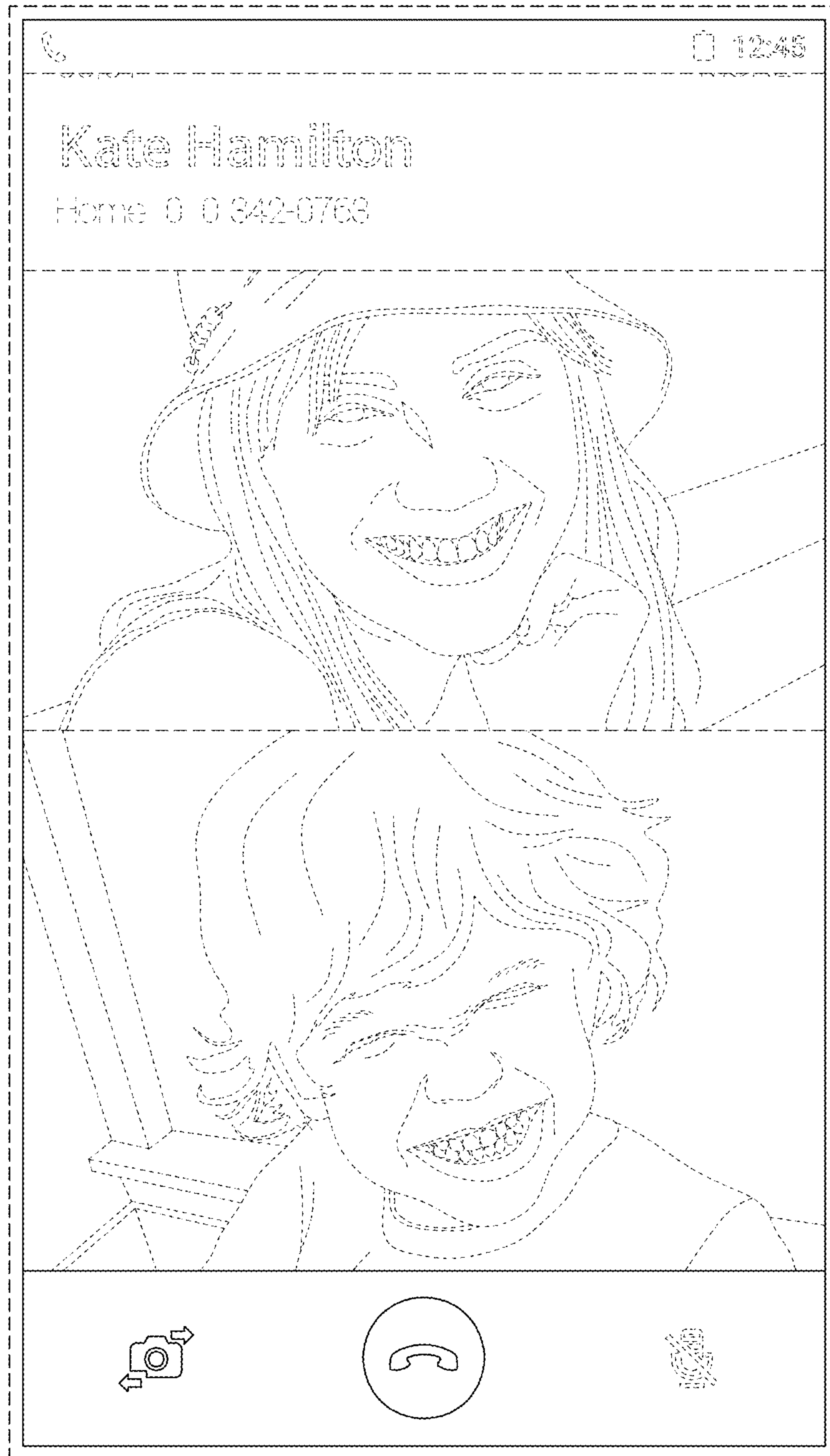

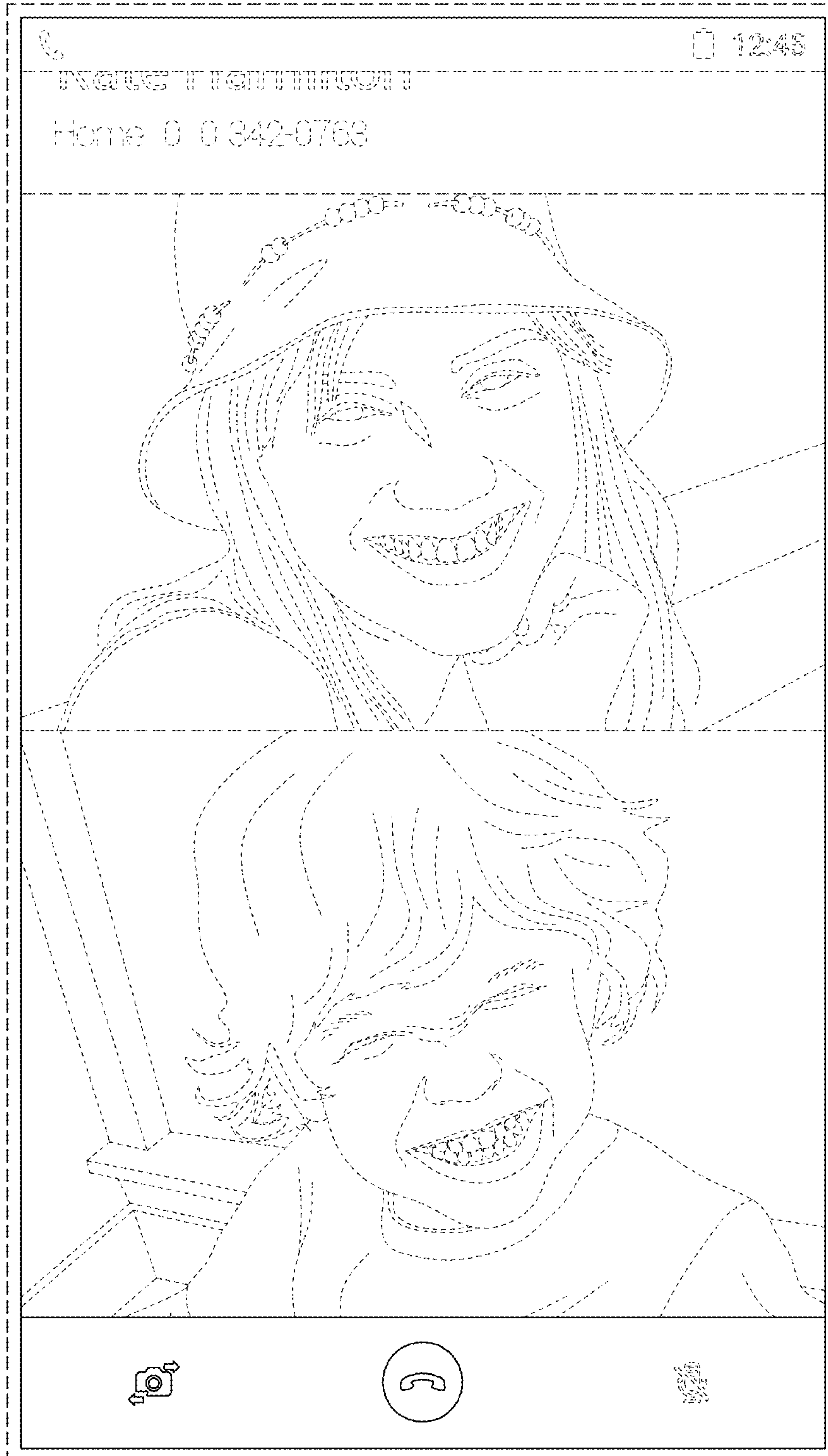

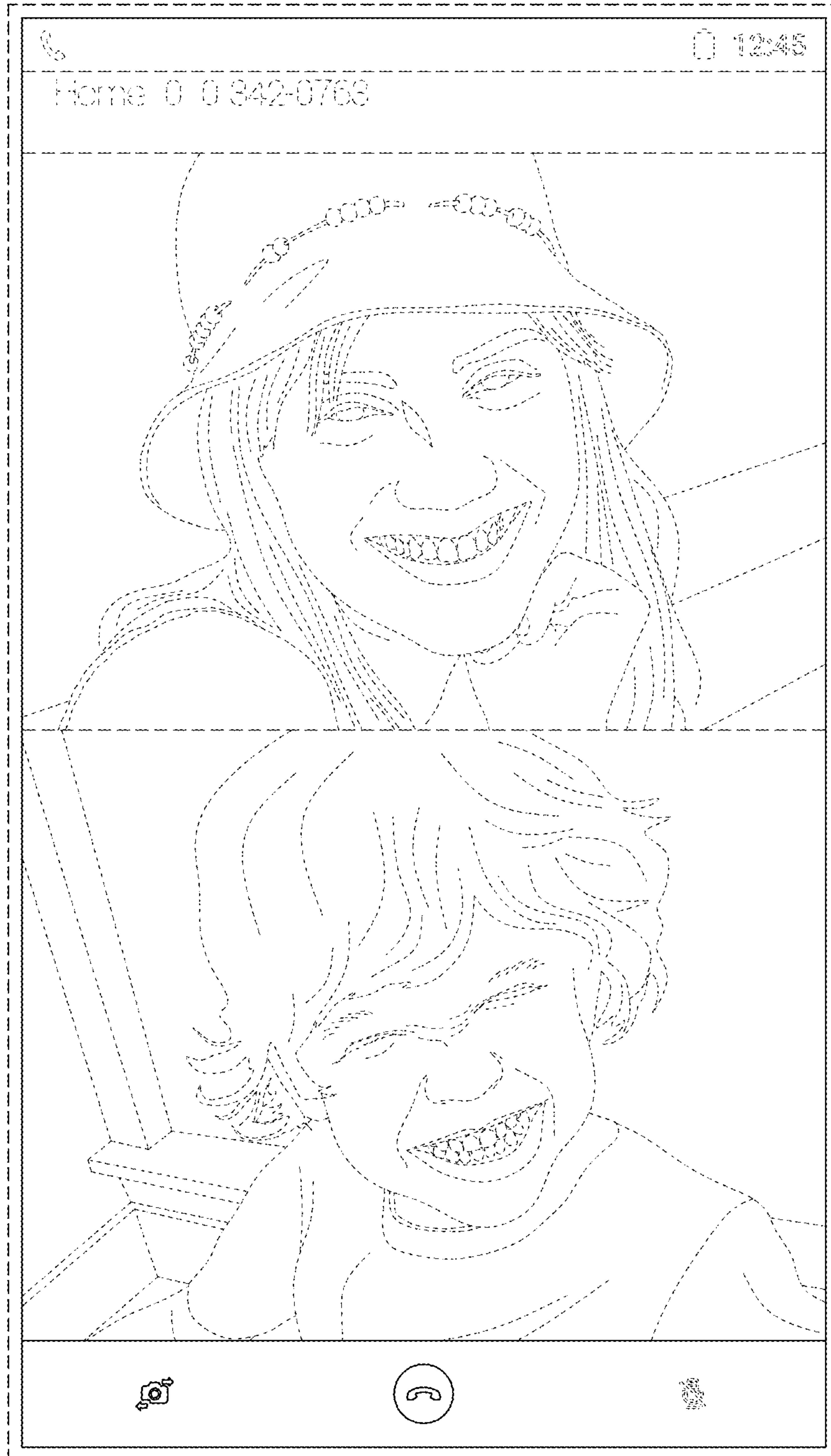

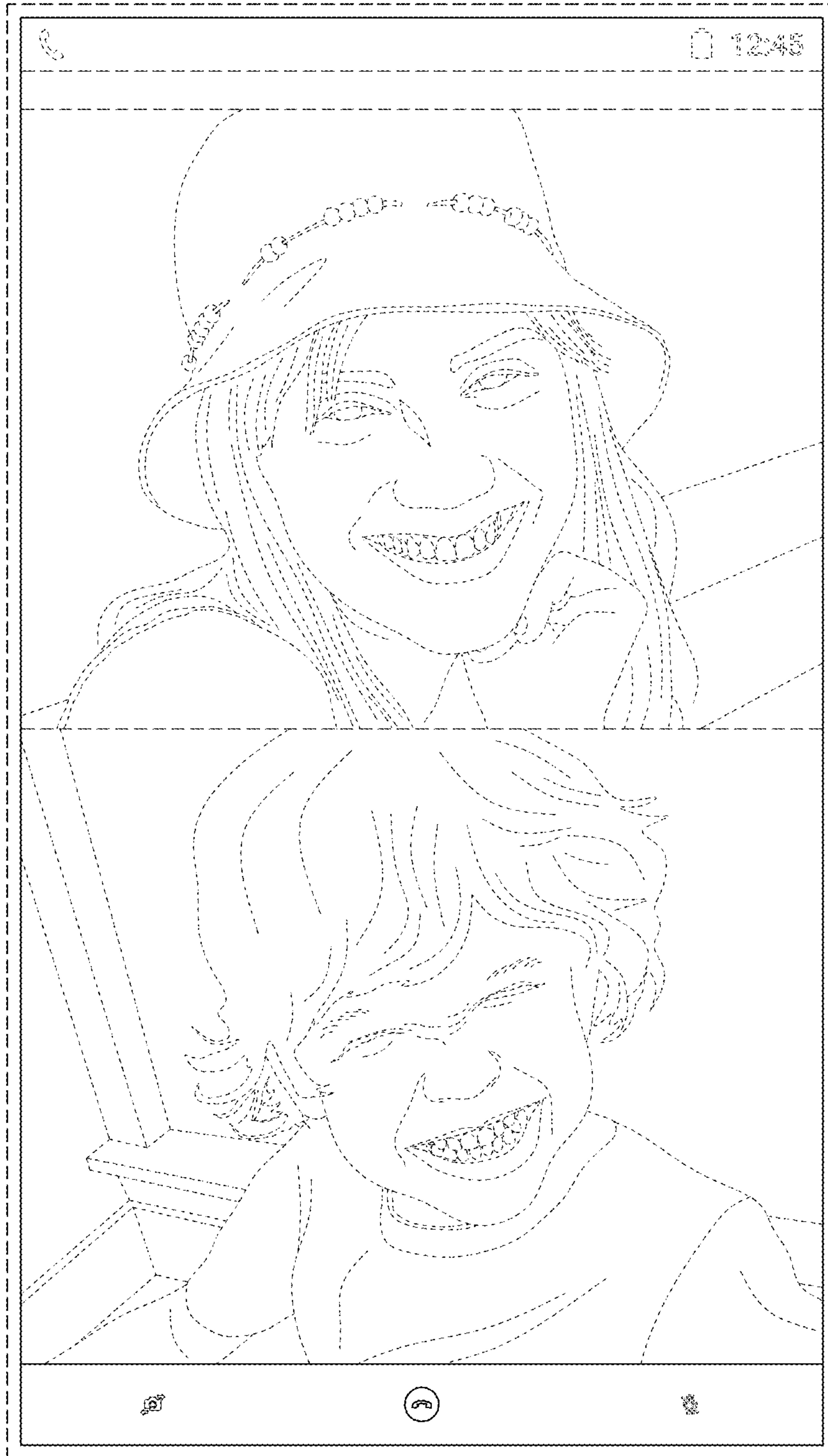

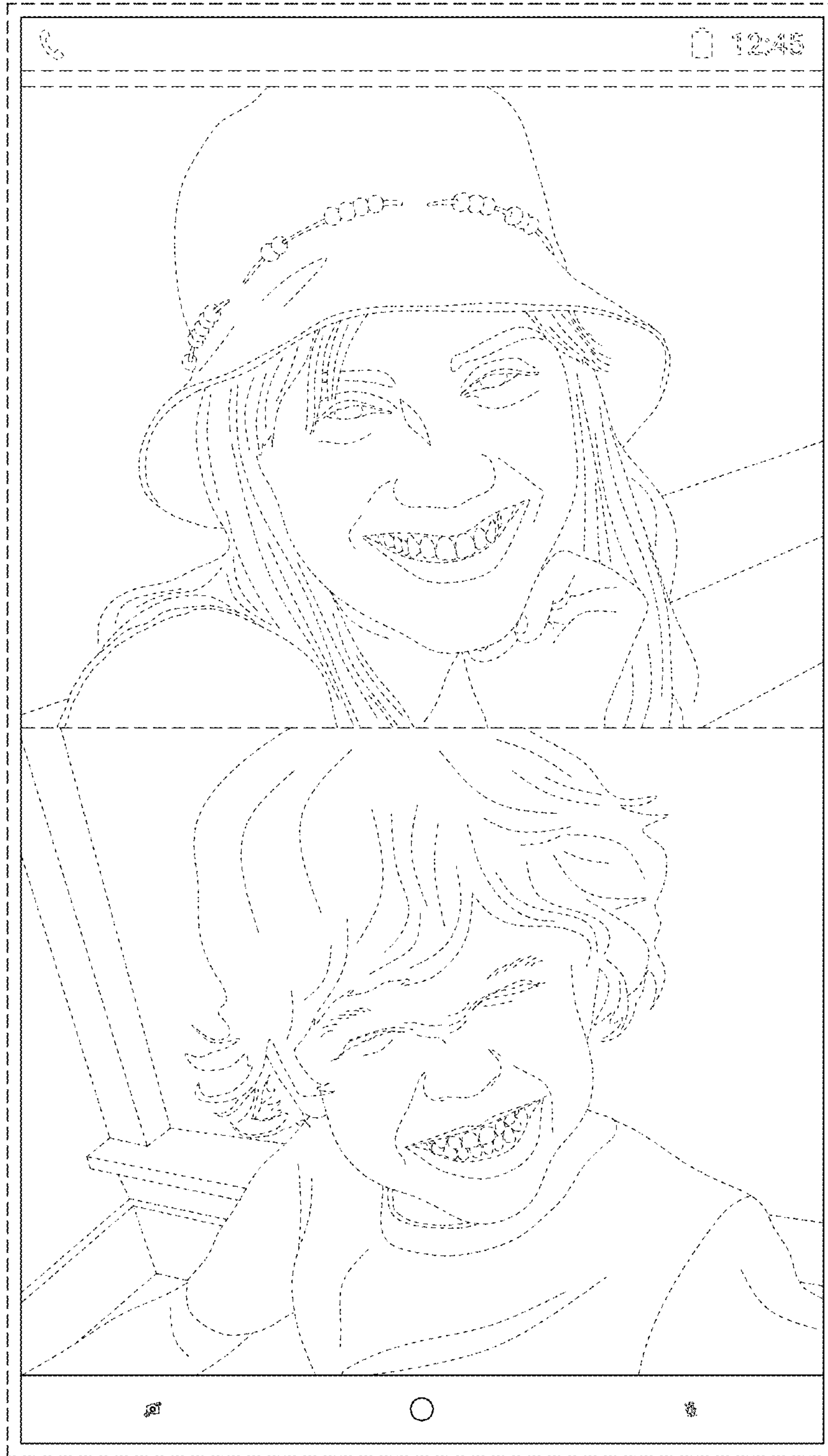
