(57) **CLAIM**

The ornamental design for a vertically-oriented, translucent transaction card, as shown and described.

DESCRIPTION

FIG. 1 depicts a perspective view of a front face of a vertically-oriented, translucent transaction card.
FIG. 2 depicts a front elevational view of FIG. 1.
FIG. 3 depicts a back elevational view of FIG. 1.
FIG. 4 depicts a side elevational view of FIG. 1.
FIG. 5 depicts an opposite side elevational view of FIG. 1.
FIG. 6 depicts a bottom plan view of FIG. 1; and,
FIG. 7 depicts a top plan view of FIG. 1.
The broken lines in the drawings illustrate environmental structure on the article and form no part of the claimed design.

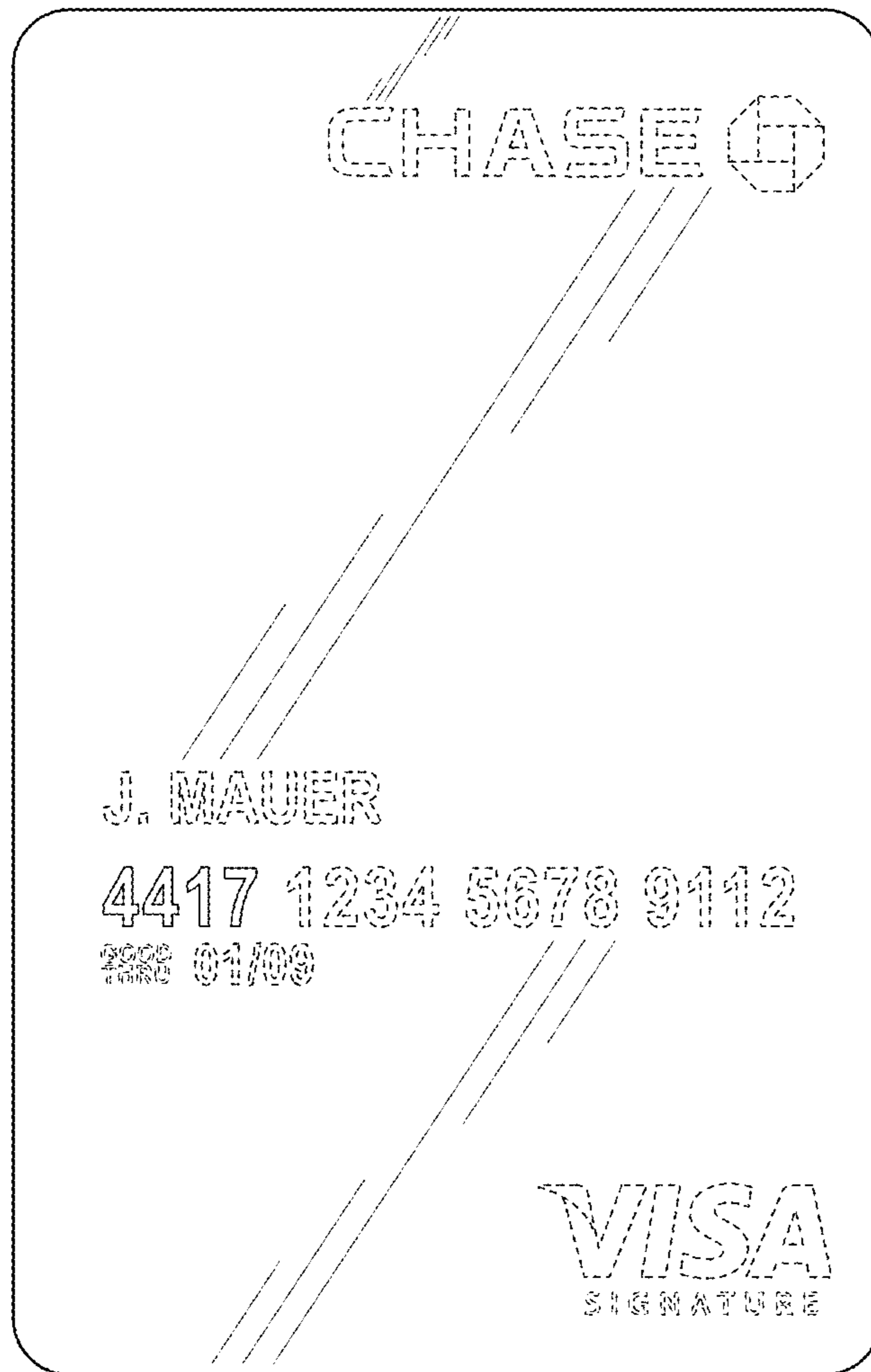

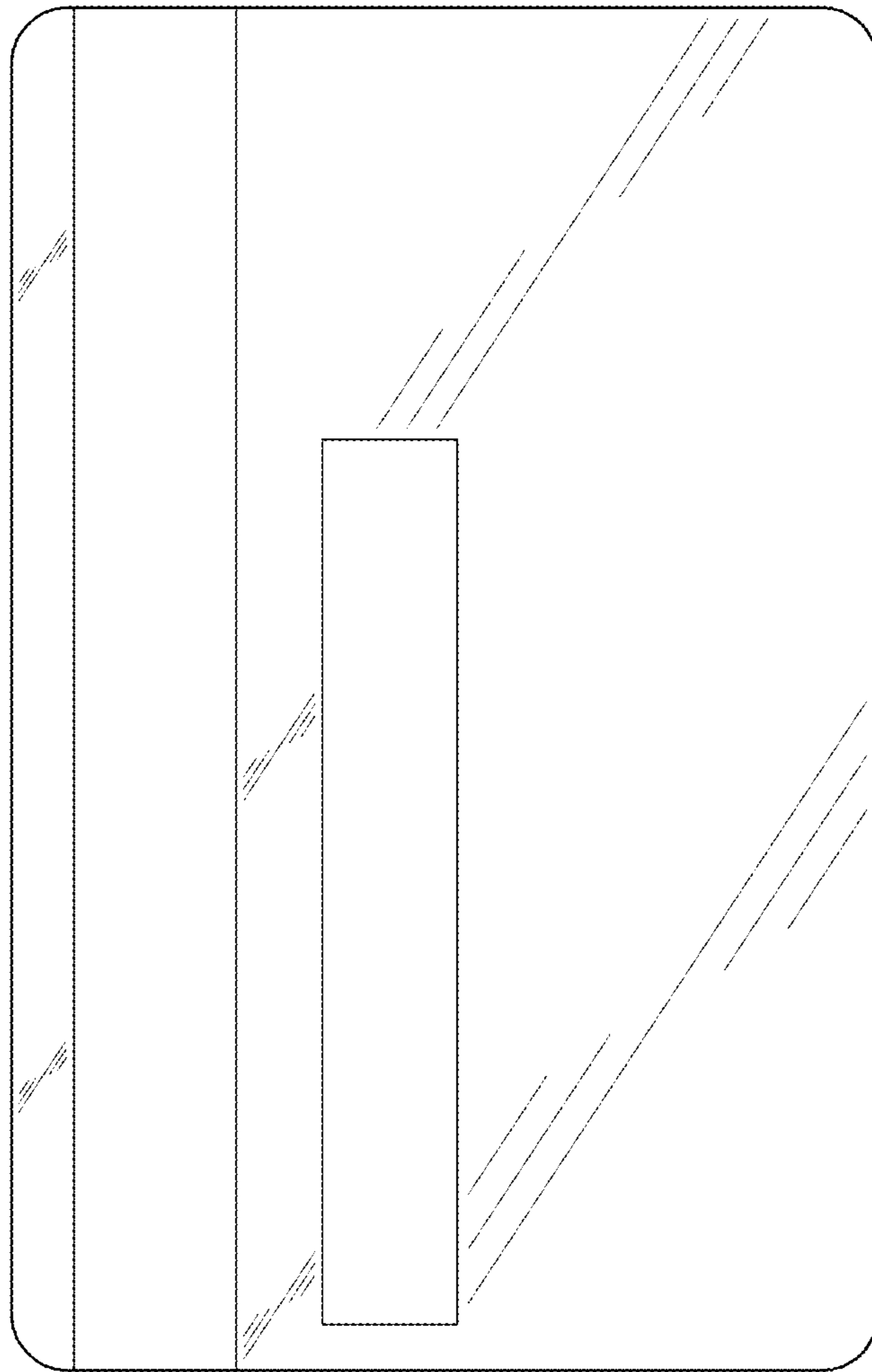

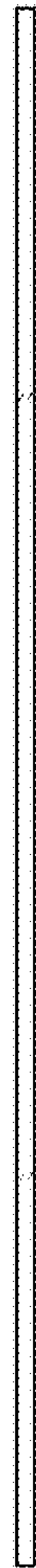

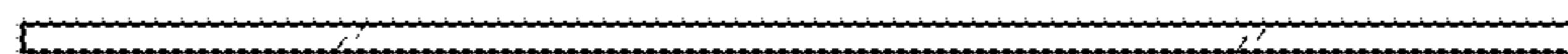

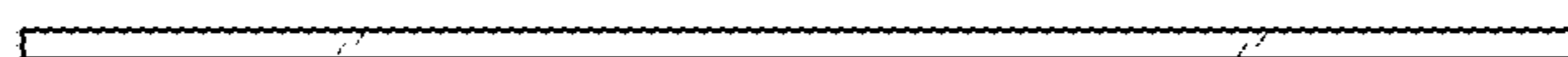
