(57) **CLAIM**

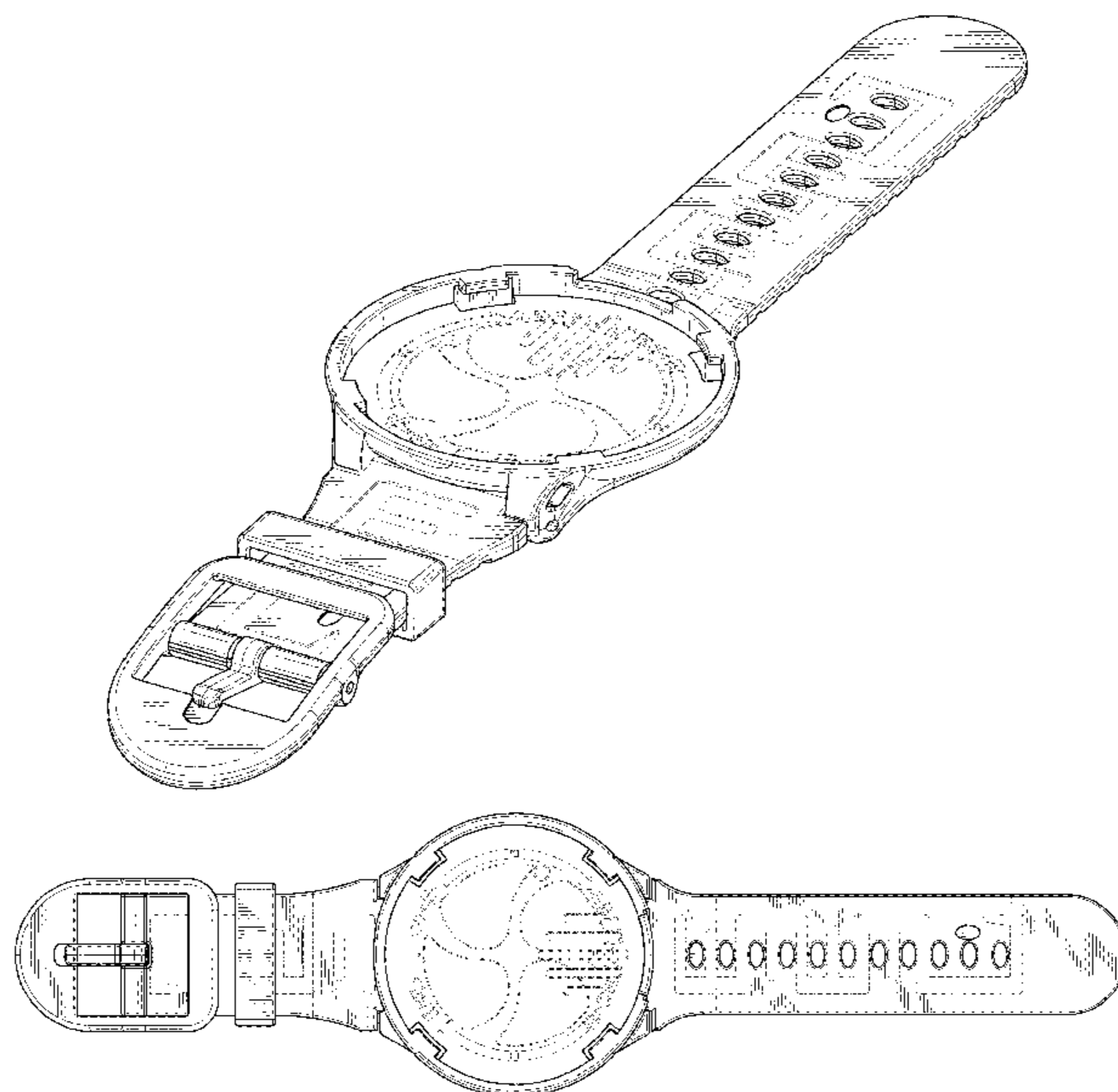
The ornamental design for a strap for watch-shaped toy, as shown and described.

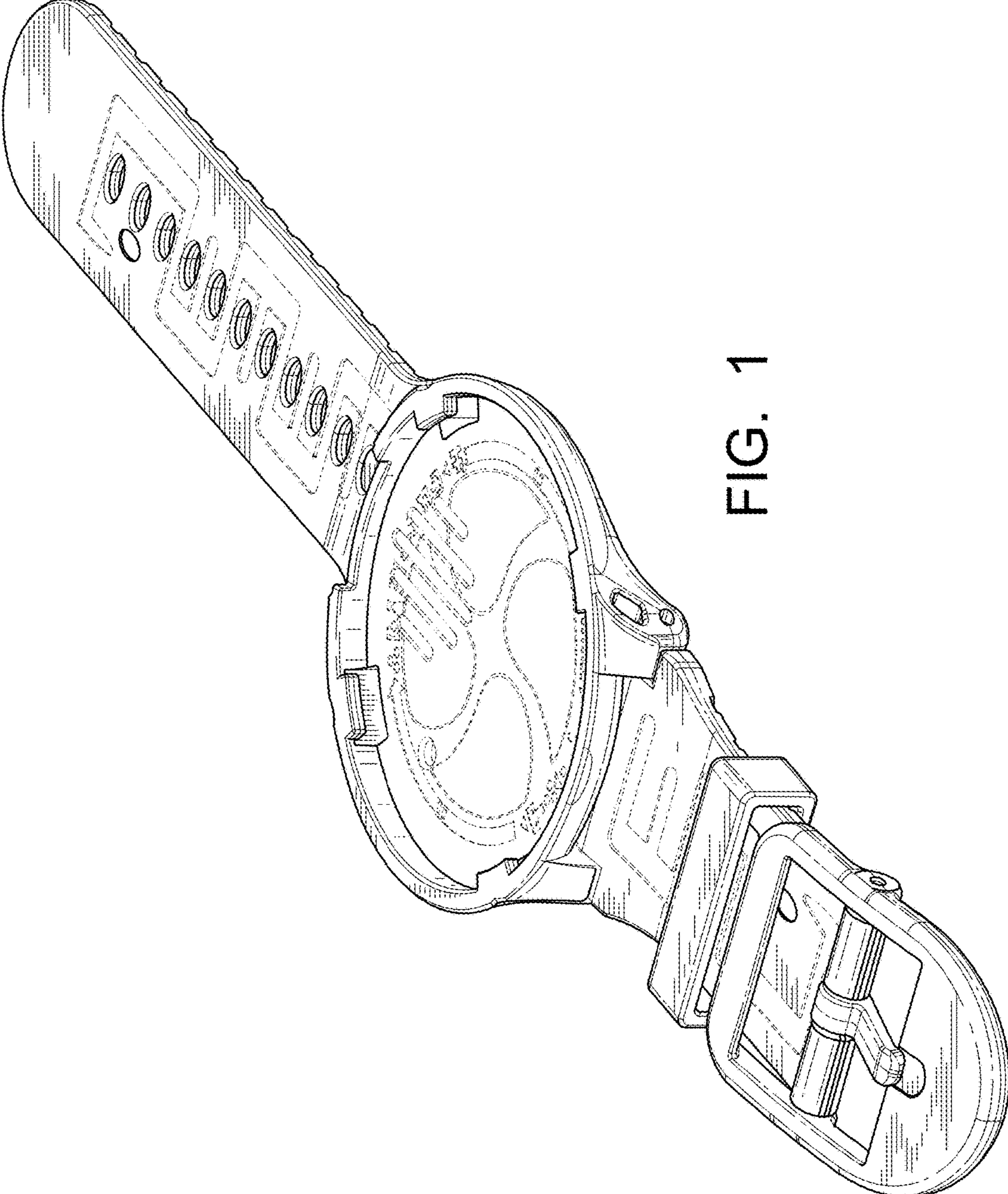

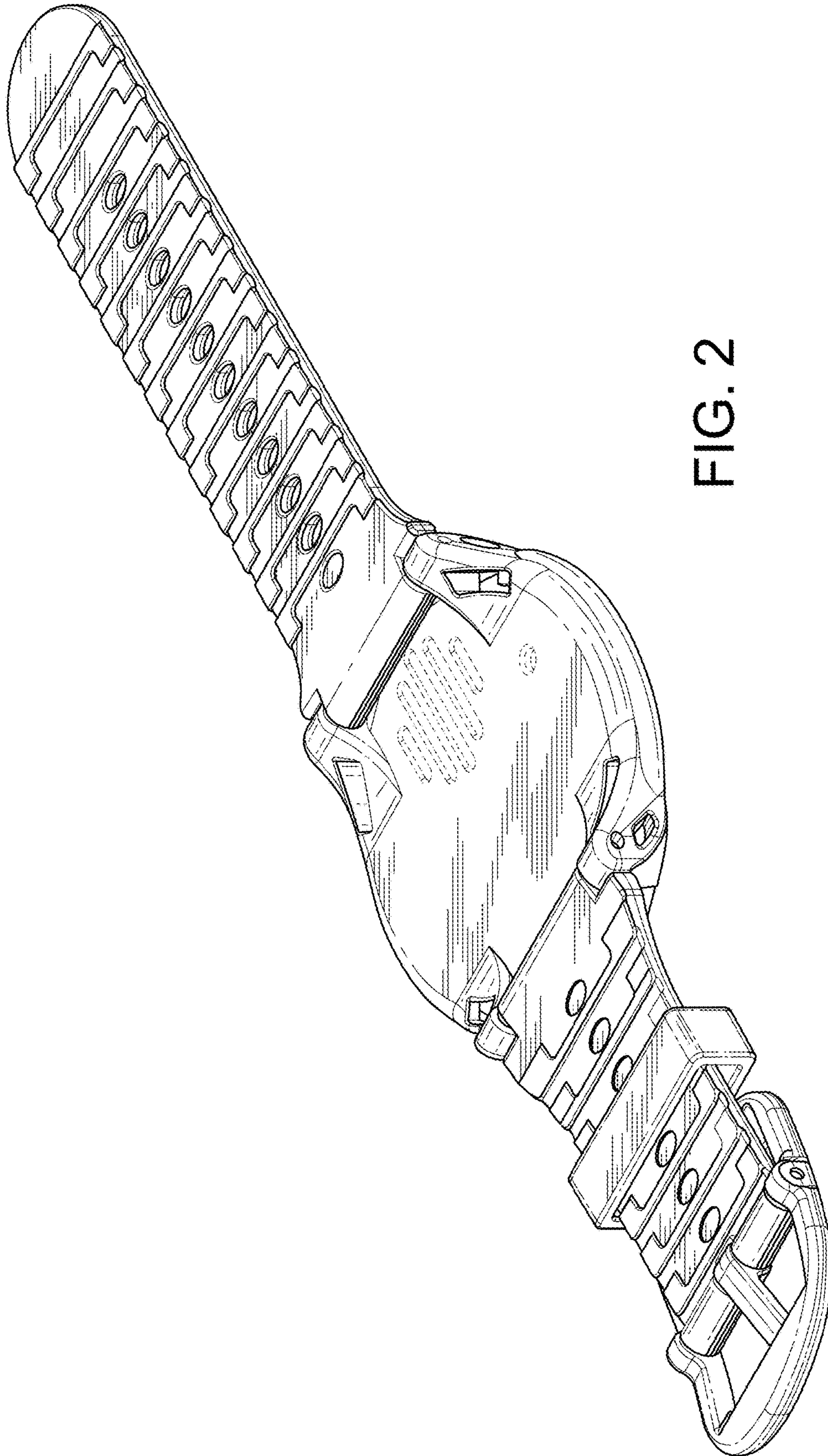

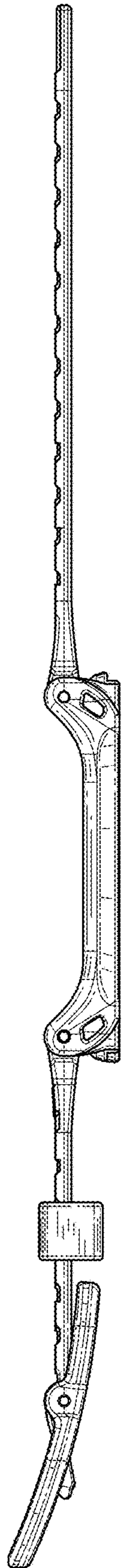

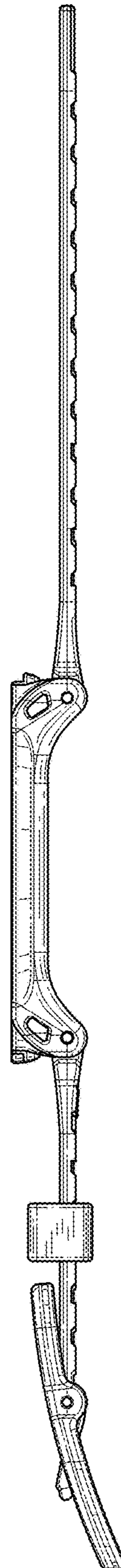

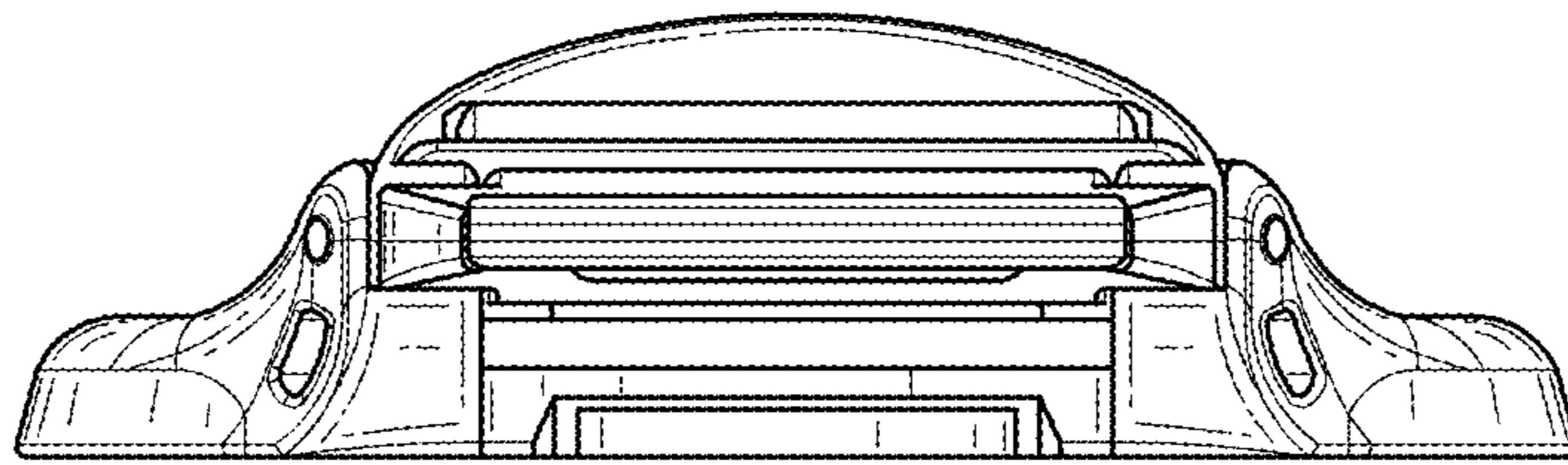

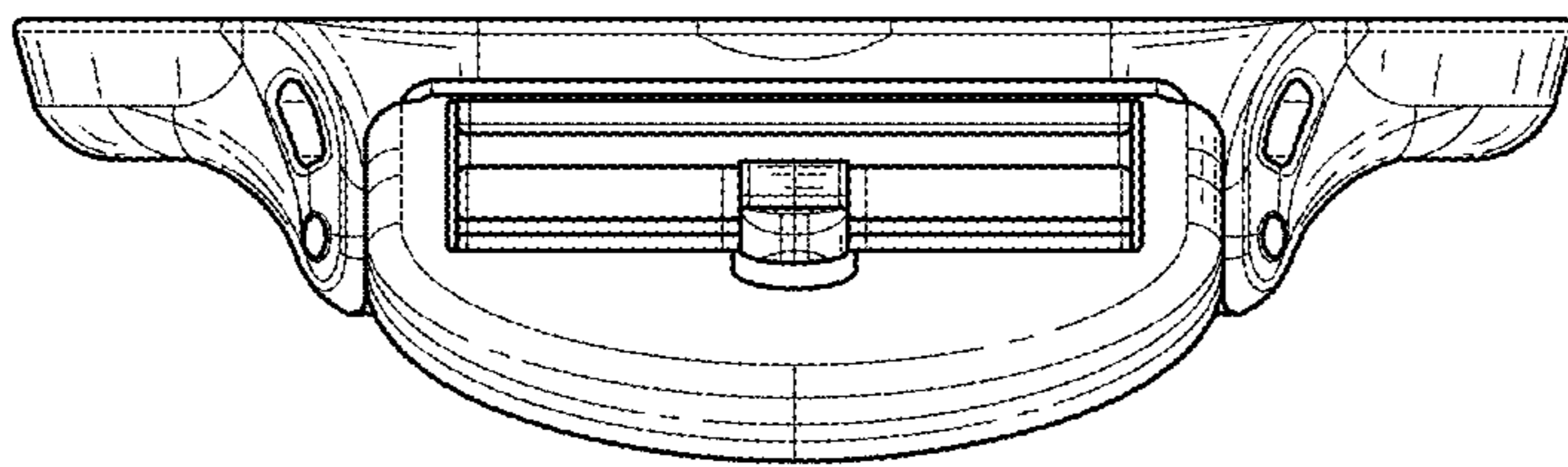

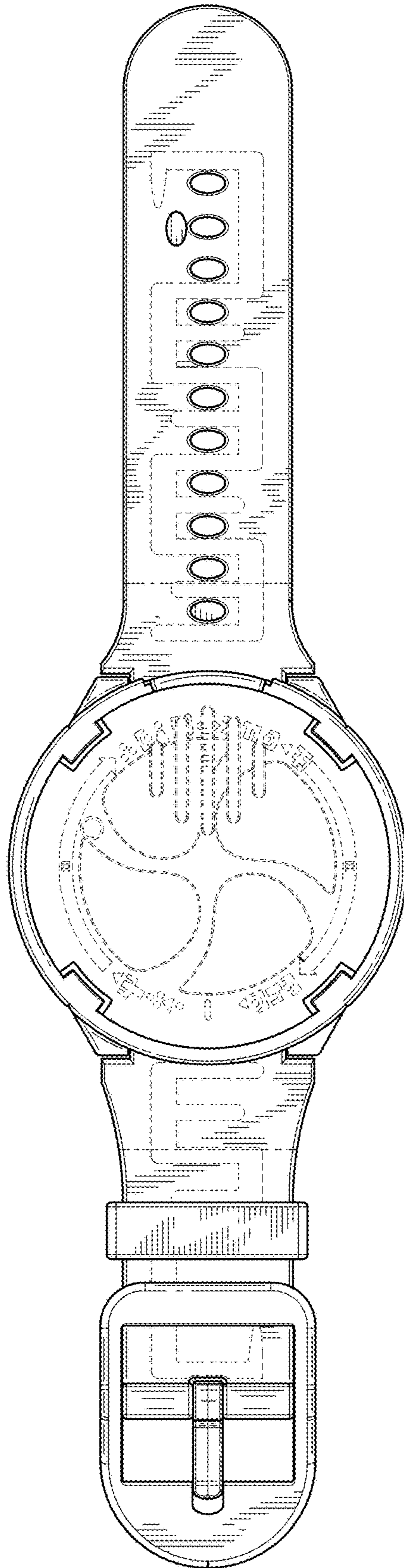

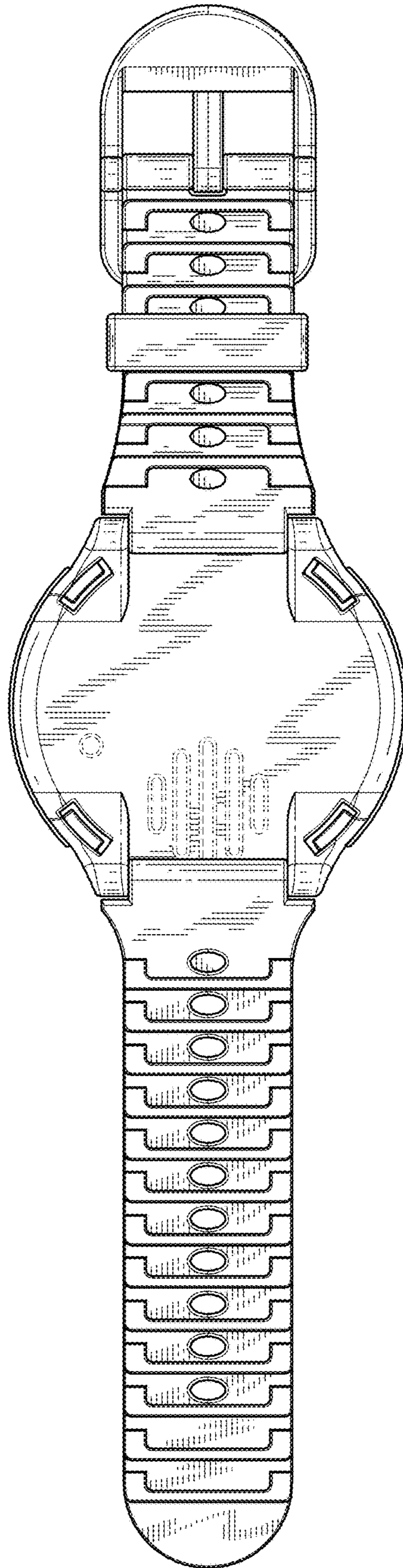
