DESCRIPTION

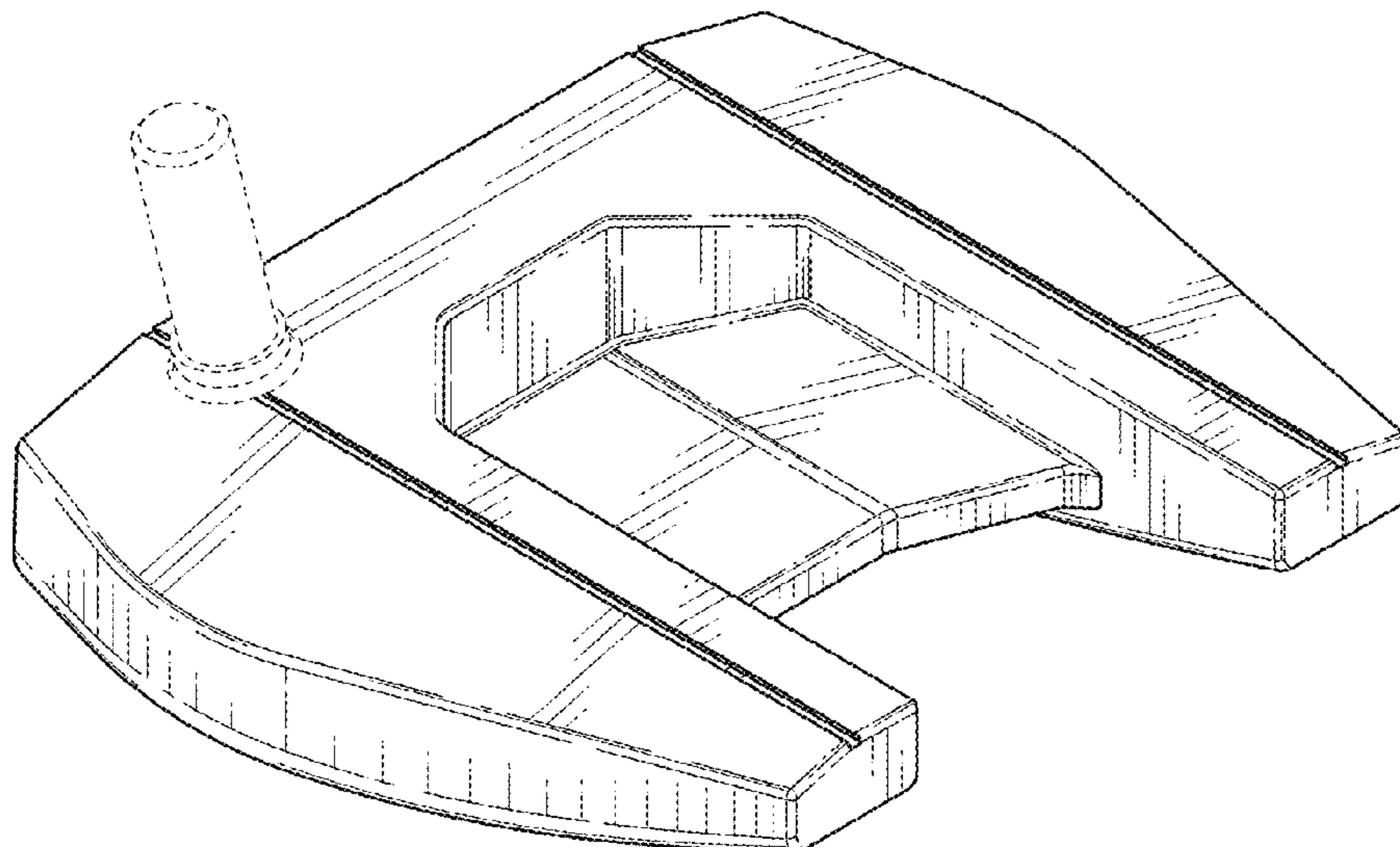
FIG. 1 is a rear perspective view of a the putter head as claimed herein;

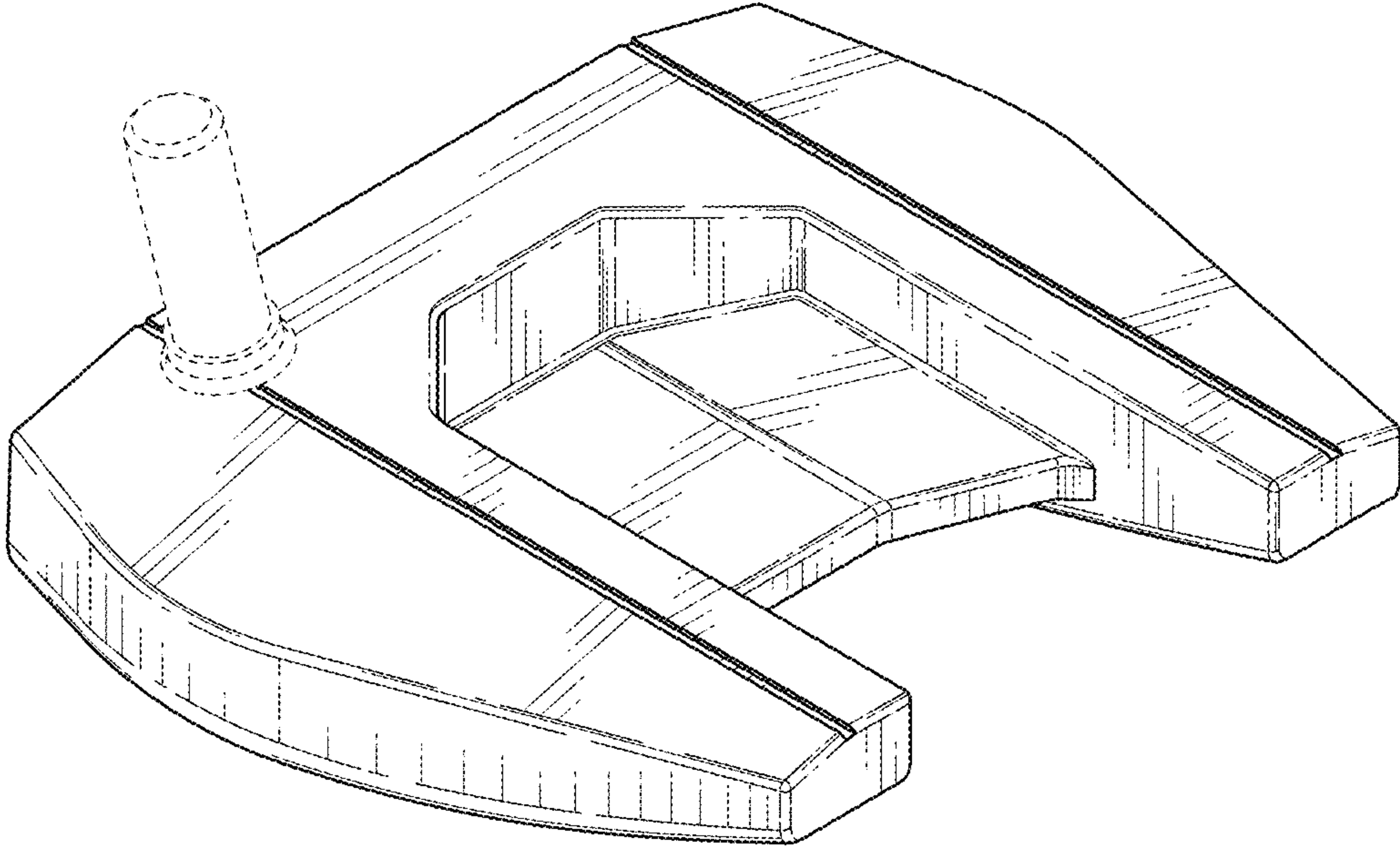

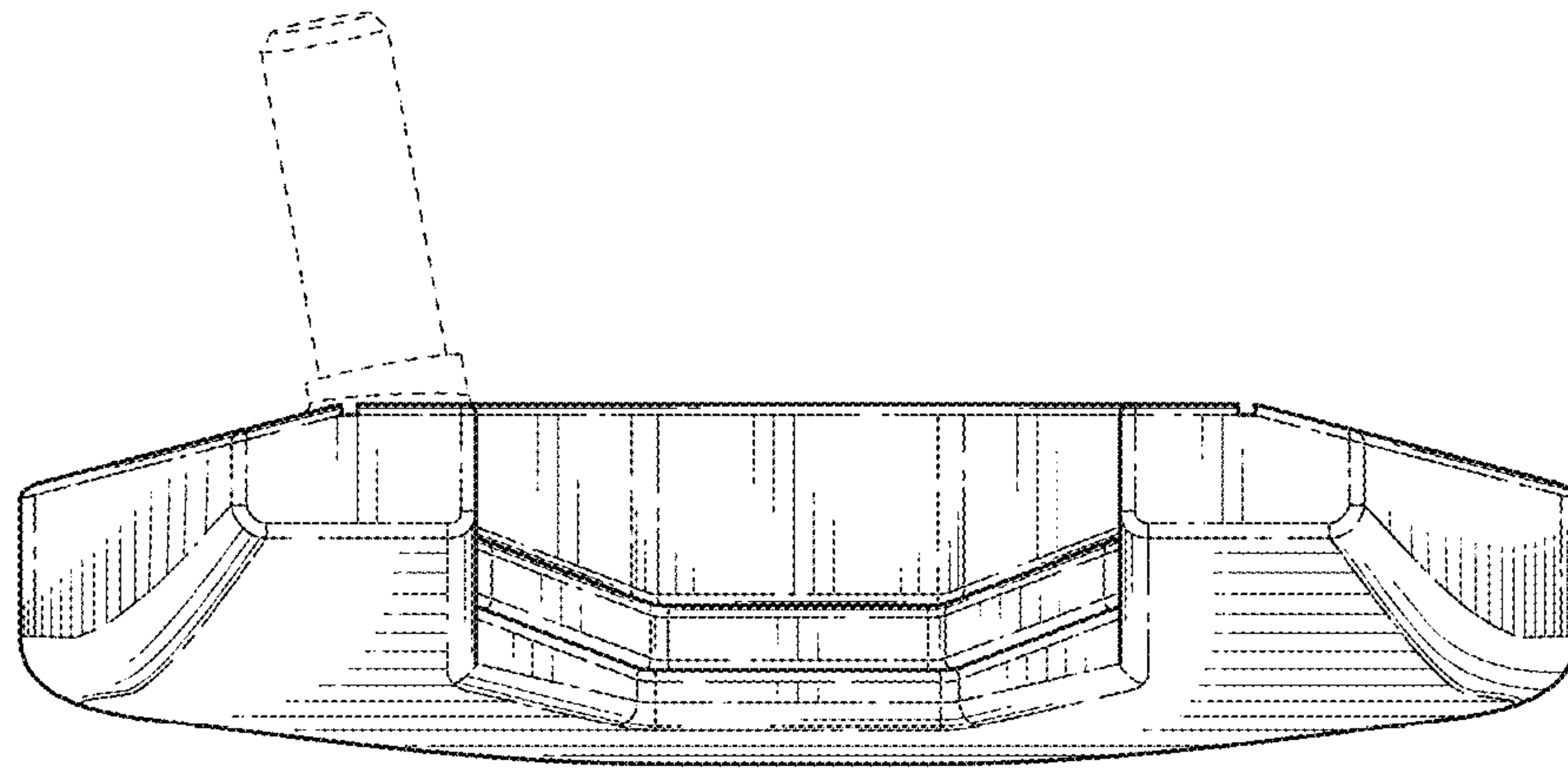

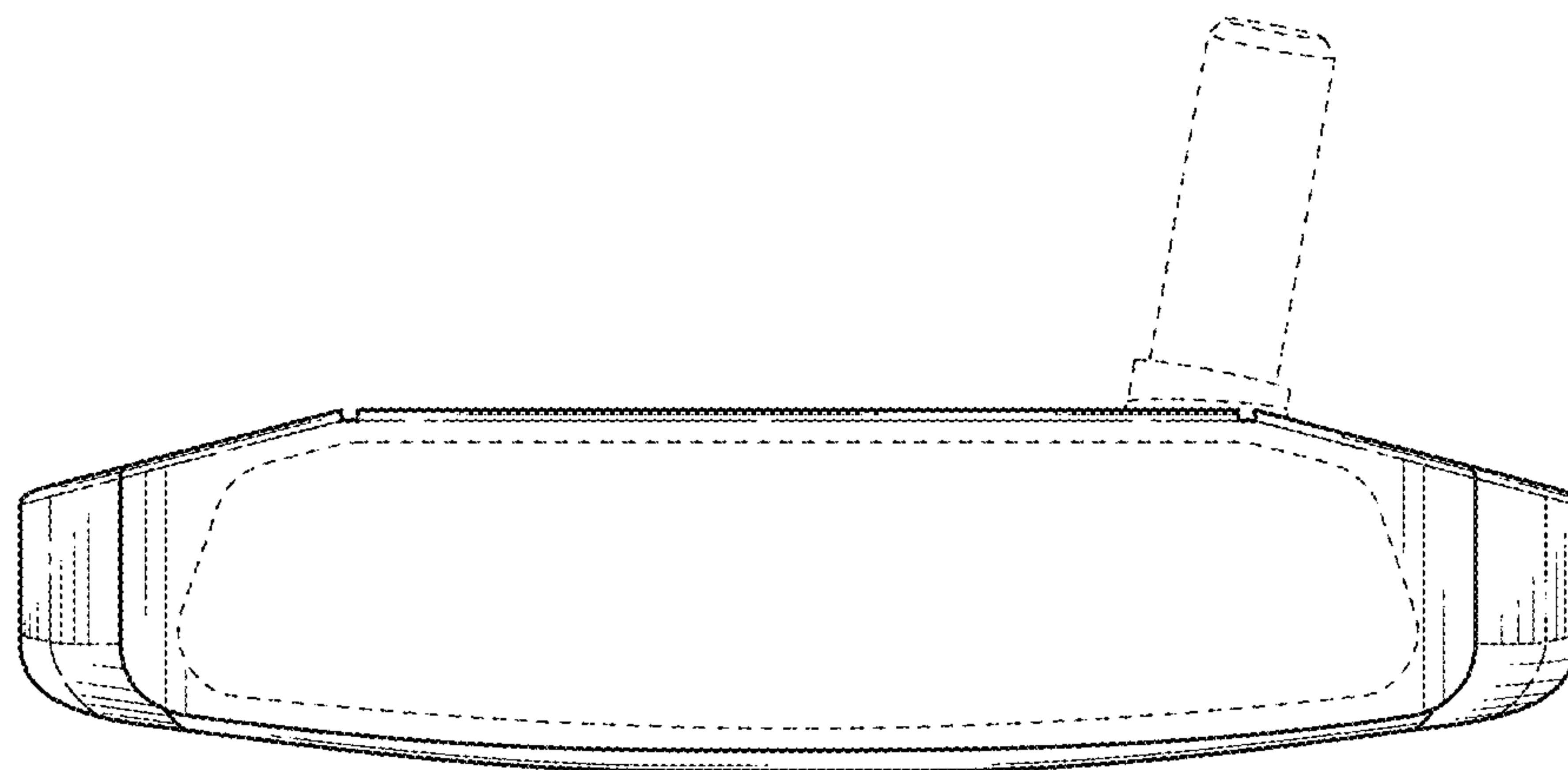

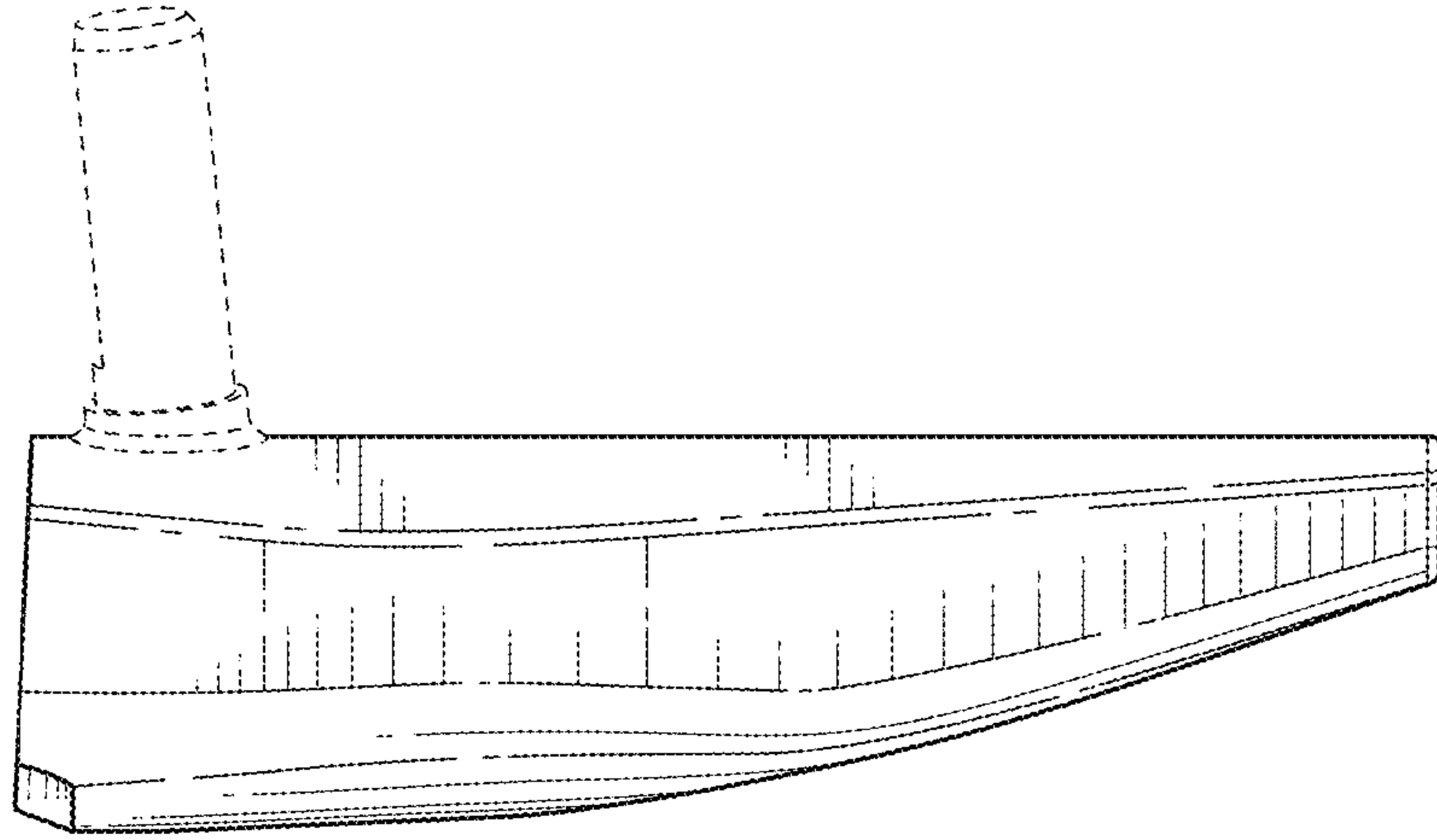

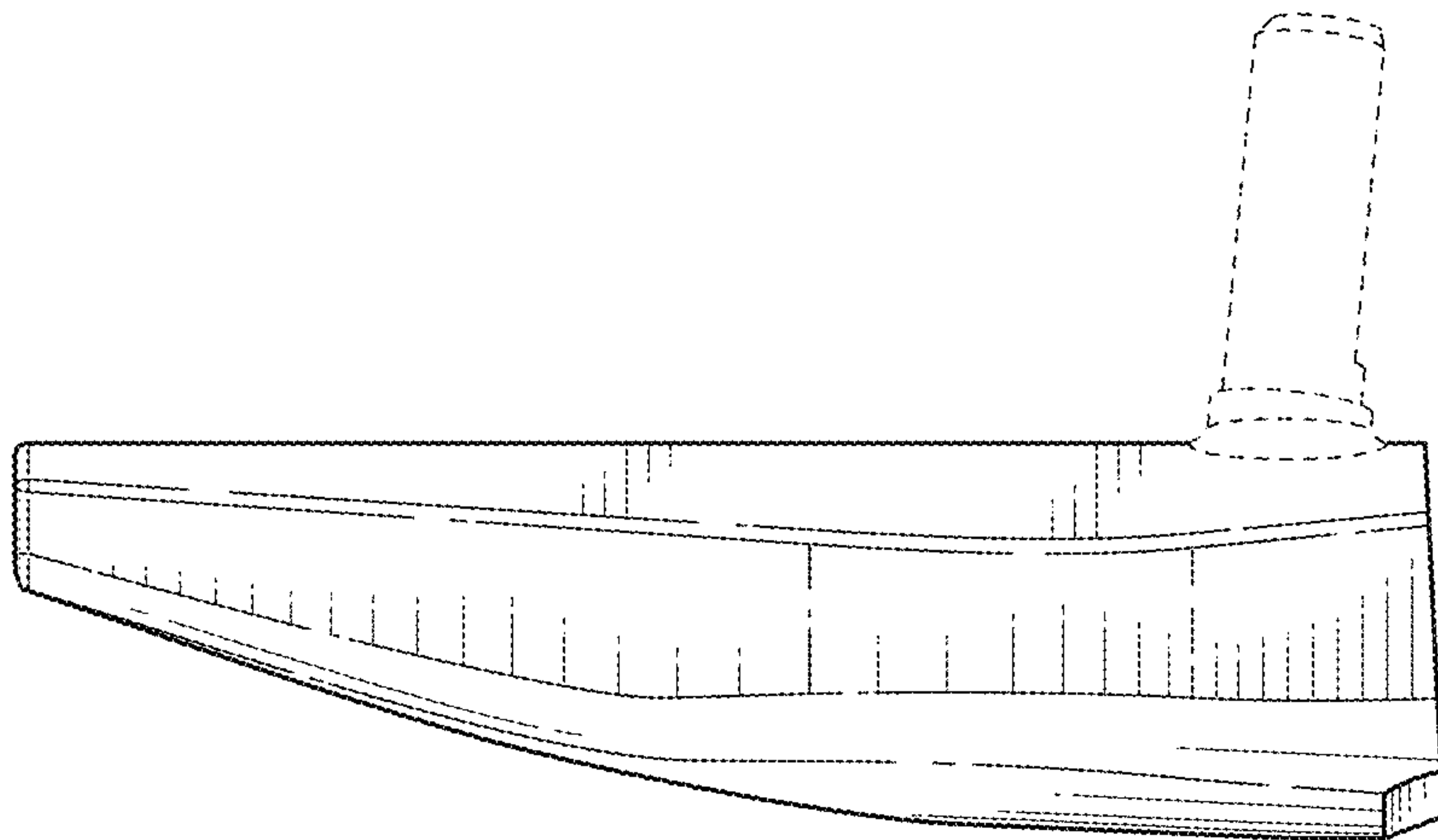

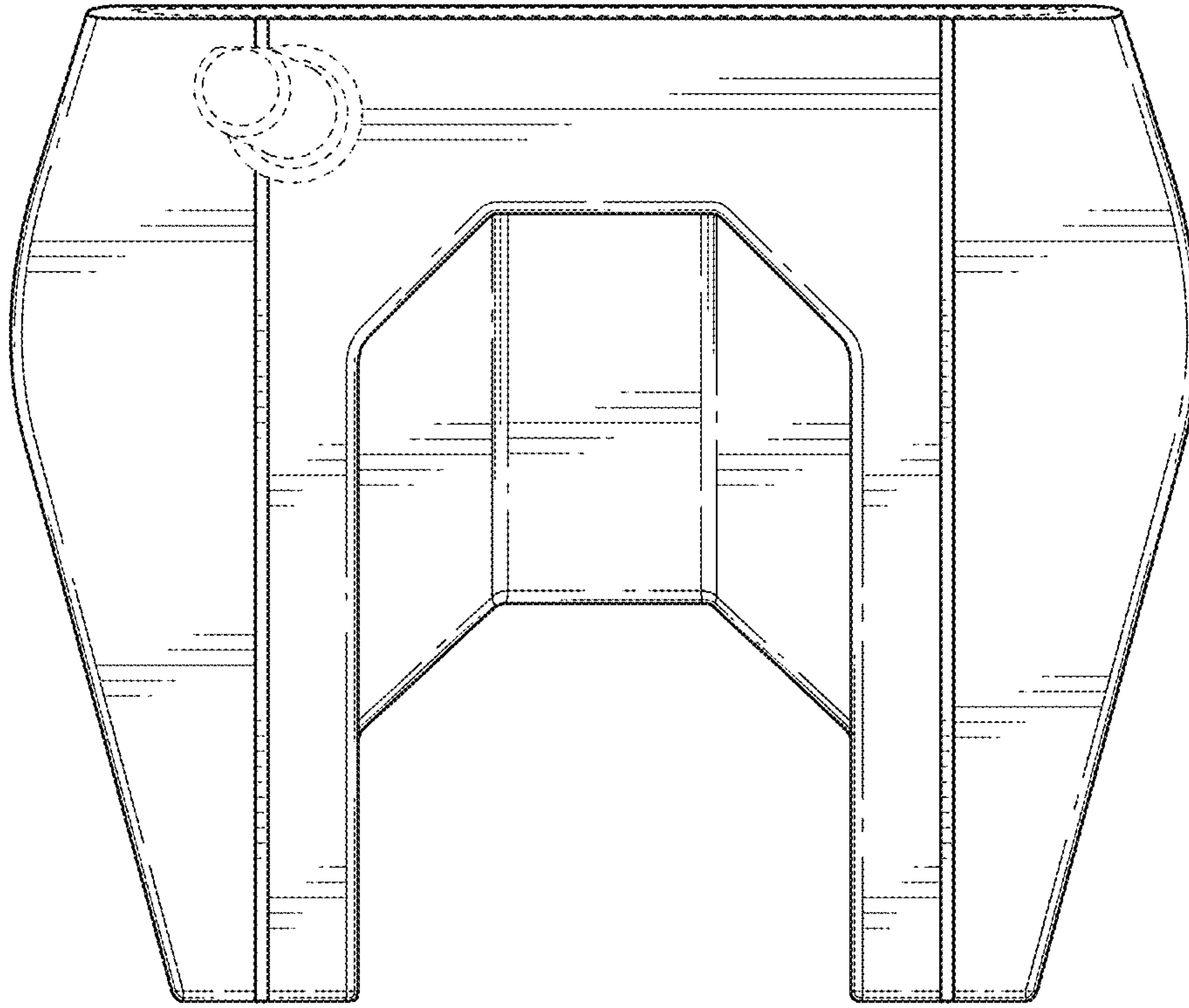

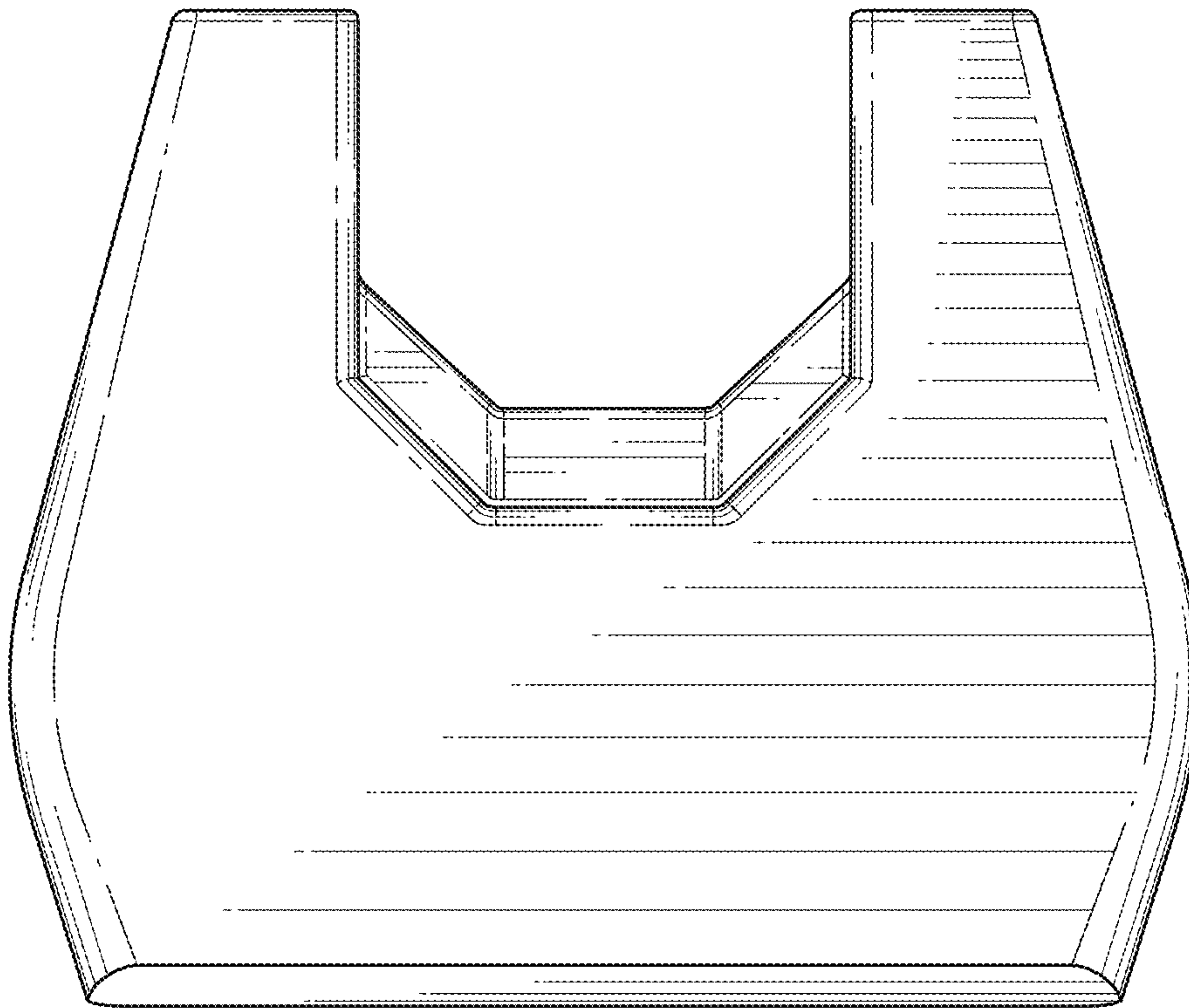
