FIG. 1.2 is a bottom plan view thereof;

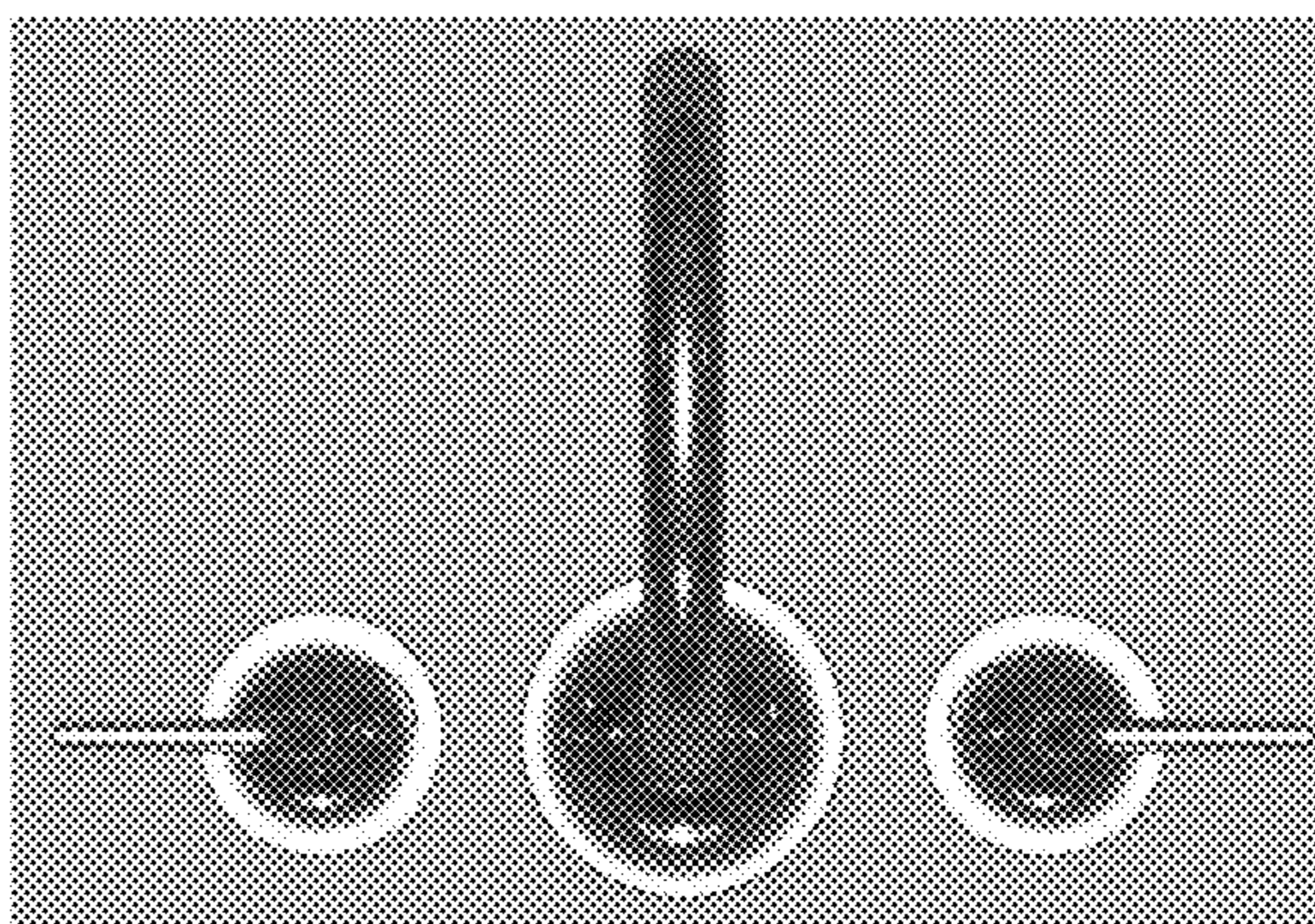
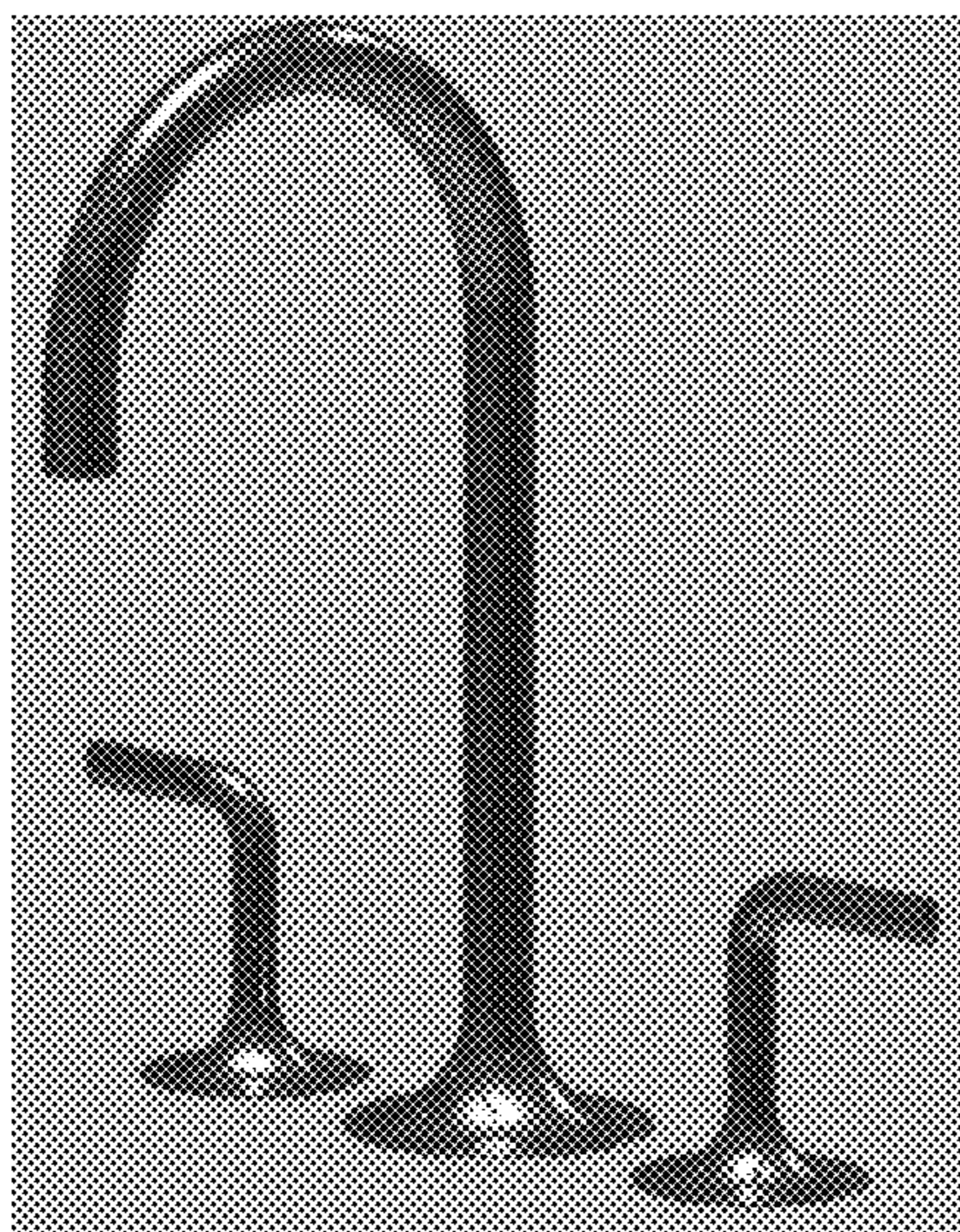
FIG. 1.3 is a front and right side perspective view thereof;

FIG. 1.4 is a right side elevation view thereof;

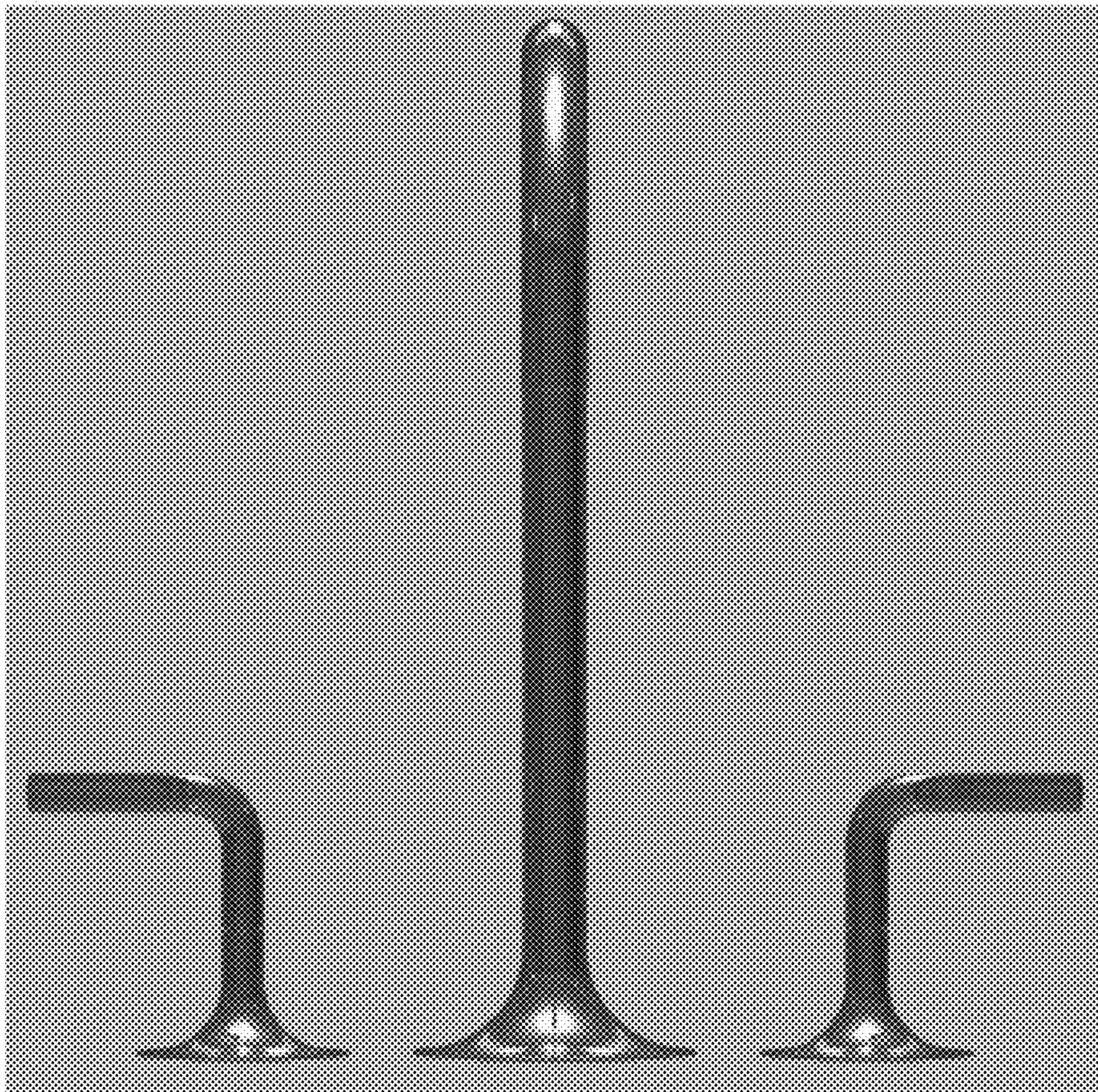
FIG. 1.5 is an left side elevation view thereof; and

FIG. 1.6 is a top plan view thereof.

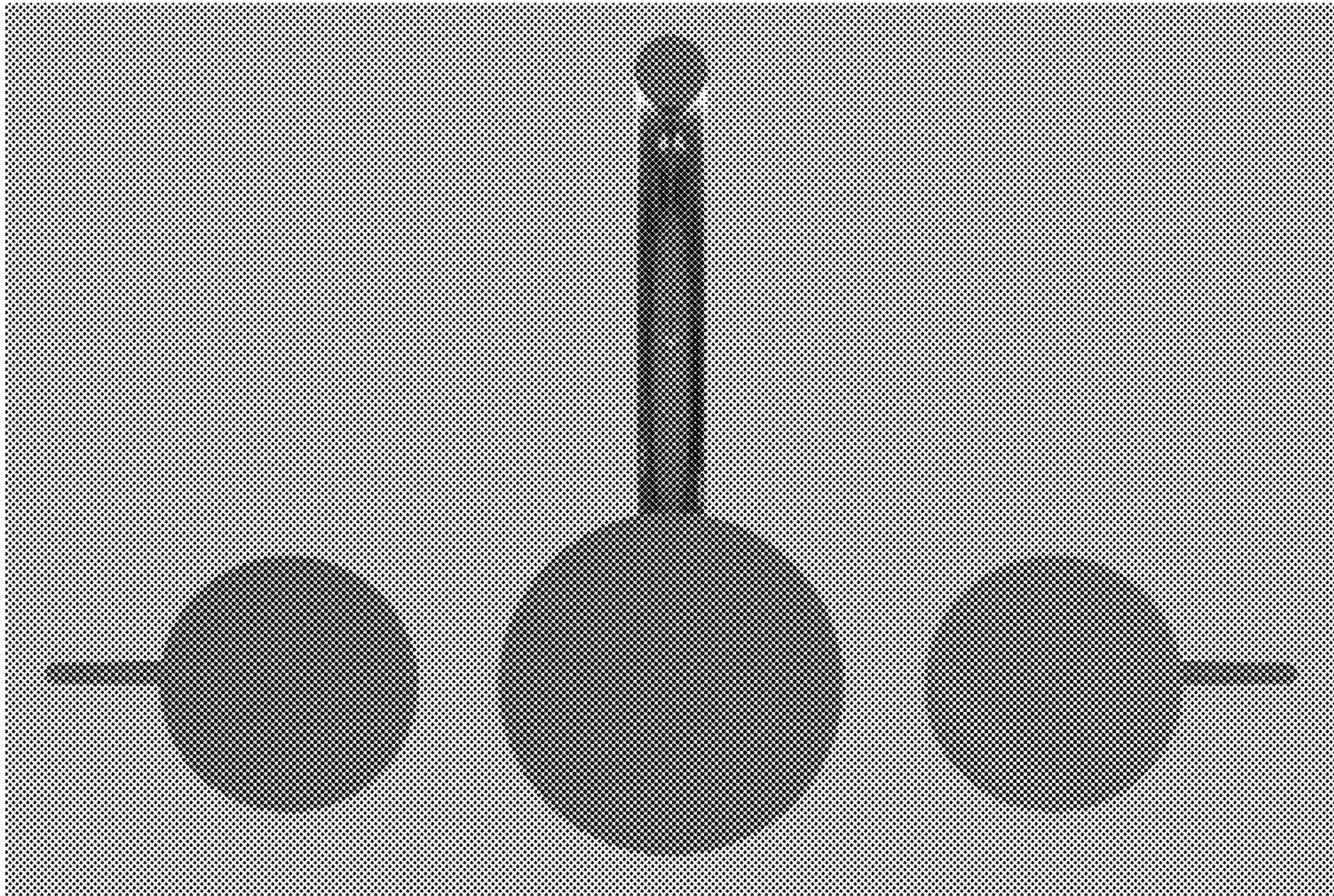

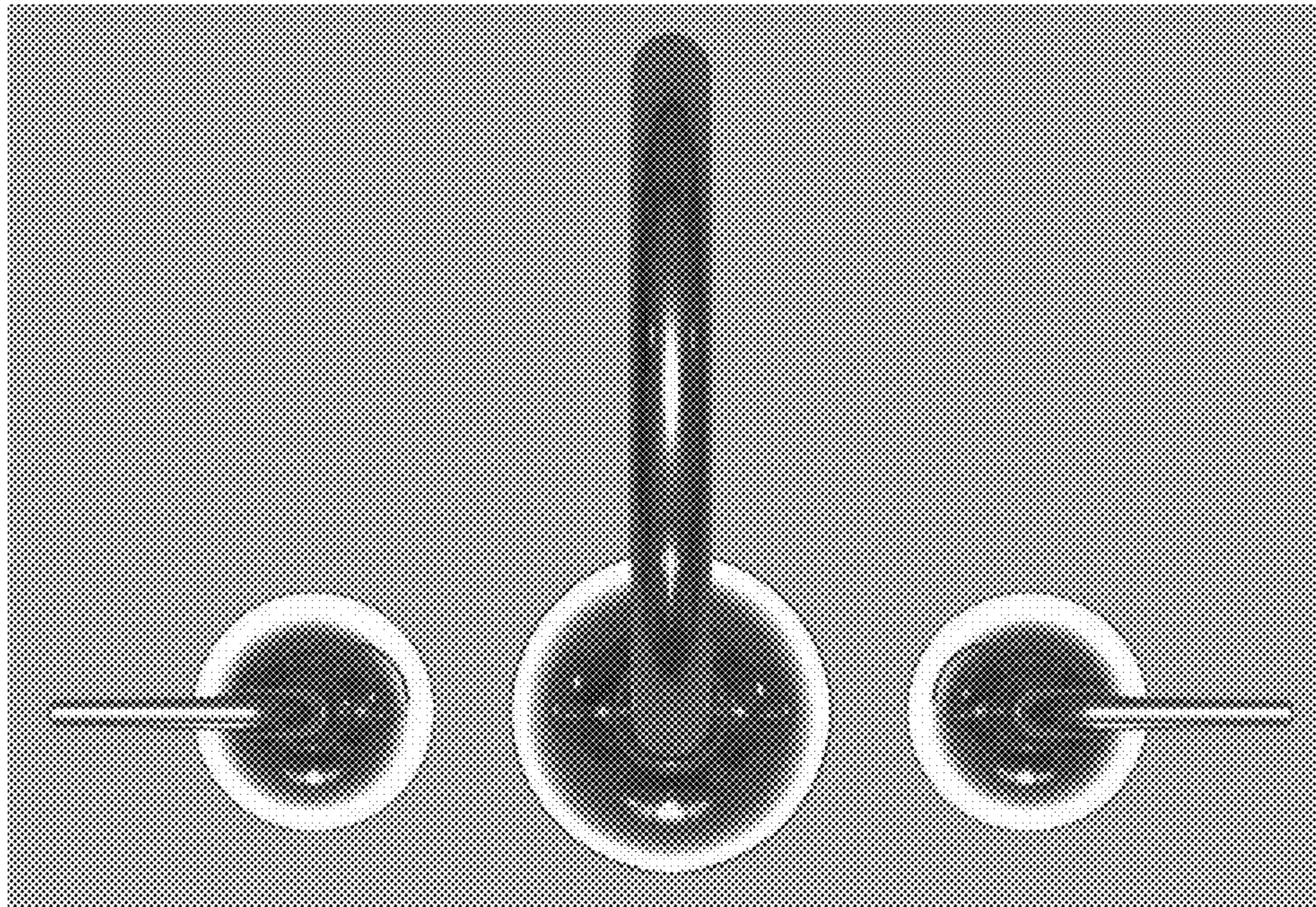

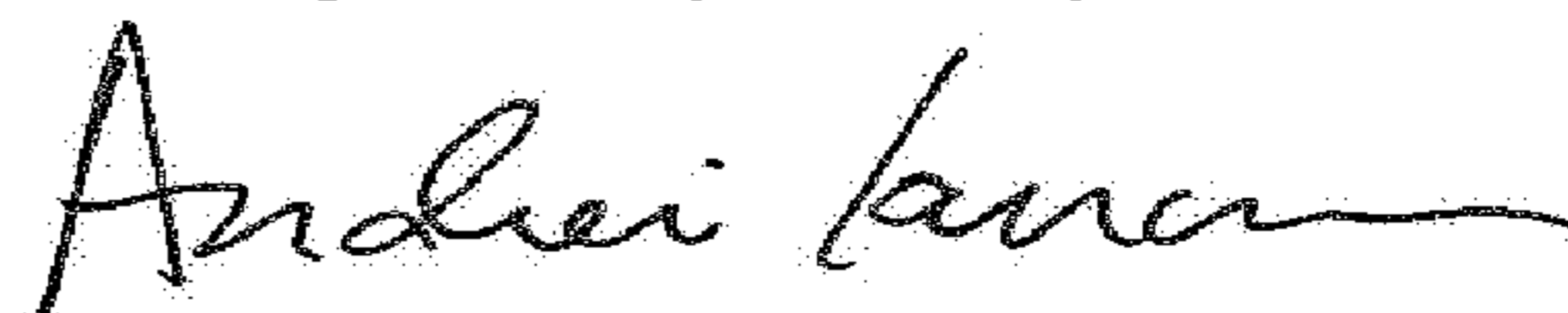
