The second embodiment of the vehicle daytime running lamp bezel is a mirror image of the first embodiment disclosed in FIGS. 1 through 9 and is not shown.

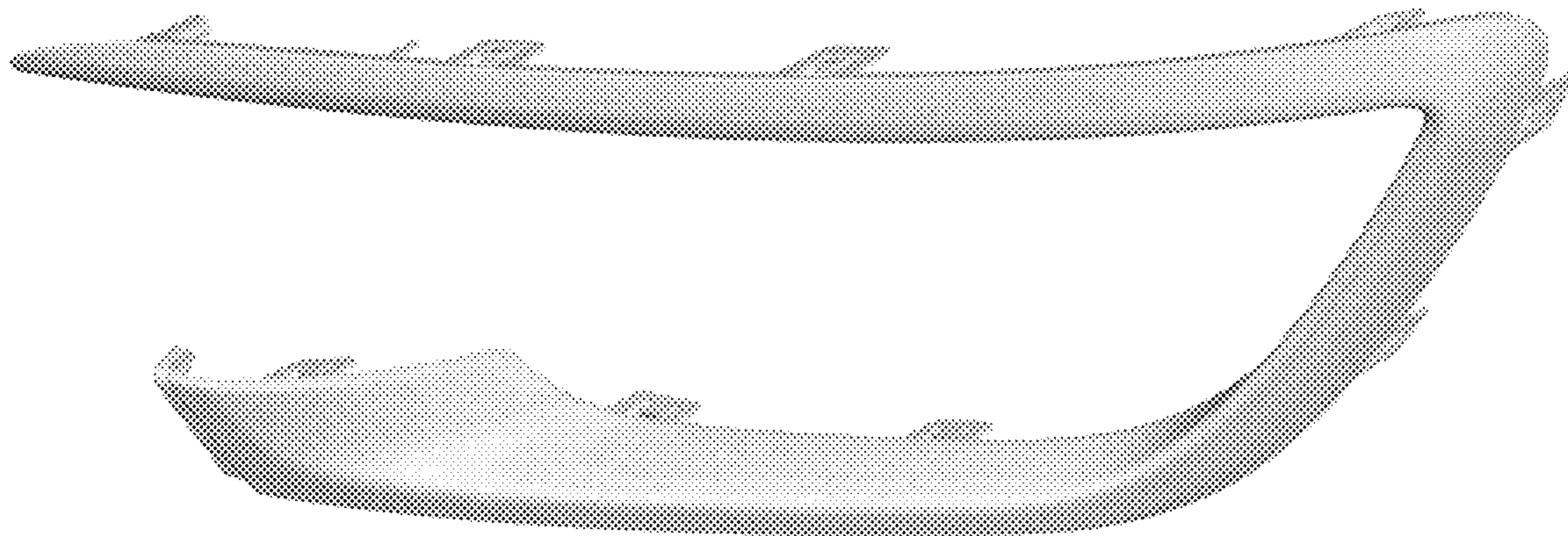

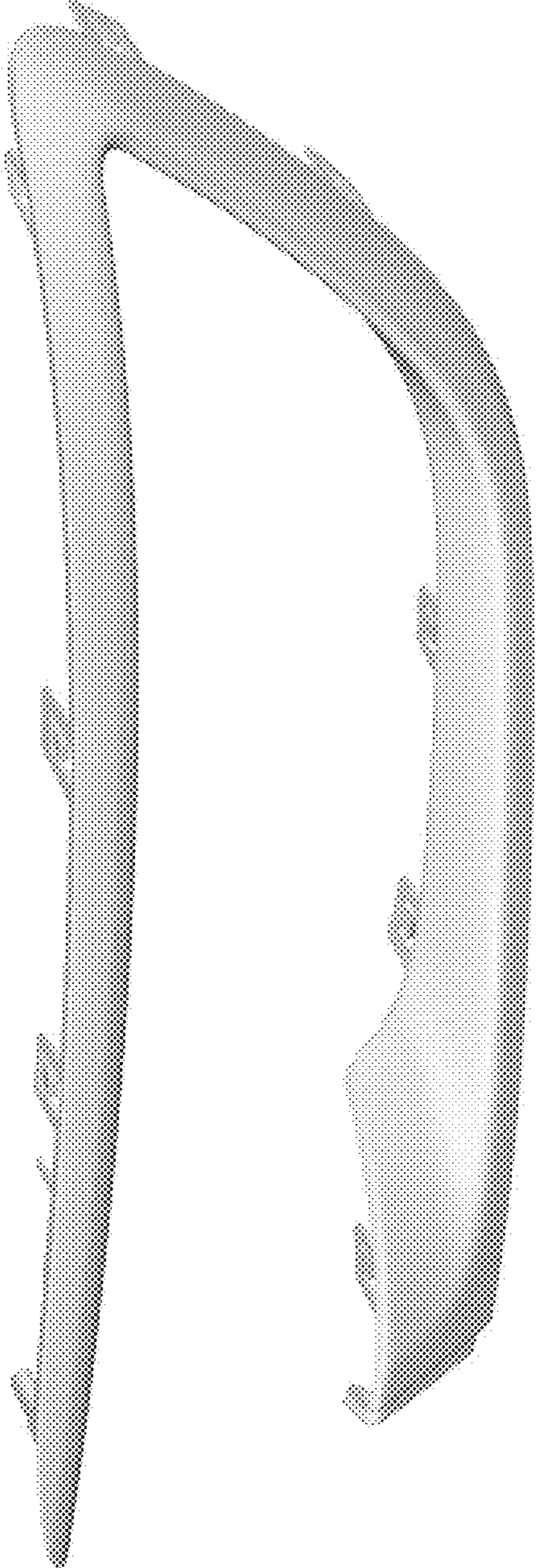

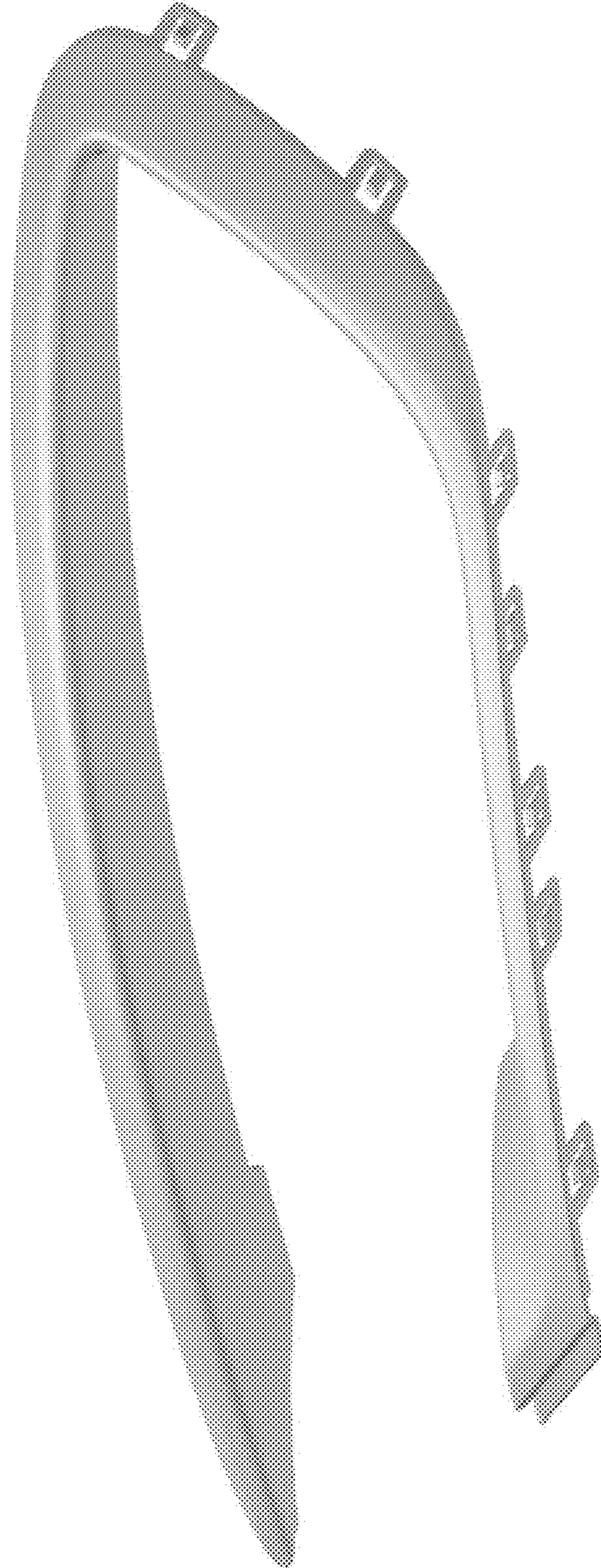

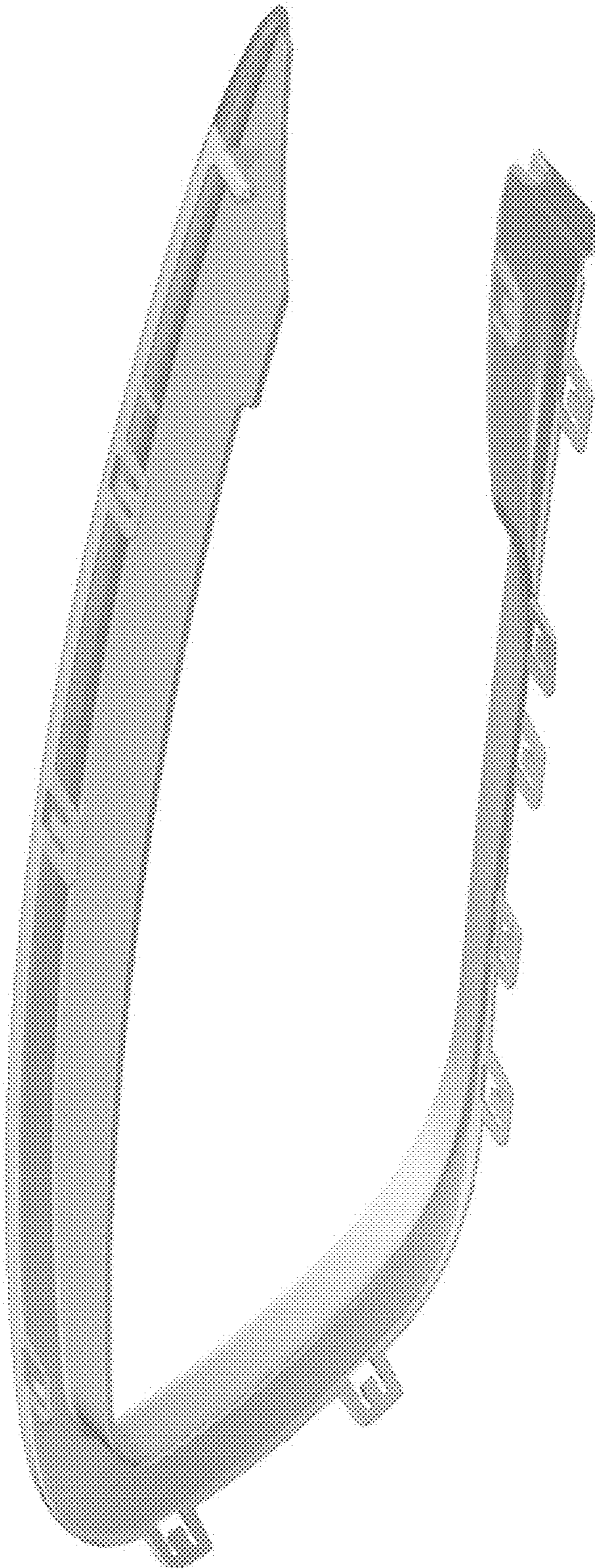

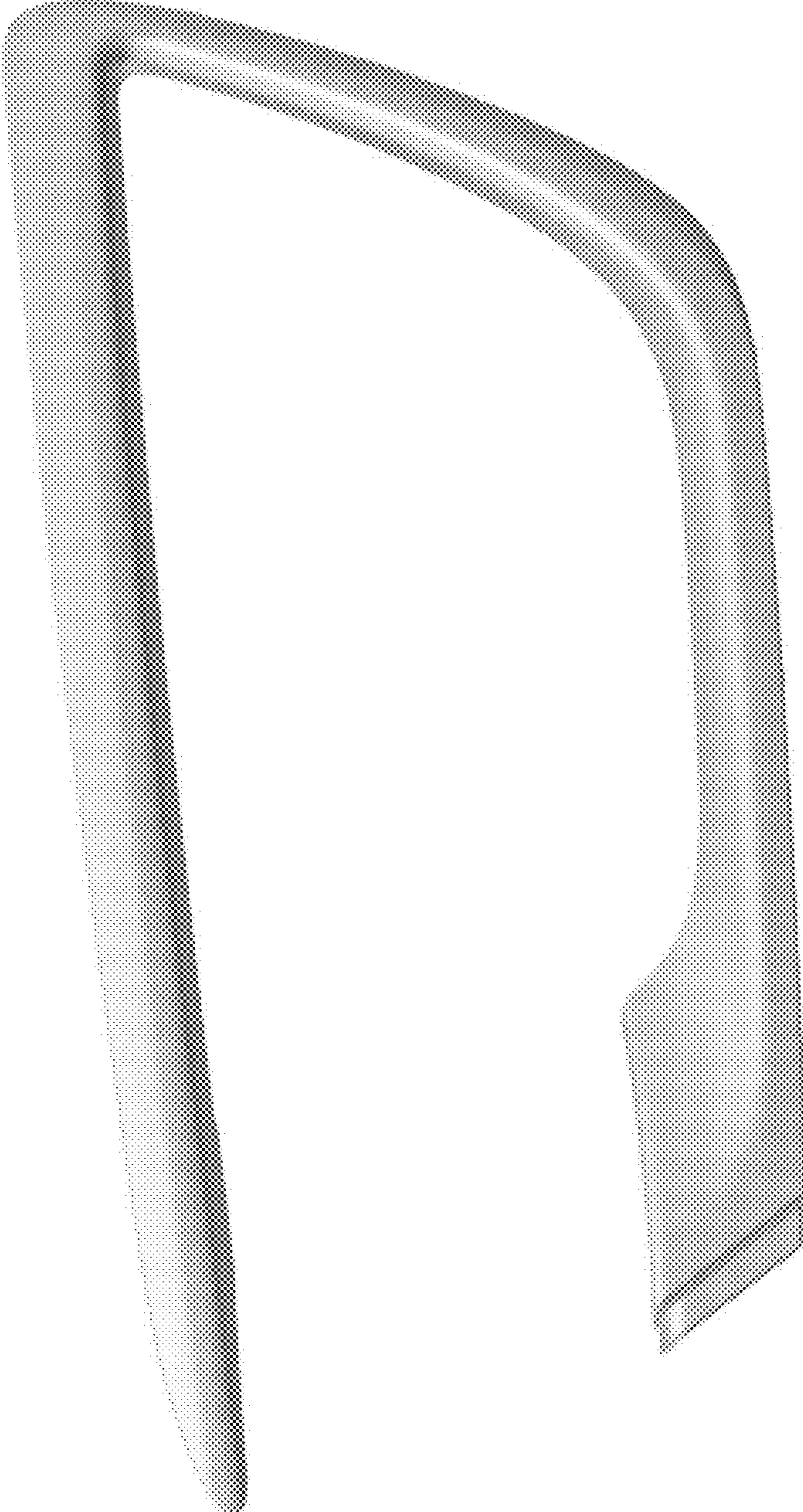

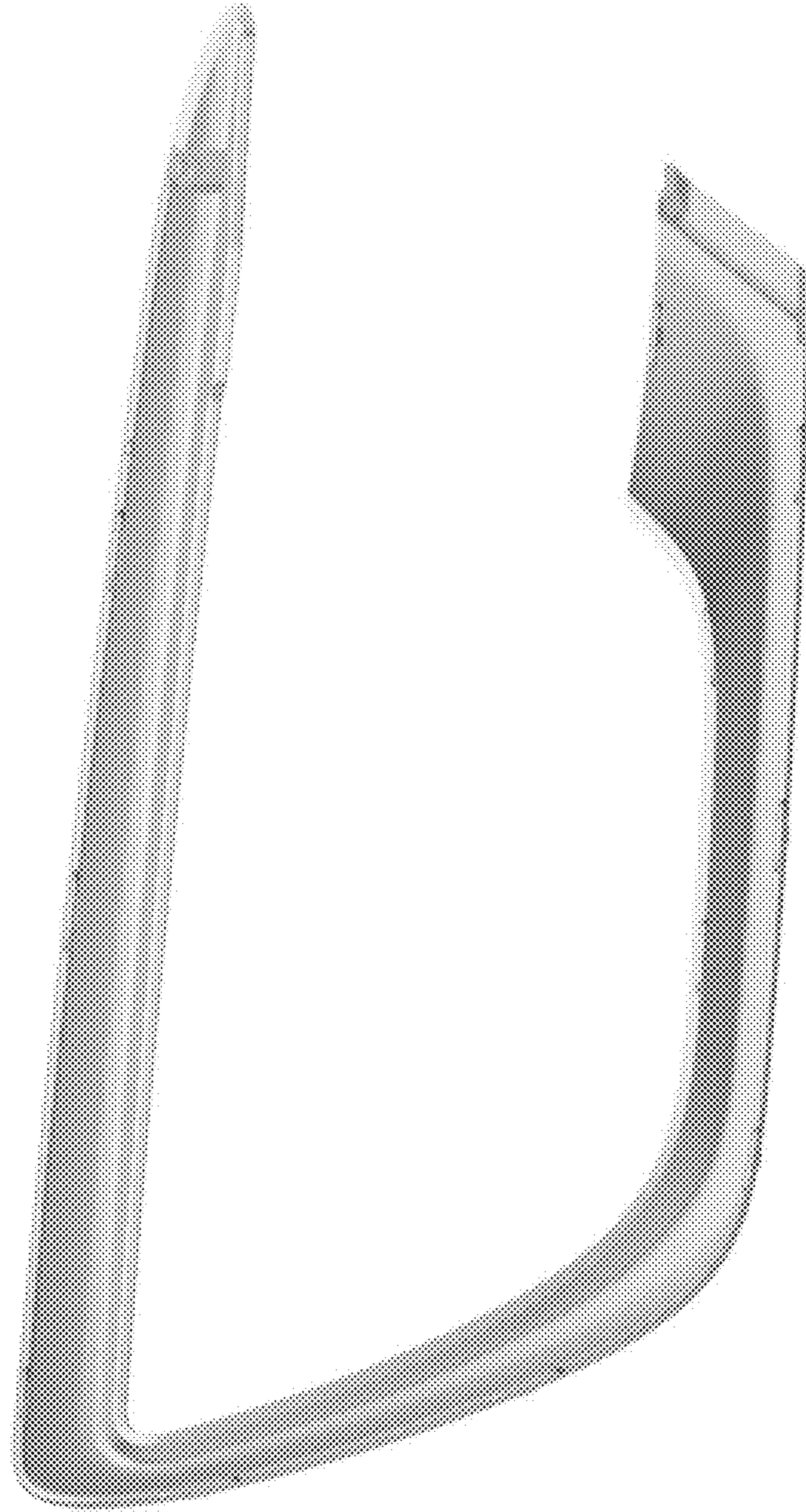

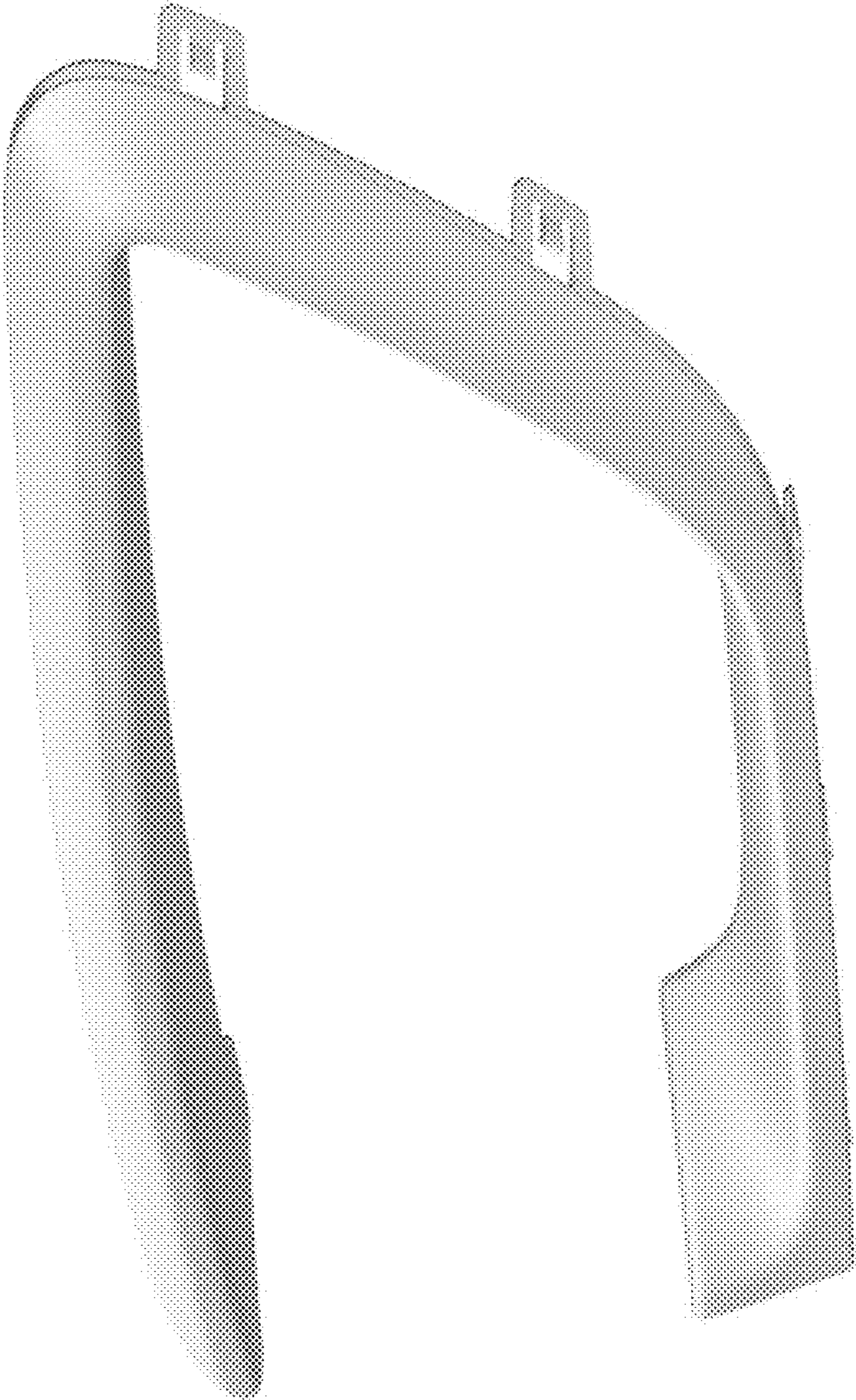

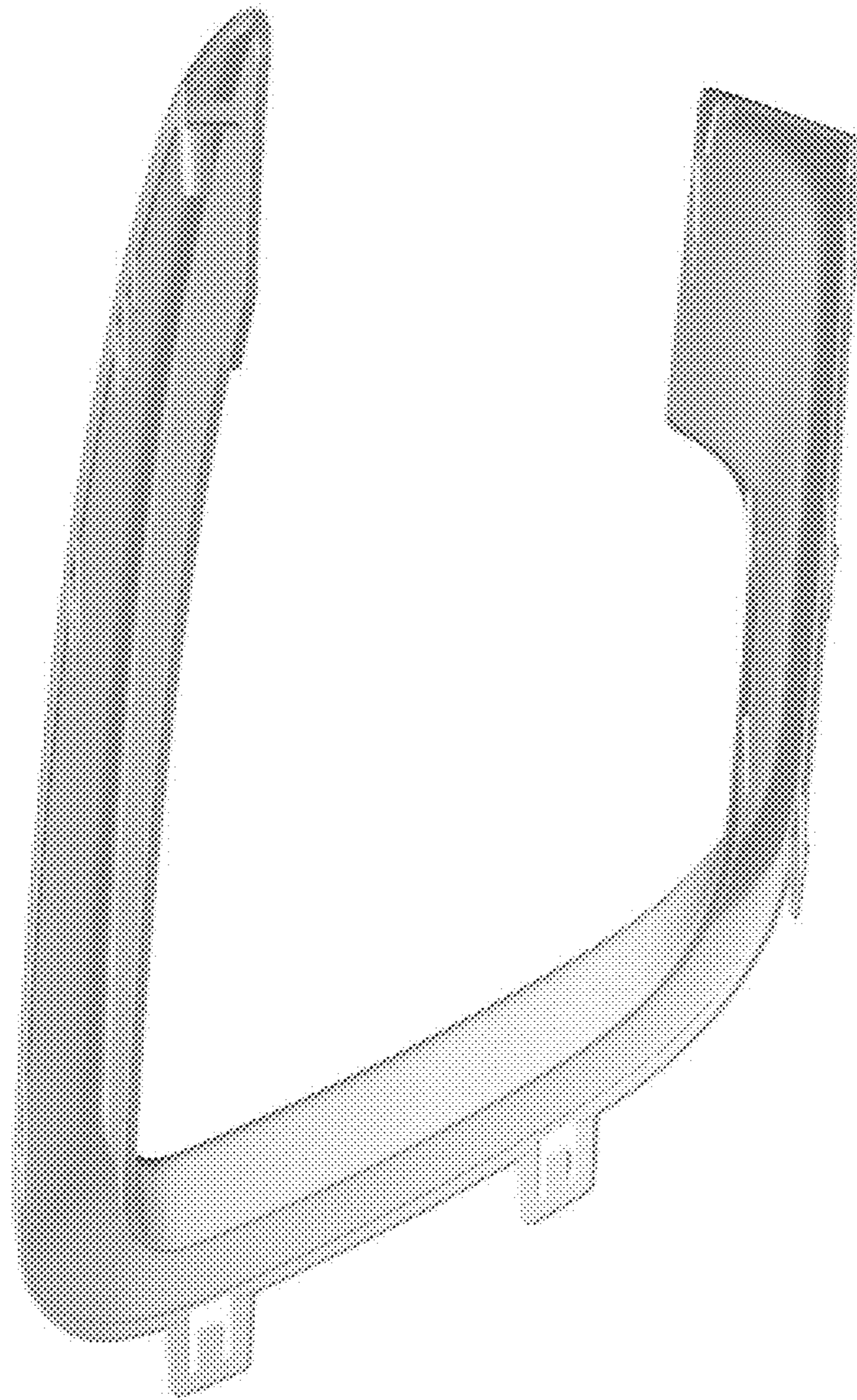

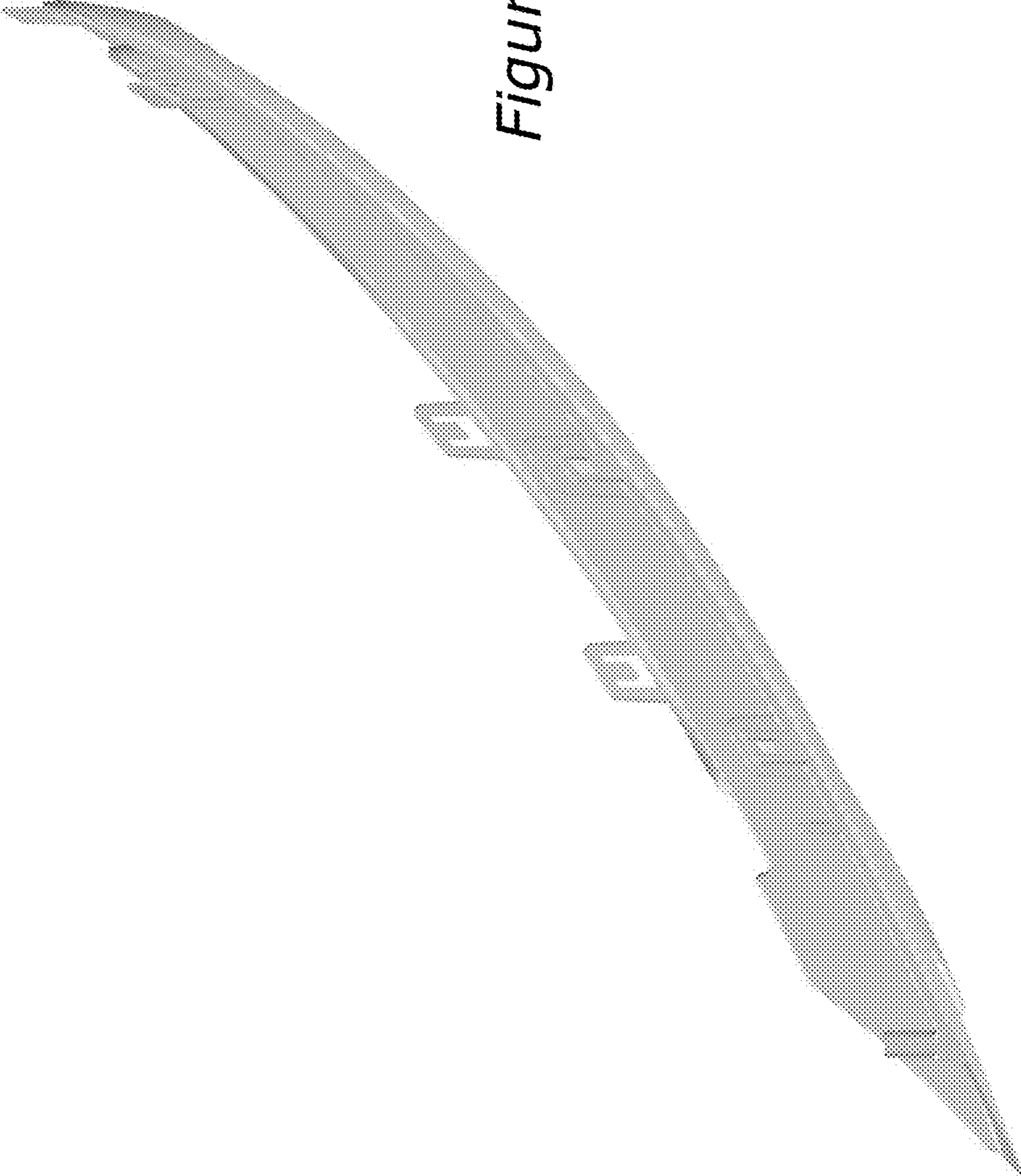
