I claim the ornamental design for a hair styling device, as shown and described.

FIG. 5 is a side view of the hair styling device shown in FIG. 1.

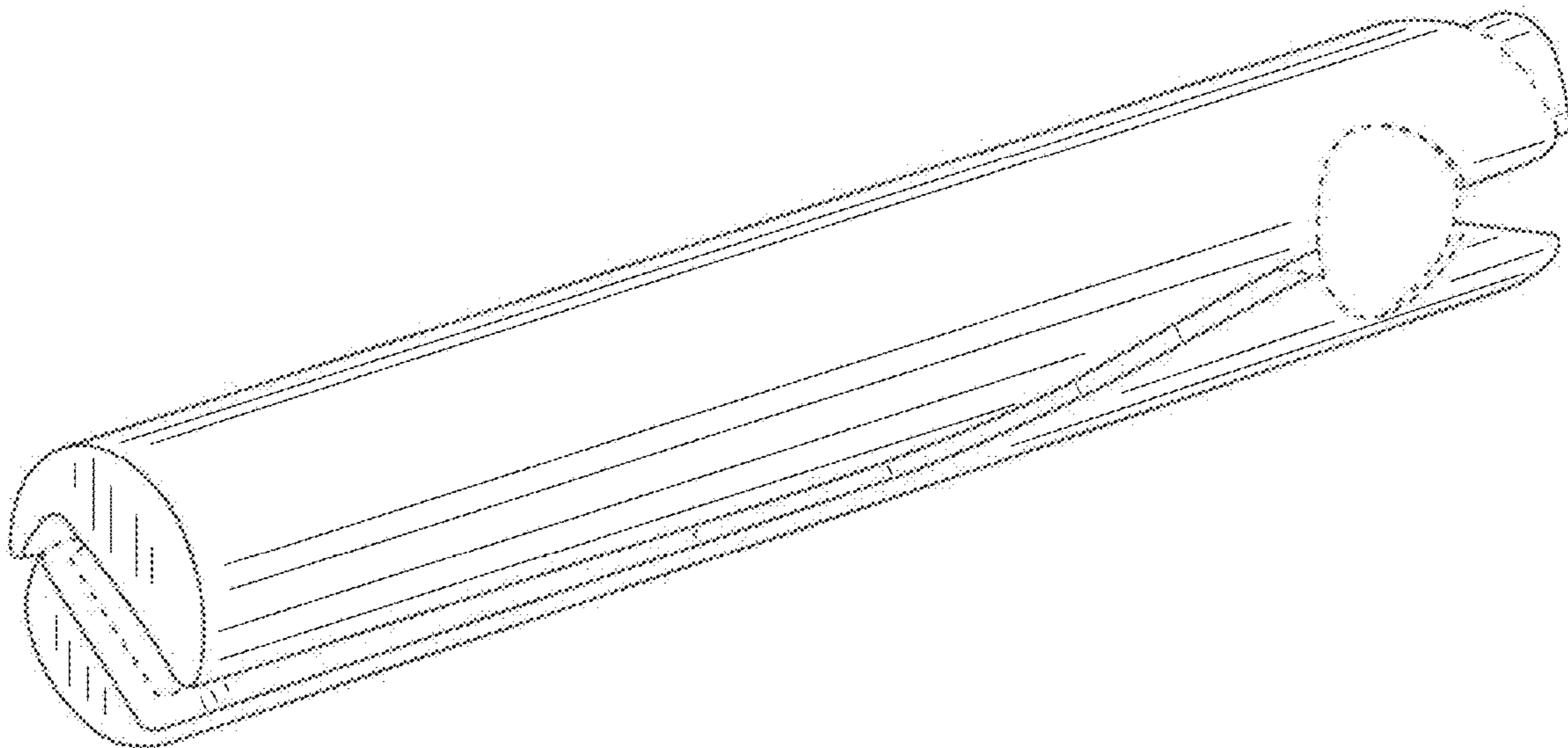
FIG. 6 is a side view of the hair styling device shown in FIG. 1.

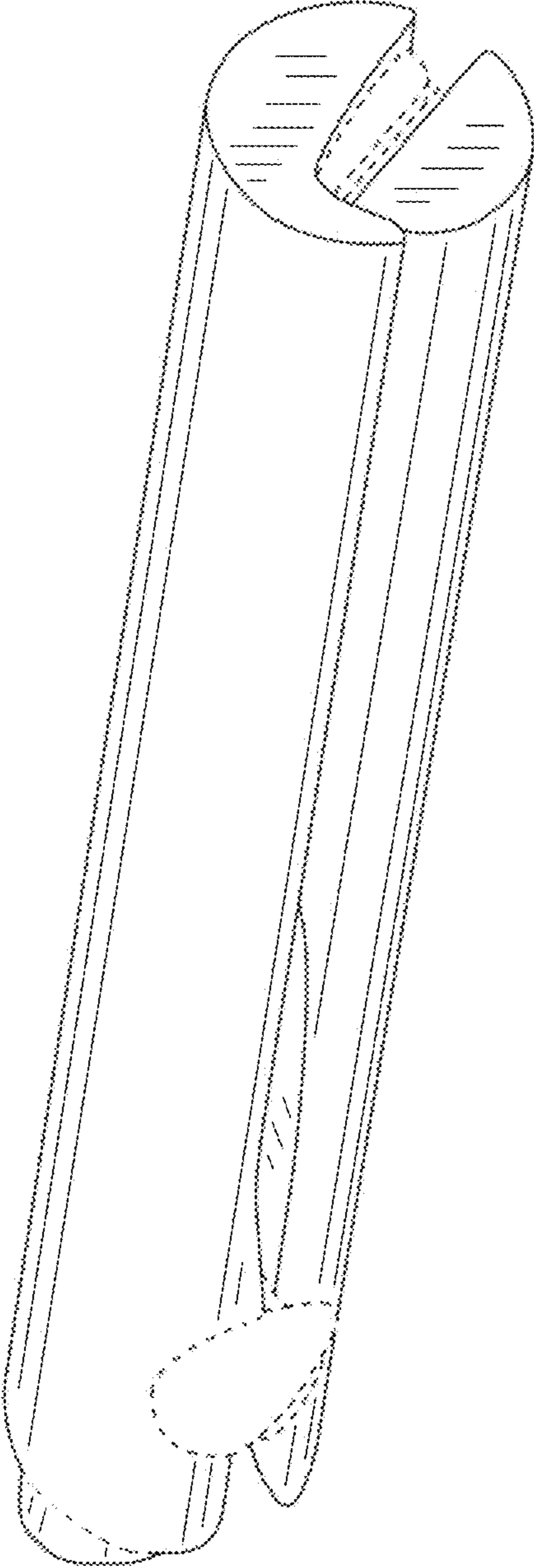

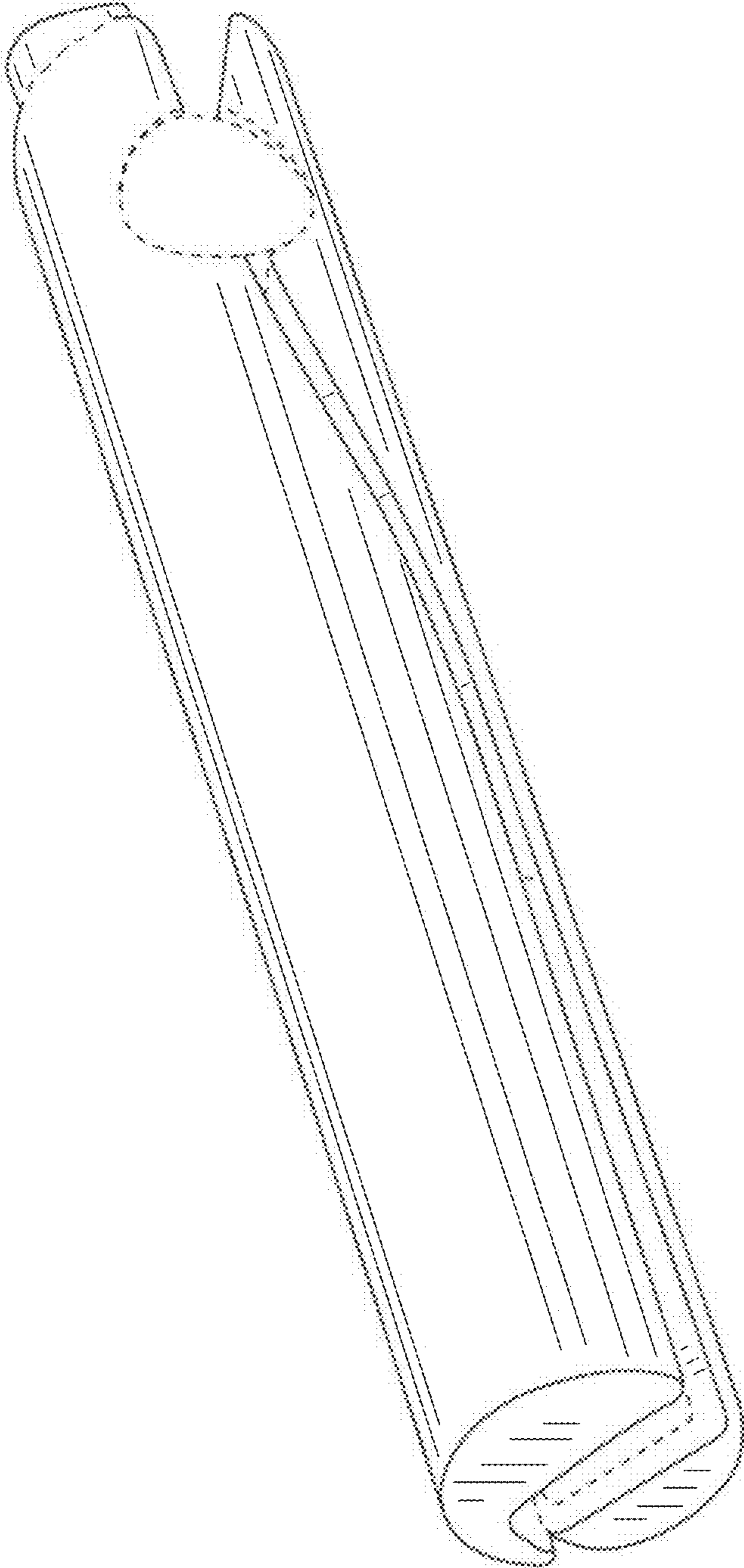

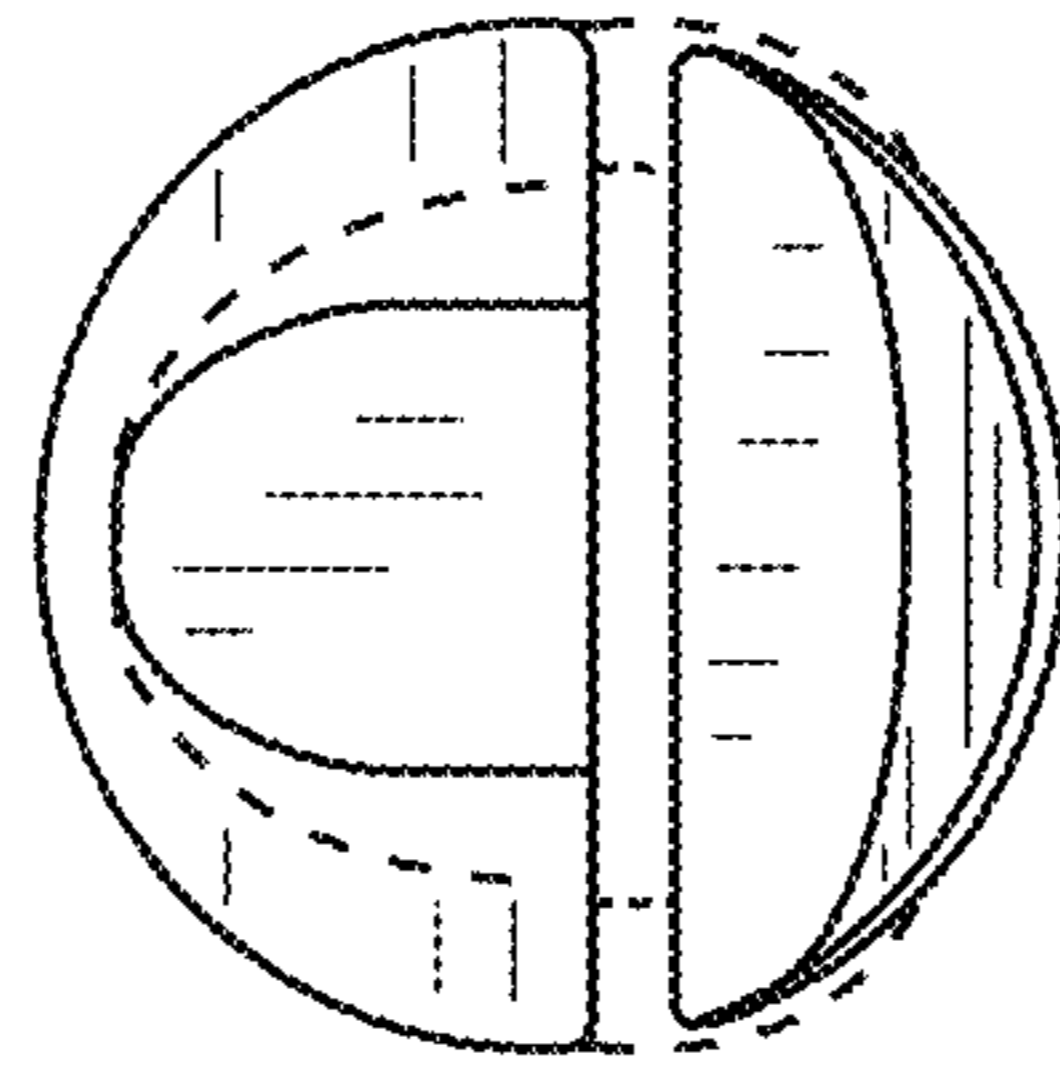

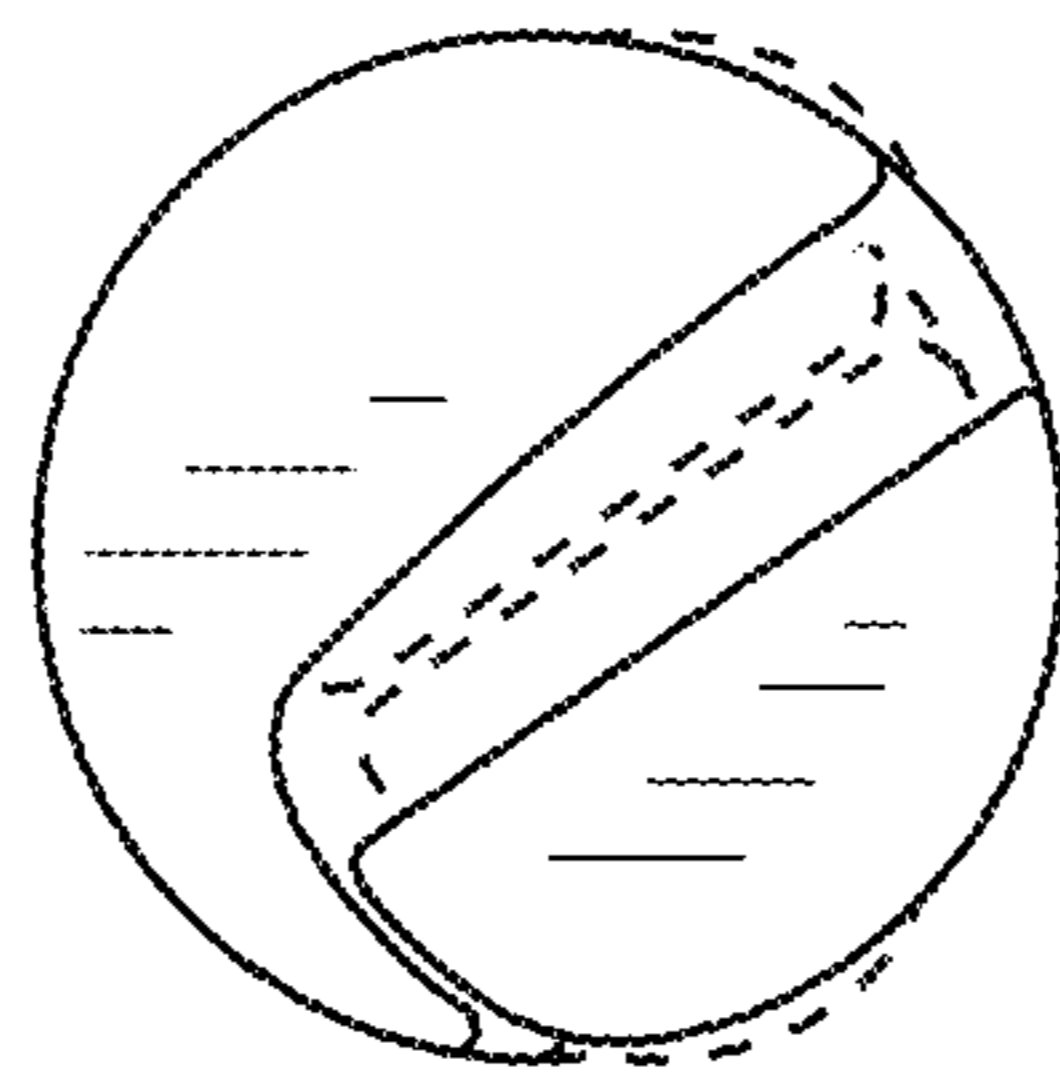

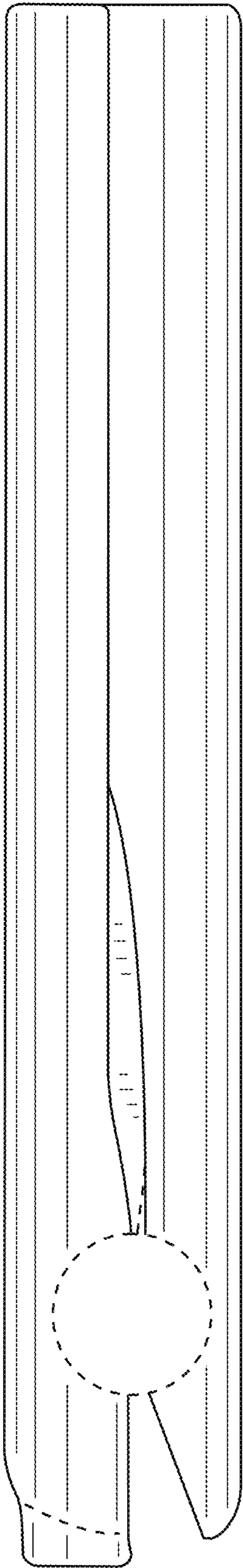

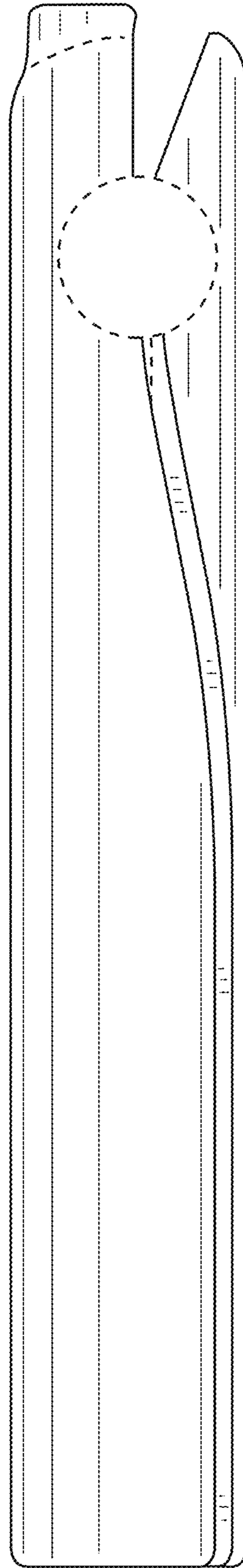

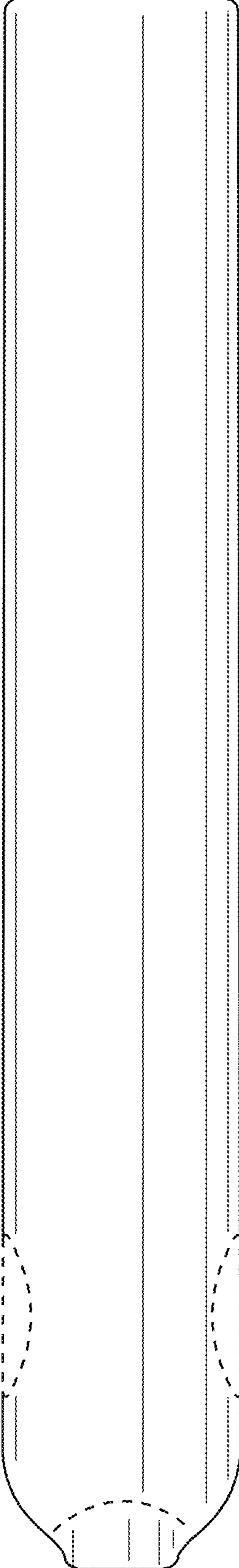

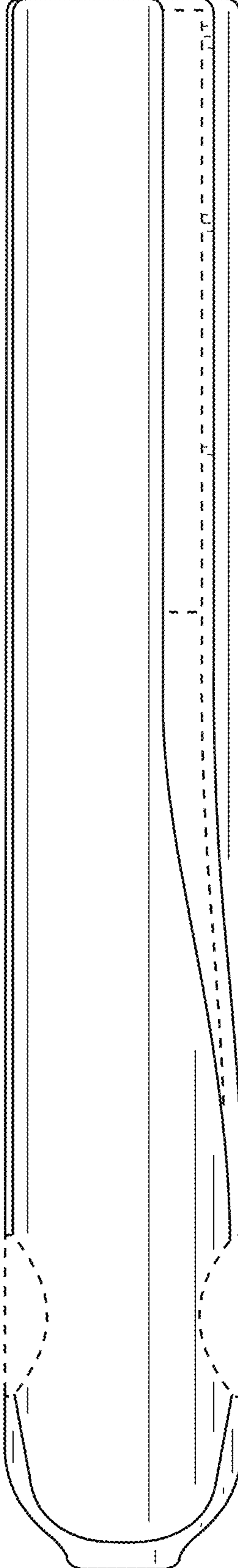
