The ornamental design for a toothbrush head, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear, left-side, and top view of a toothbrush head that has the design.

FIG. 2 is a front view of the toothbrush head.

FIG. 3 is a rear view of the toothbrush head.

FIG. 4 is a top view of the toothbrush head.

FIG. 5 is a bottom view of the toothbrush head.

FIG. 6 is a left-side view of the toothbrush head; and,

FIG. 7 is a right-side view of the toothbrush head.

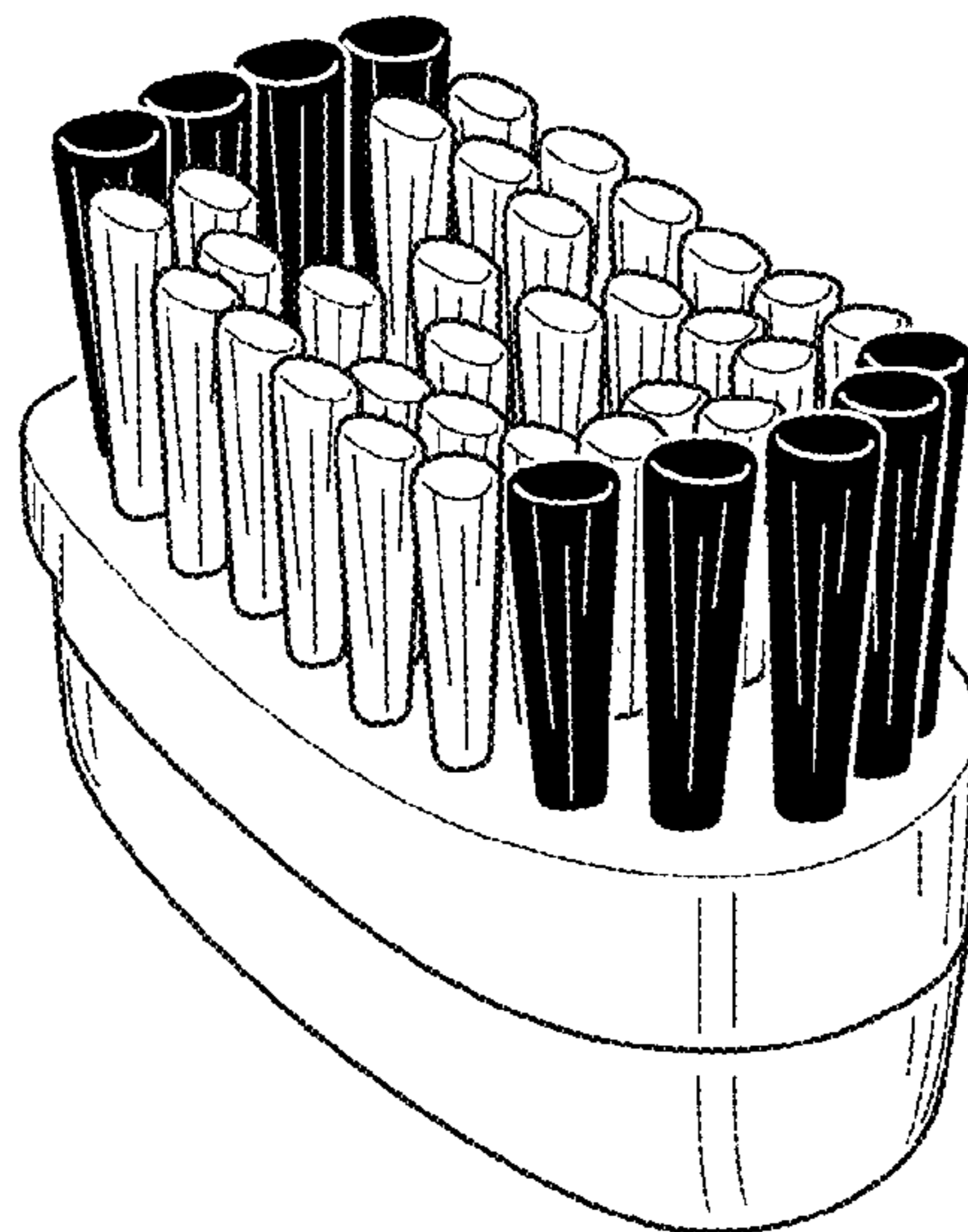
The broken lines show the boundaries of the claimed design and elements of the toothbrush head that form no part of the claimed design.

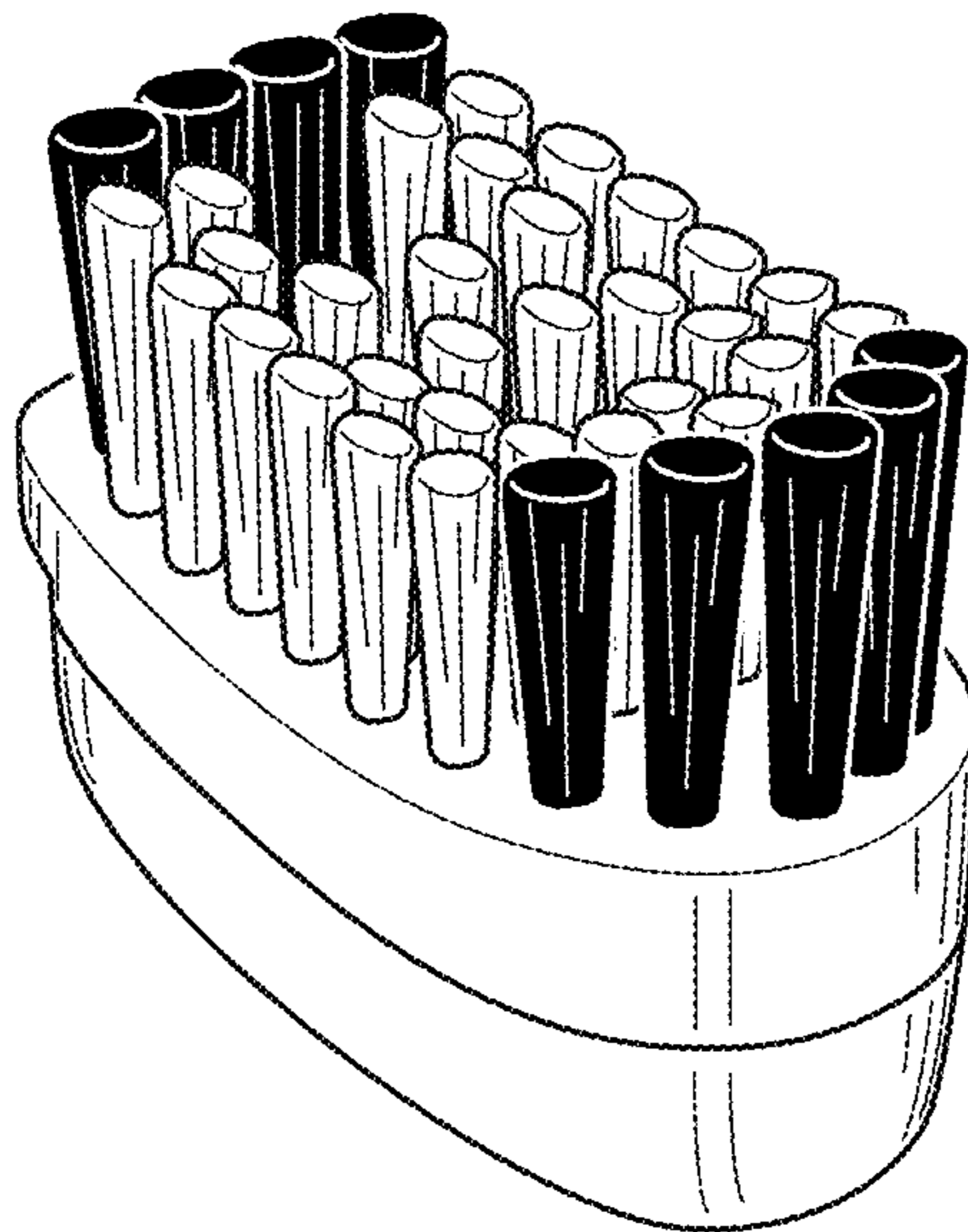

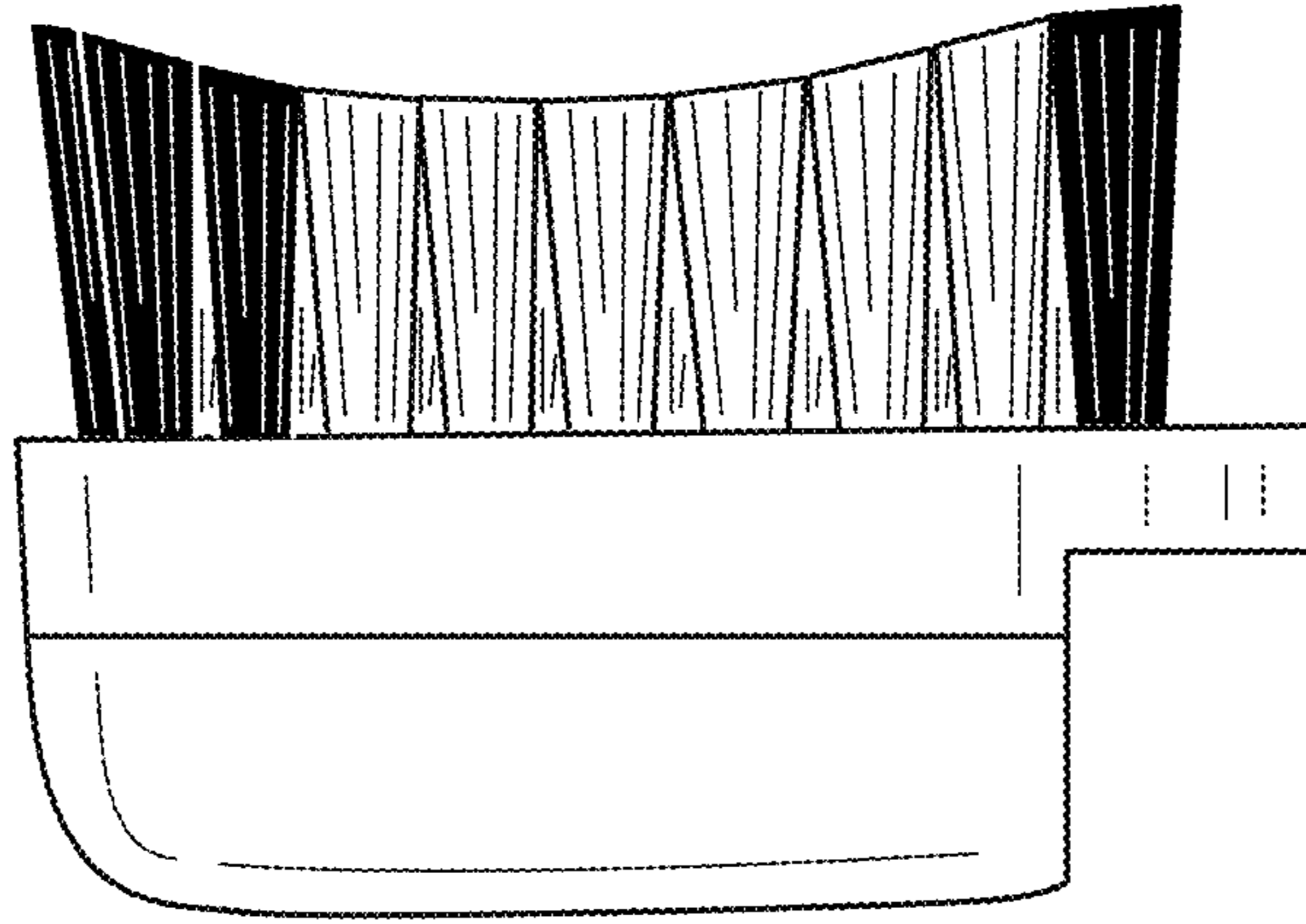

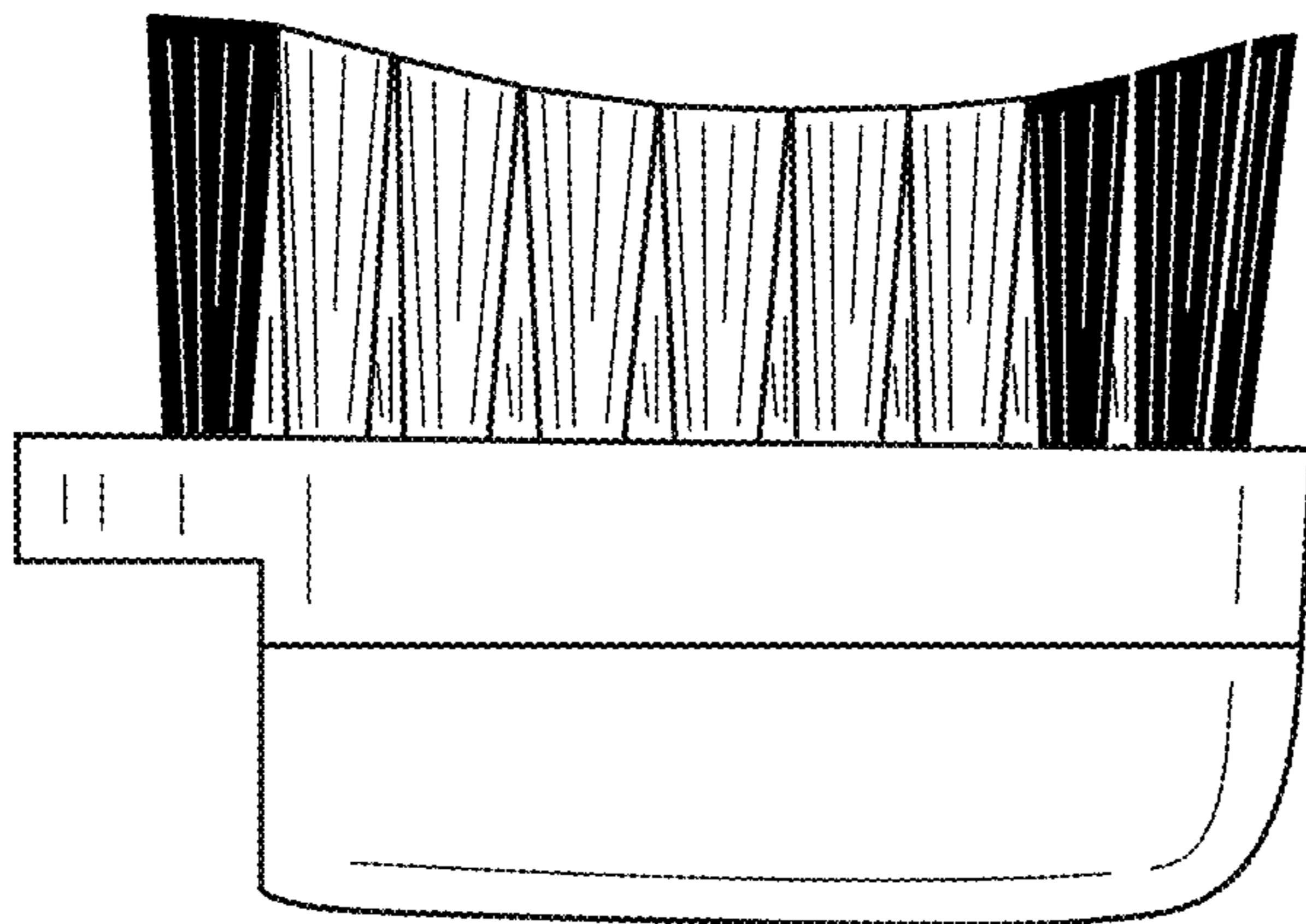

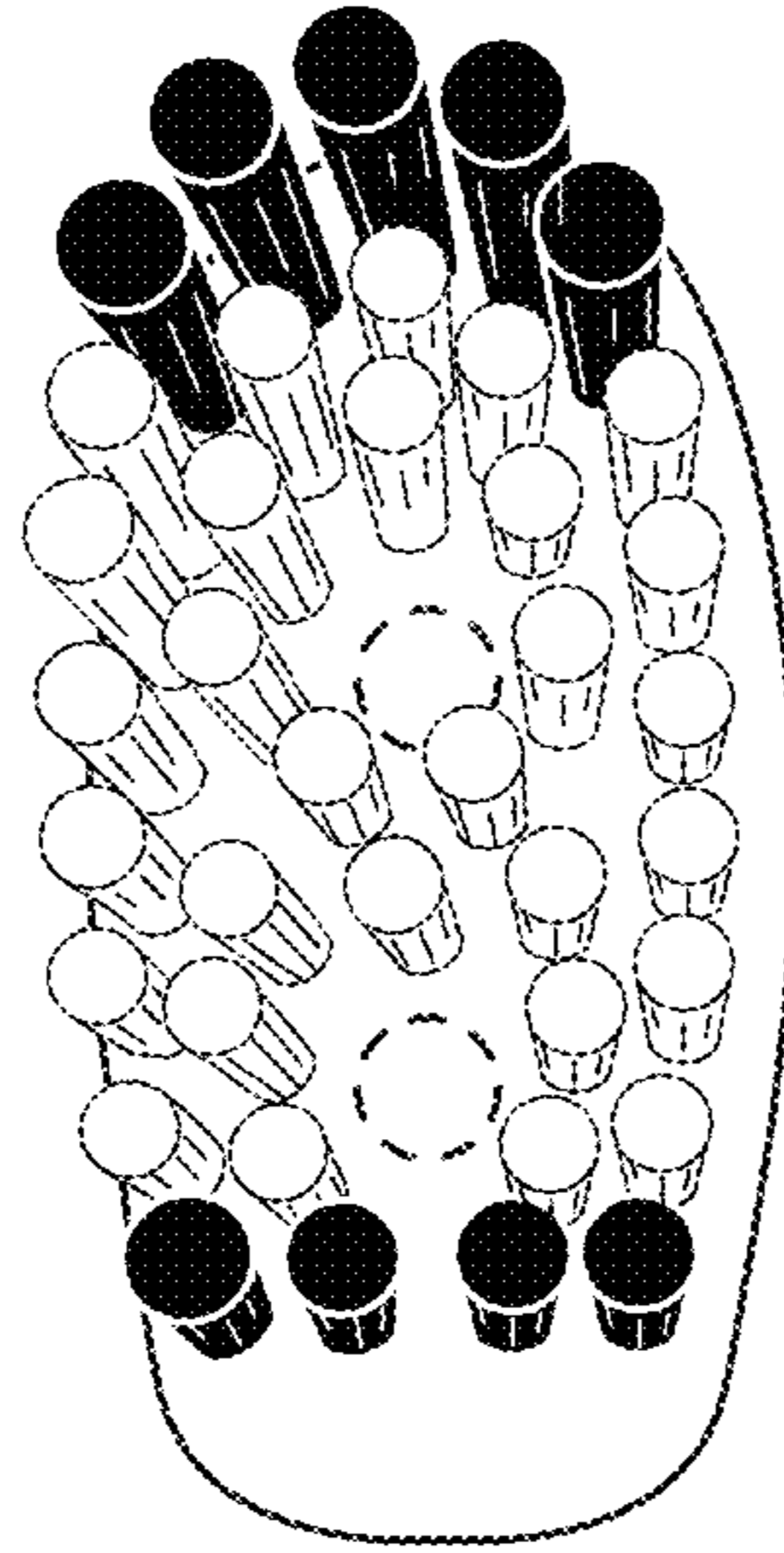

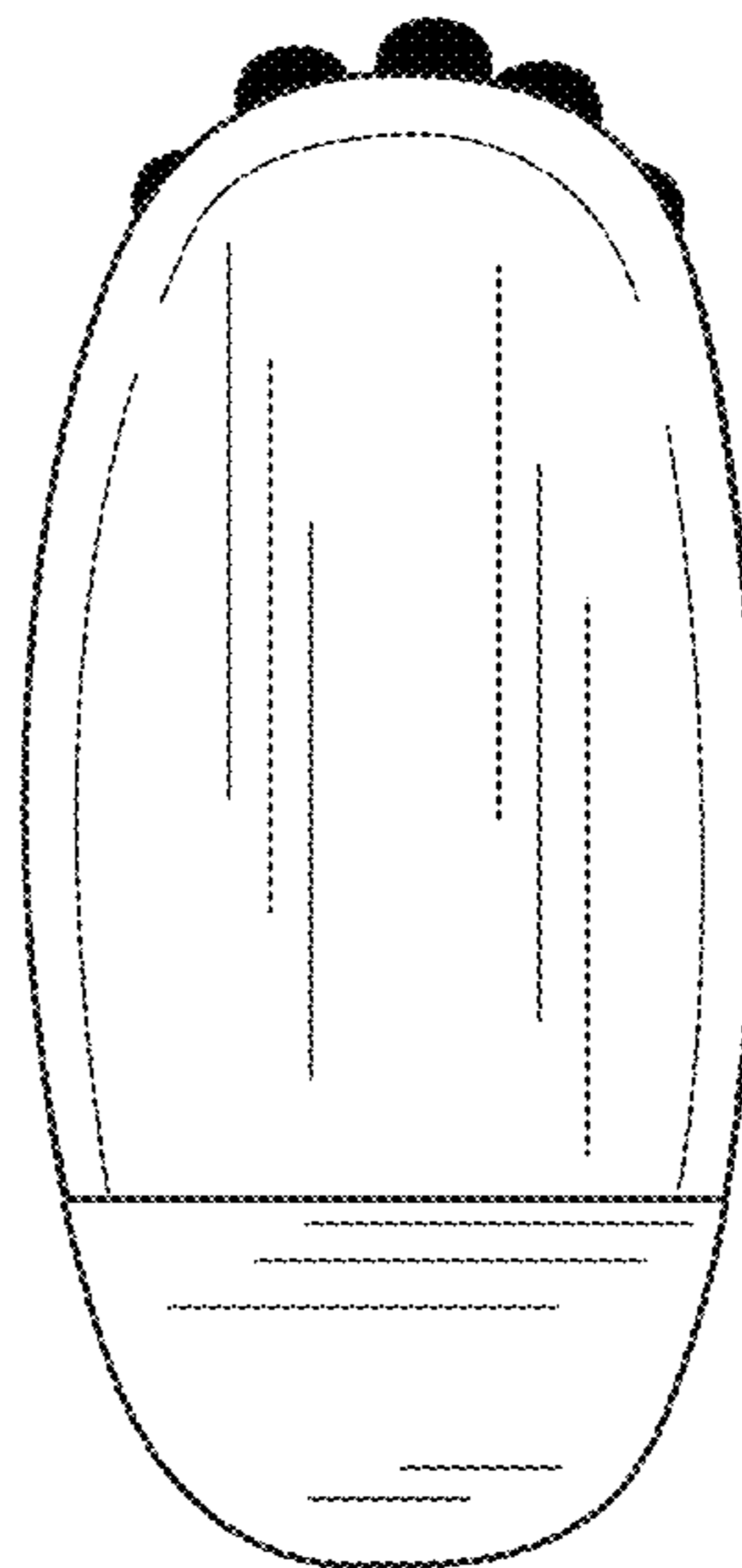

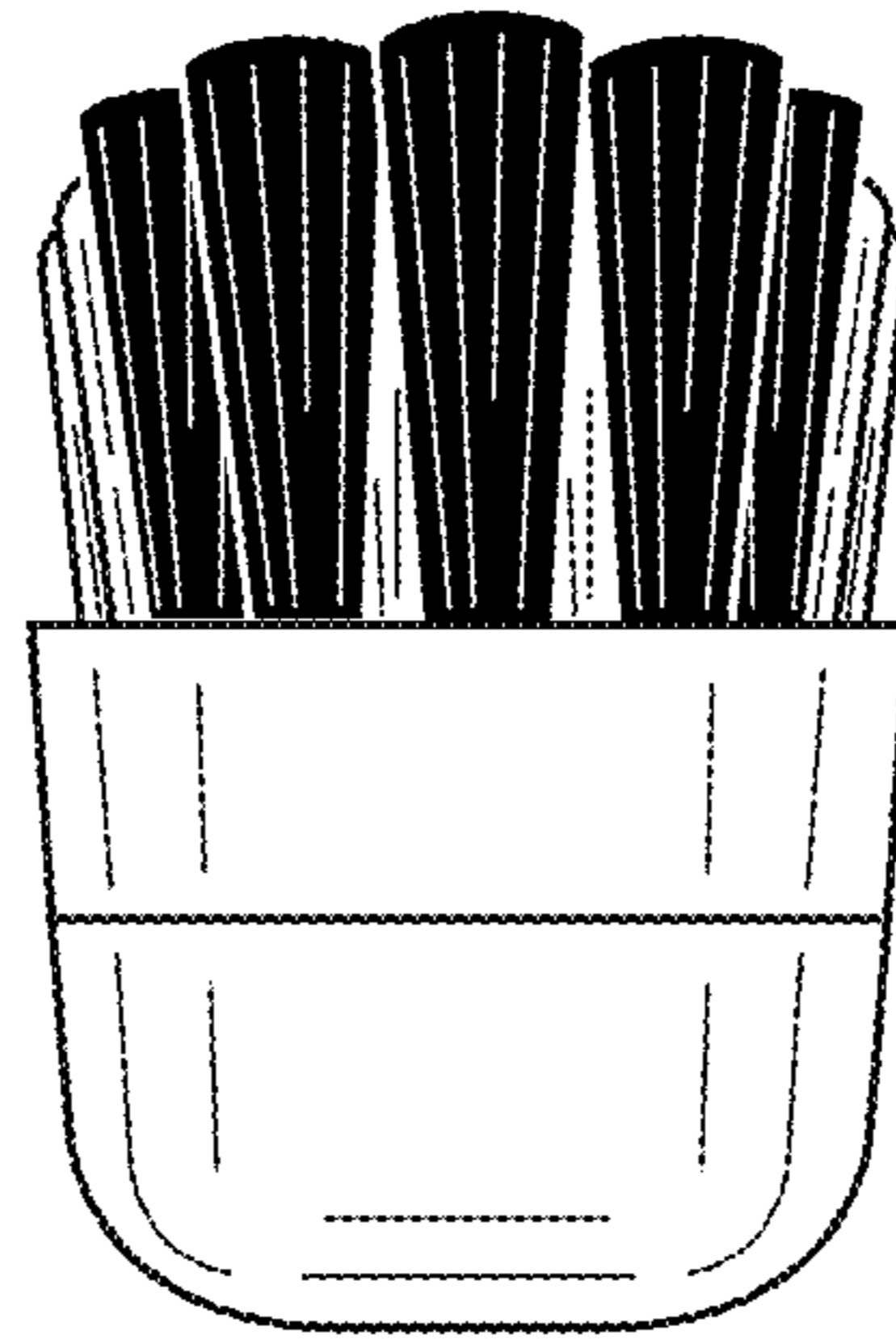

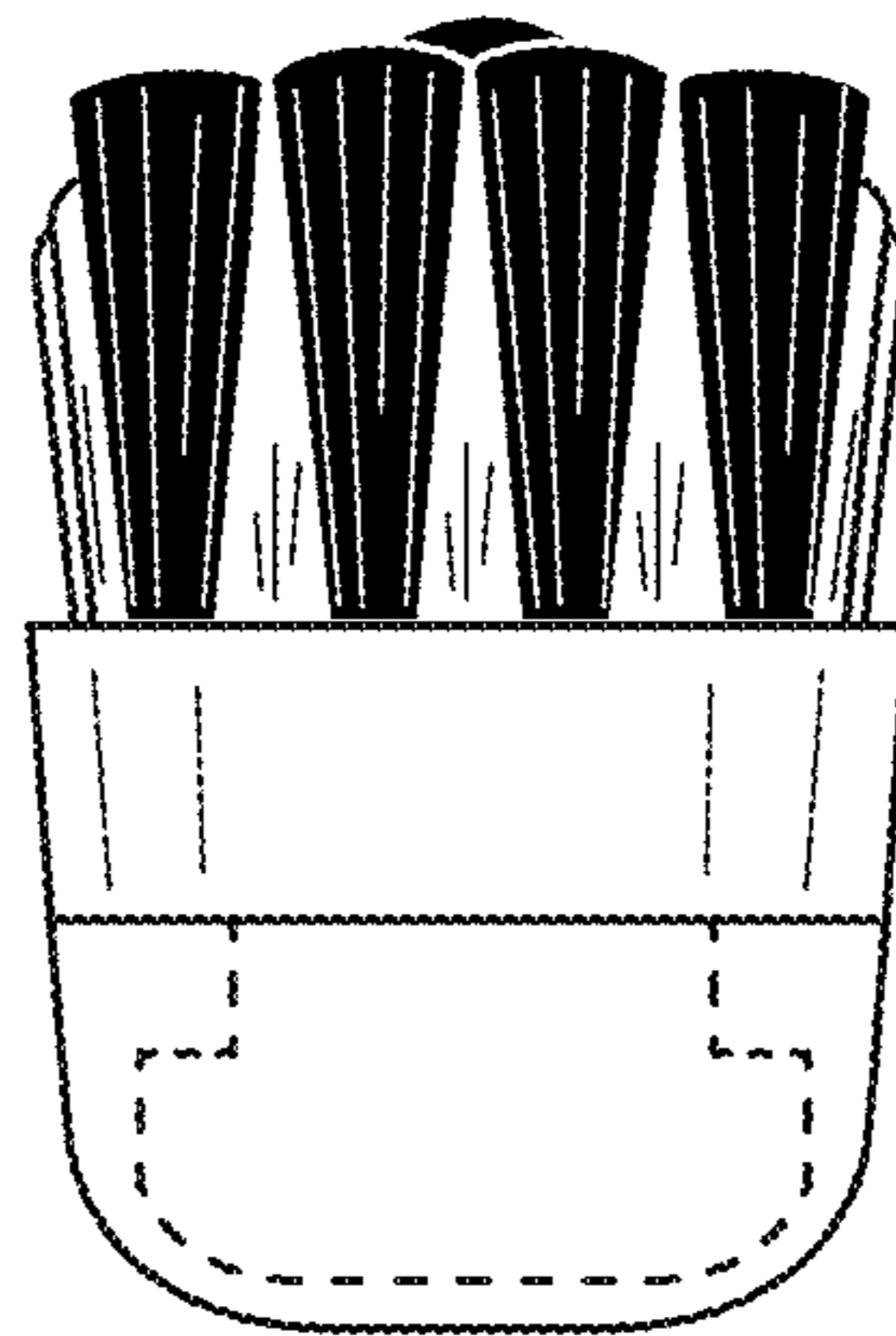
