FIG. 10 is a front perspective view of the hairbrush of FIG. 1.

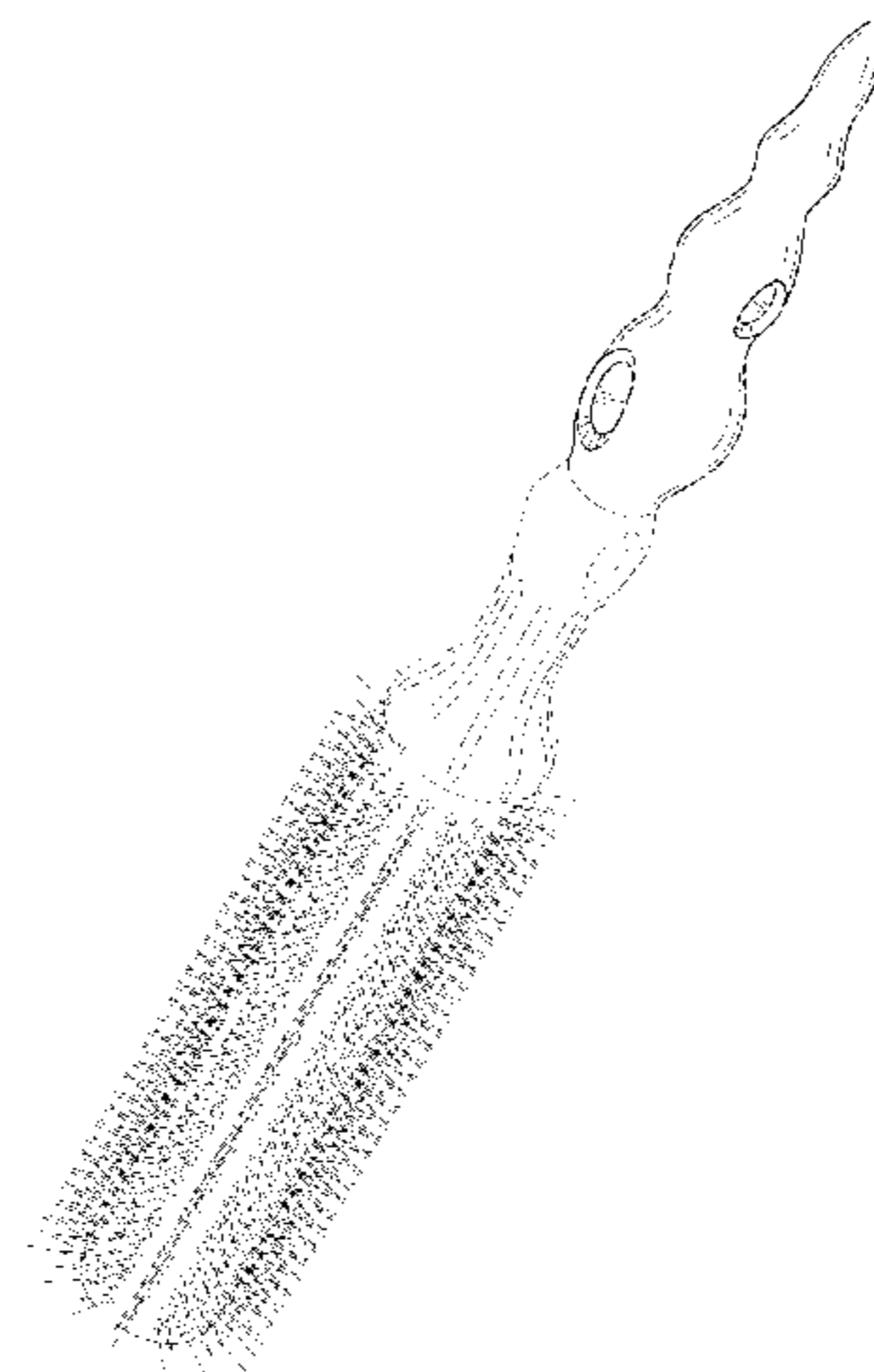

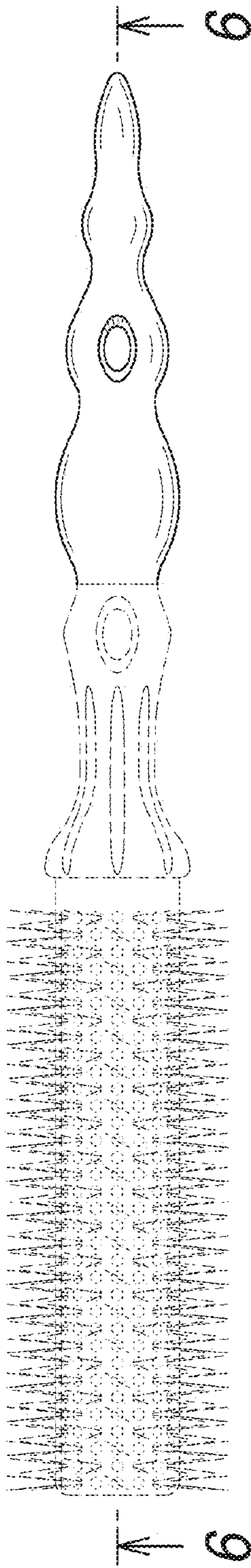

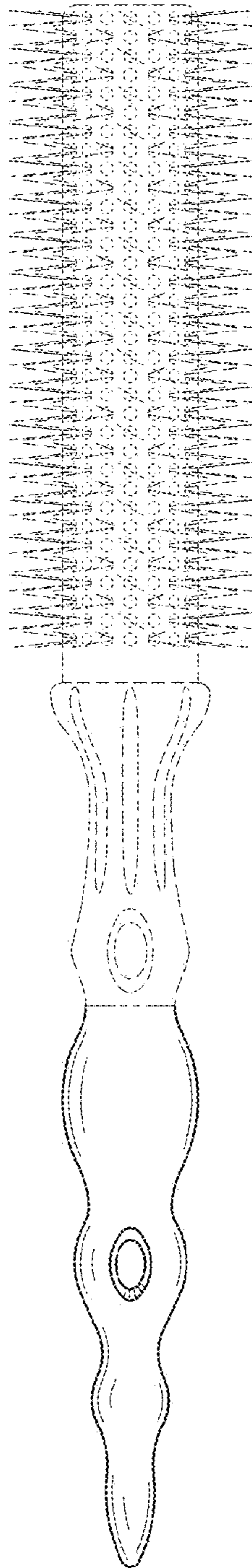
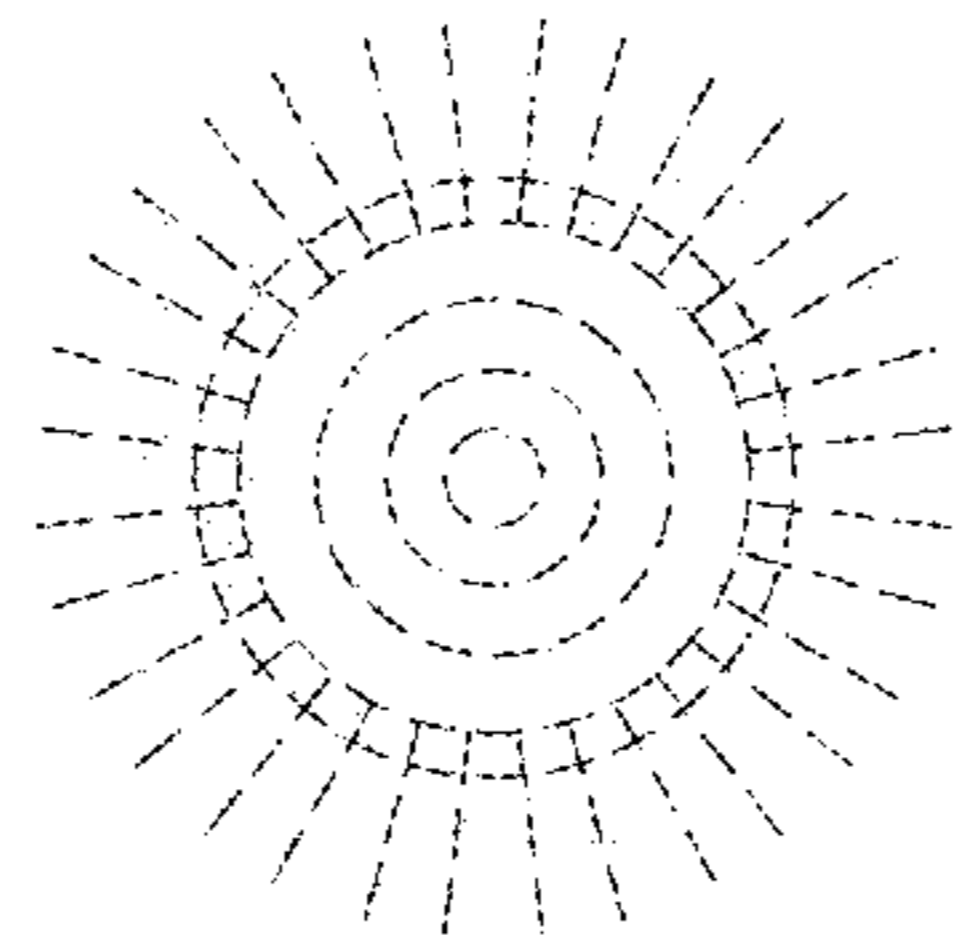
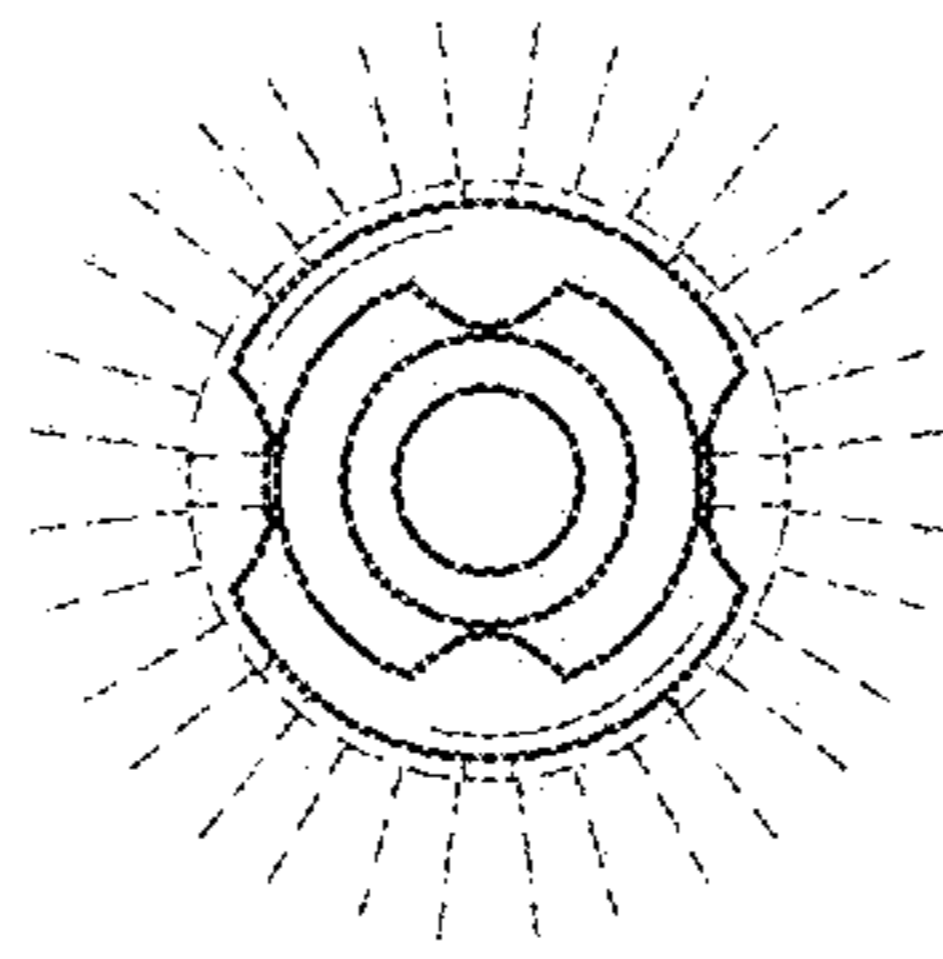

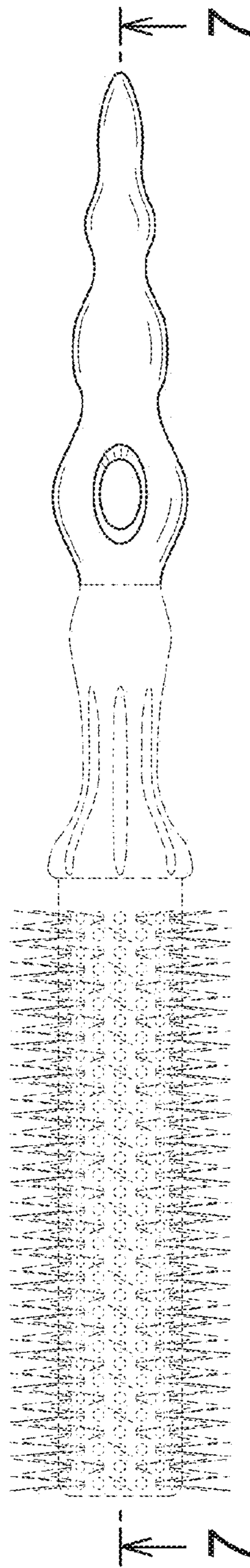

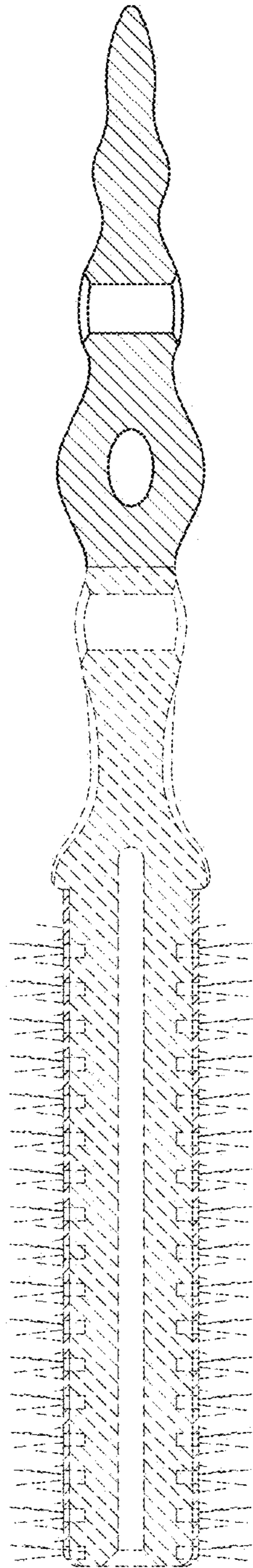

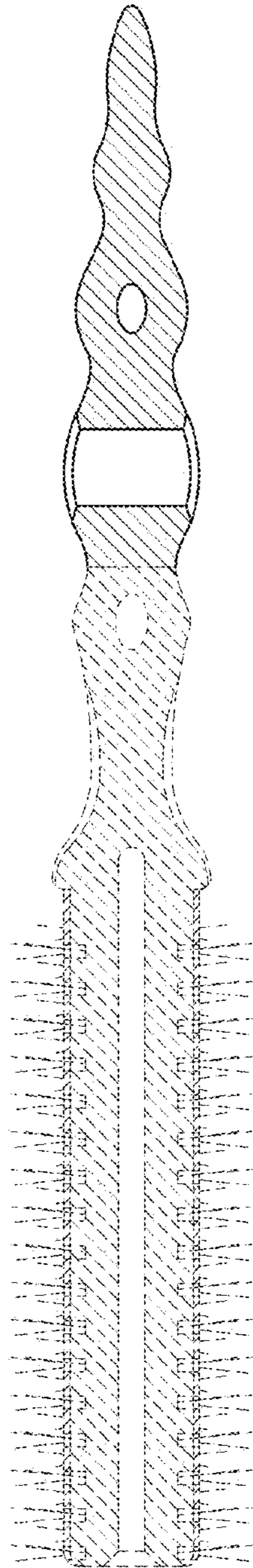

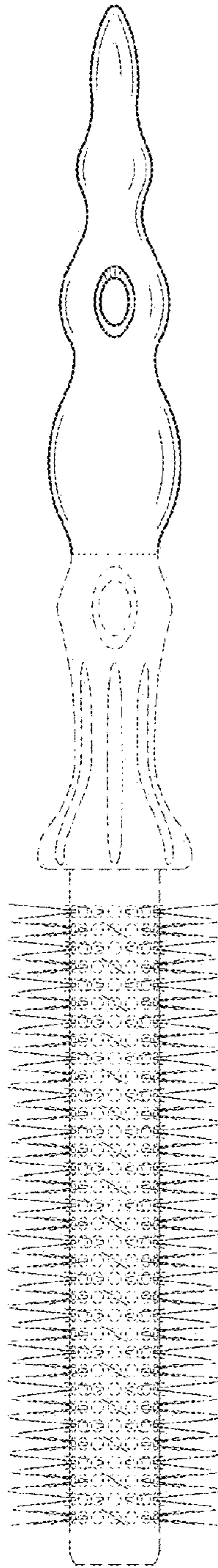

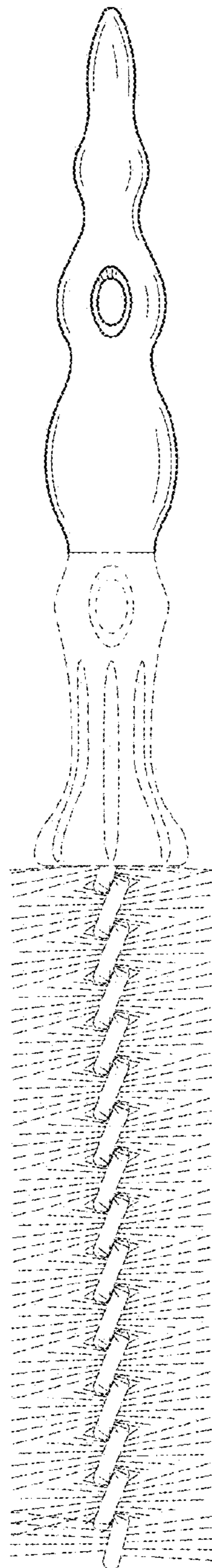

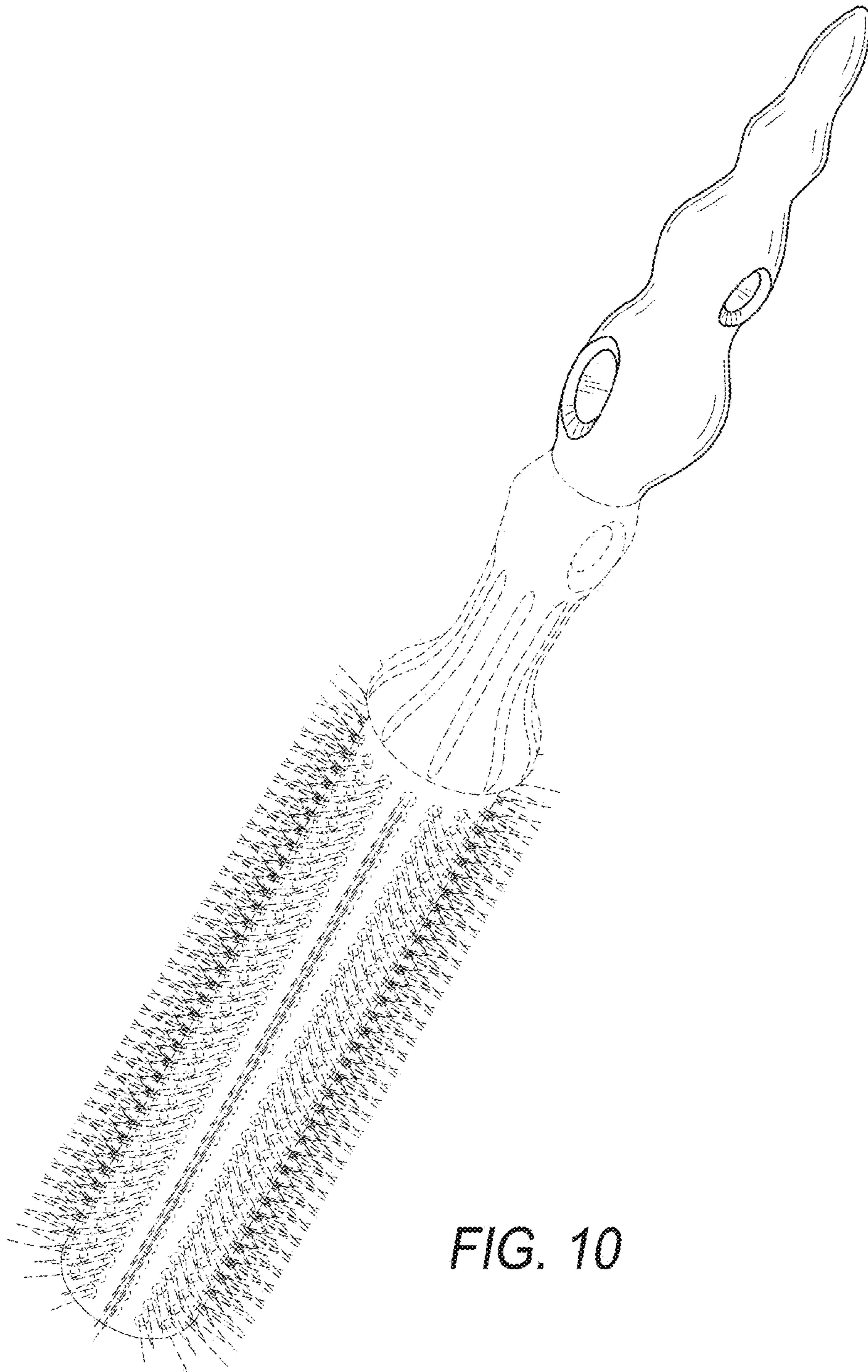
