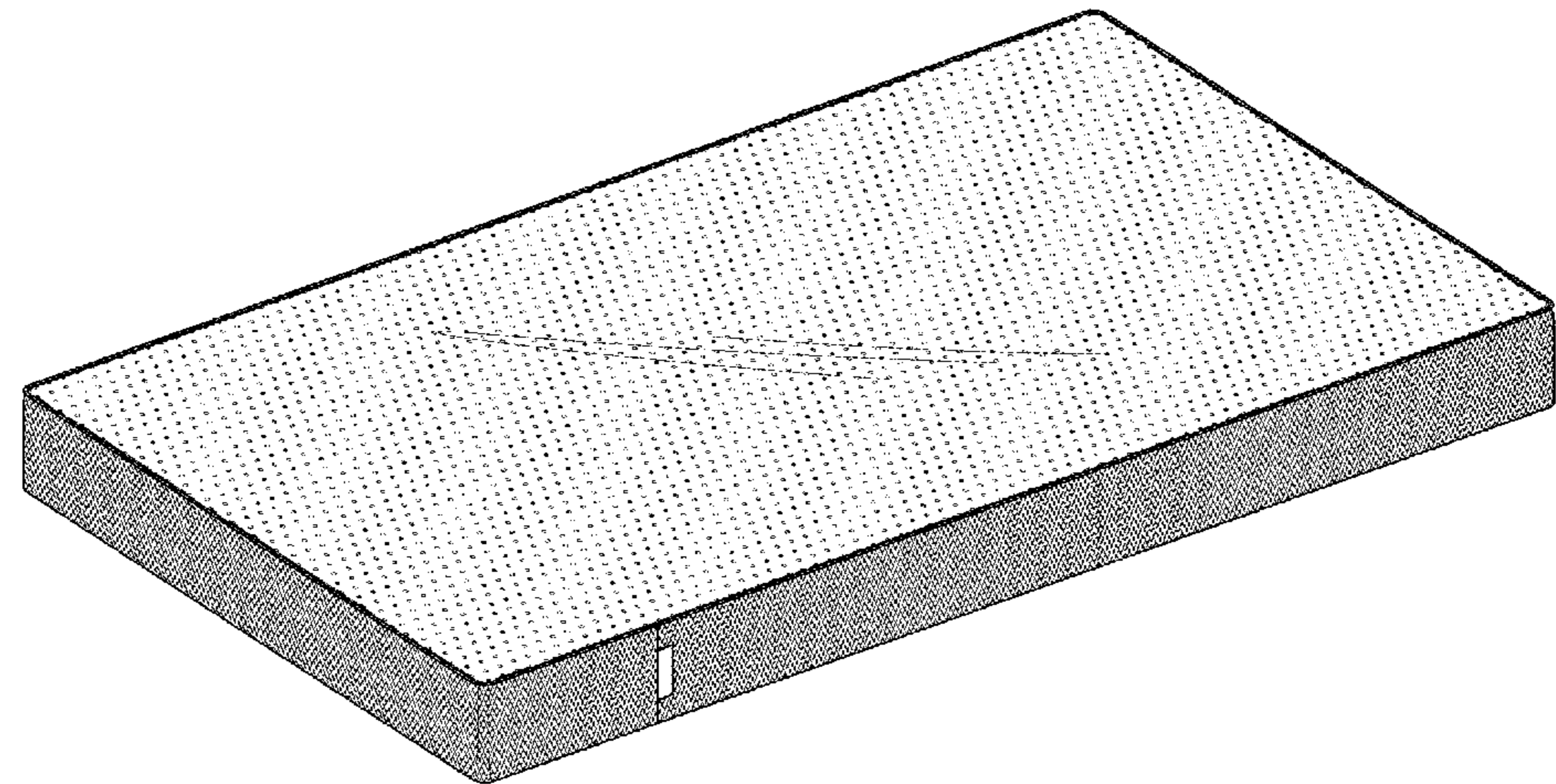


FIG. 32 is a front elevational view thereof (back elevational view is identical);

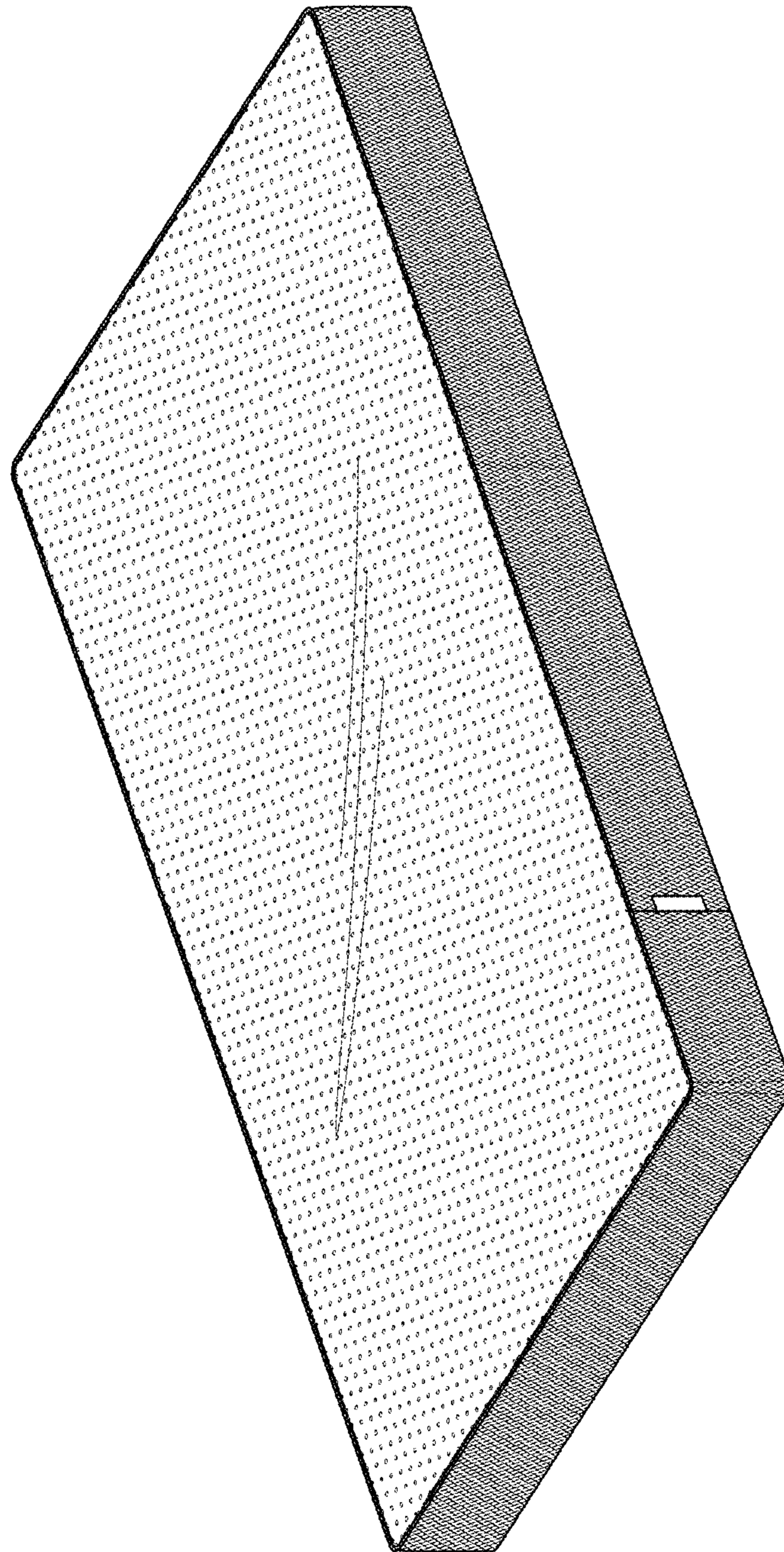

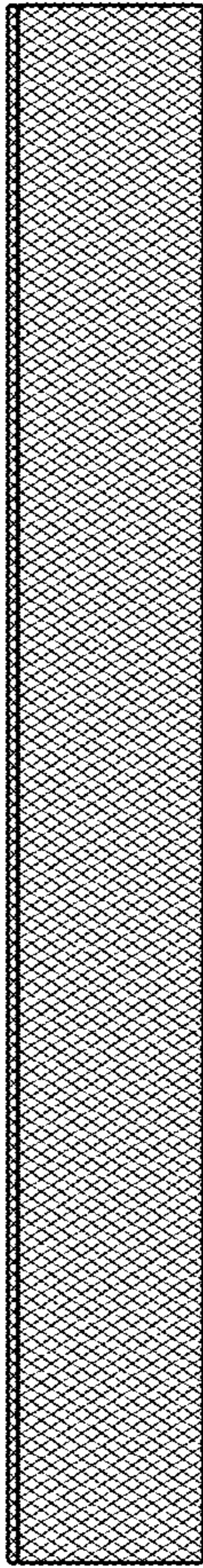

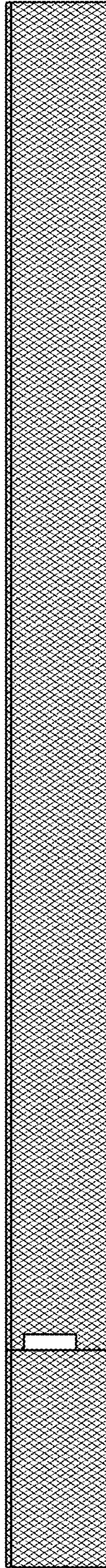

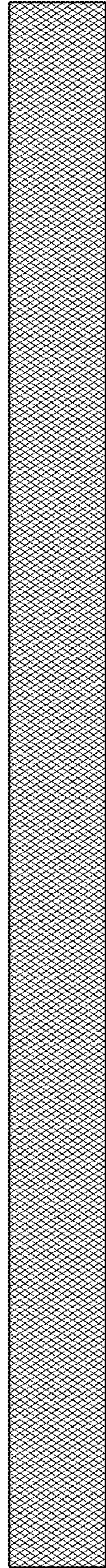

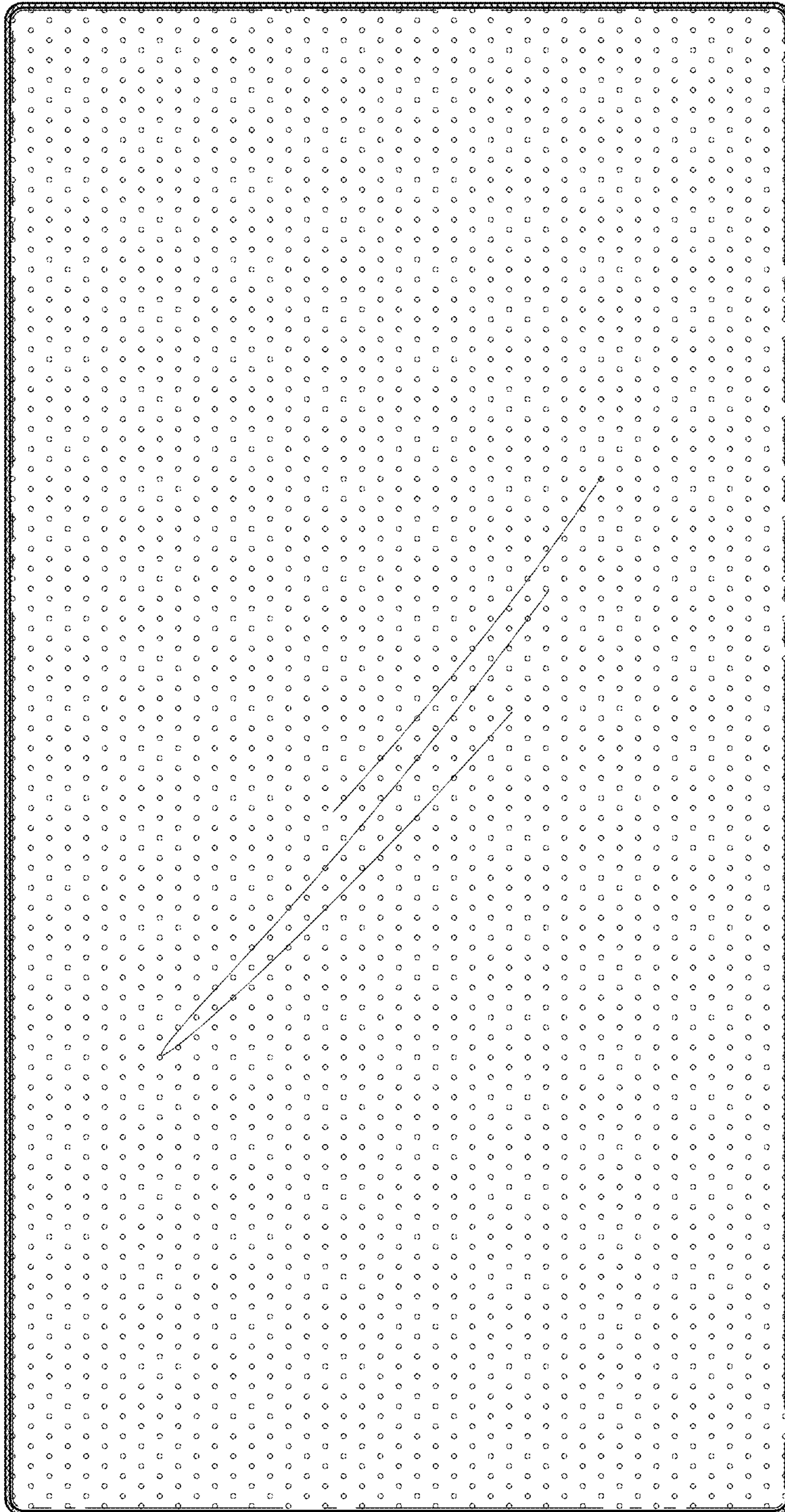

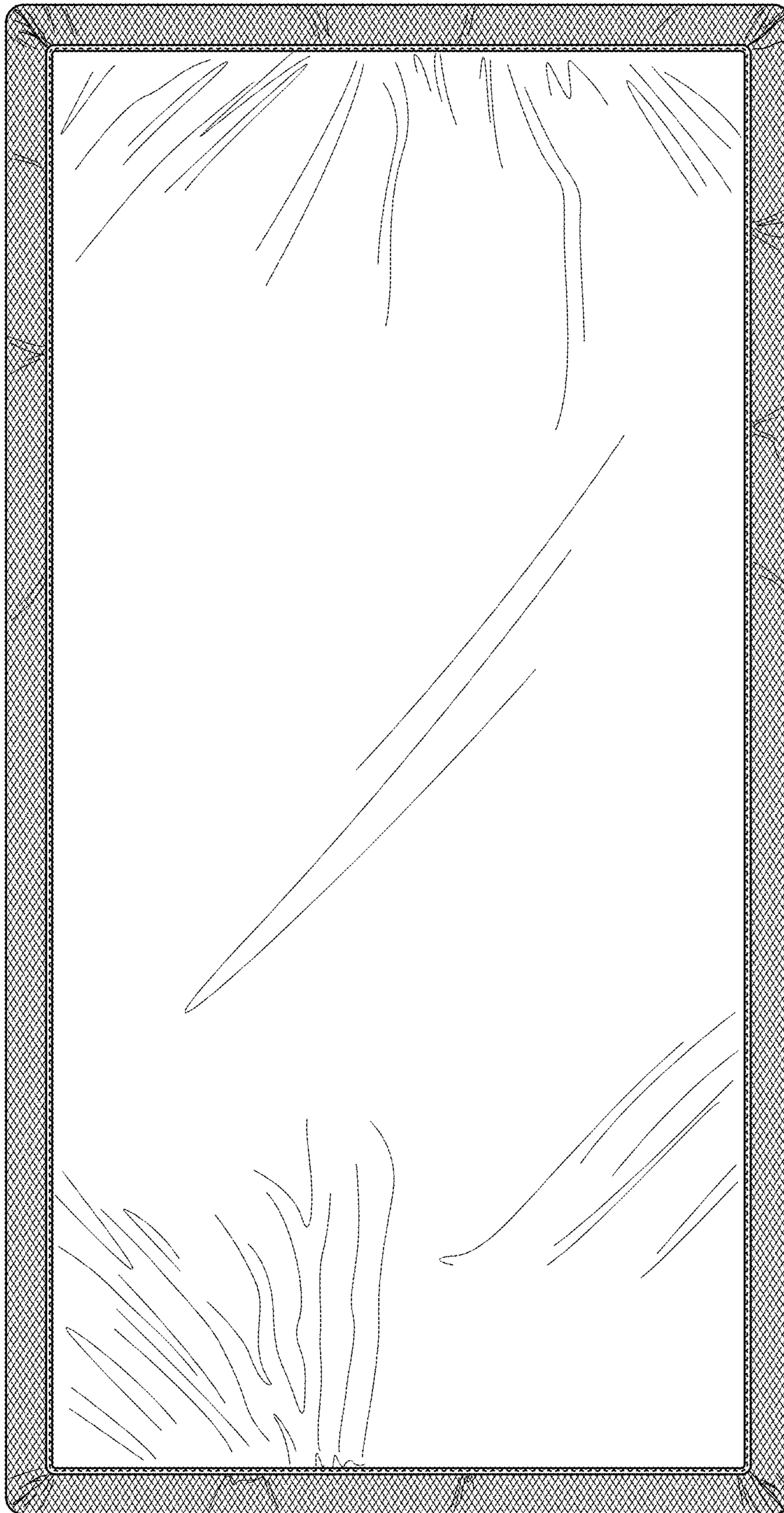

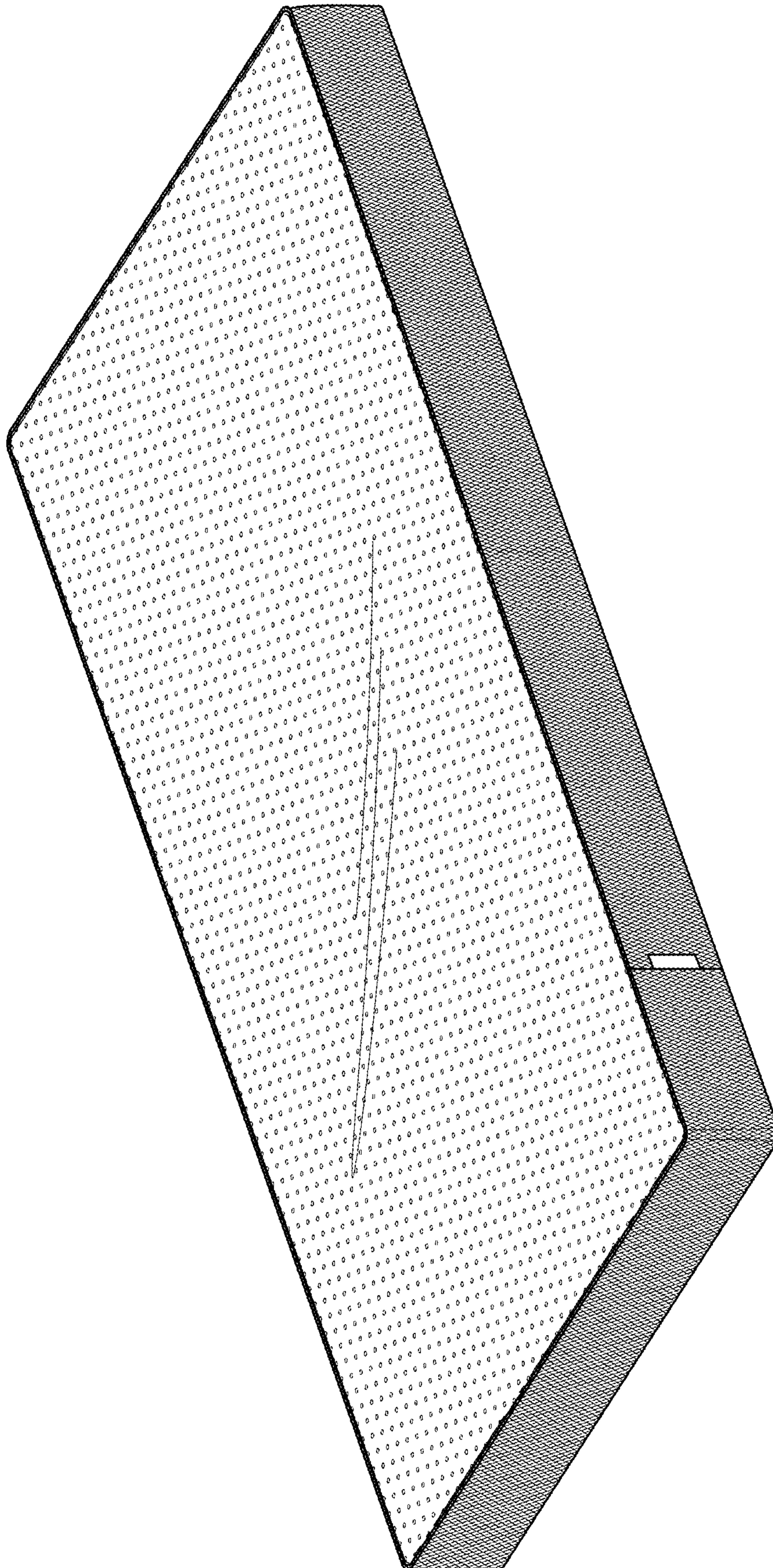

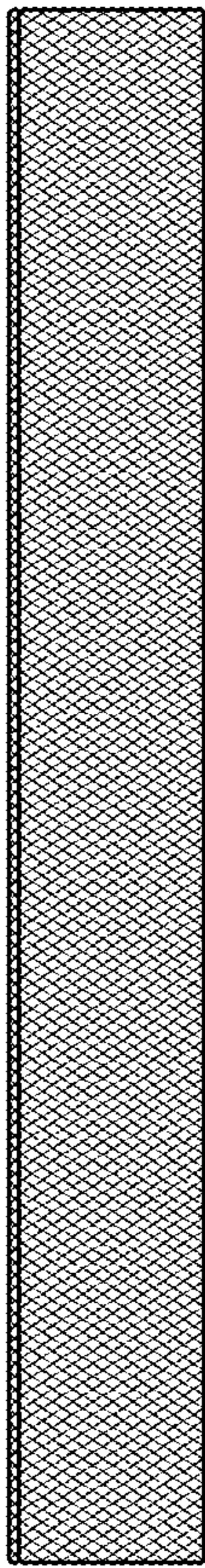

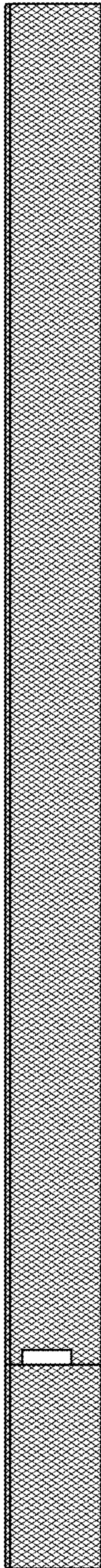

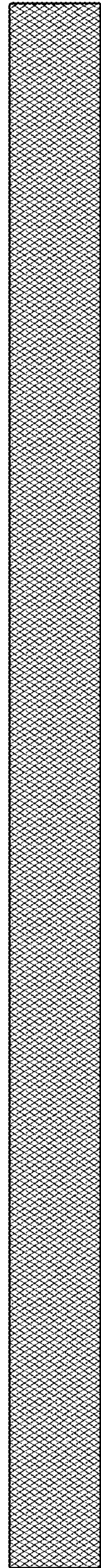

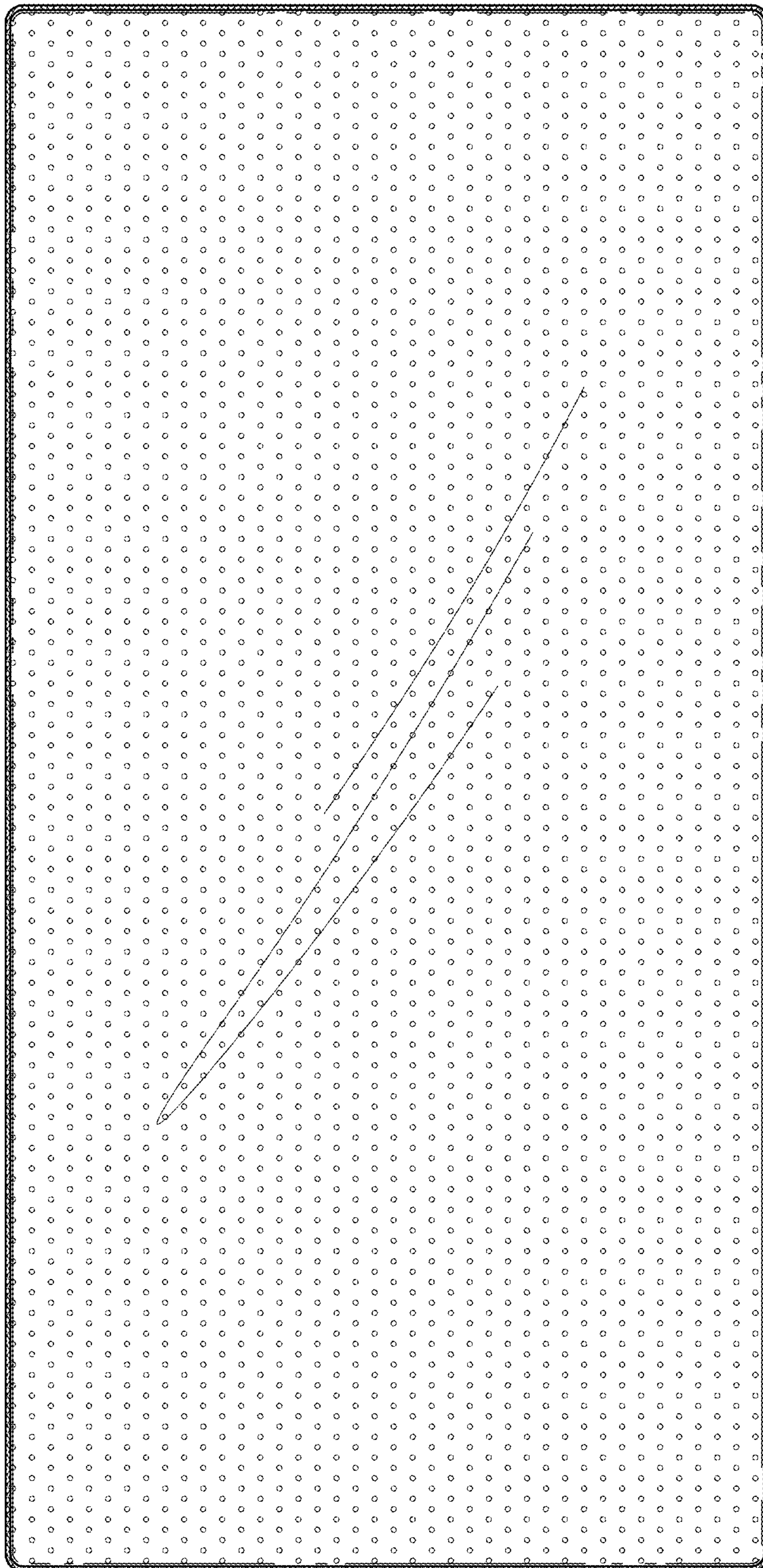

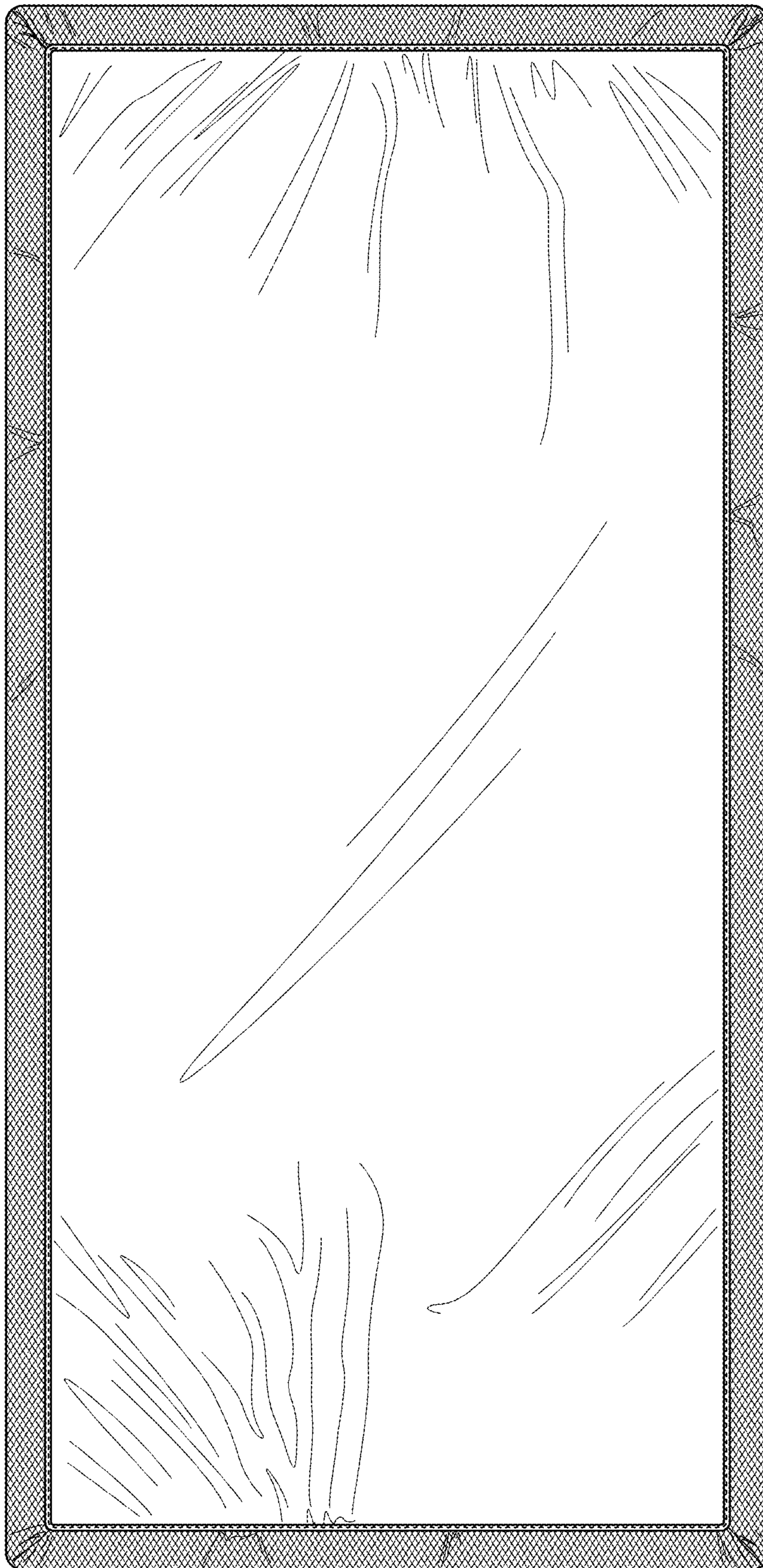

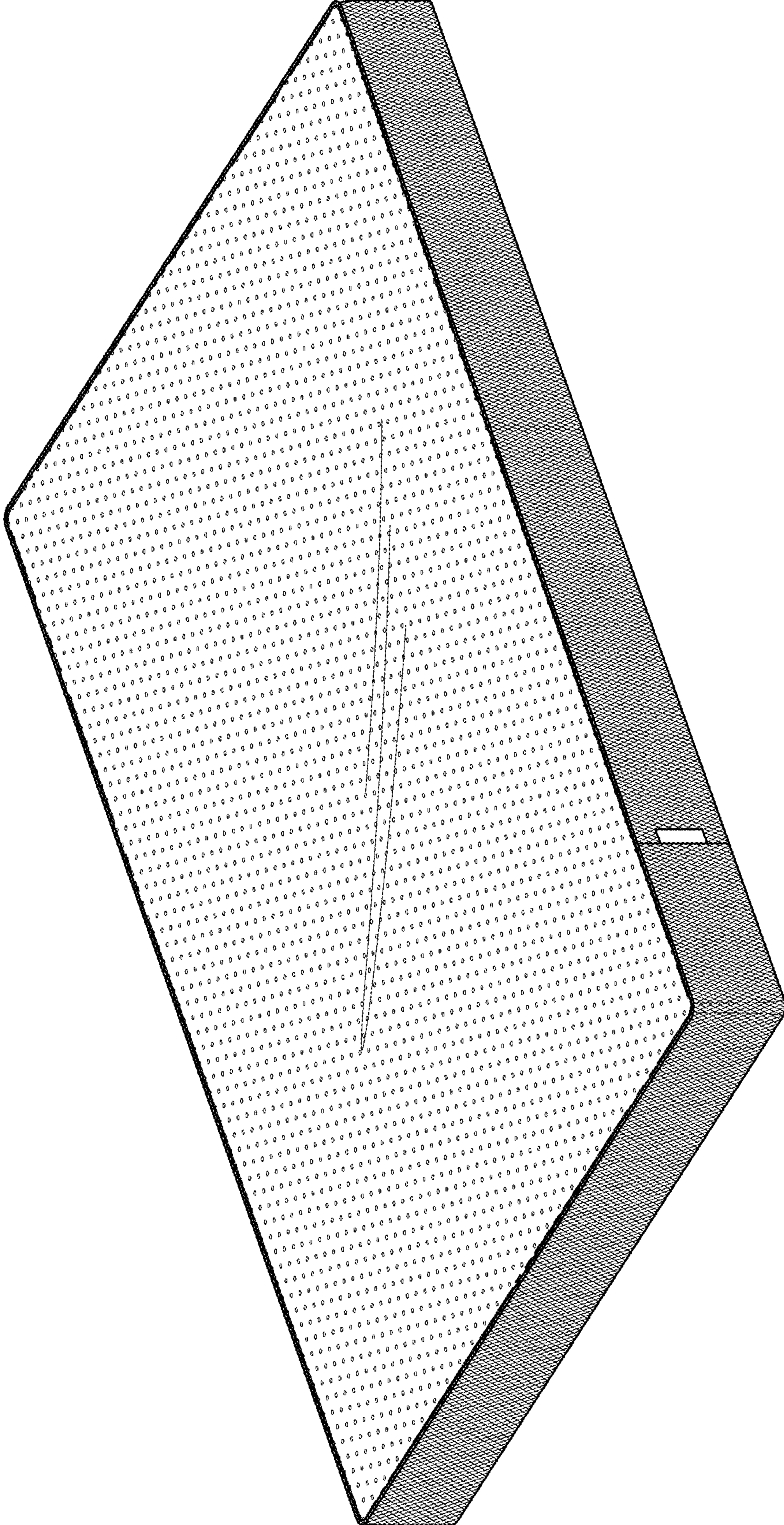

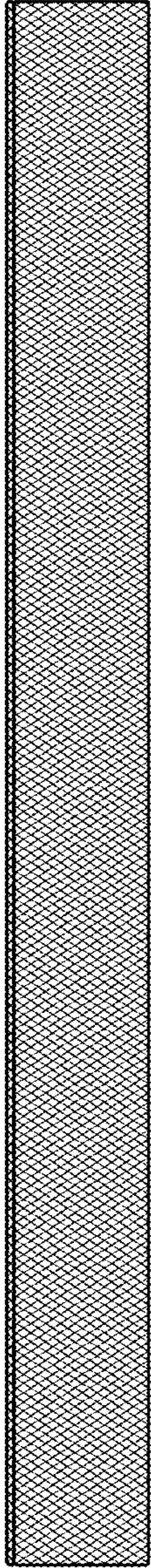

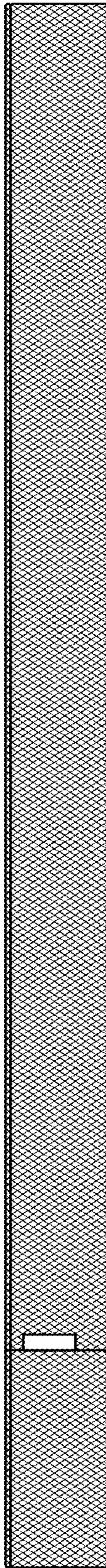

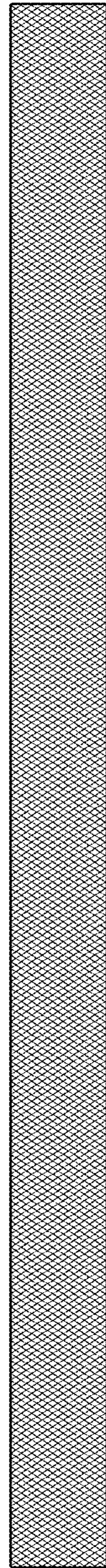

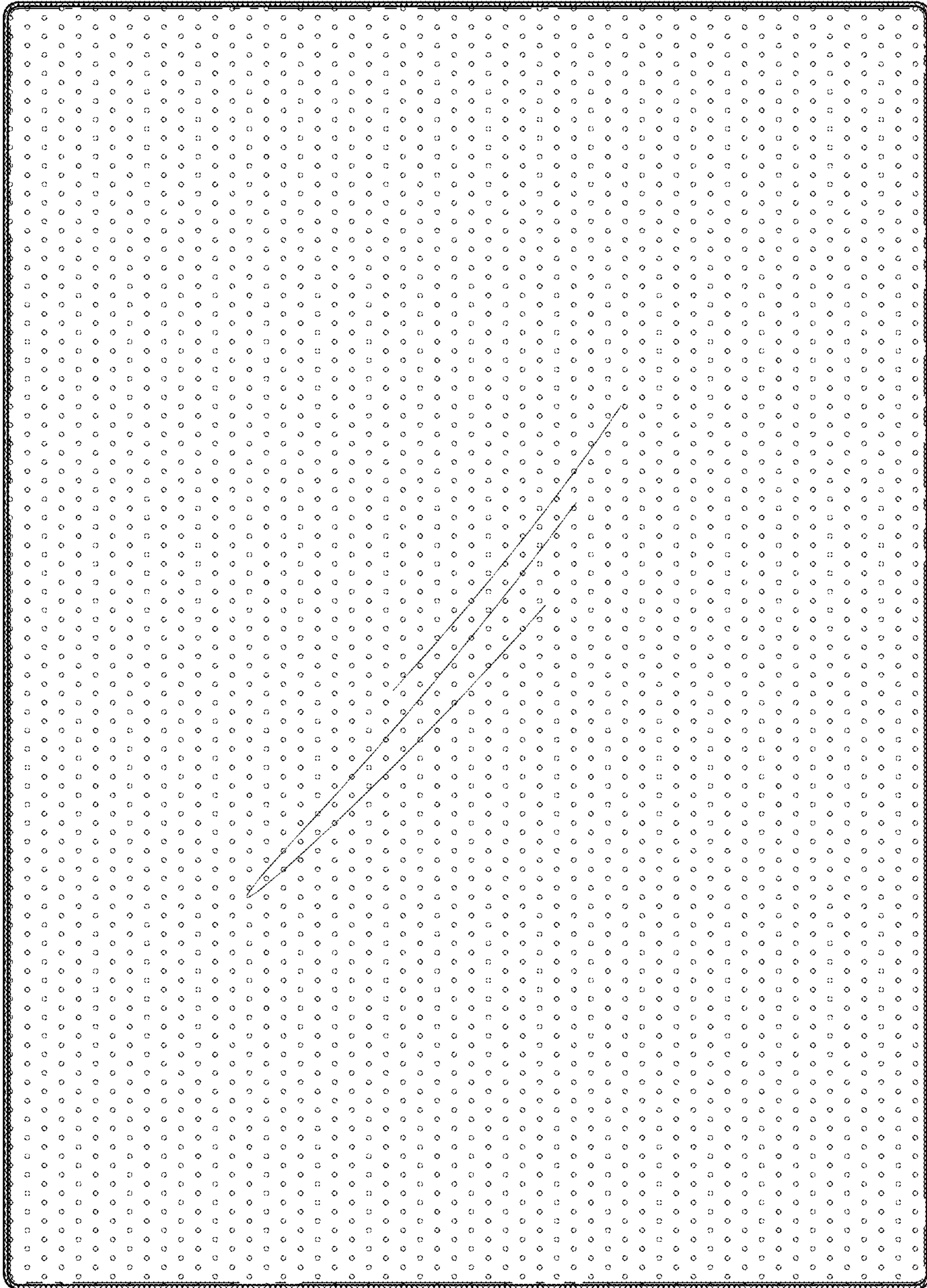

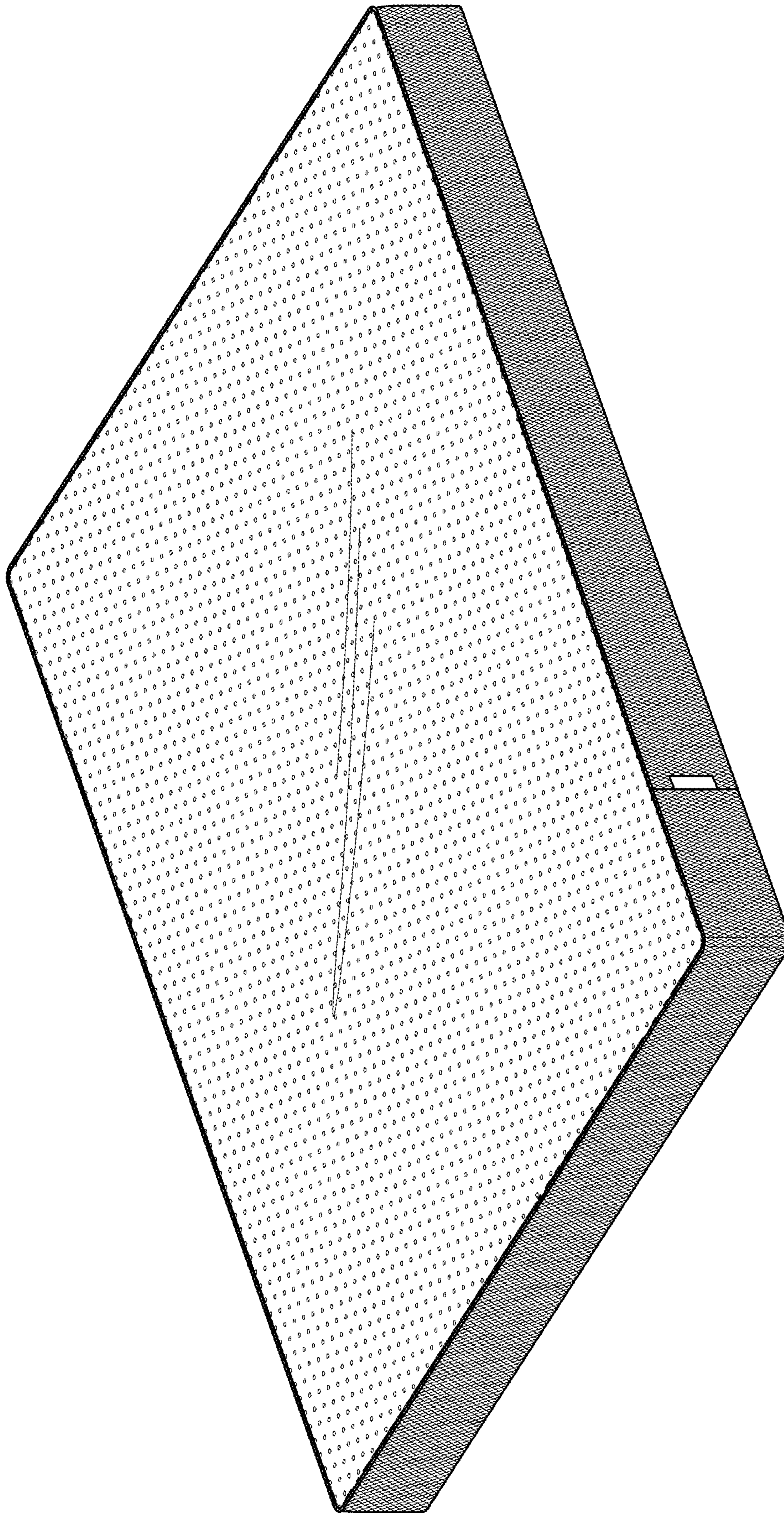

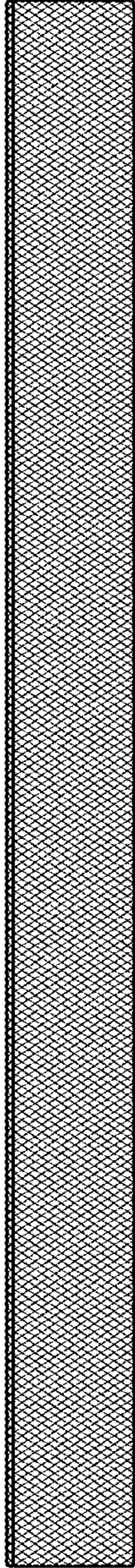

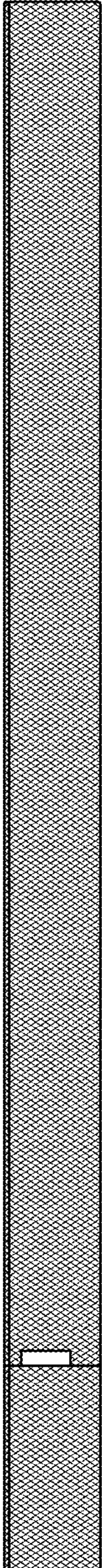

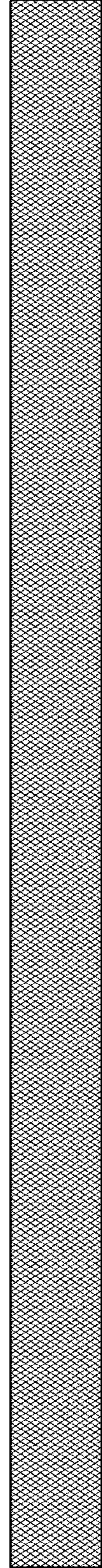

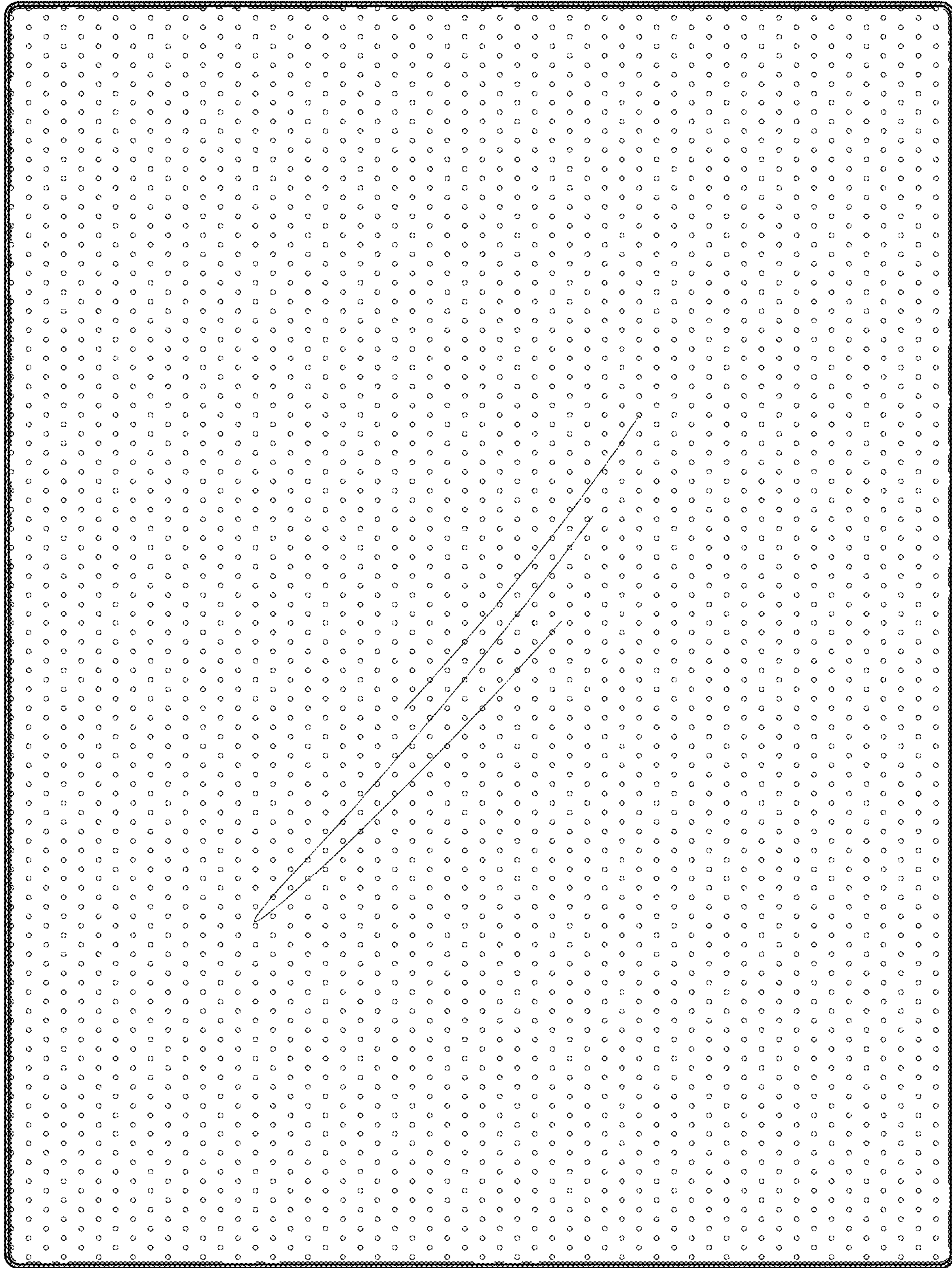

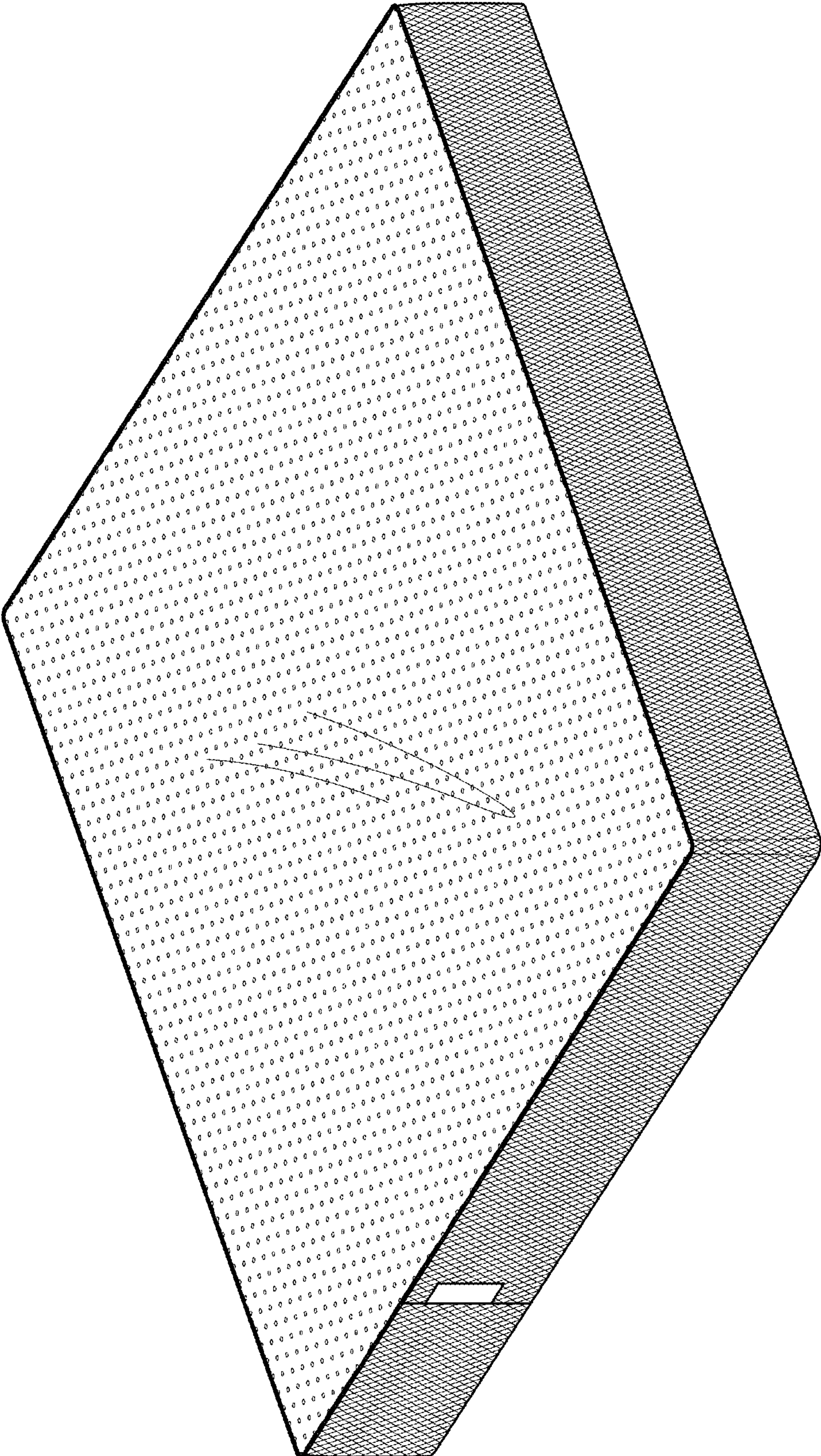

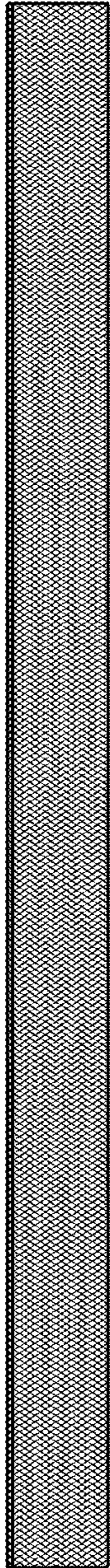

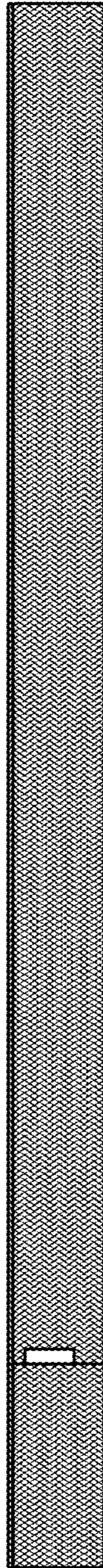

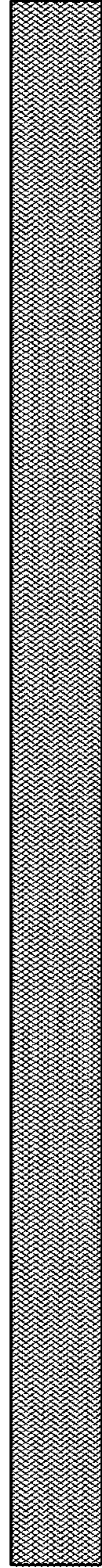

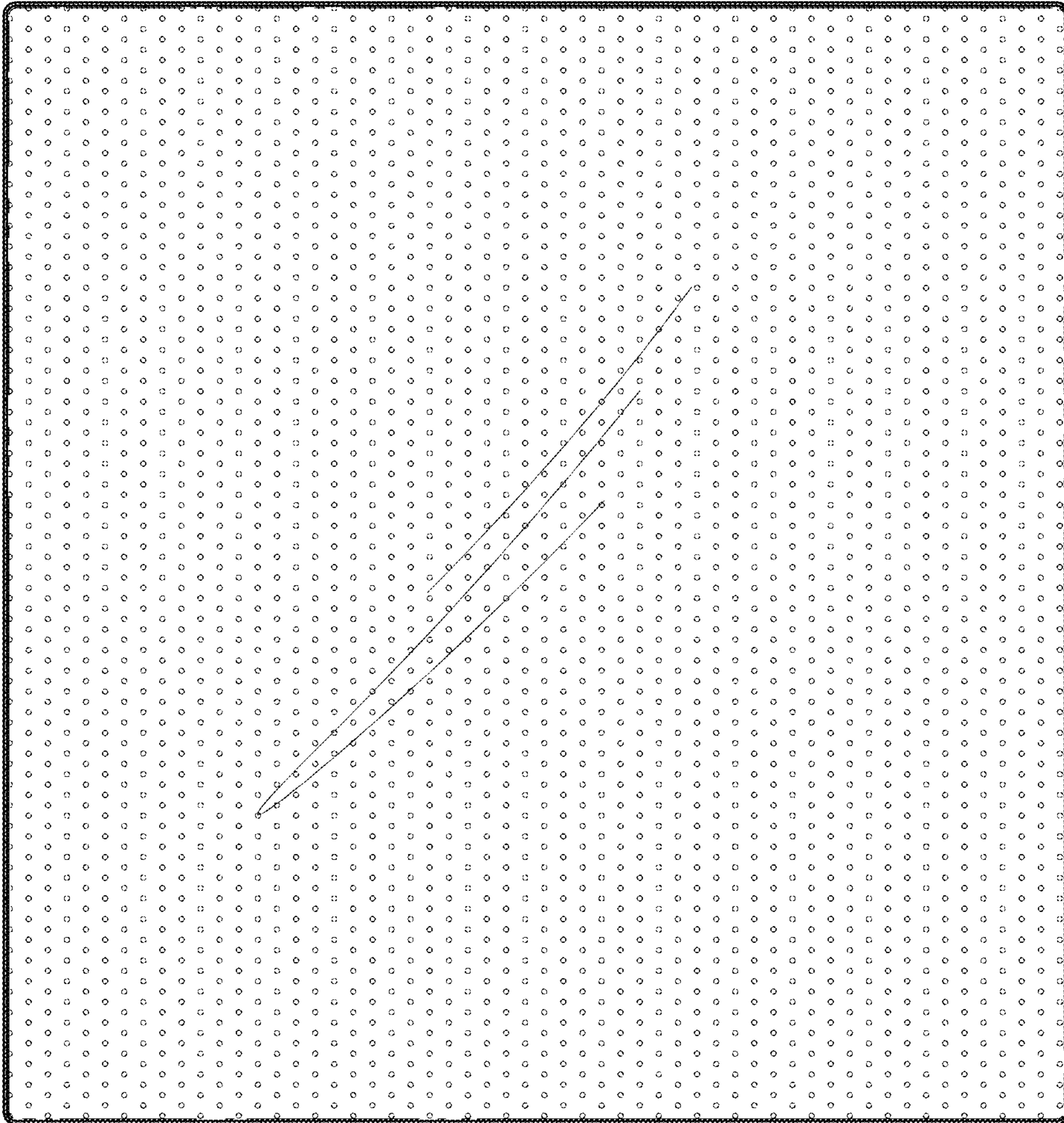

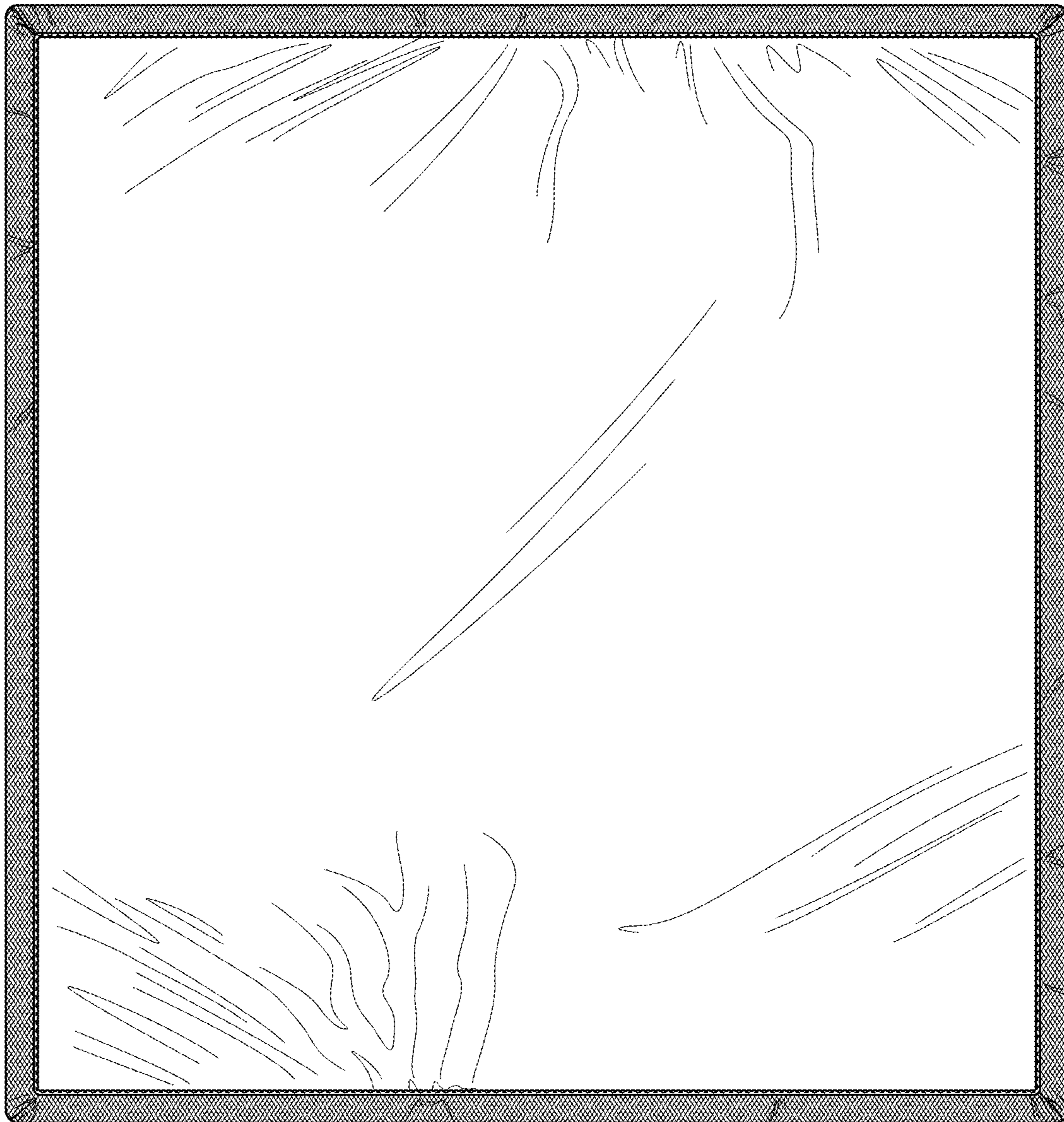

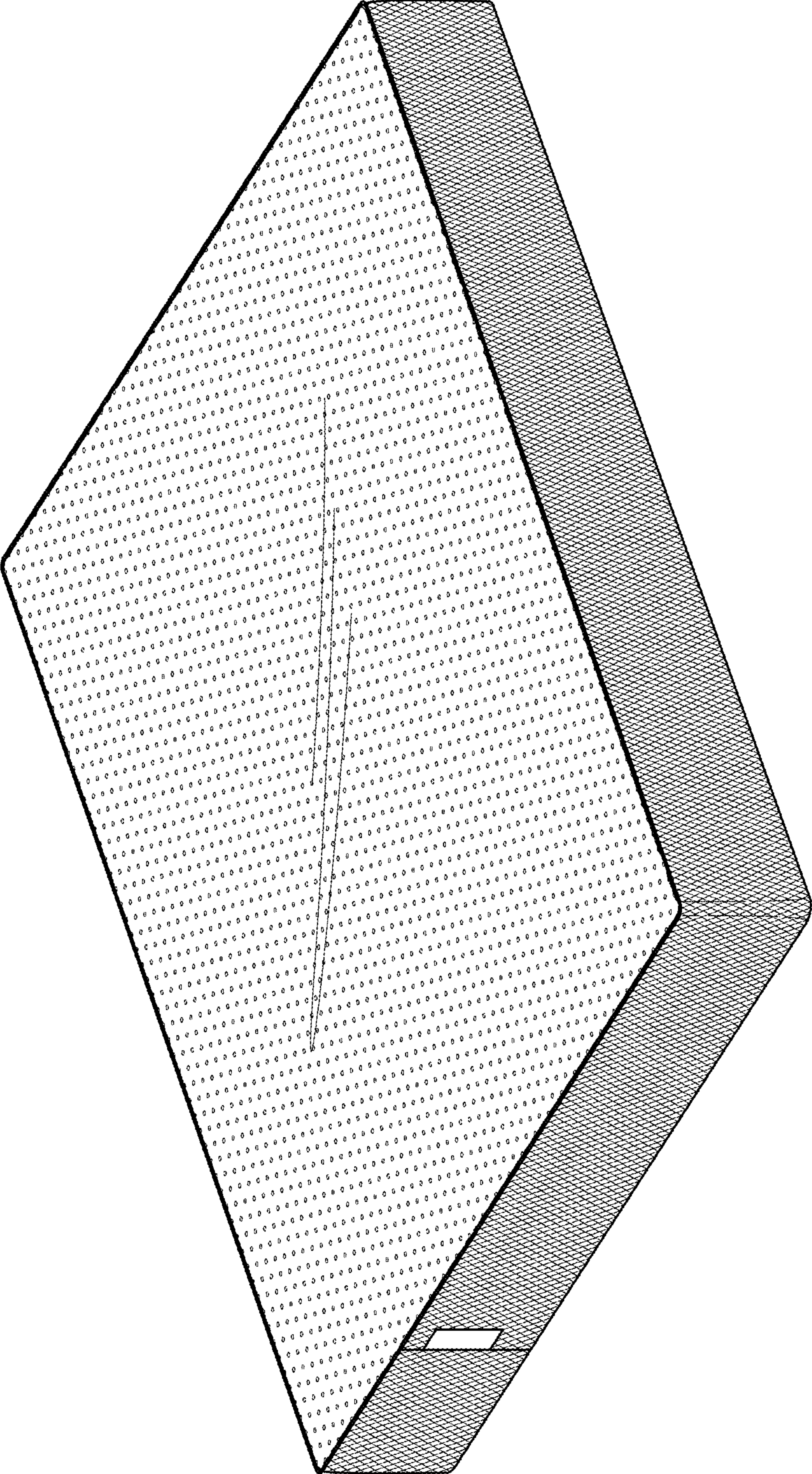

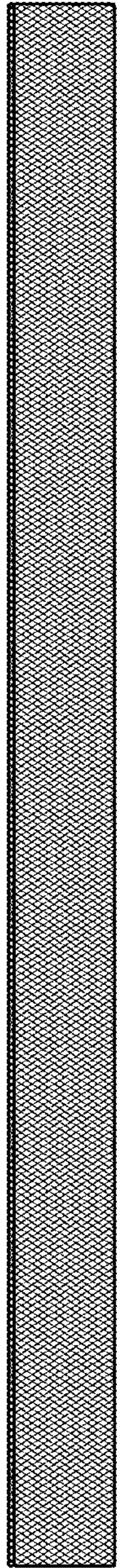

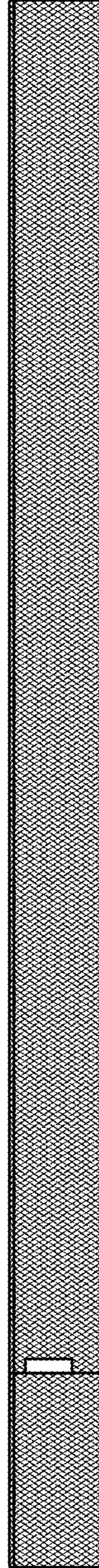

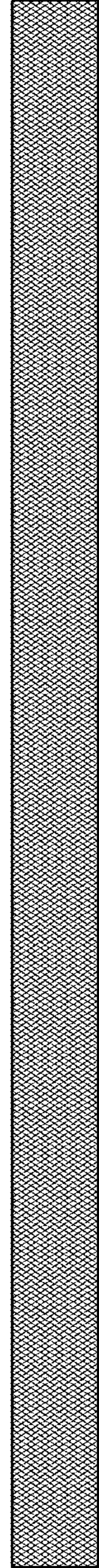

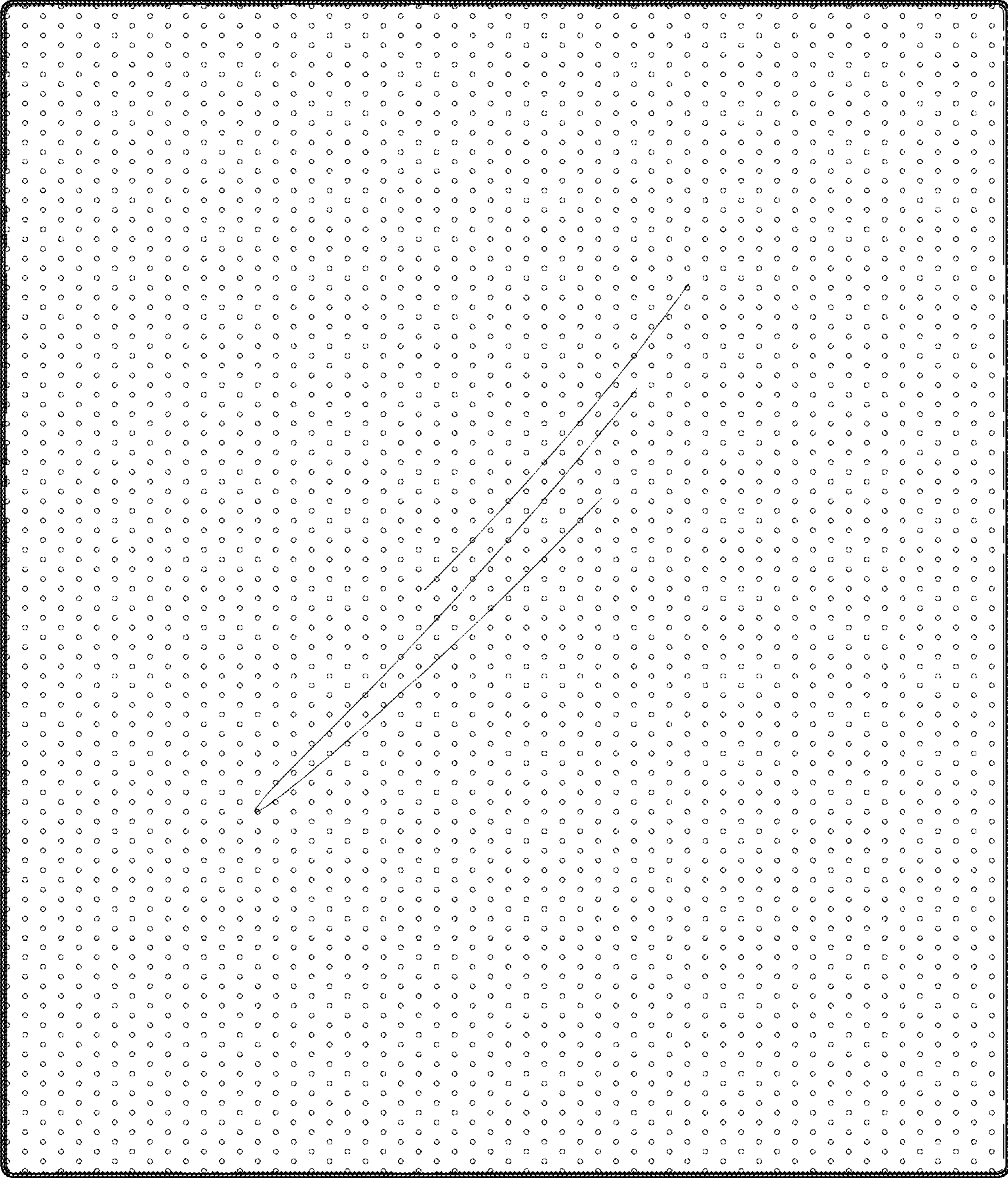

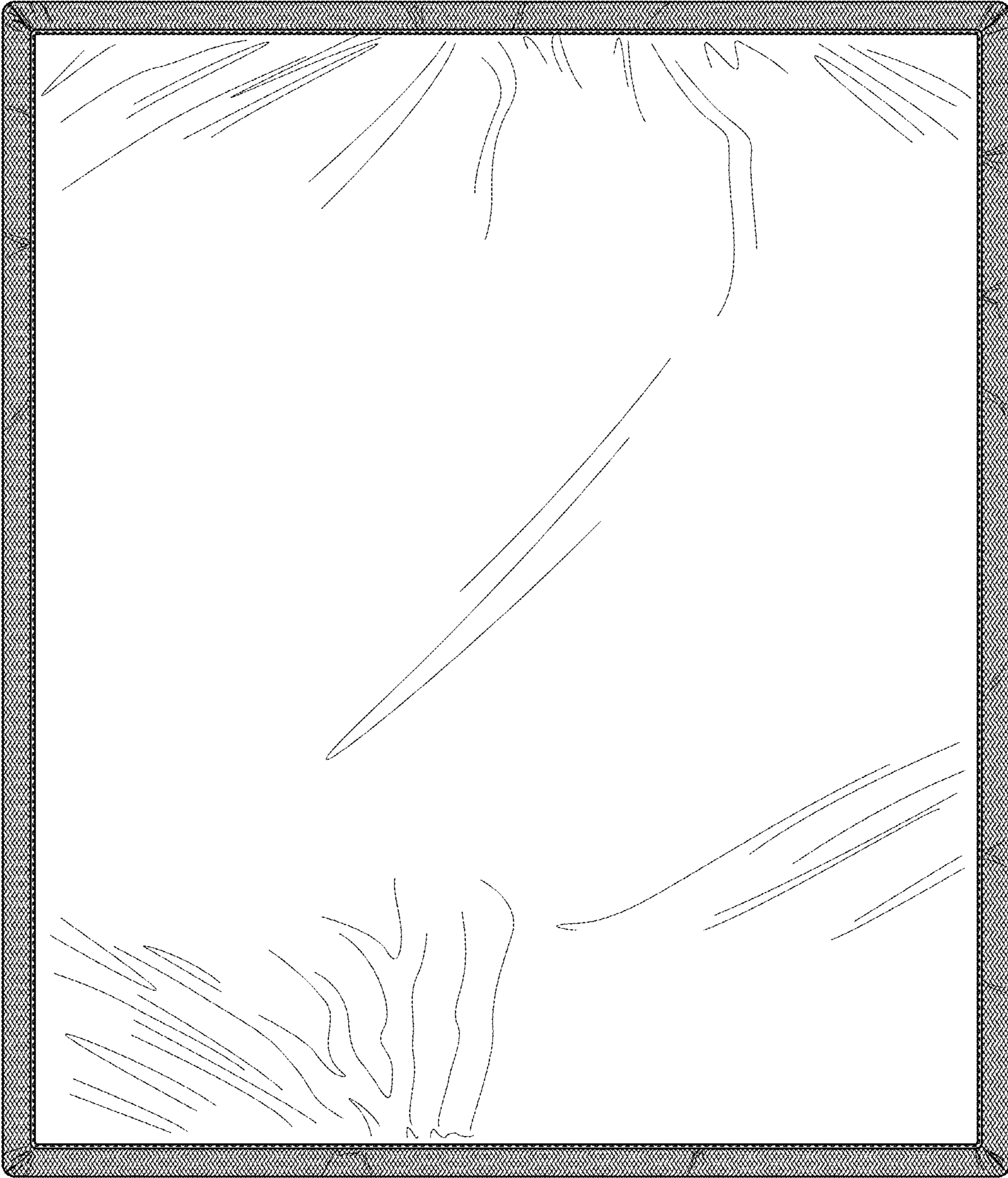
