(57) **CLAIM**

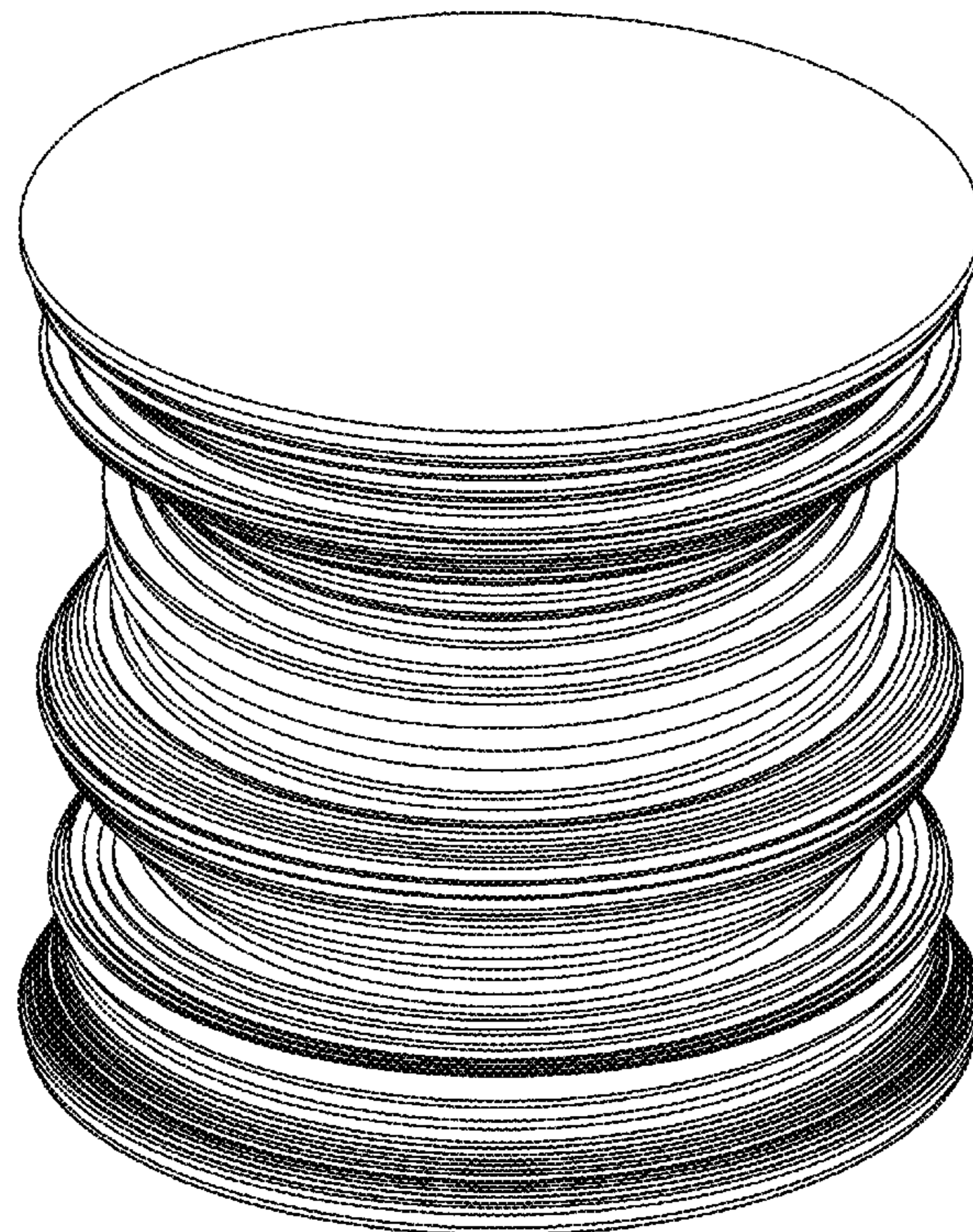
The ornamental design for a table, as shown and described.

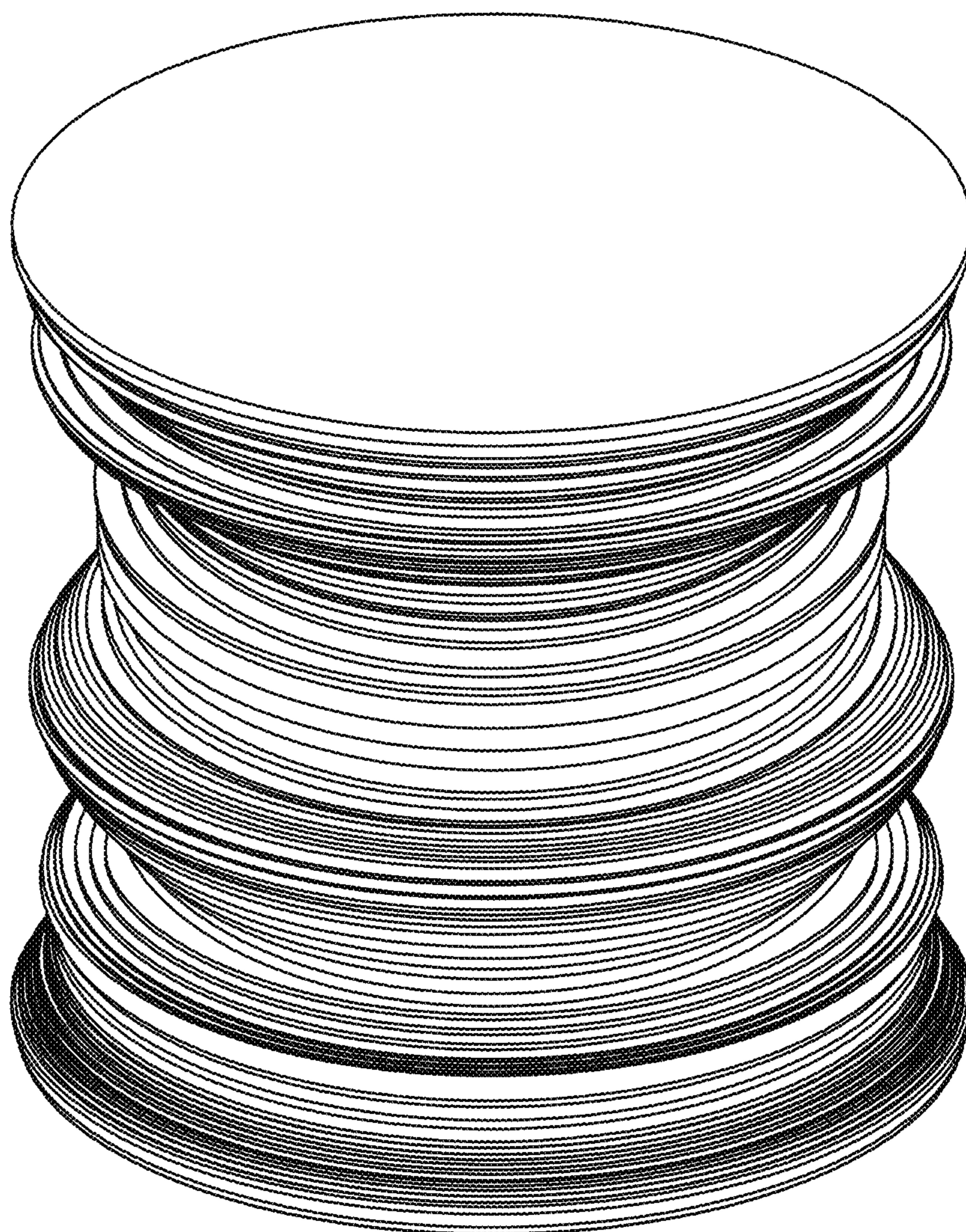

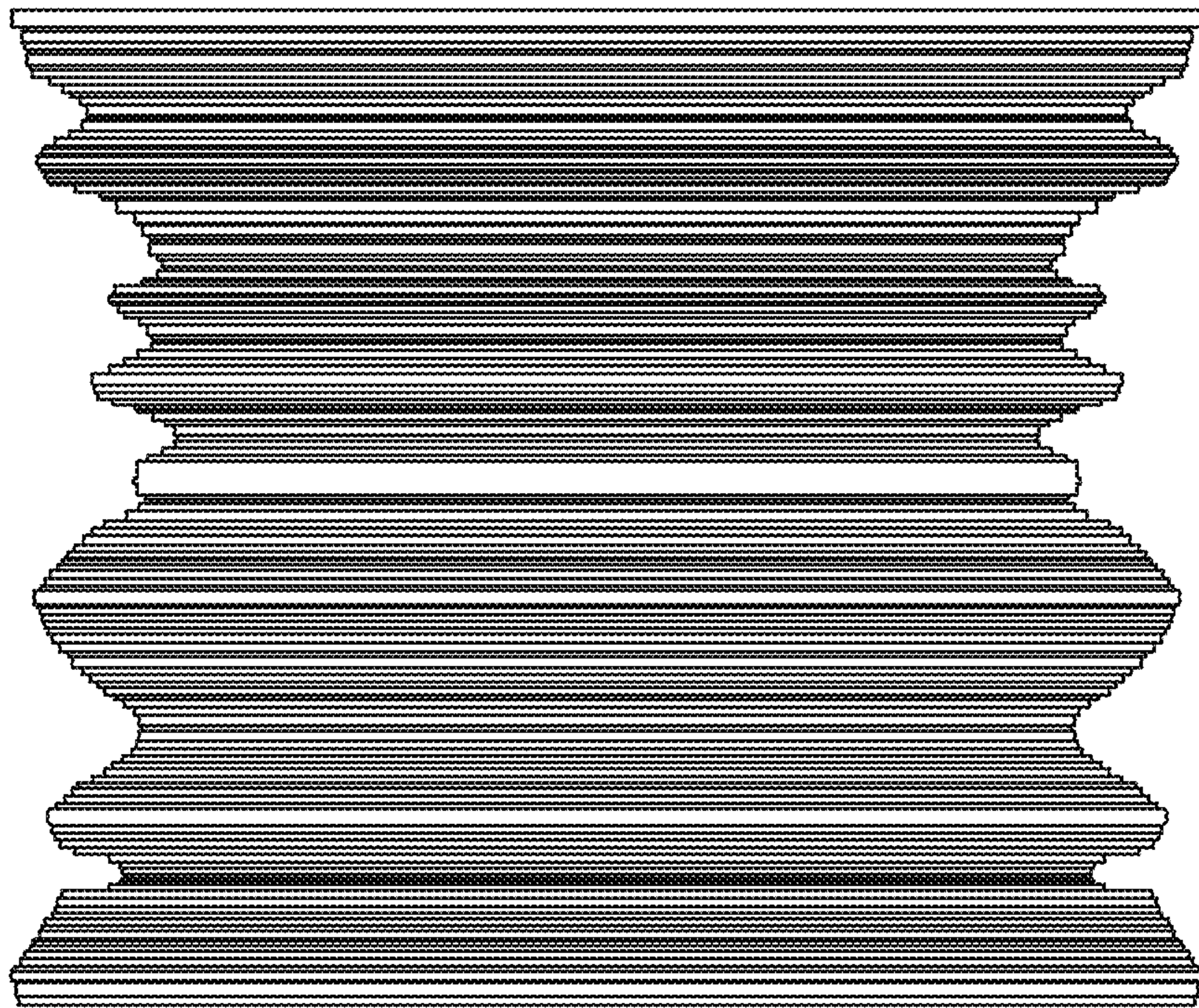

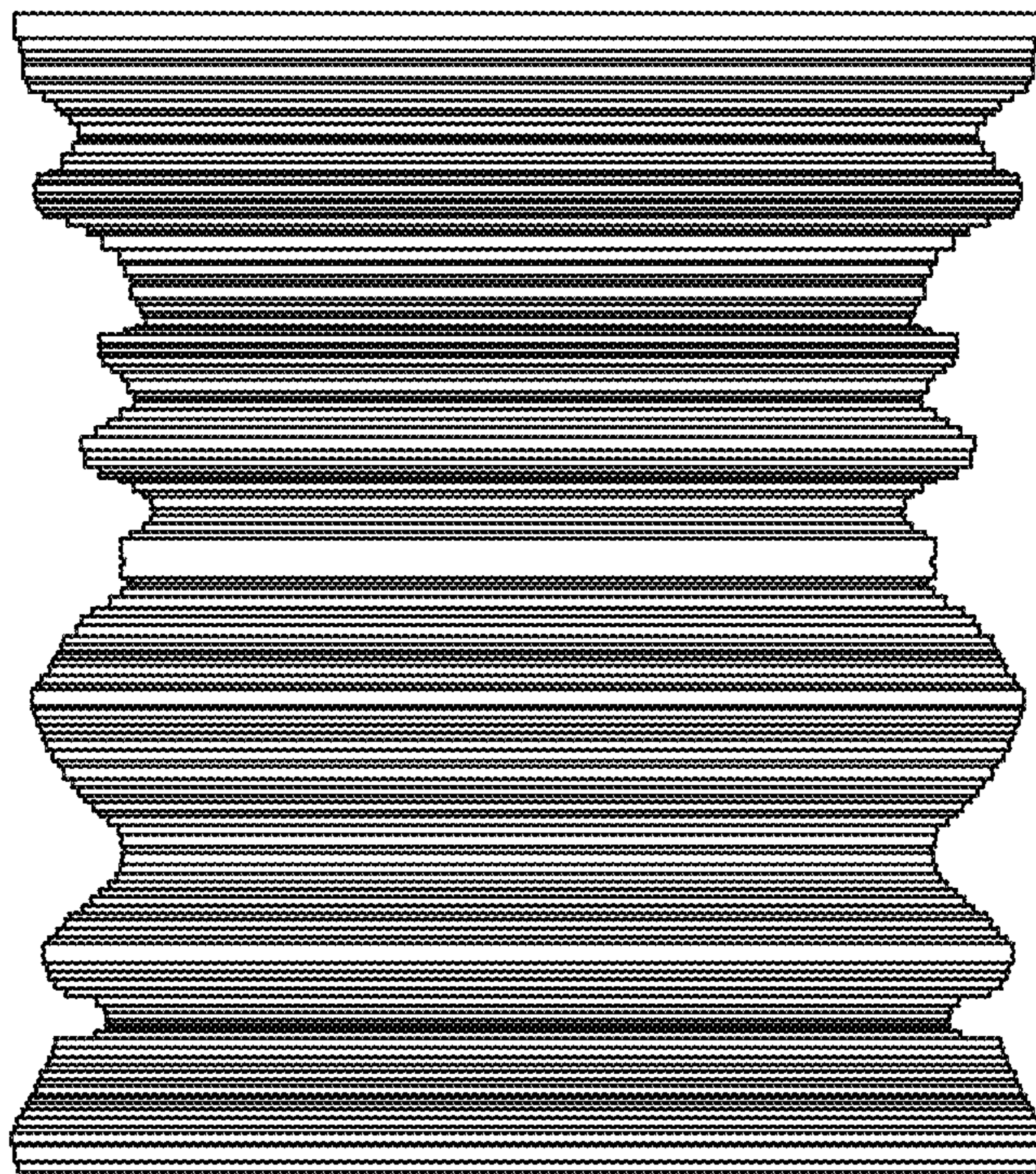

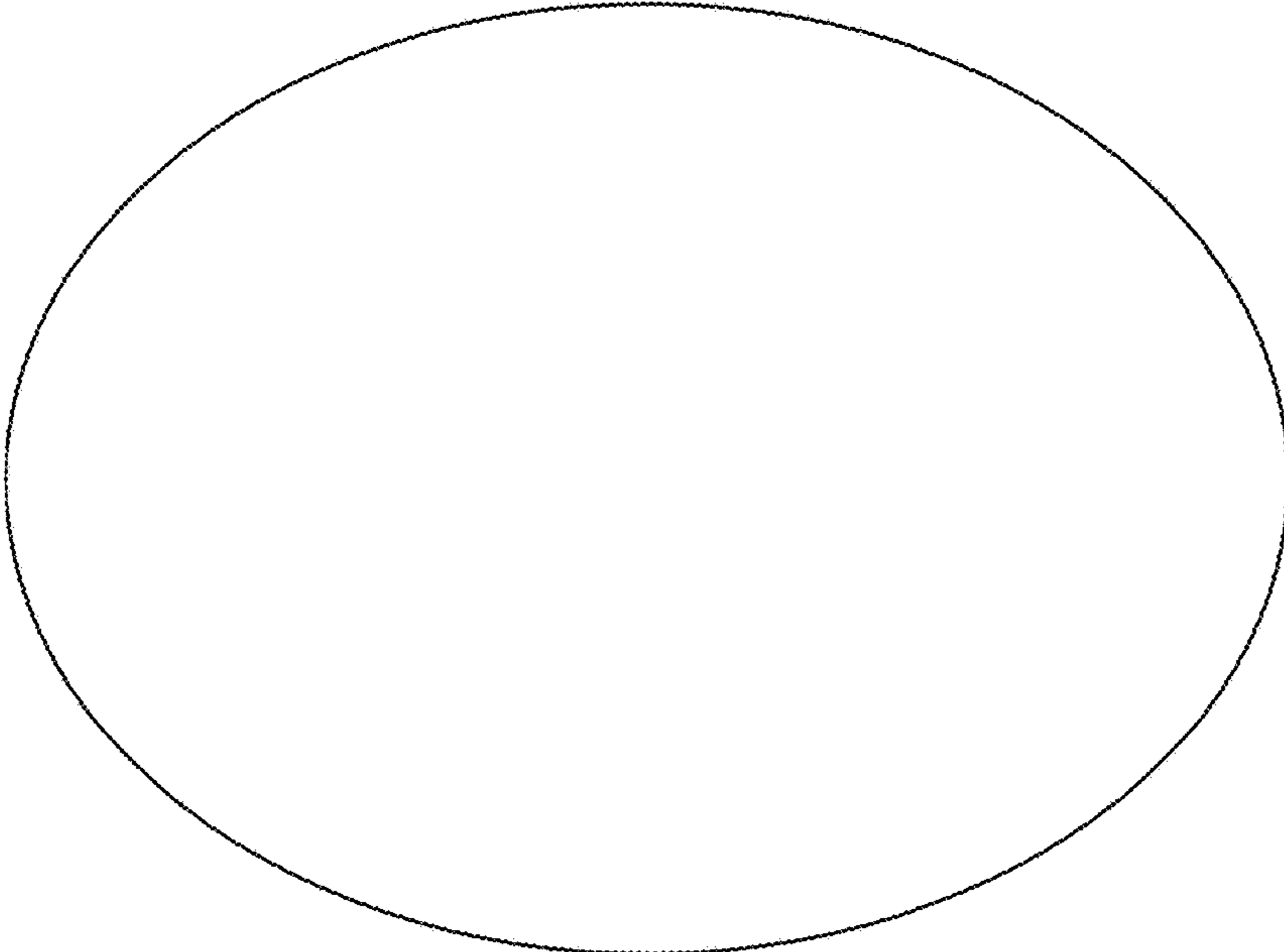

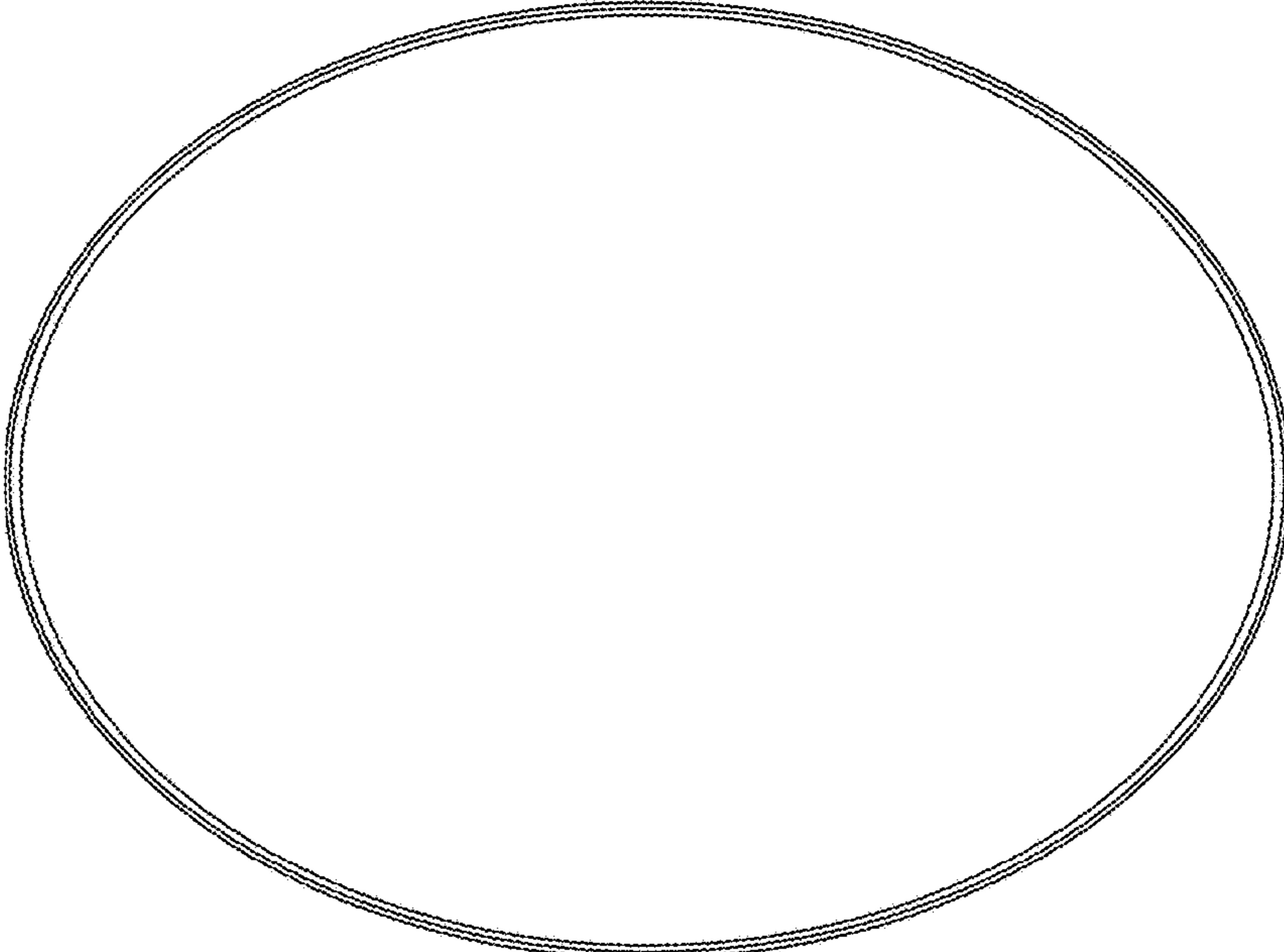
