DESCRIPTION

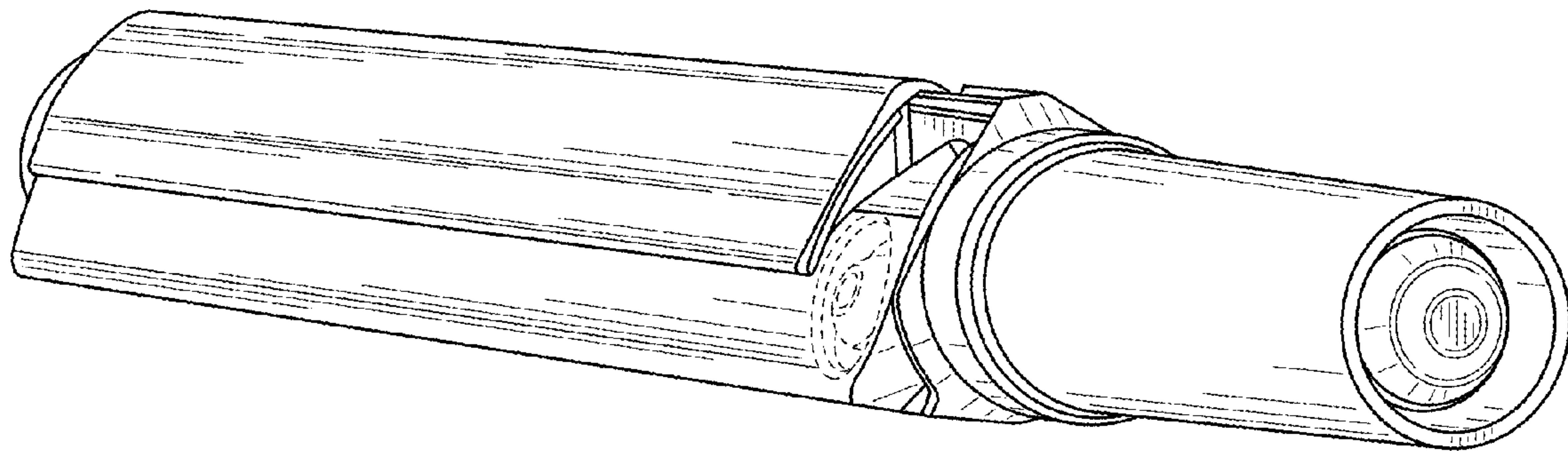
FIG. 1 is a first perspective view of the signaling flare according to a first variant;

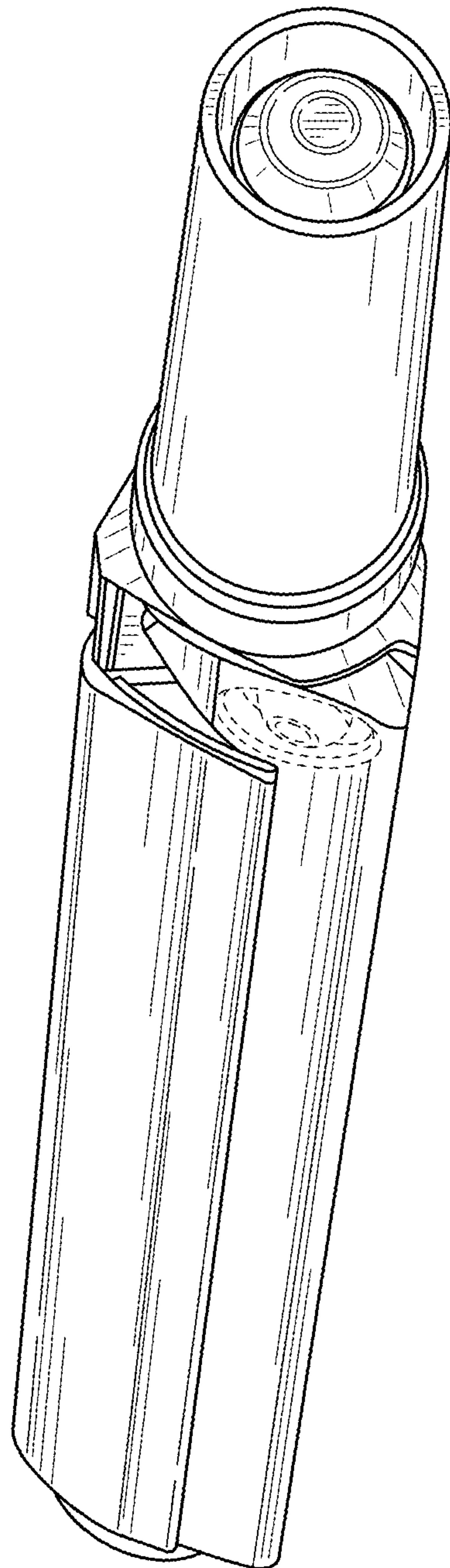

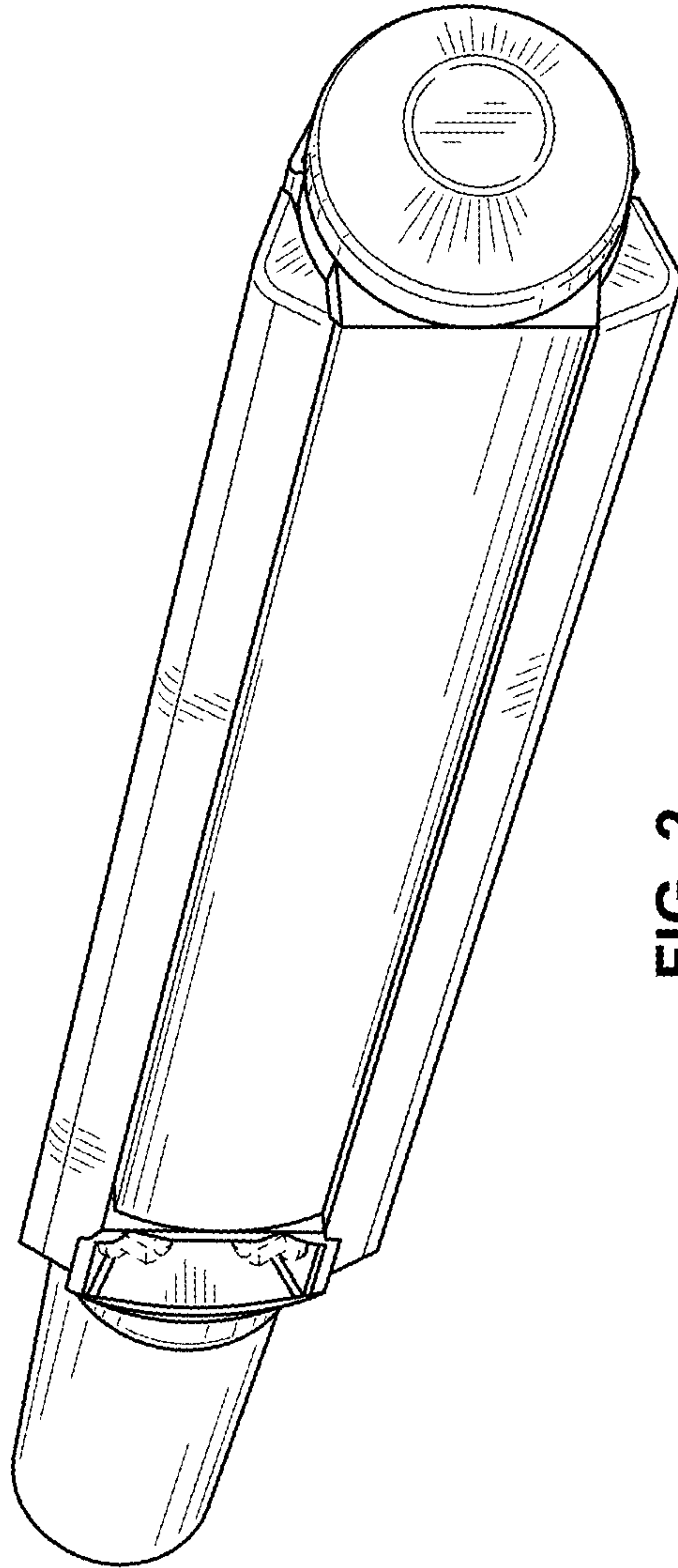

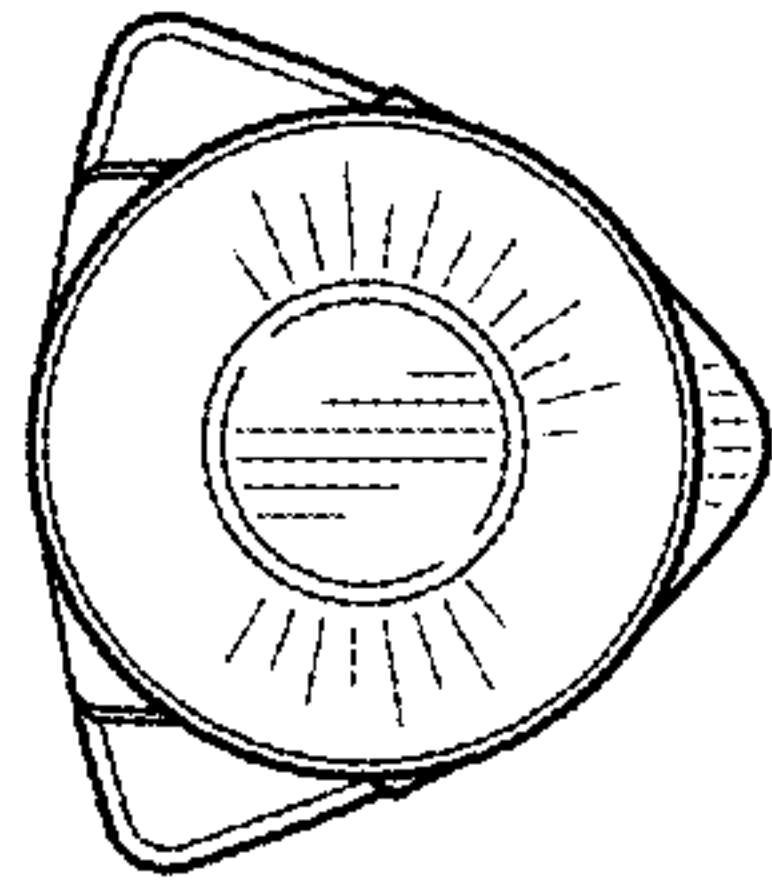

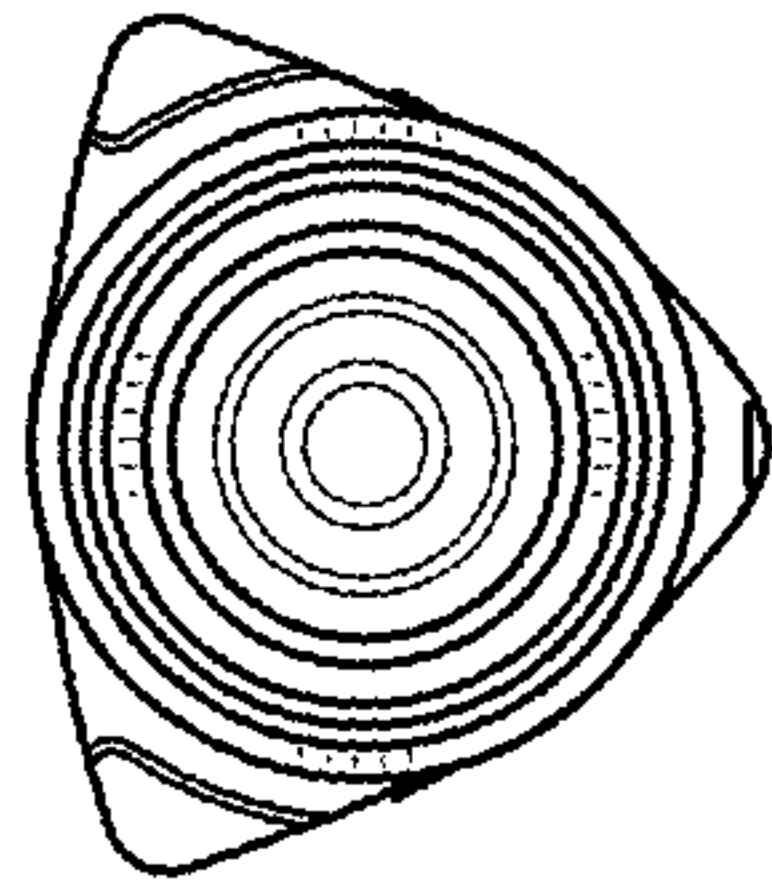

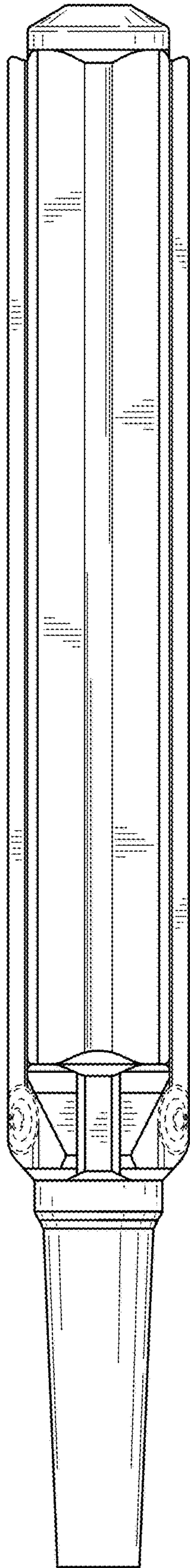

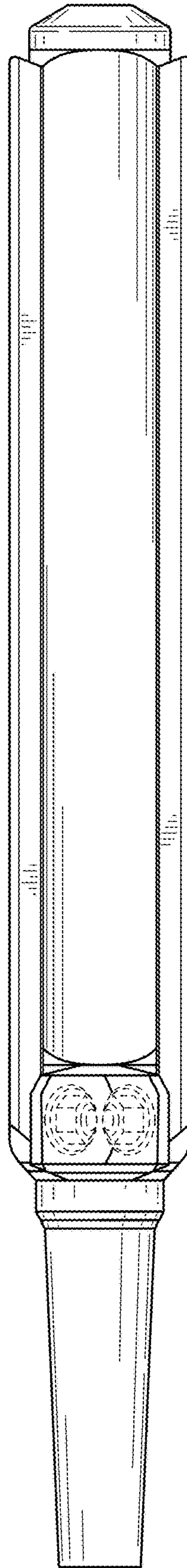

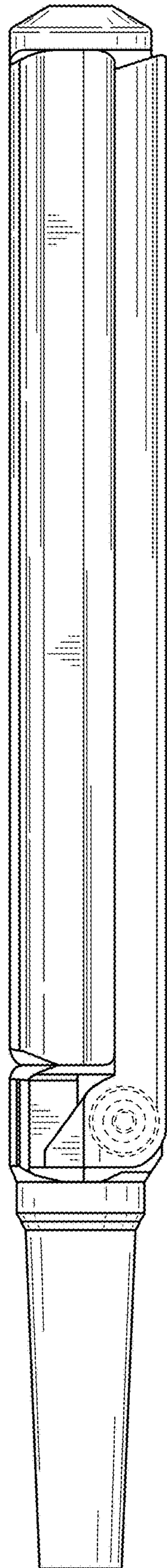

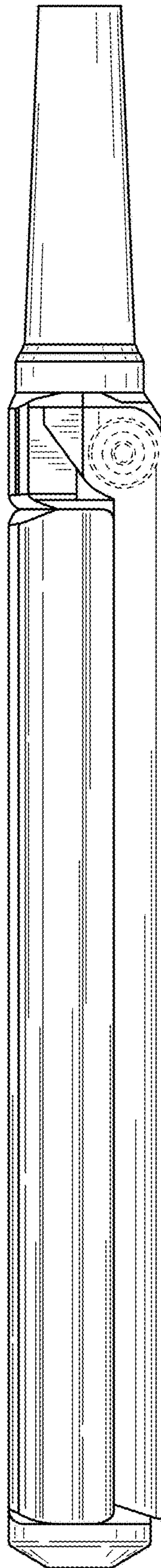
