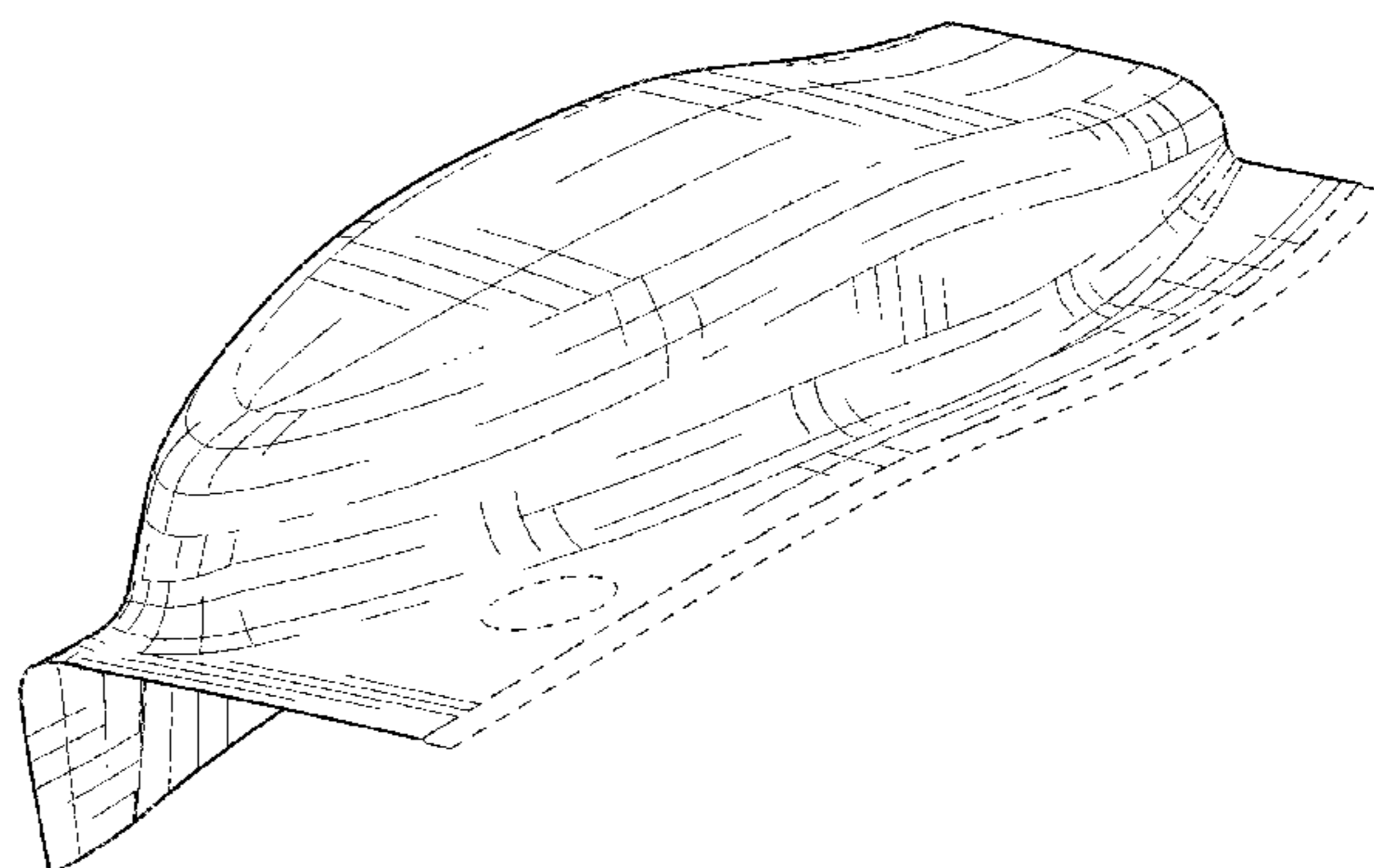
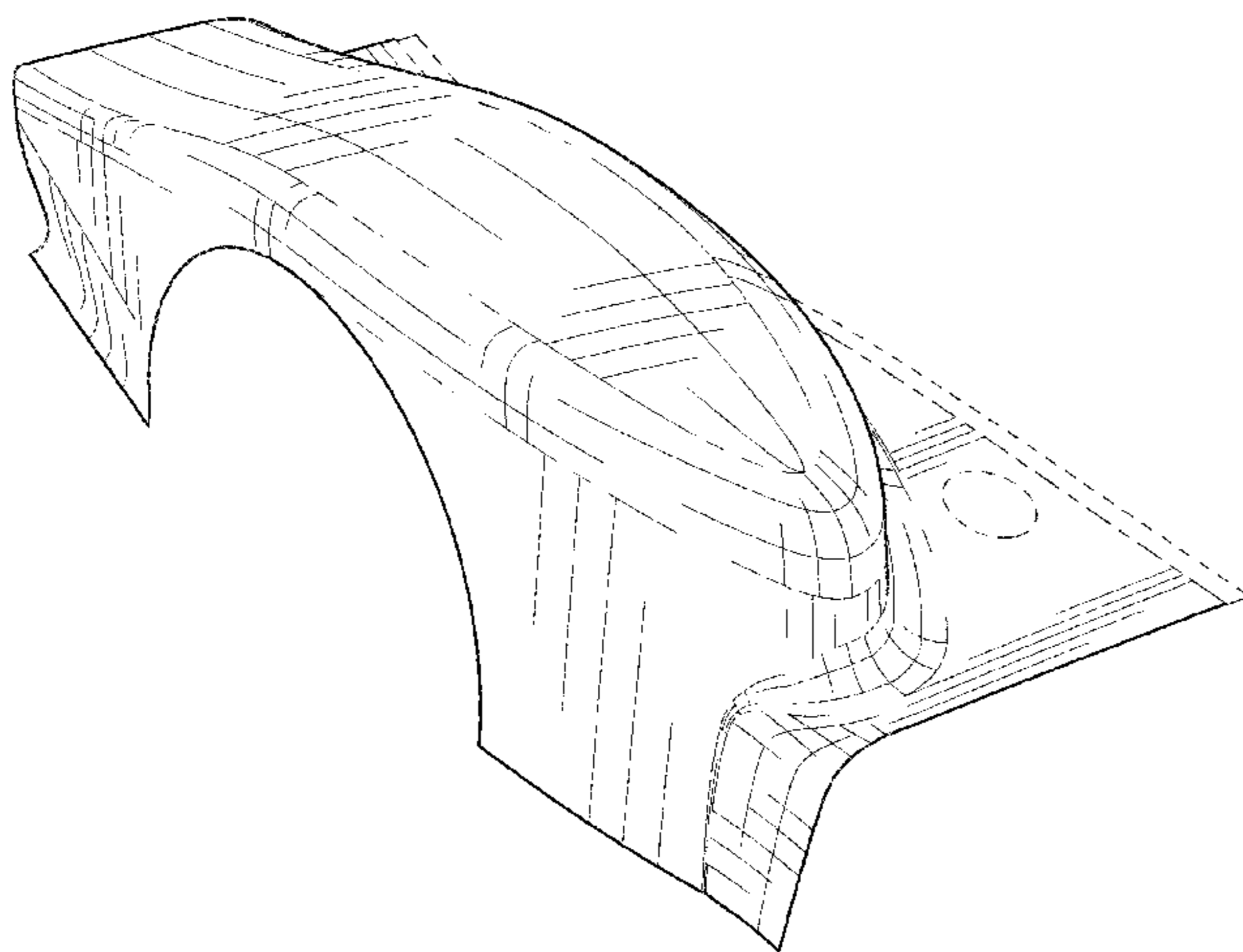
The ornamental design for a right rear section for a car body, as shown and described.

DESCRIPTION

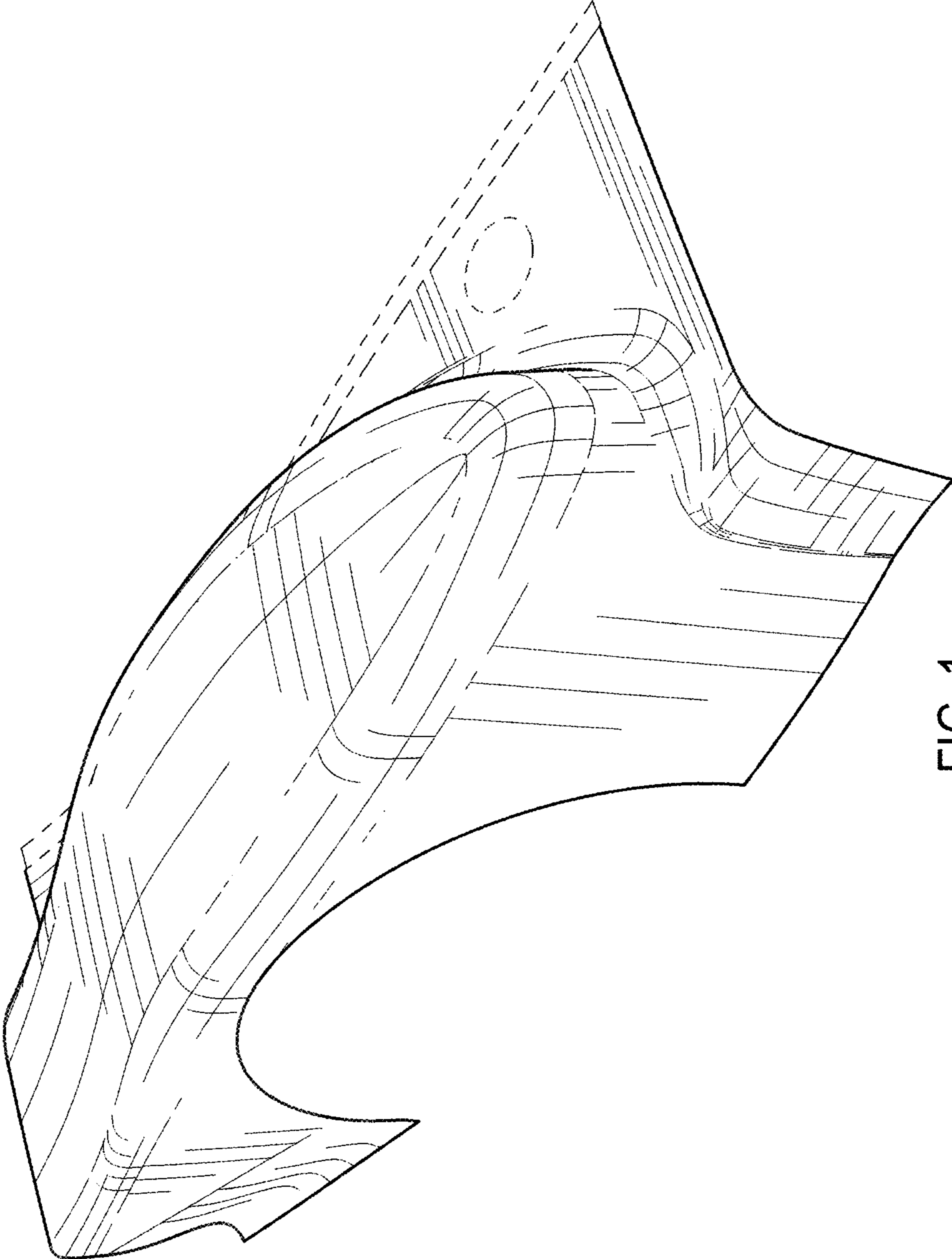

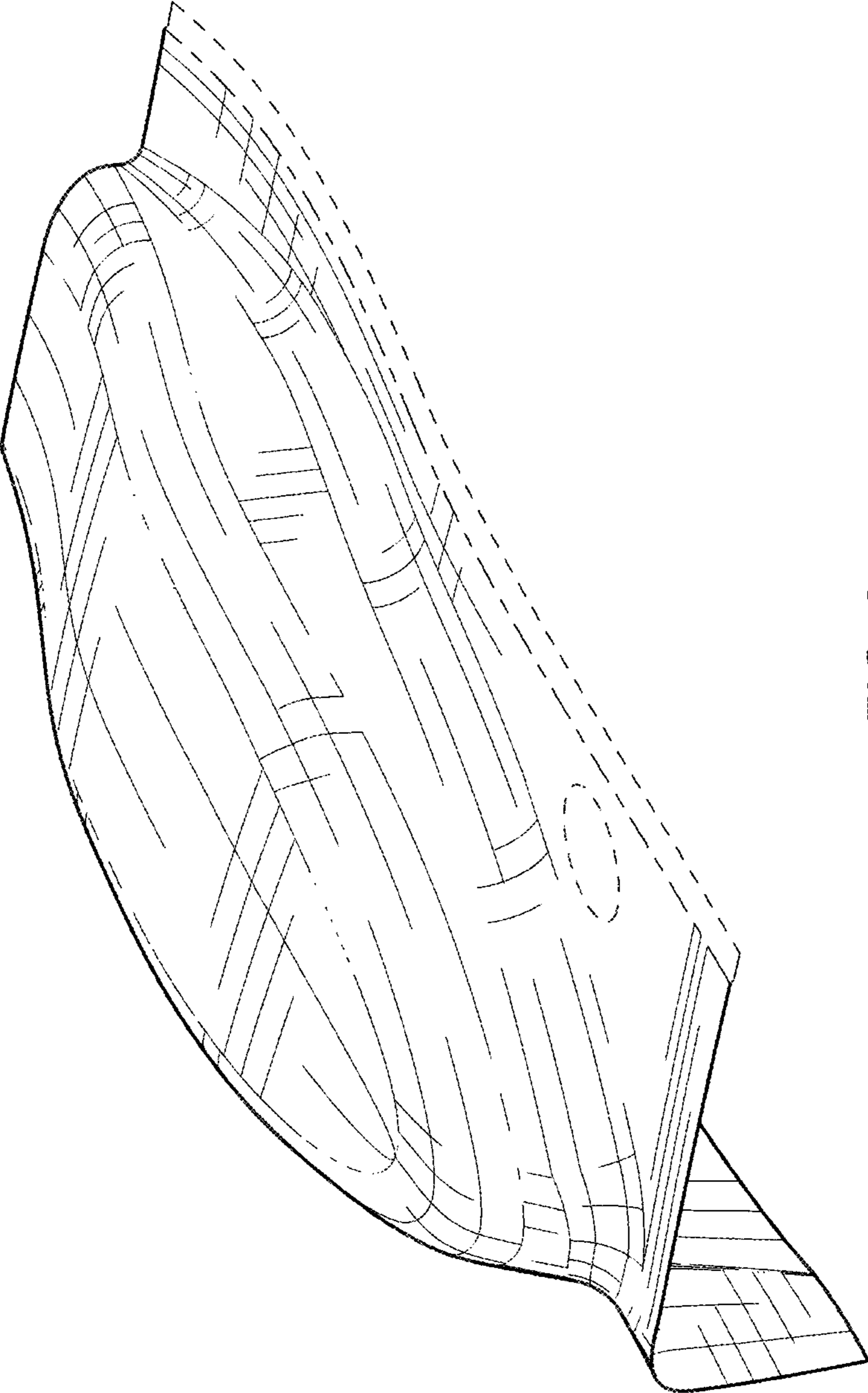

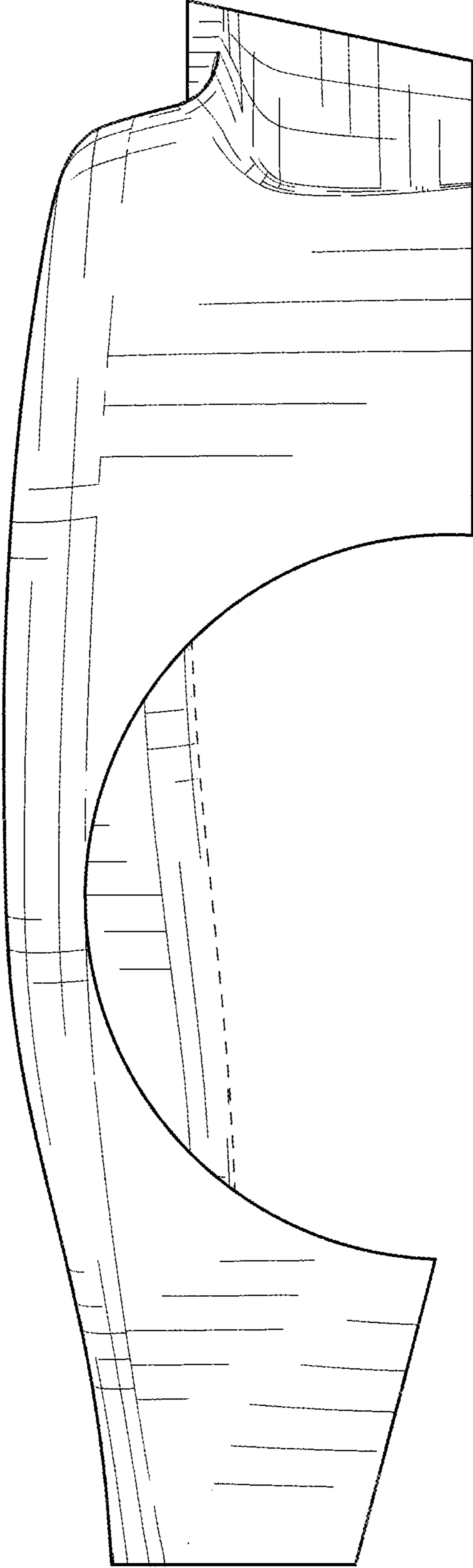

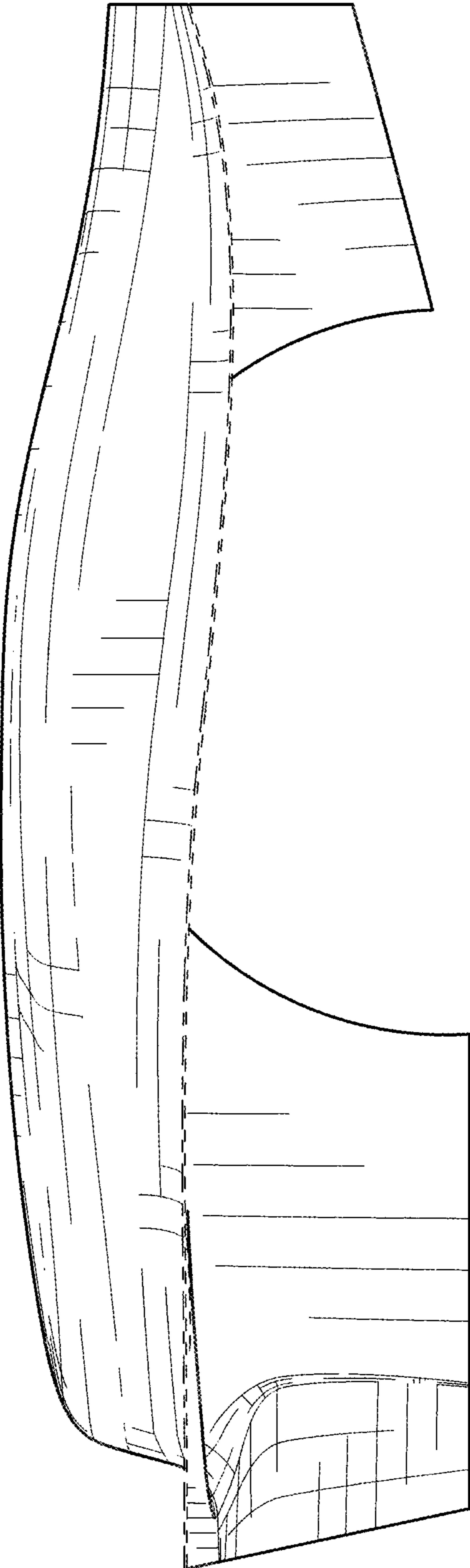

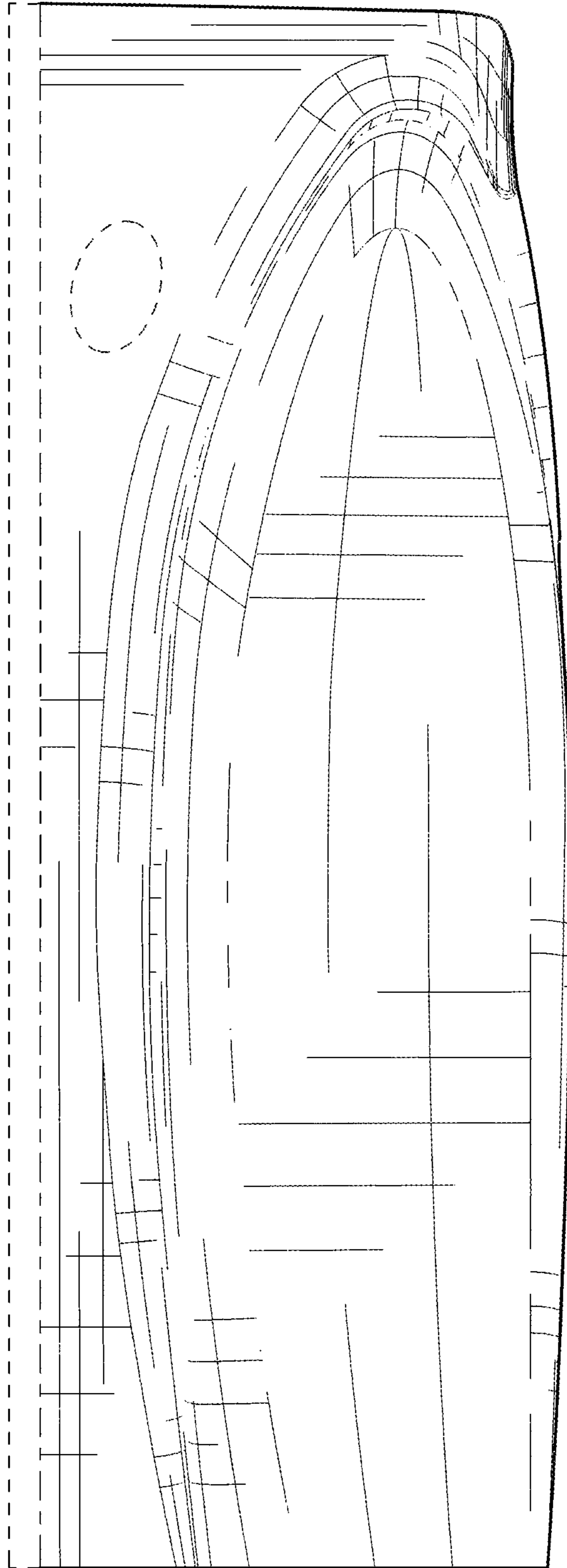

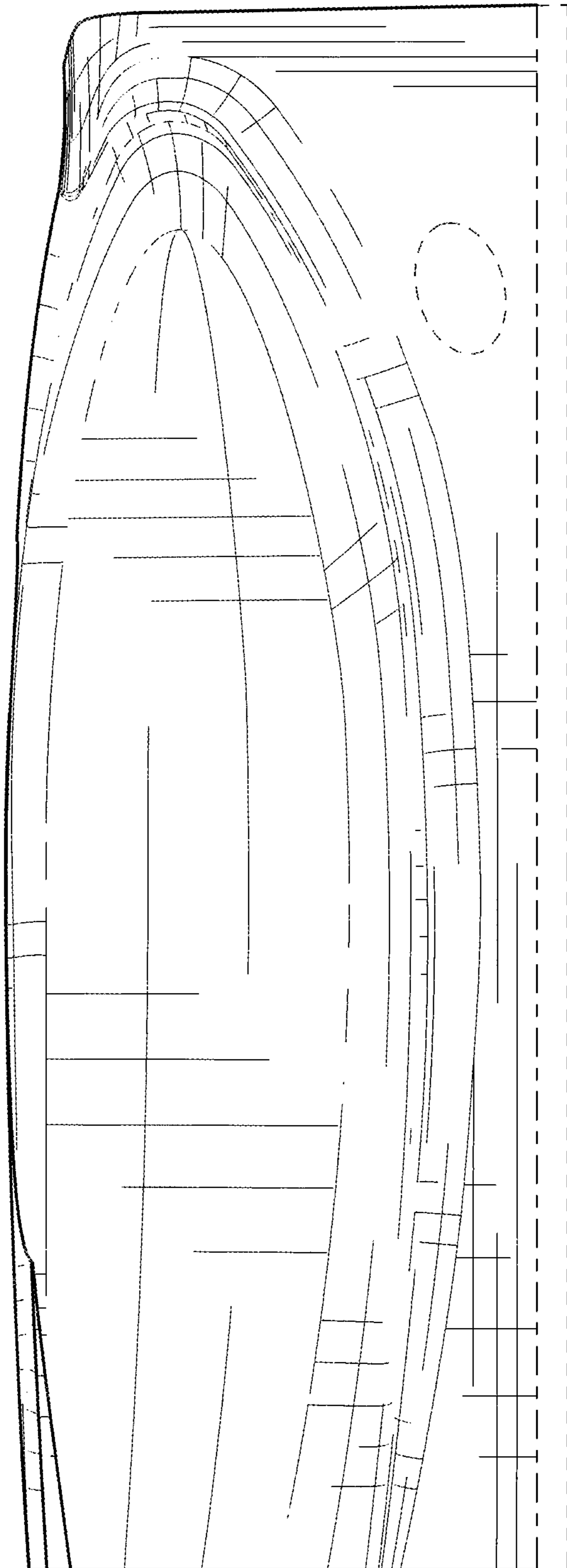

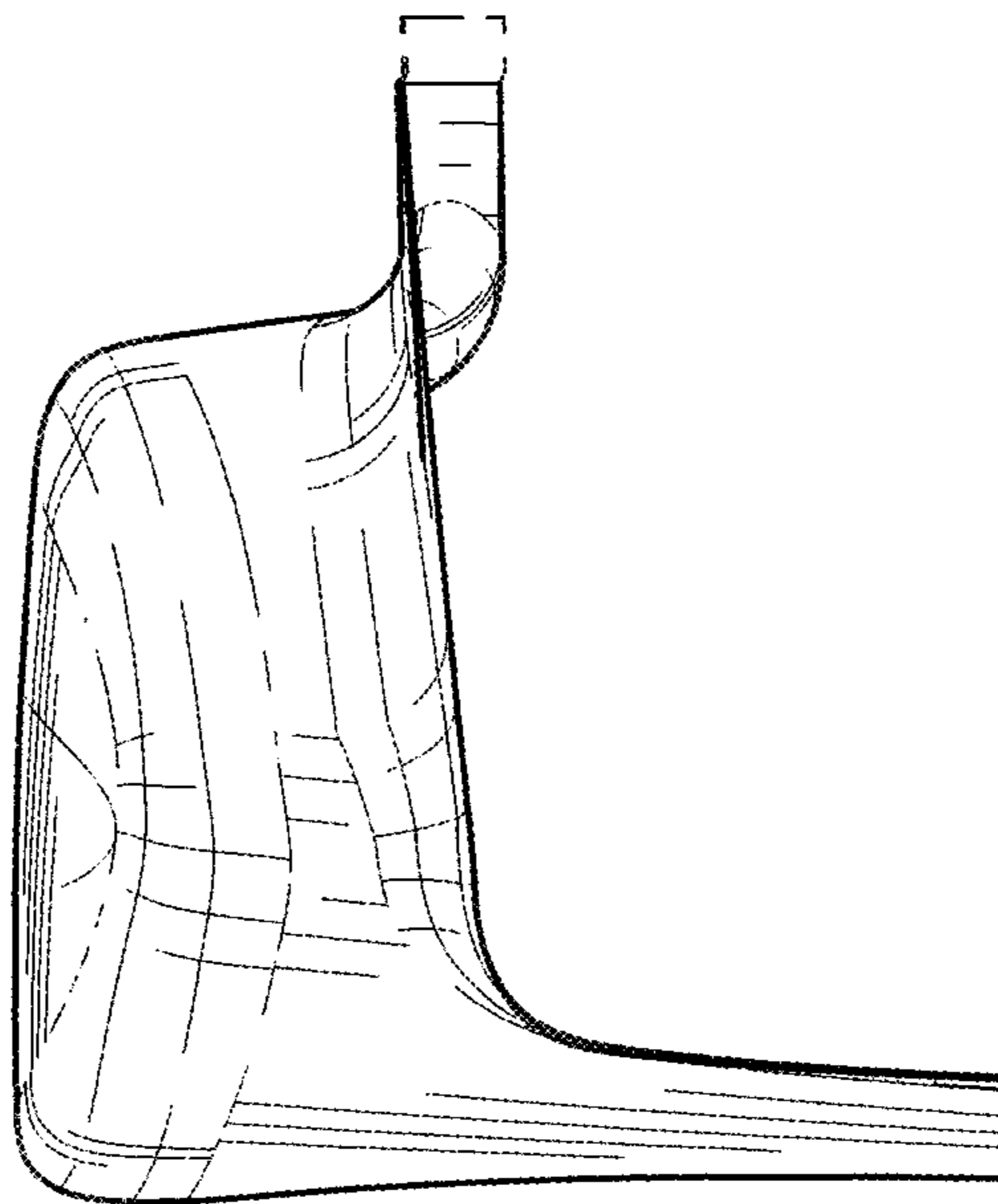

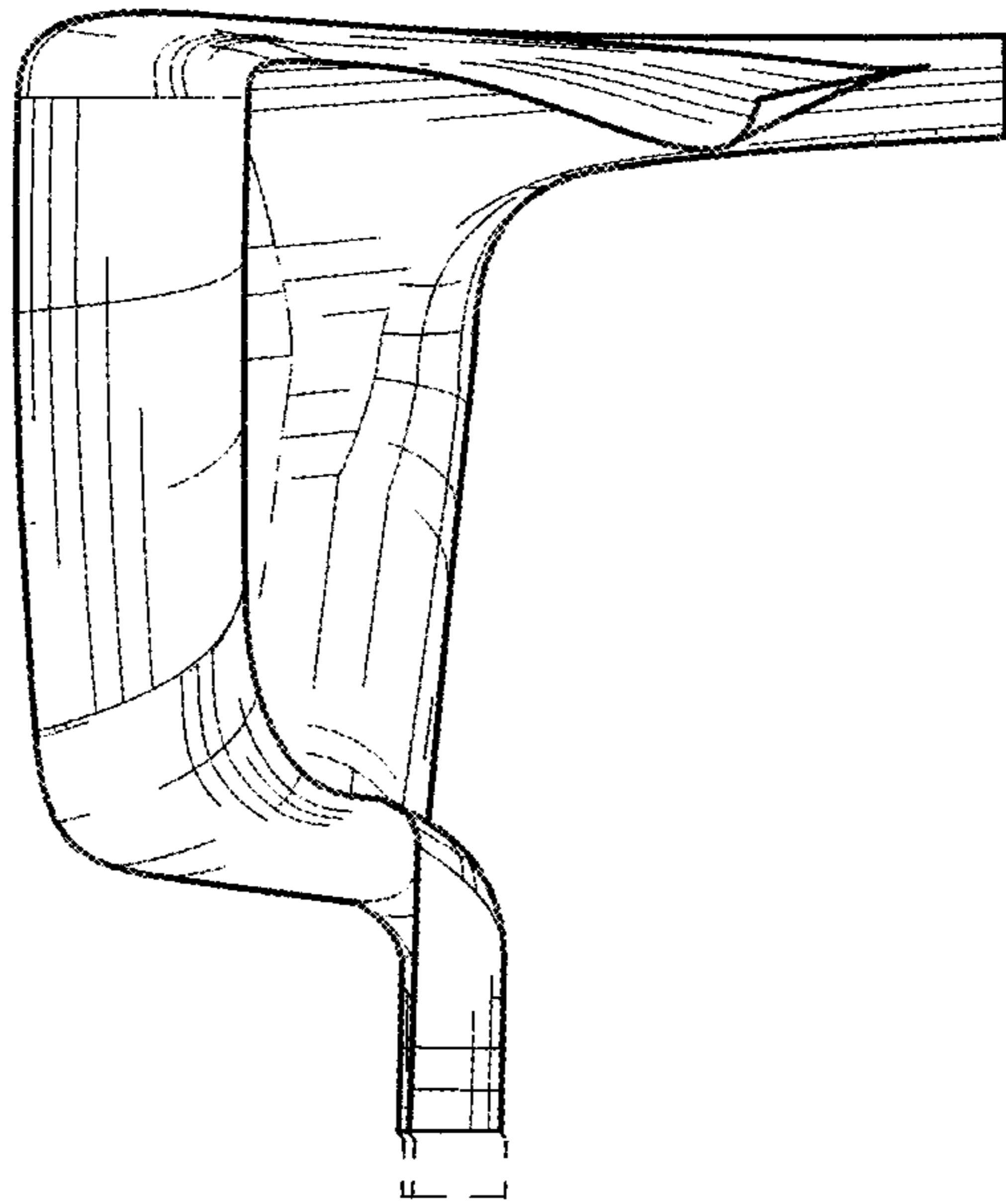
