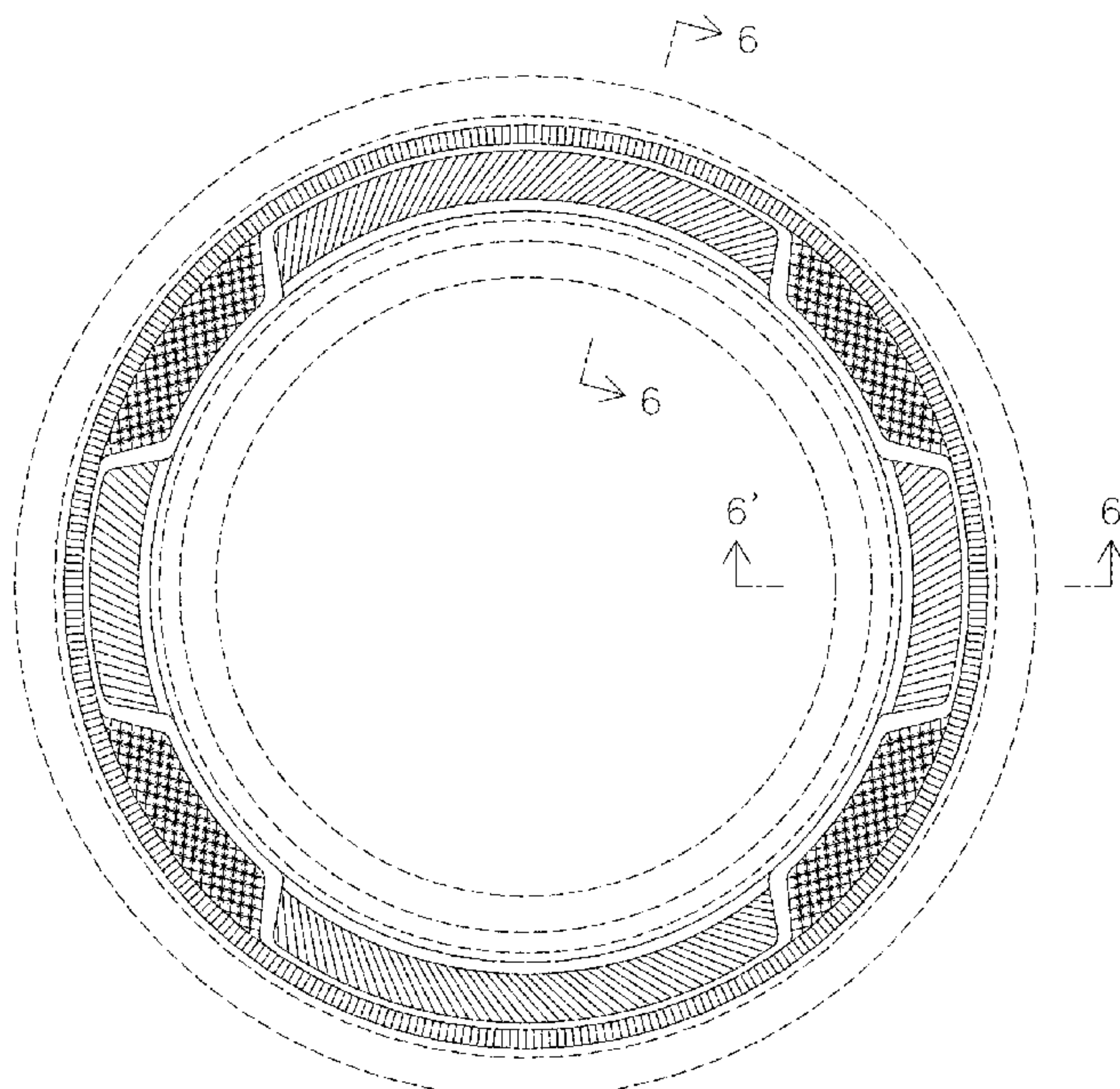
(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire showing the claimed design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a top plan view thereof, the bottom plan view being a mirror image;
 FIG. 5 is a left side view thereof, the right side view being a mirror image;
 FIG. 6 is an enlarged view taken along lines 6-6 and 6'-6' in FIG. 2;
 FIG. 7 is an enlarged cross-sectional view taken along line 7-7 in FIG. 6;
 FIG. 8 is another enlarged view taken along lines 6-6 and 6'-6' in FIG. 2; and,
 FIG. 9 is an enlarged cross-sectional view taken along line 9-9 in FIG. 8.
 In the drawings, the broken lines showing portions of the tire tread, sidewall, and inner bead depict portions of the tire that form no part of the claimed design.

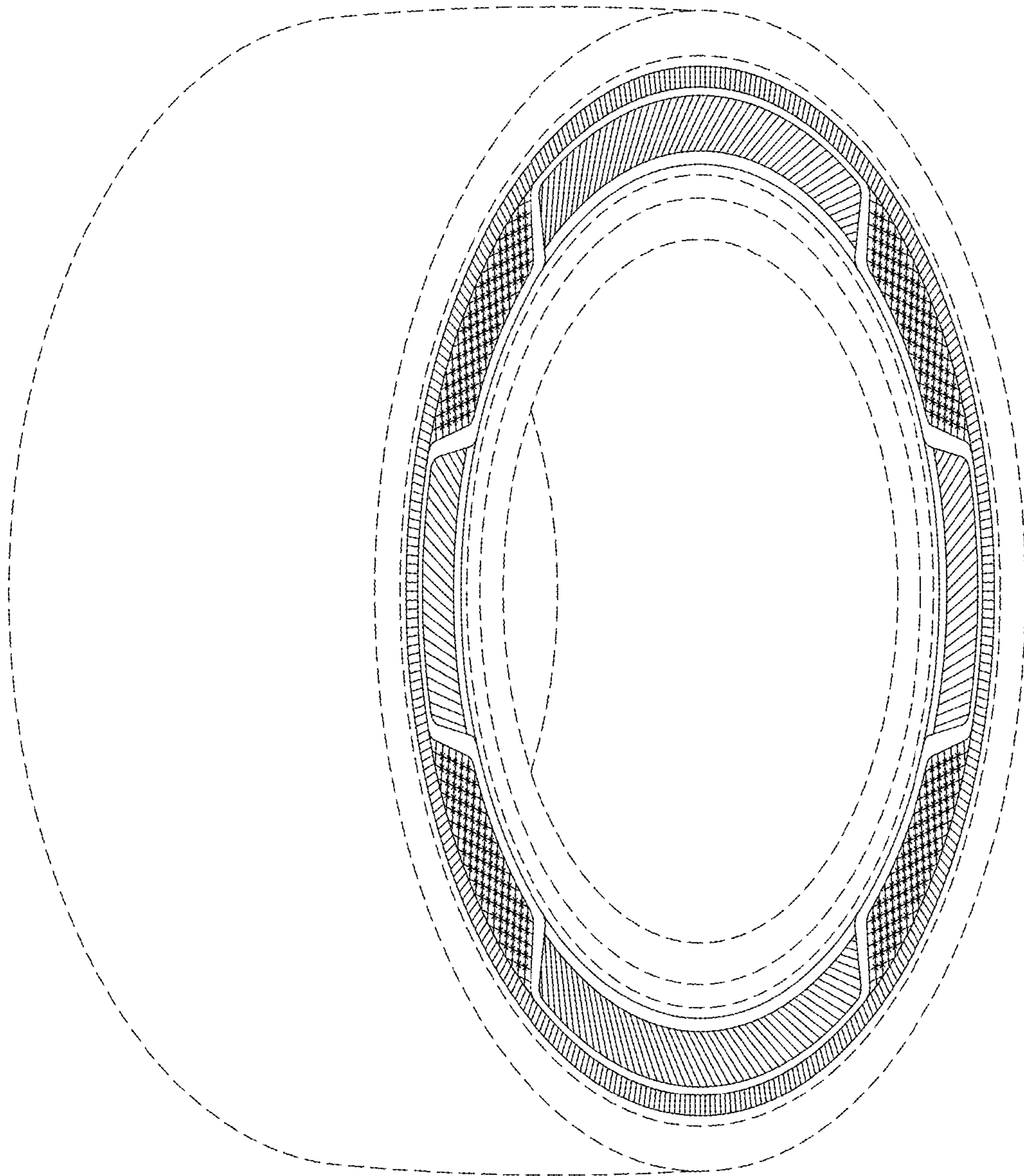

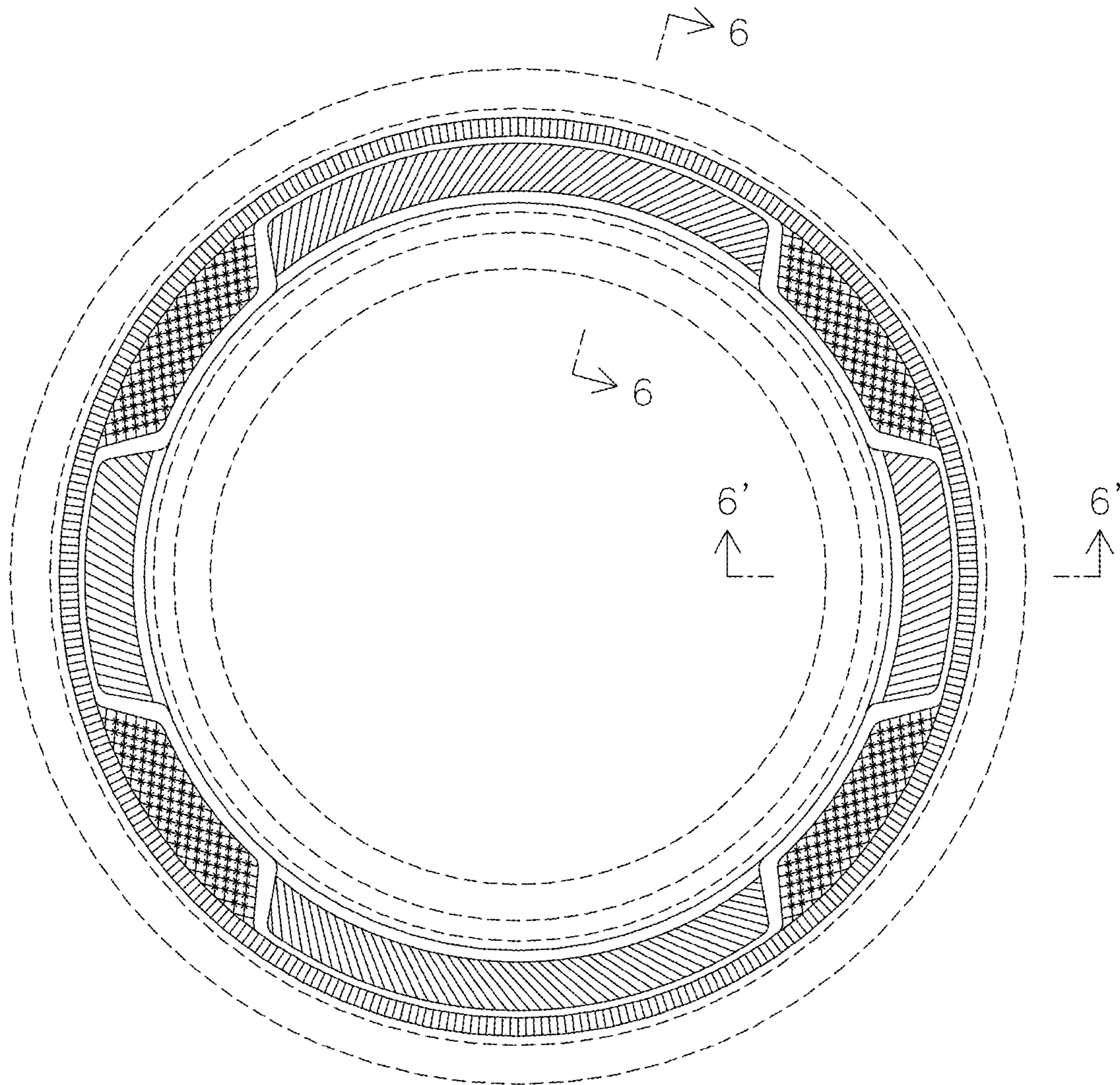

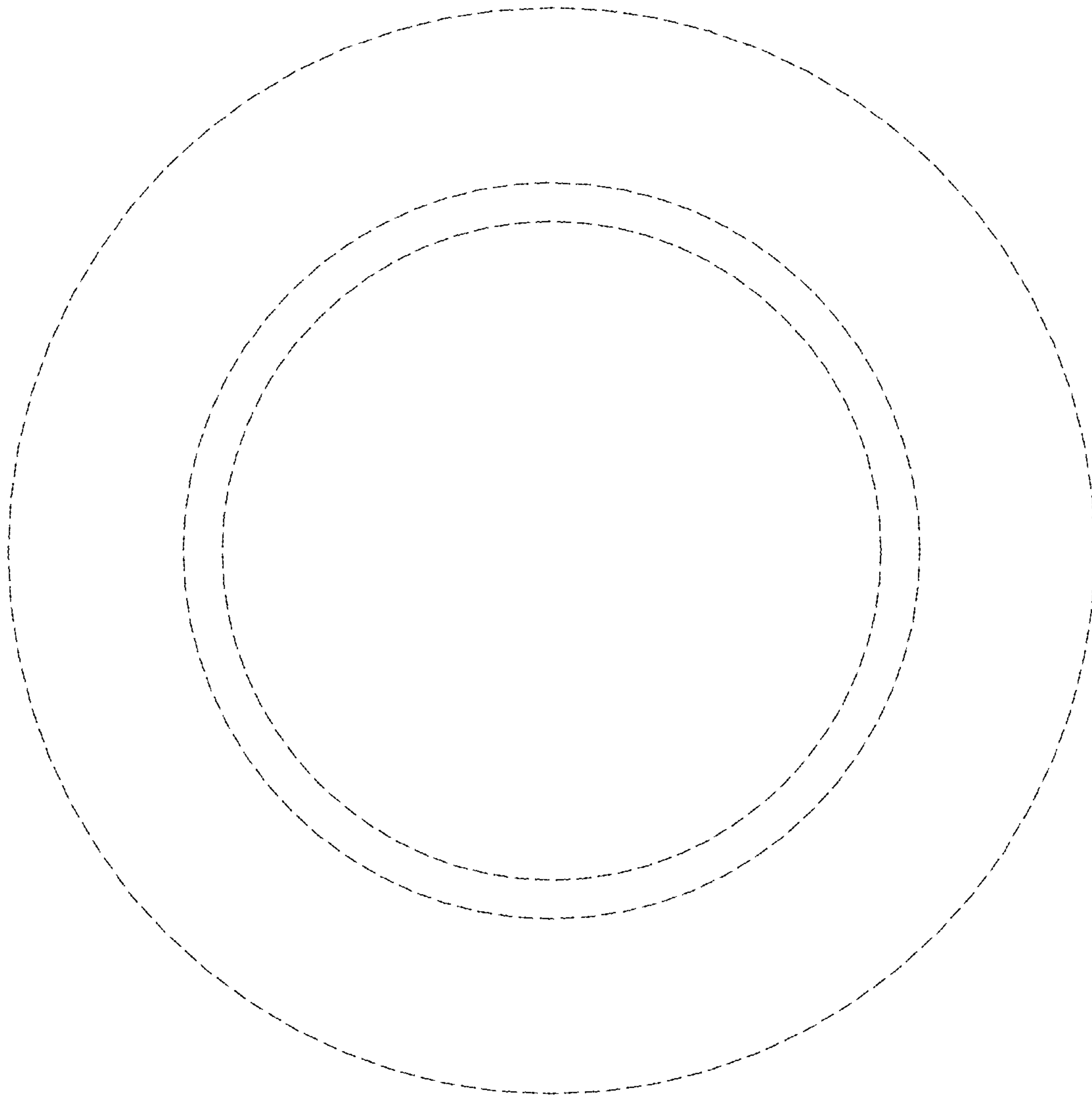

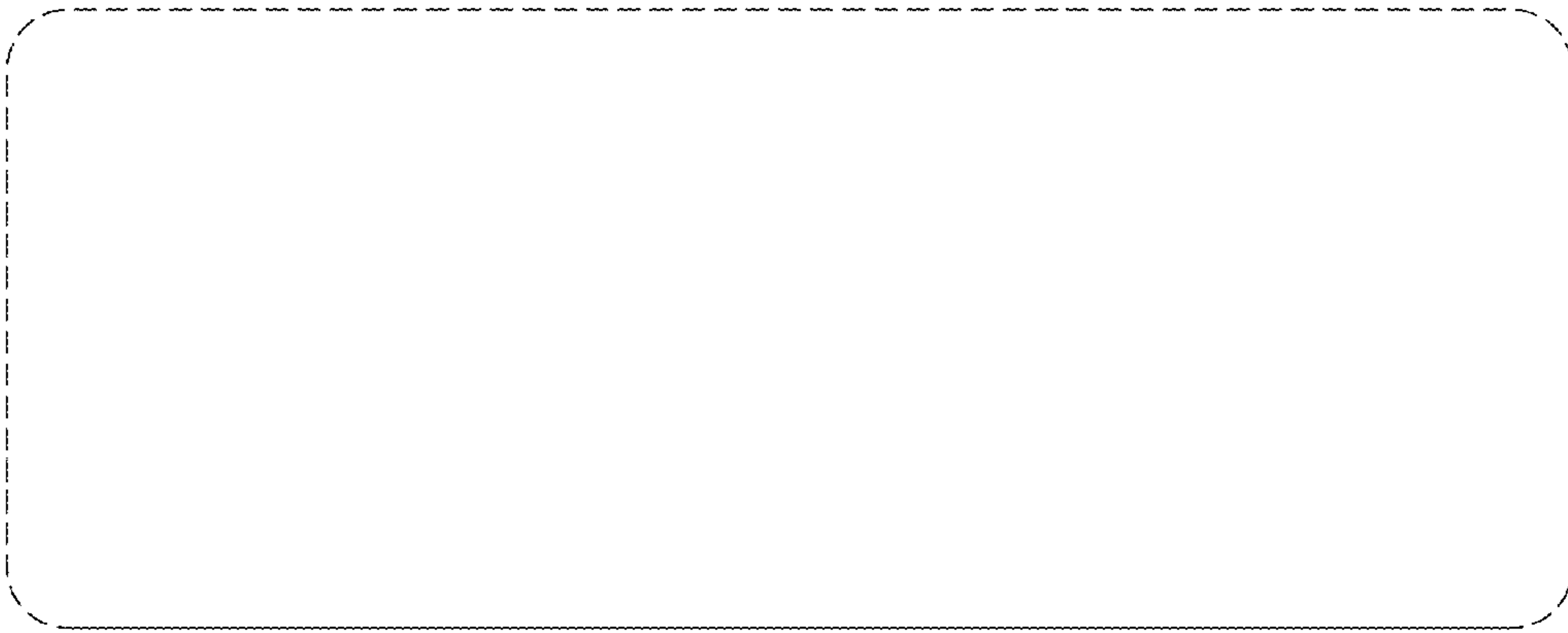

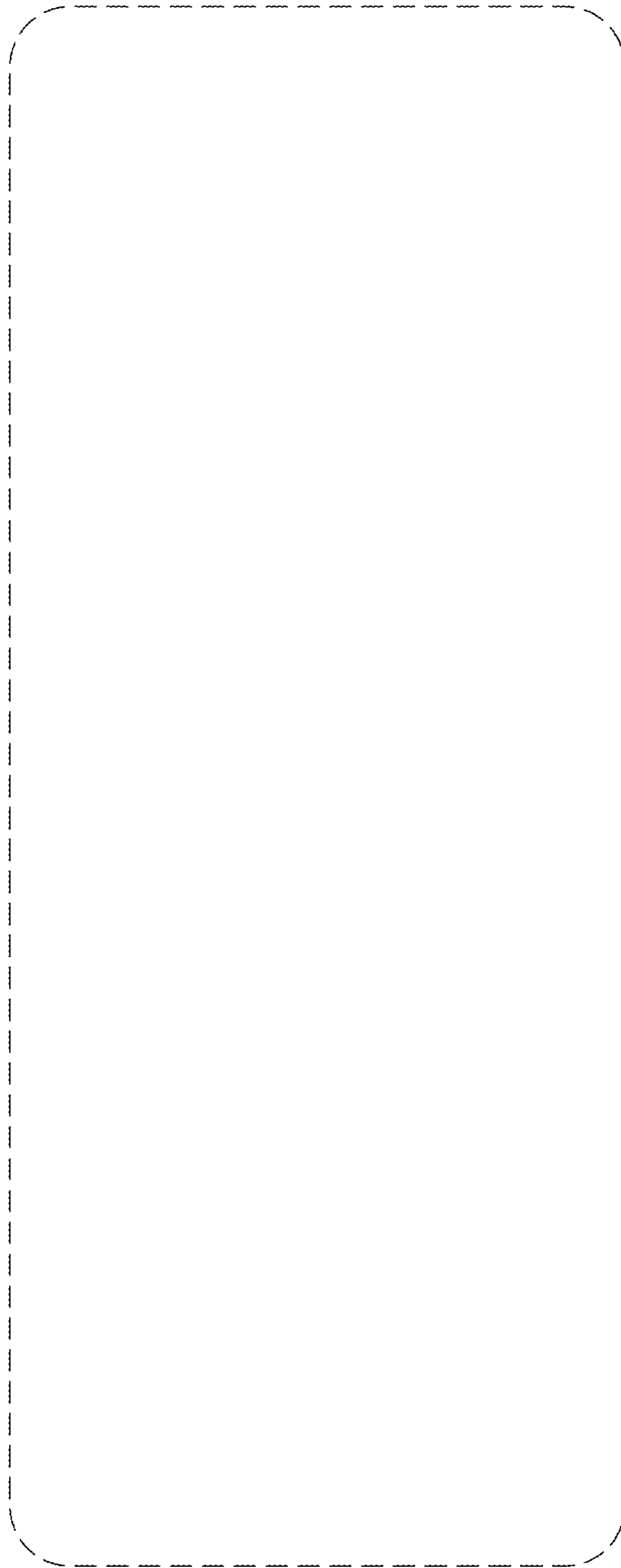

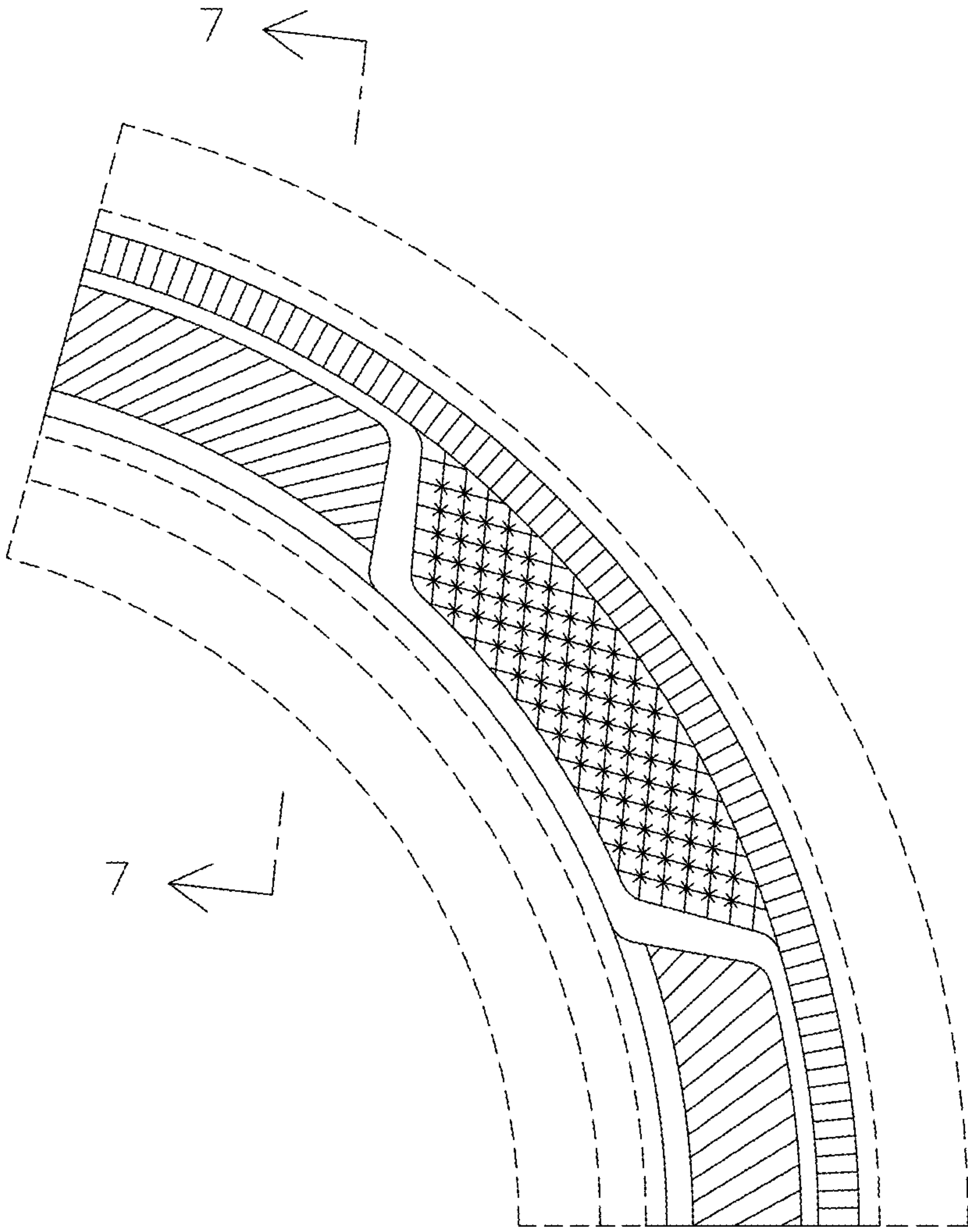

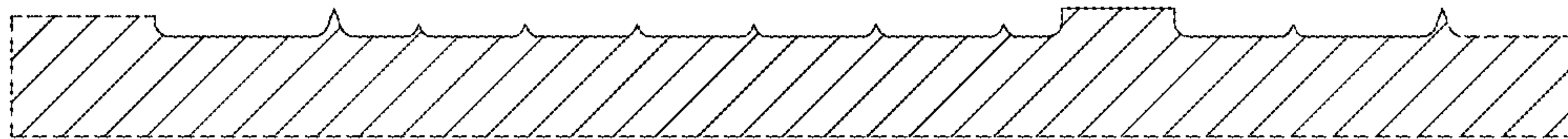

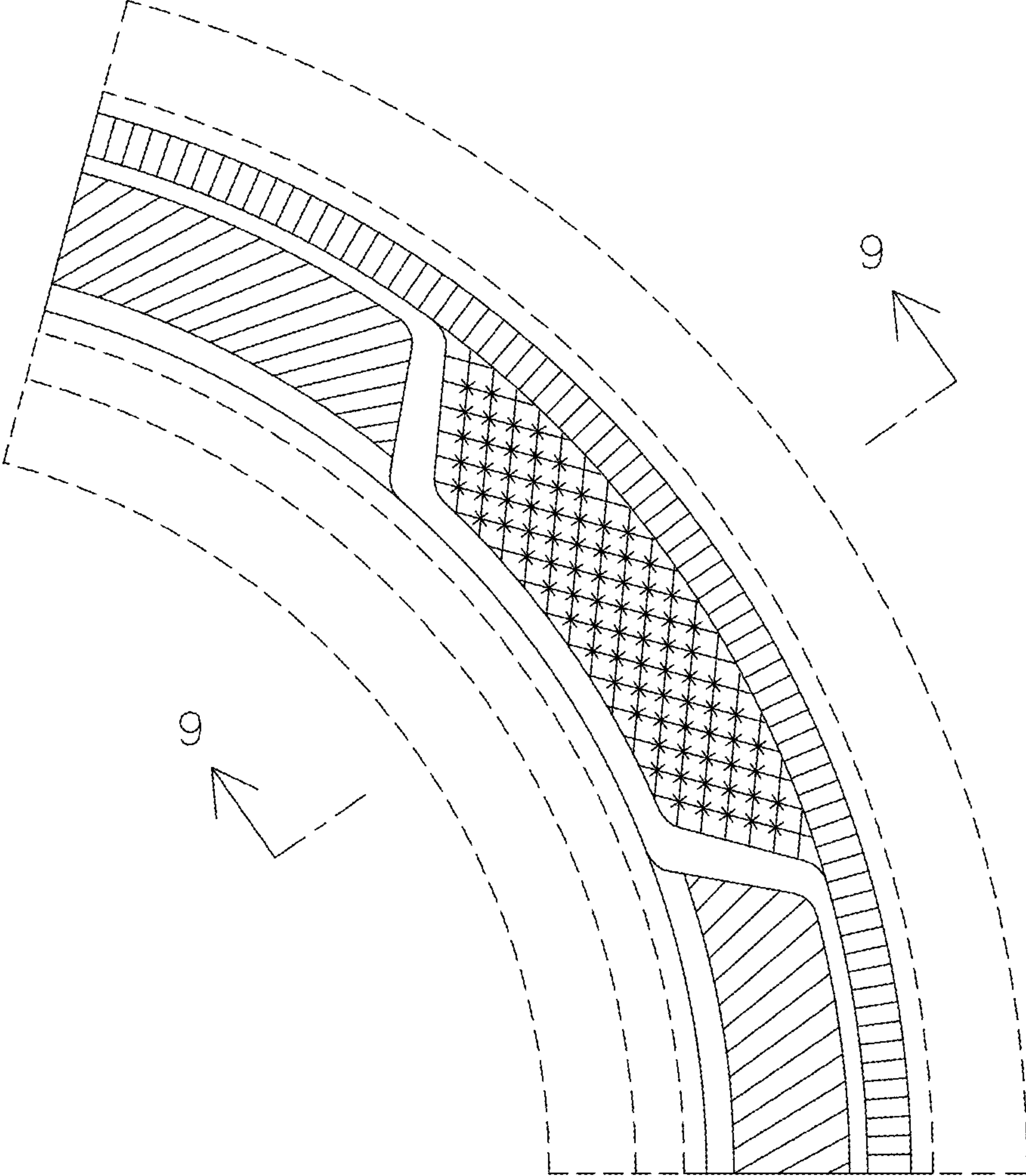

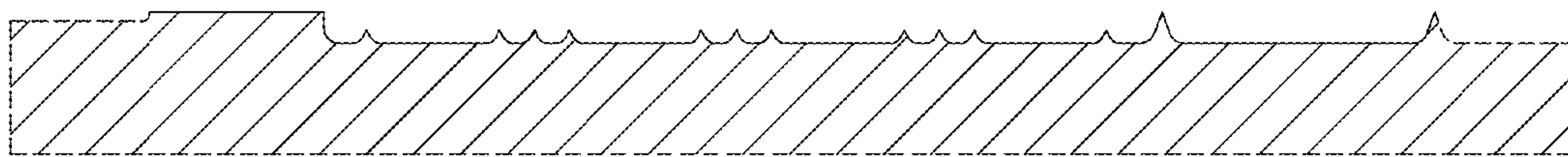
