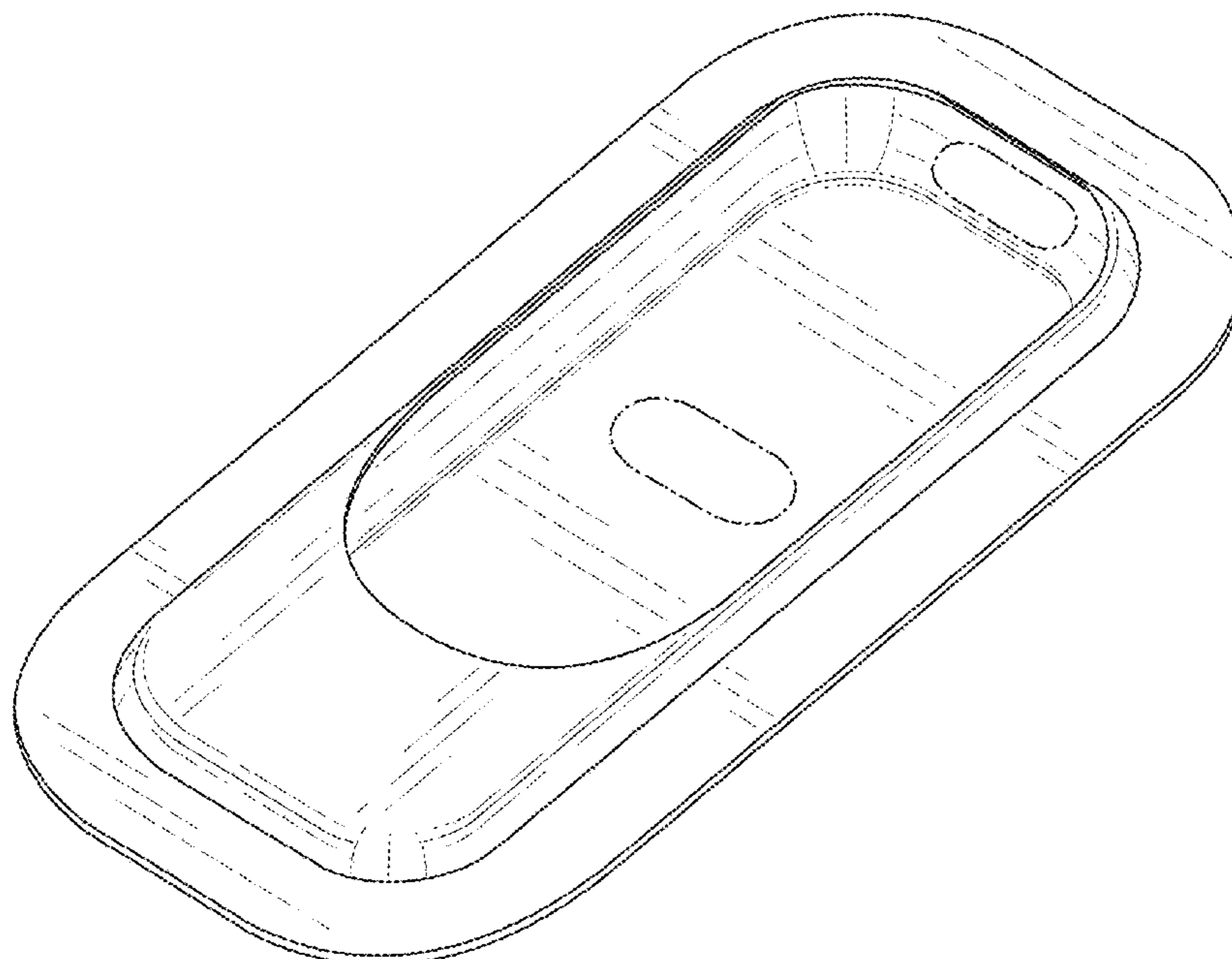
(57) **CLAIM**

The ornamental design for a housing for a biometric storage device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of housing for a biometric storage device showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof;

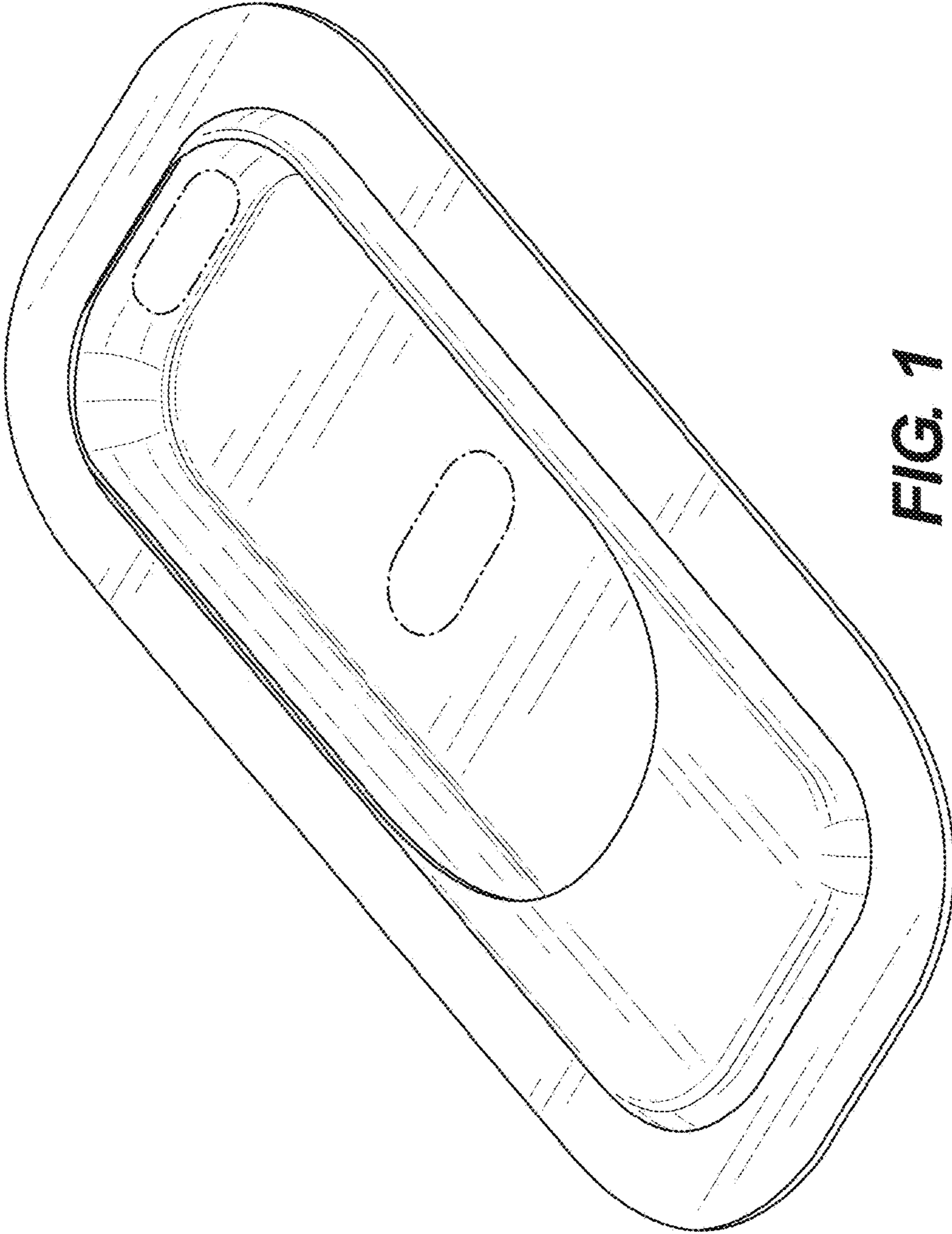

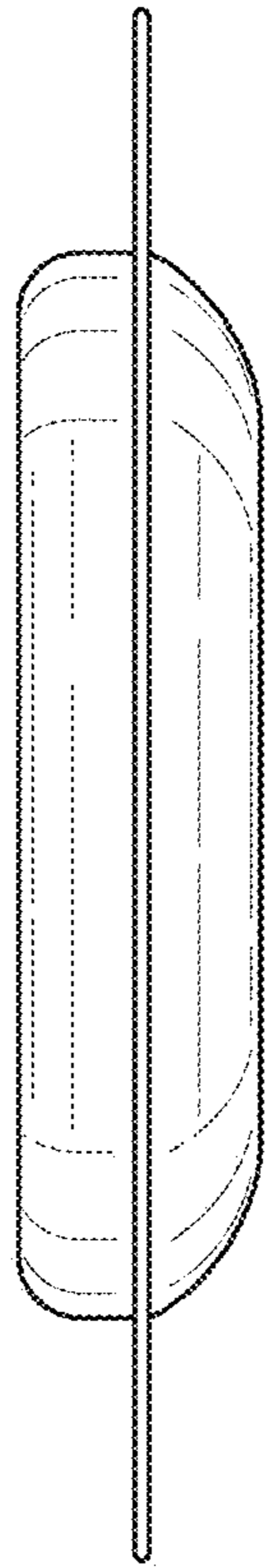

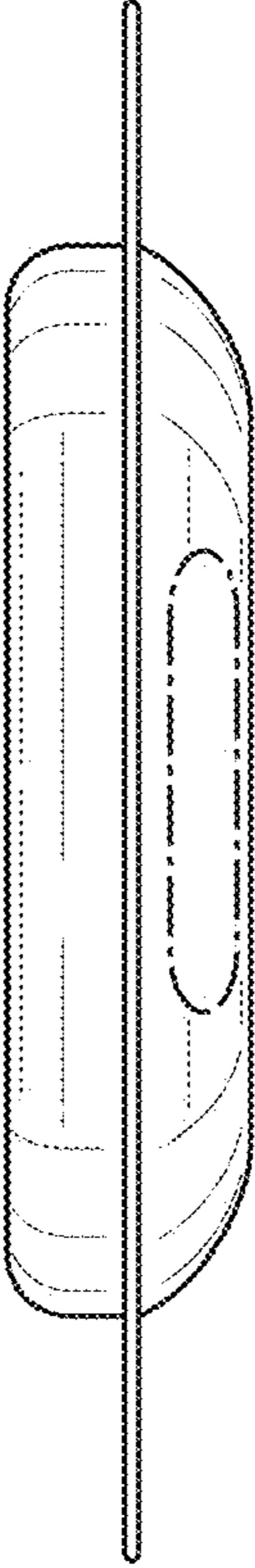

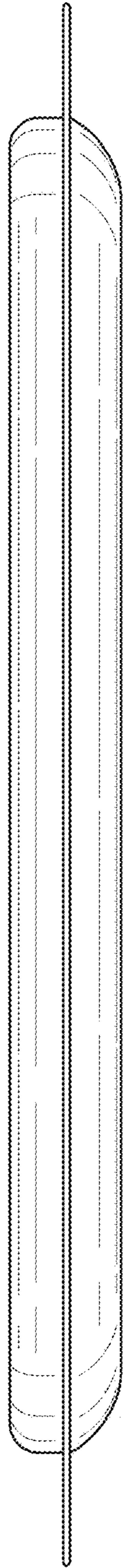

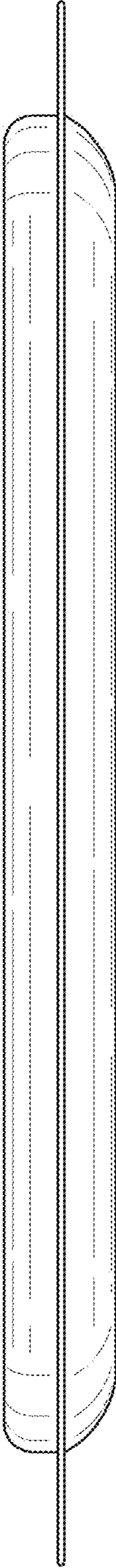

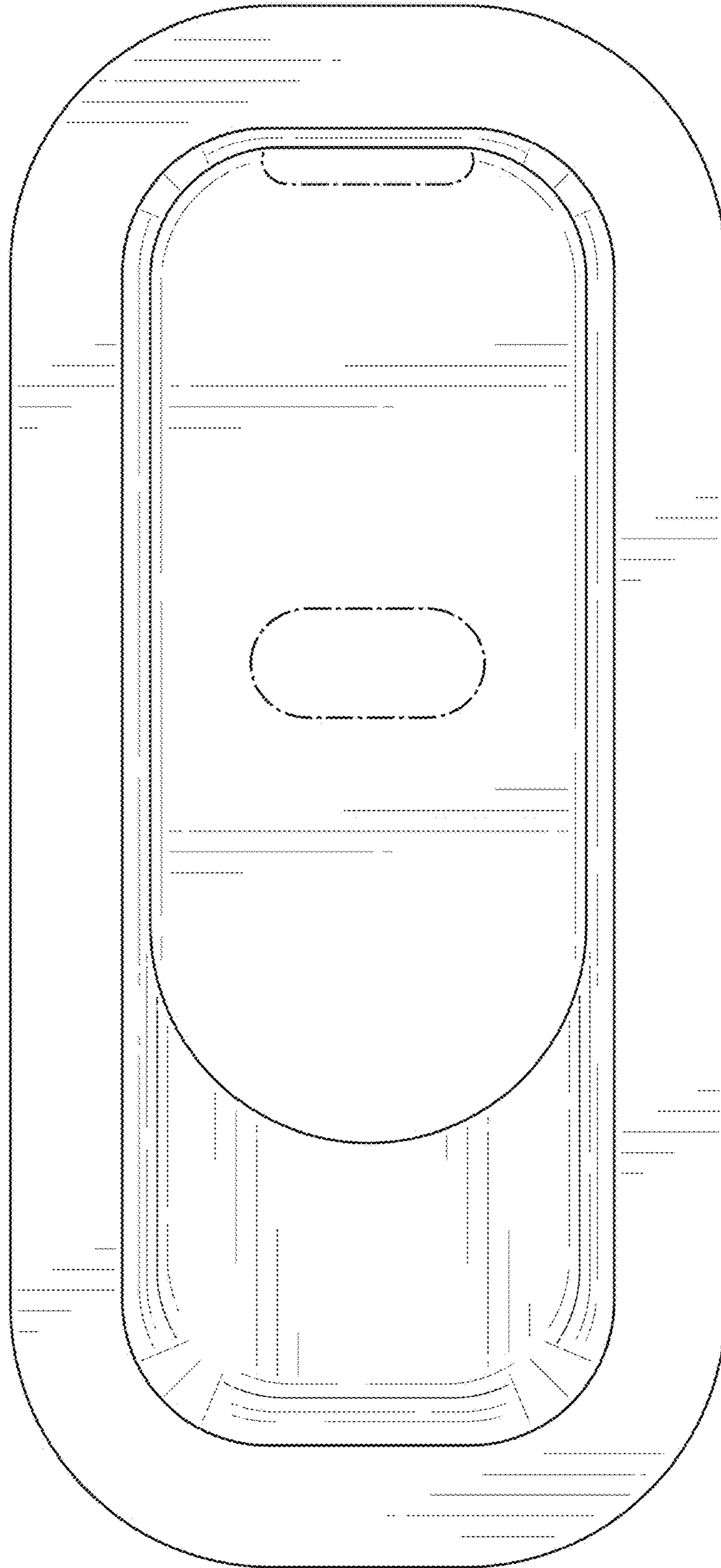

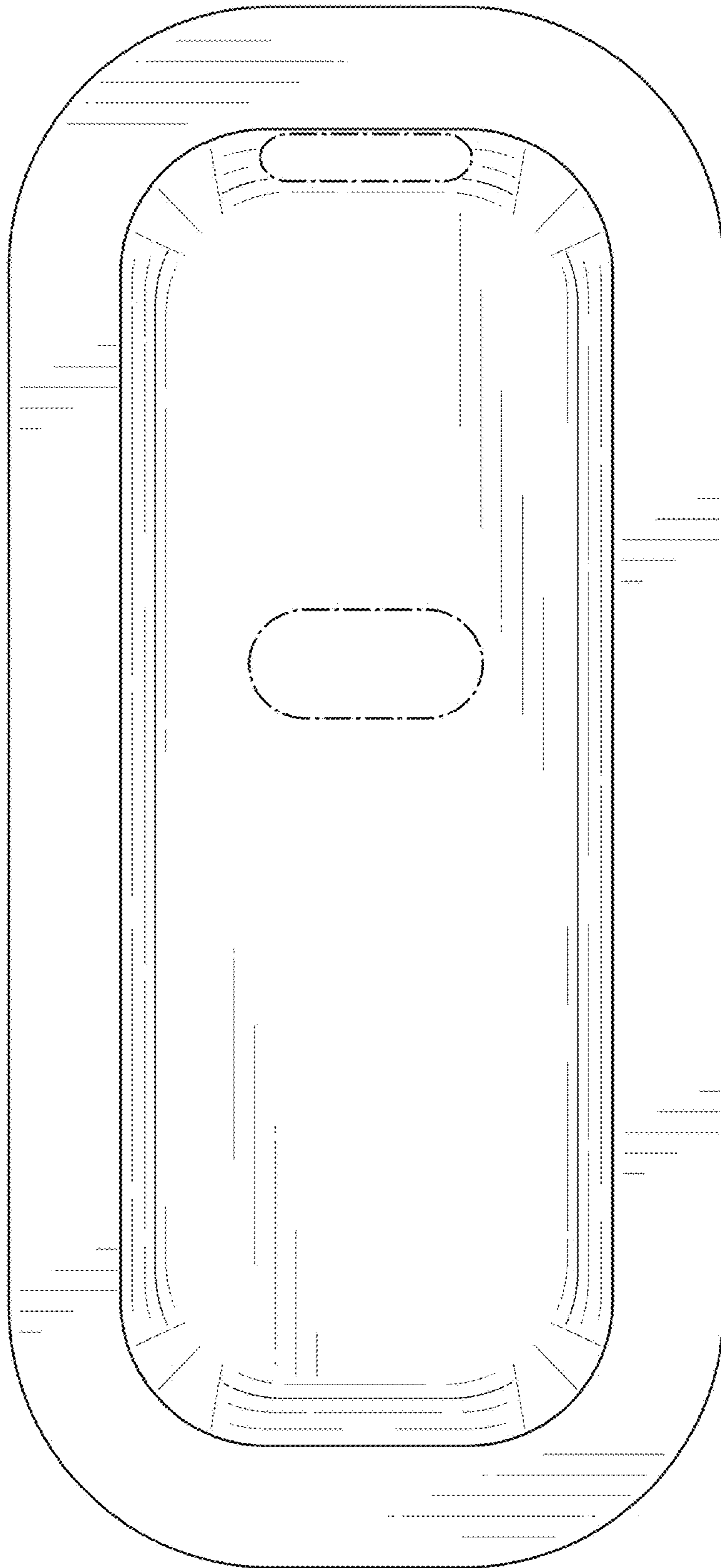

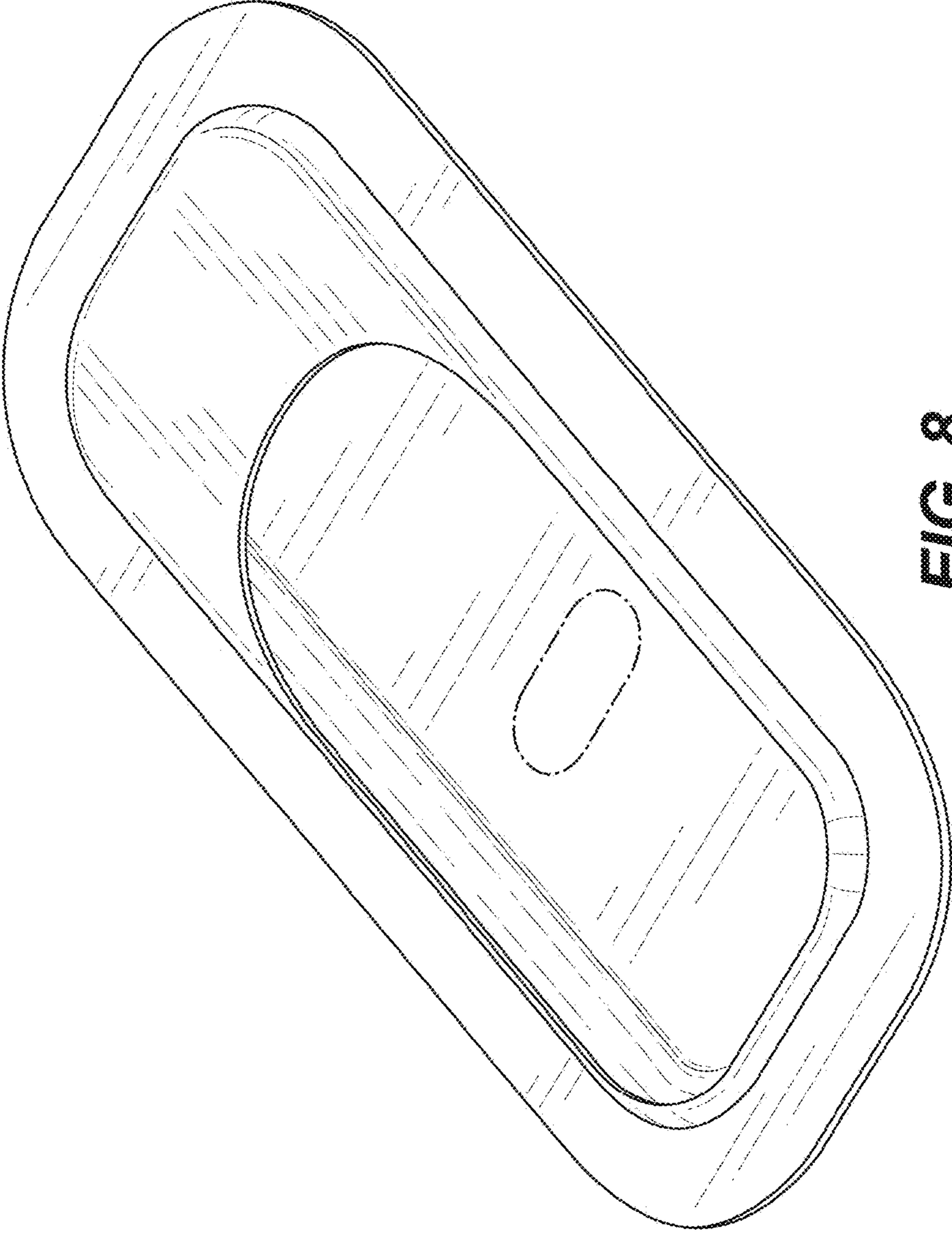
