(57) **CLAIM**

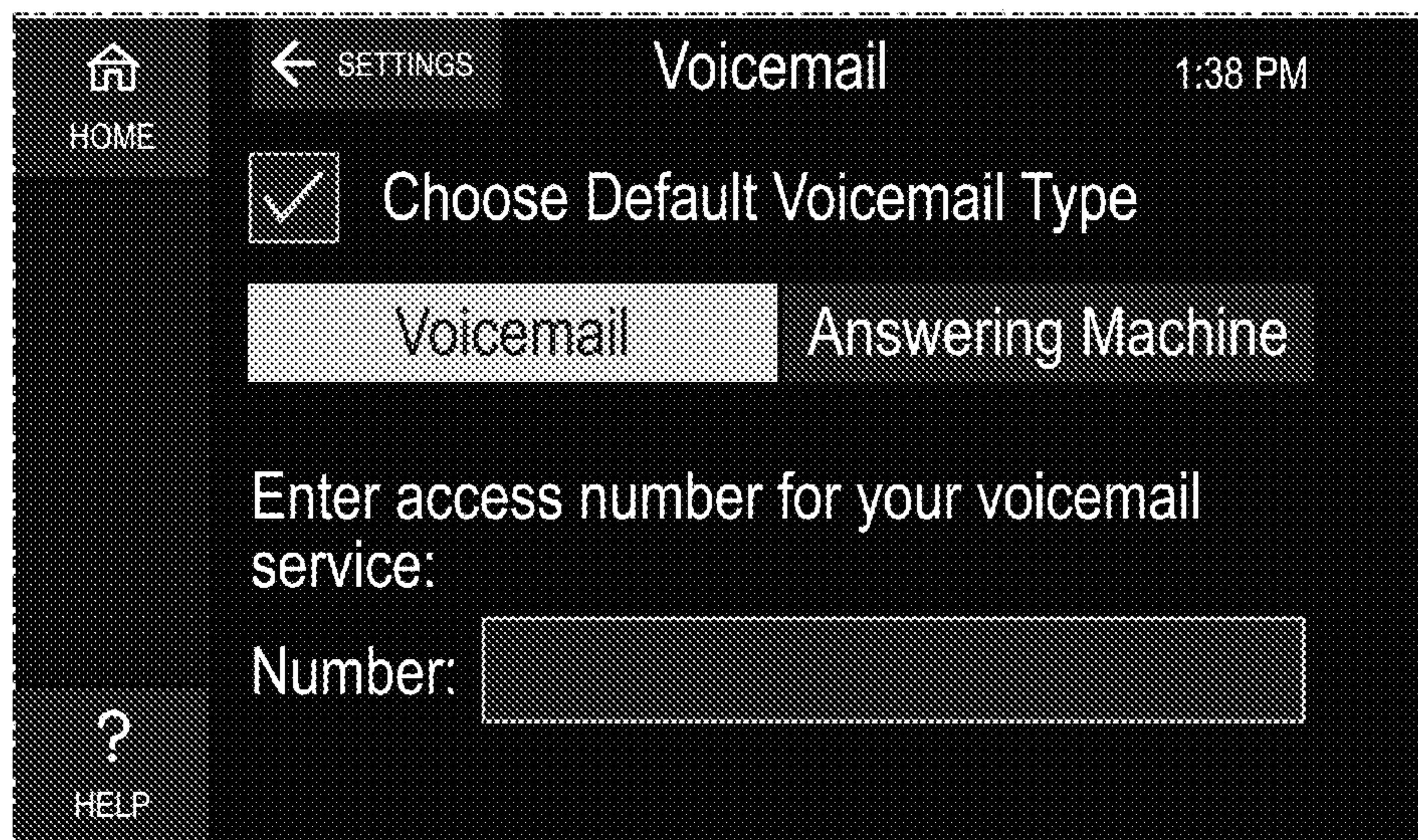
The ornamental design for a display screen of a captioning communication device with graphical user interface, substantially as shown and described.

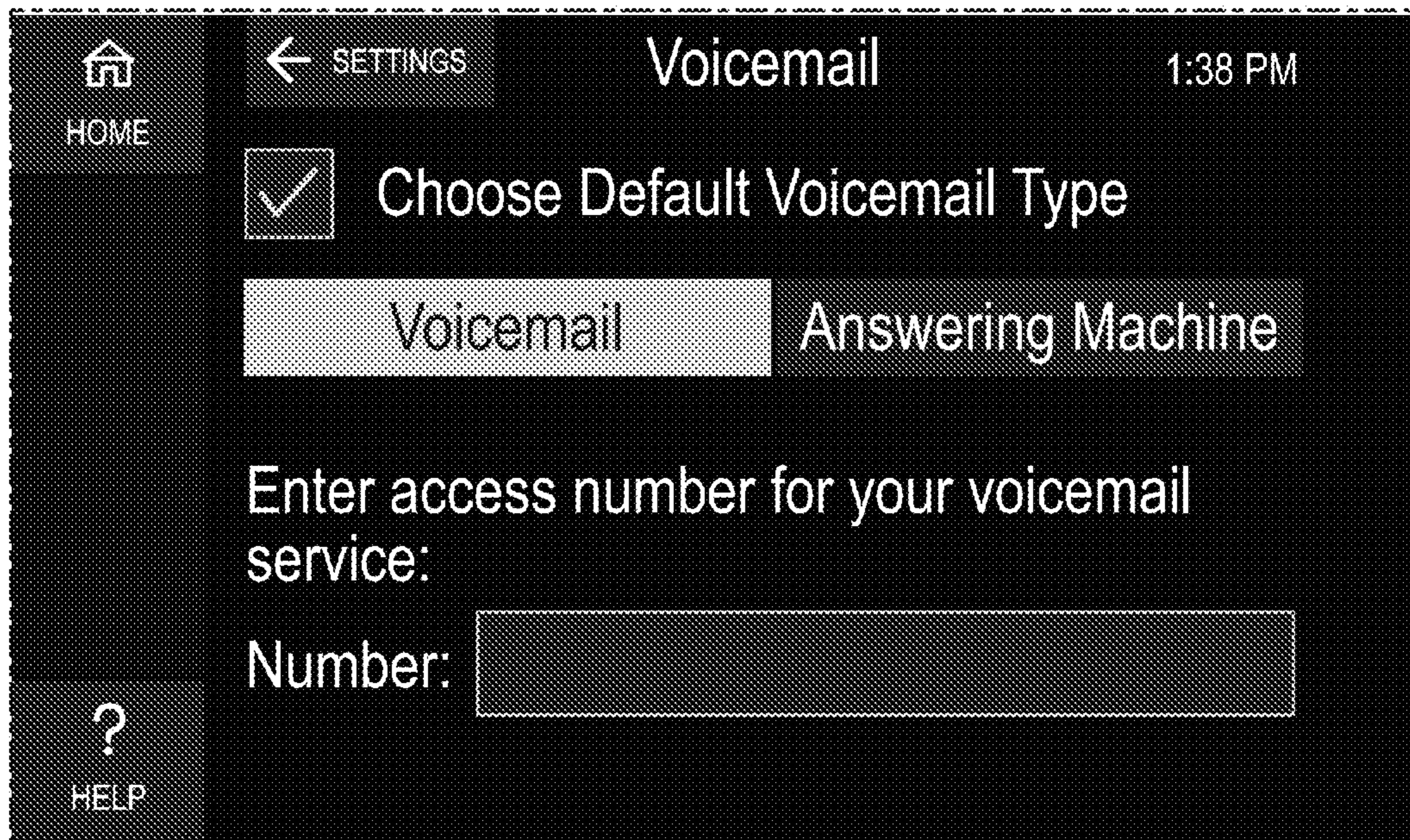

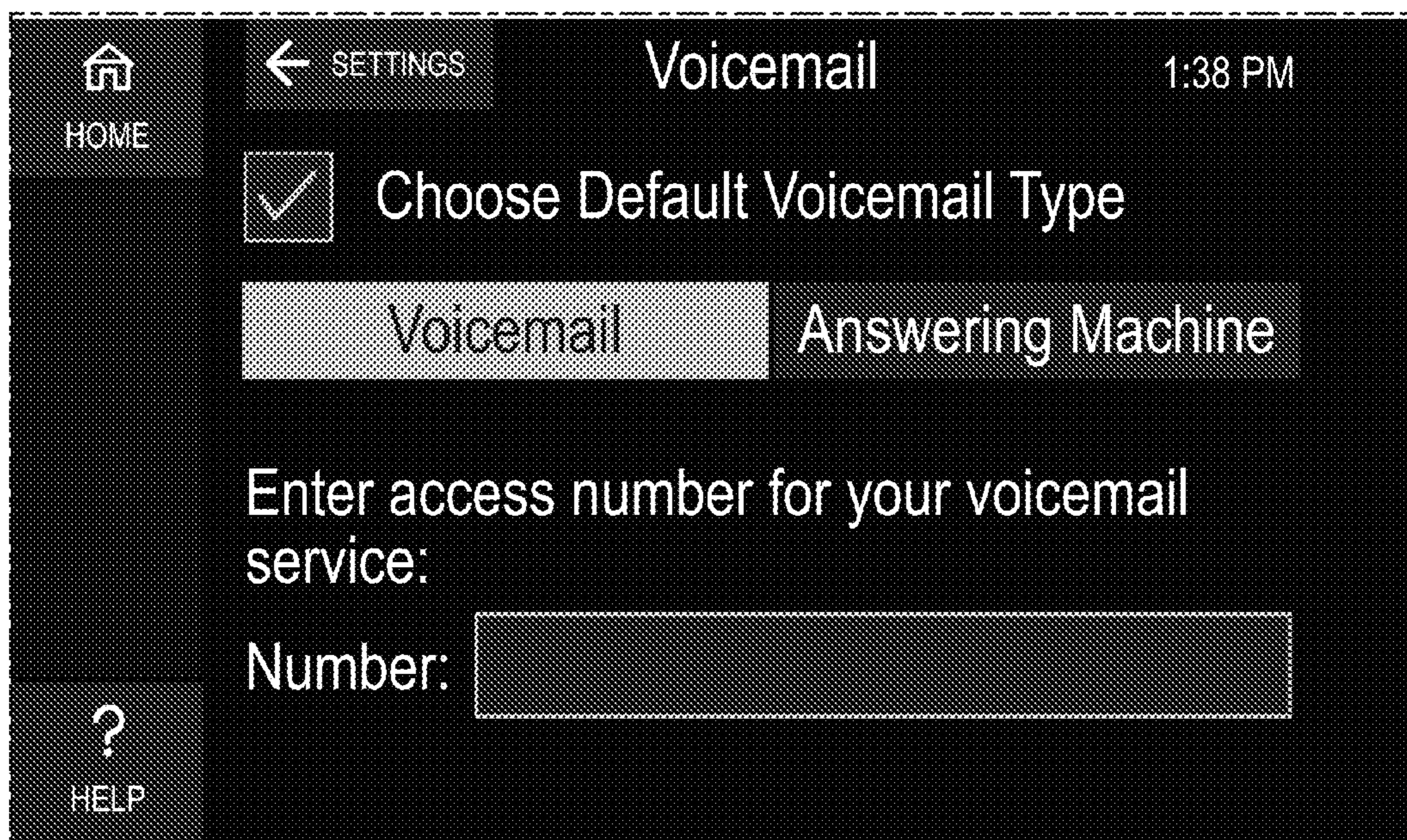
