(57) **CLAIM**

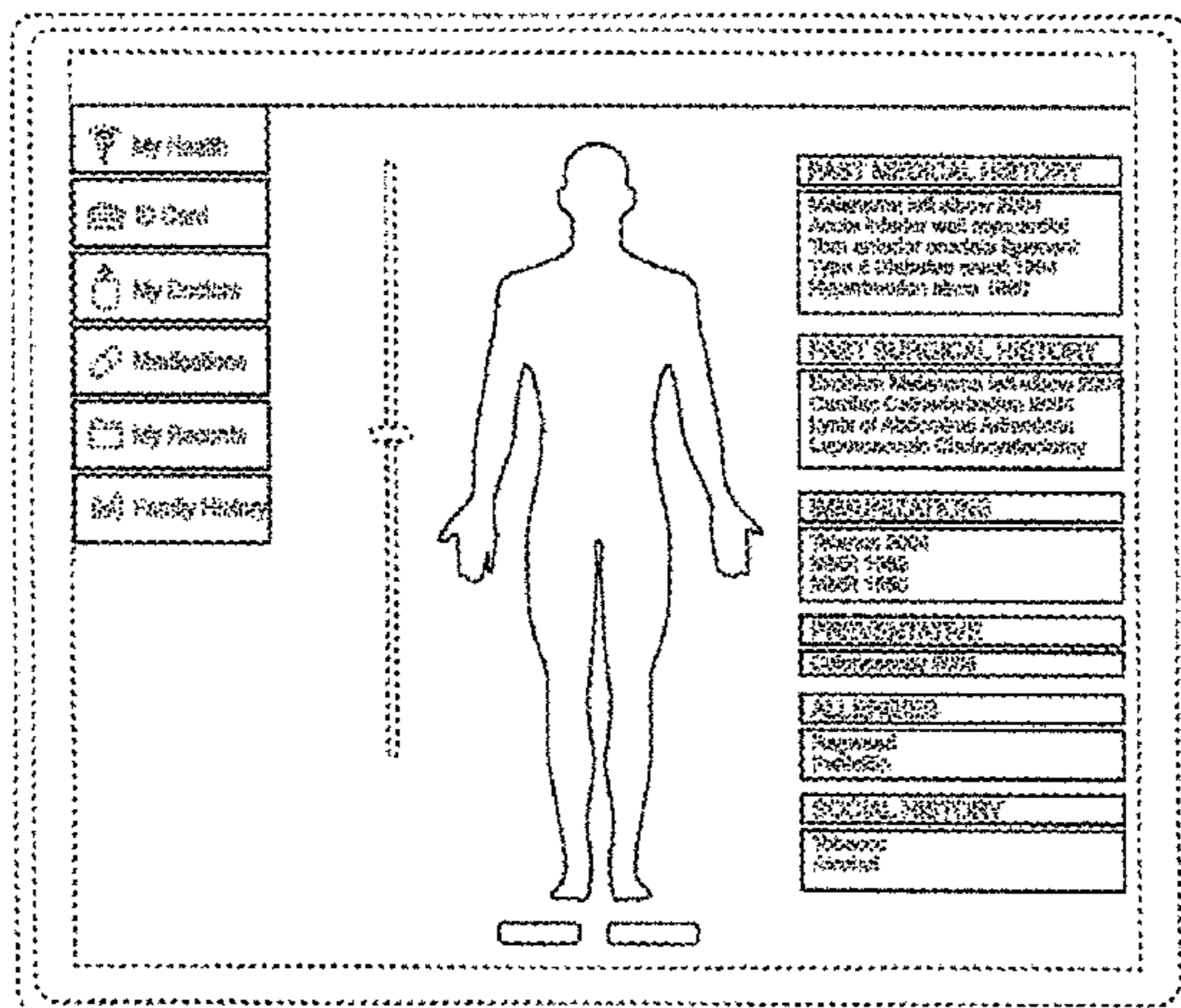
I claim the ornamental design for a display panel of a programmed computer system with a graphical user interface, as shown and described.
