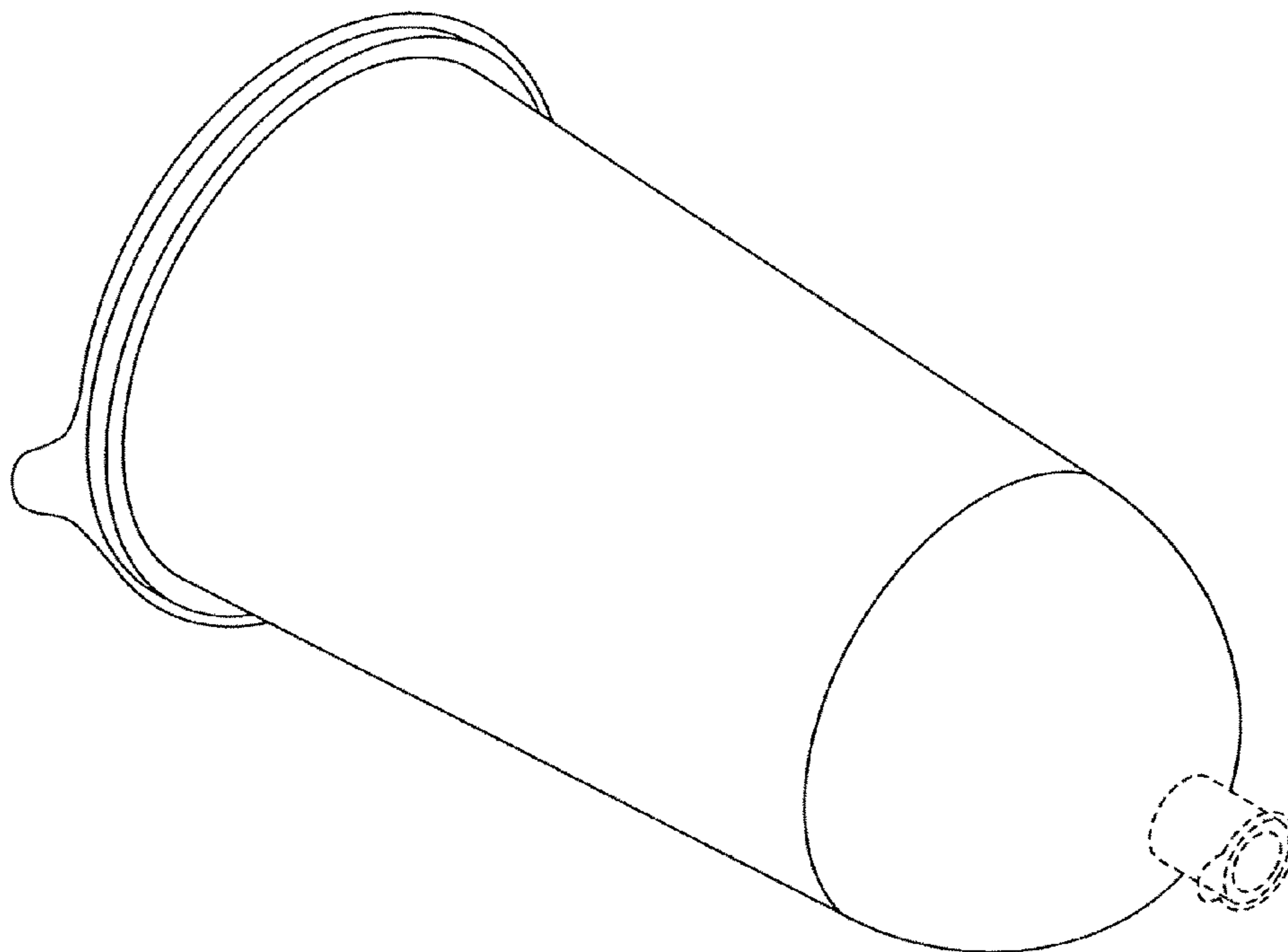
(57) **CLAIM**

The ornamental design for a disposable cartridge for a dialysis machine, as shown and described.

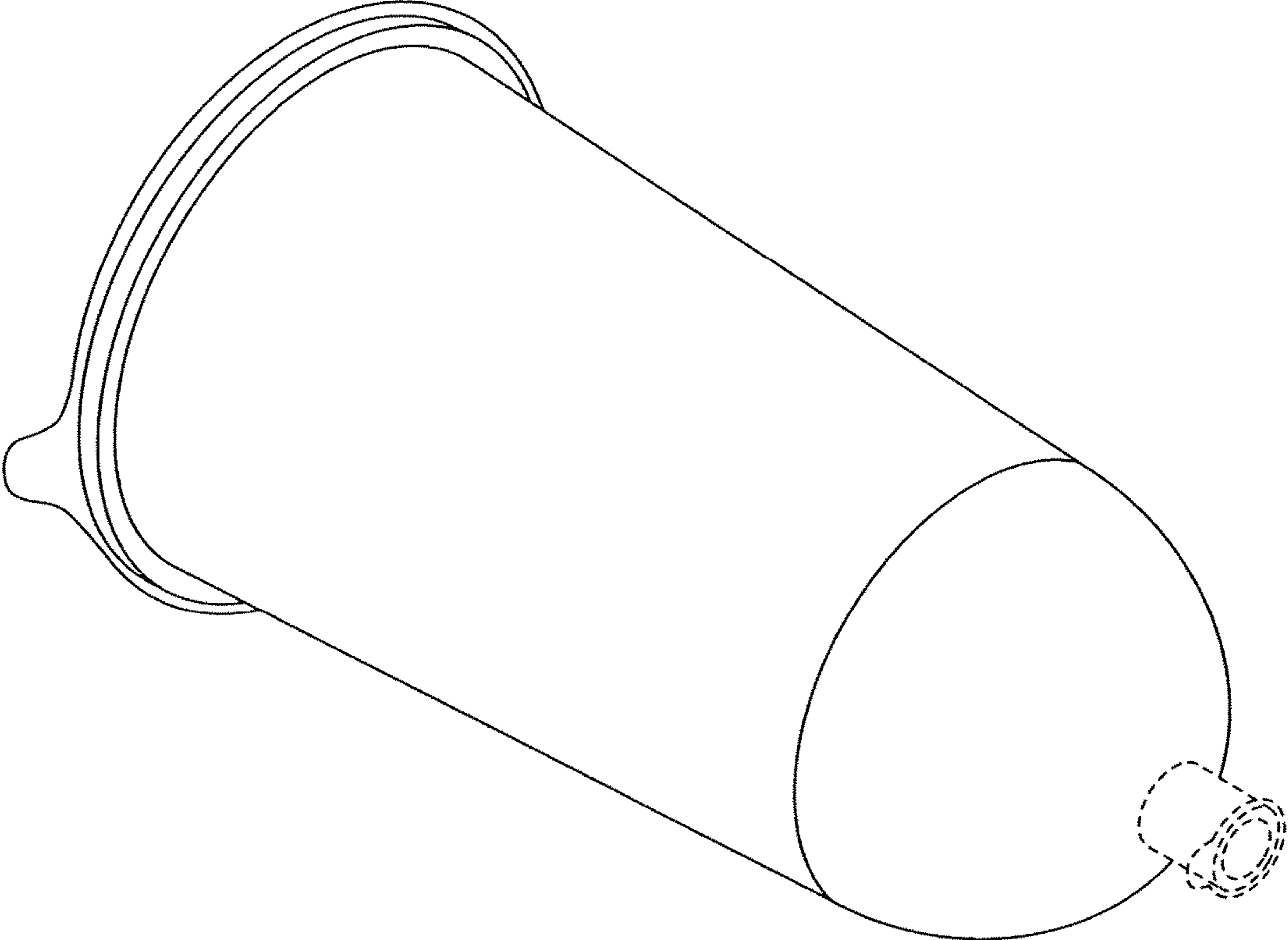
**DESCRIPTION**

FIG. 1.1 is a perspective view of a disposable cartridge for a dialysis machine showing my new design; FIG. 1.2 is a side elevation view thereof; FIG. 1.3 is a bottom plan view thereof; and FIG. 1.4 is a top plan view thereof. 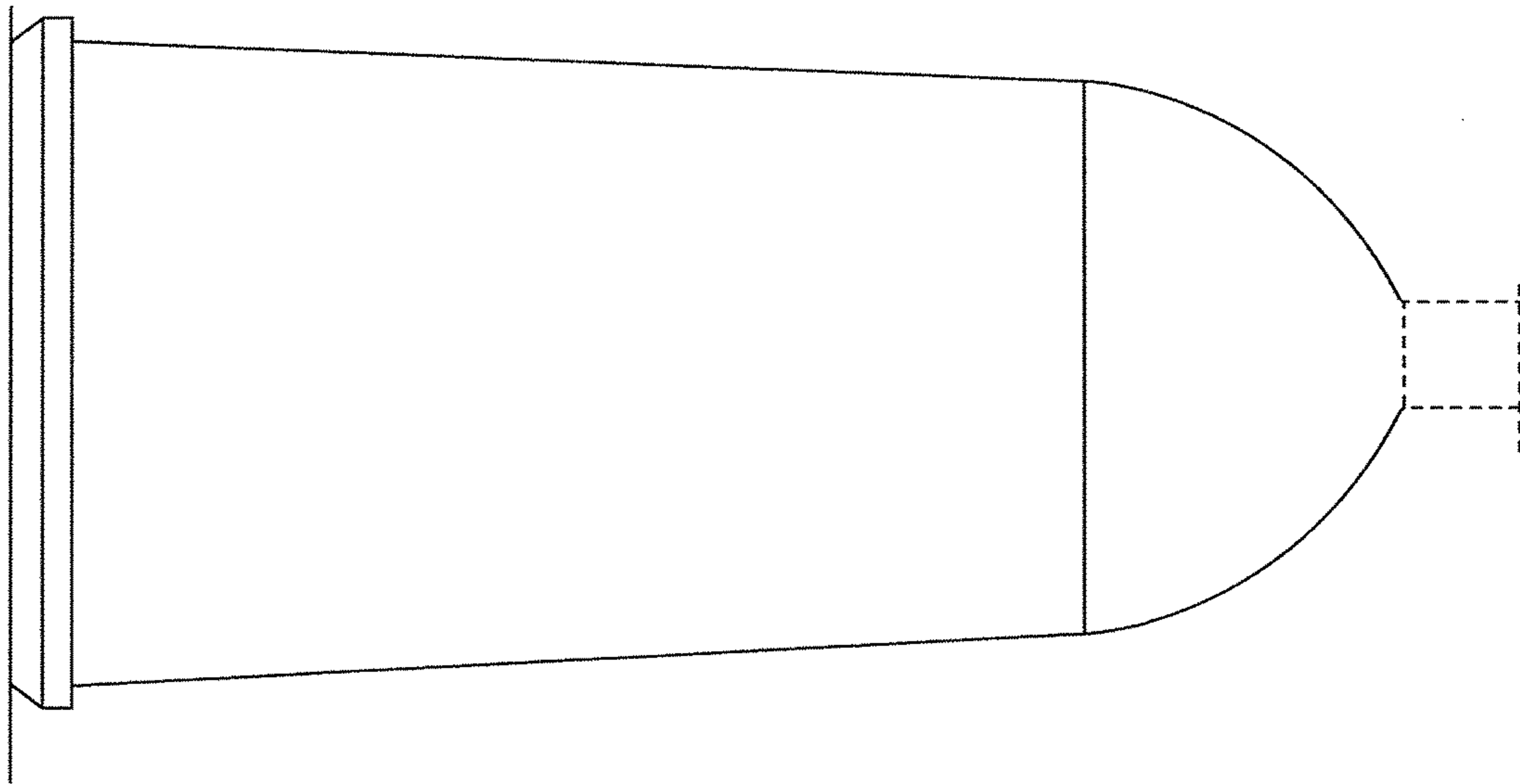

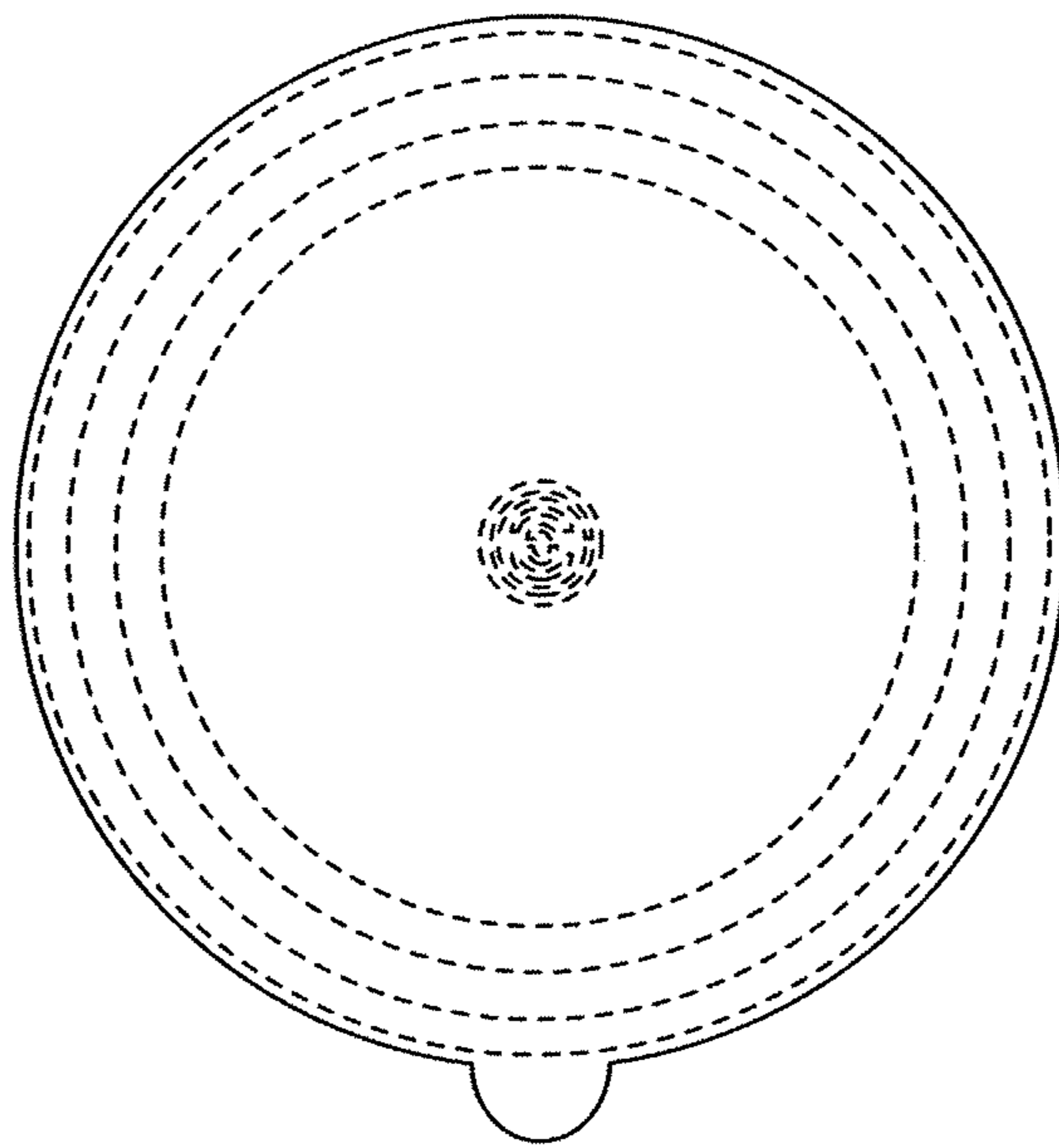
