(57) **CLAIM**

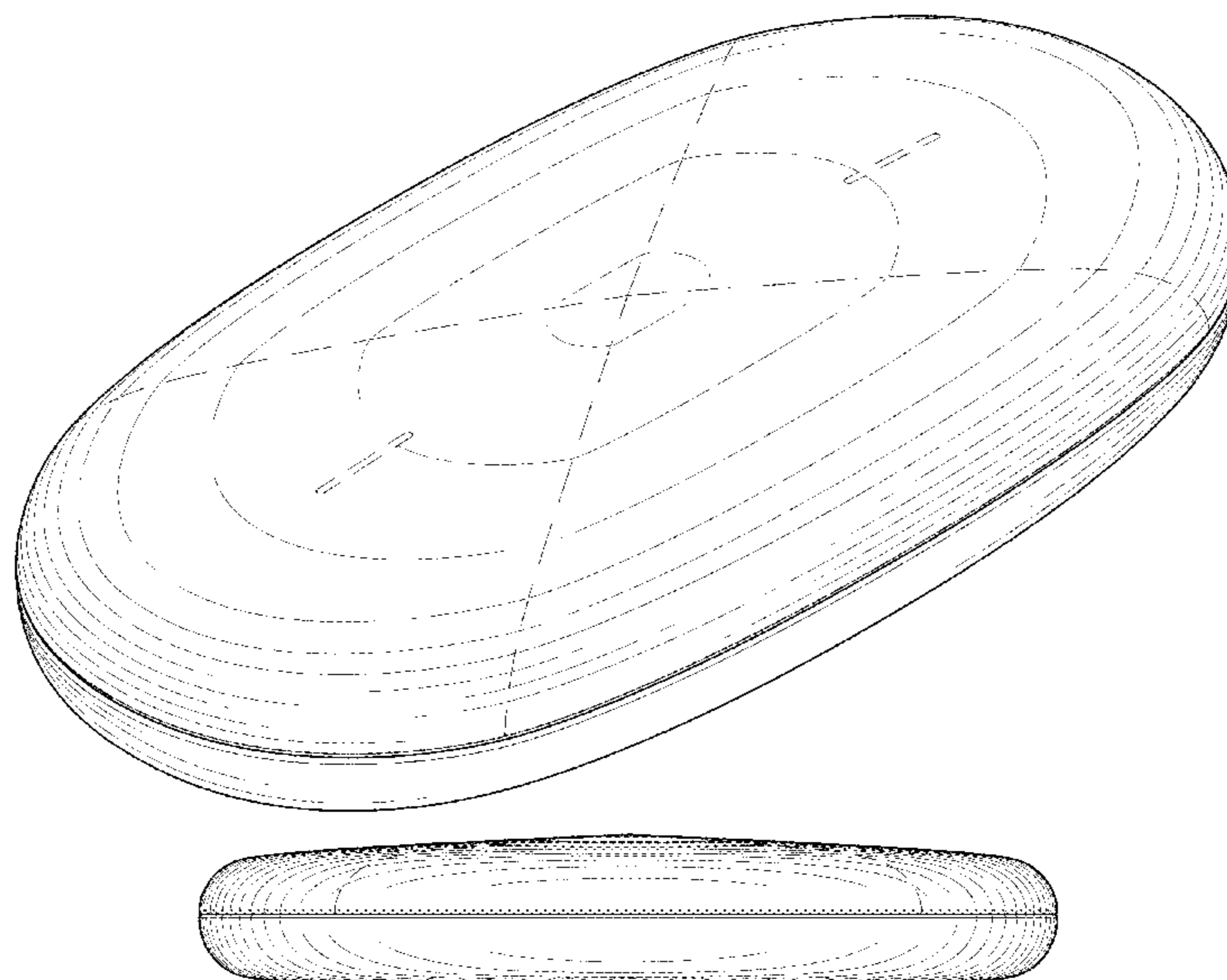
We claim the ornamental design for an electronic module, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top view of an electronic module showing my new design.
 FIG. 2 is a perspective bottom view thereof.
 FIG. 3 is a top view thereof.
 FIG. 4 is a bottom view thereof.
 FIG. 5 is a front elevational view thereof, the rear being a mirror image; and,
 FIG. 6 is a left side elevational view thereof, the right being a mirror image.
 The line shadings in the figures are included for the purpose of illustrating contour and are not intended to be illustrative of texture or gloss. None of the broken lines form a part of the claimed design.

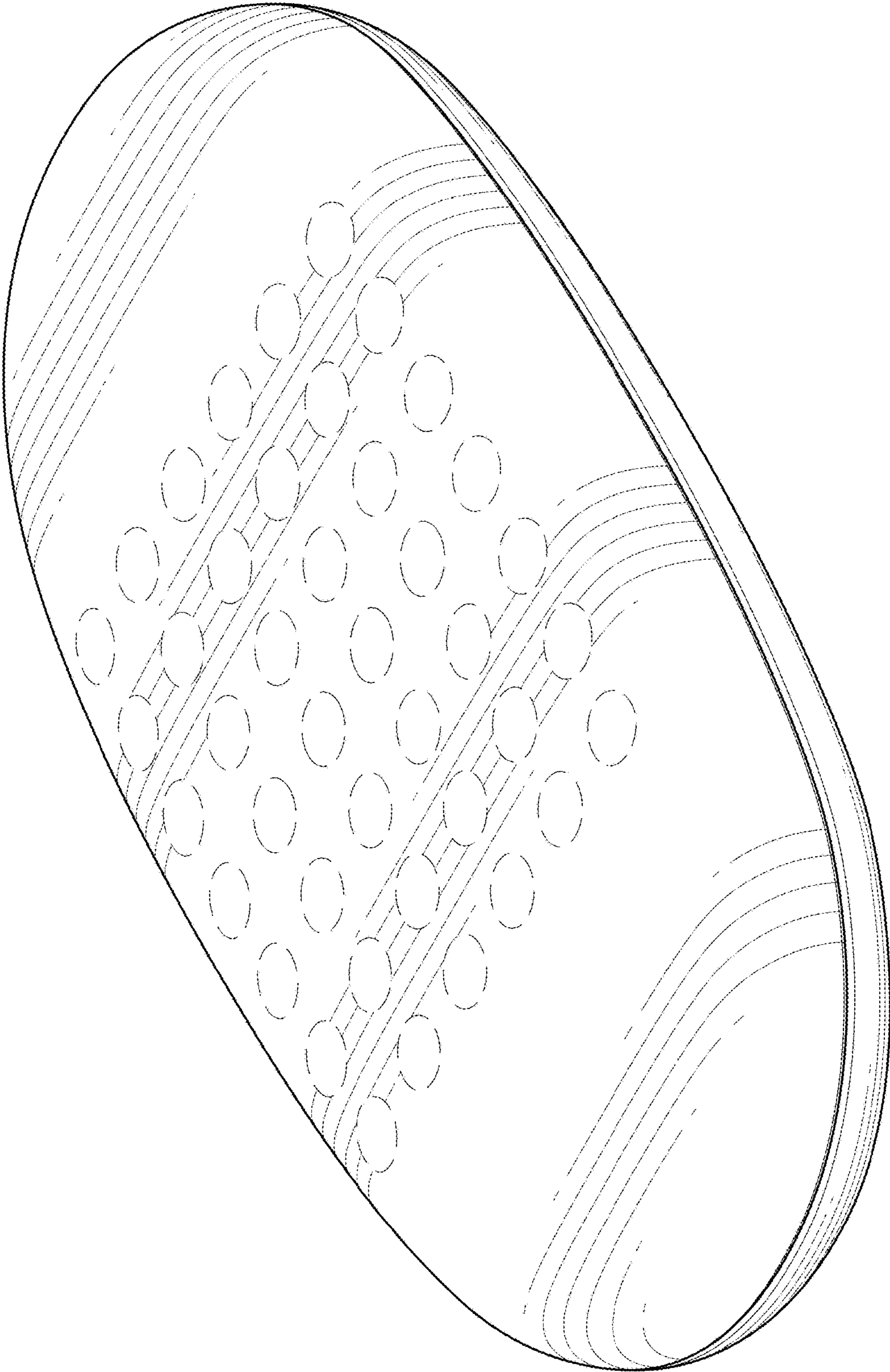

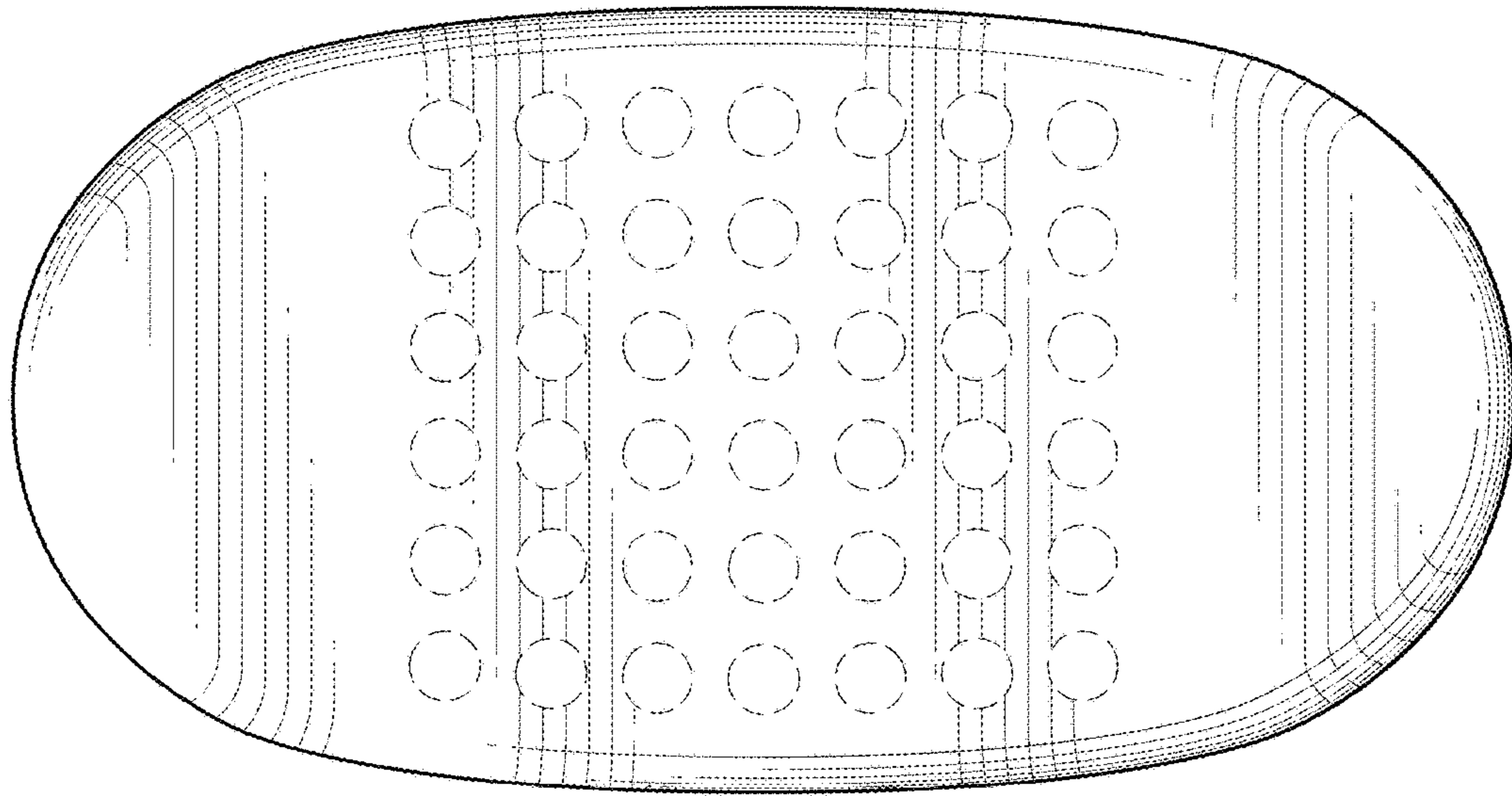

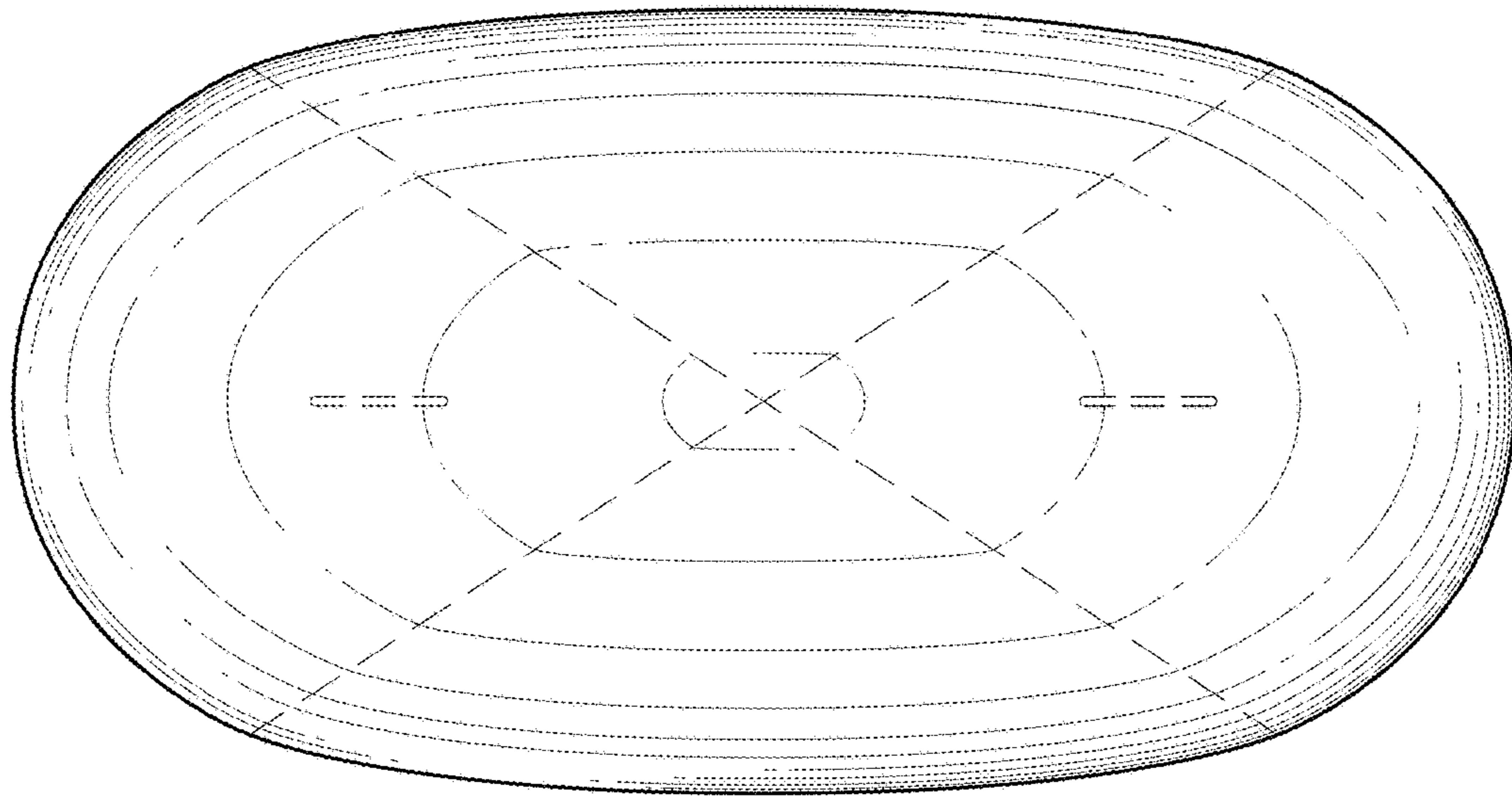

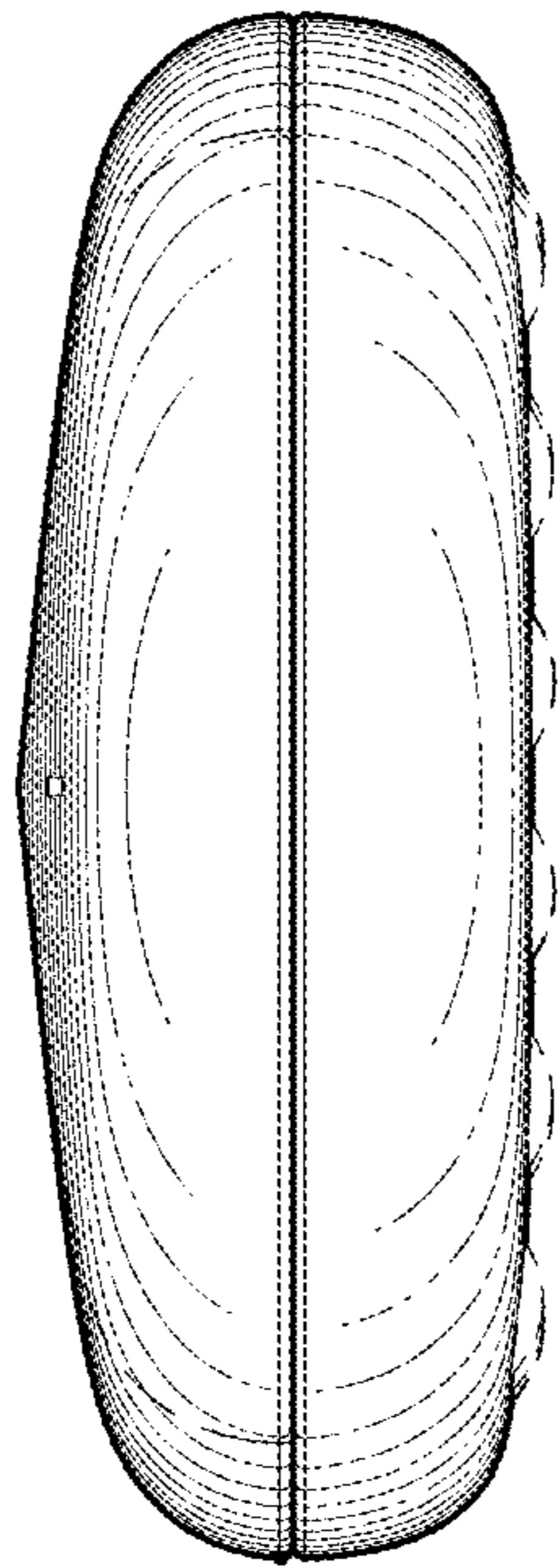

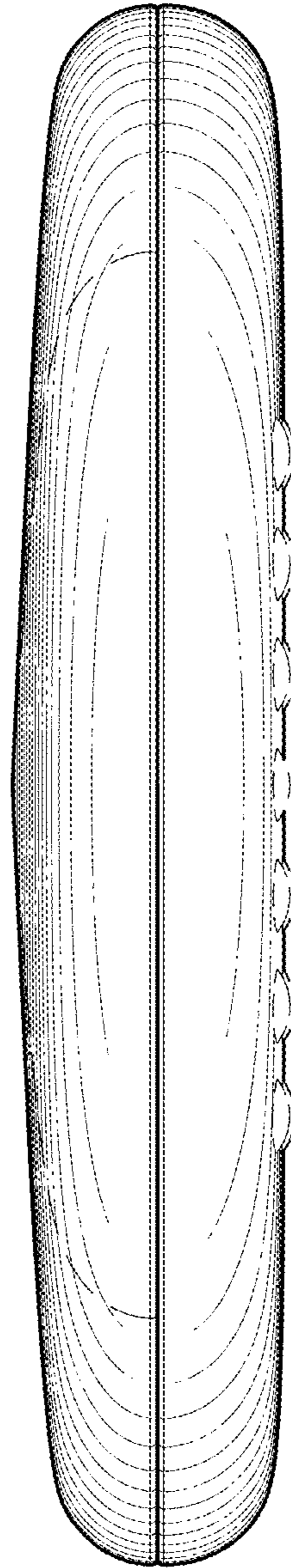
