(57) **CLAIM**

The ornamental design for a decorative cushion massage device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective back view of a decorative cushion massage device showing the new design.

FIG. 2 is a top-end view thereof.

FIG. 3 is a front view thereof.

FIG. 4 is a left side view thereof.

FIG. 5 is a right side view thereof.

FIG. 6 is a back view thereof.

FIG. 7 is a bottom-end view thereof.

FIG. 8 is a perspective back view thereof, similar to FIG. 1, but without evenly spaced broken lines.

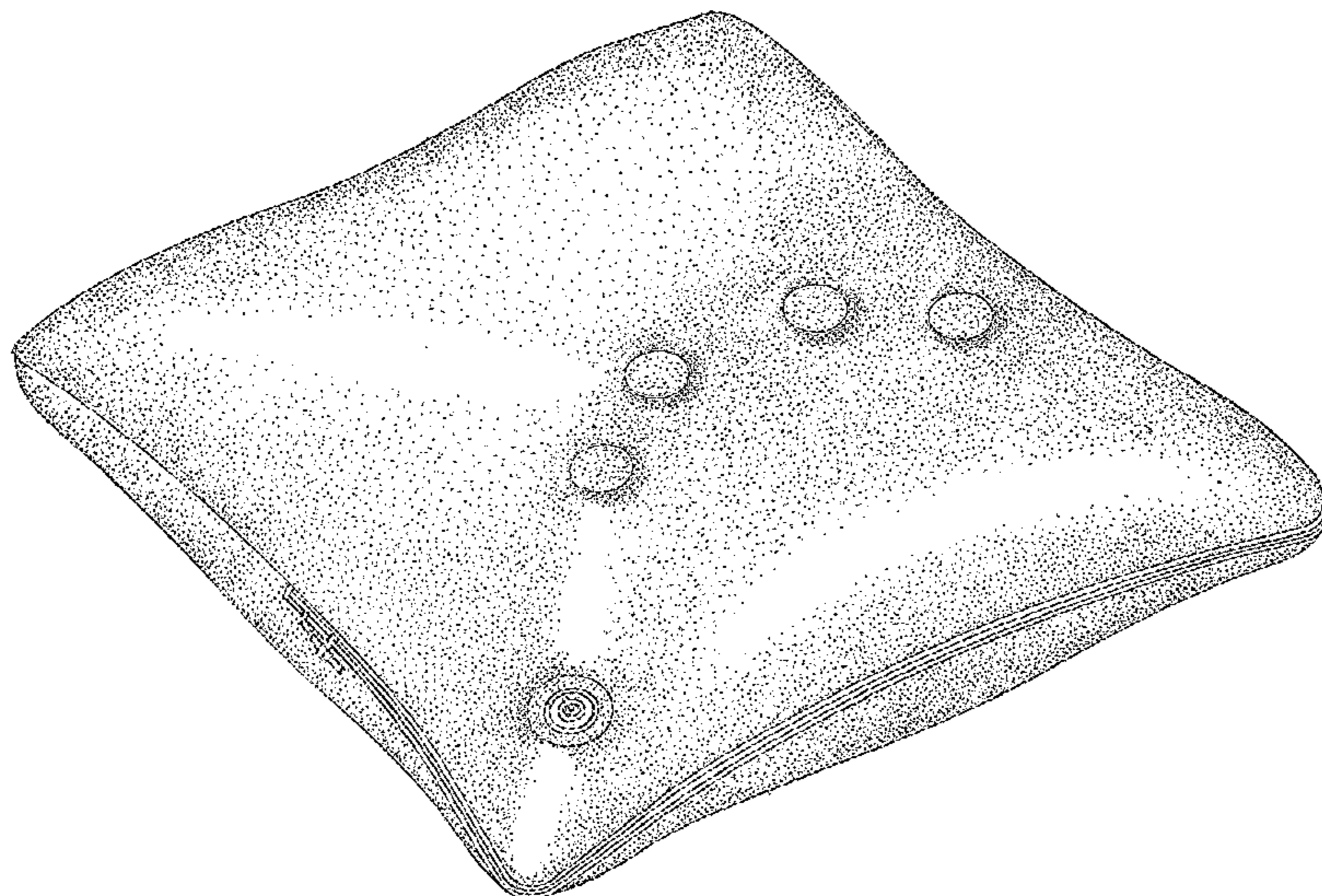
FIG. 9 is a front view thereof, similar to FIG. 3, but without evenly spaced broken lines.

FIG. 10 is a right side view thereof, similar to FIG. 5, but without evenly spaced broken lines; and,

FIG. 11 is a back view thereof, similar to FIG. 6, but without evenly spaced broken lines.

The broken line showing in the figures is for the purpose of illustrating portions of the decorative cushion massage device and forms no part of the claimed design.

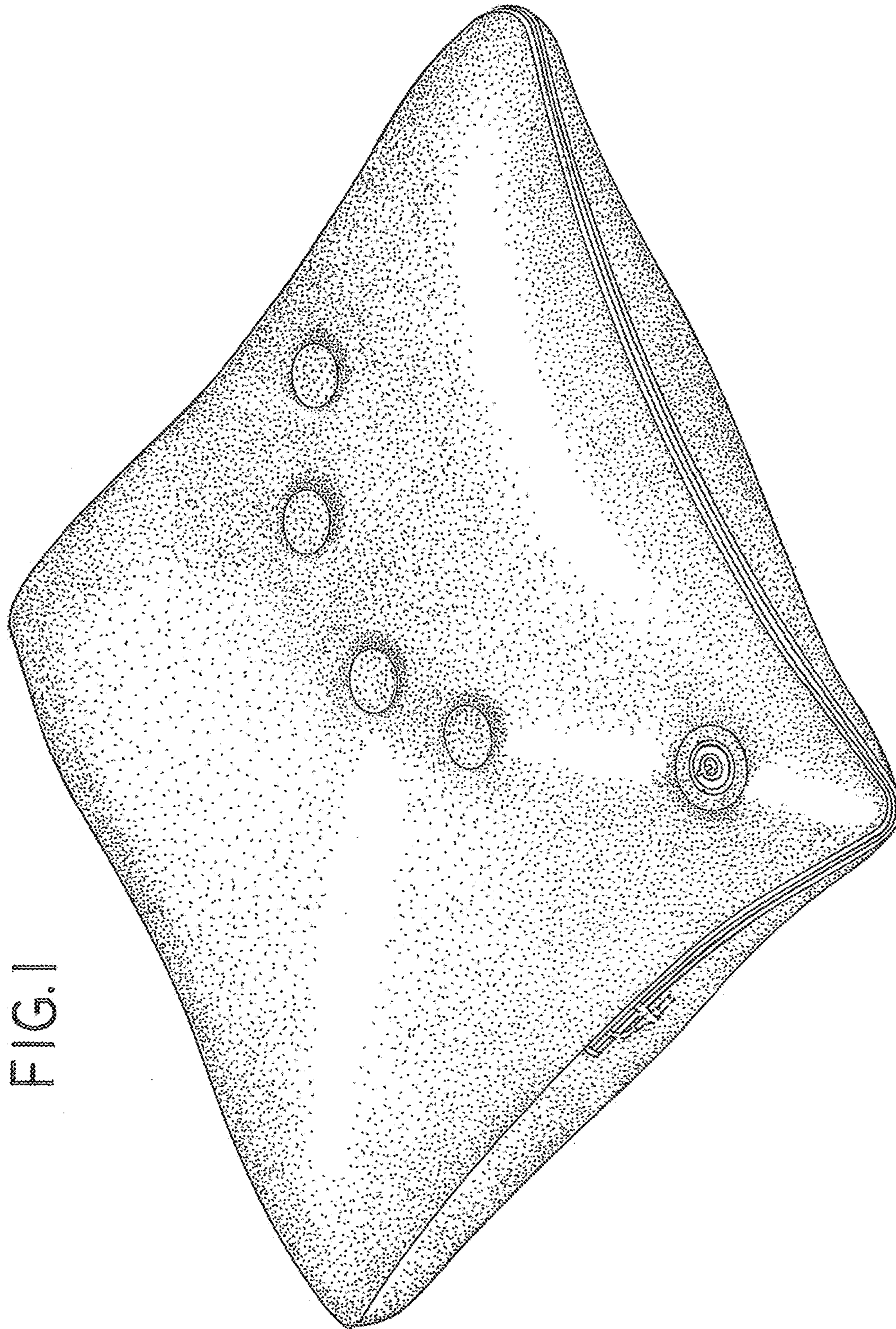

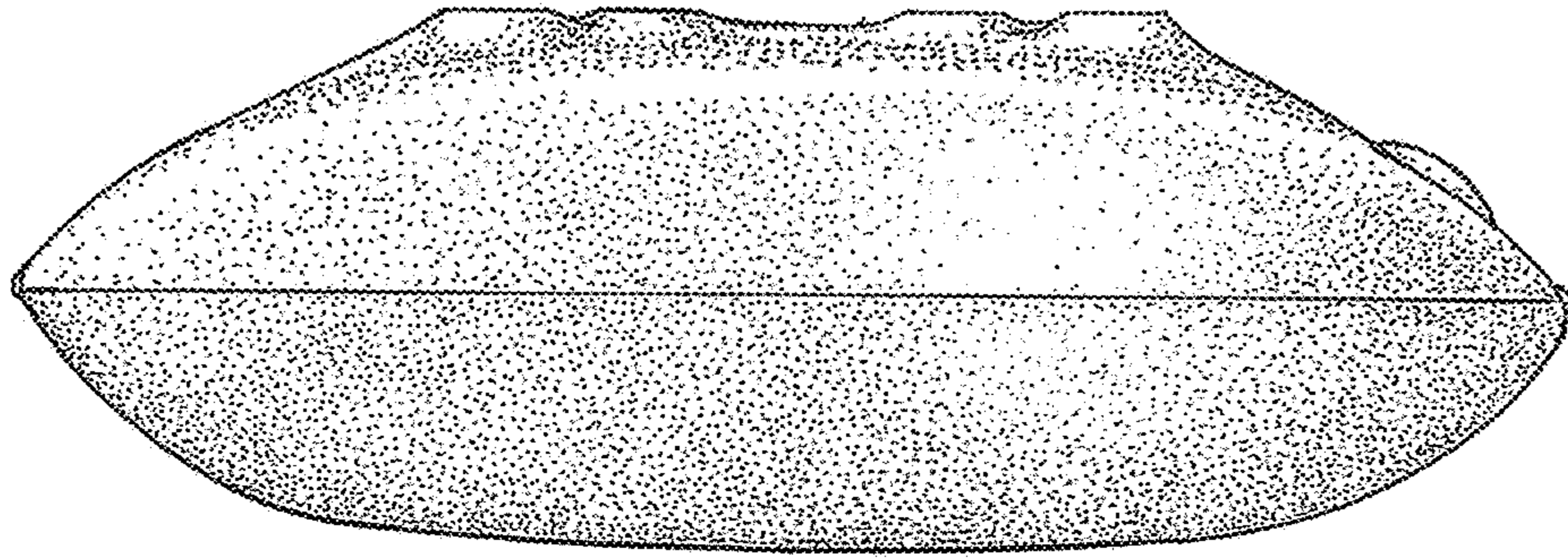

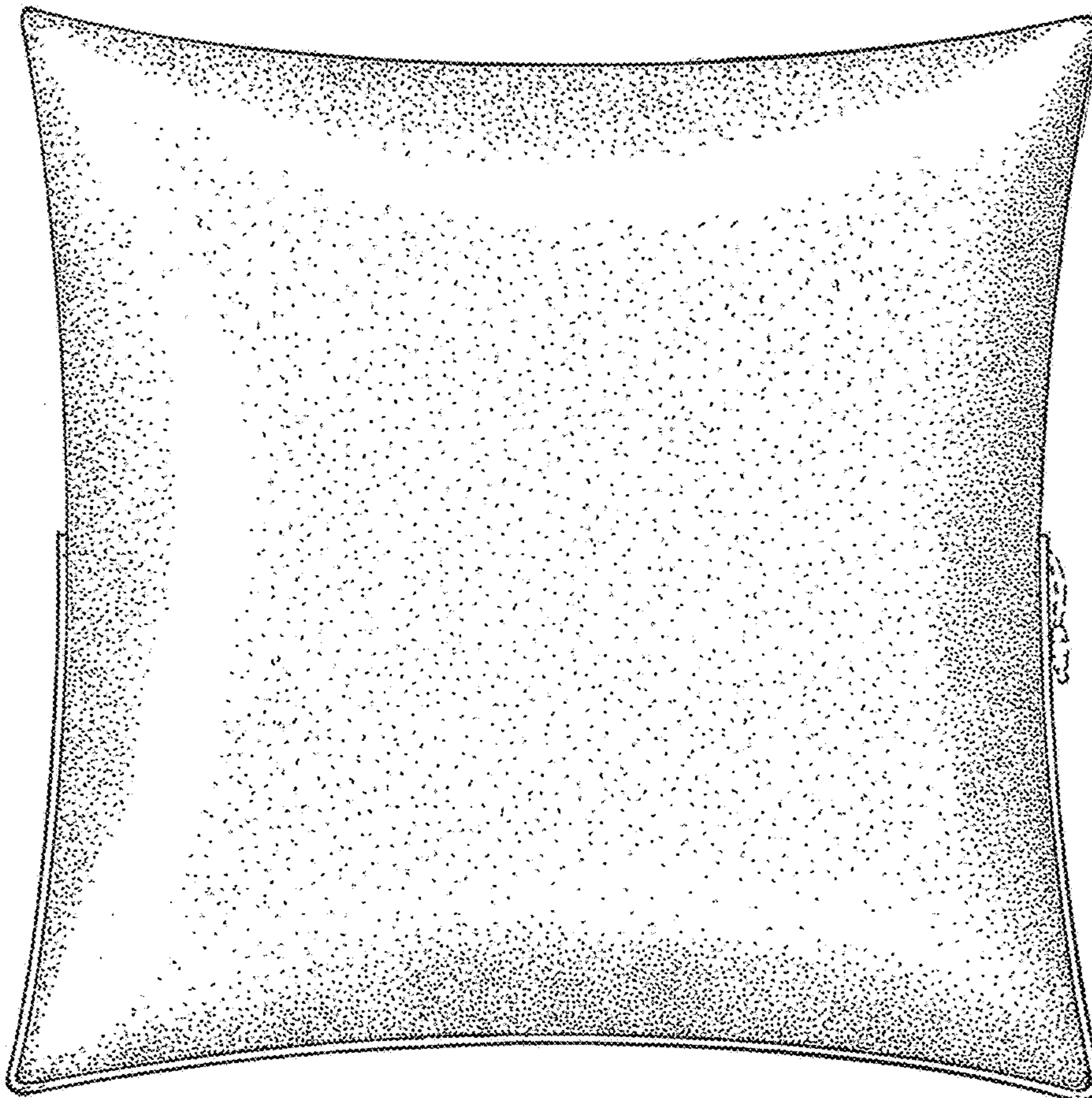

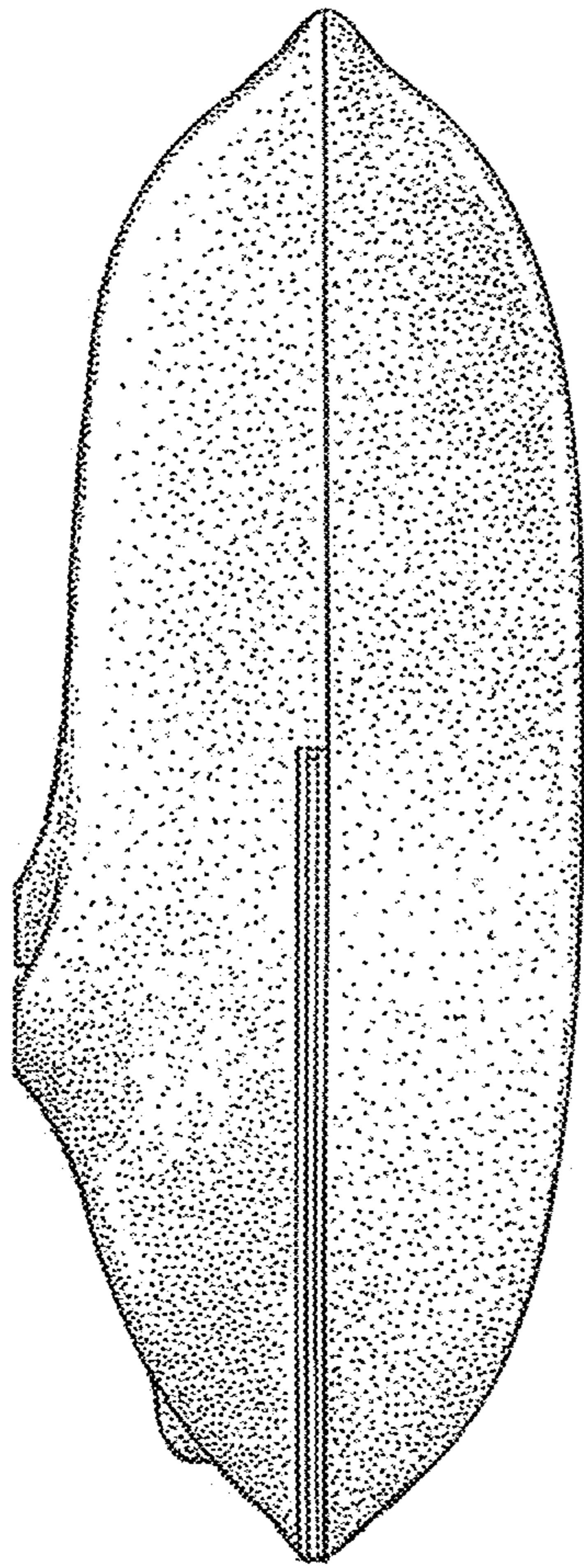

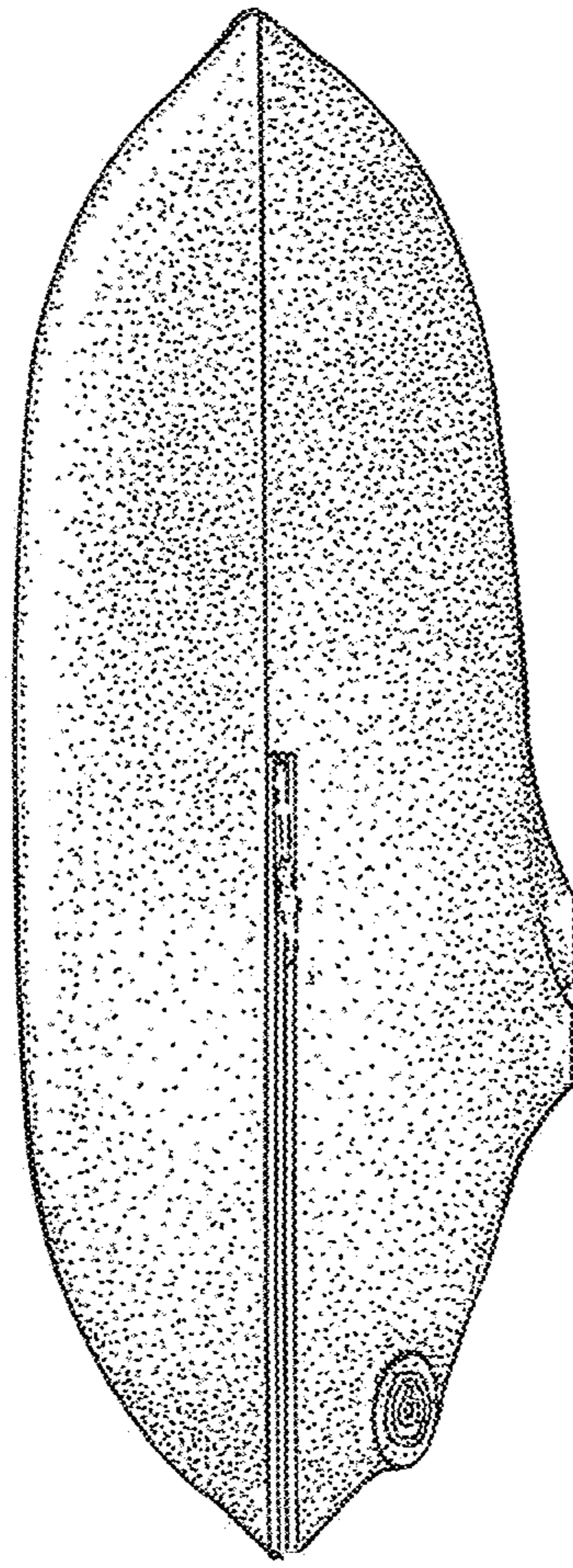

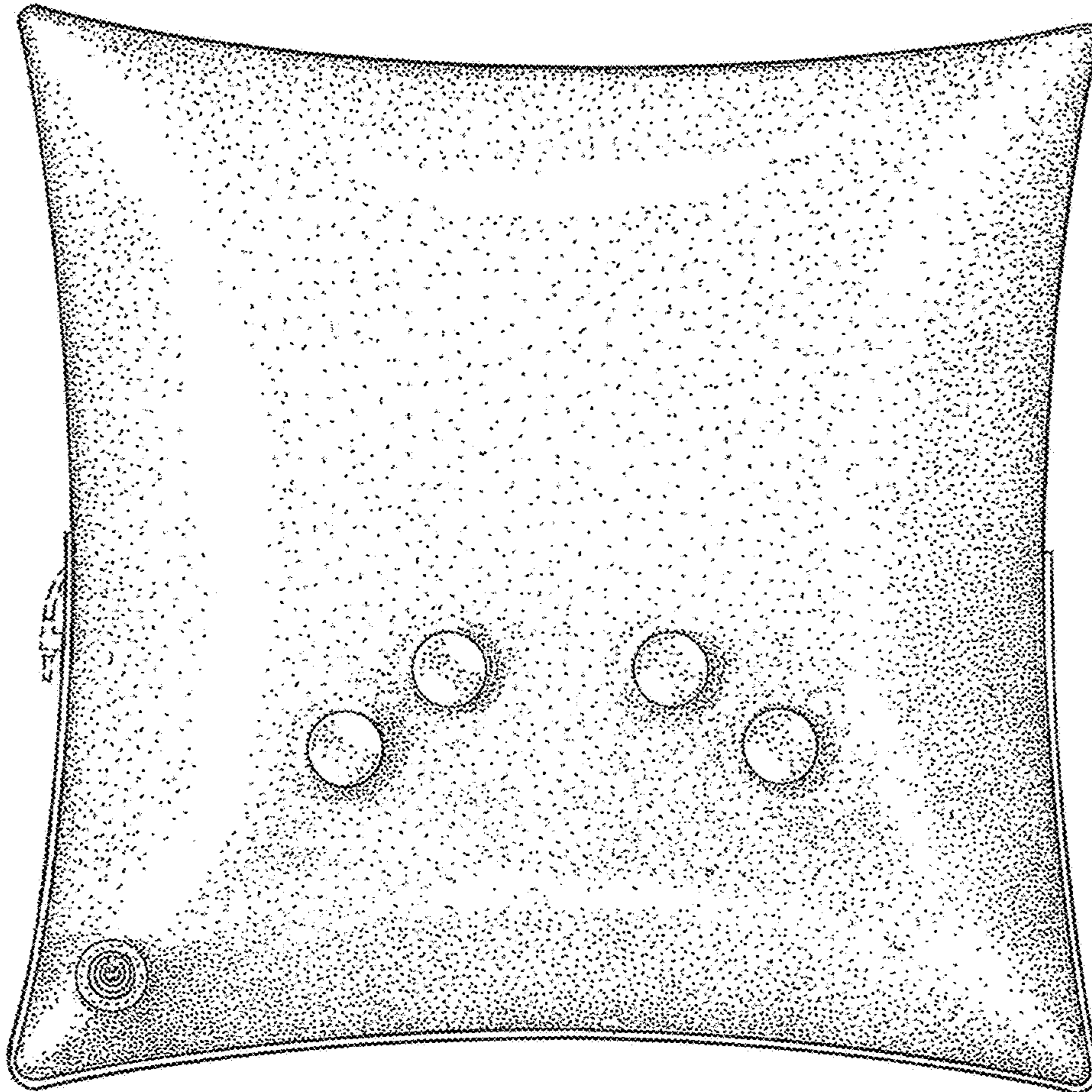
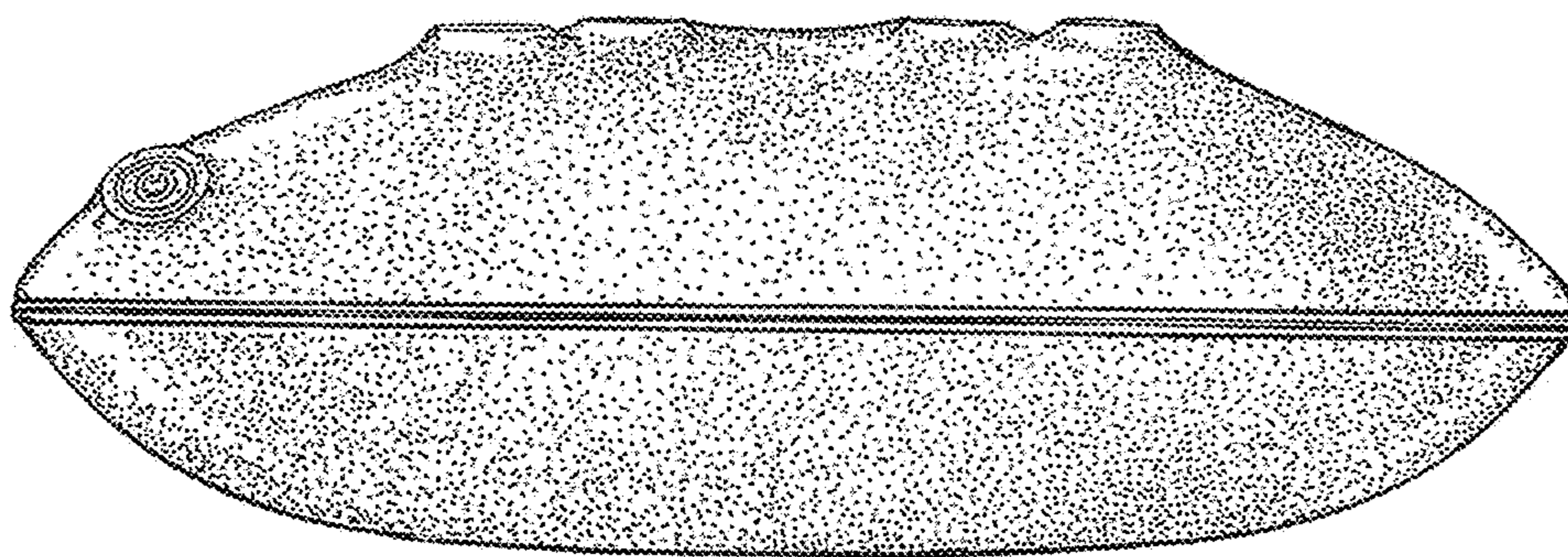

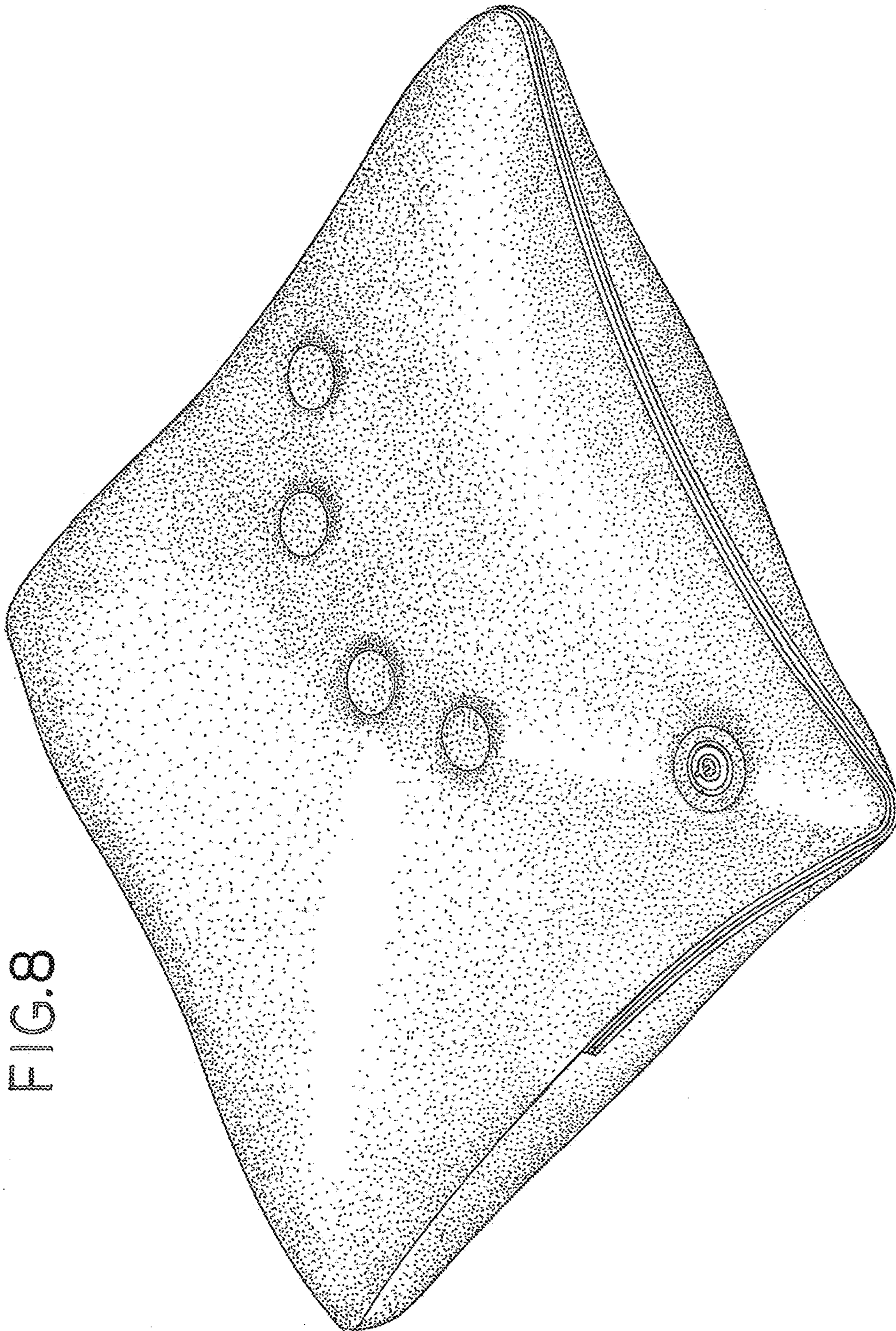

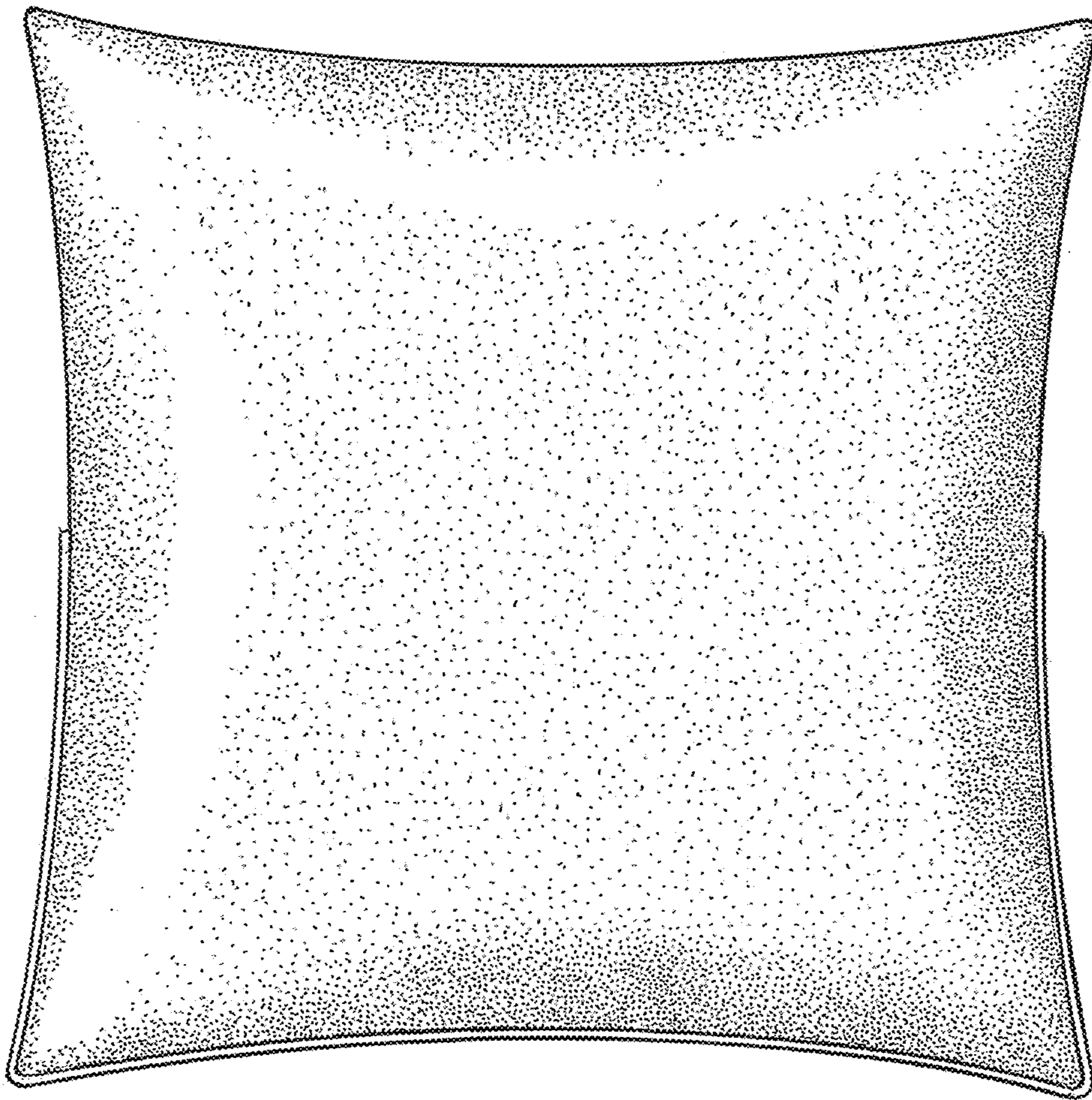

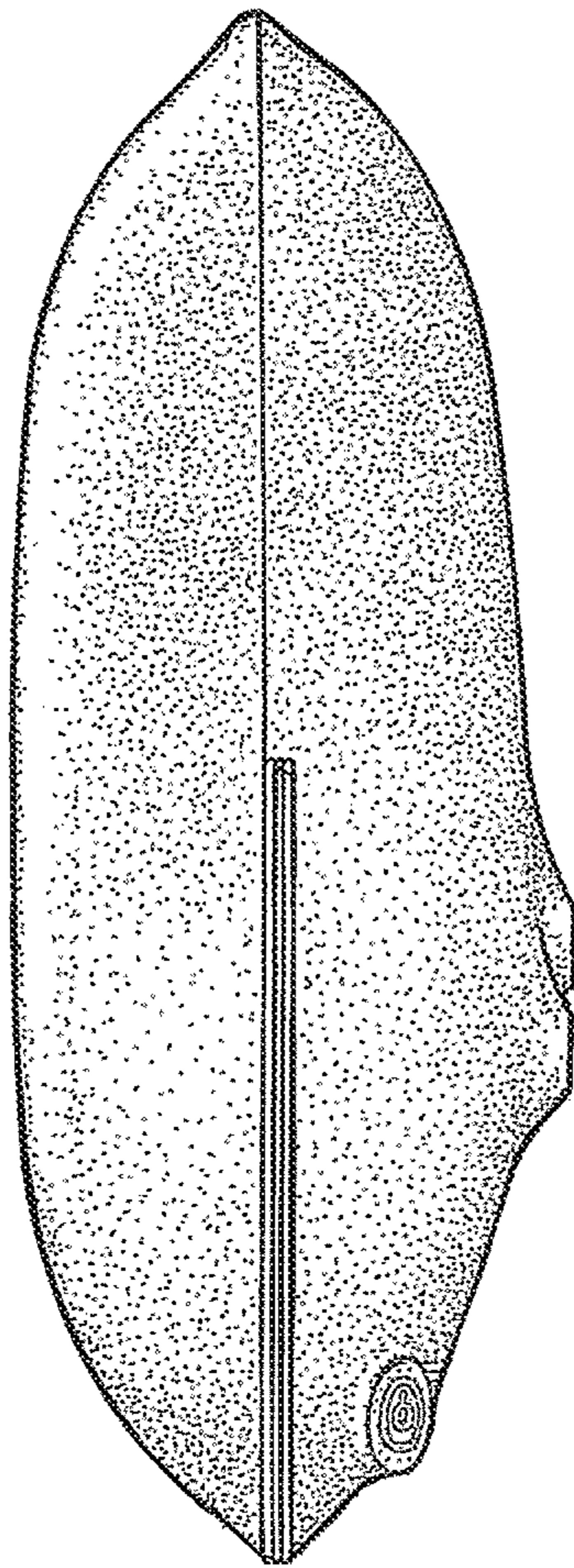
