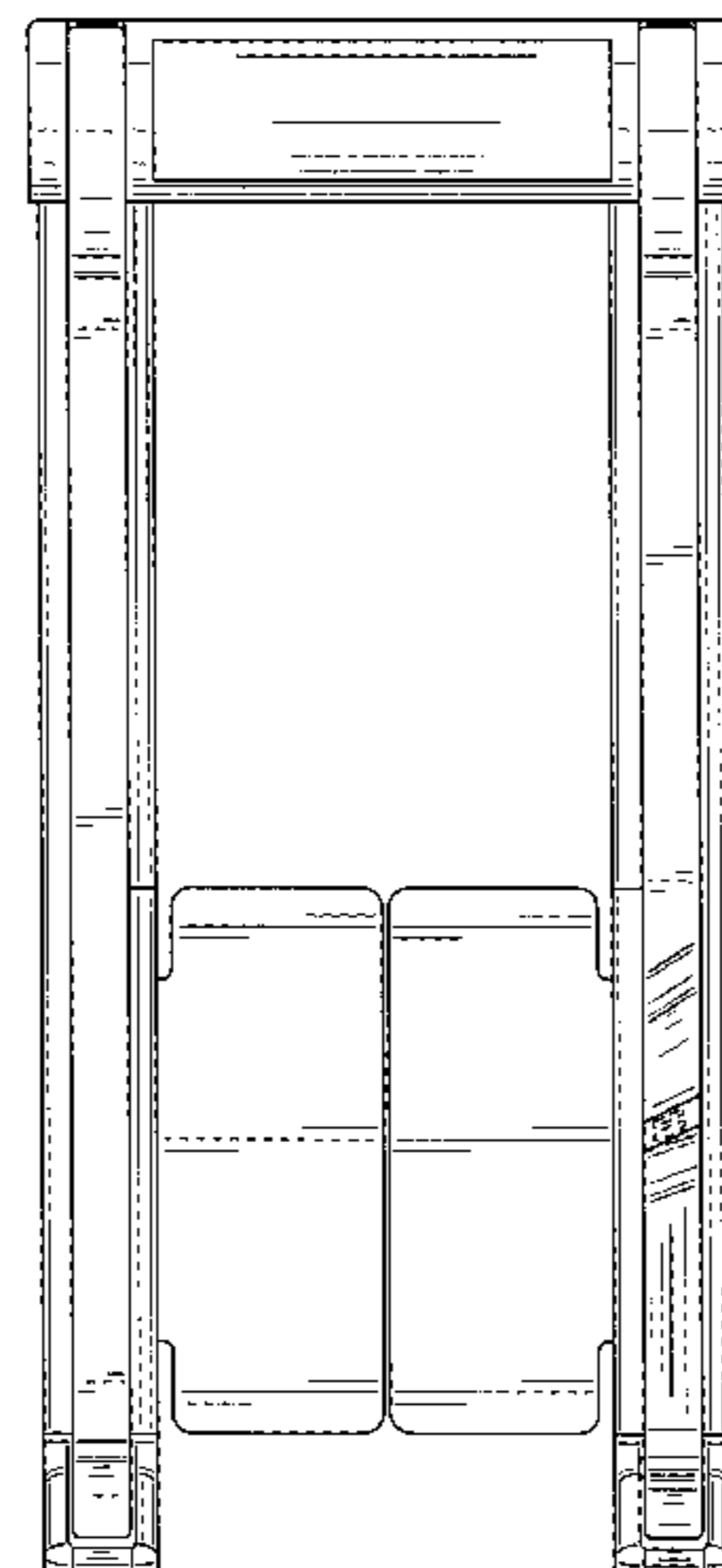
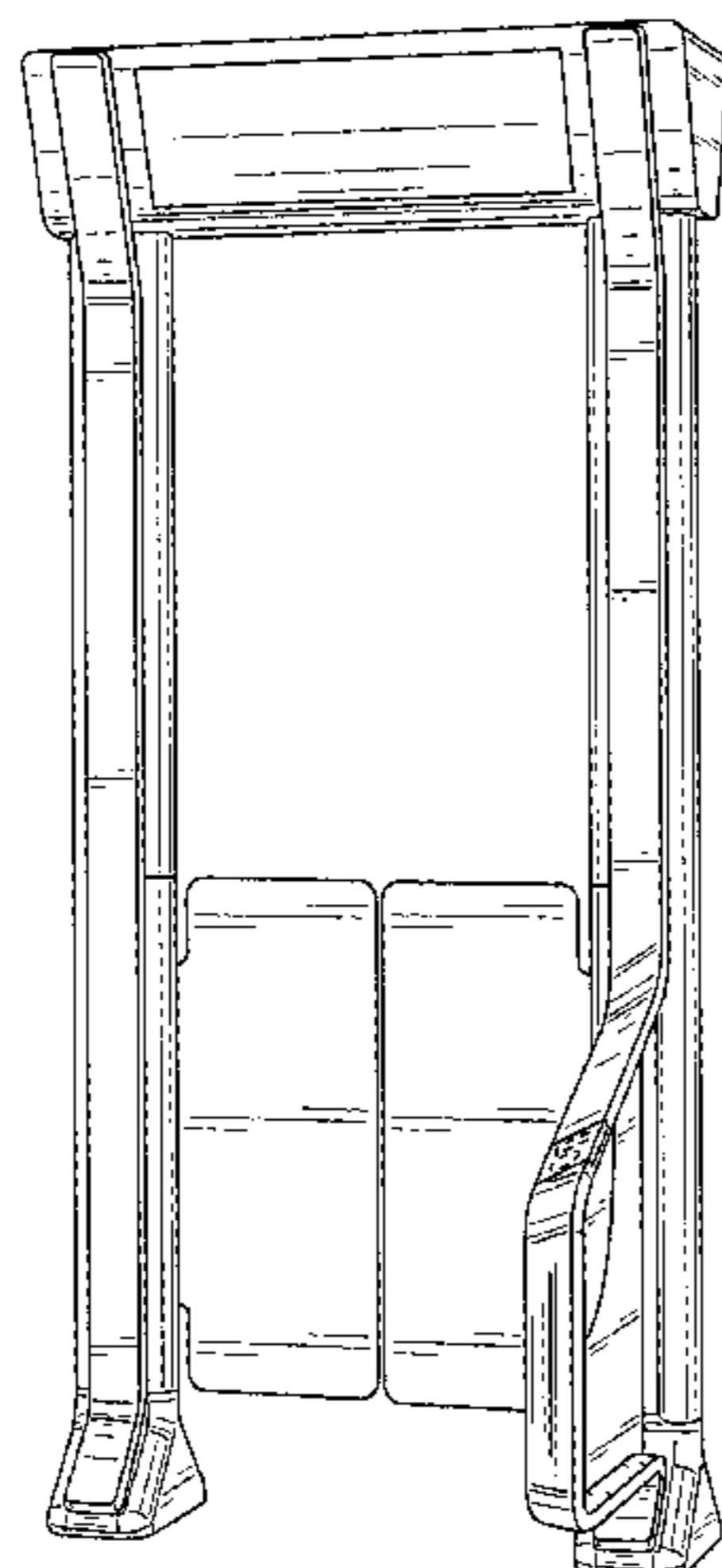
The ornamental design for an automatic access gate, as shown and described.

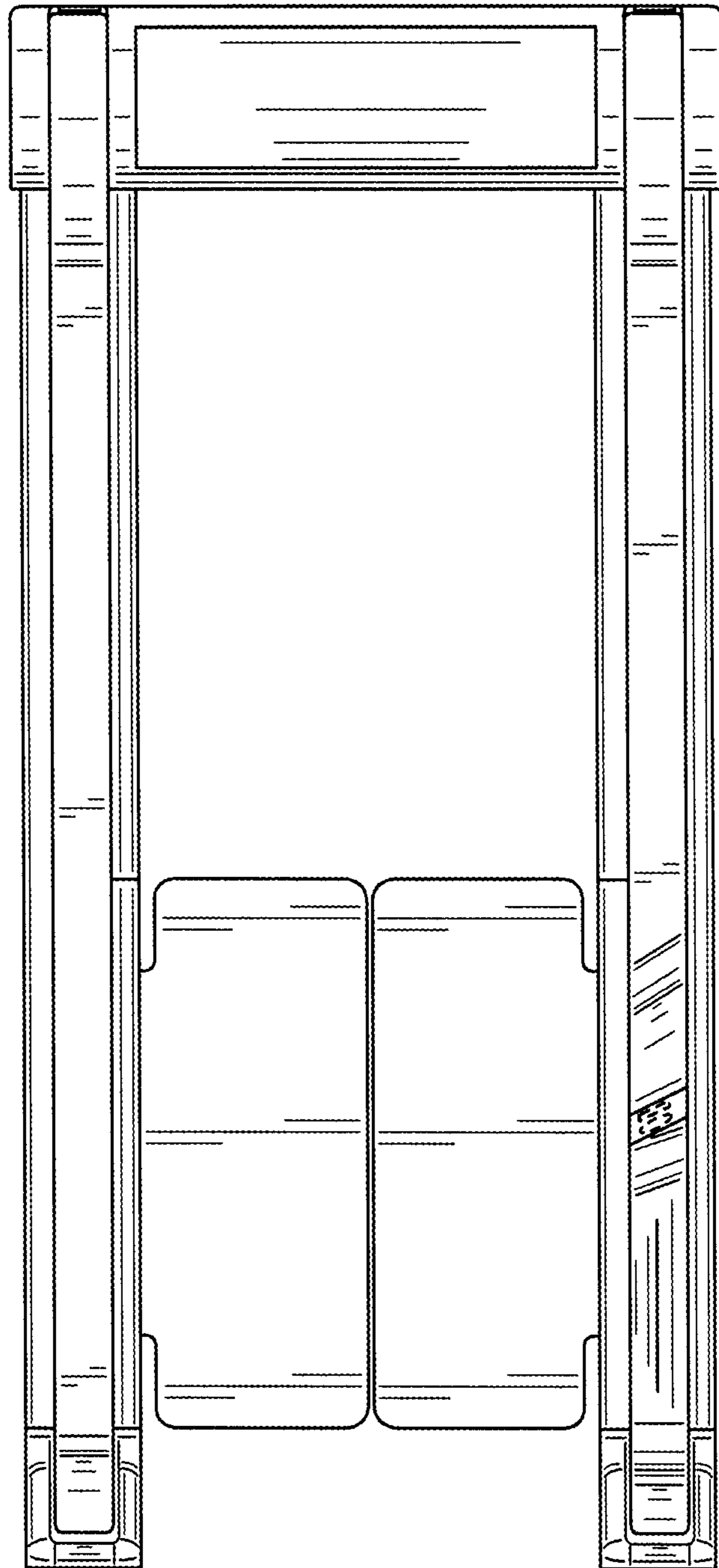

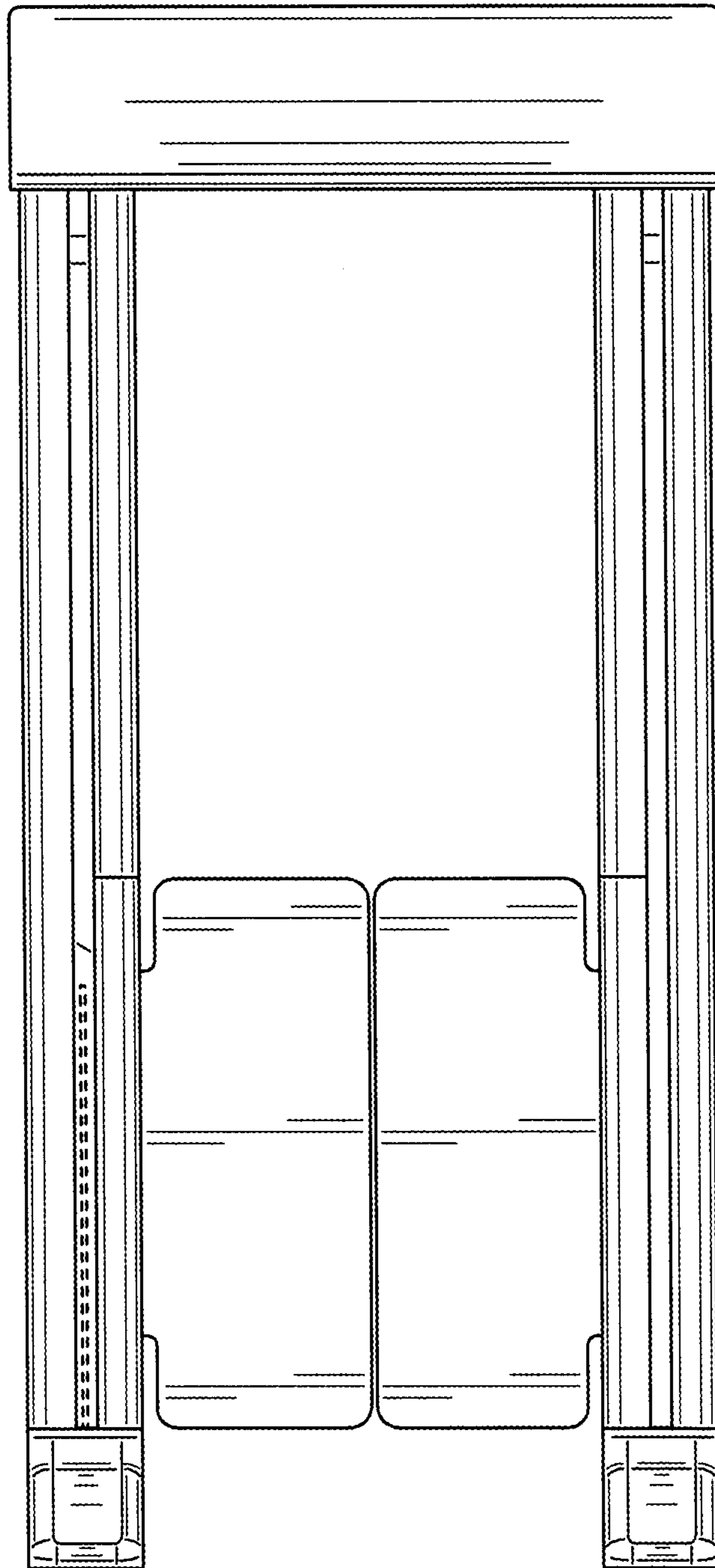

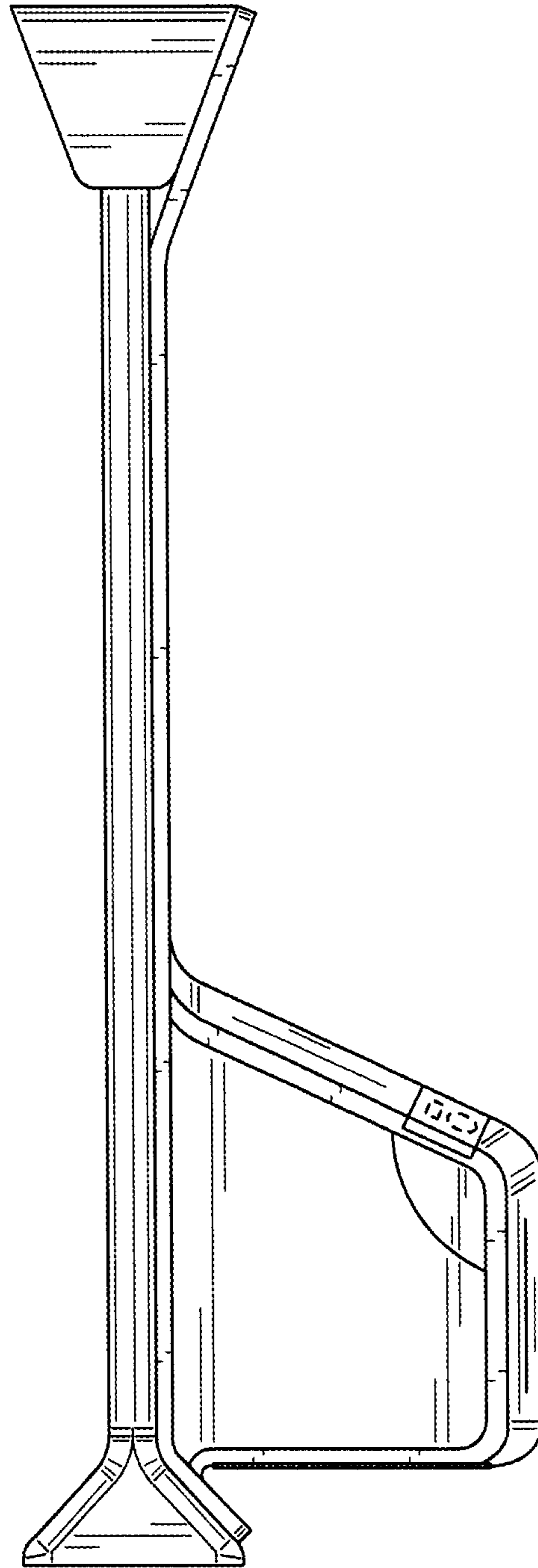

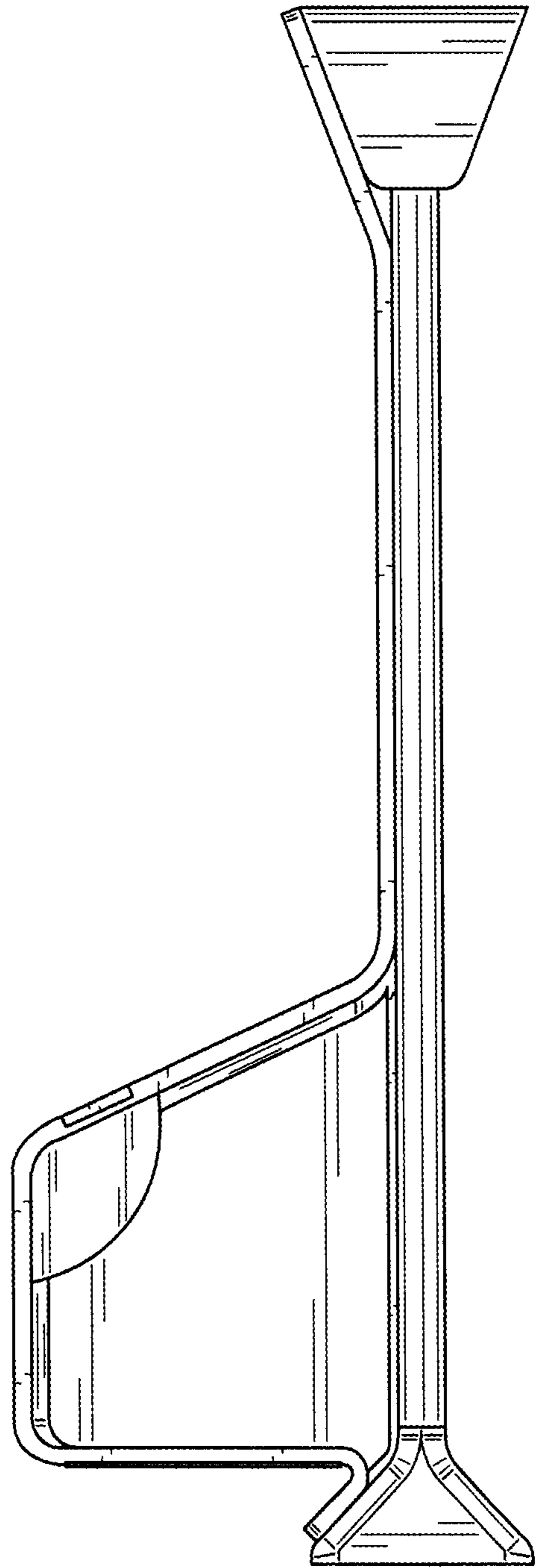

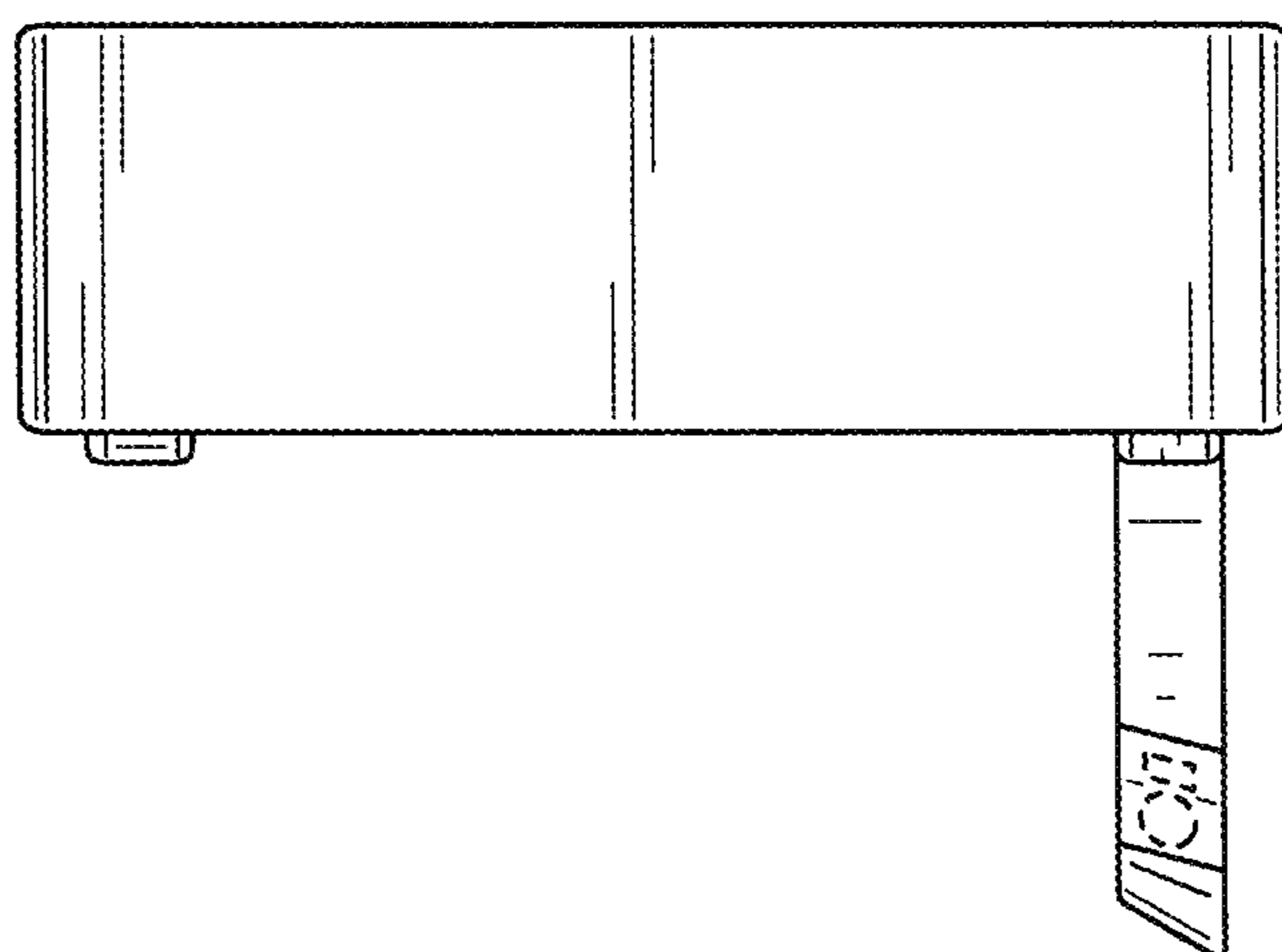

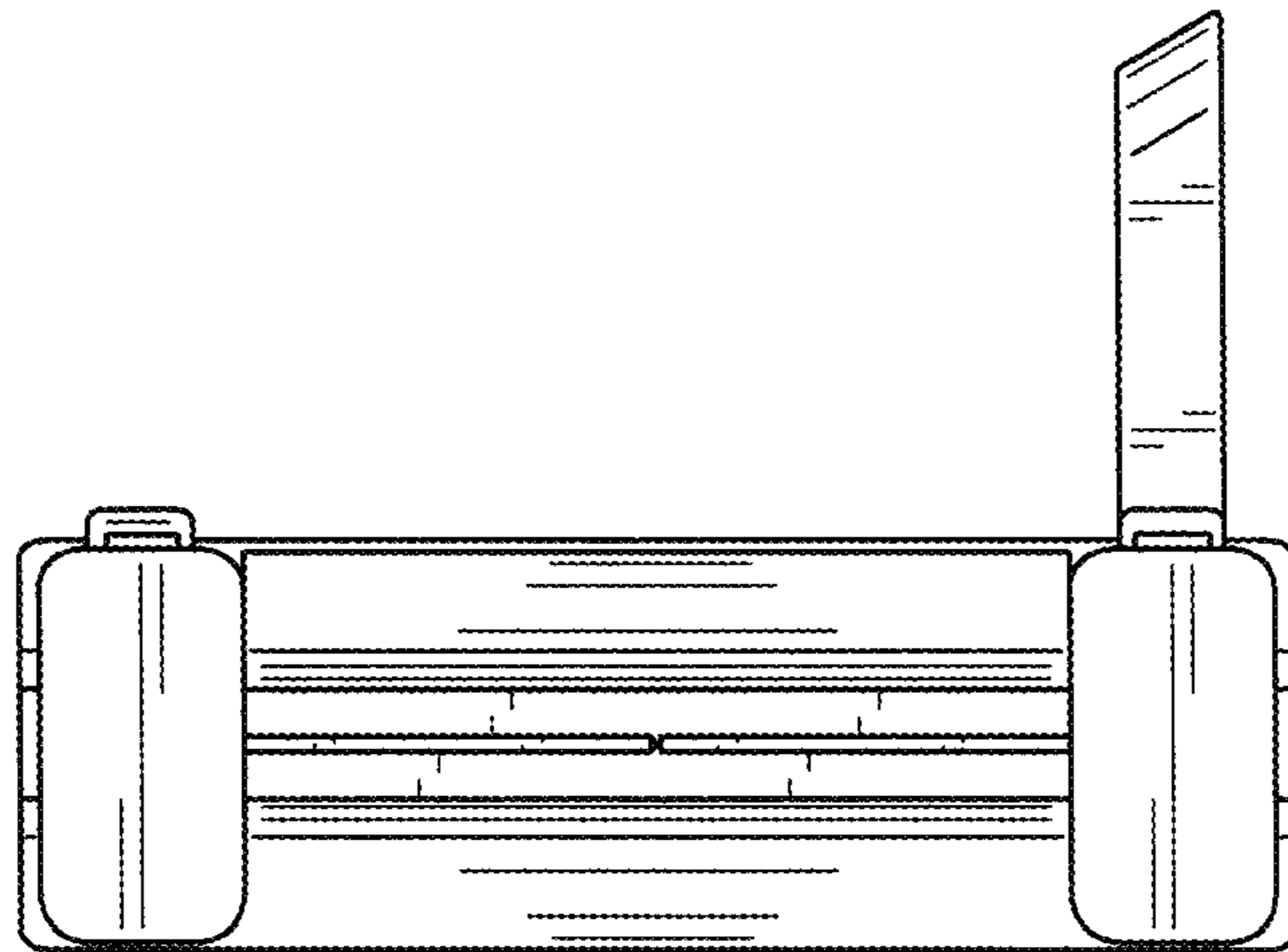
