The ornamental design for a pool equipment door/driveway gate, as shown and described.

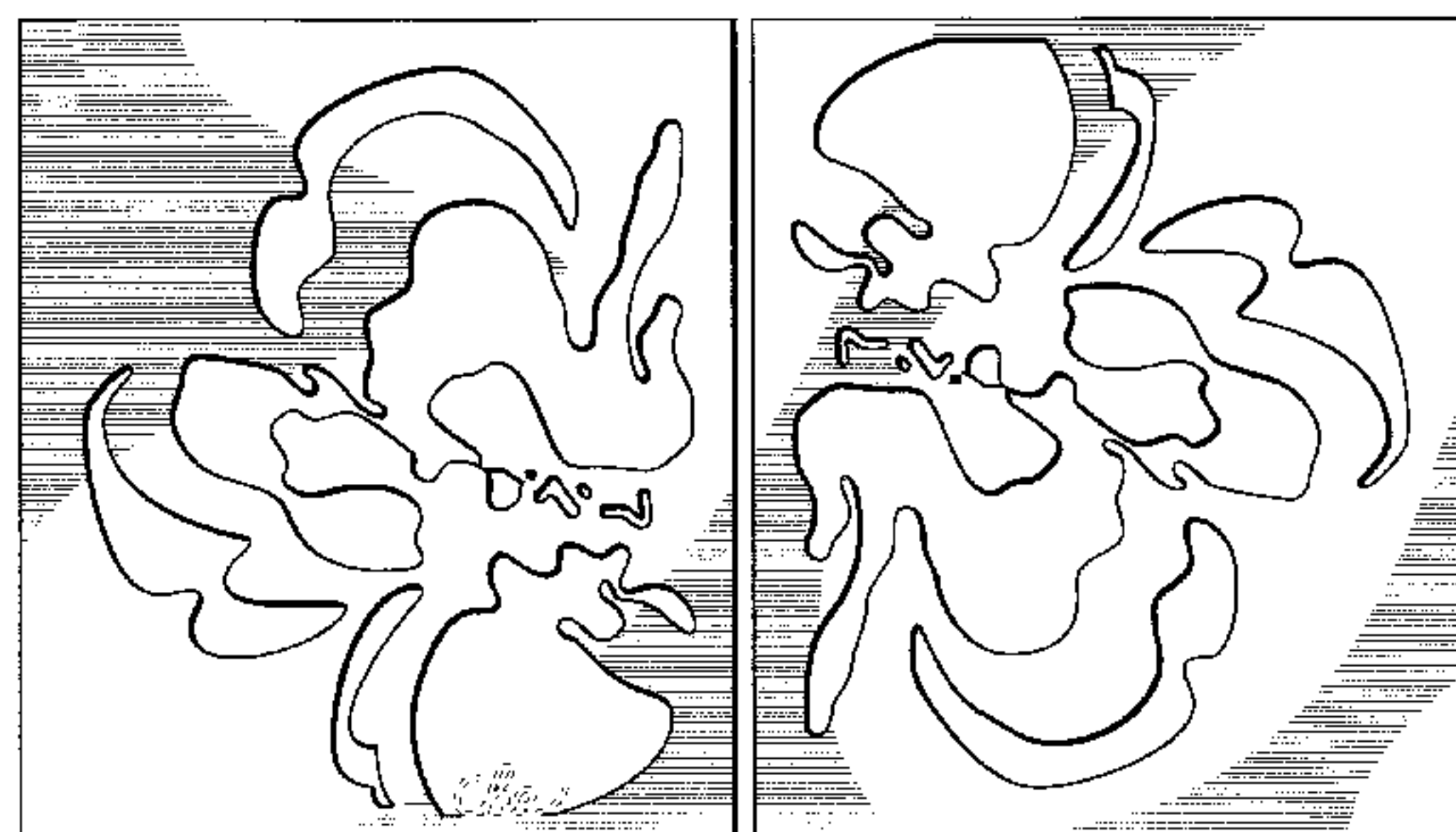
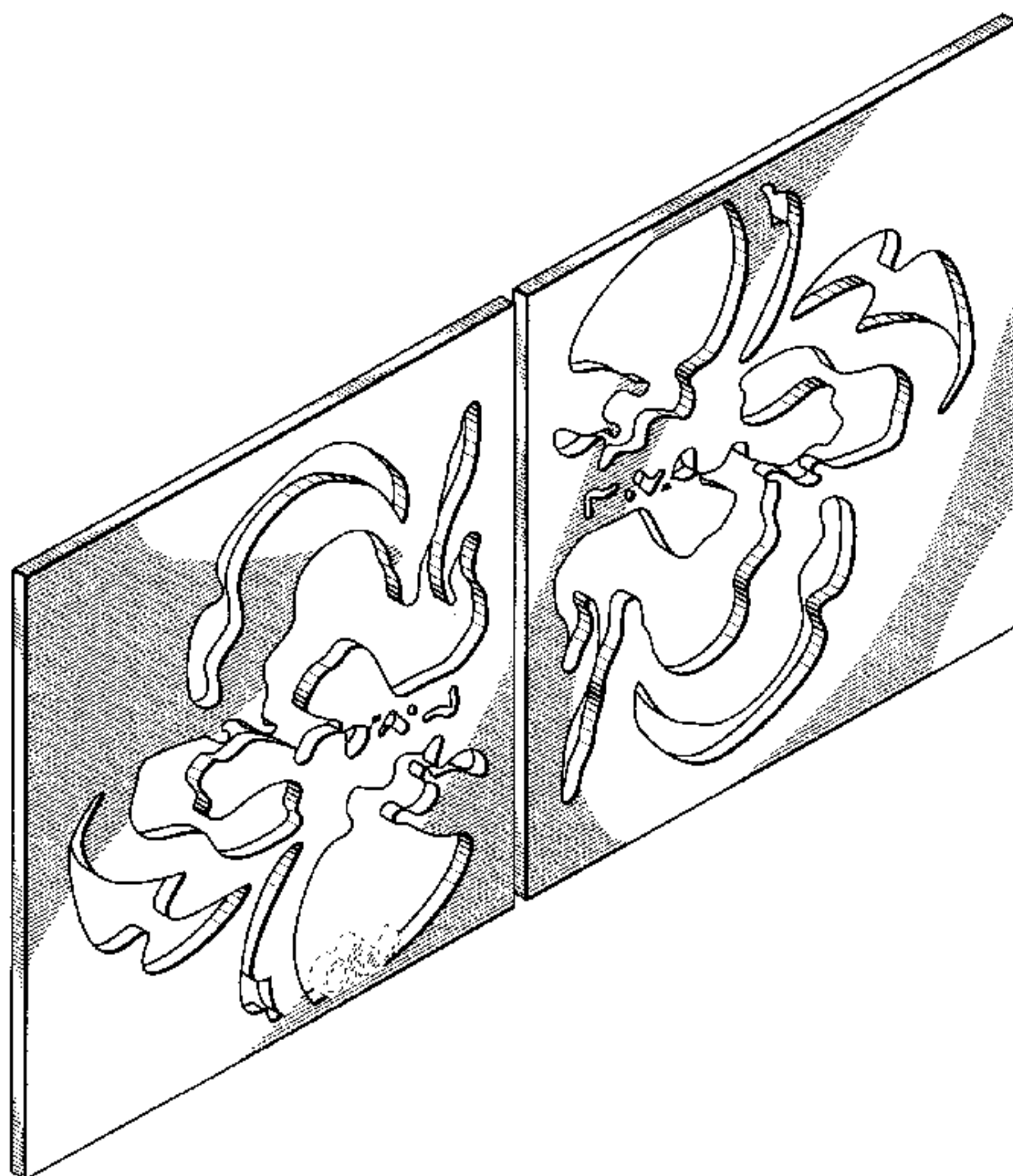
DESCRIPTION

FIG. 1 is a top perspective view of a pool equipment door/driveway gate according to an embodiment of the present invention; and,

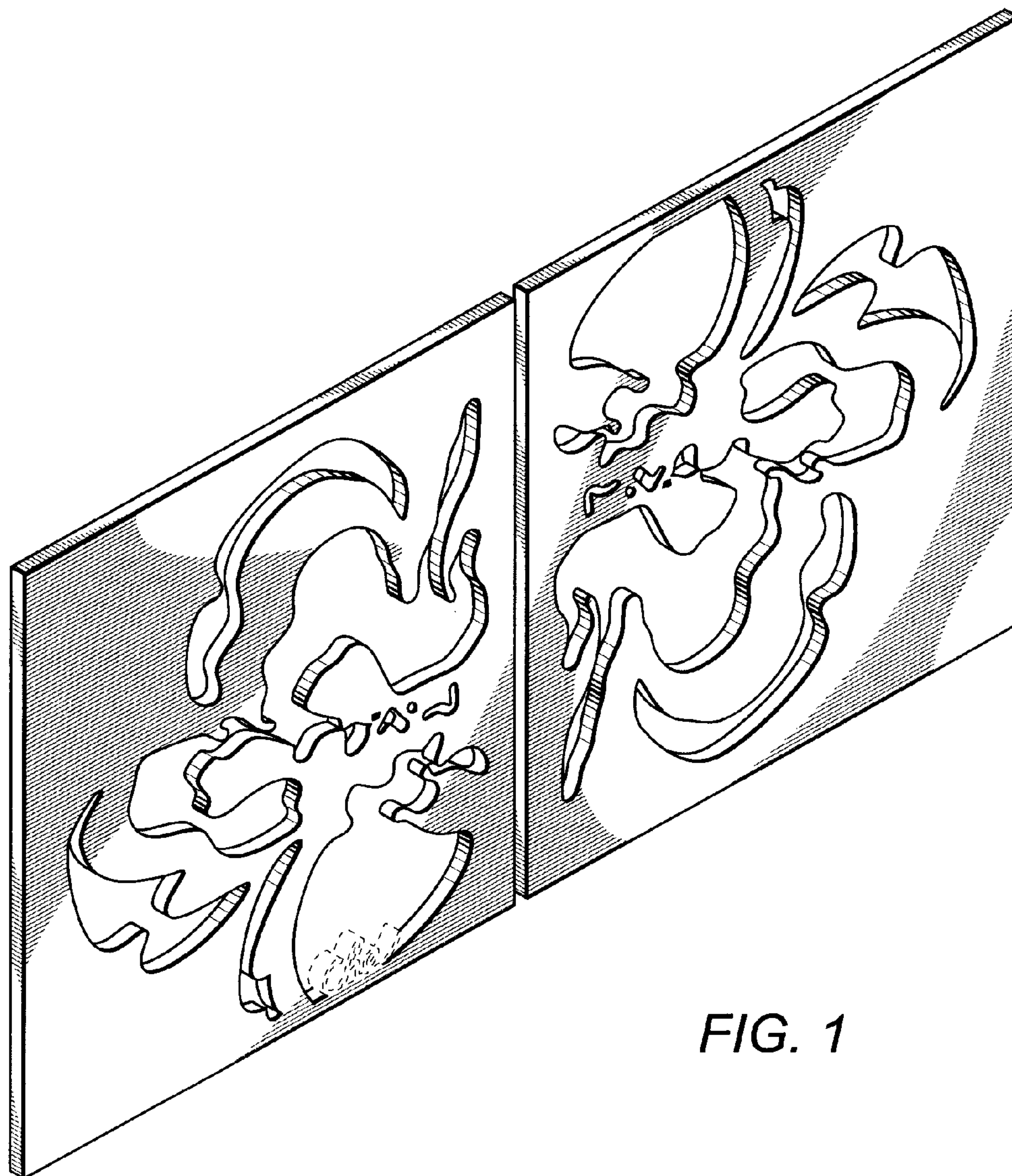

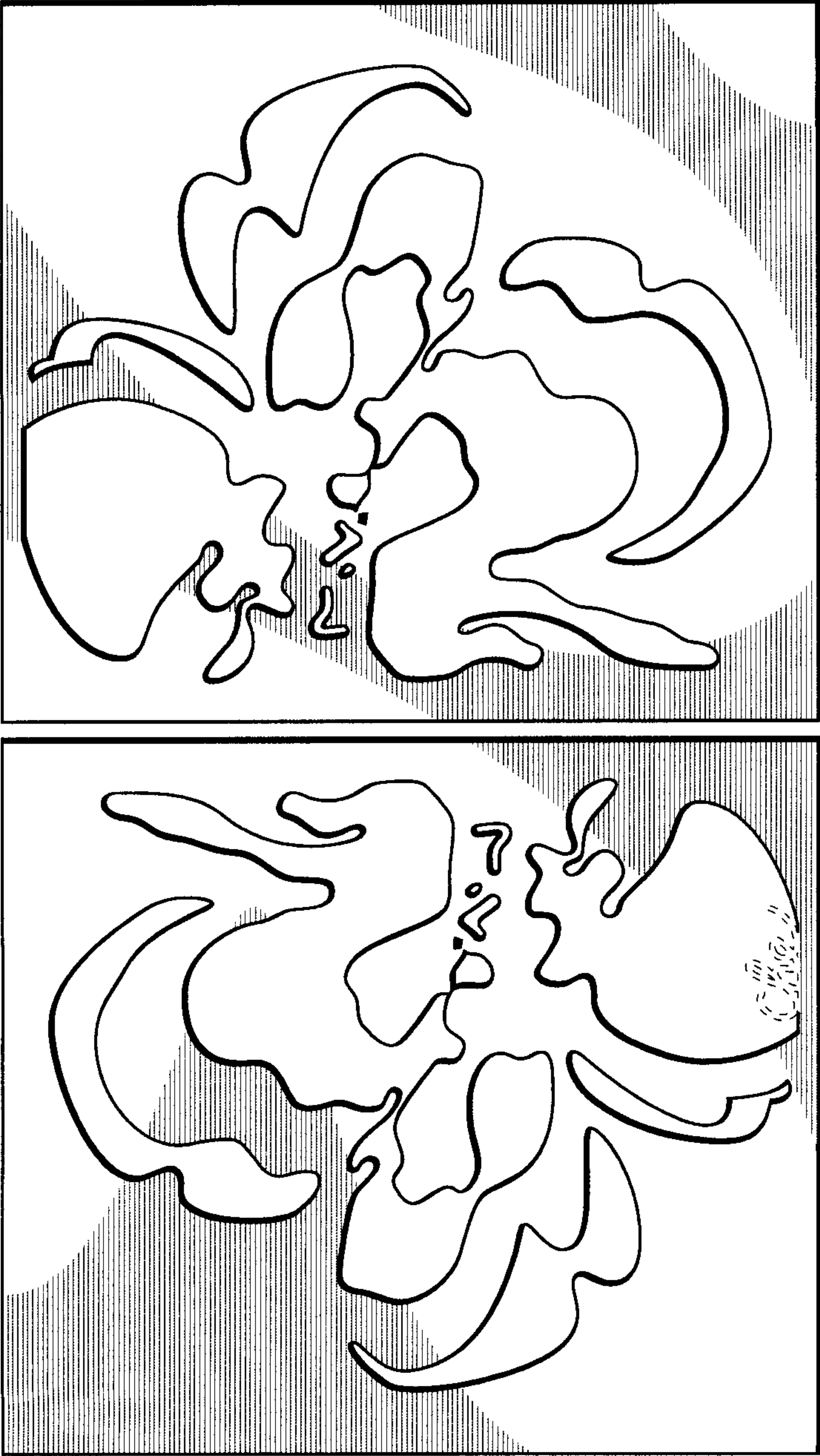
