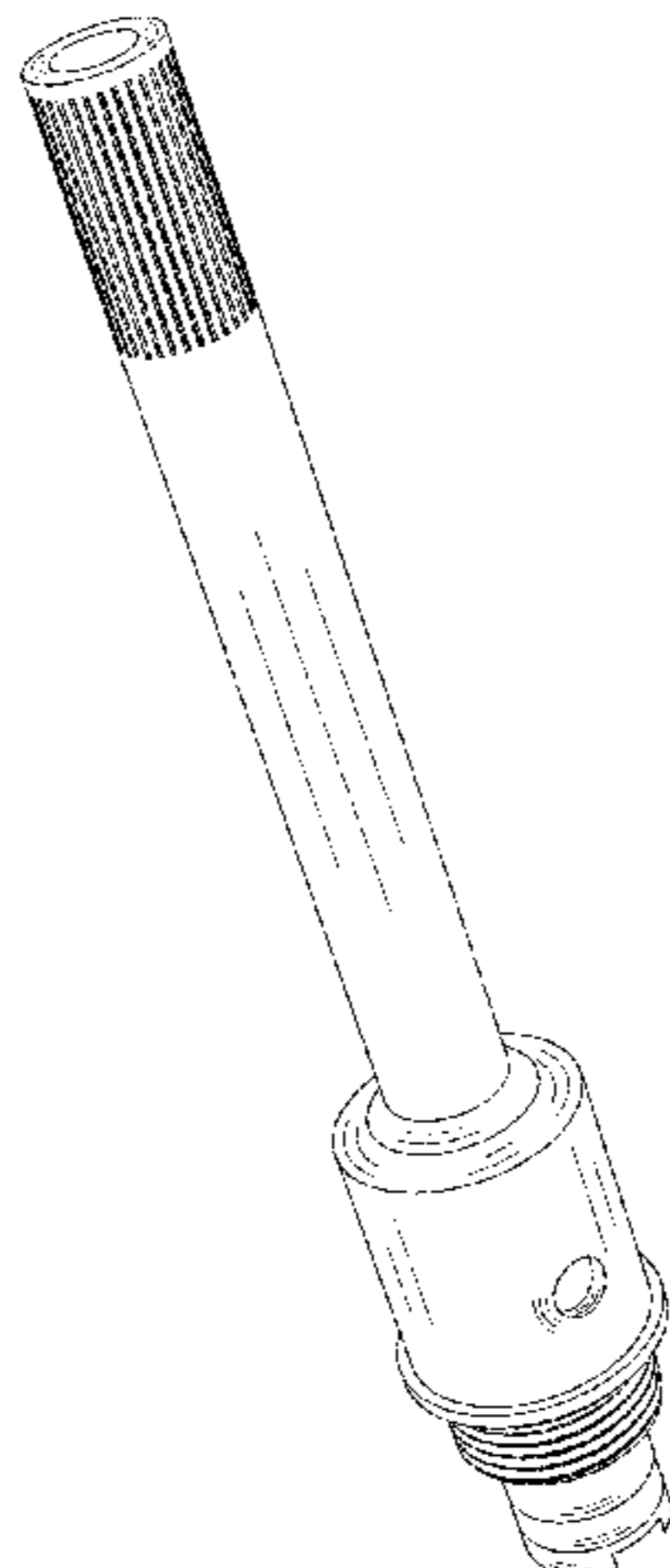


FIG. 21 is a perspective view of the third embodiment thereof.

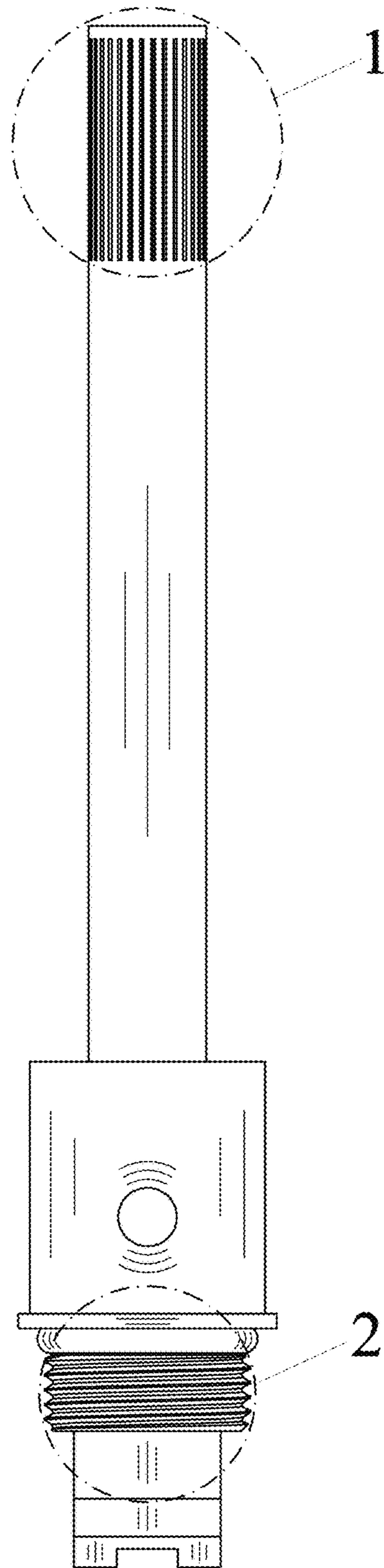

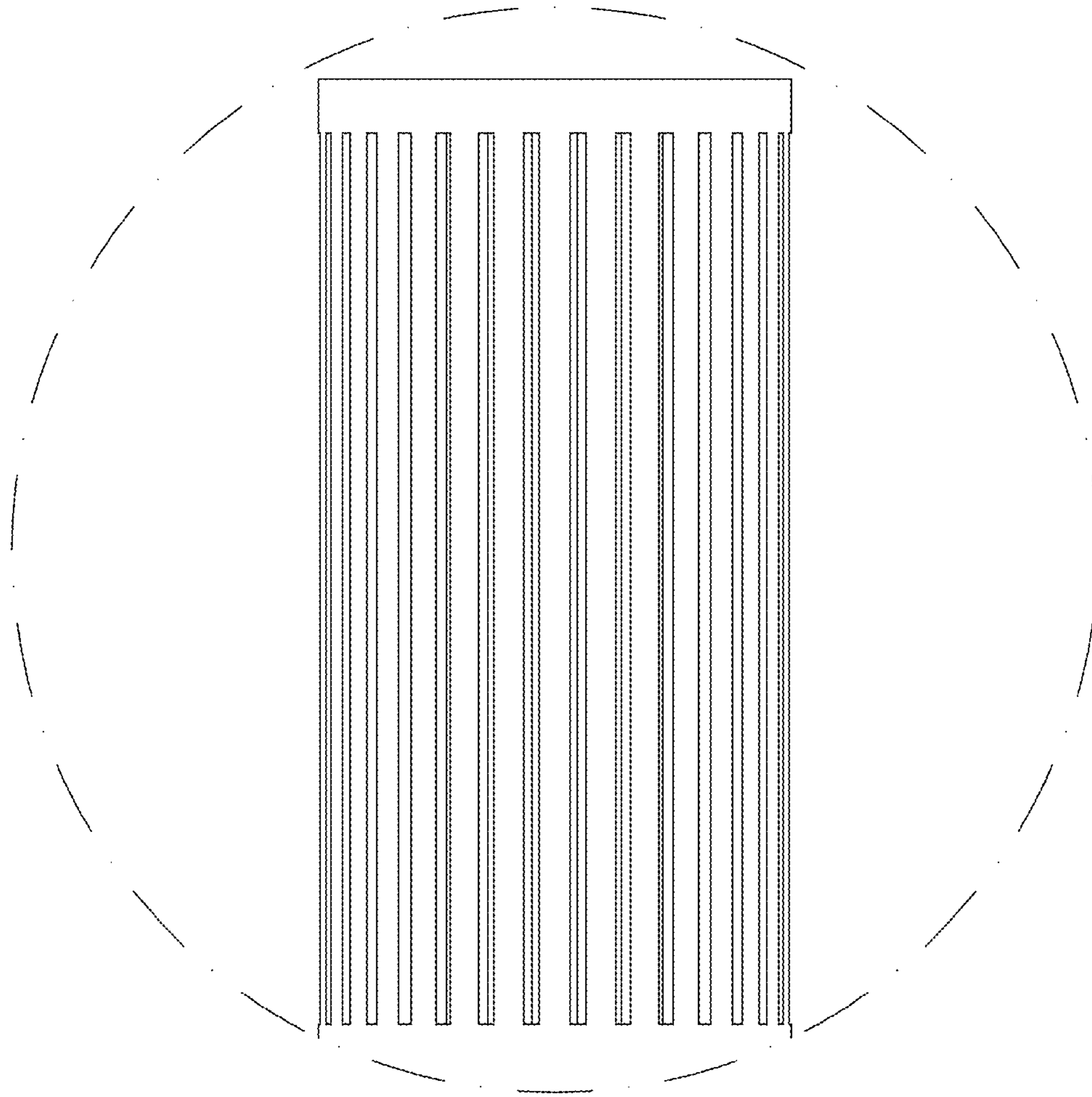

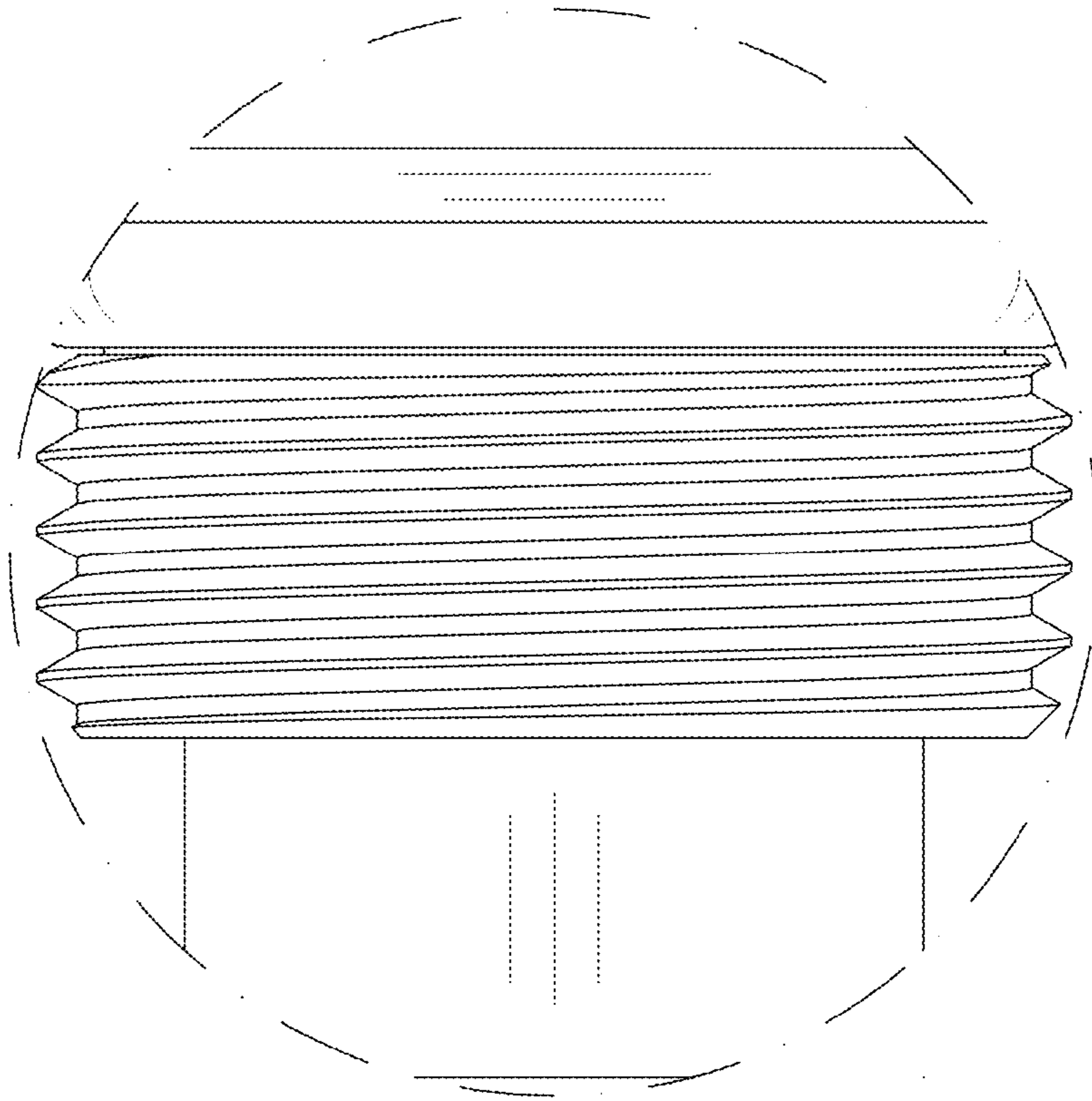

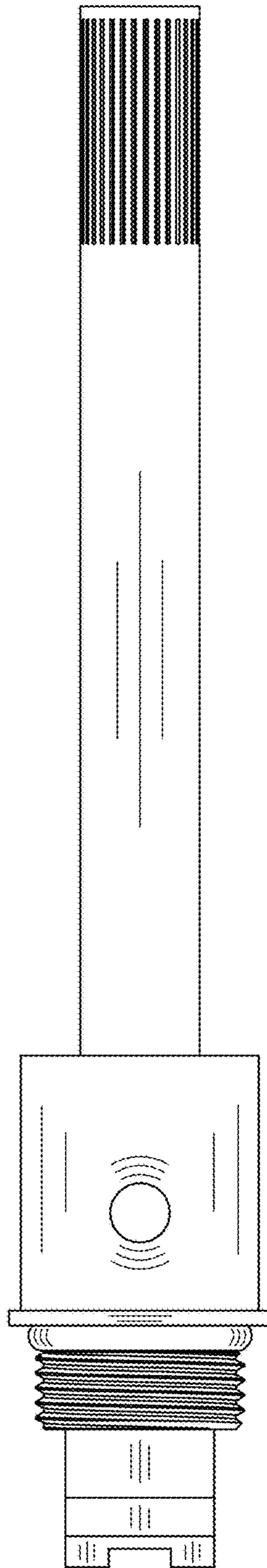

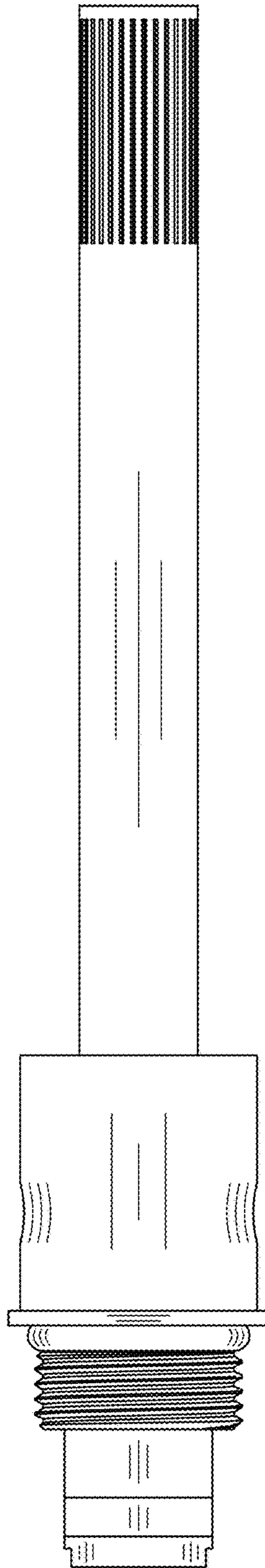

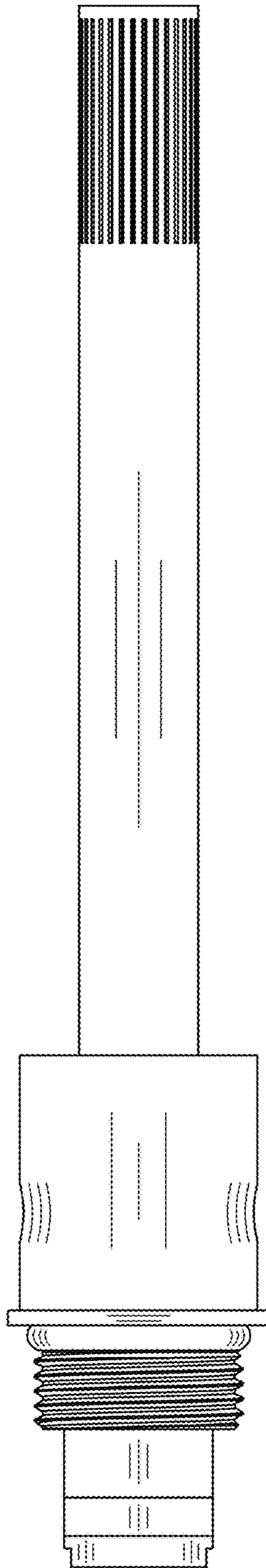

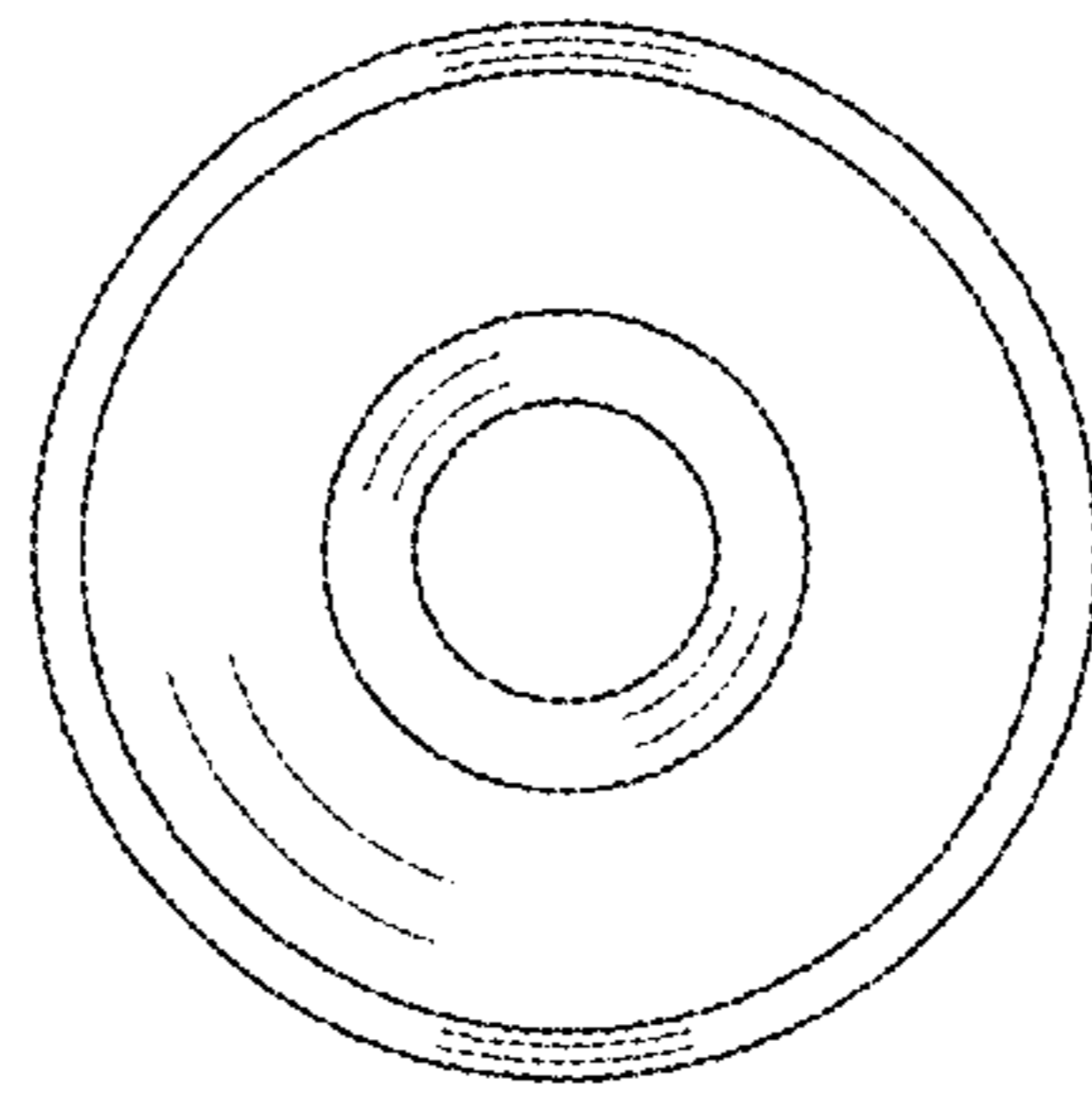

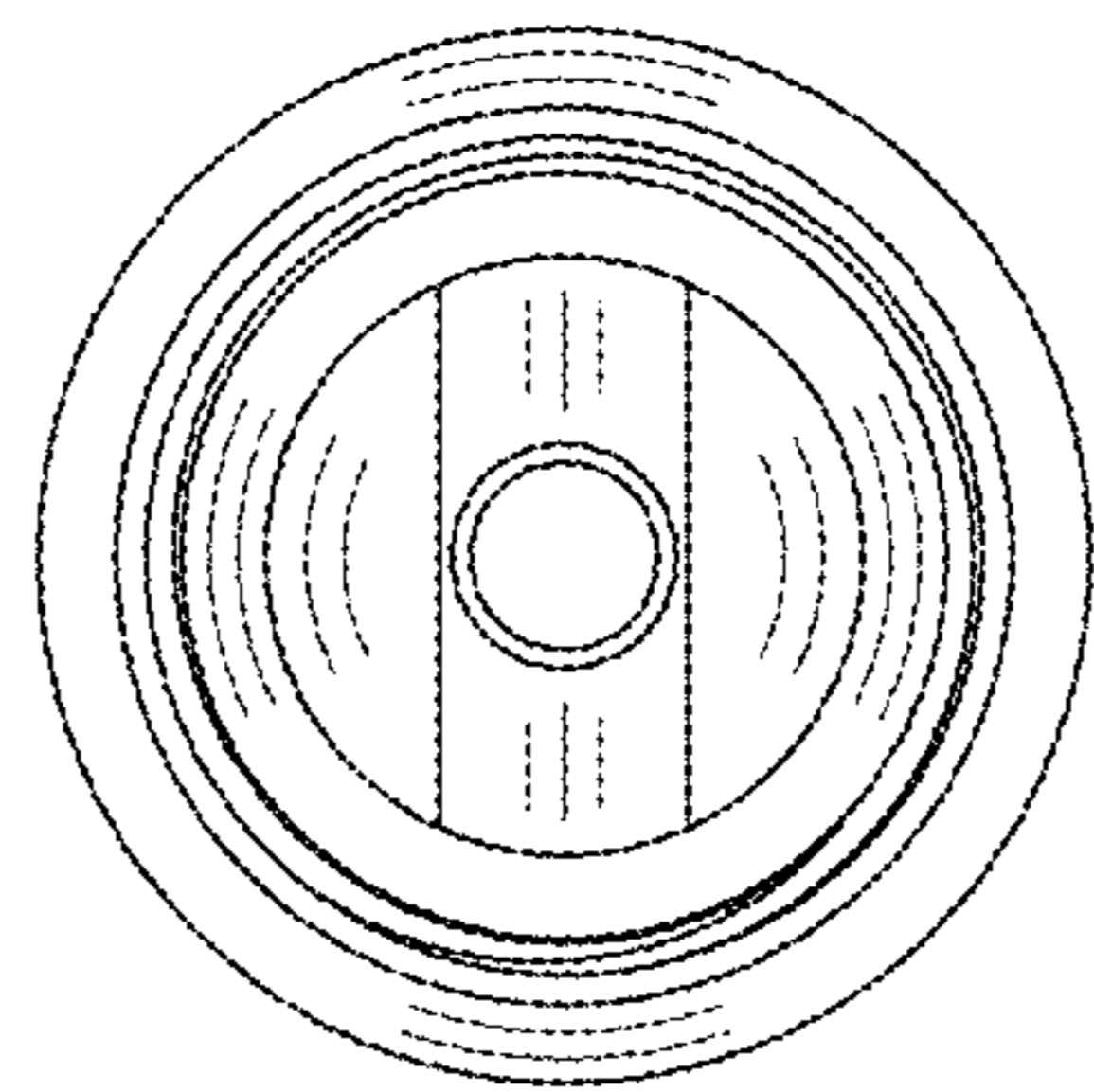

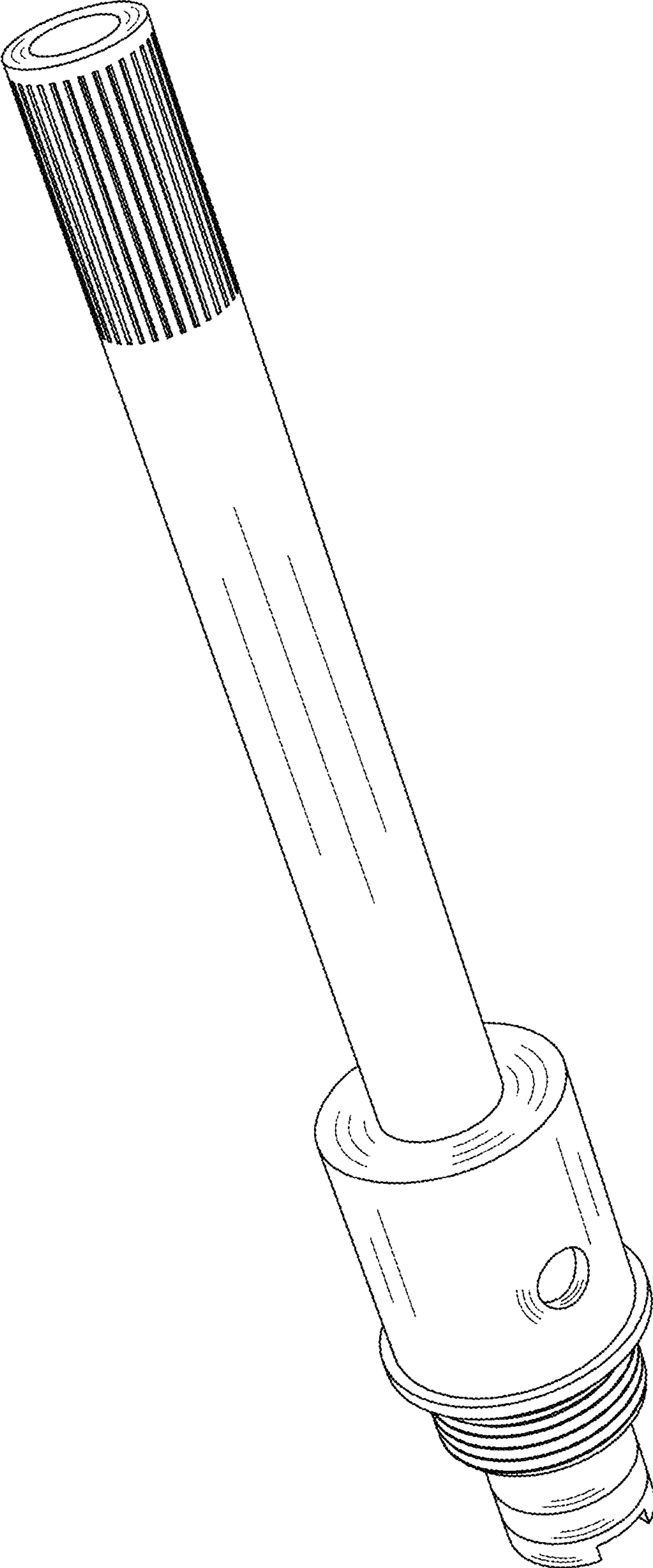

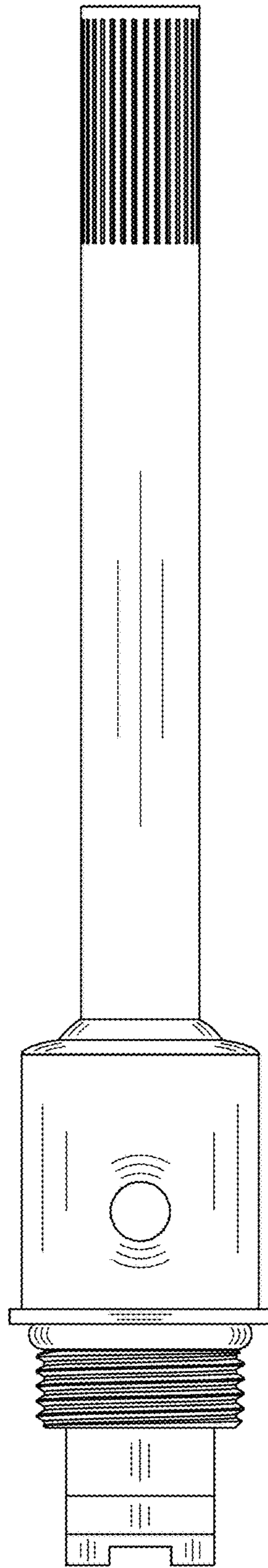

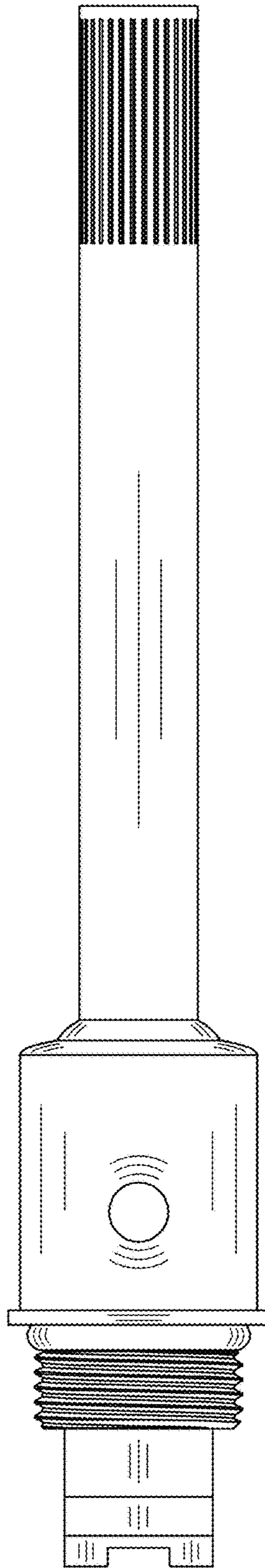

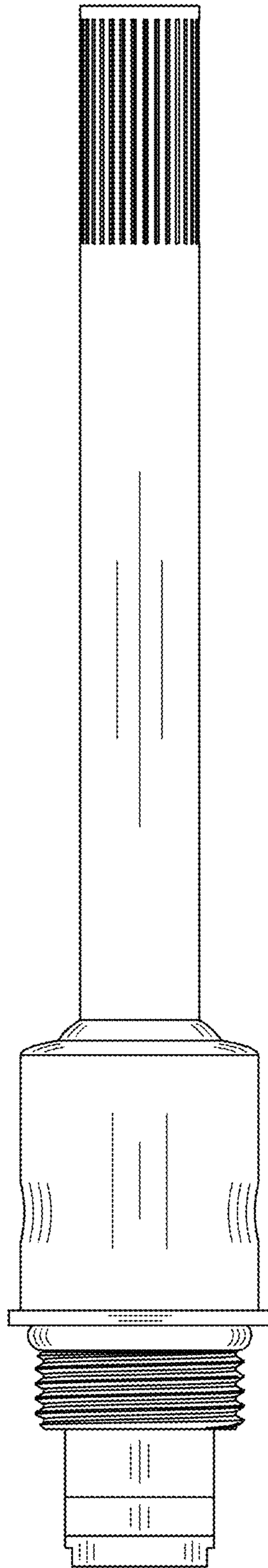

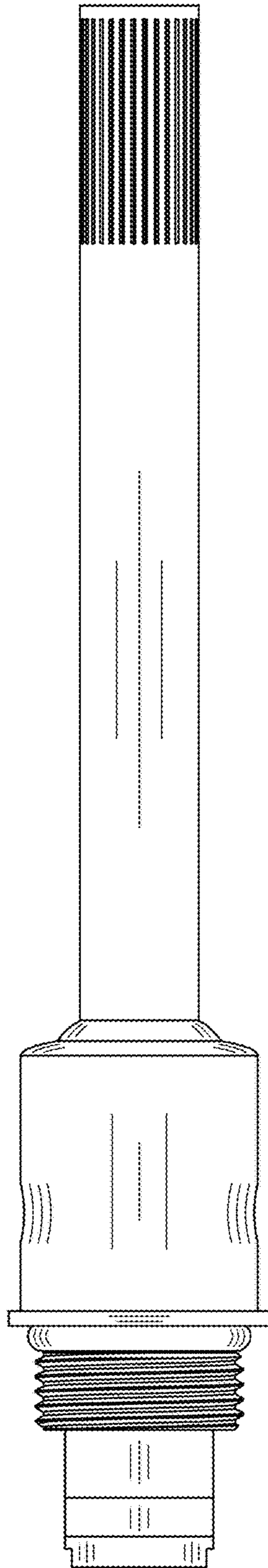

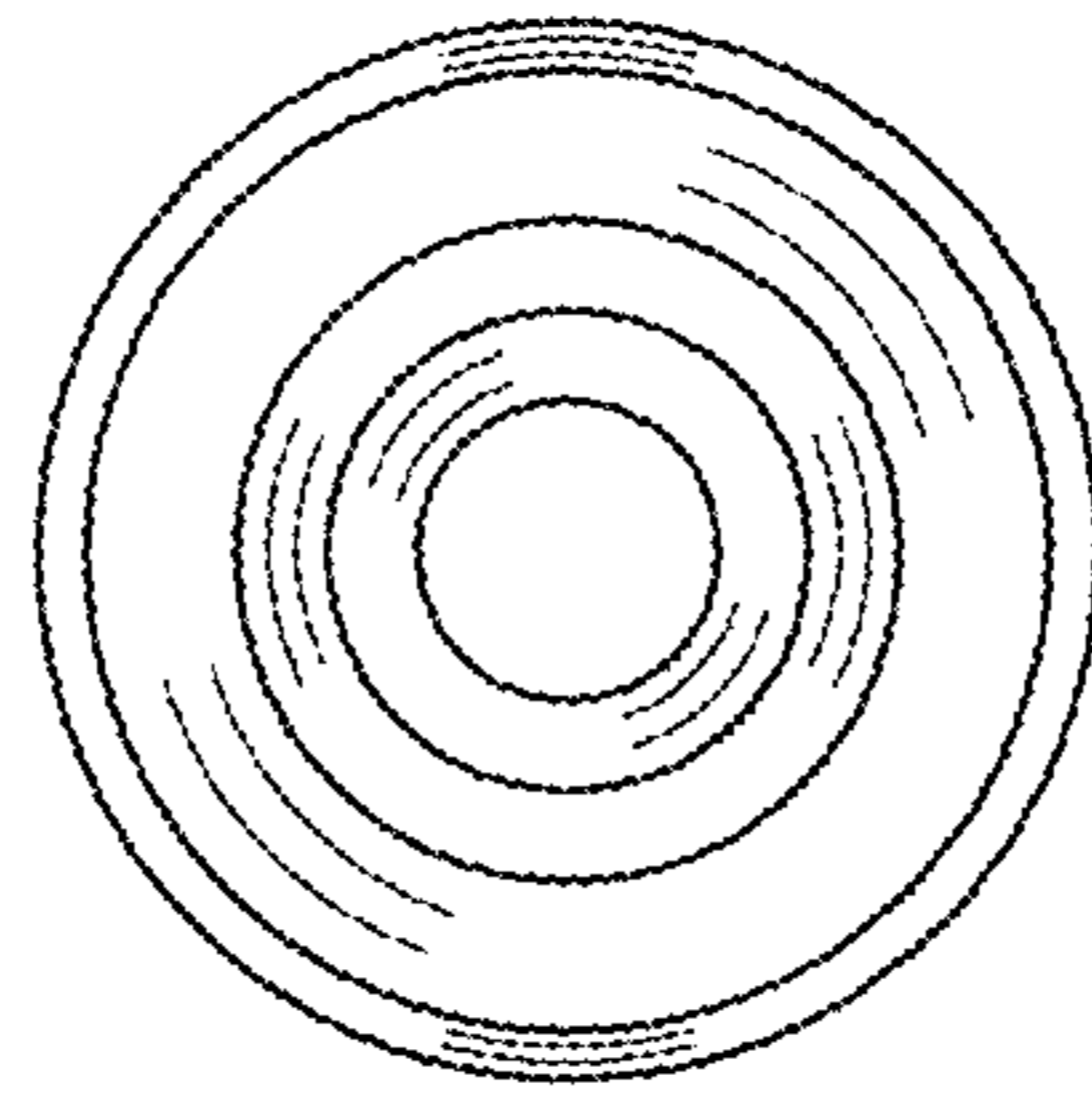

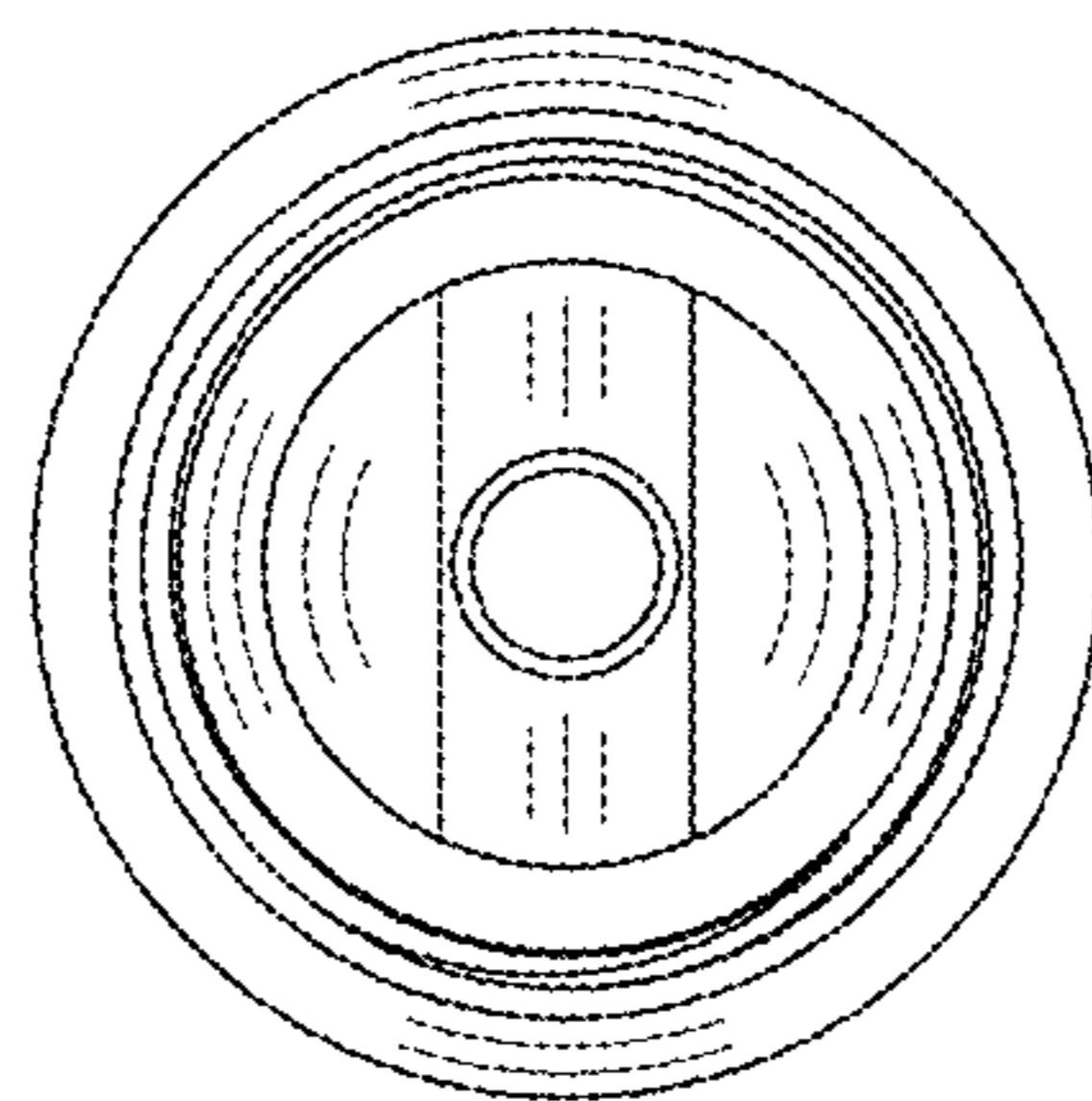

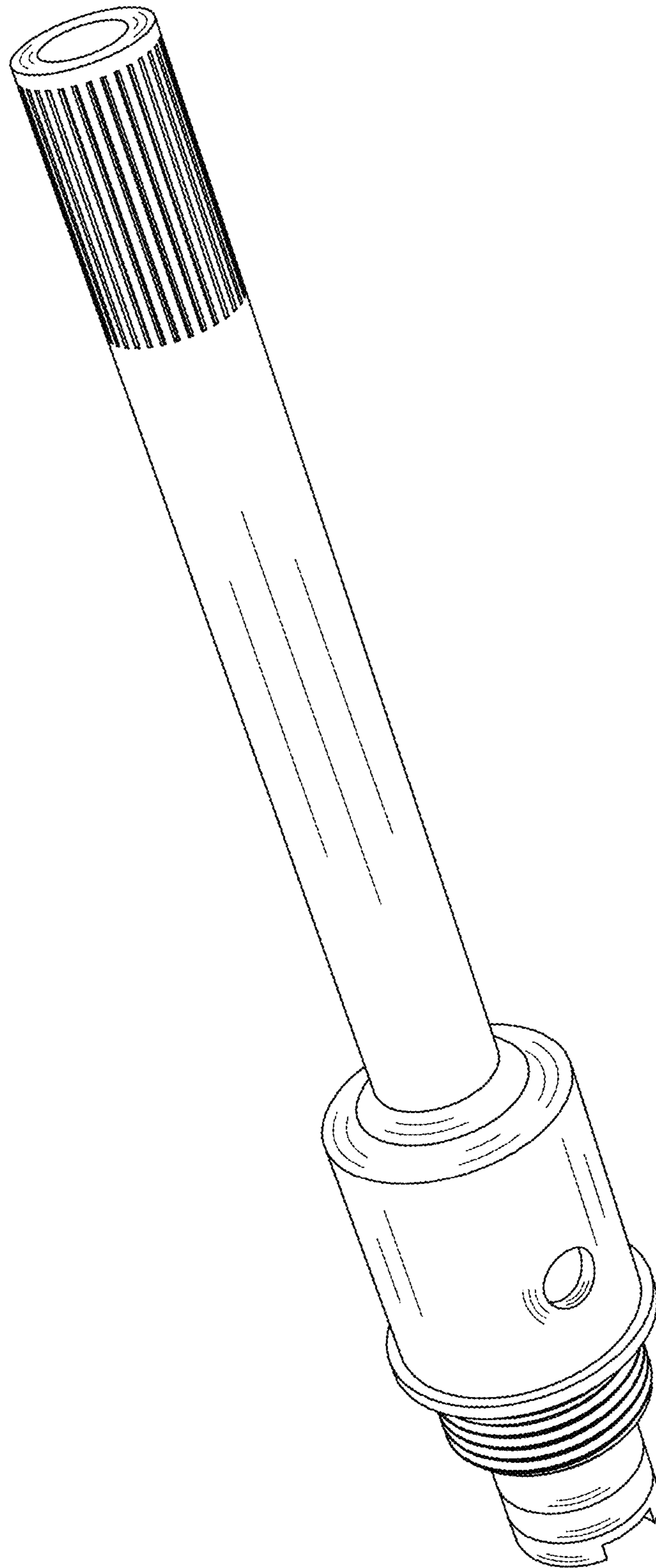

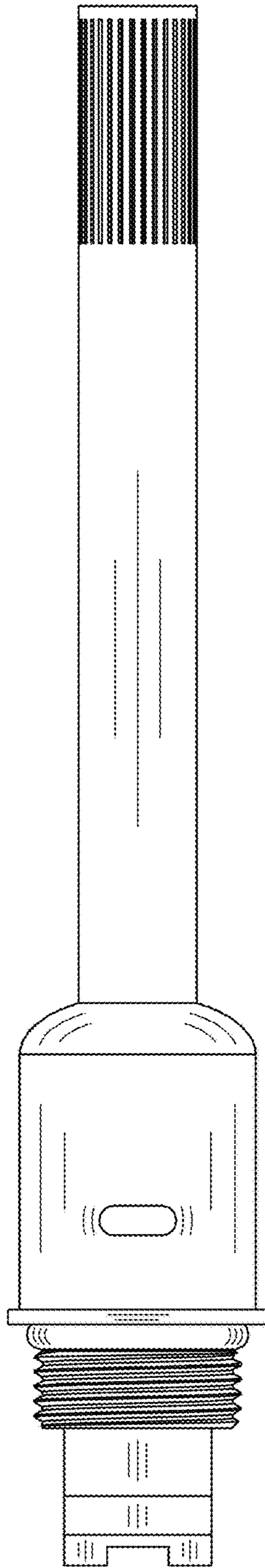

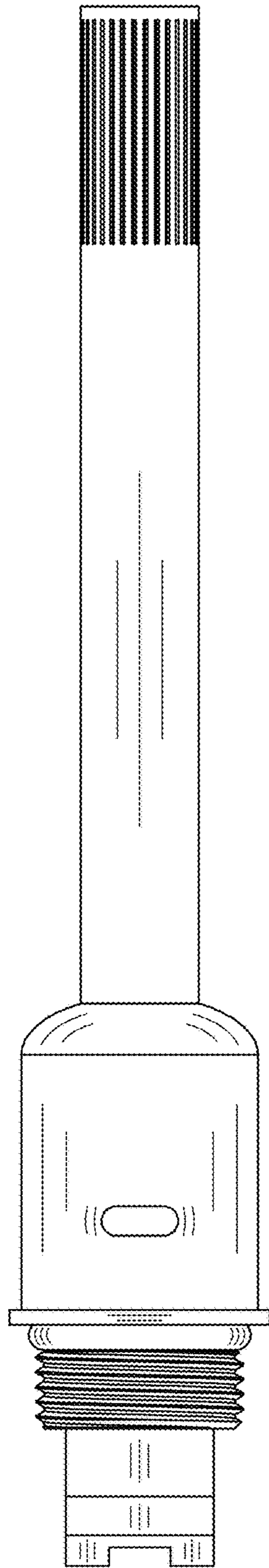

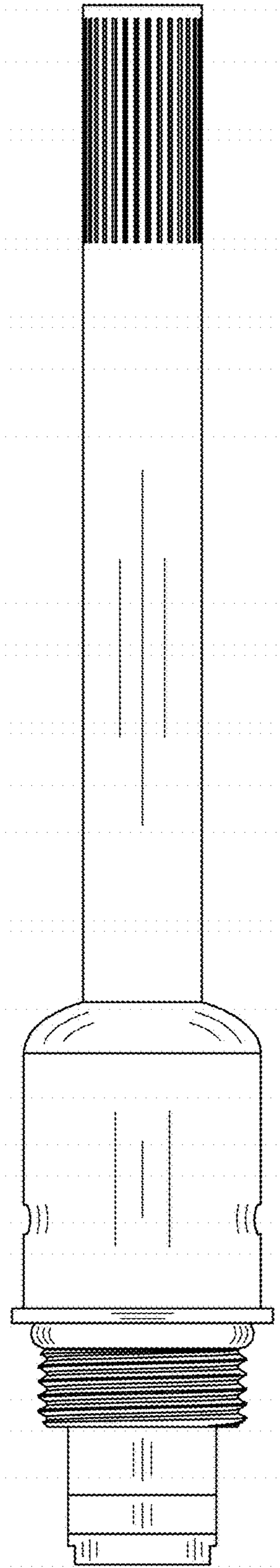

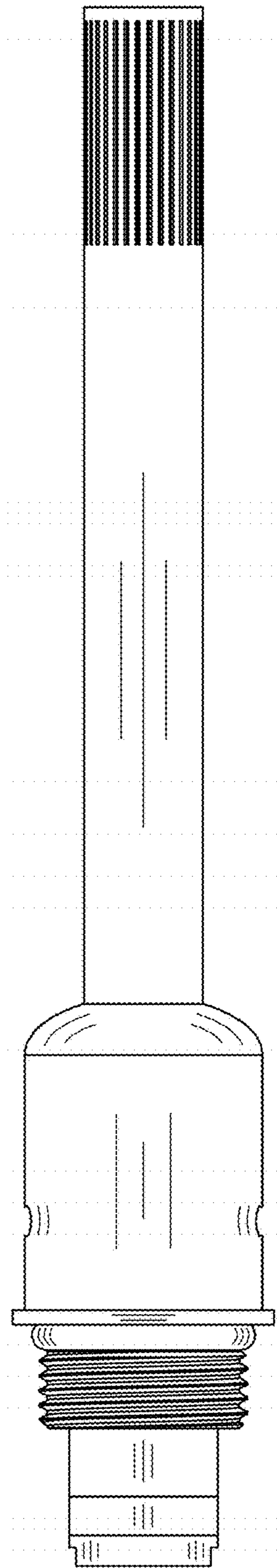

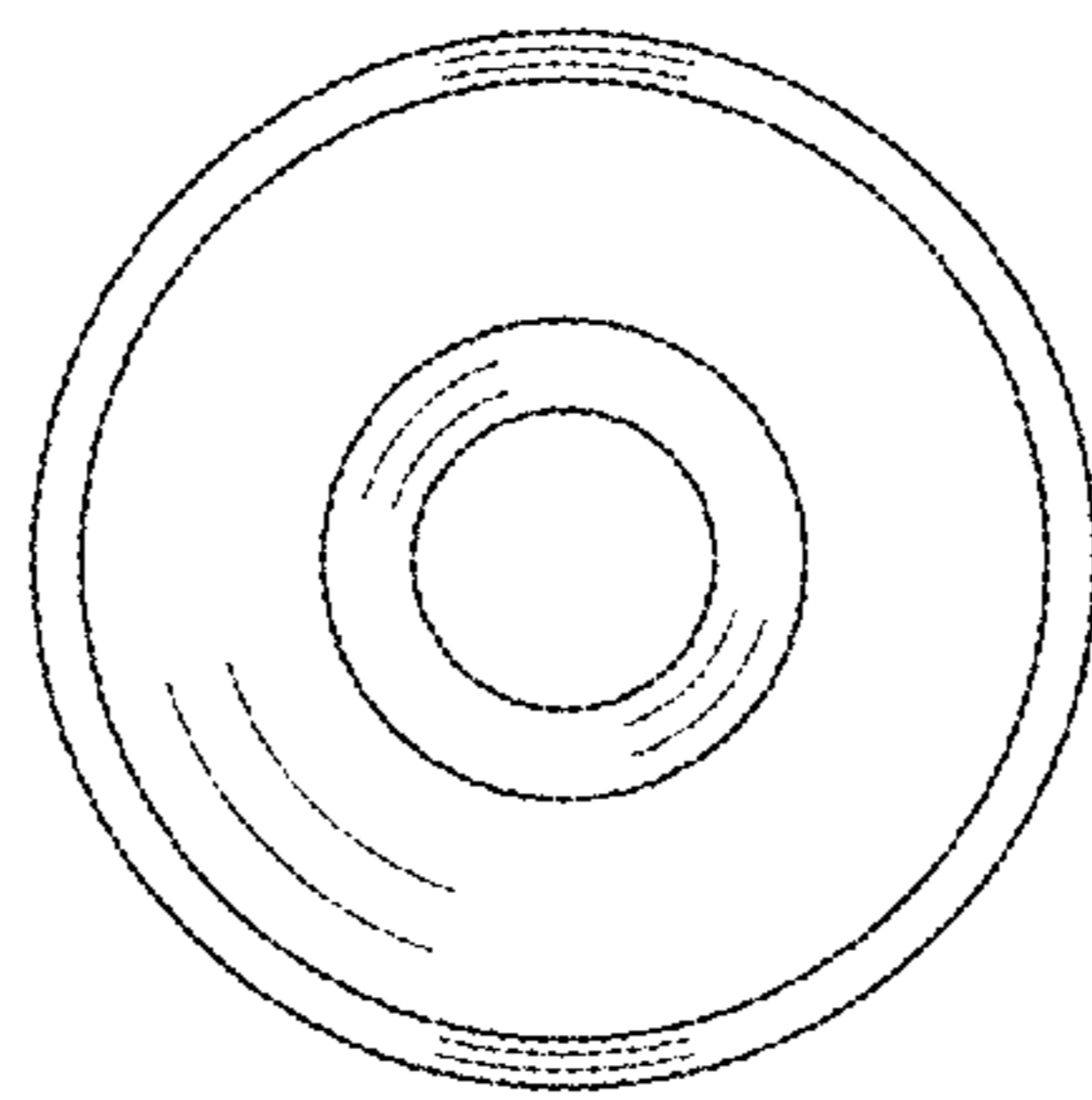

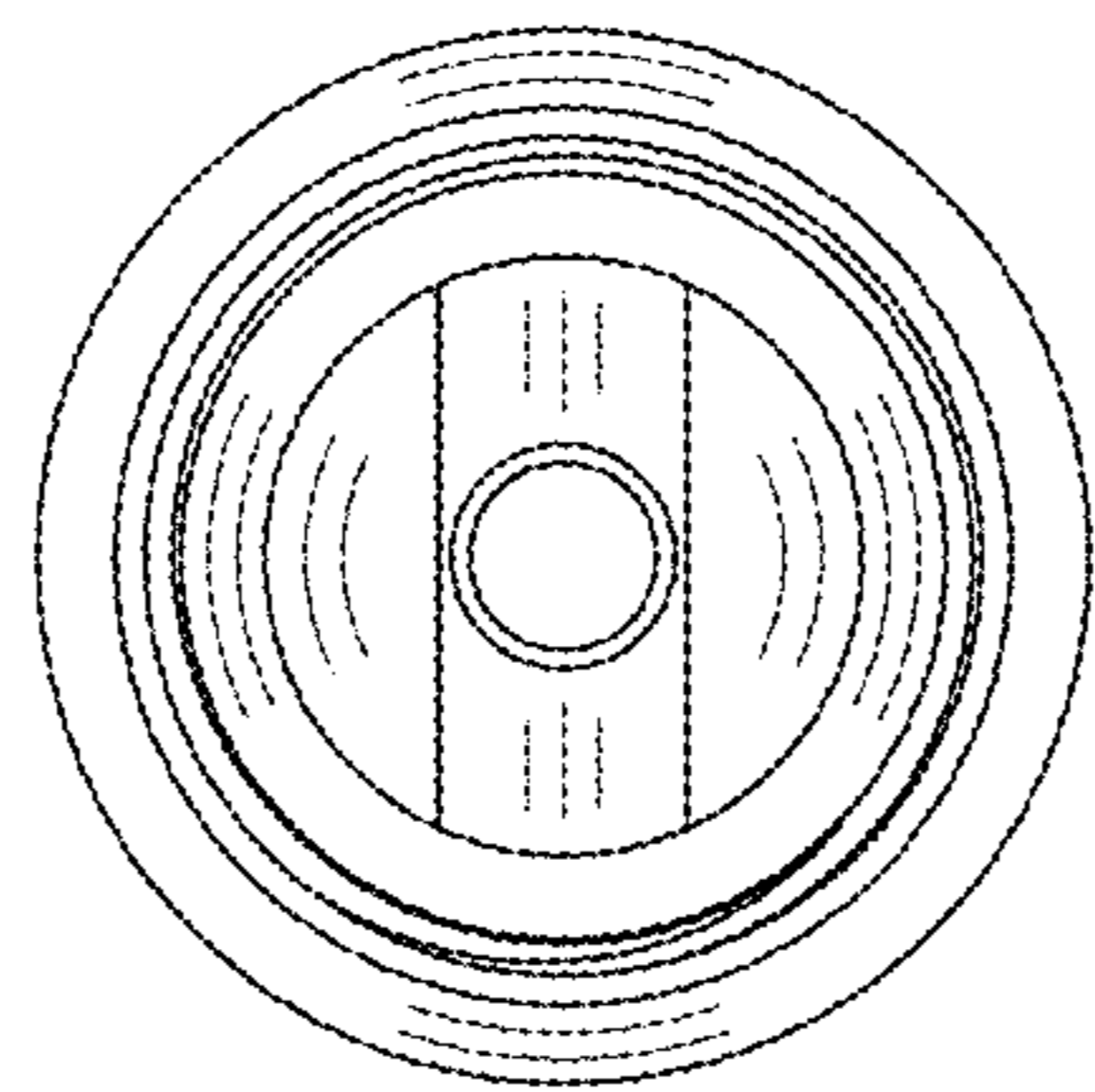

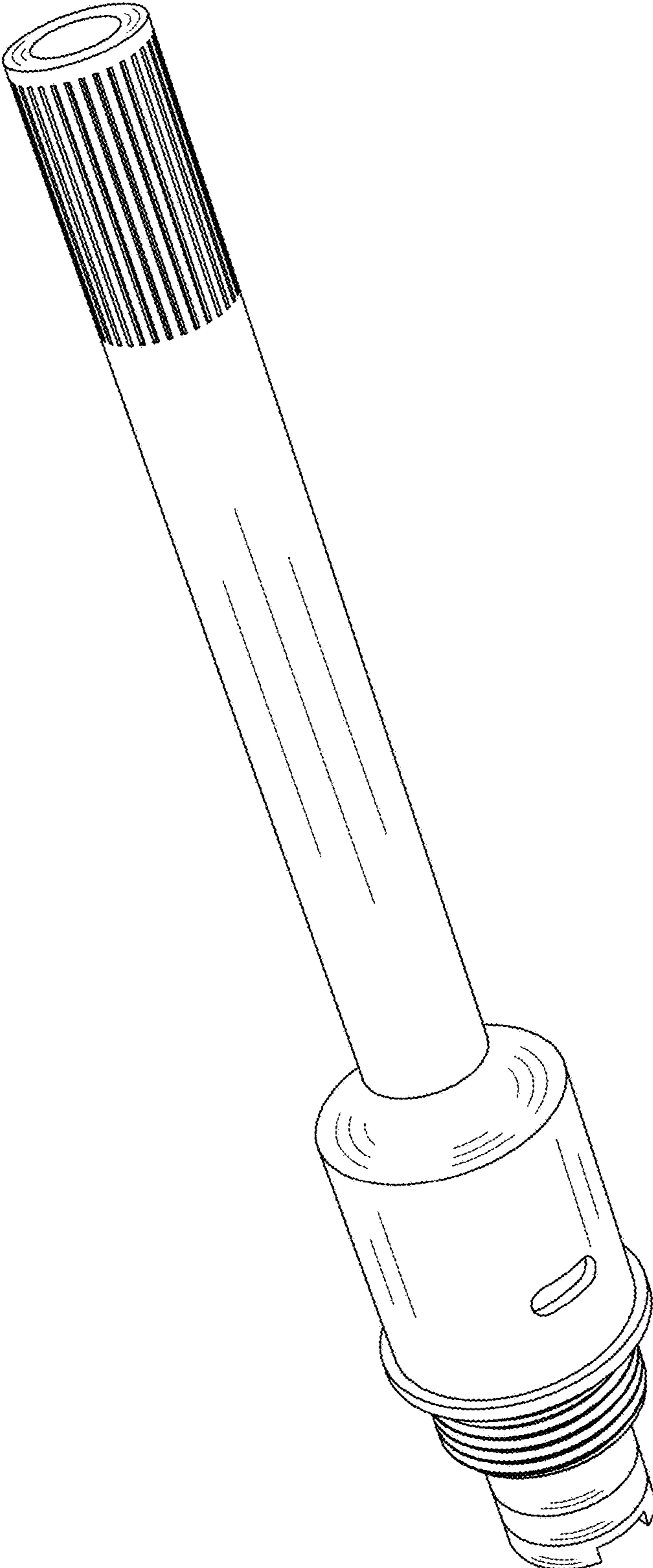
