FIG. 7 is a bottom view.

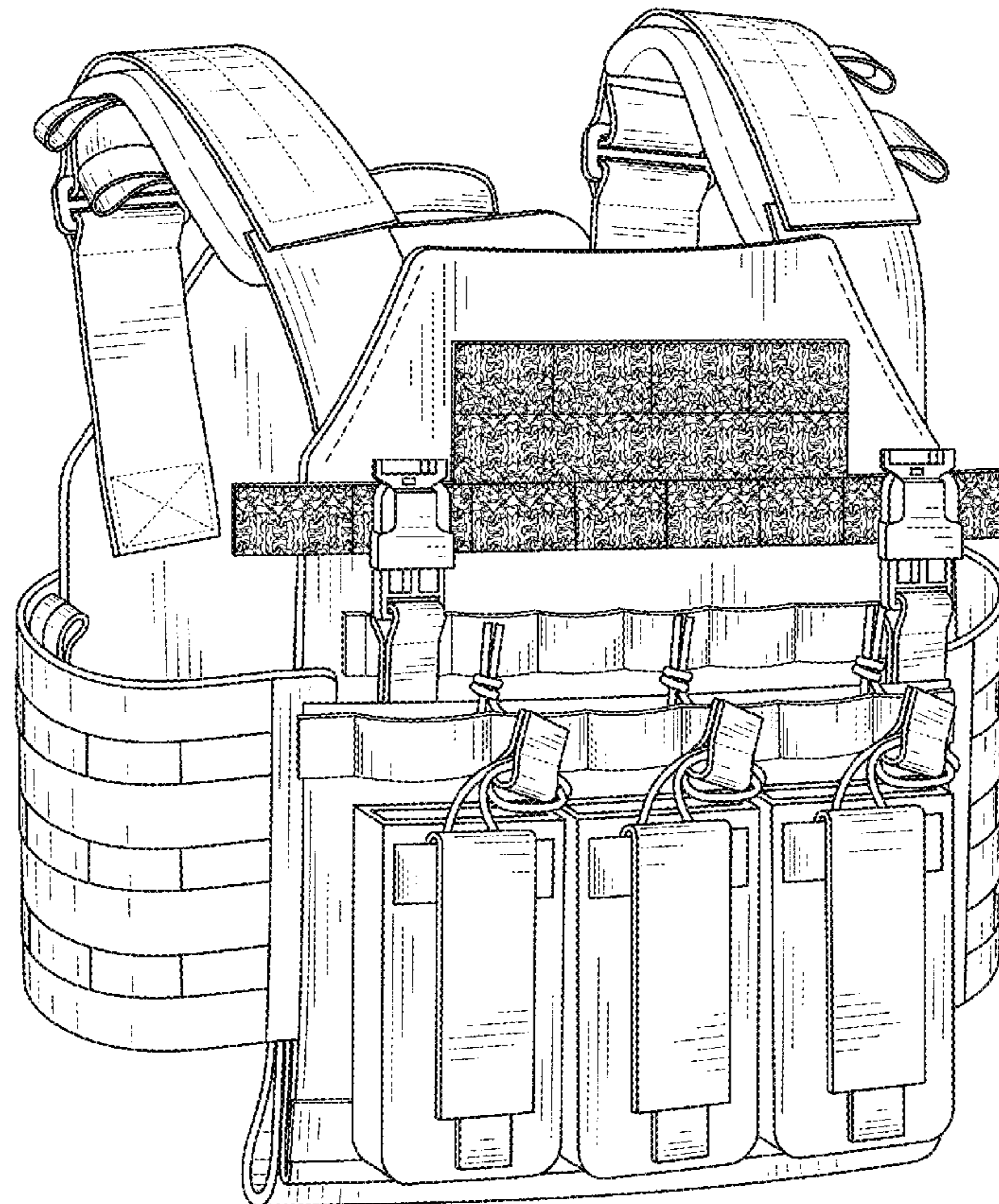

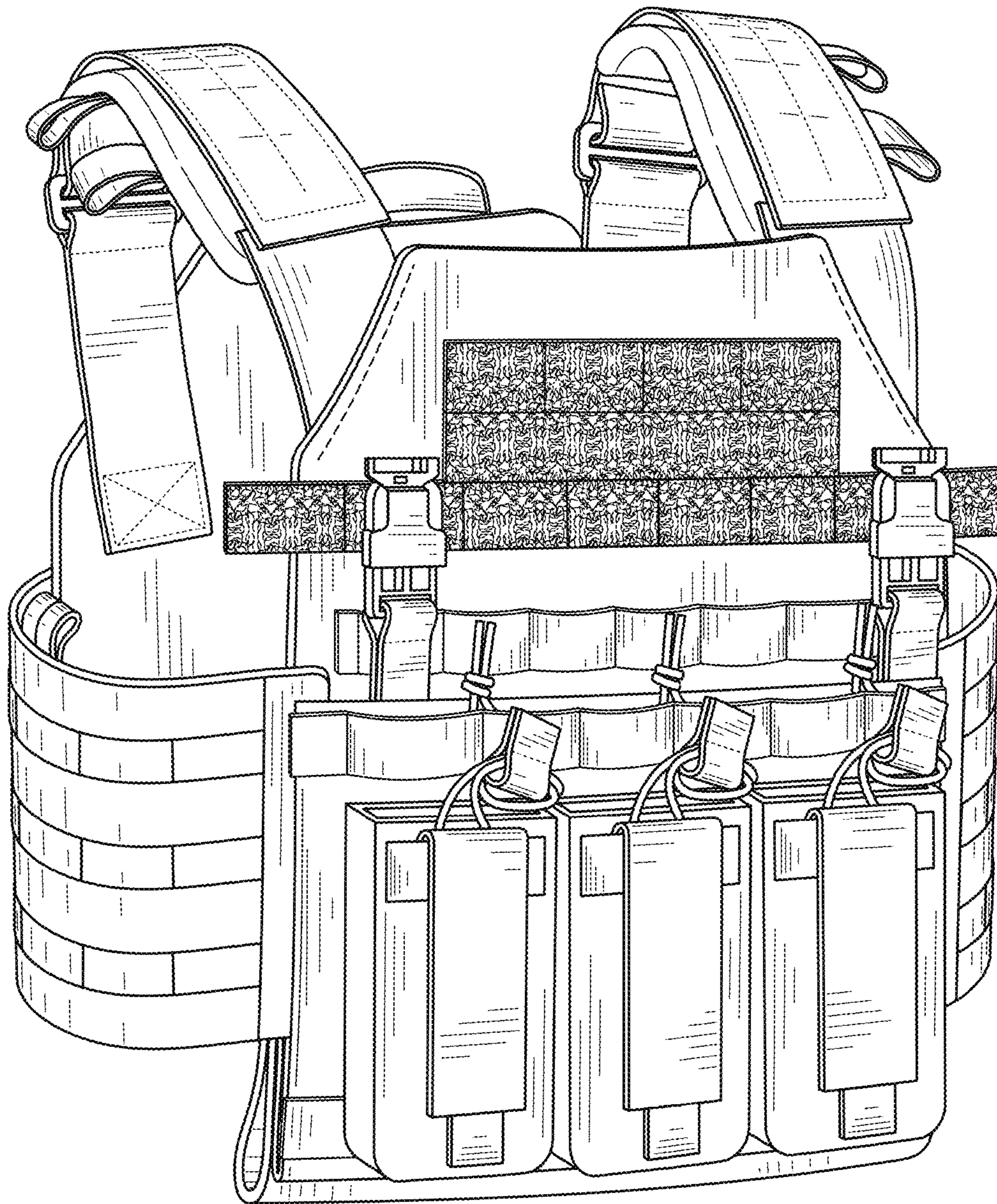

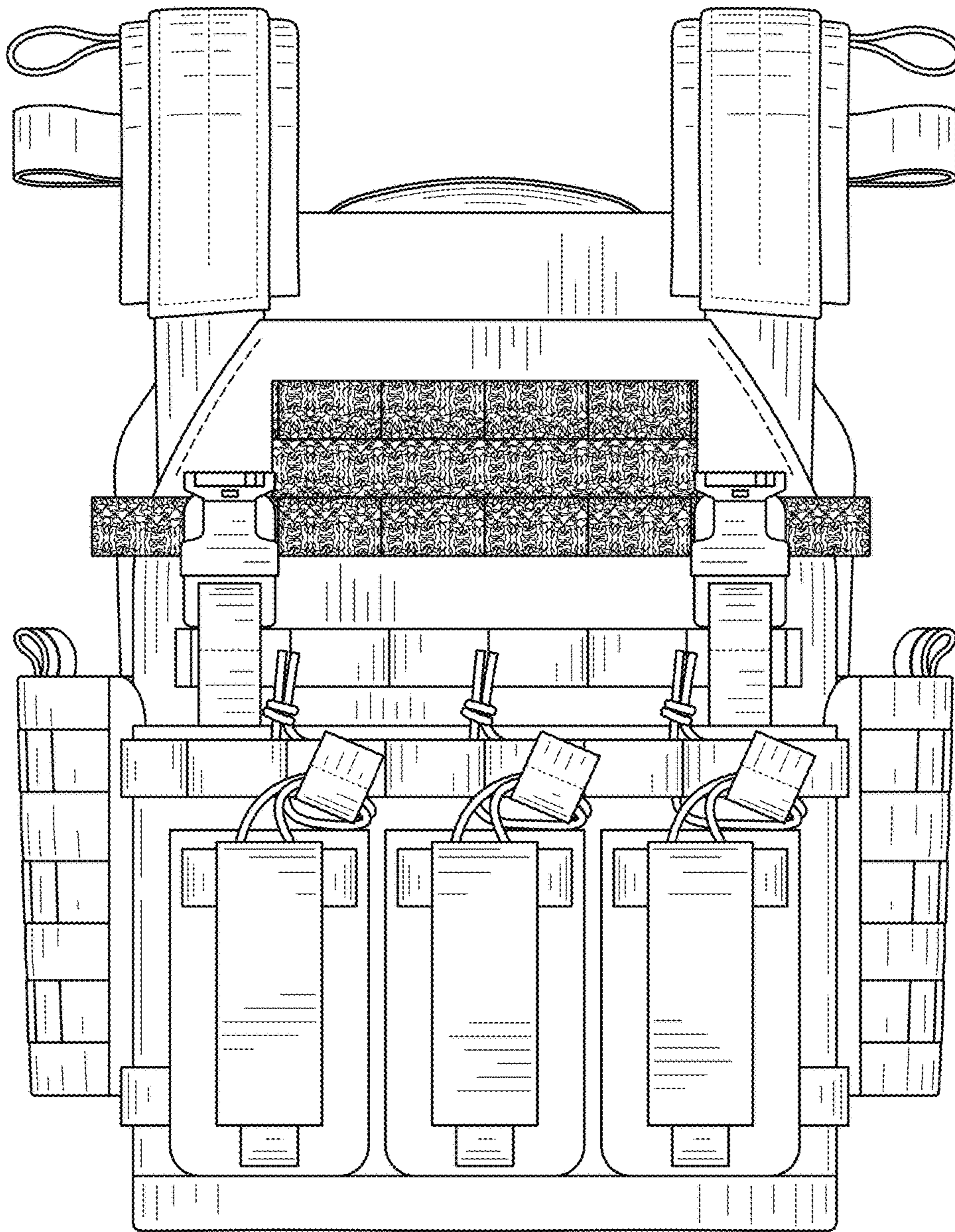

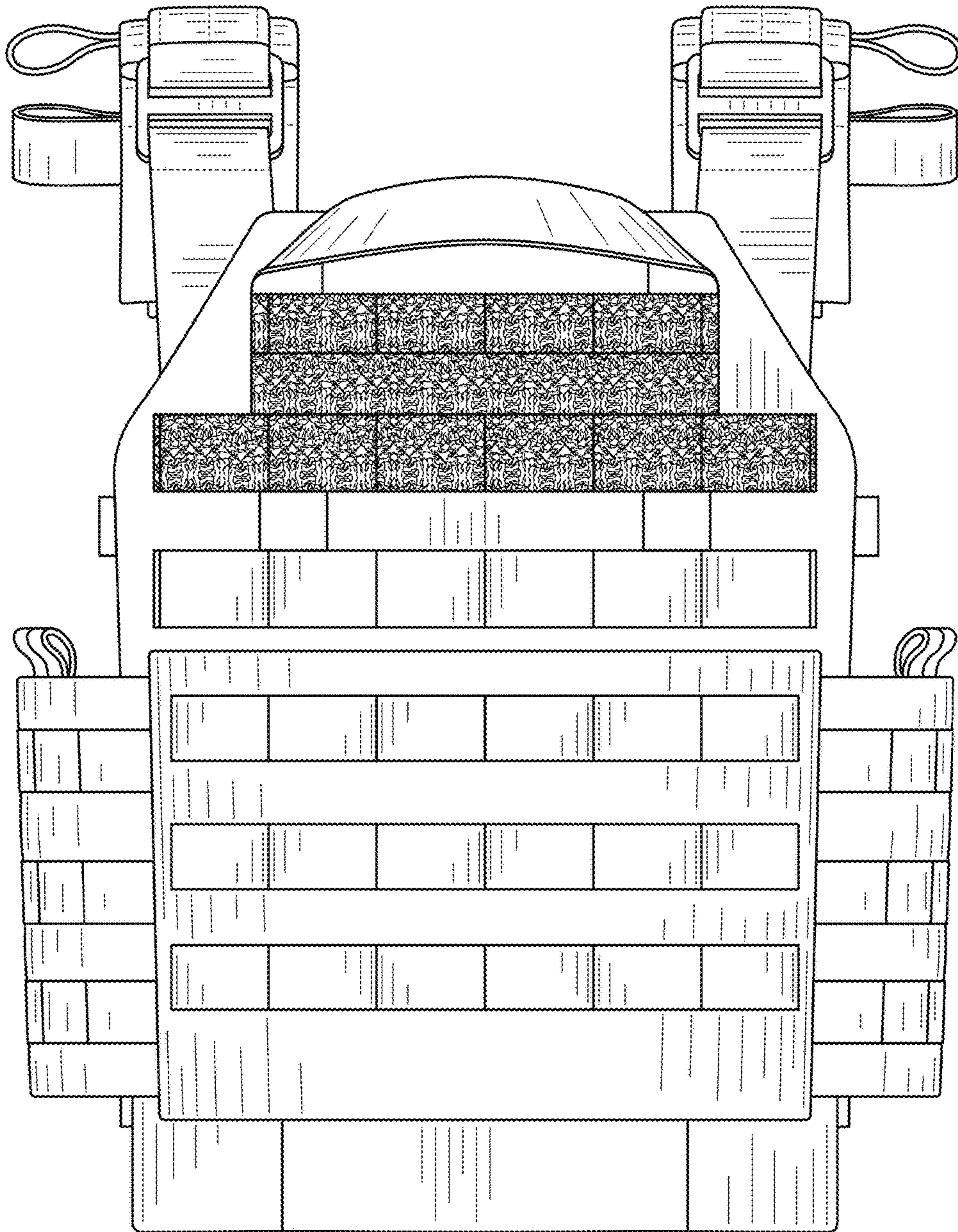

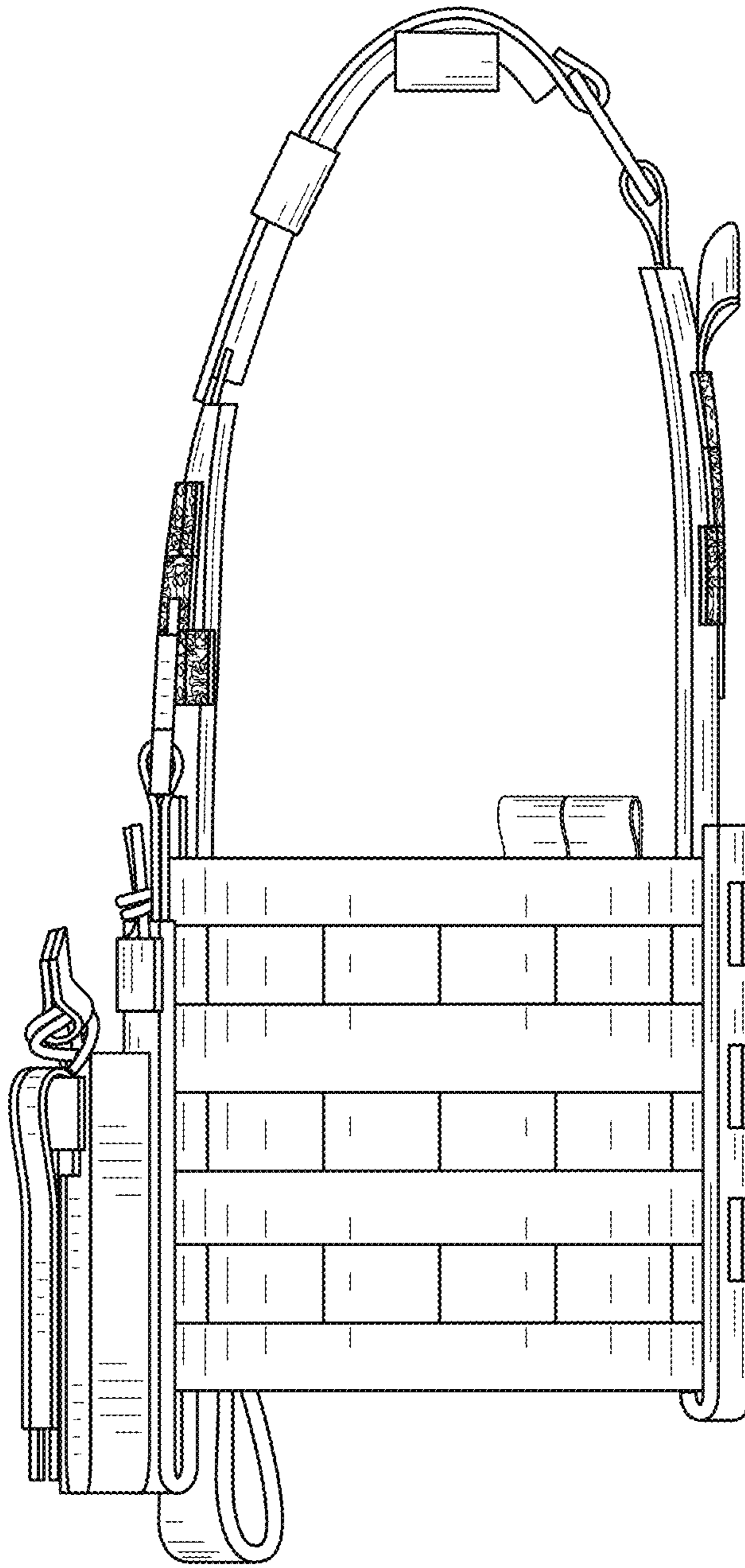

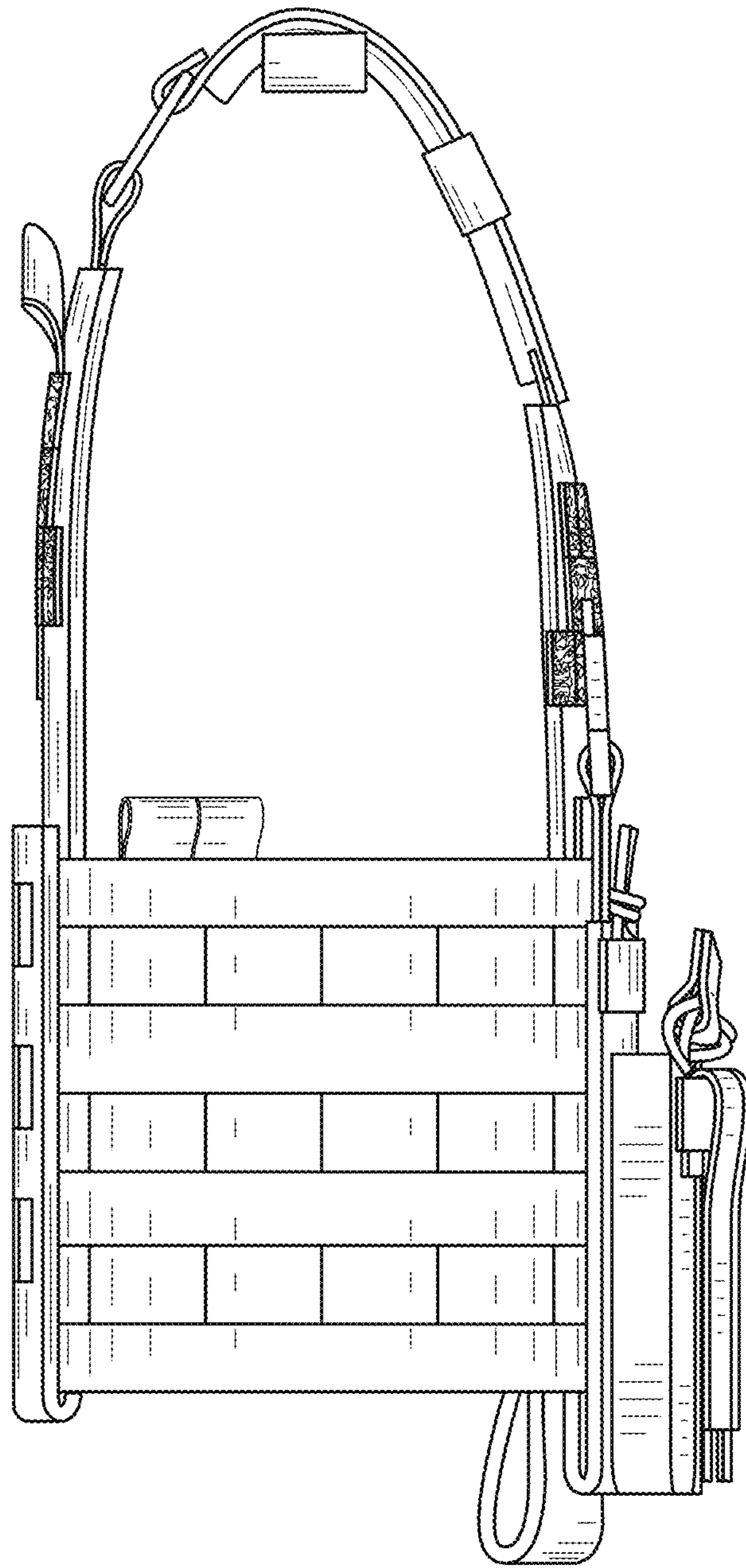

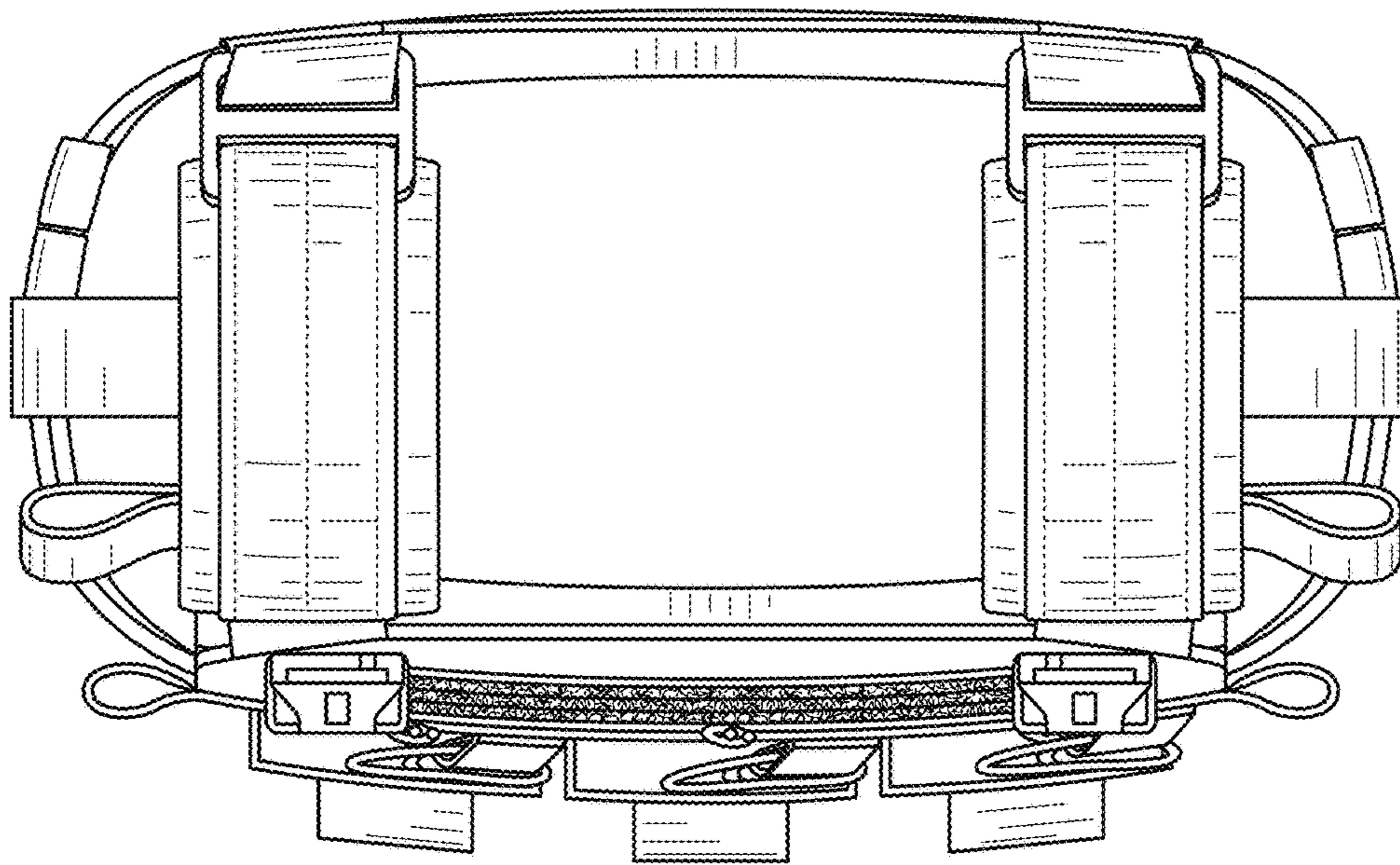

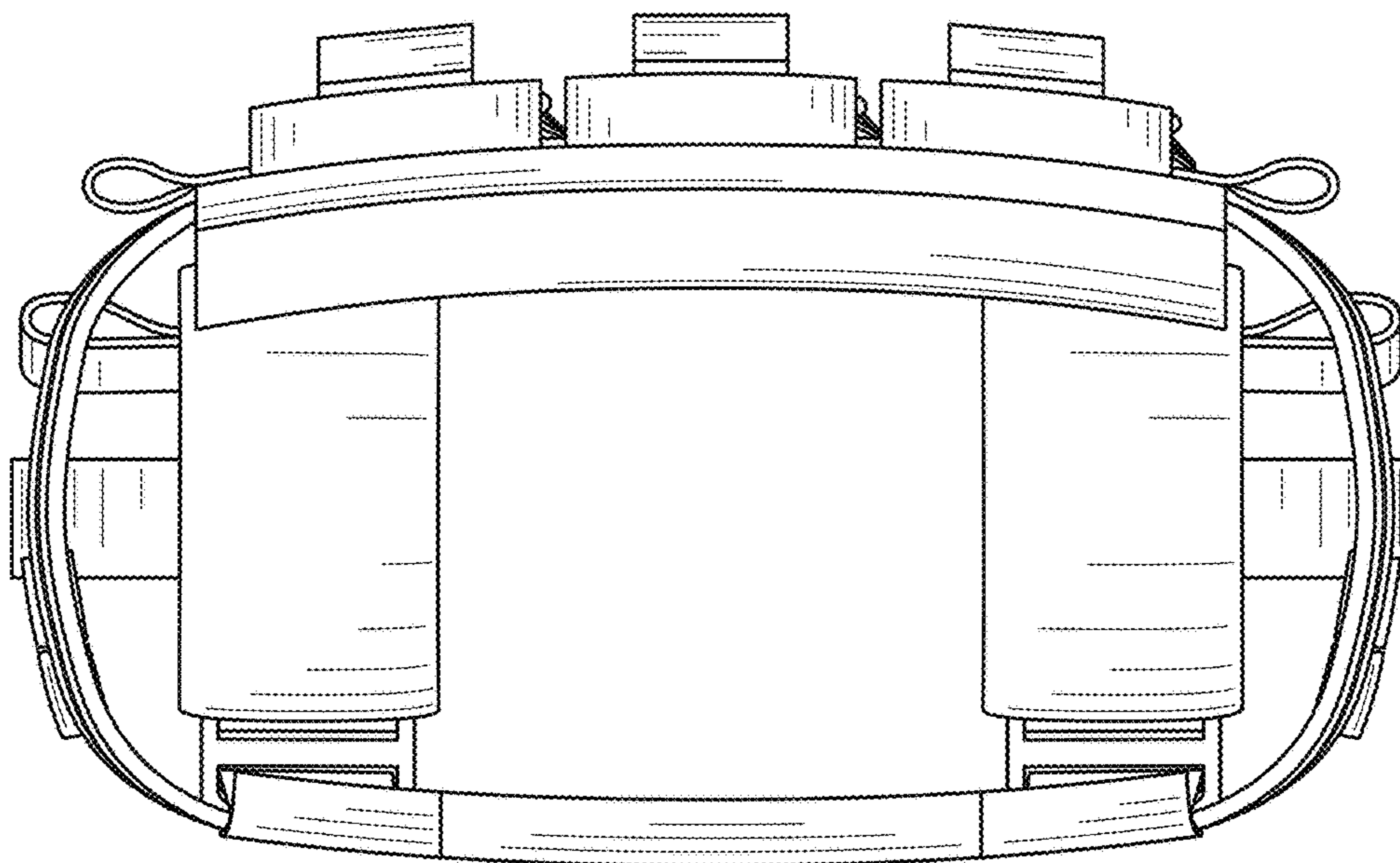
