**DESCRIPTION**

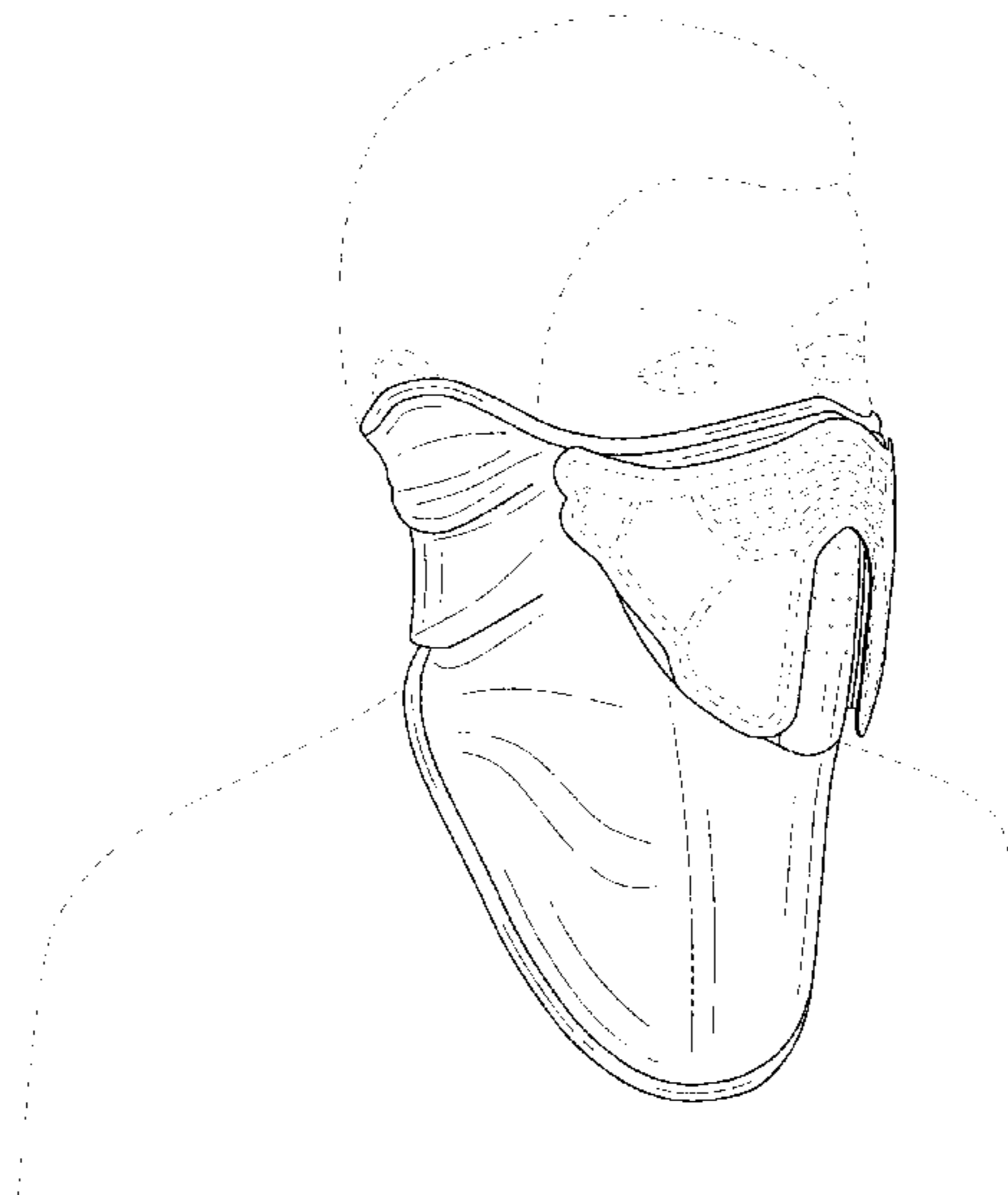
FIG. 1 is a front, left perspective view of a light up face mask showing my new design;

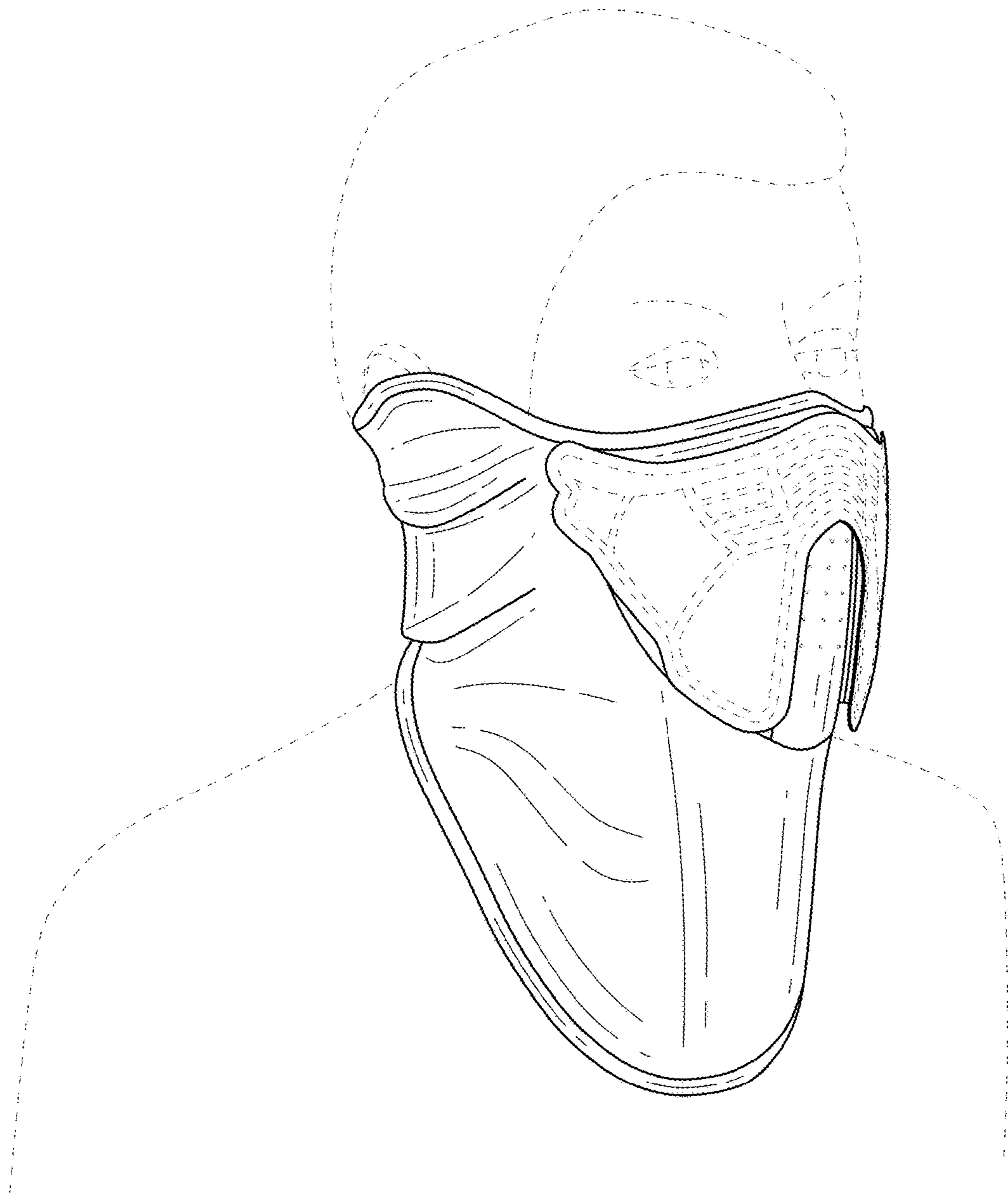

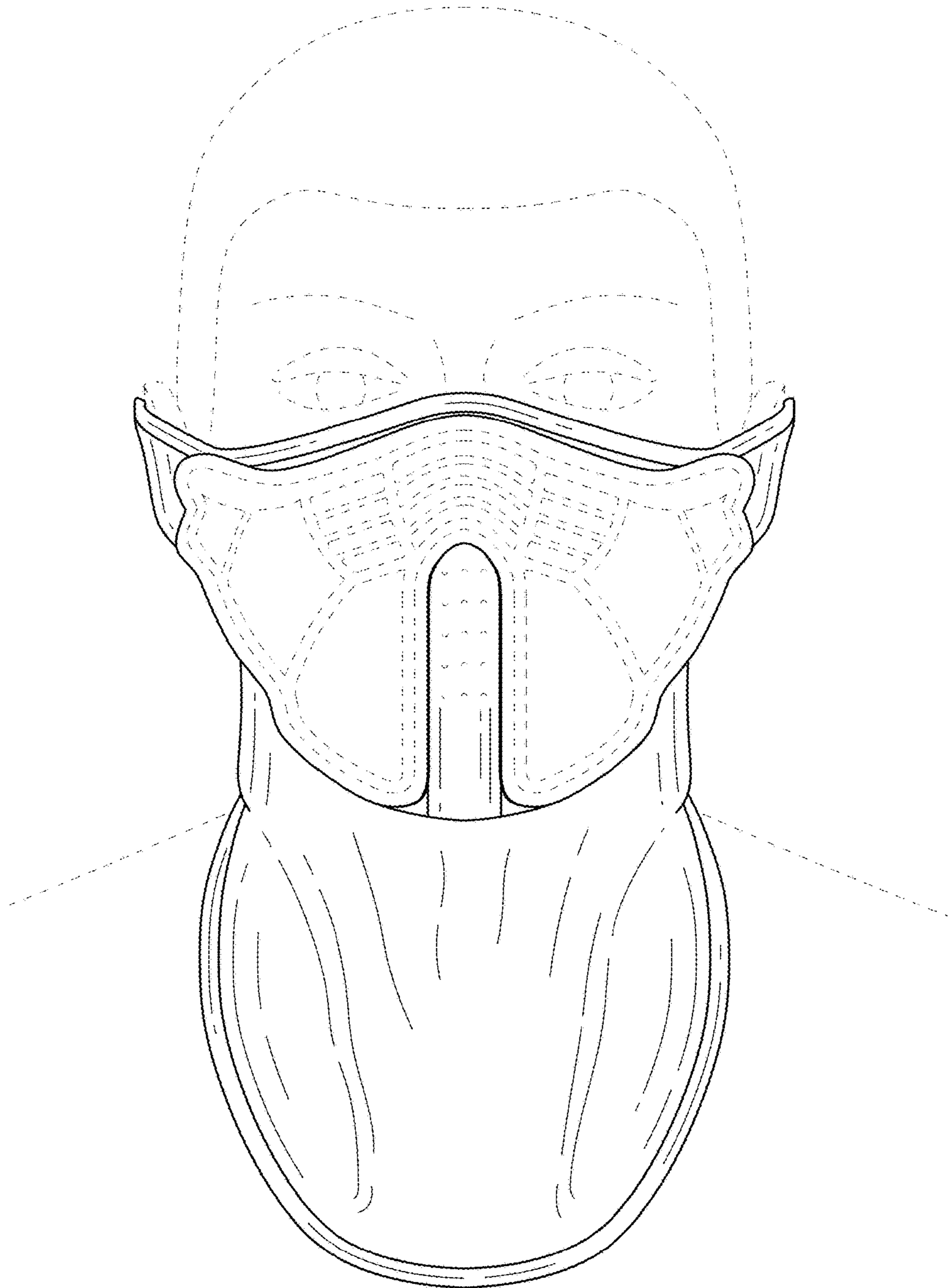

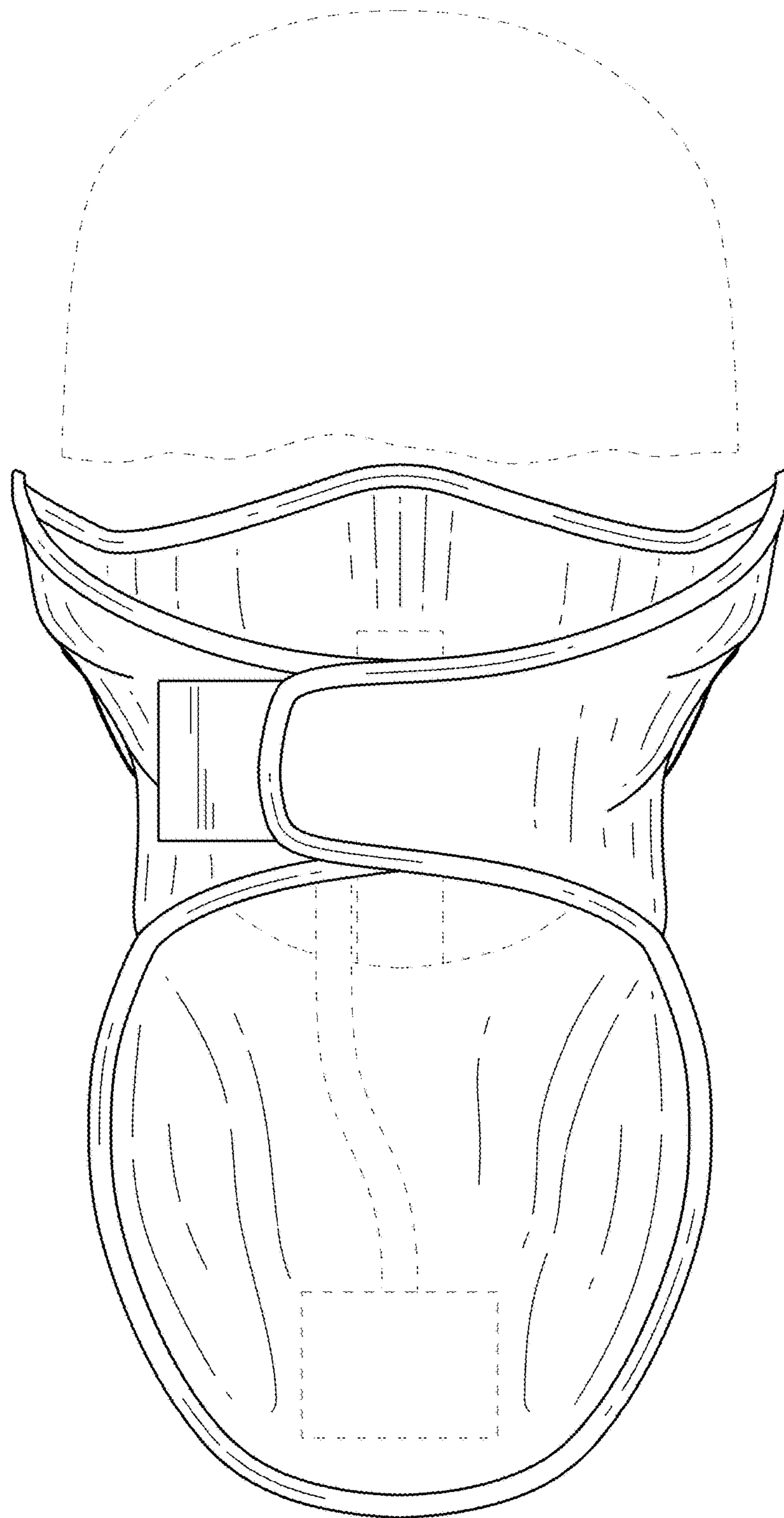

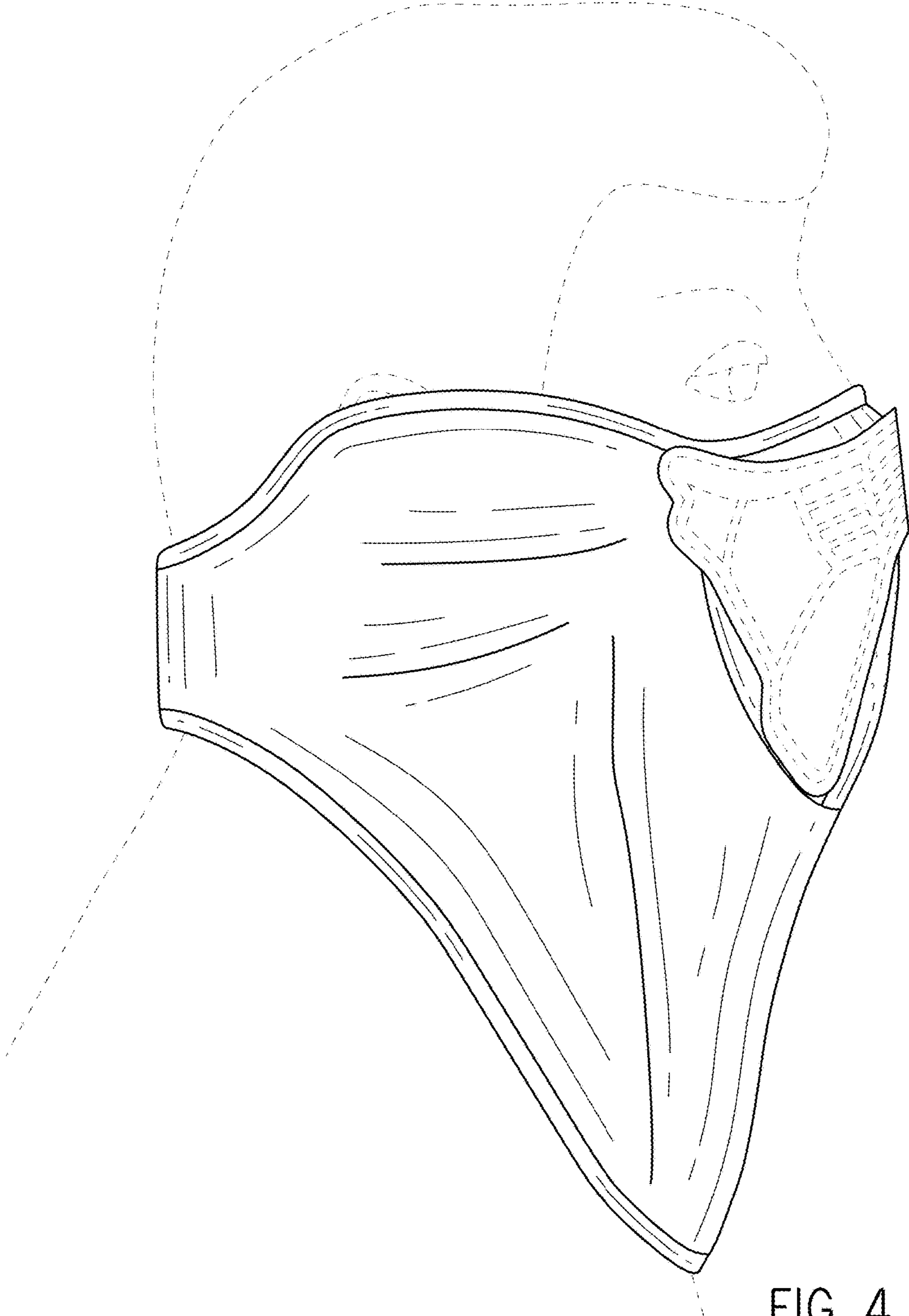

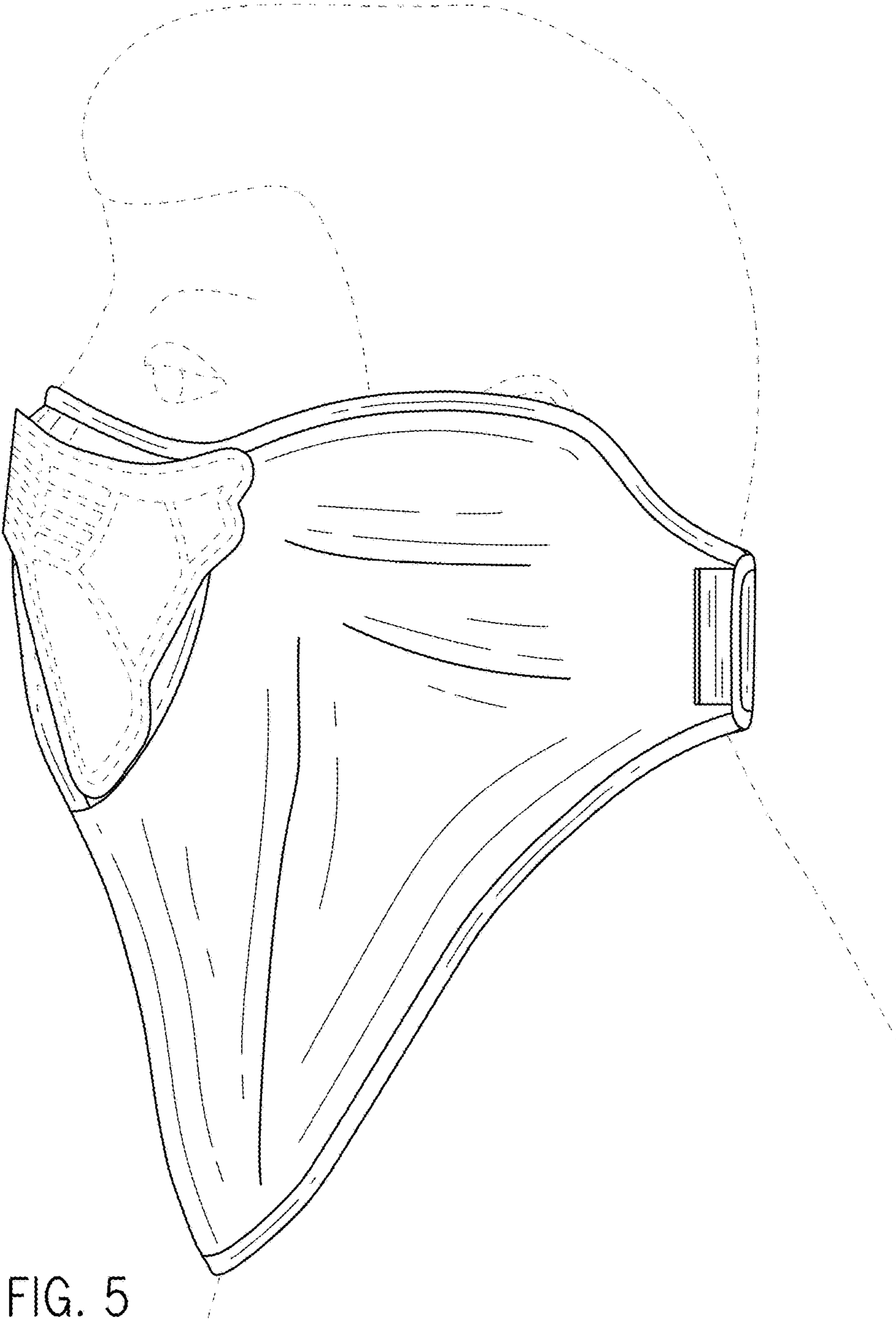

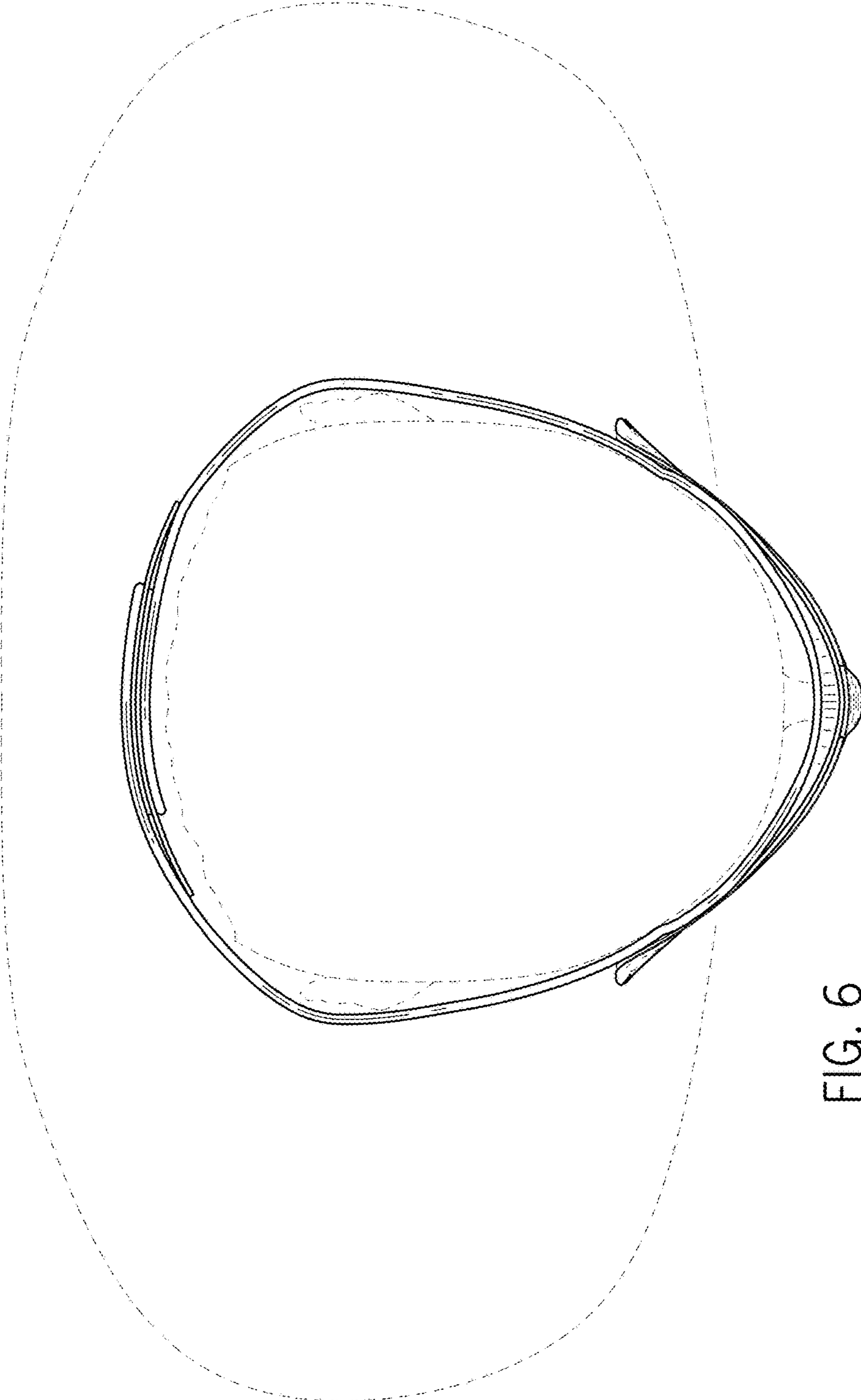

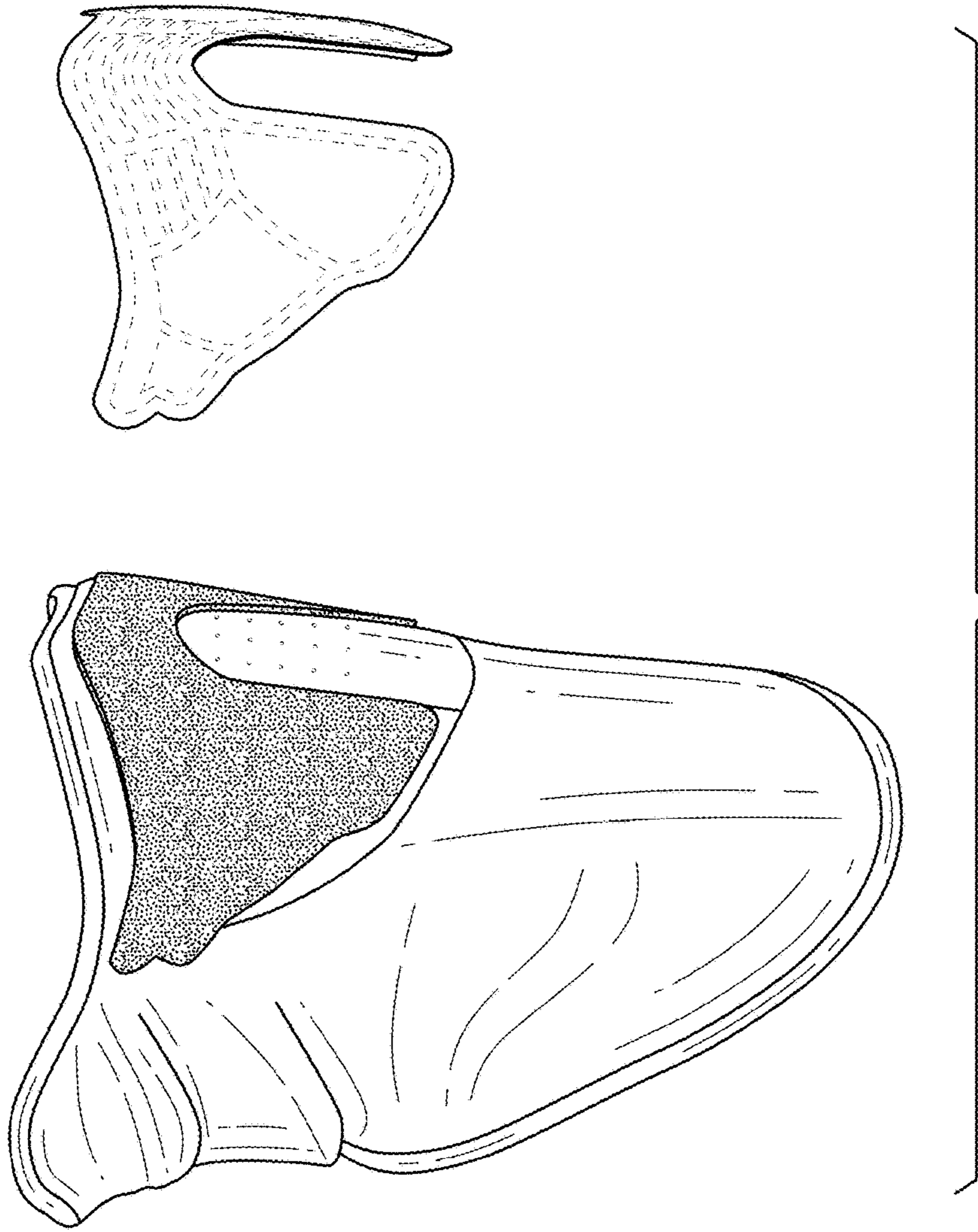
