FIG. 15 is a left side plan view thereof;

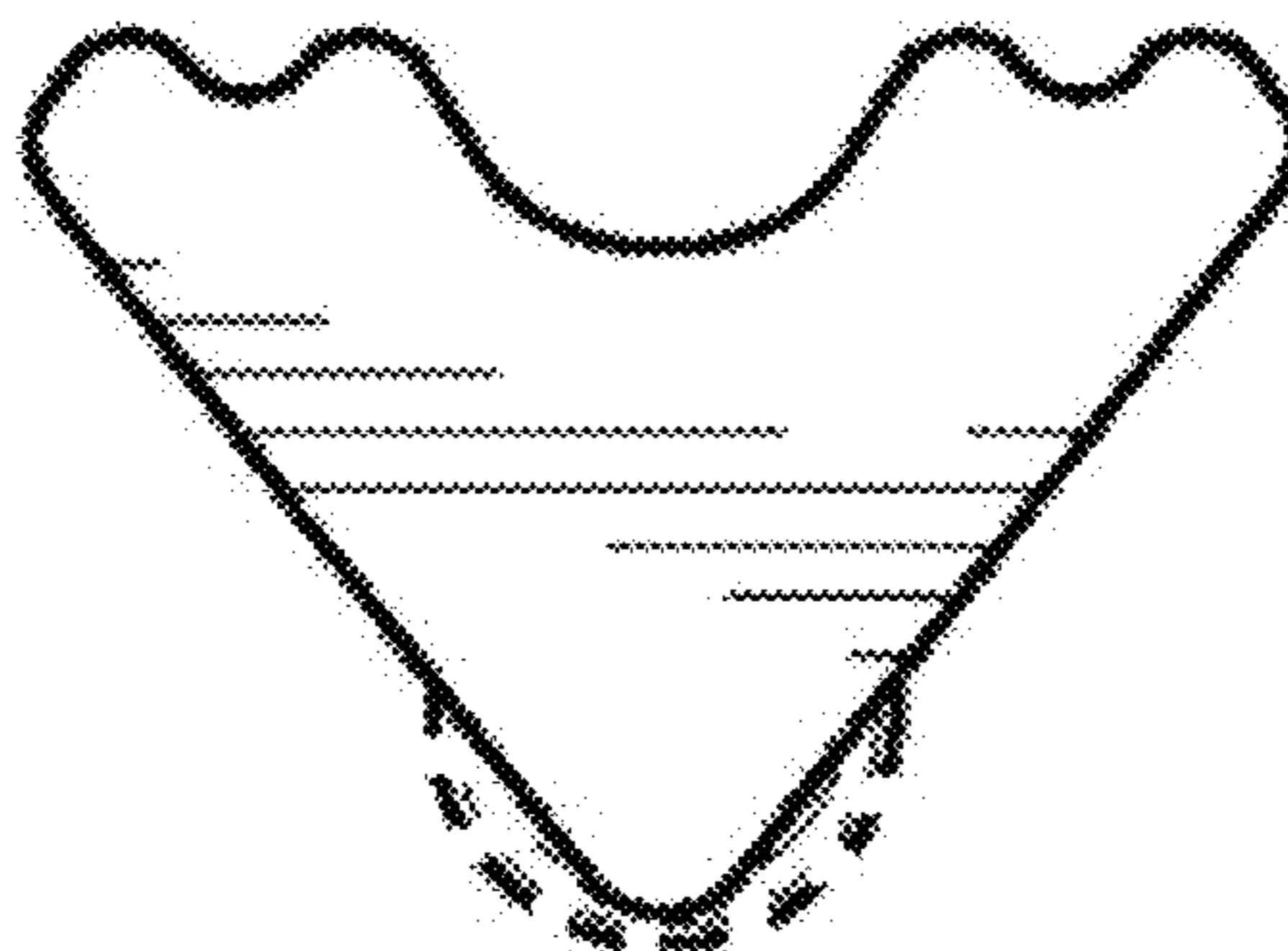
FIG. 16 is a right side plan view thereof;

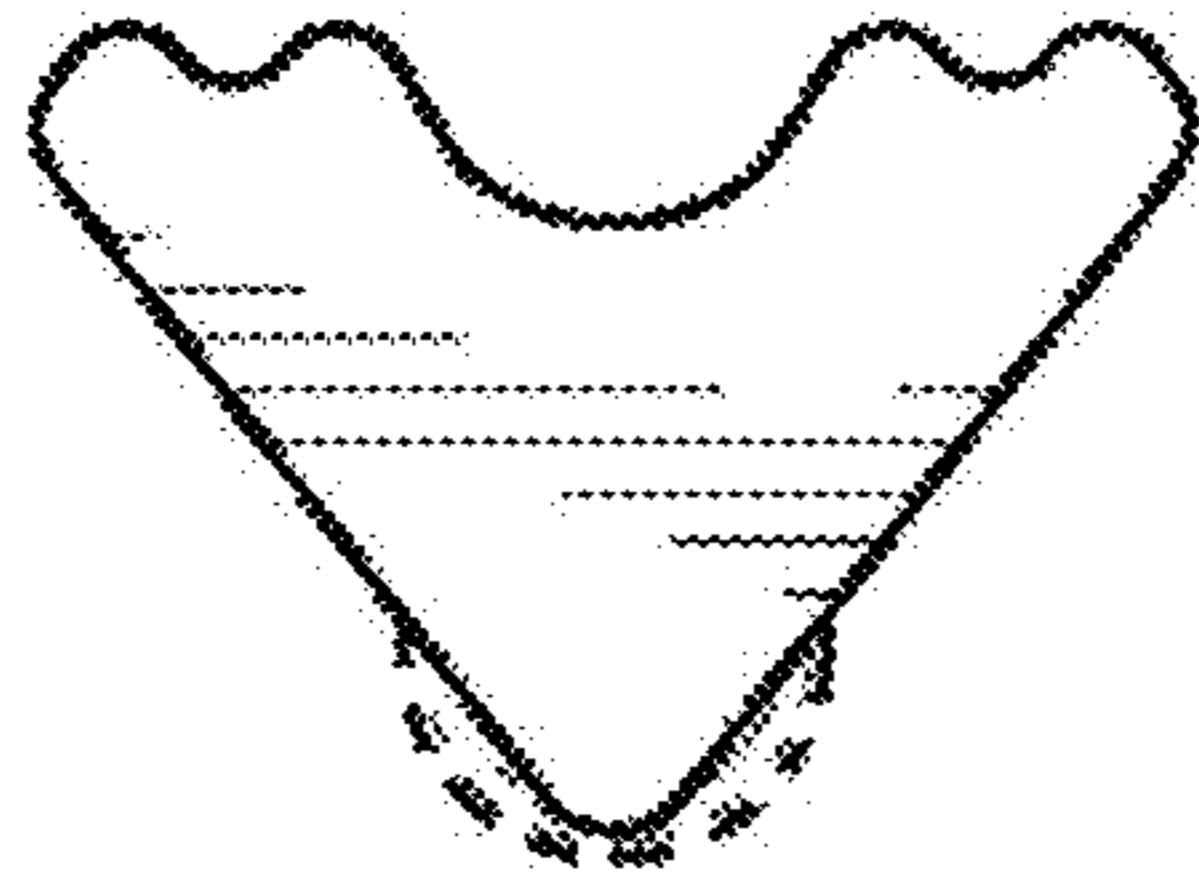
FIG. 17 is a top plan view thereof; and,

FIG. 18 is a bottom plan view thereof.

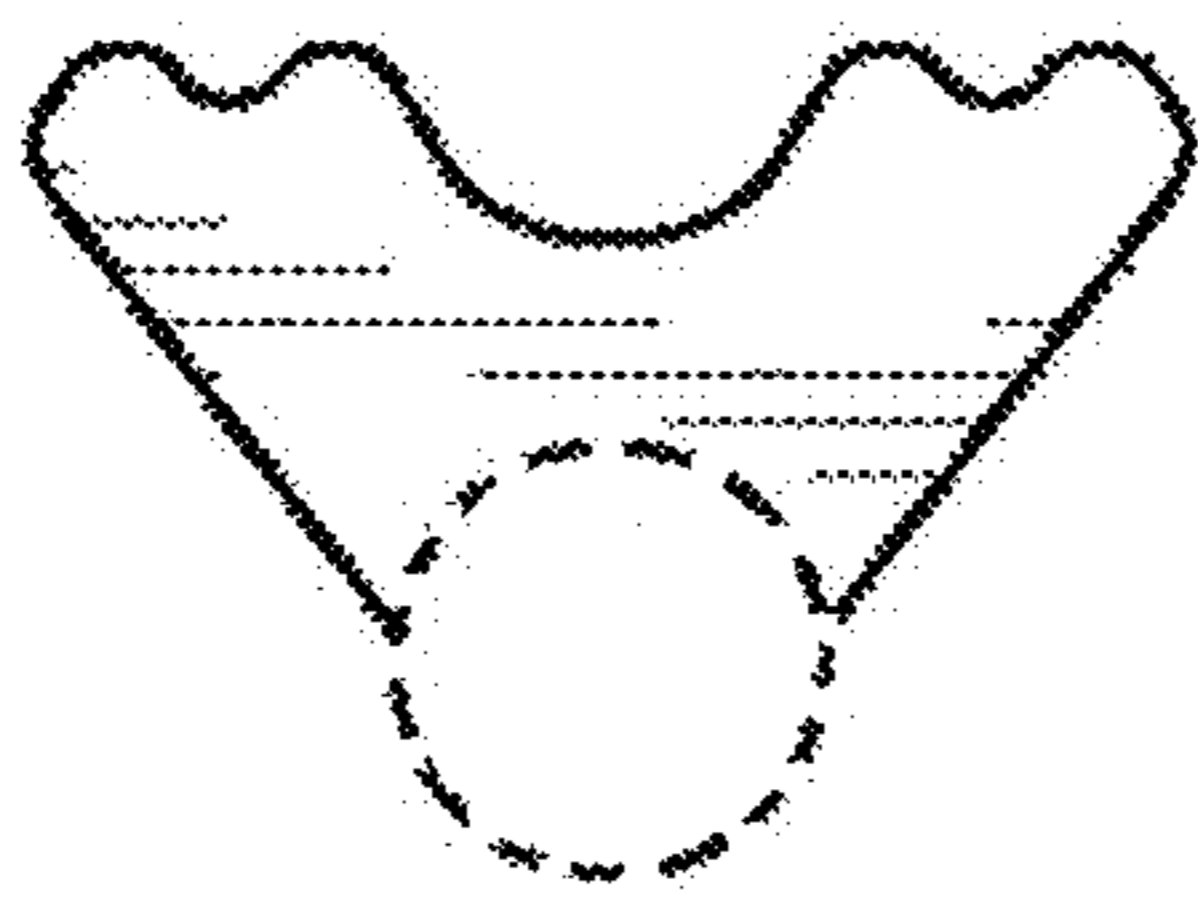
The broken lines in a drawing depict portions of the cleaning tool that form no part of the claimed design.

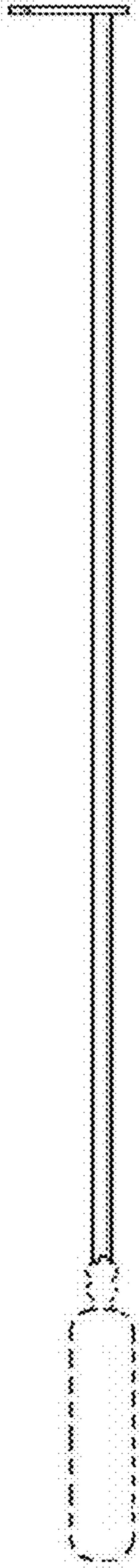




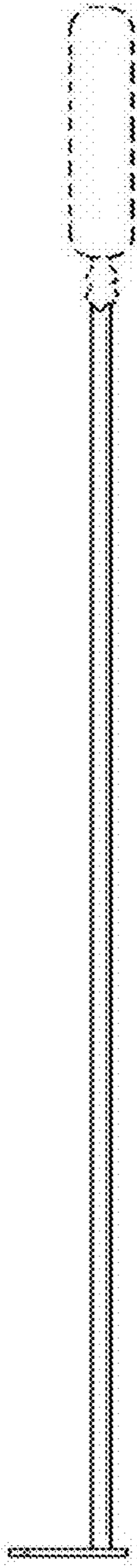

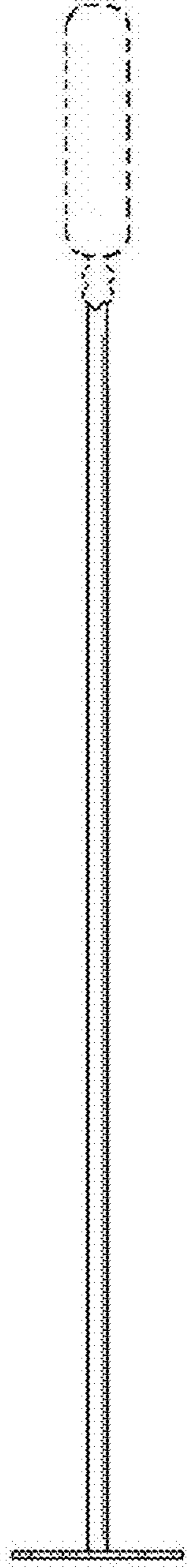

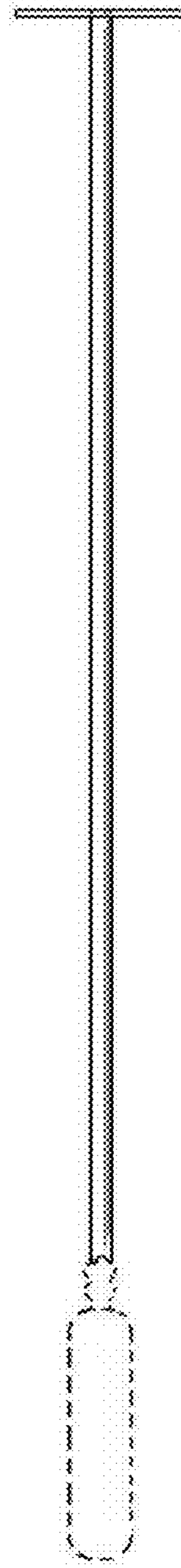

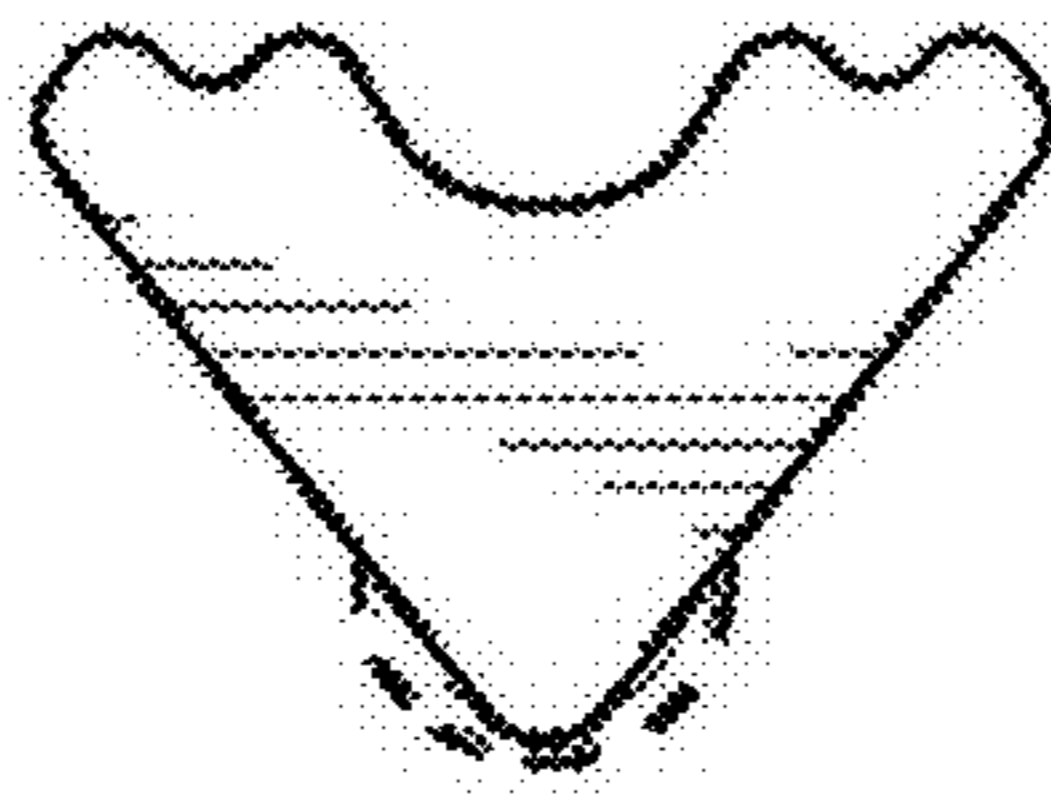

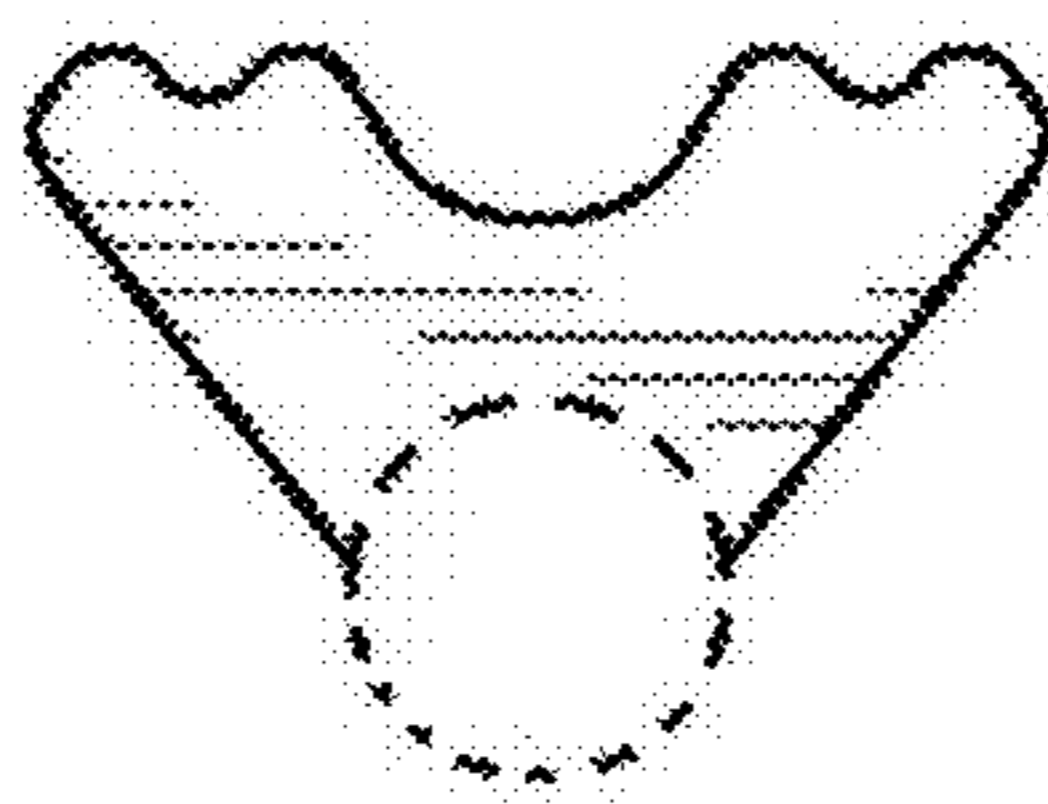

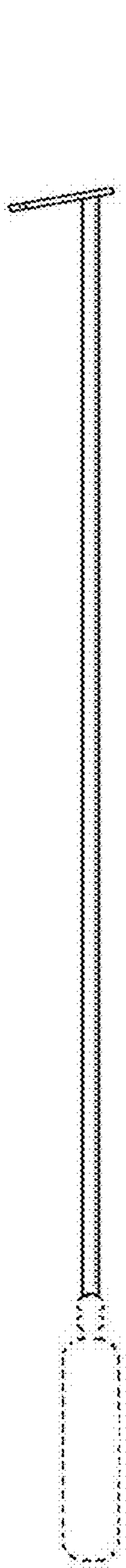

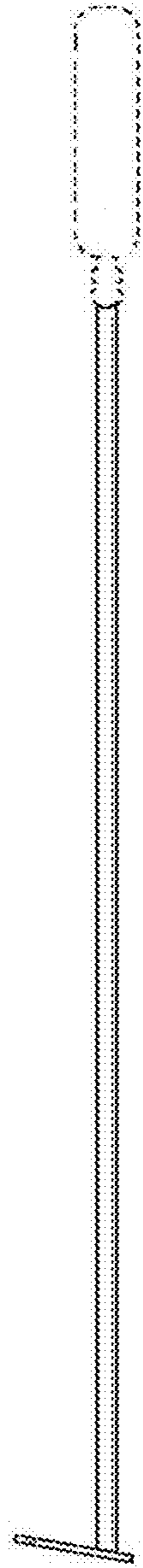

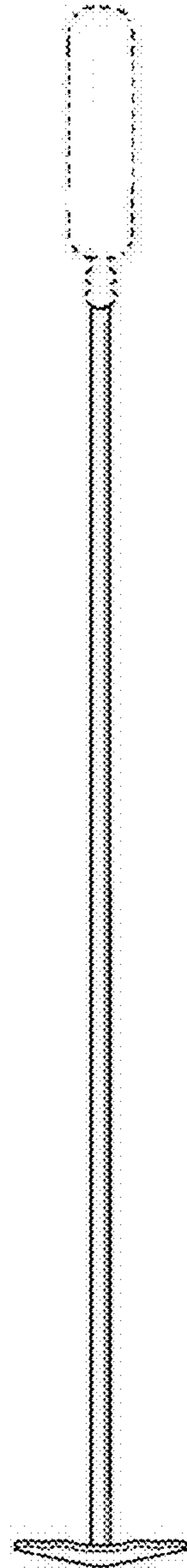

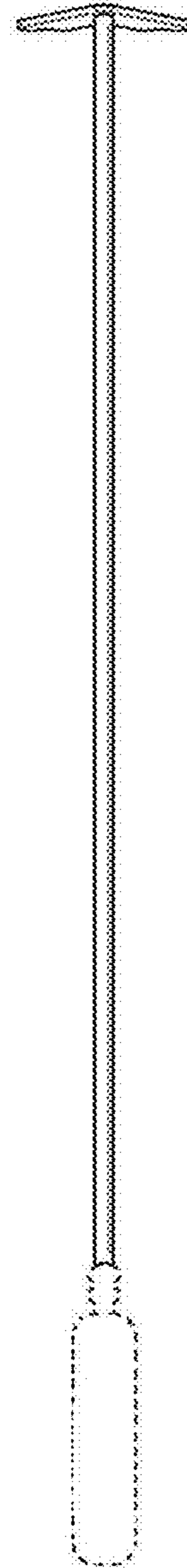

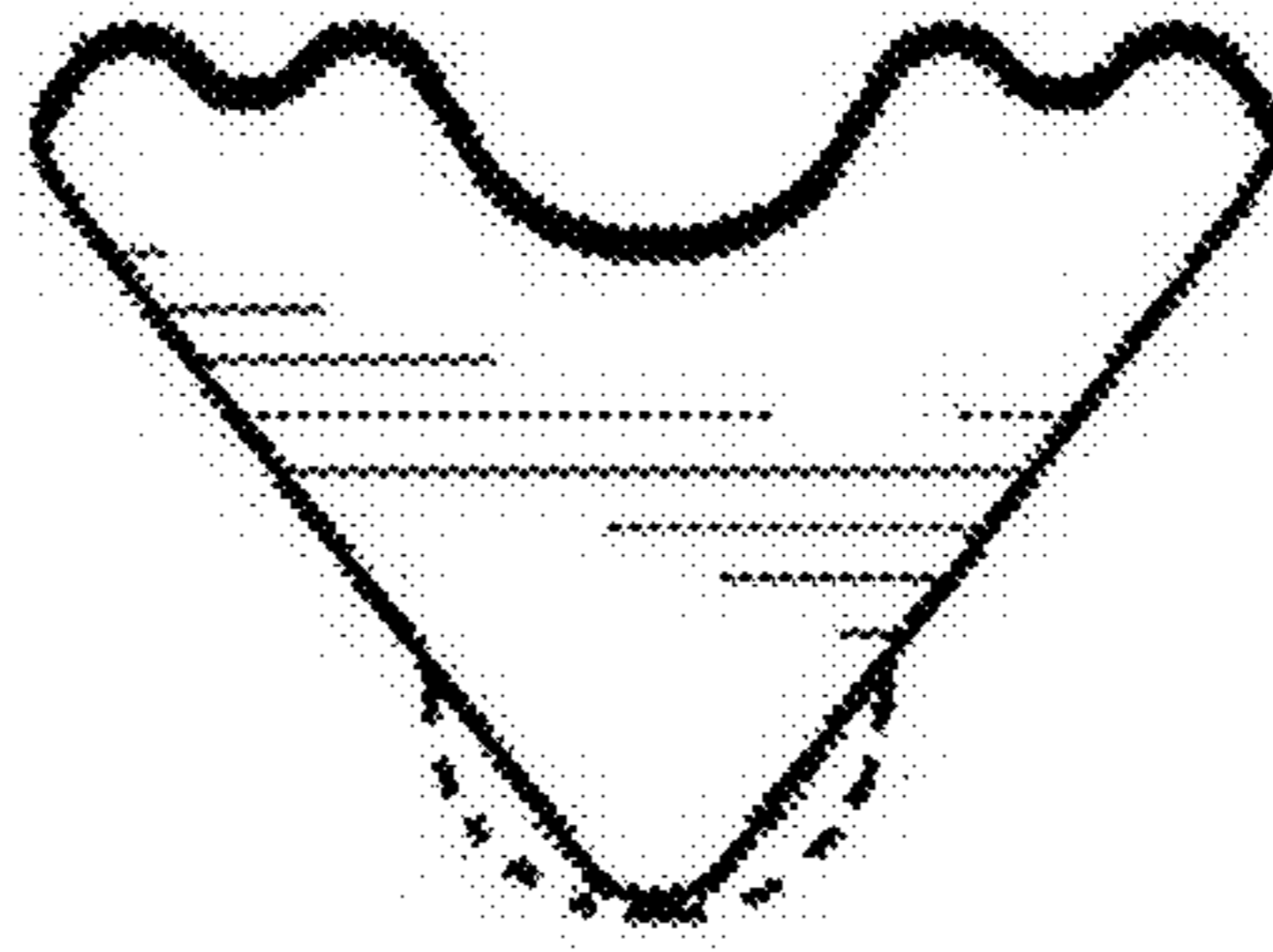

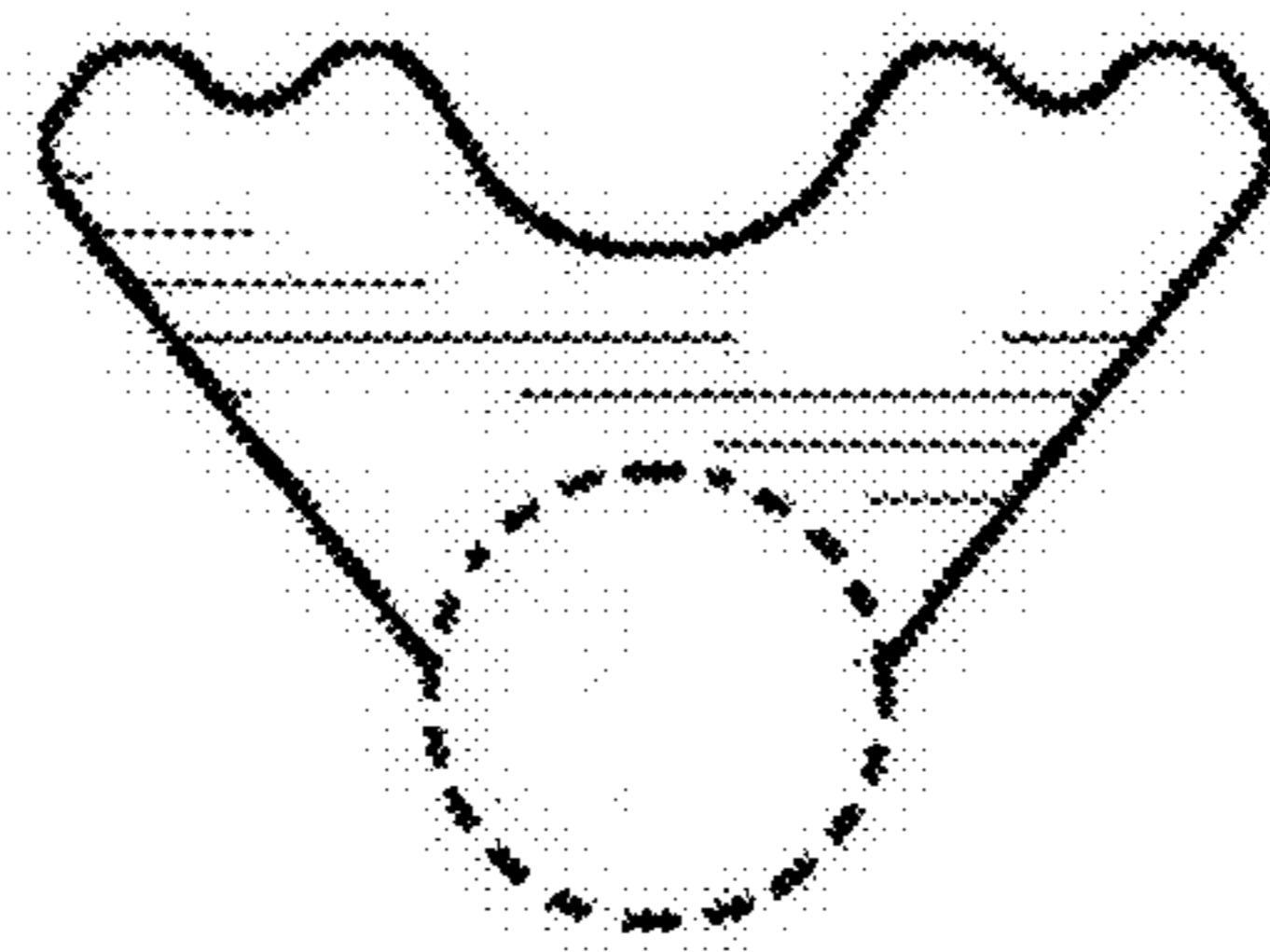

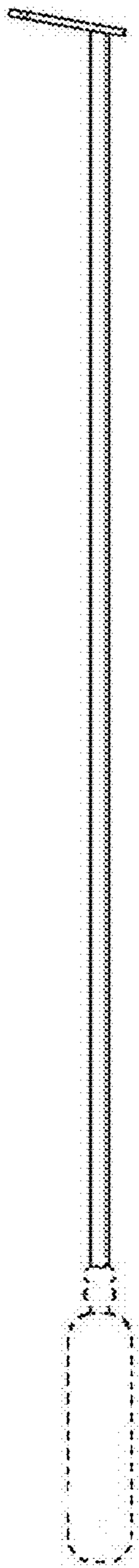

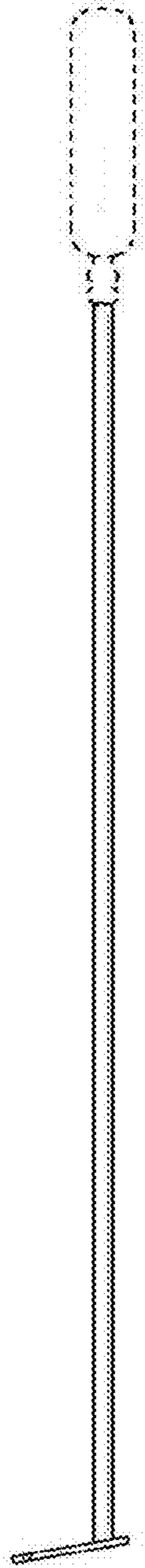

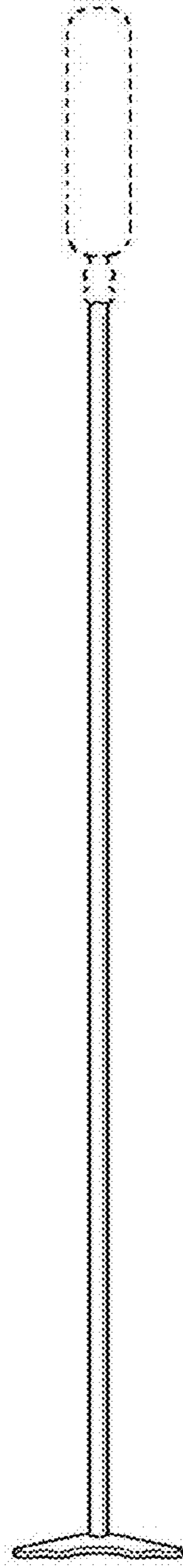

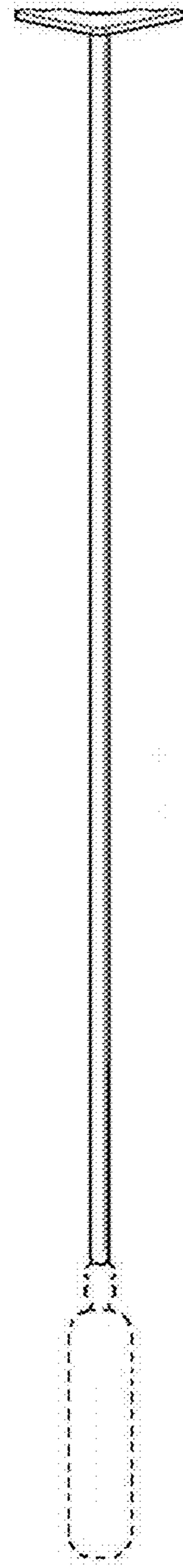
