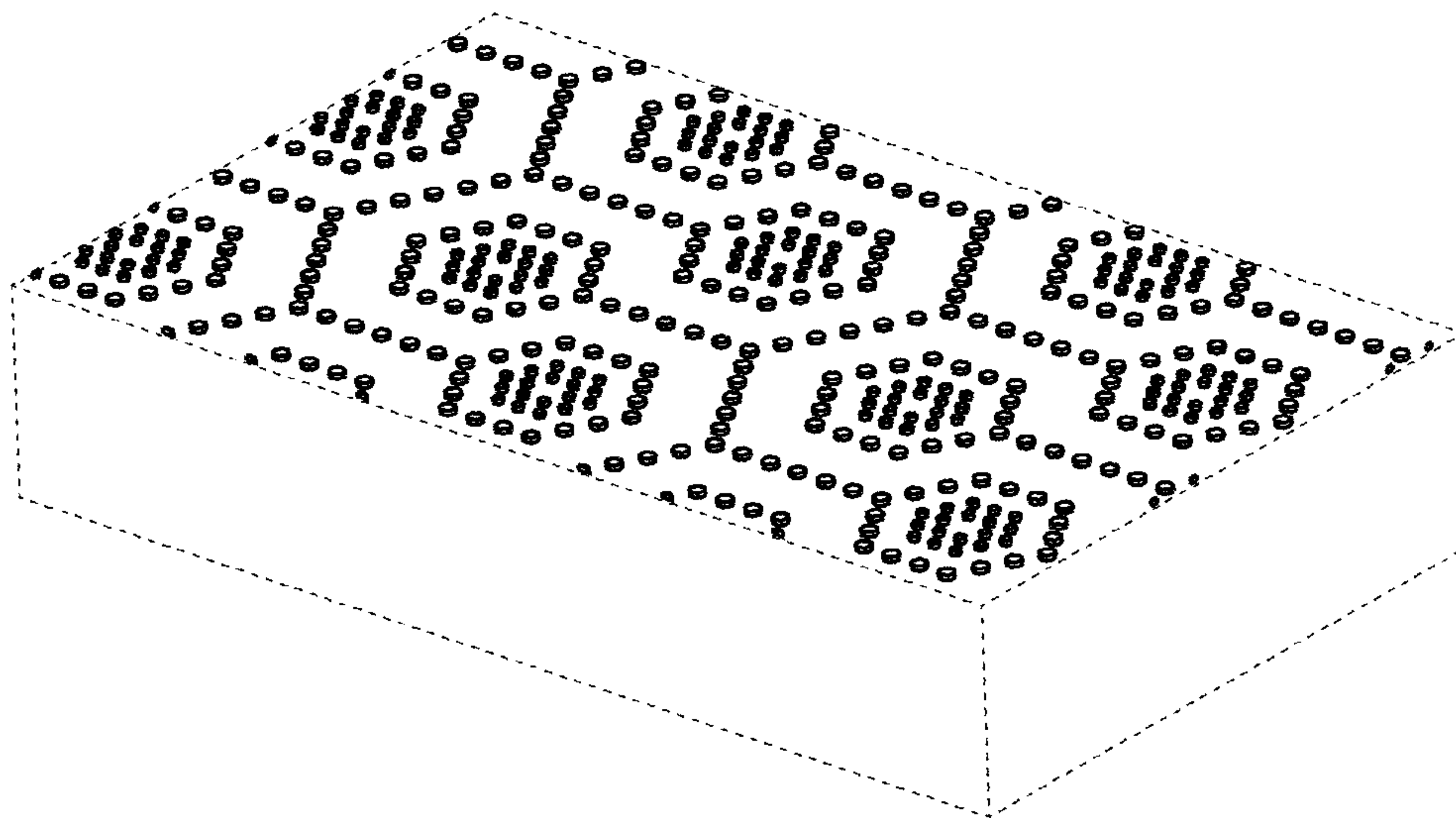
FIG. 1 is a perspective view of a first embodiment of a cleaning article showing the new design;

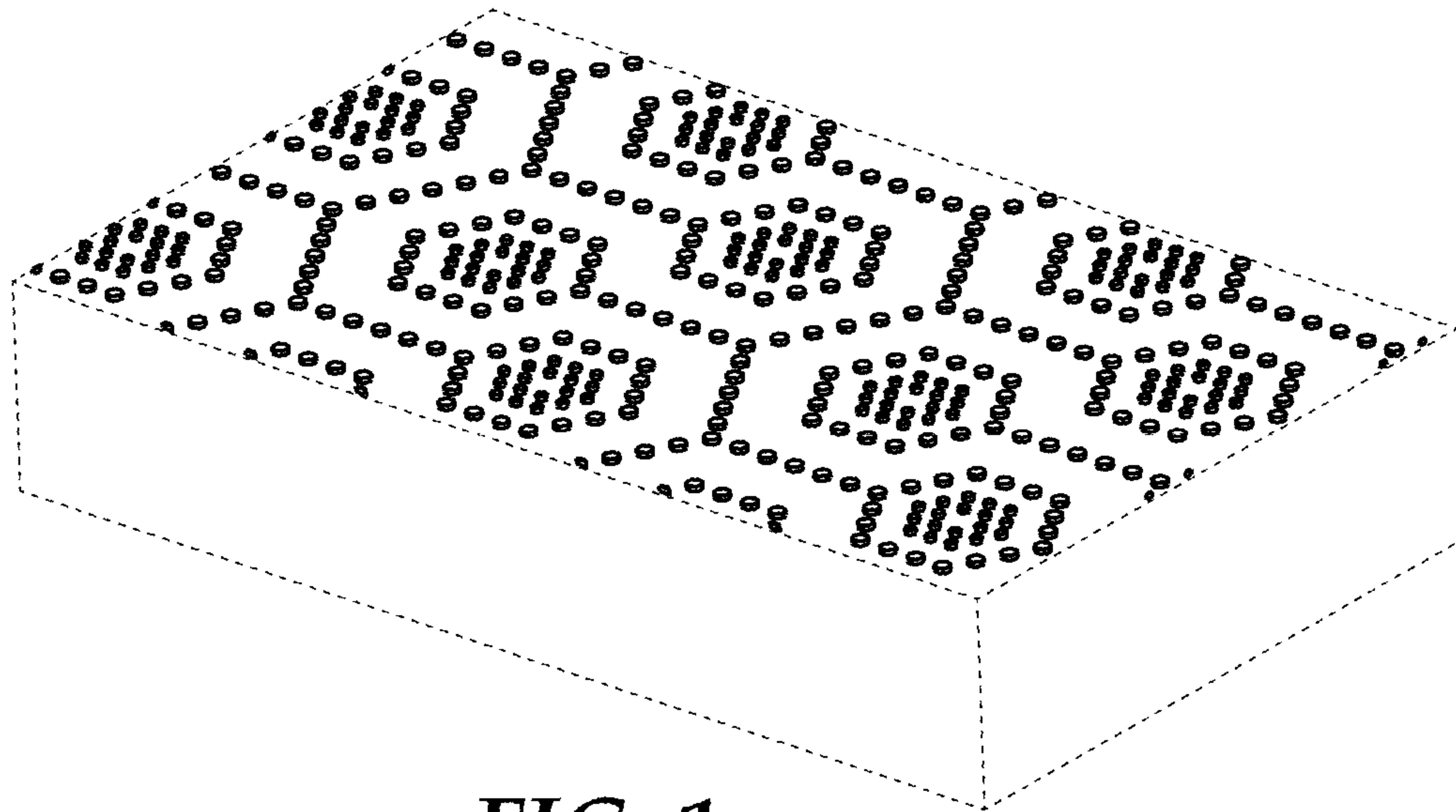

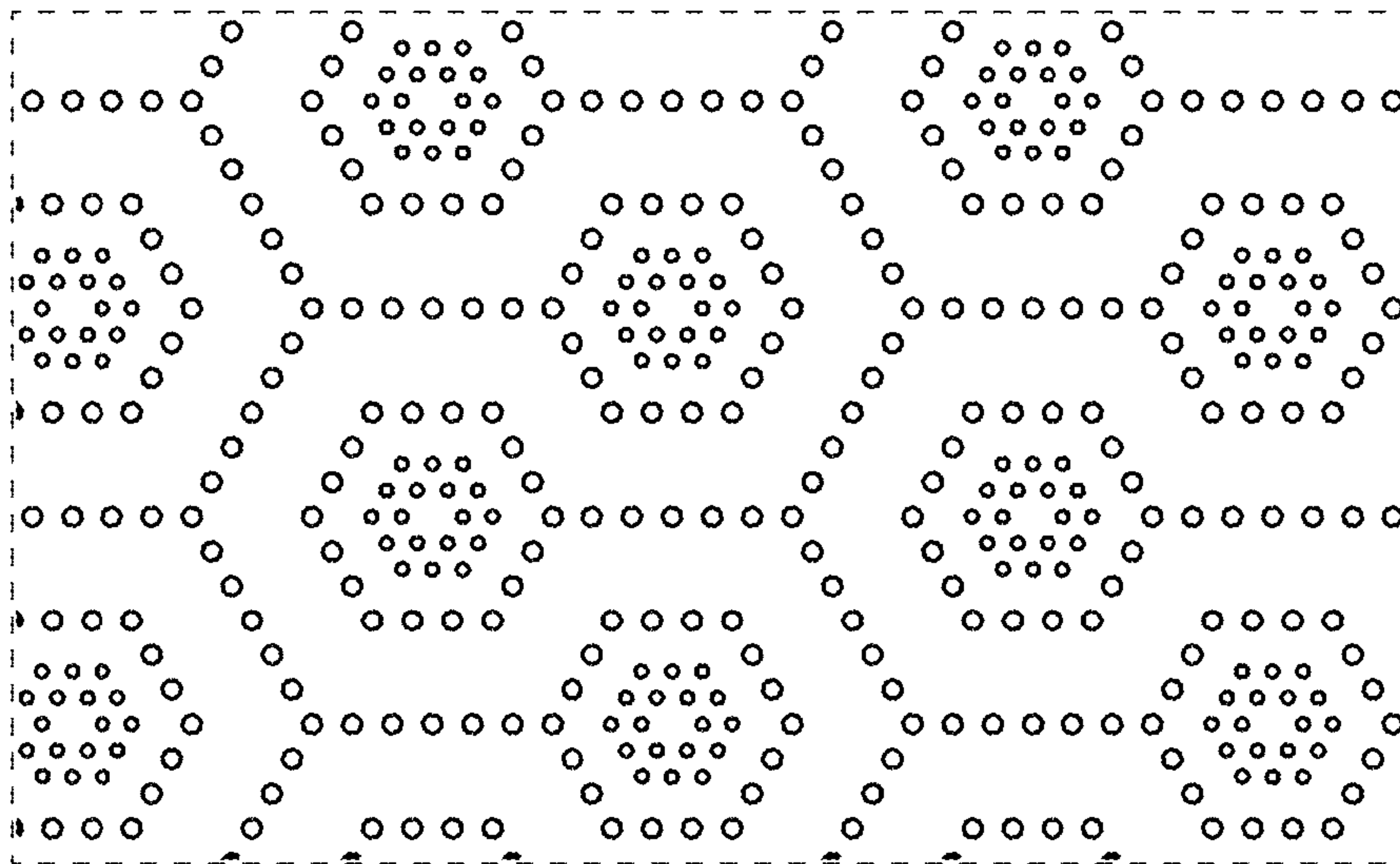

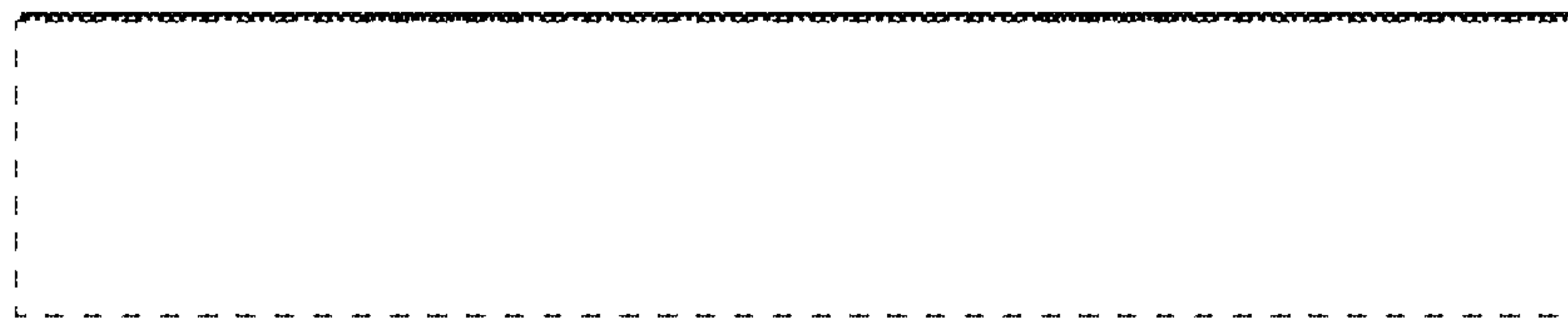

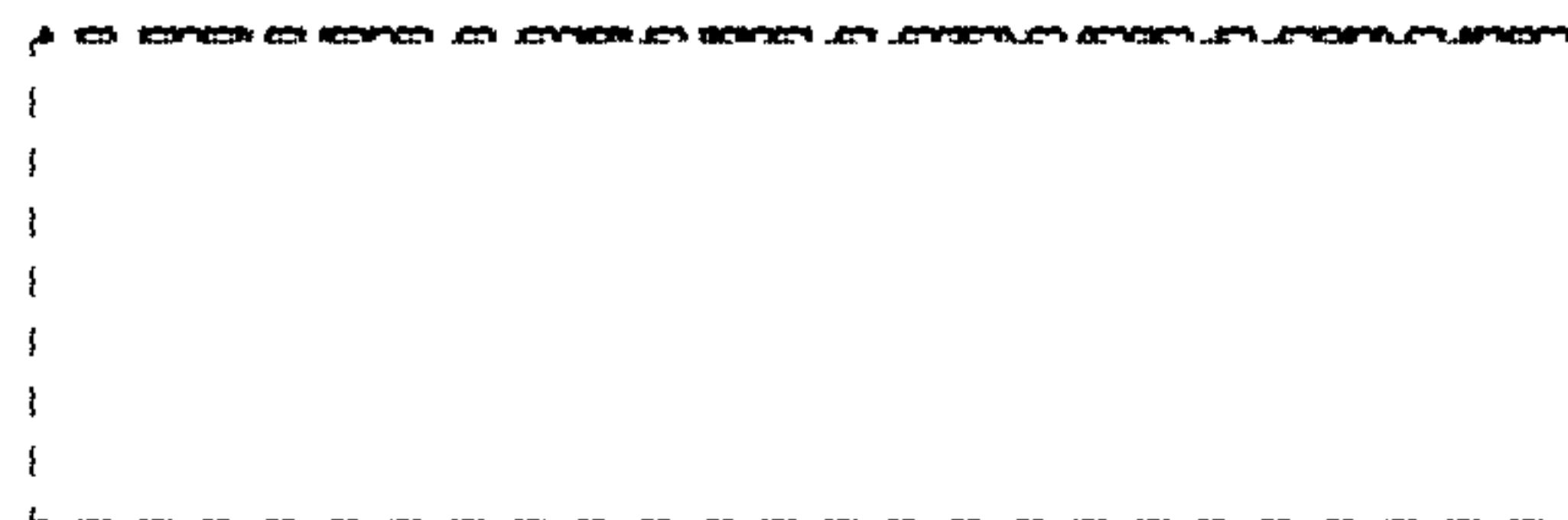

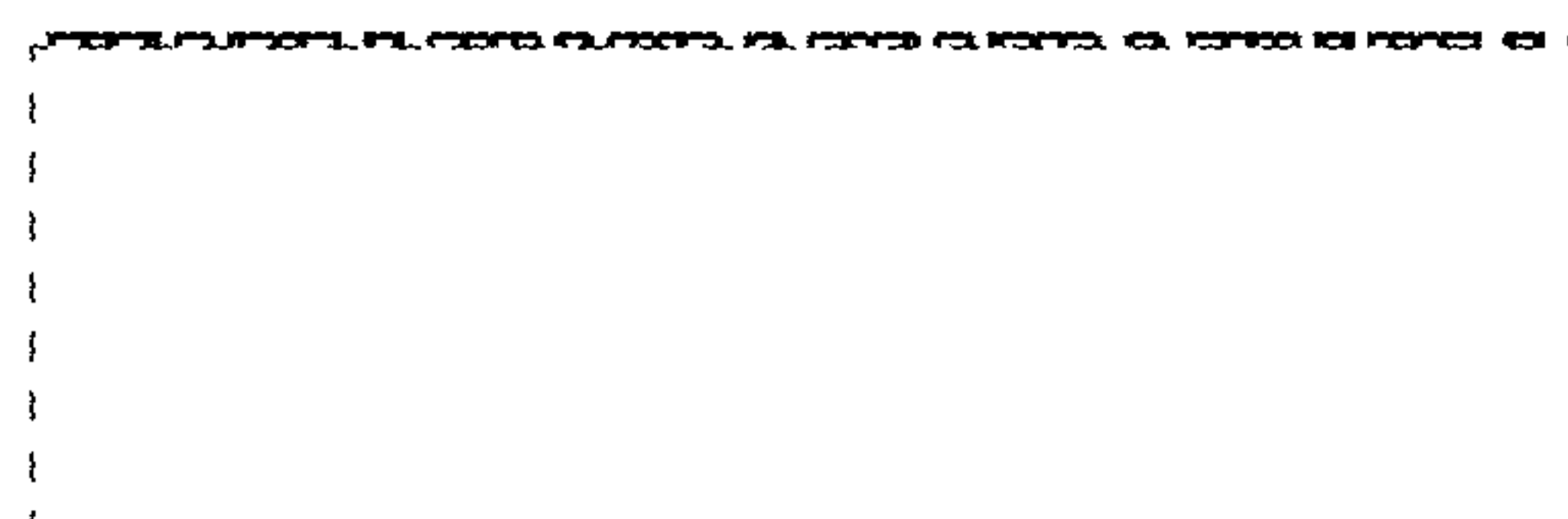

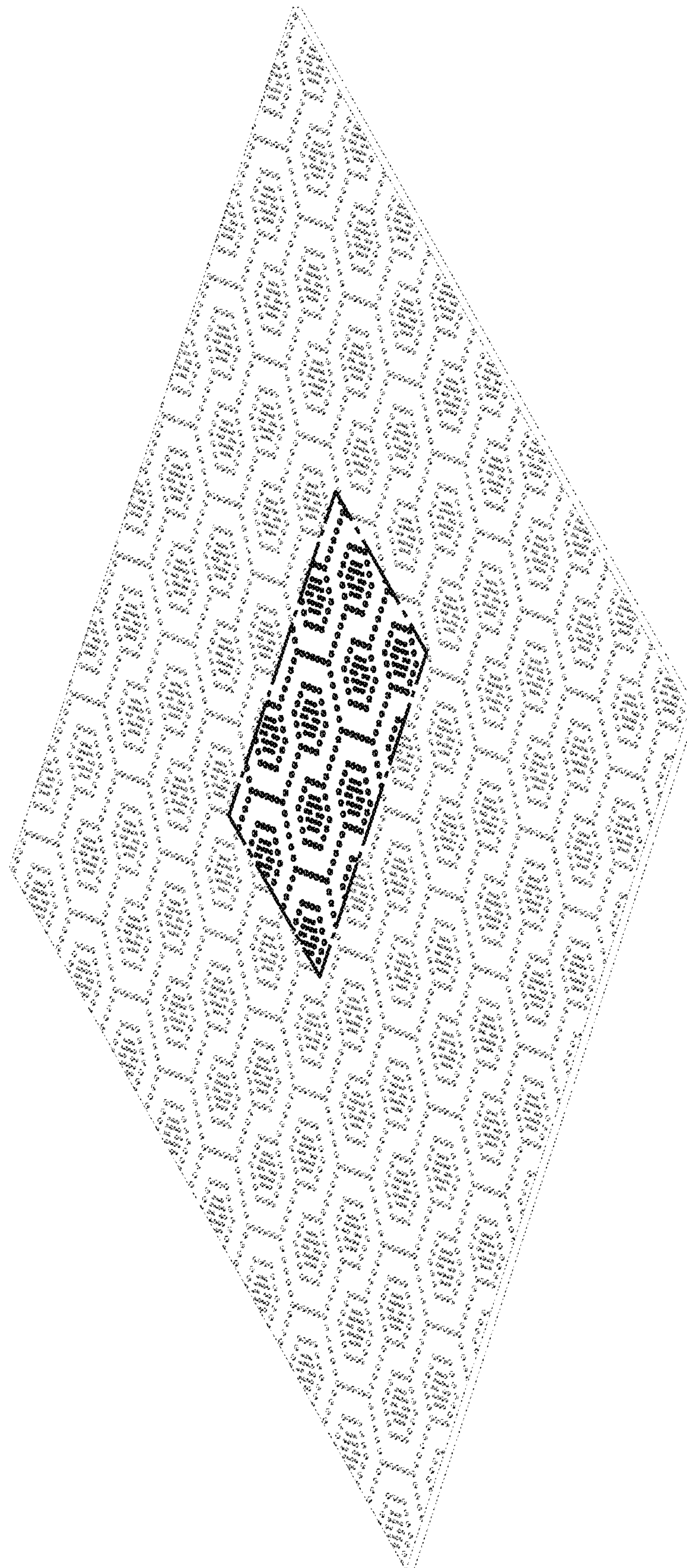

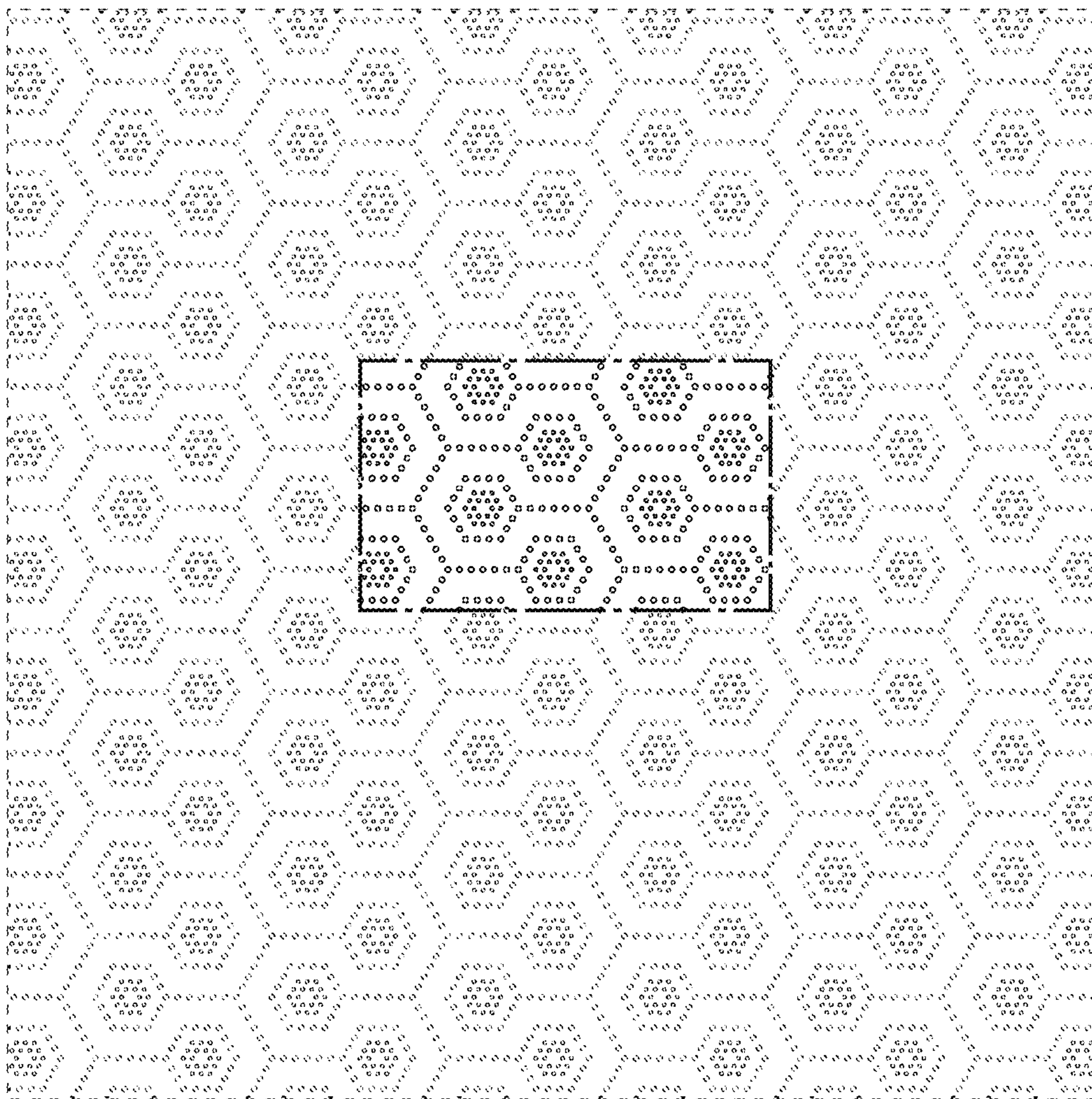

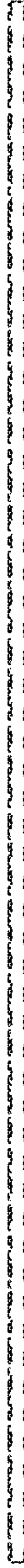

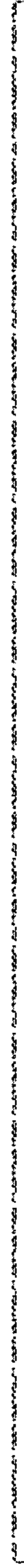

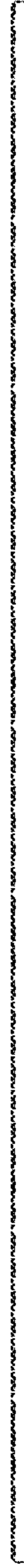

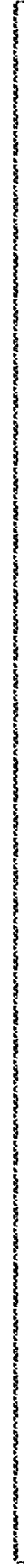
