FIG. 12 is a left side view of the swimwear of FIG. 9;

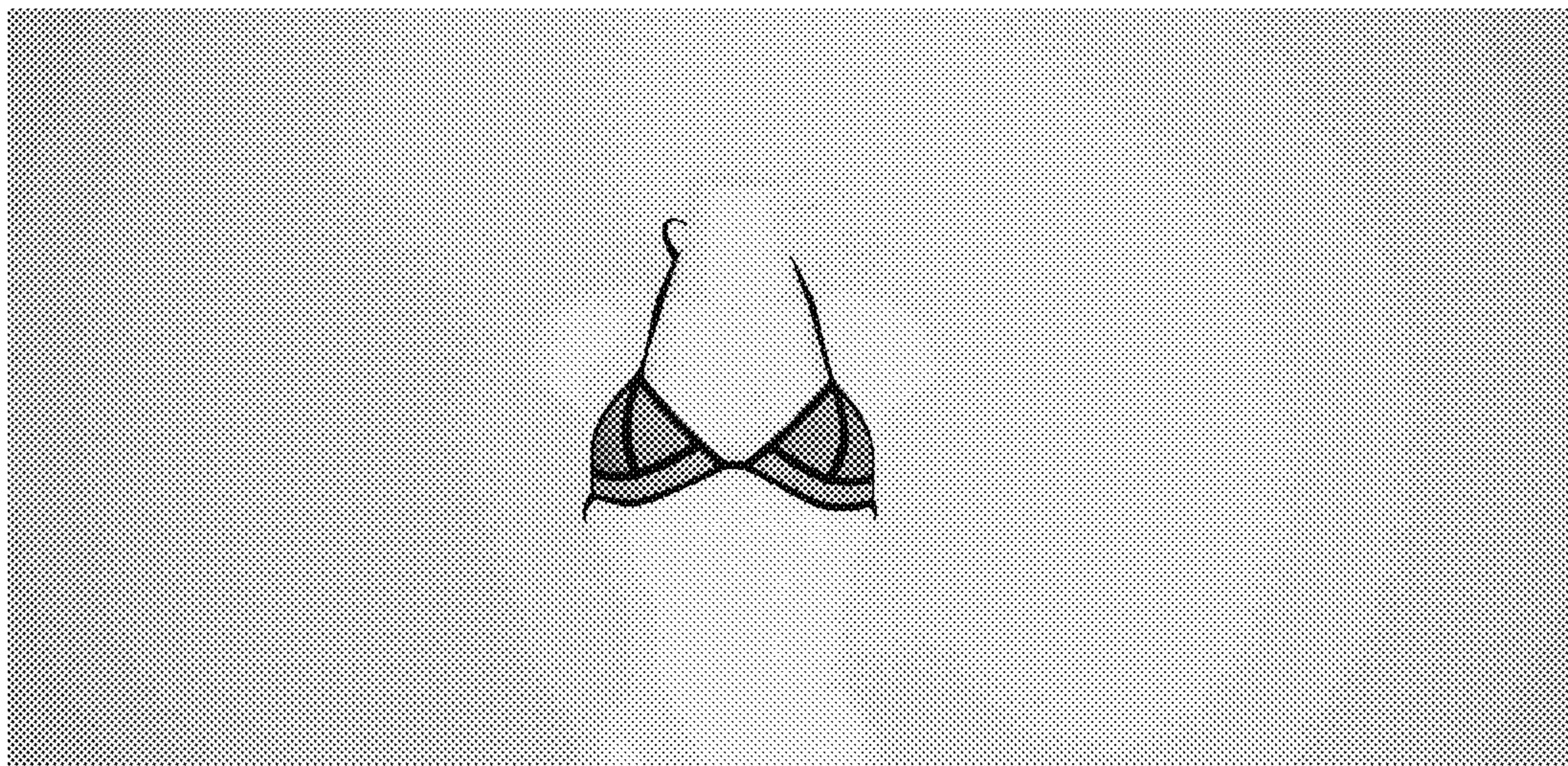
FIG. 13 is a front view of a fourth embodiment of swimwear, in accordance with the present invention;

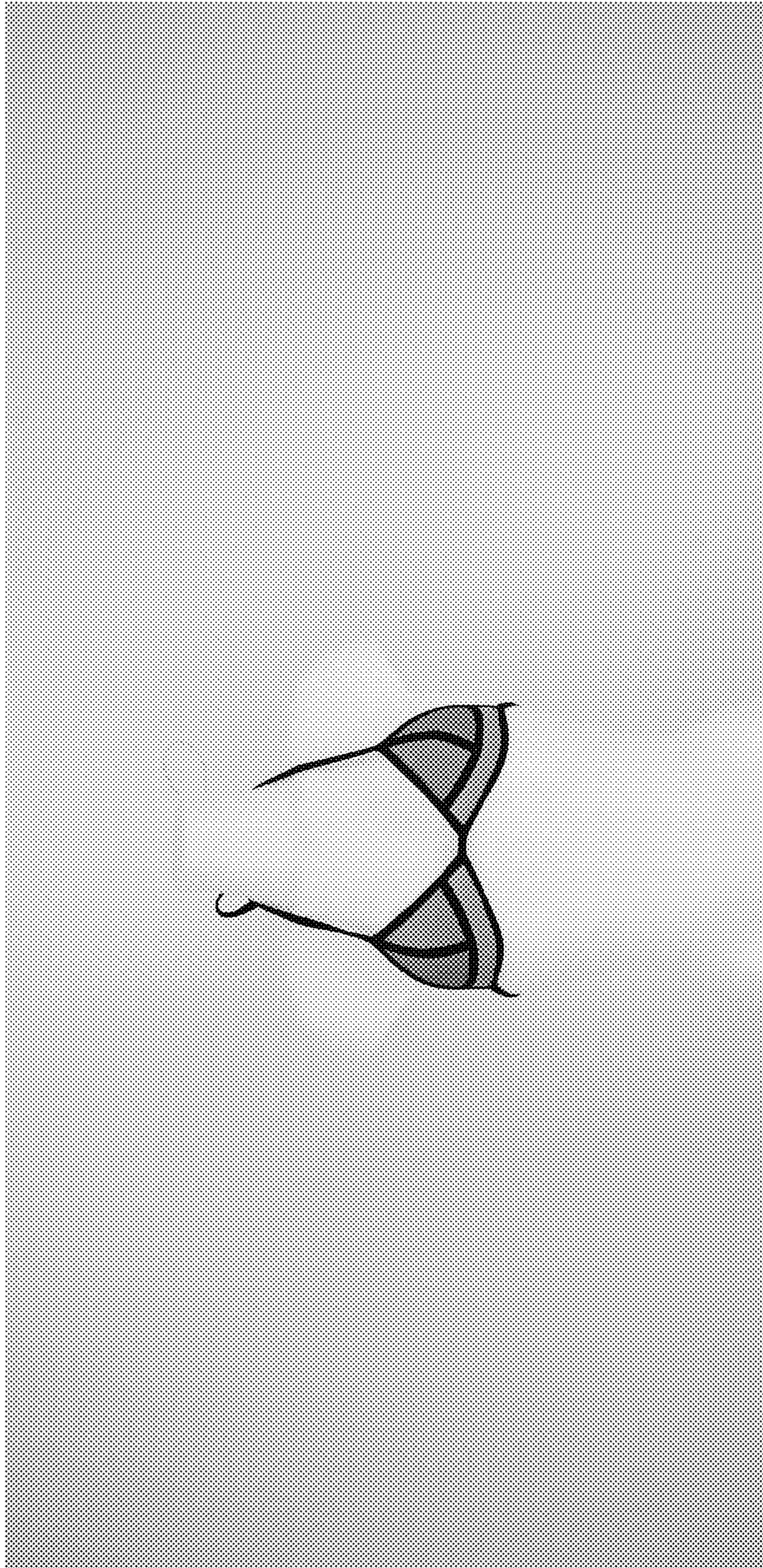

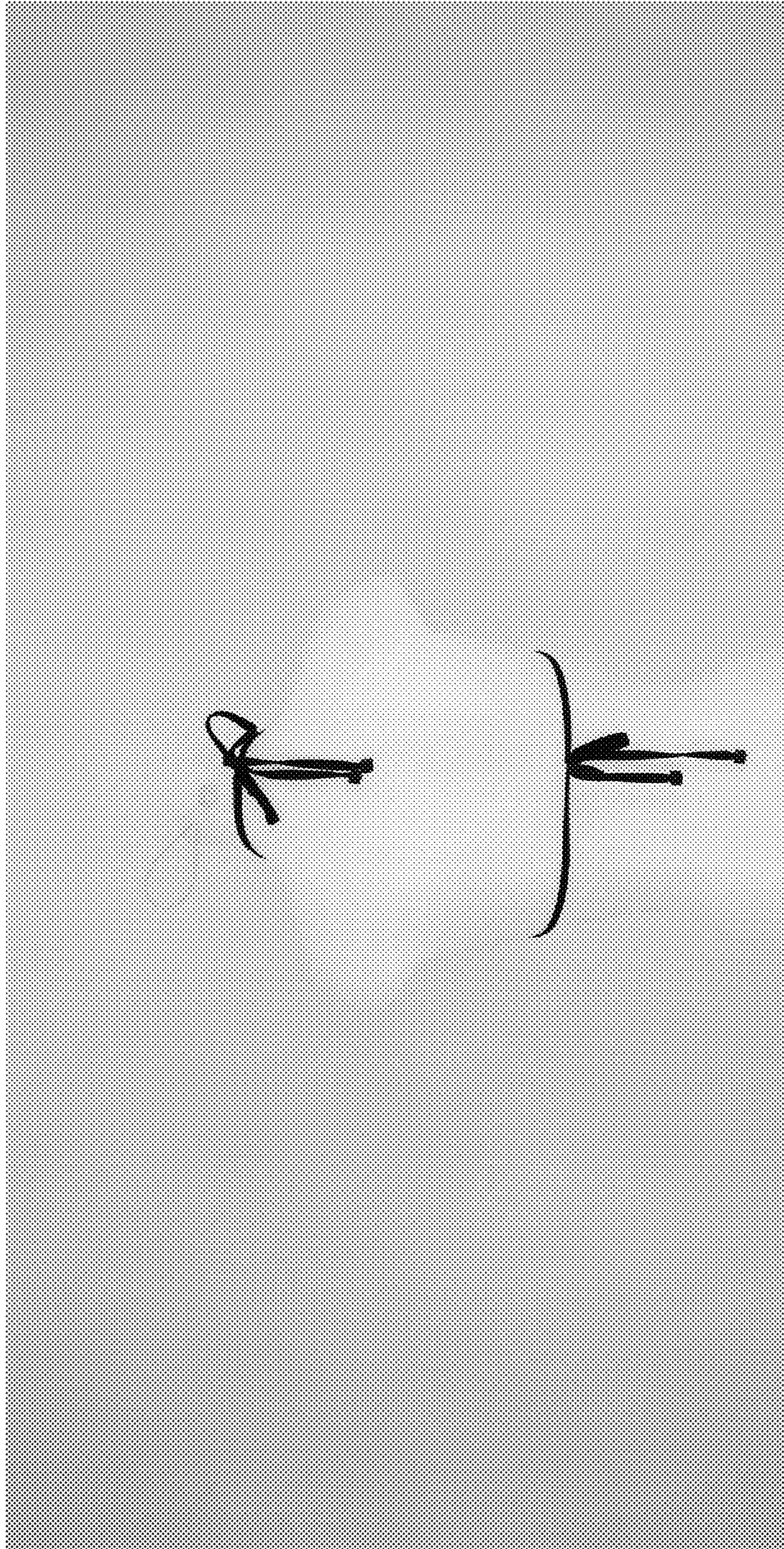

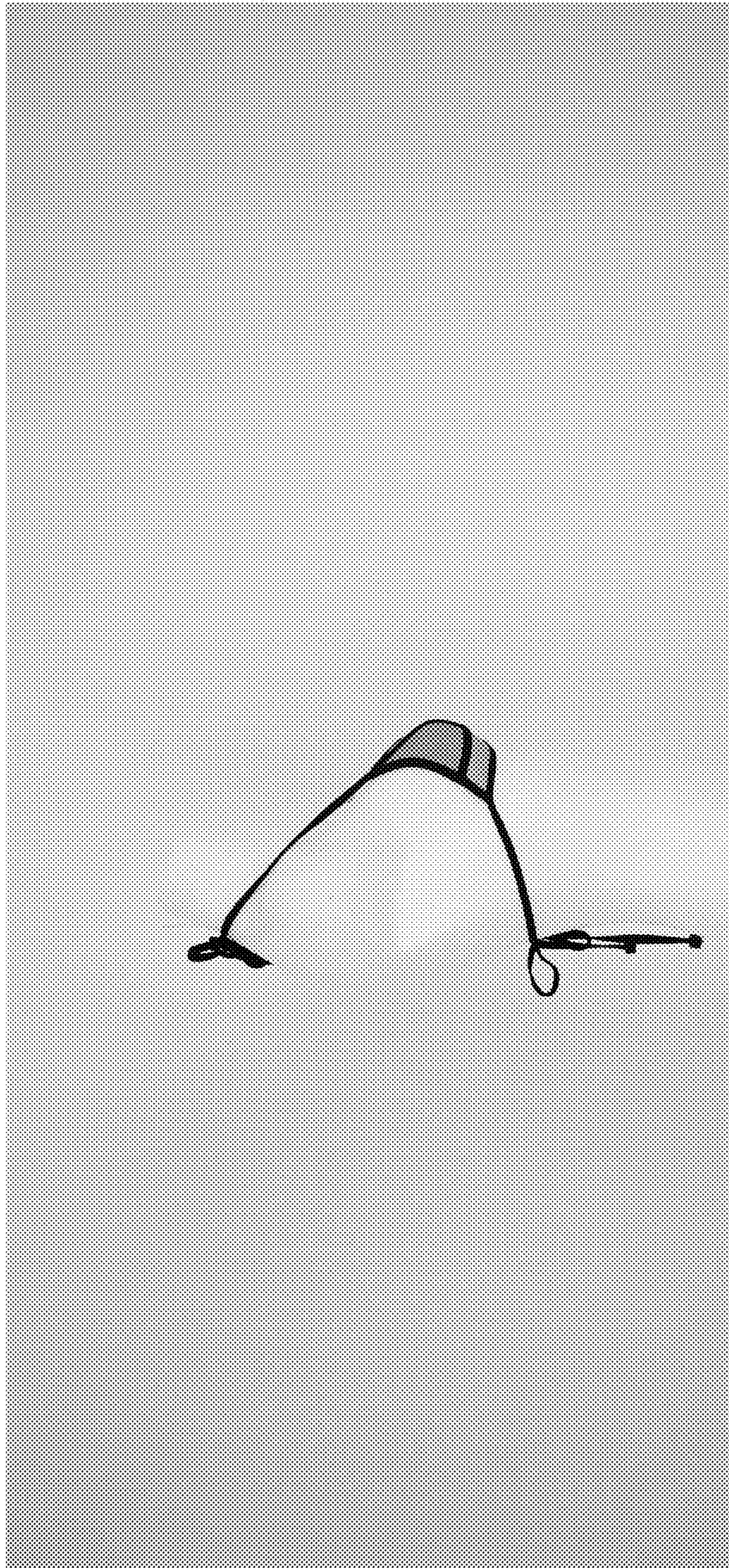

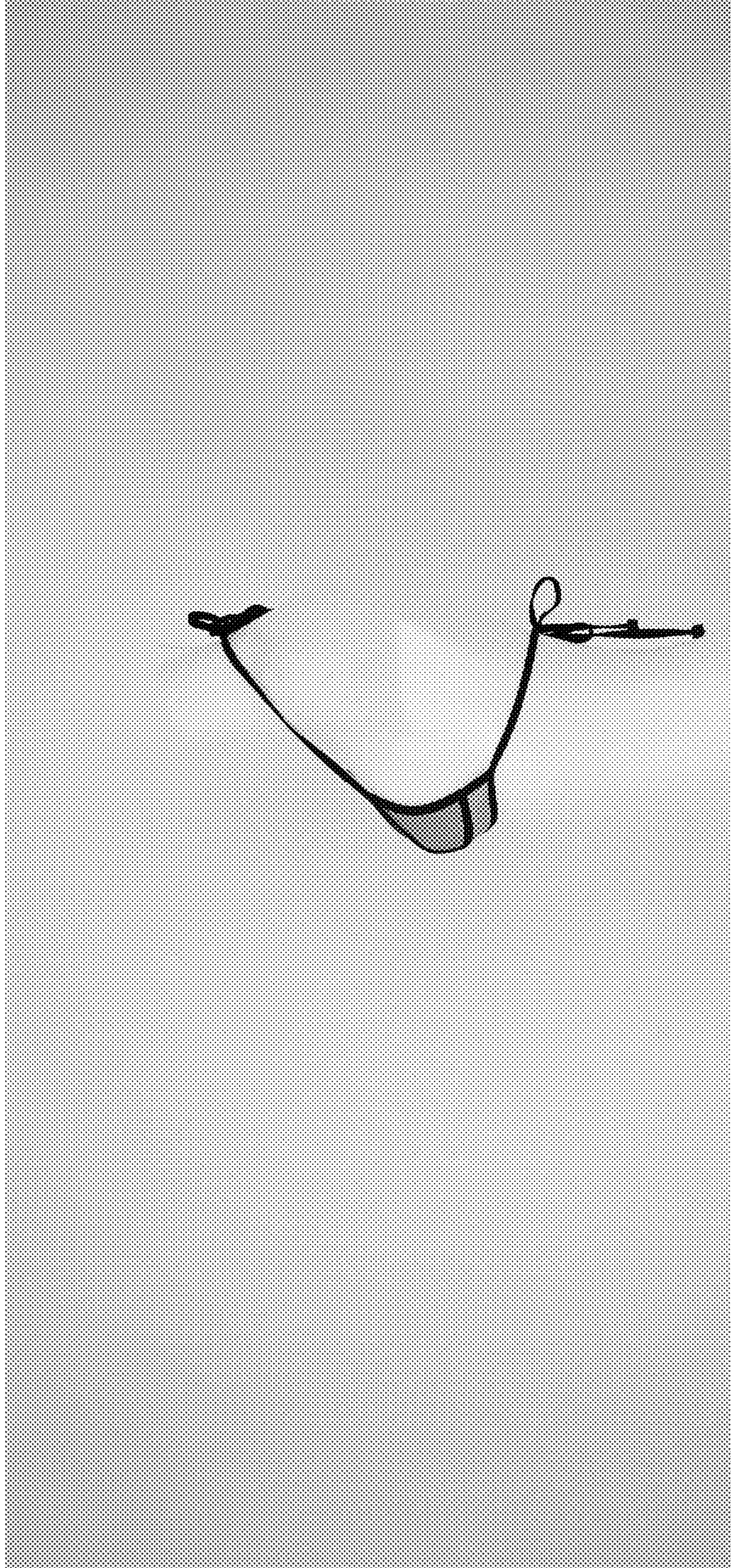

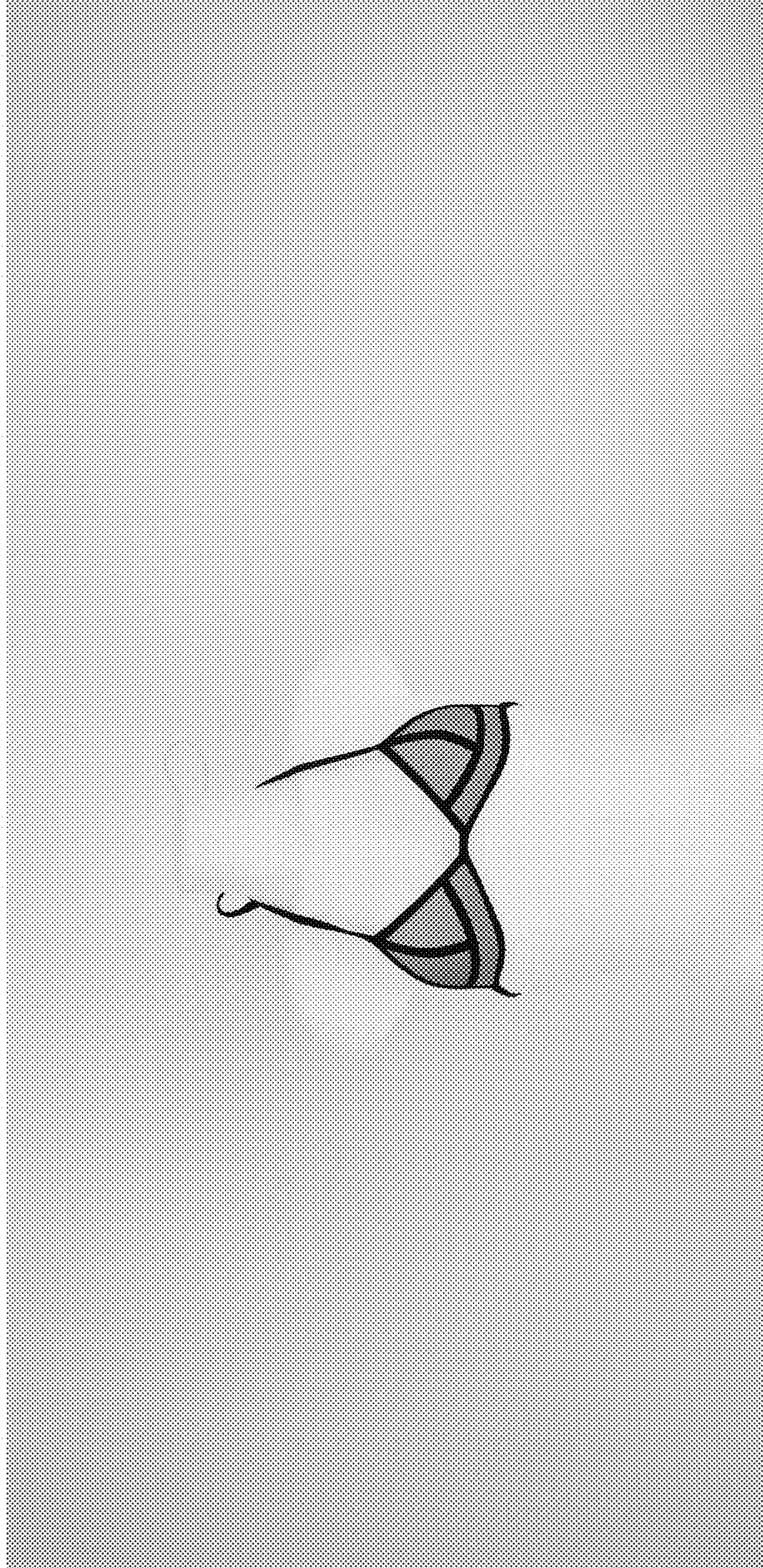

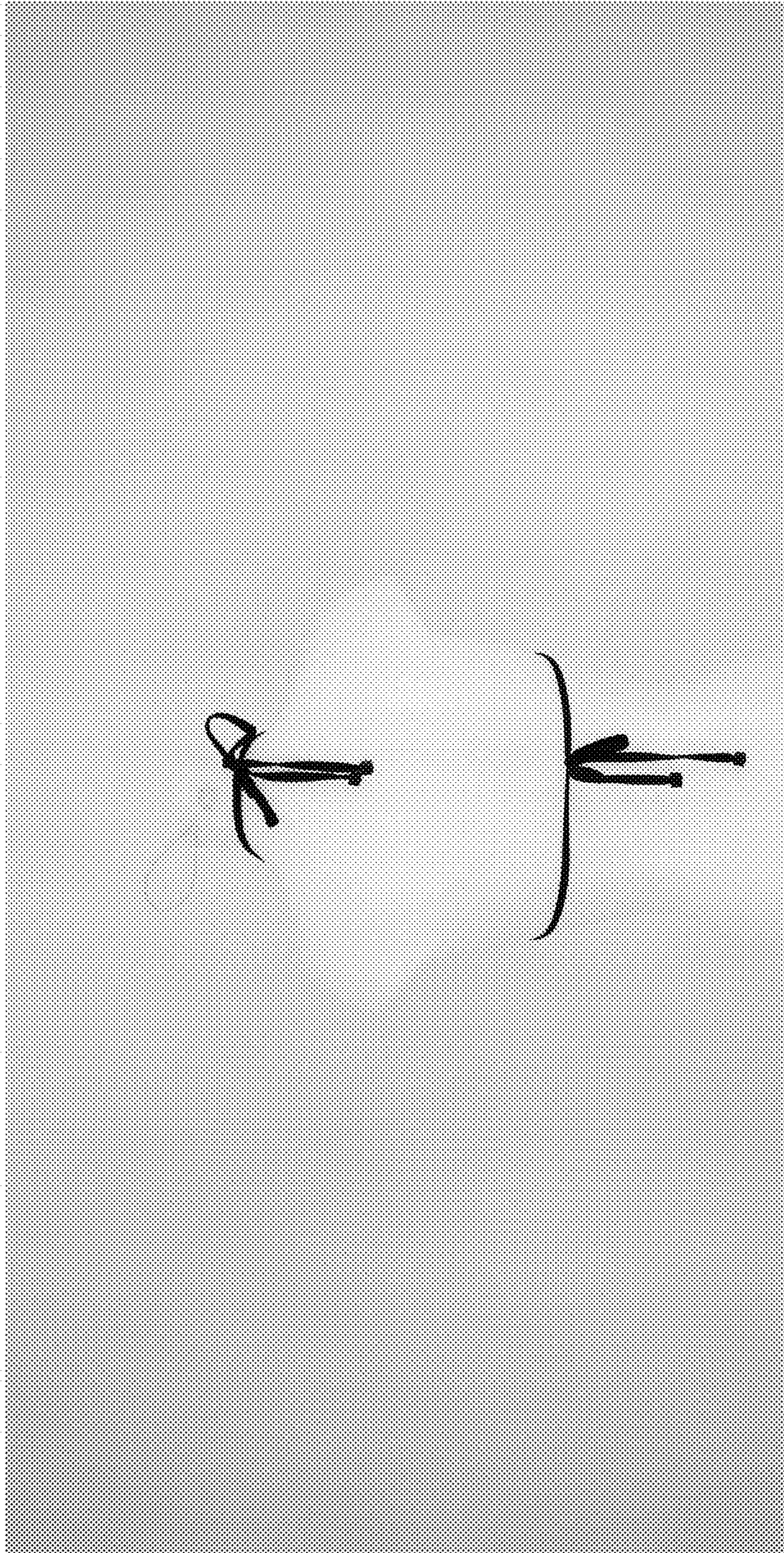

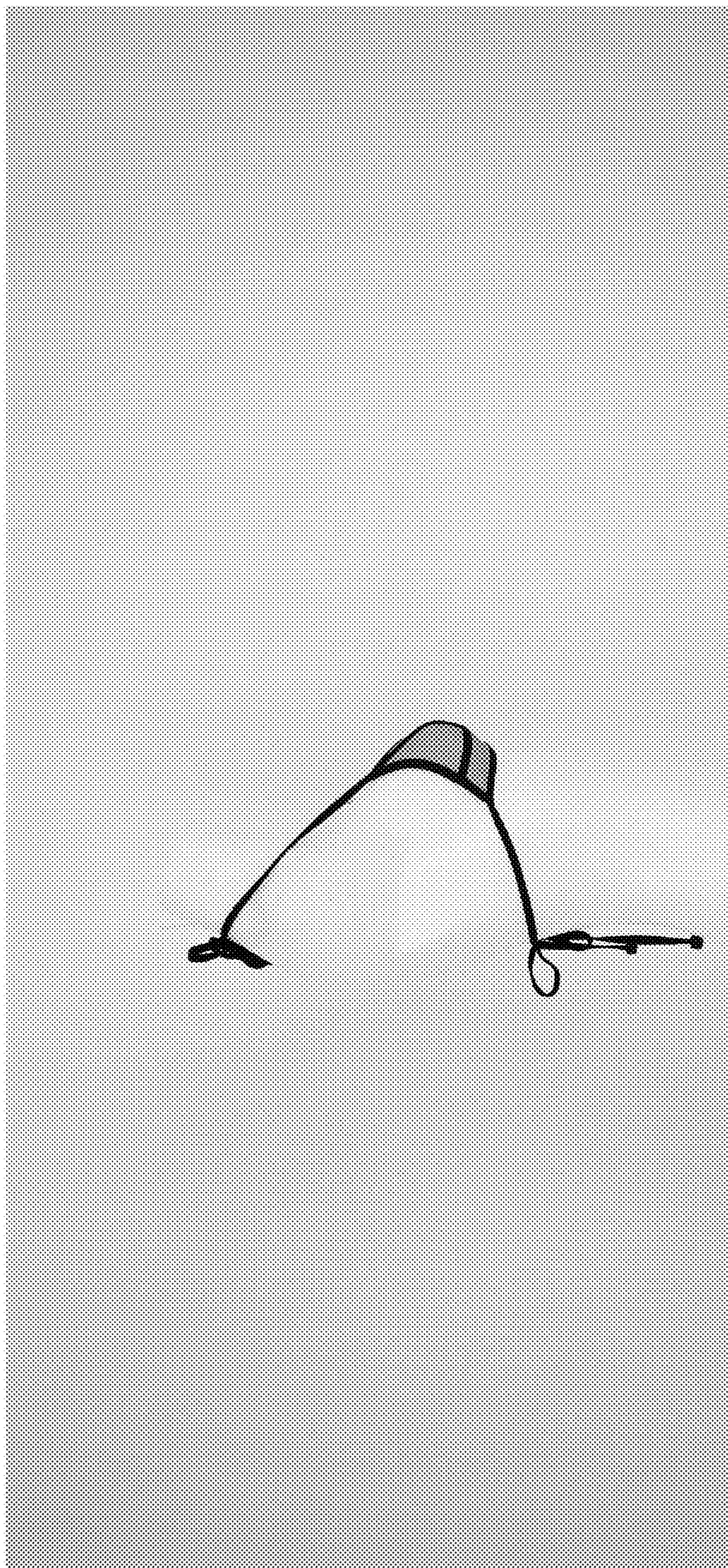

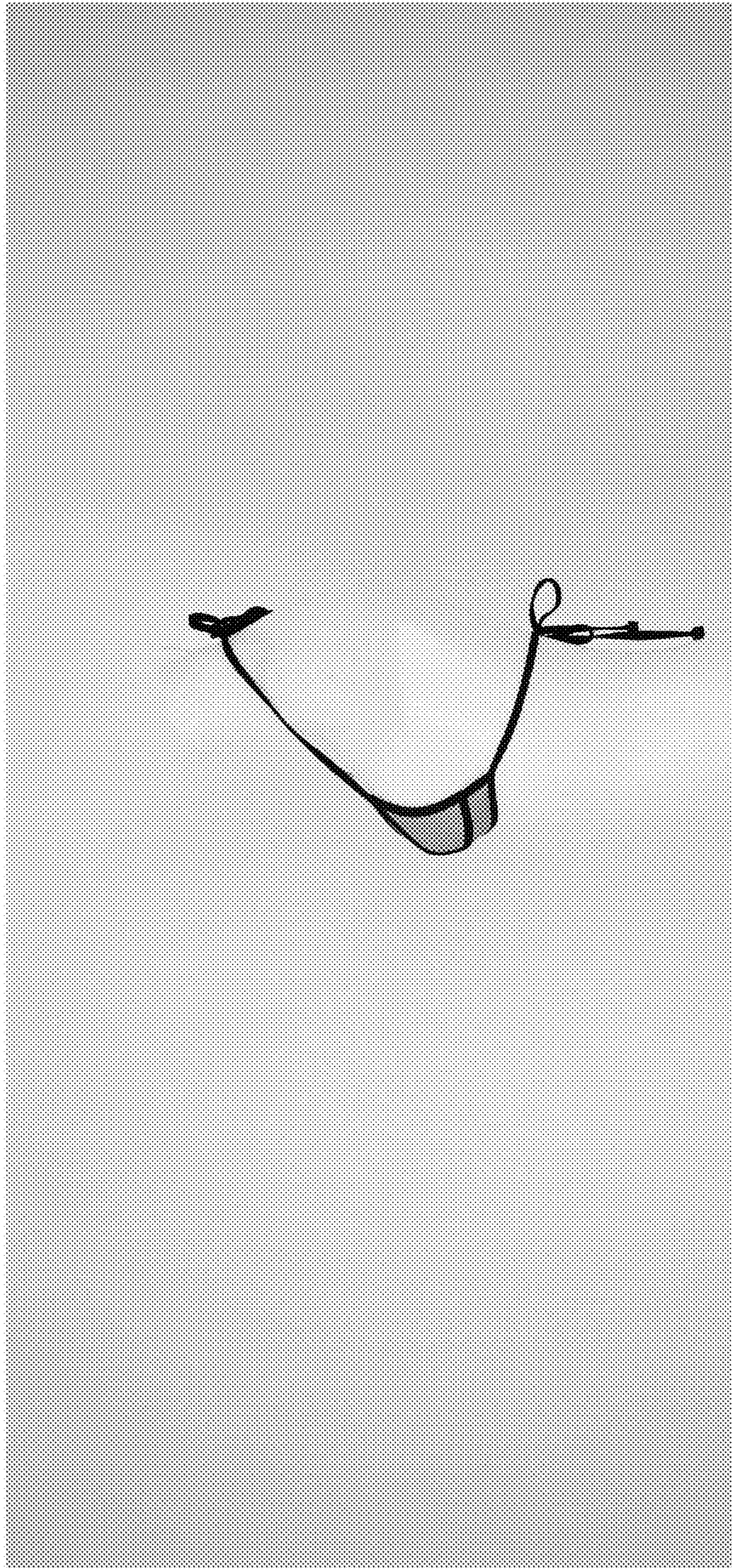

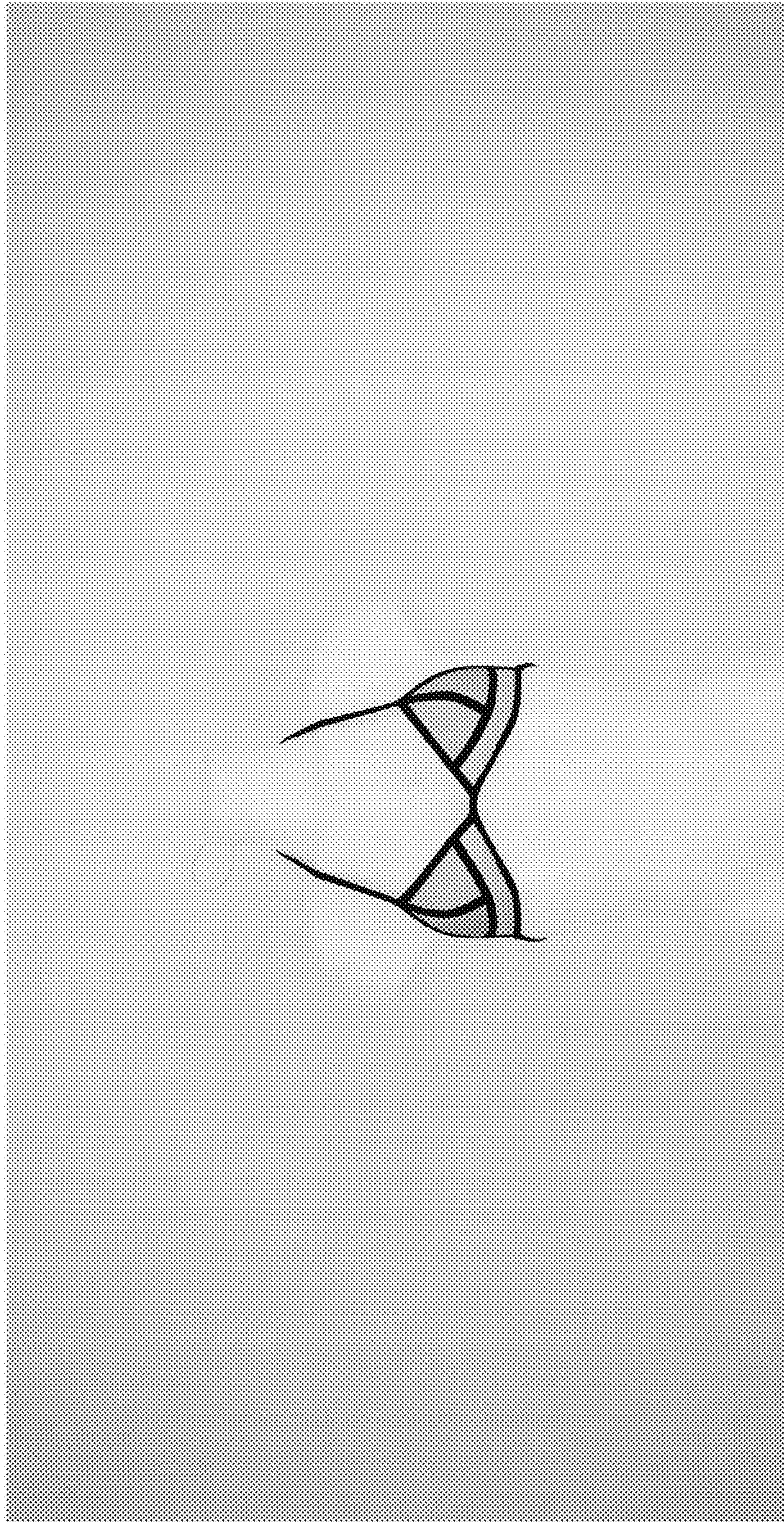

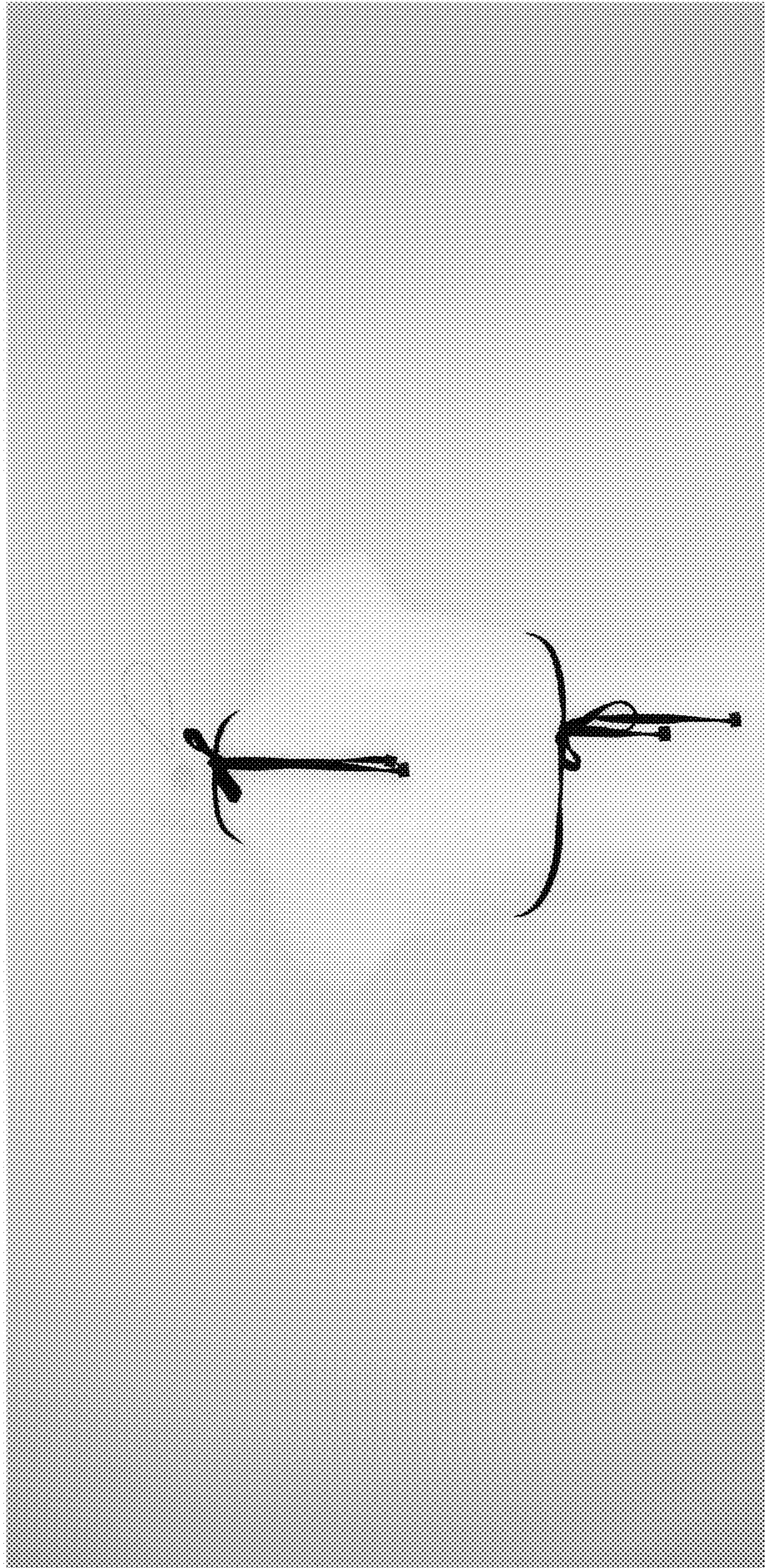

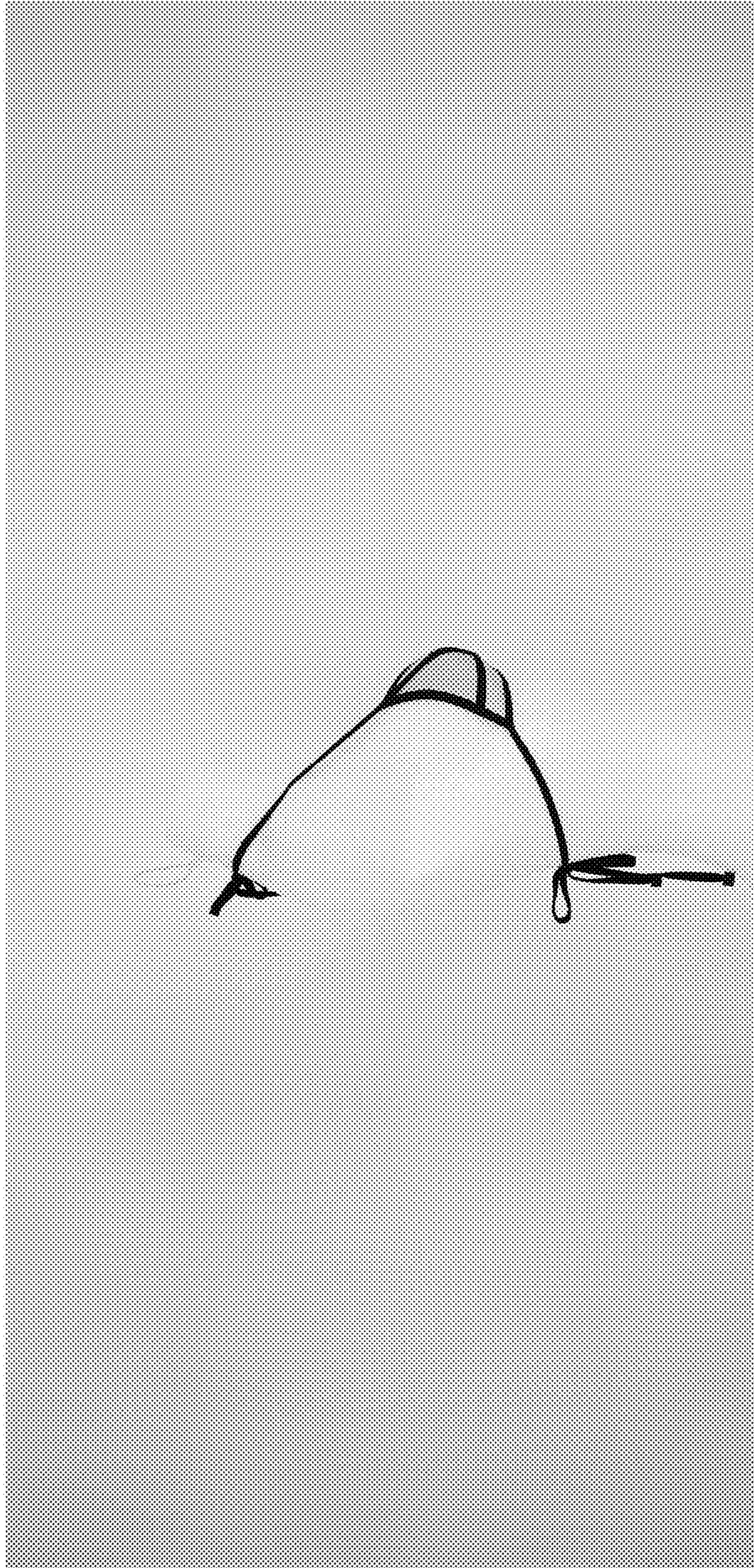

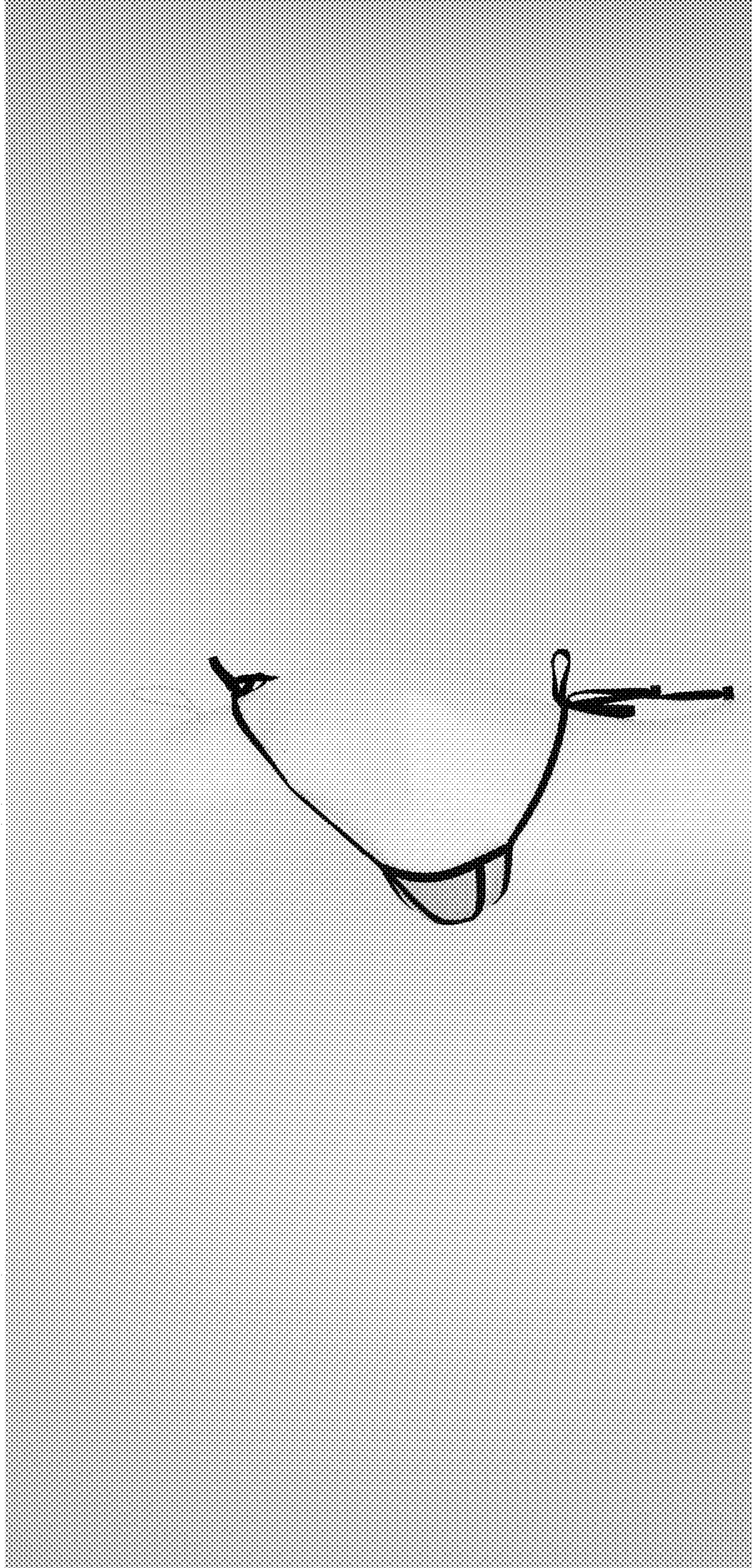

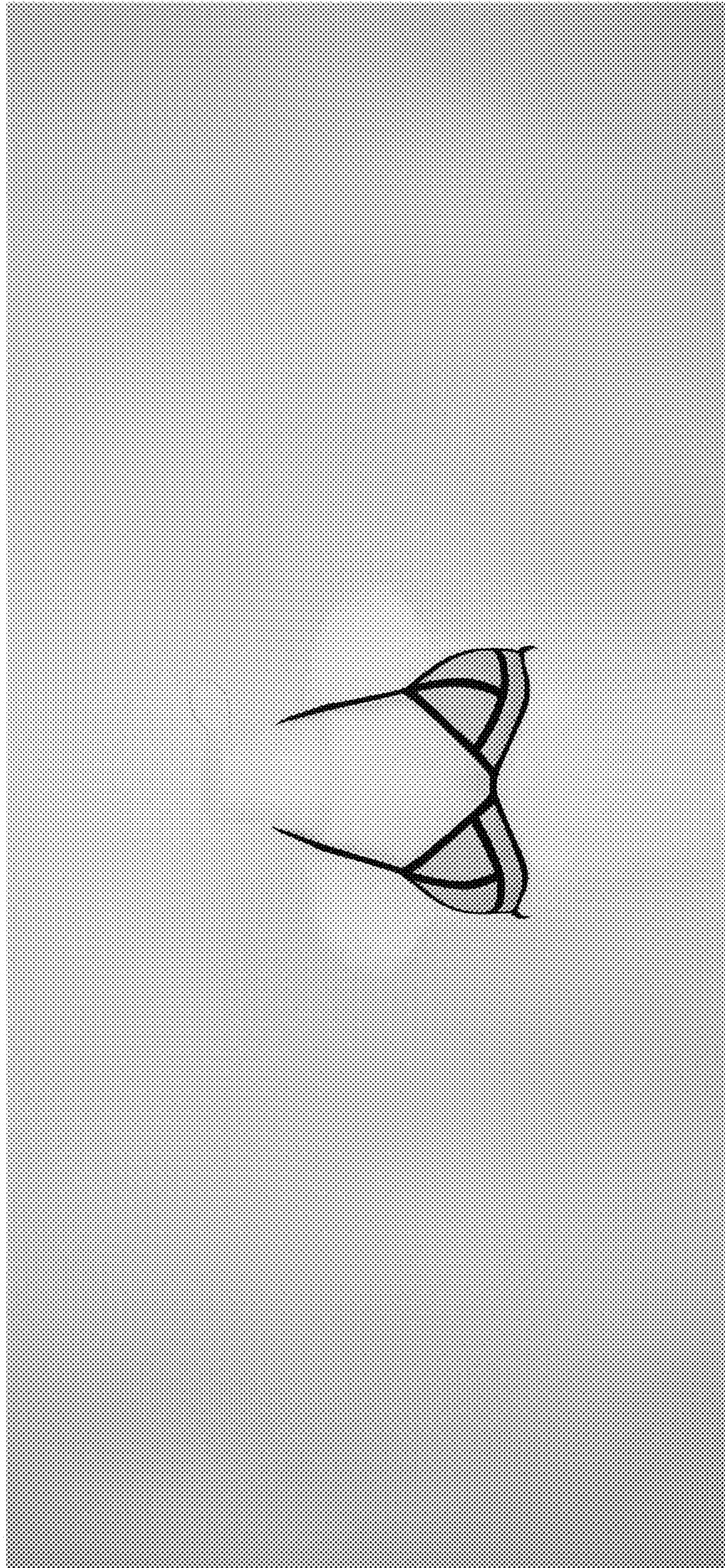

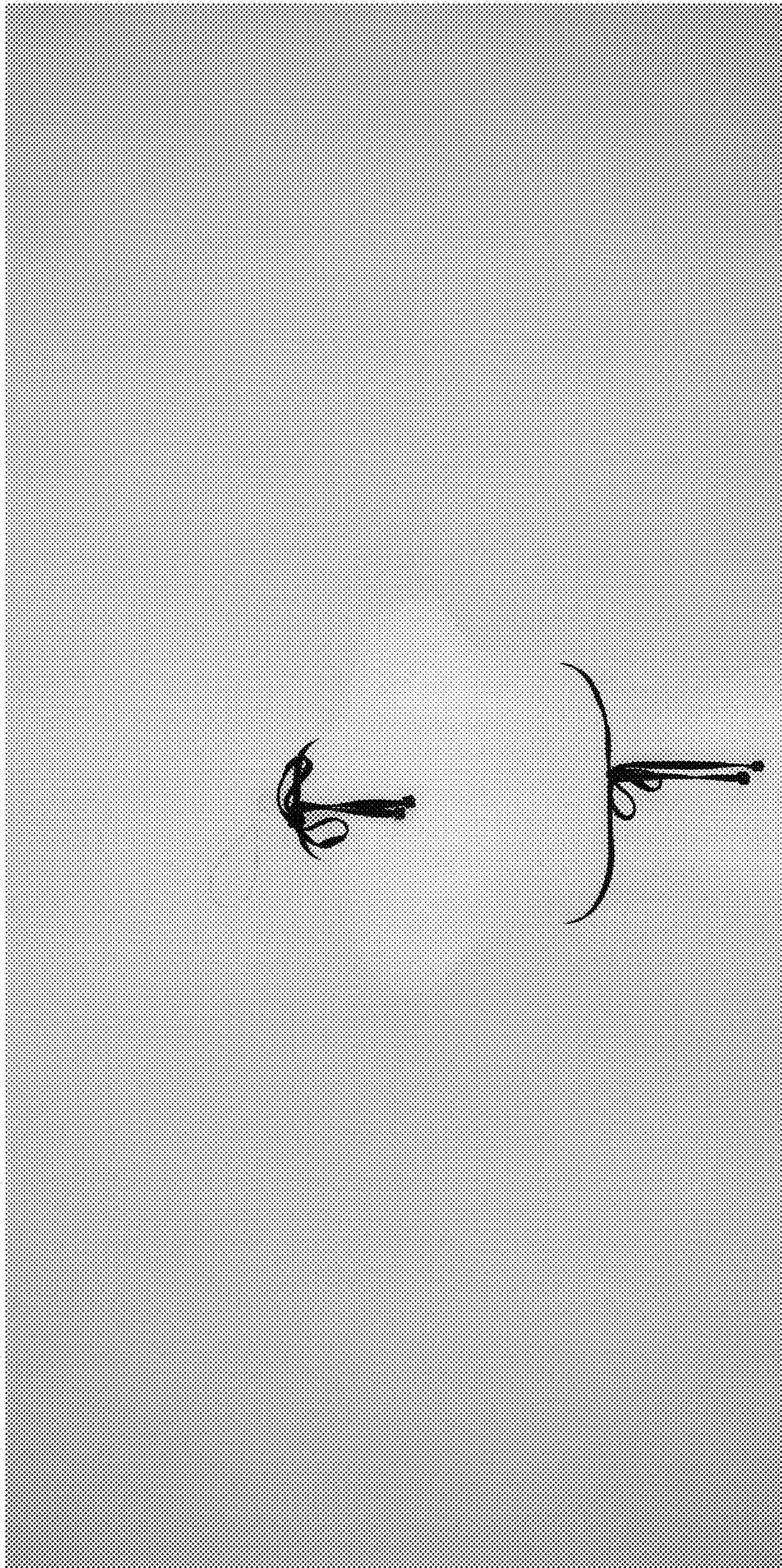

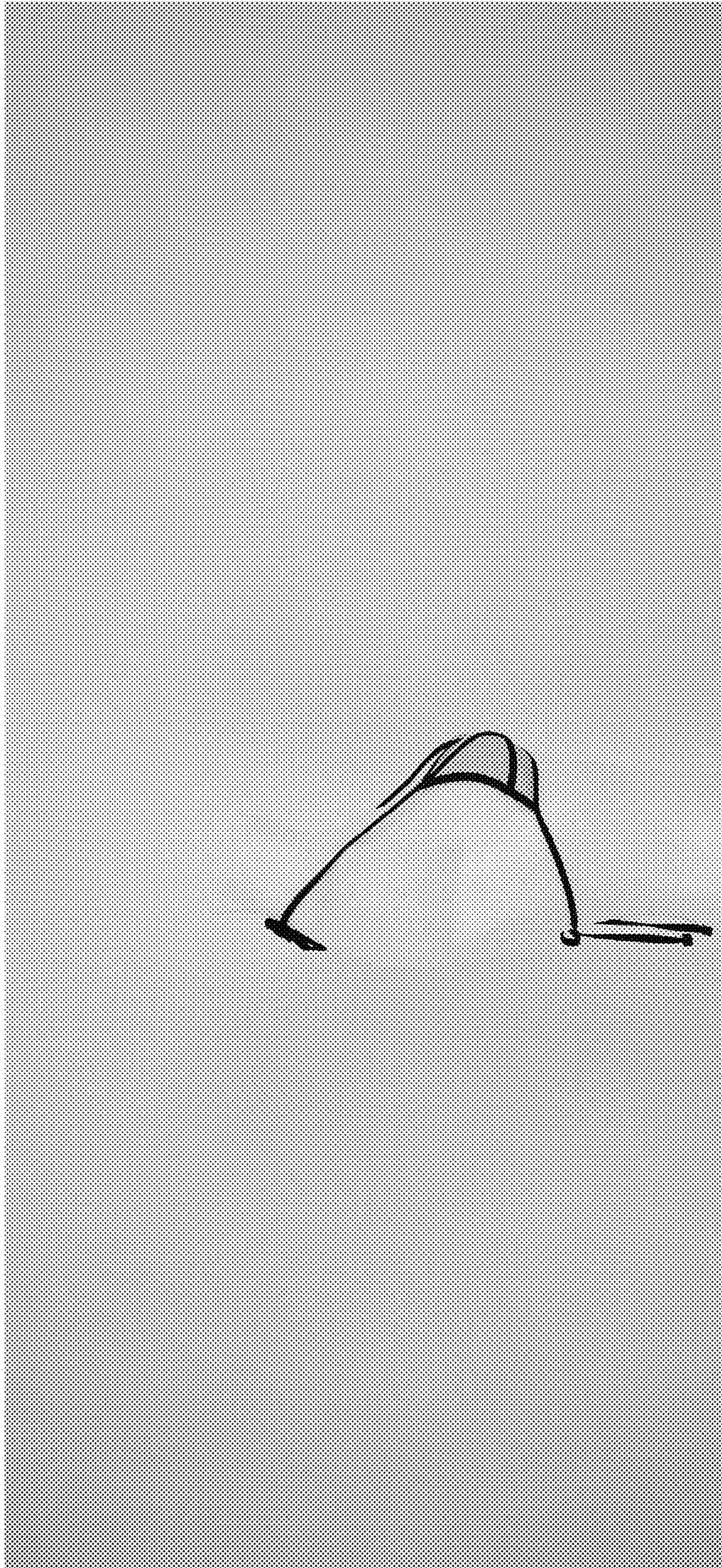

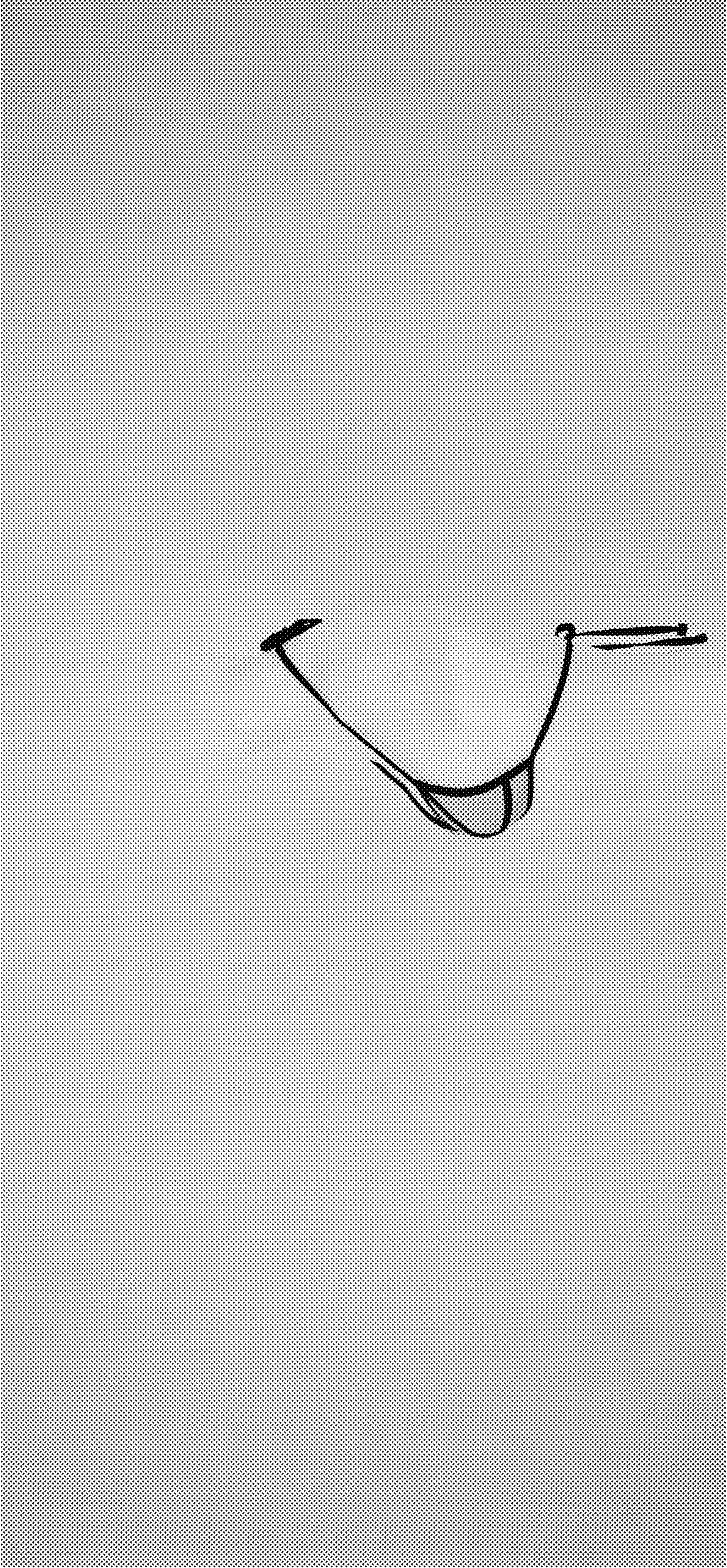
