FIG. 14 is a left side view of the wallet style portable electronic device case with the case in the closed position;

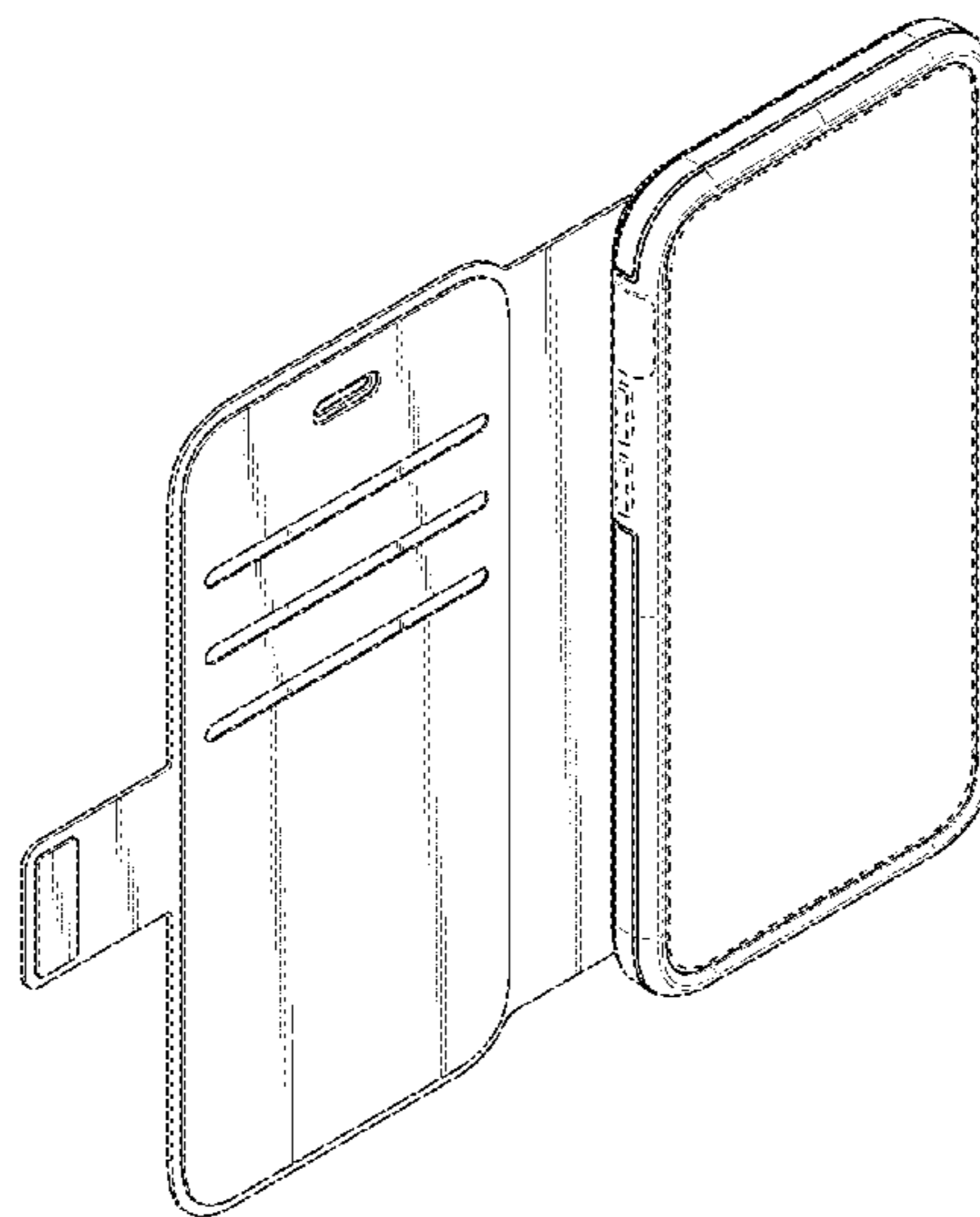
FIG. 15 is a right side view of the wallet style portable electronic device case with the case in the closed position;

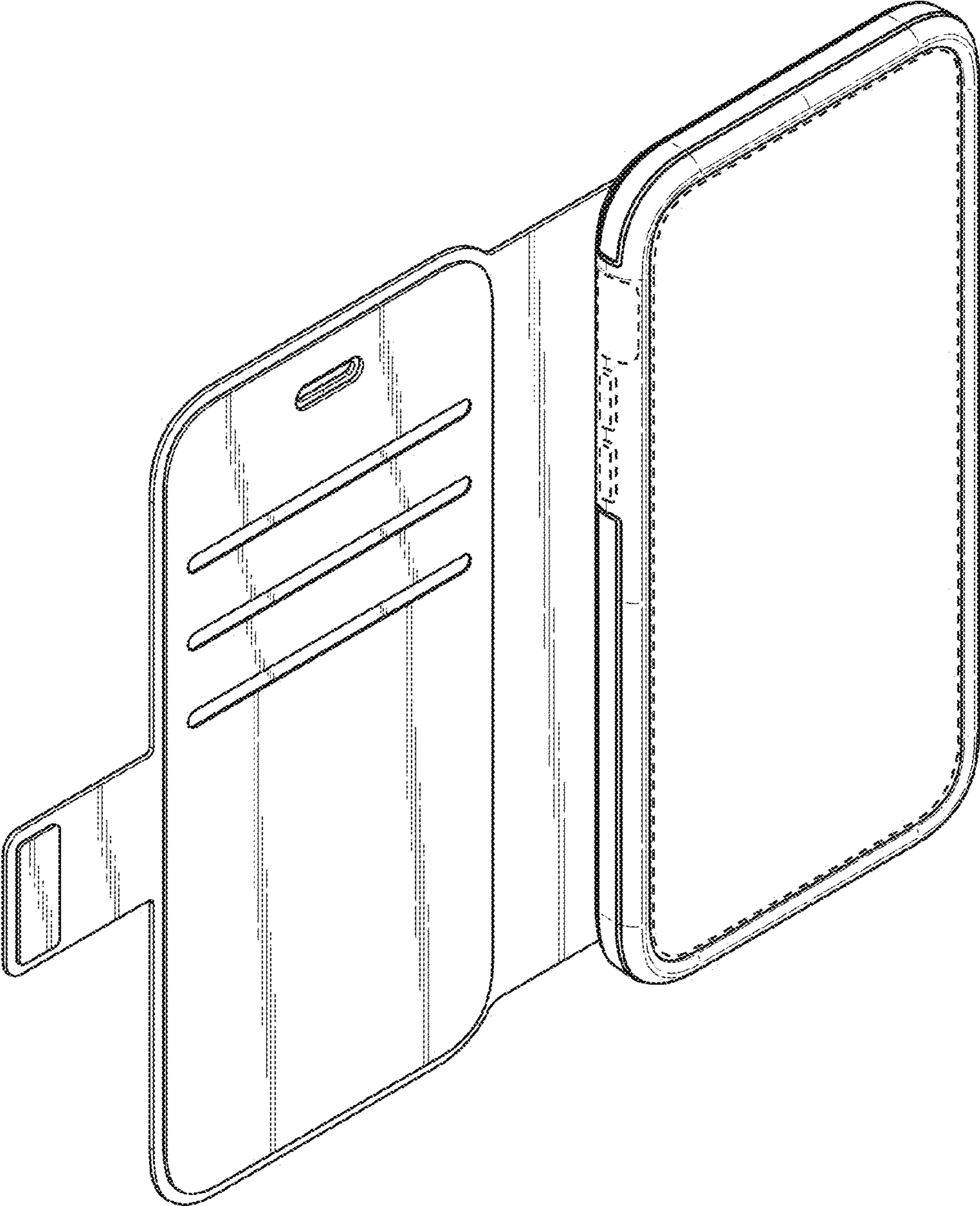

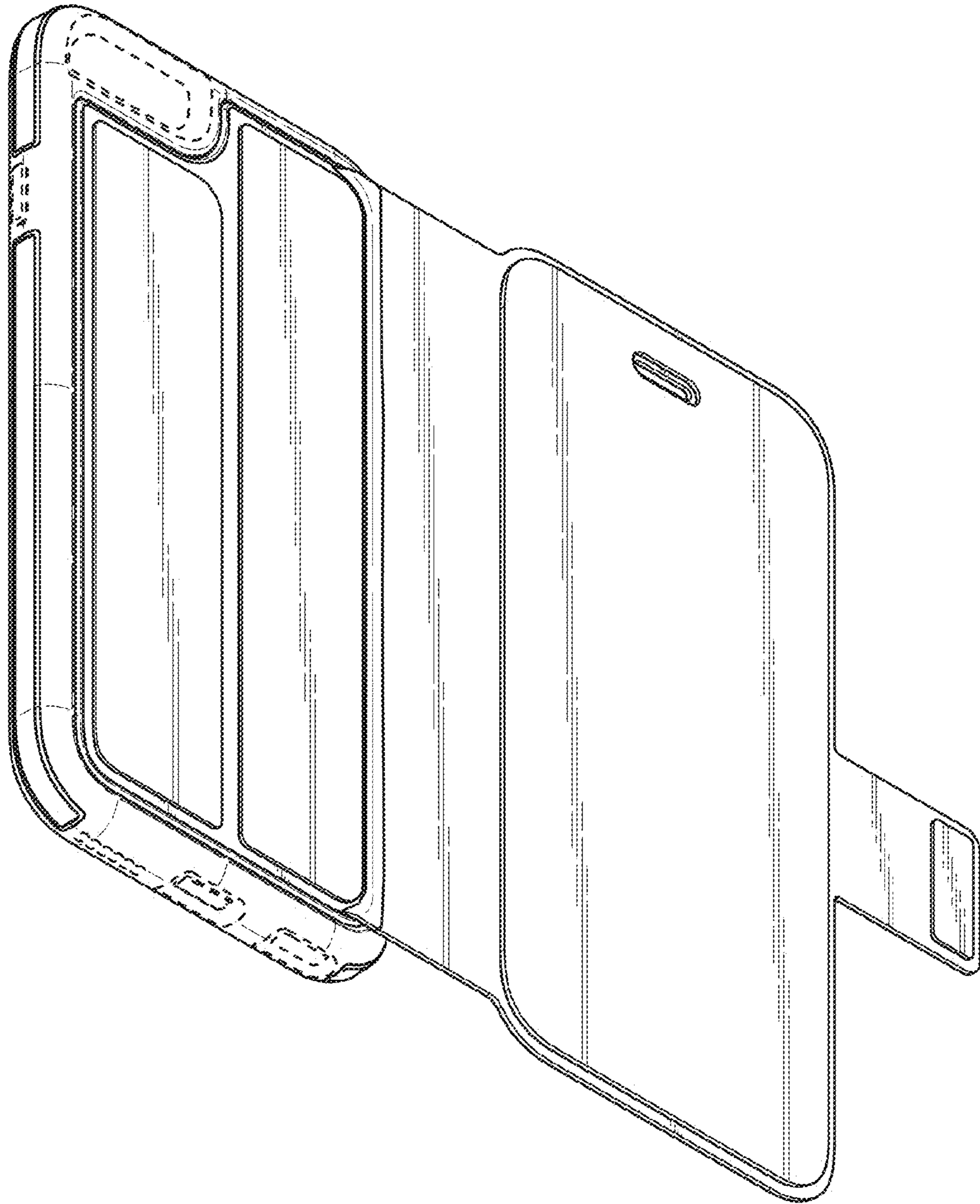

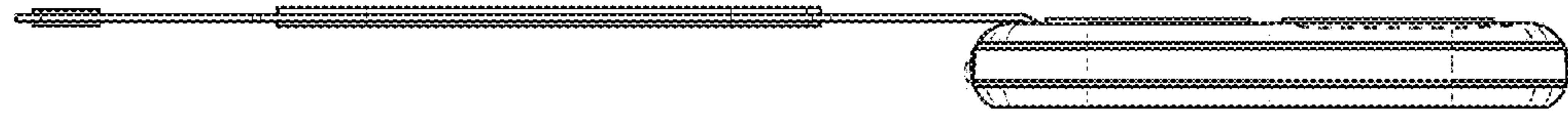

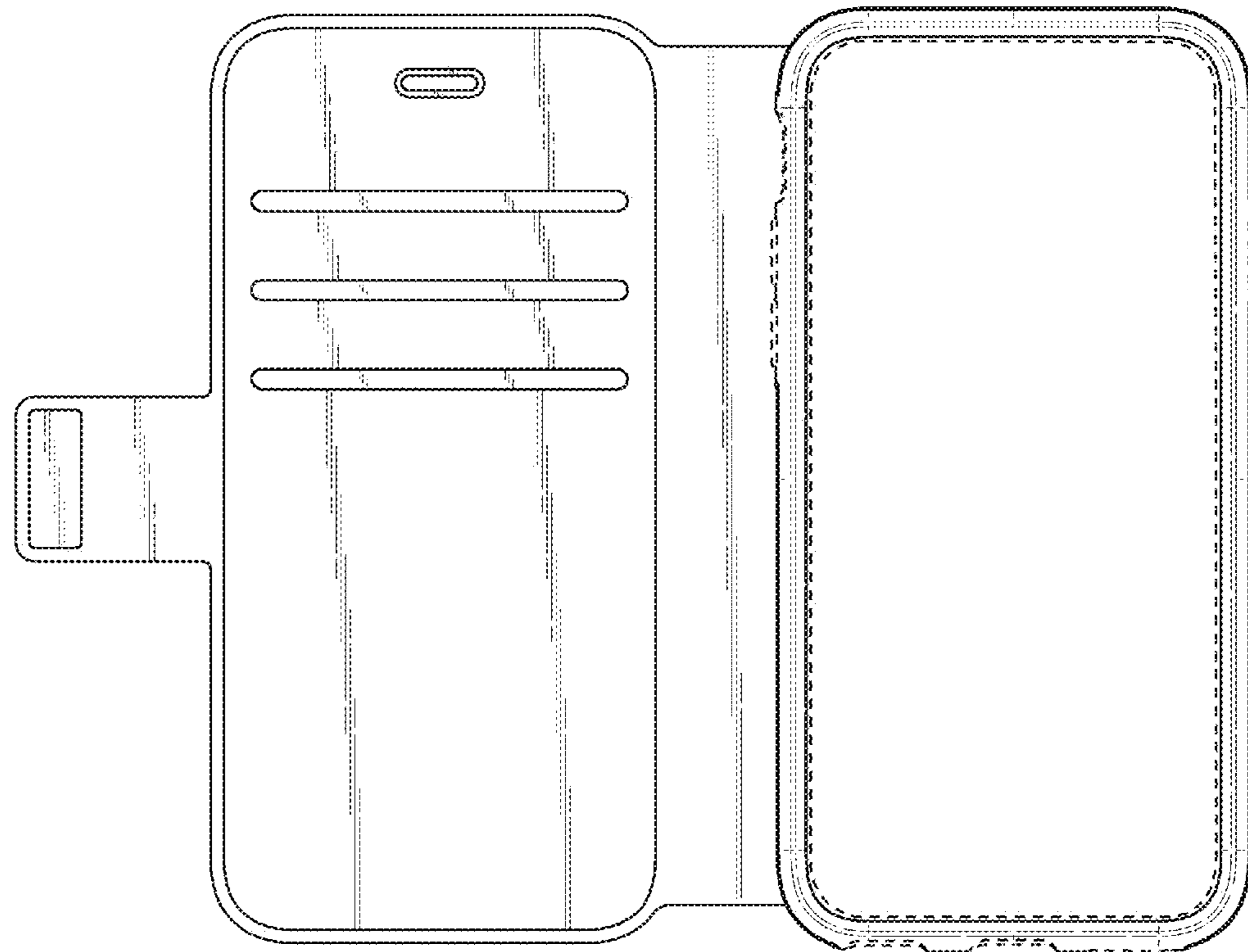

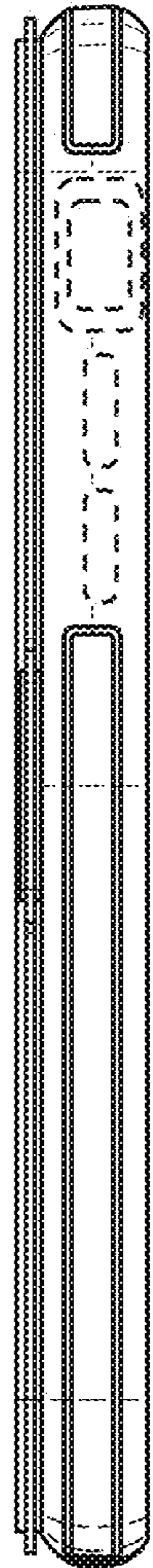

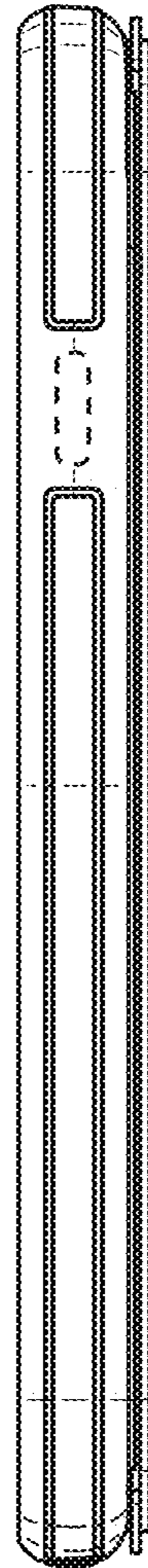

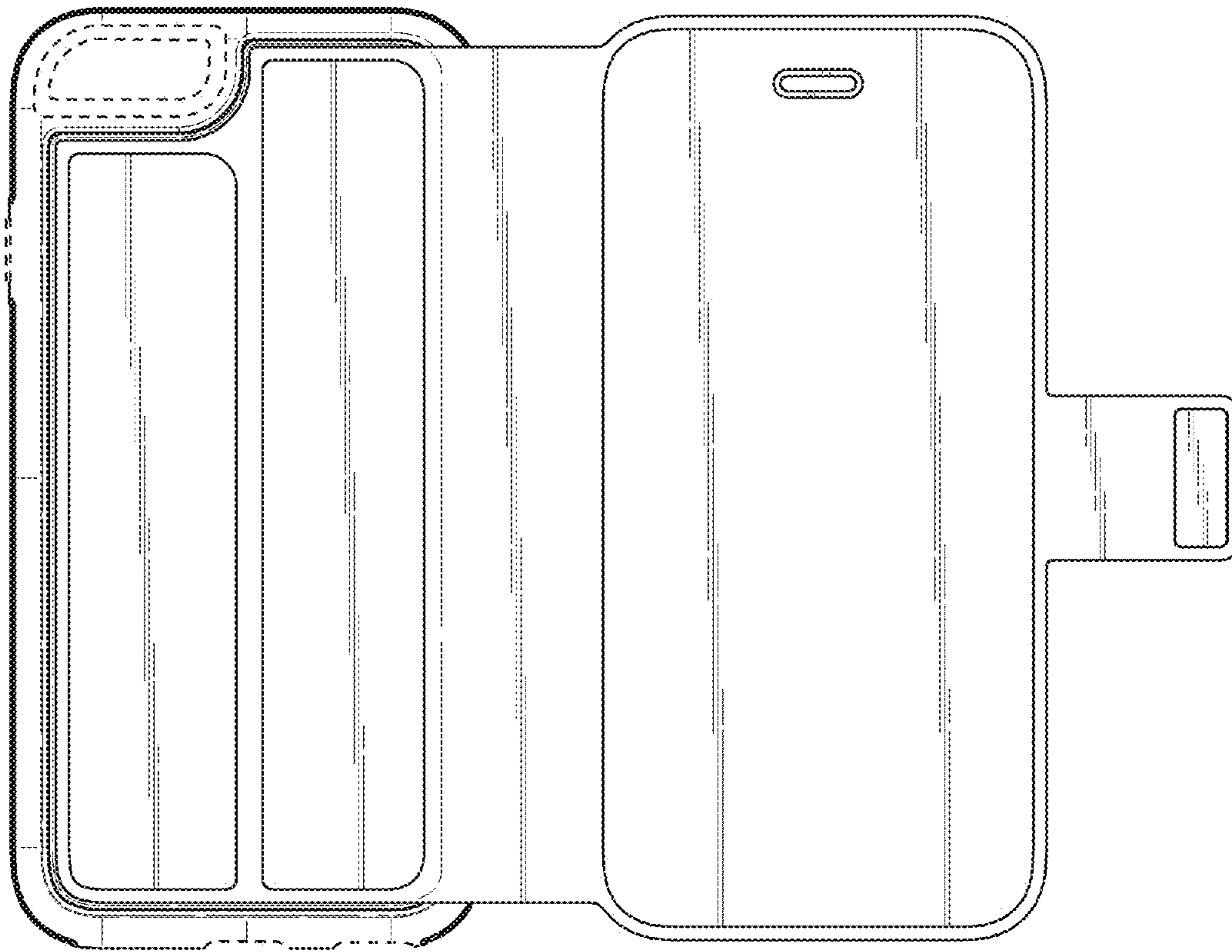

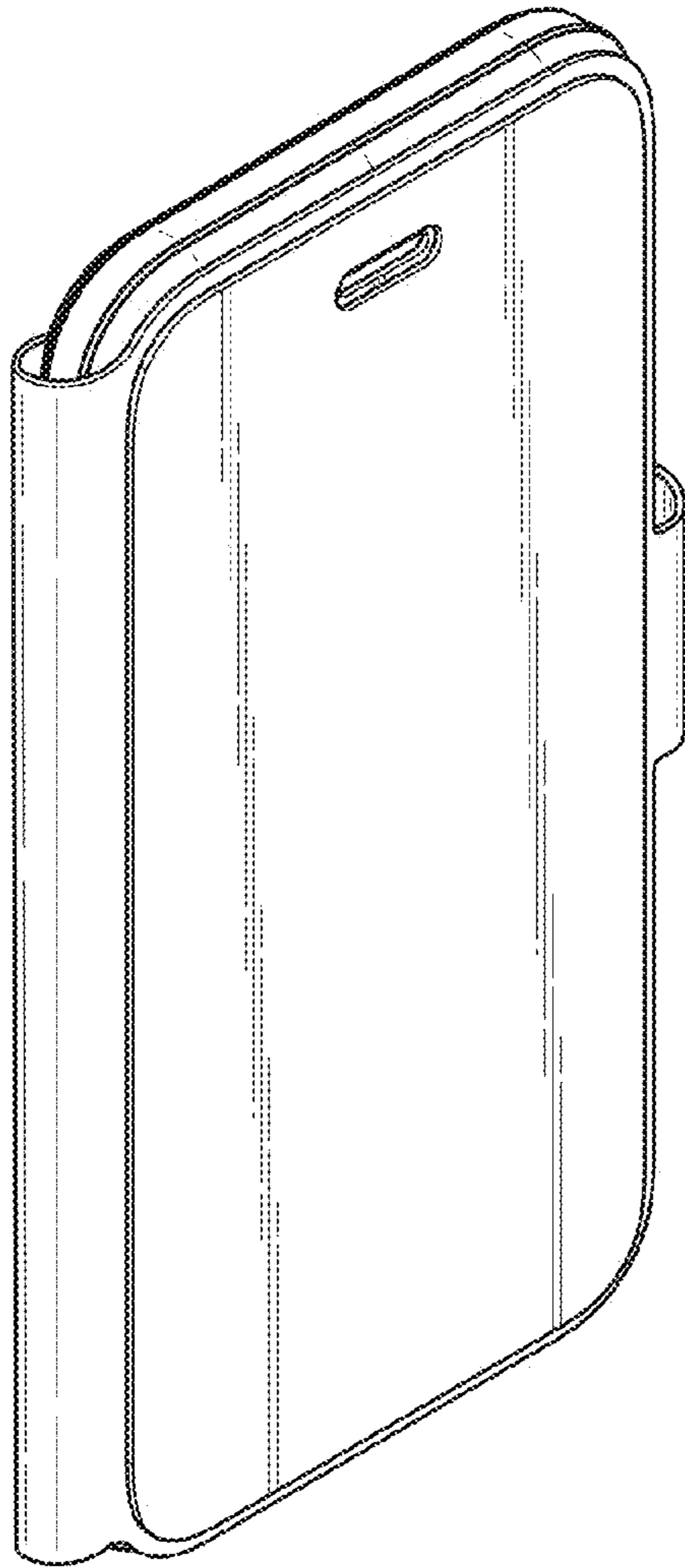

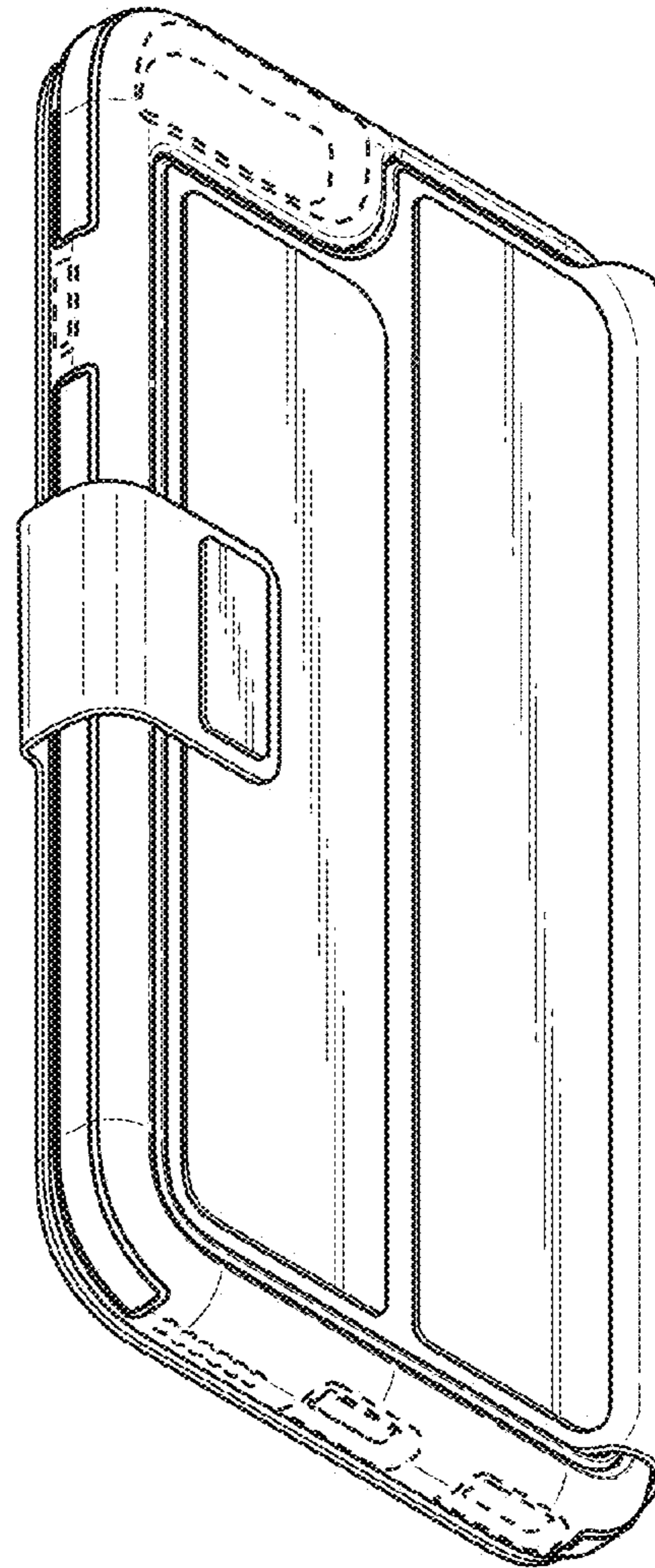

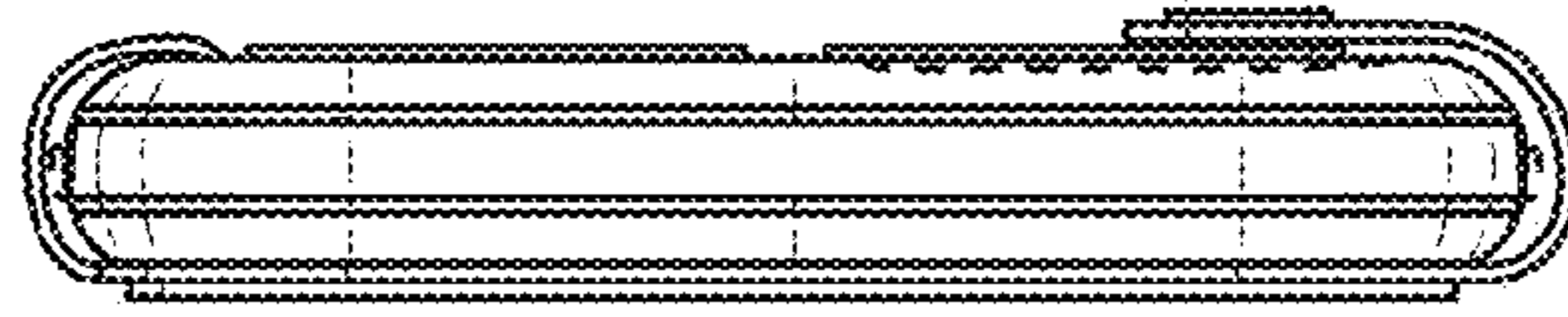

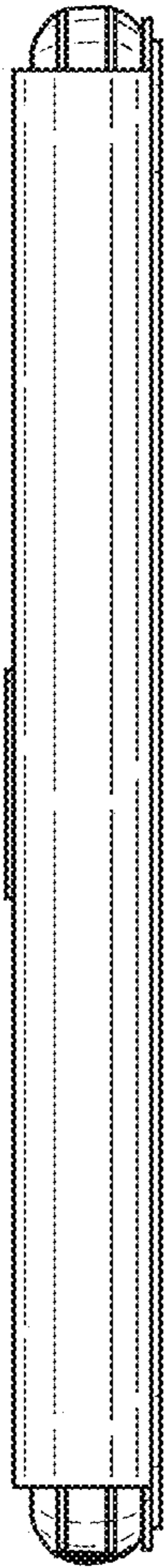

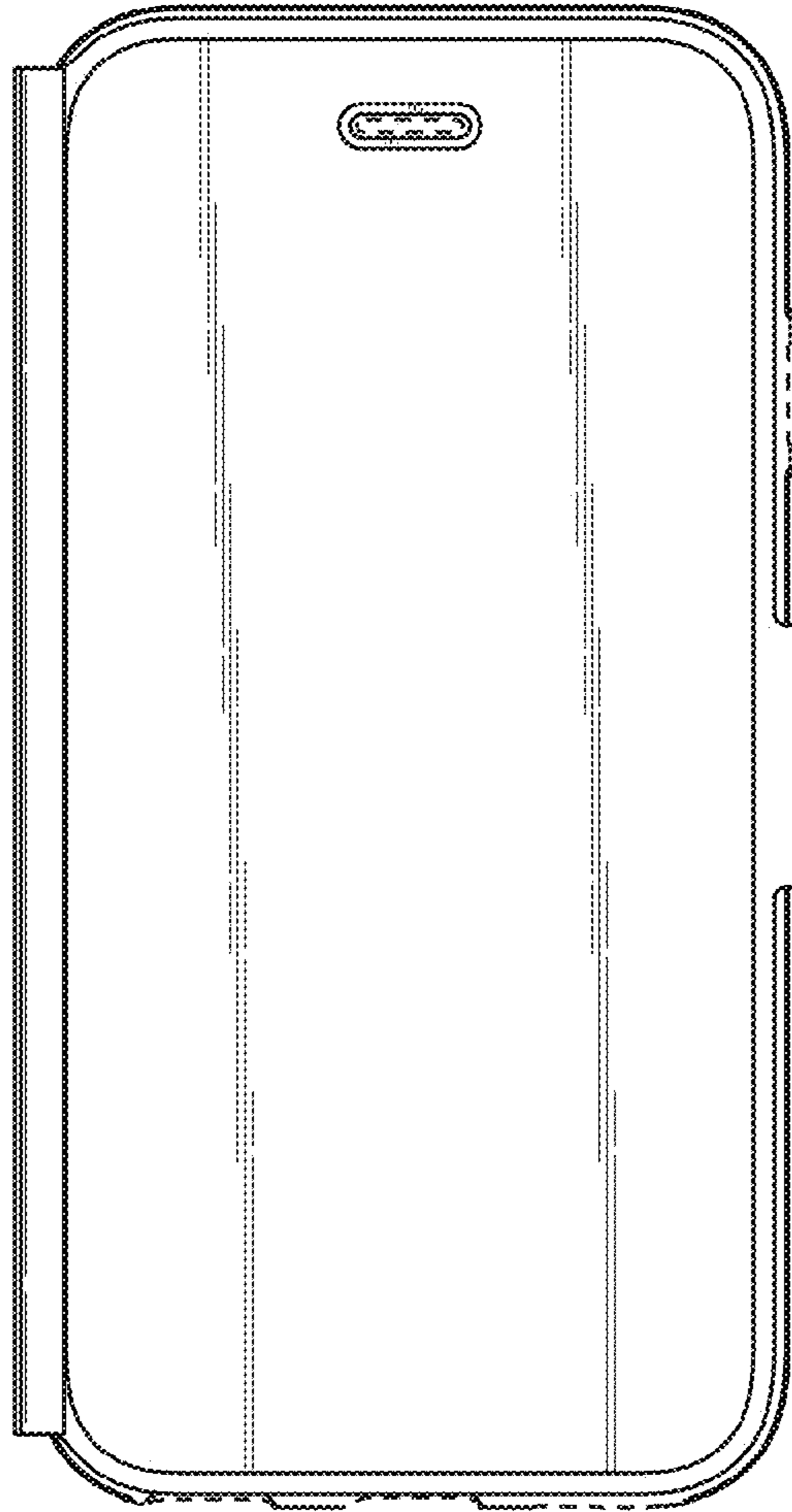

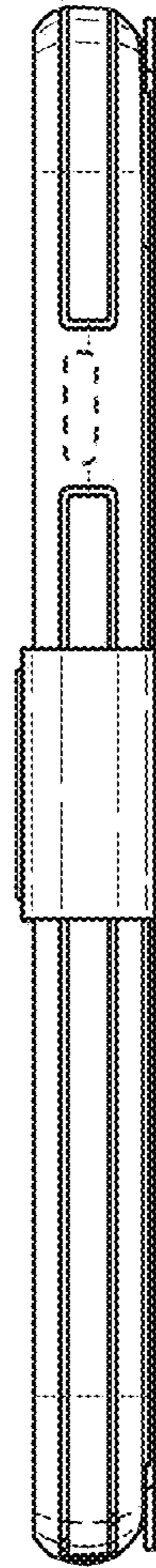

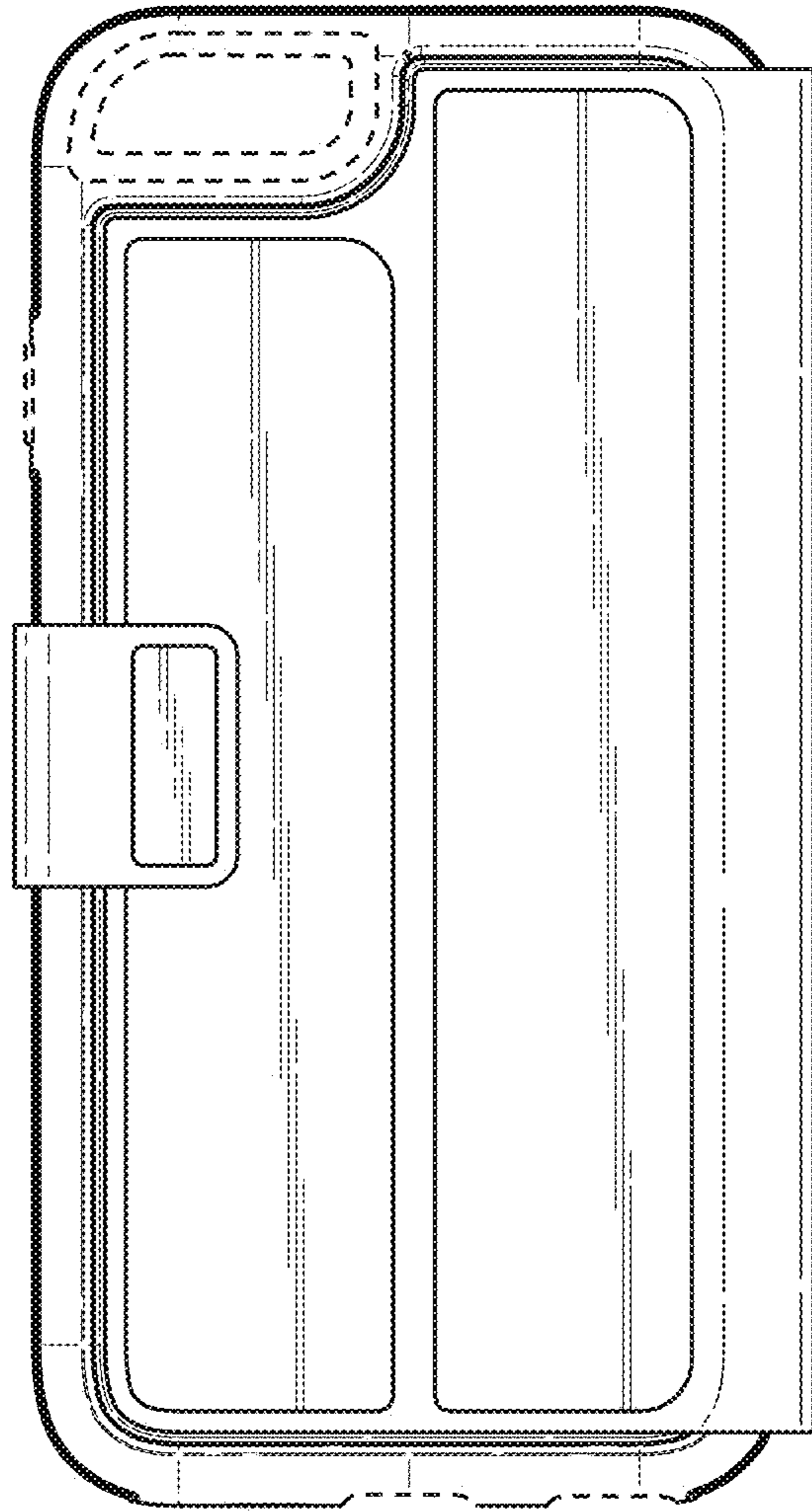
