(57) **CLAIM**

The ornamental design for a basket, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a new design for a basket;

FIG. 2 is a bottom, front perspective view of the new design for a basket seen in FIG. 1;

FIG. 3 is a front elevation view of the new design for a basket seen in FIG. 1; rear view being identical;

FIG. 4 is a side elevation view of the new design for a basket seen in FIG. 1; other side being identical;

FIG. 5 is a top plan view of the new design for a basket seen in FIG. 1; and,

FIG. 6 is a bottom plan view of the new design for a basket seen in FIG. 1.

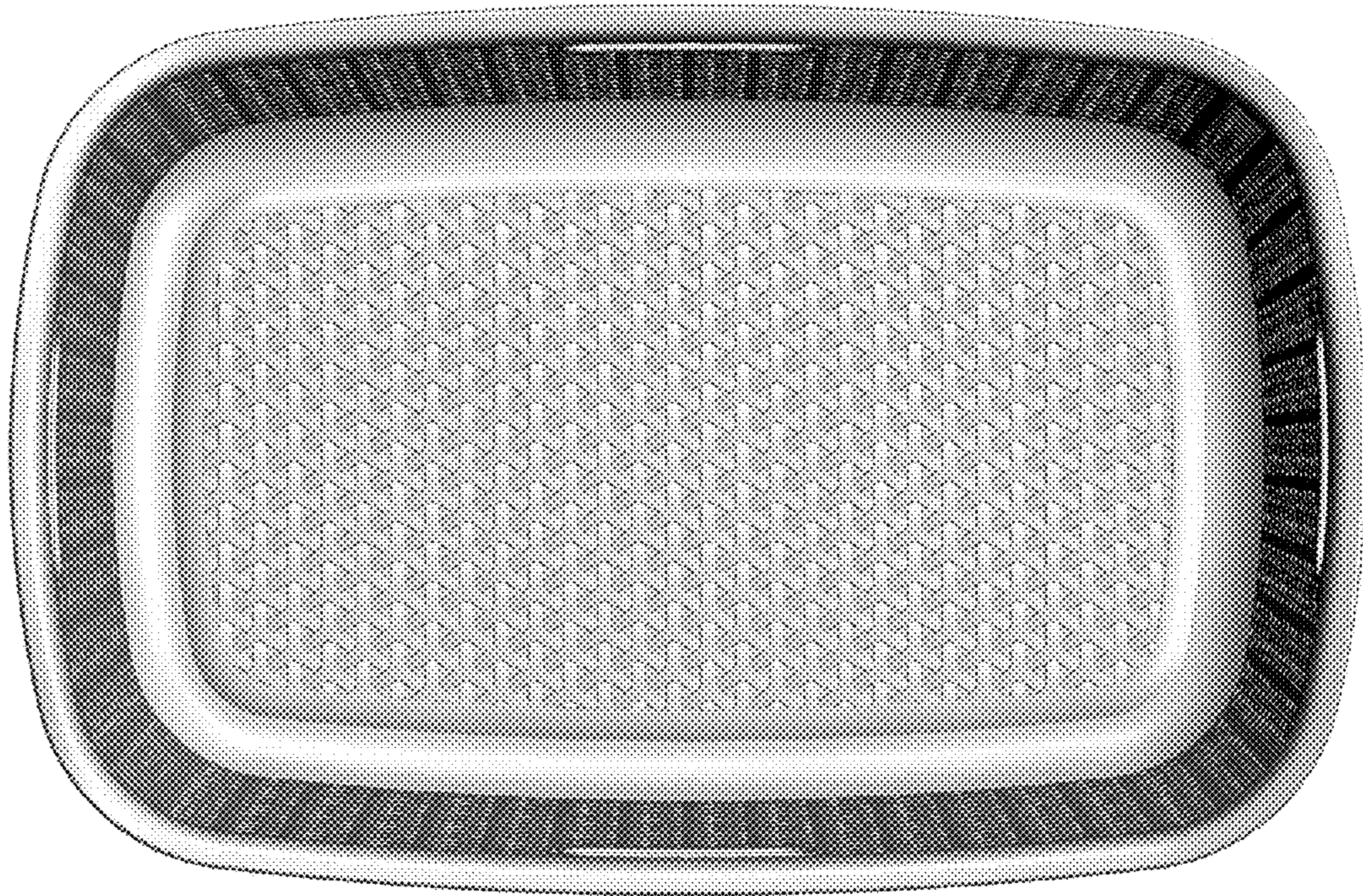
