FIG. 6 is a right side view of the drinking container infuser; and,

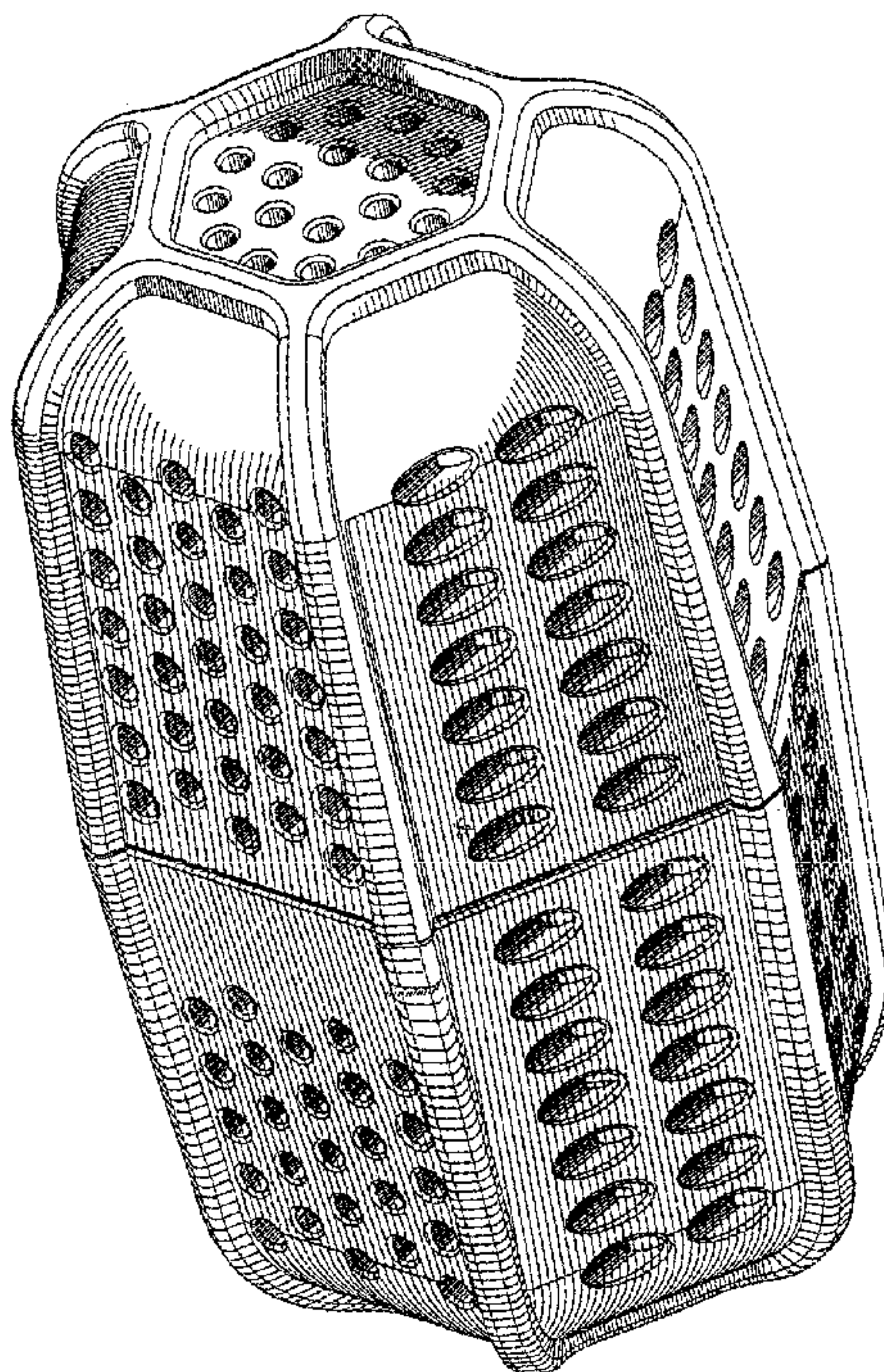
FIG. 7 is a left side view of the drinking container infuser.

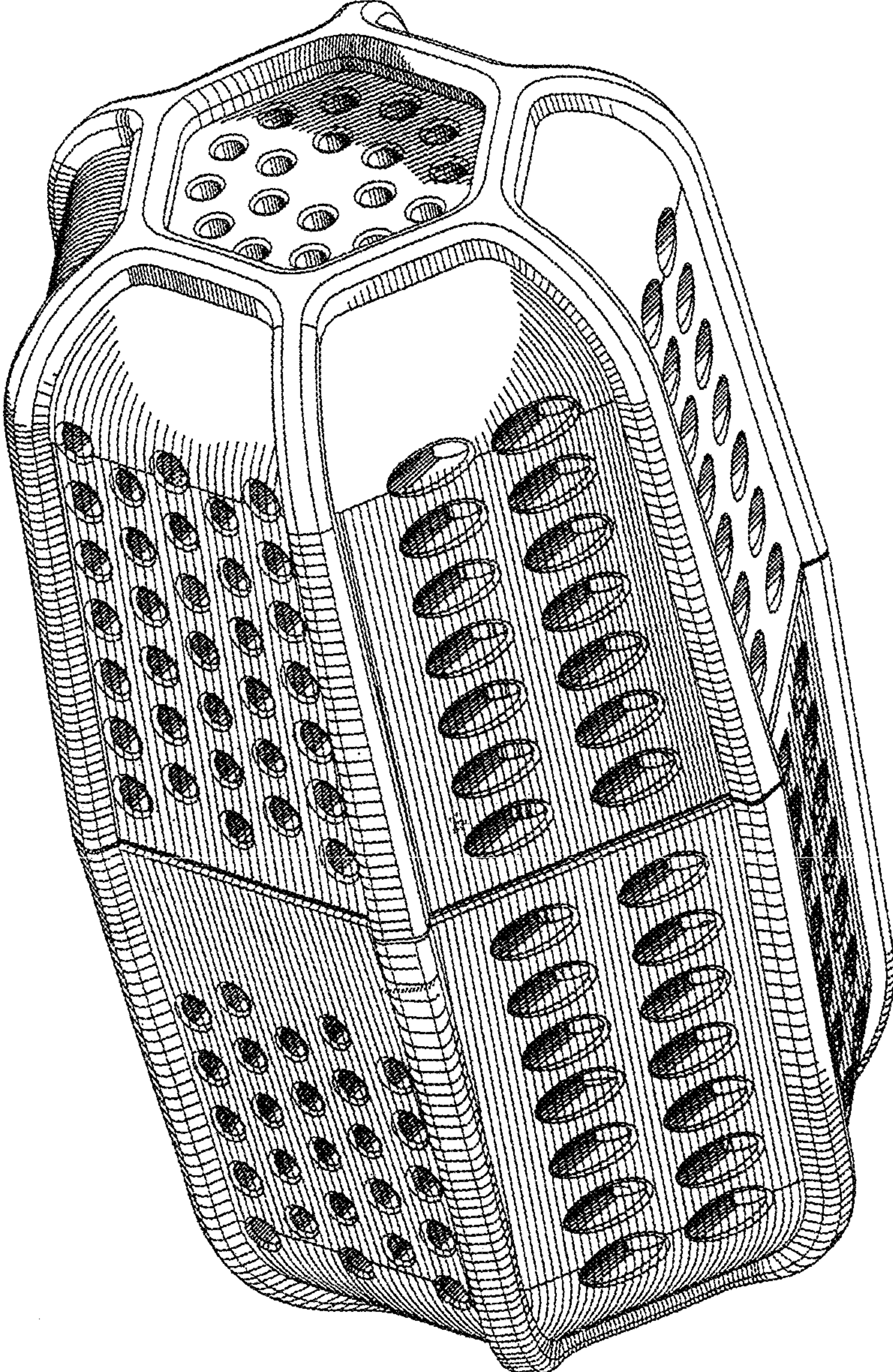

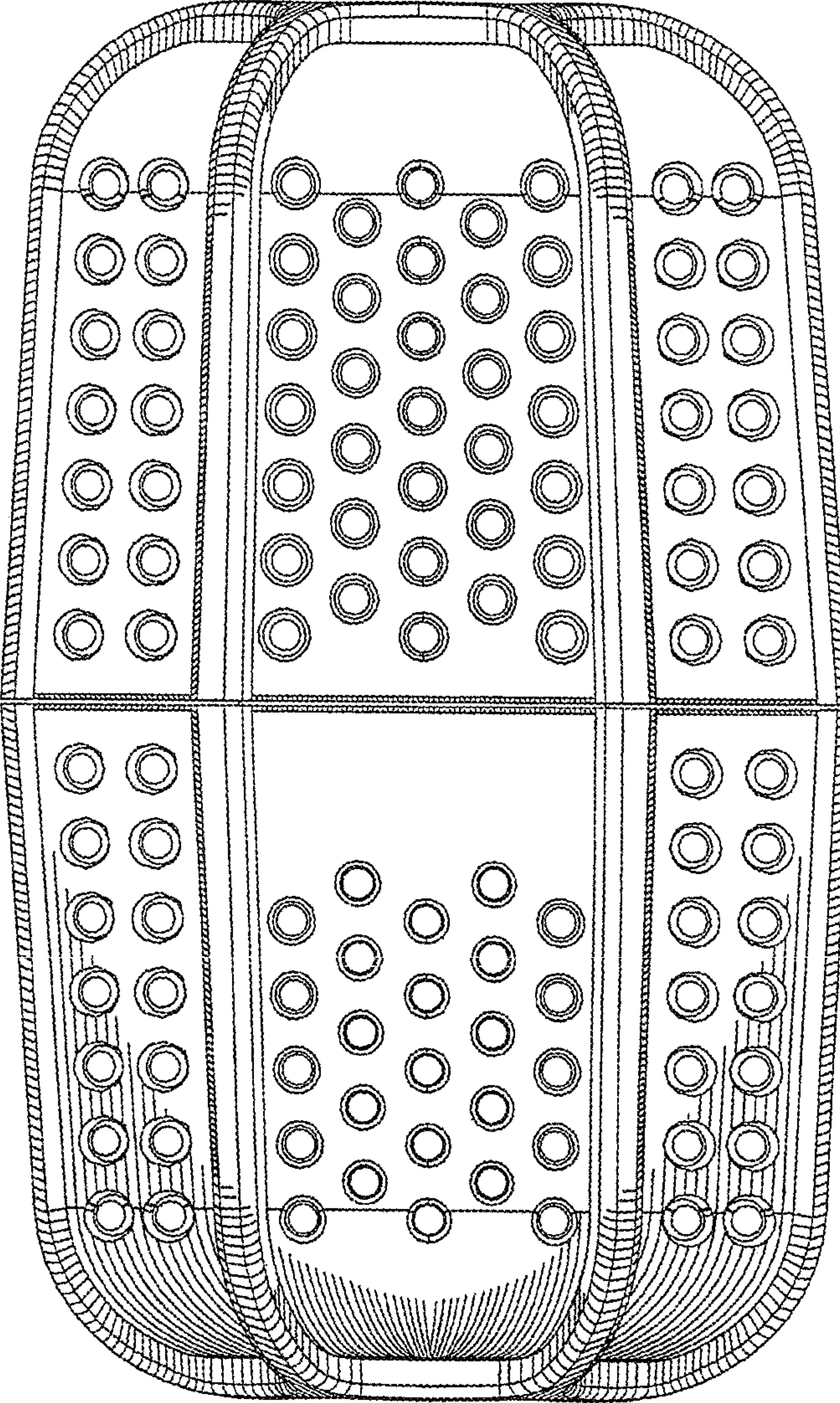

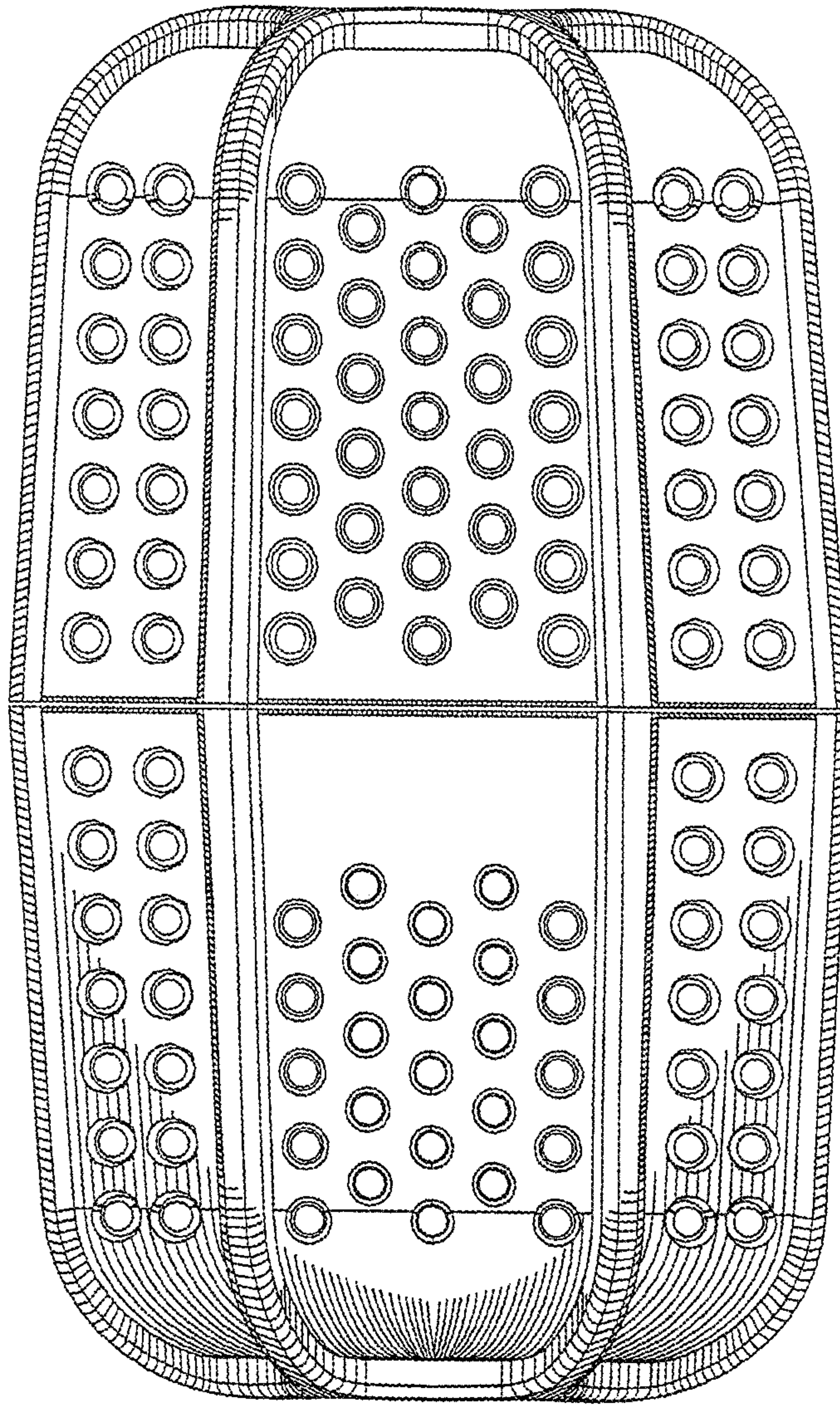

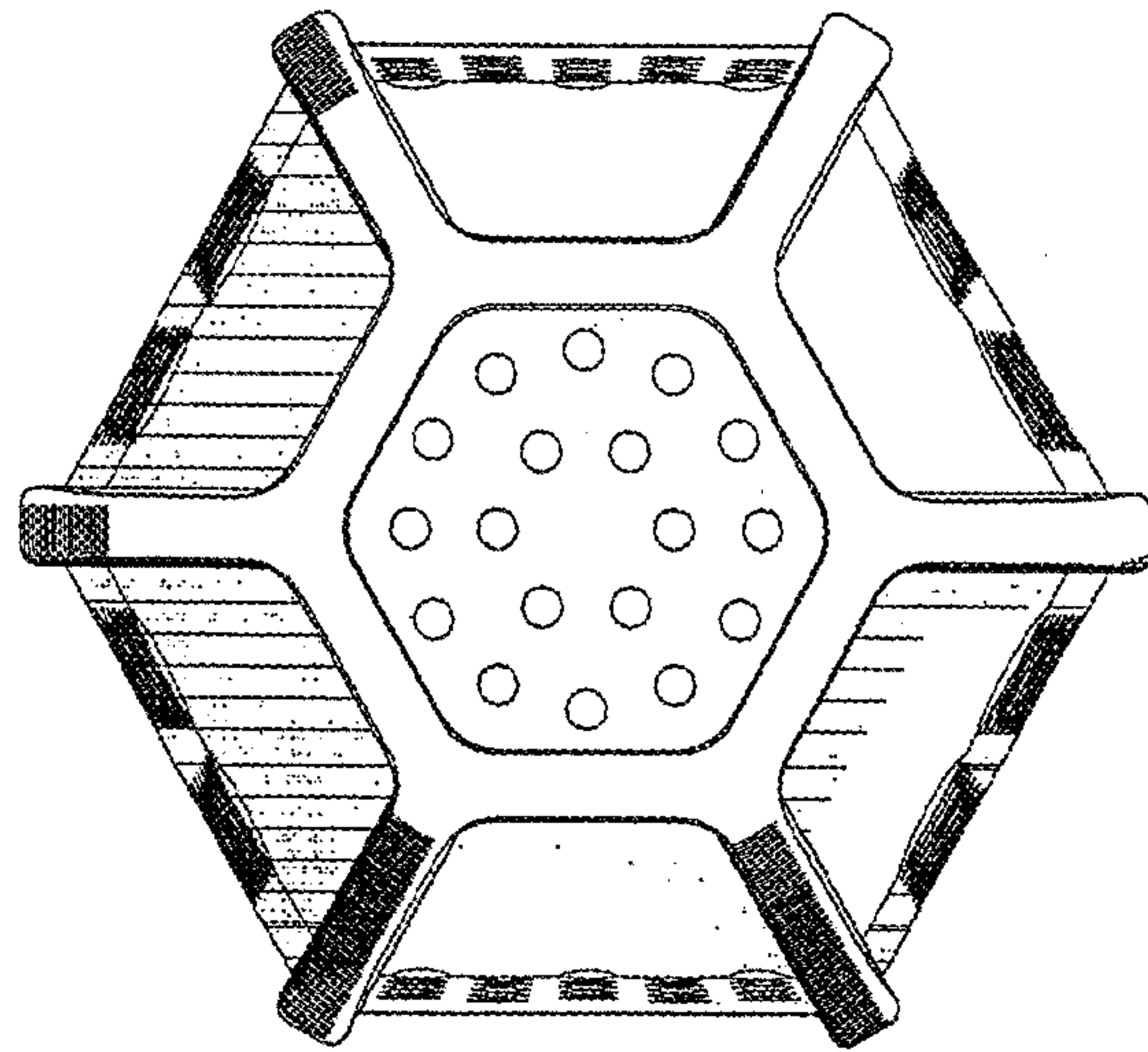

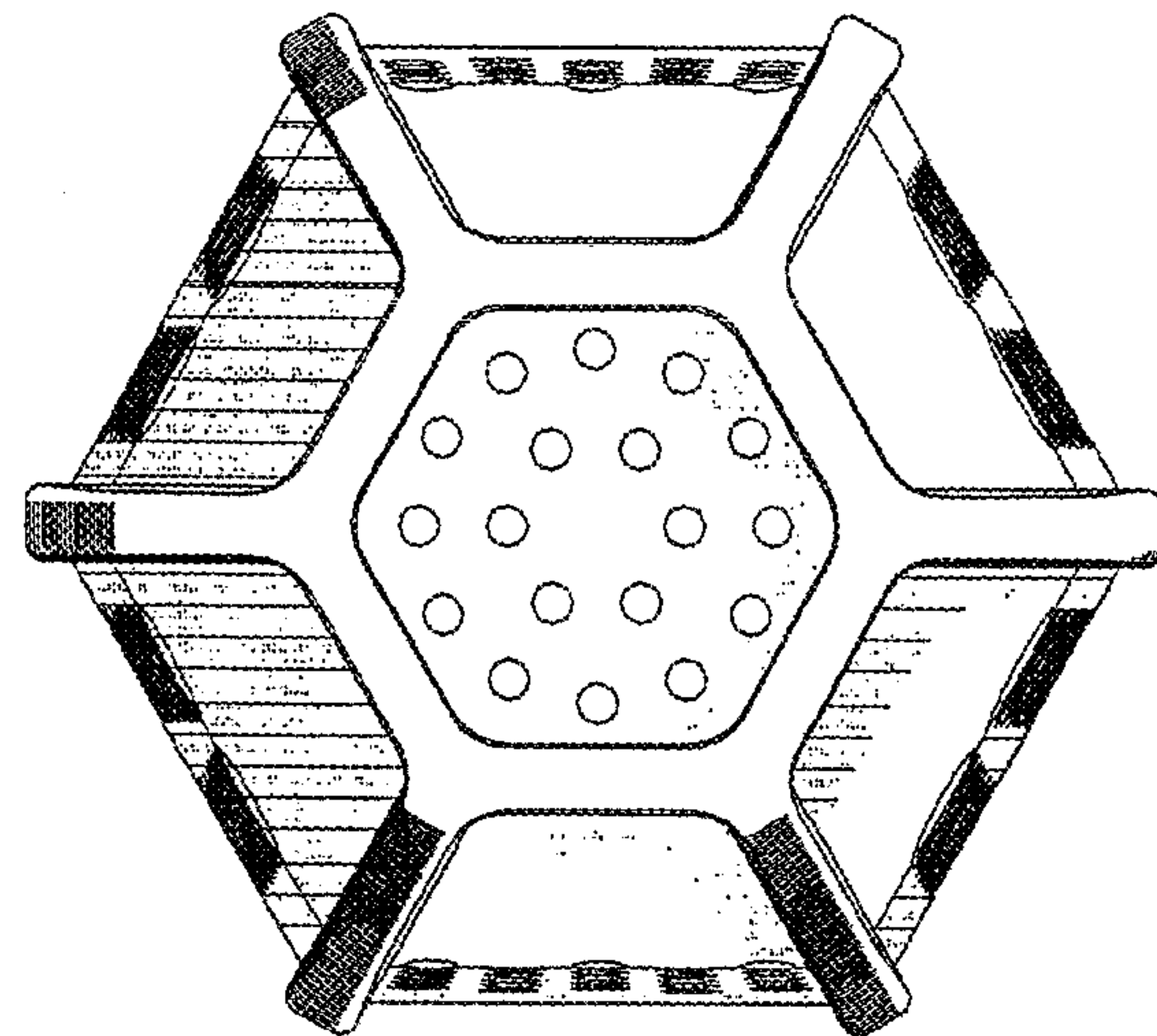

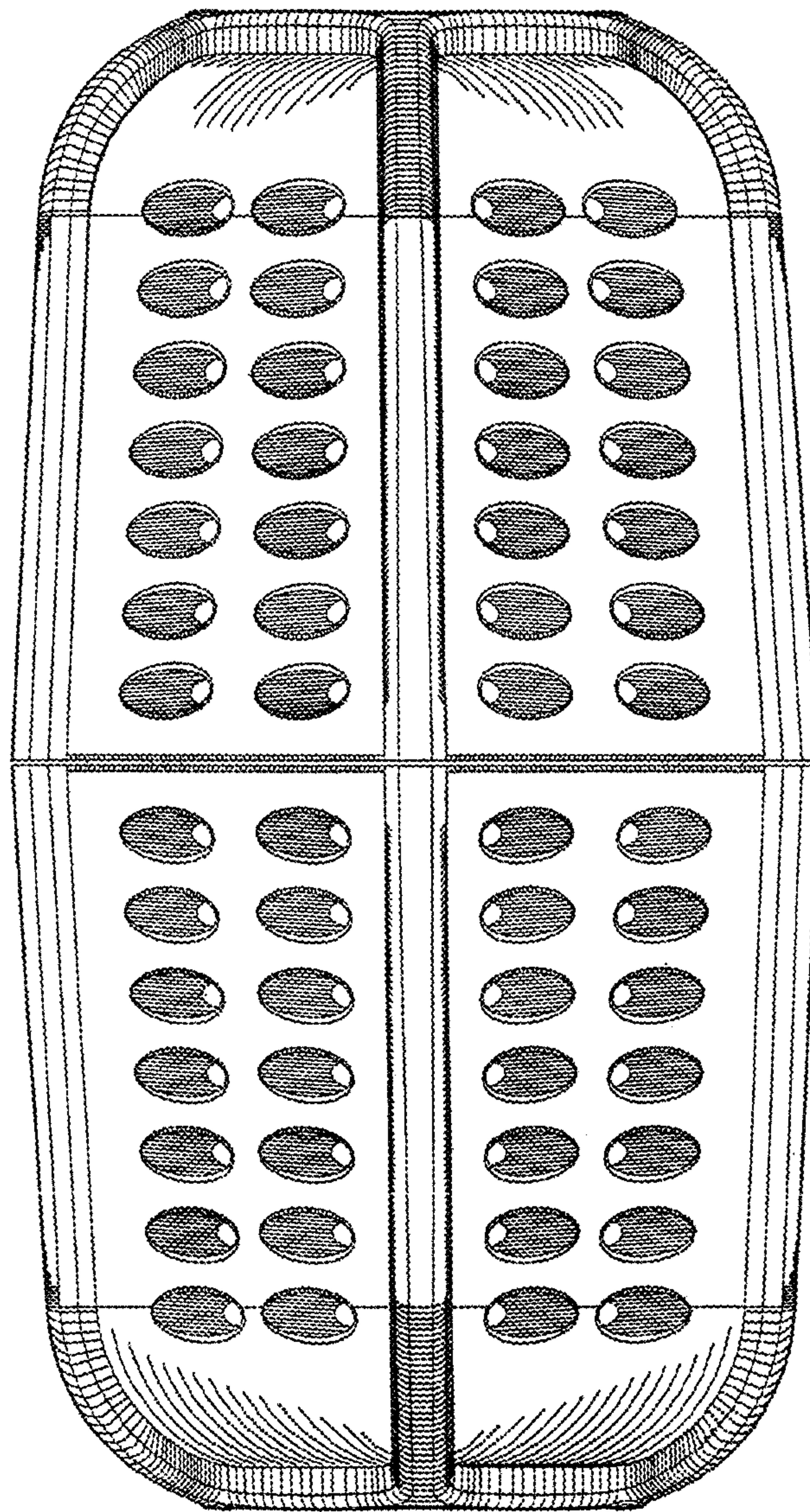

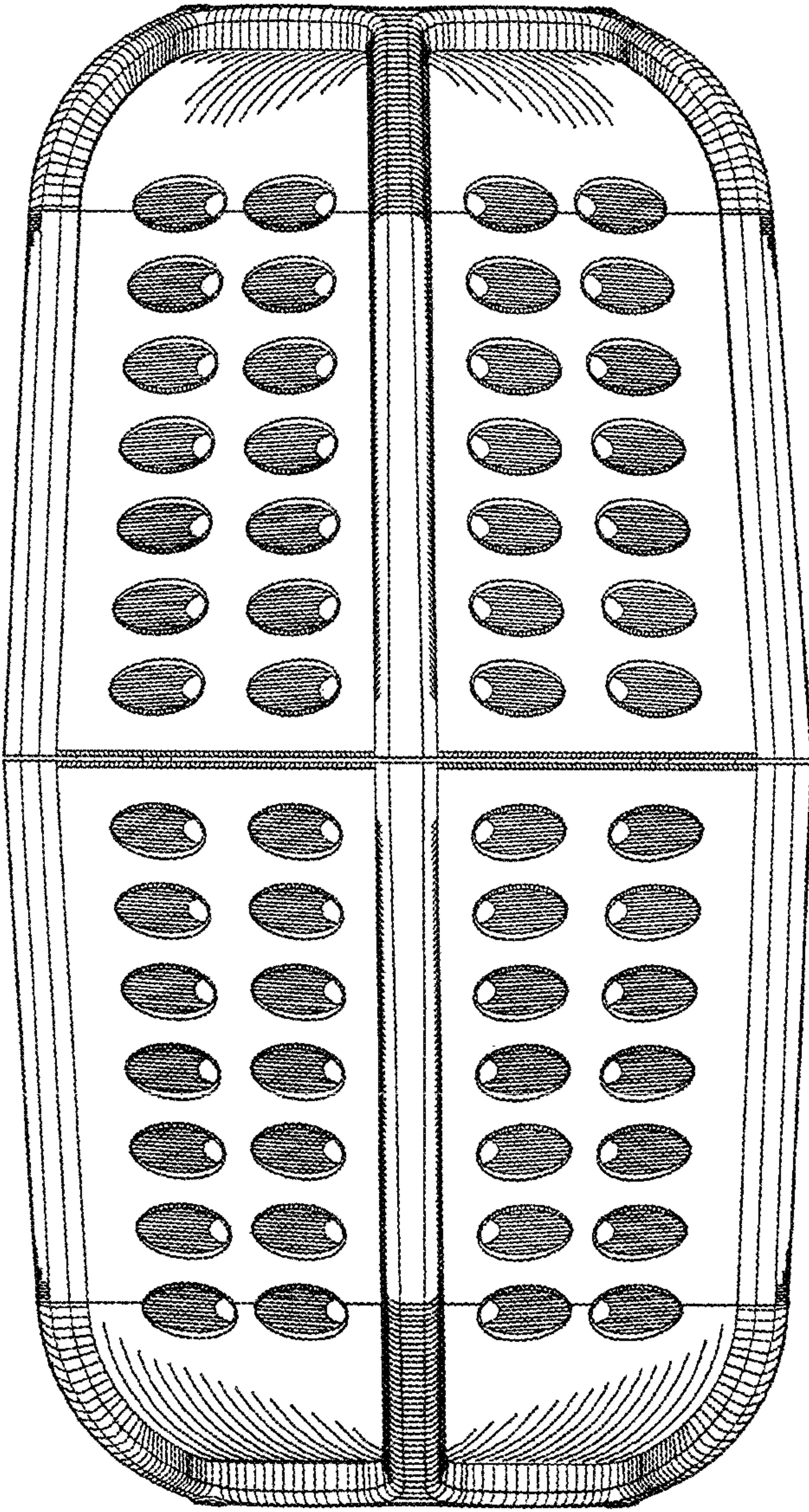
