DESCRIPTION

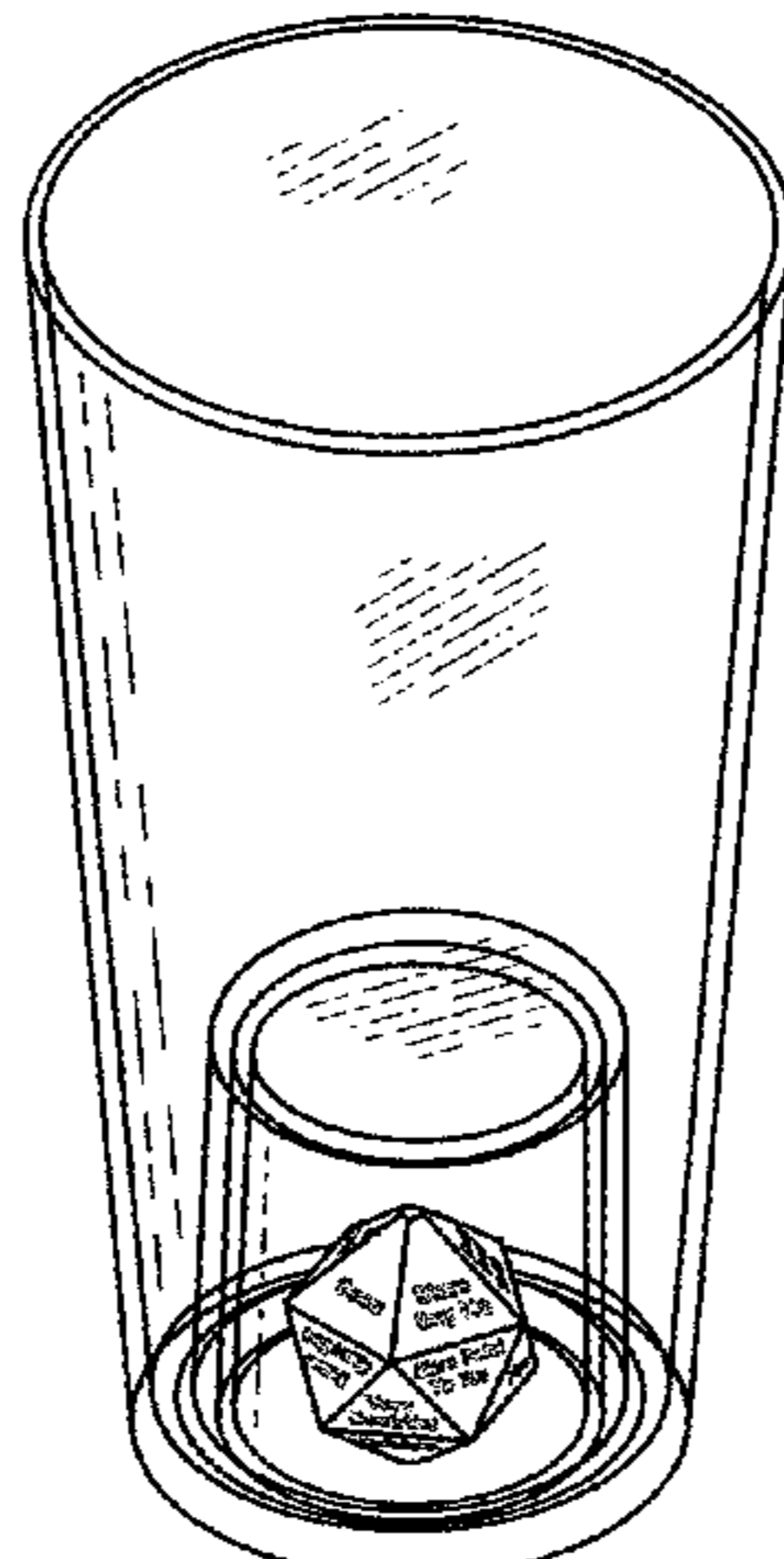
FIG. 1 is a top and front perspective view of a fortune glass showing our new design;

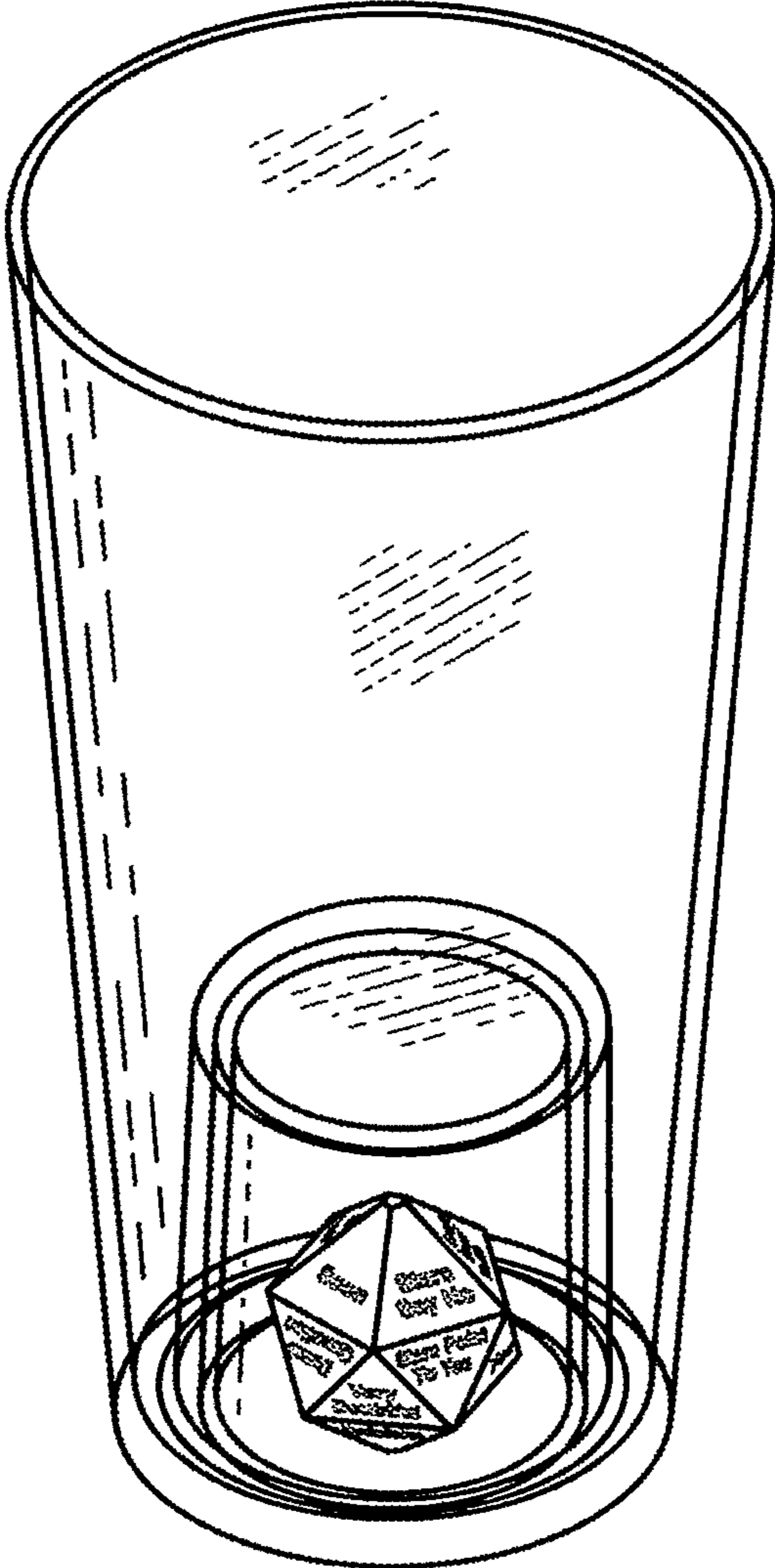

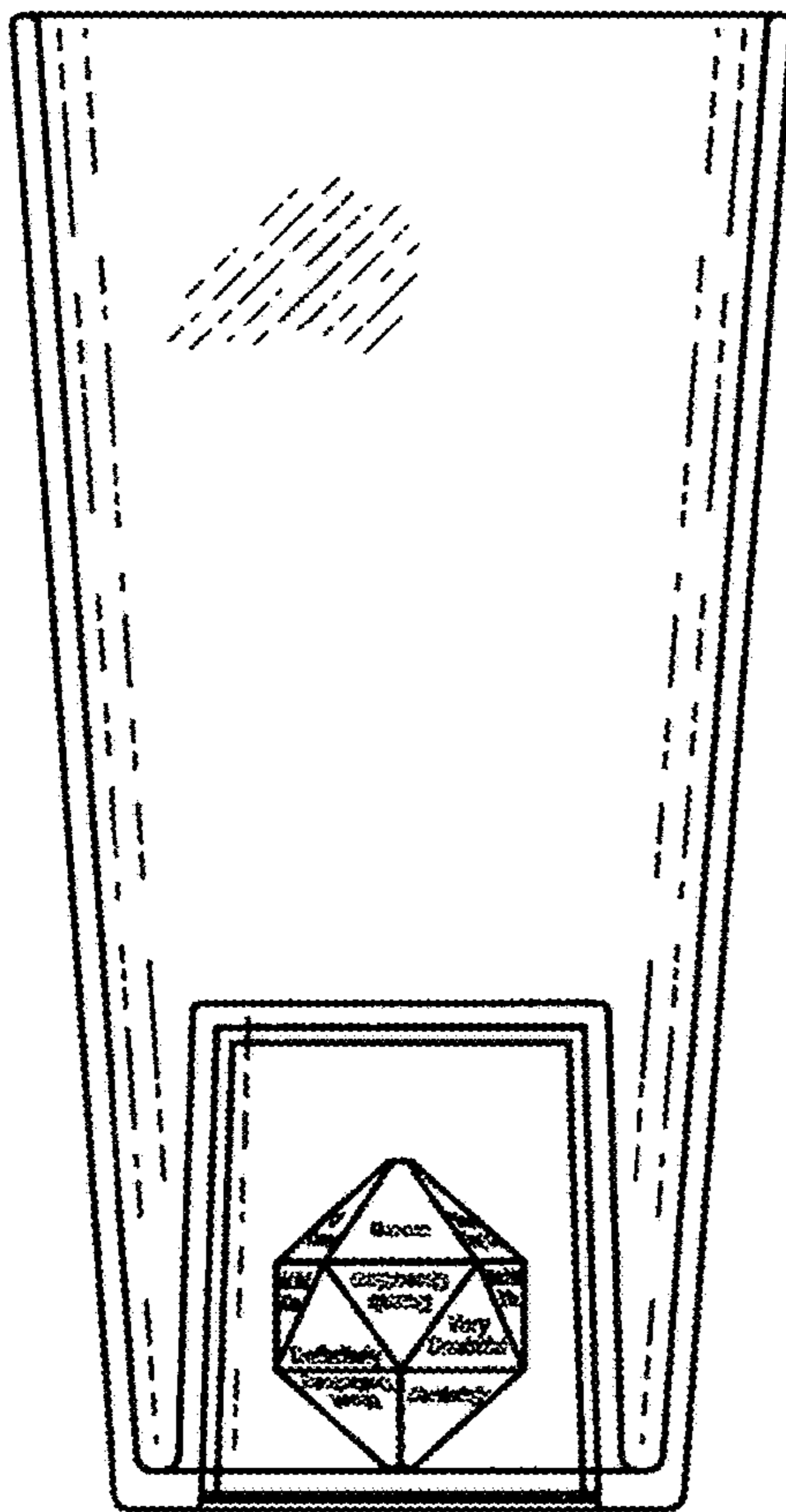

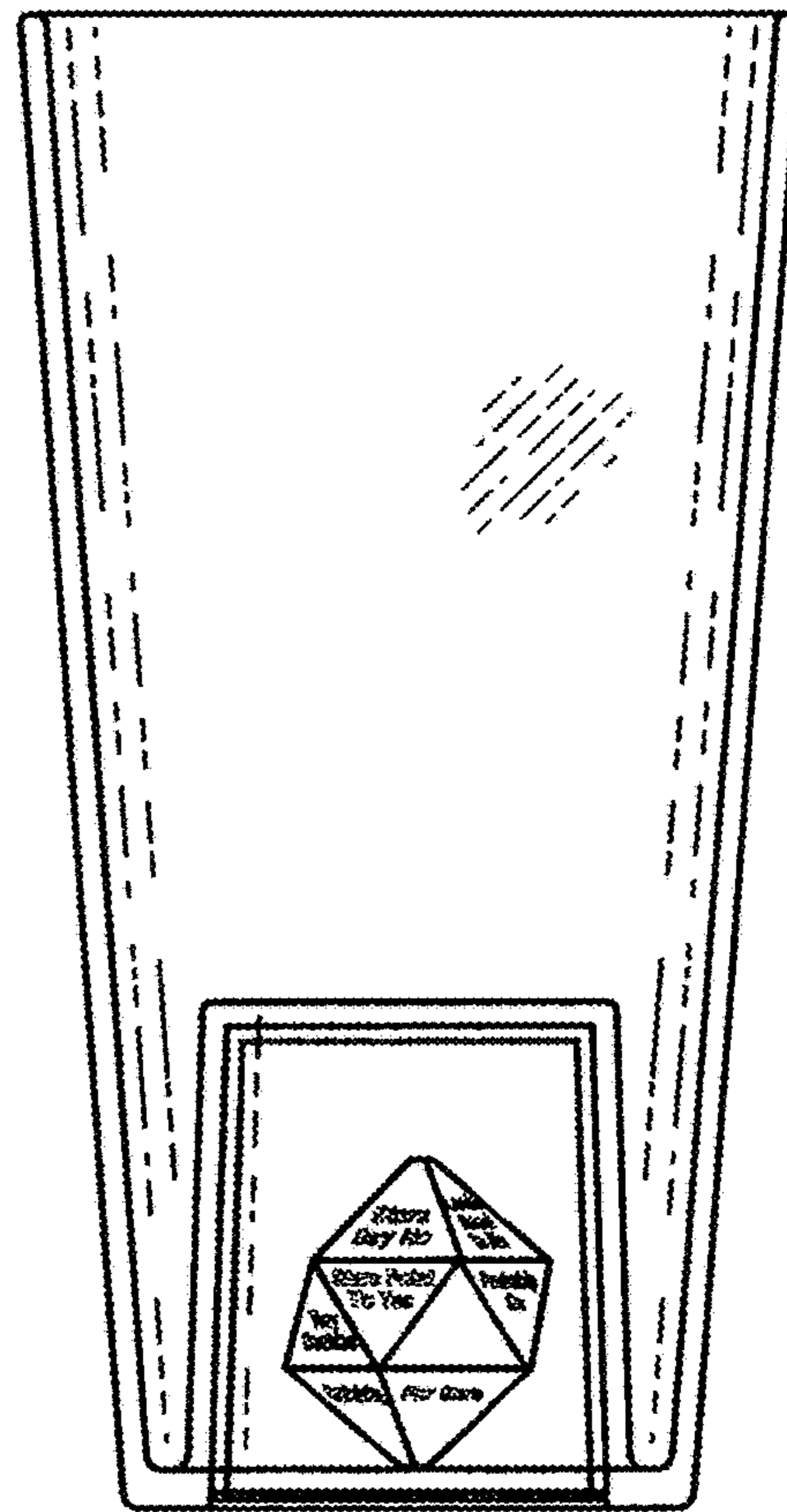

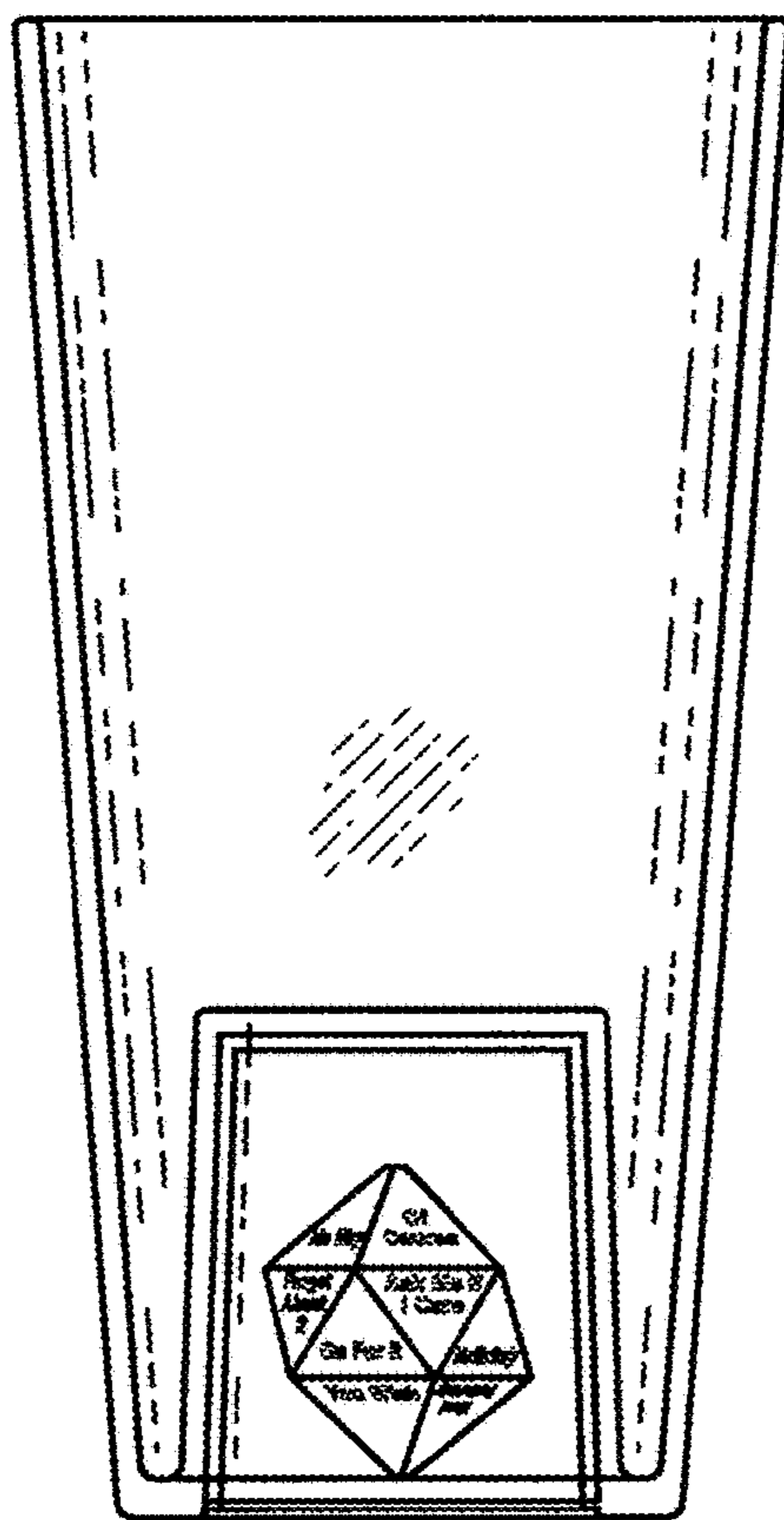

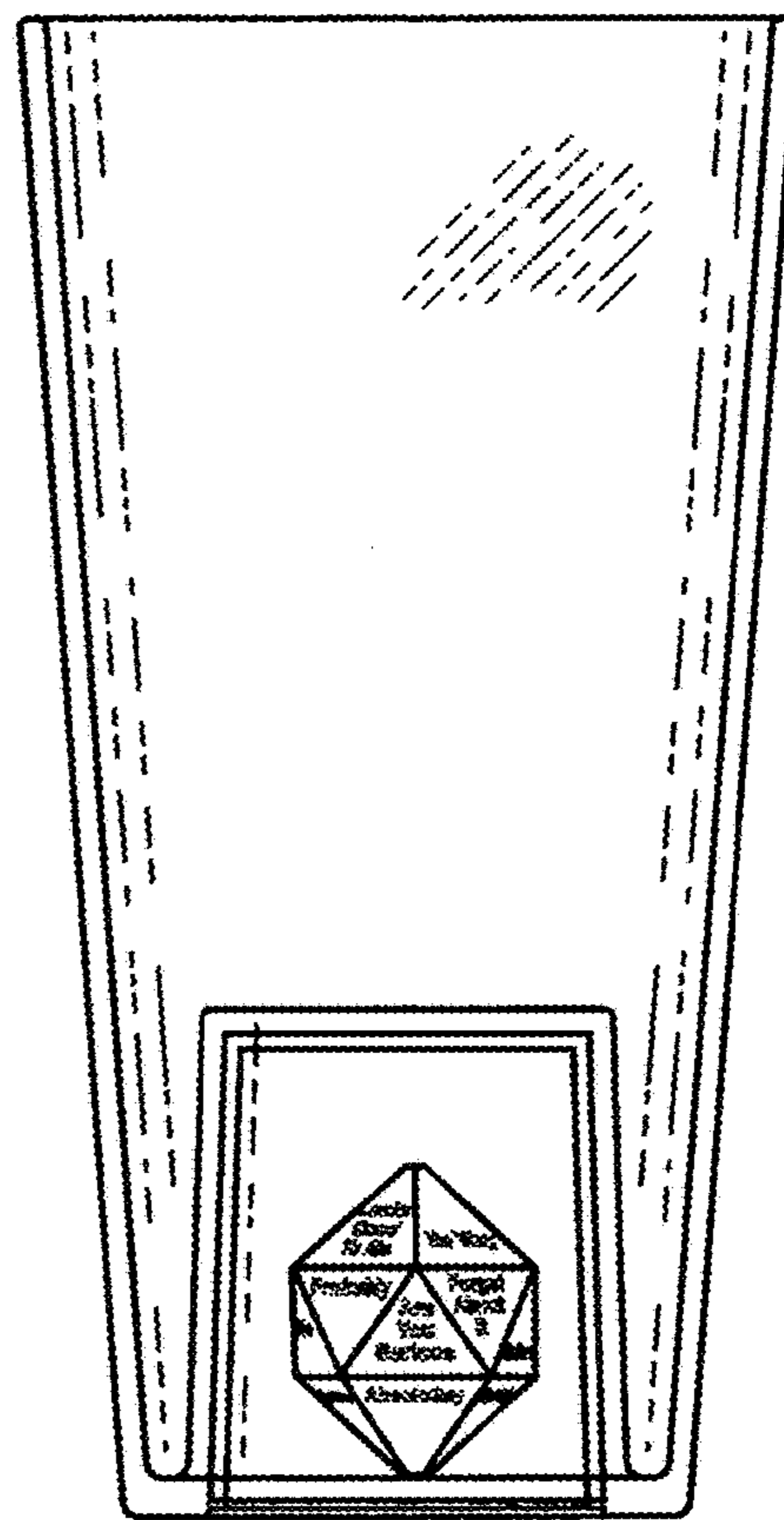

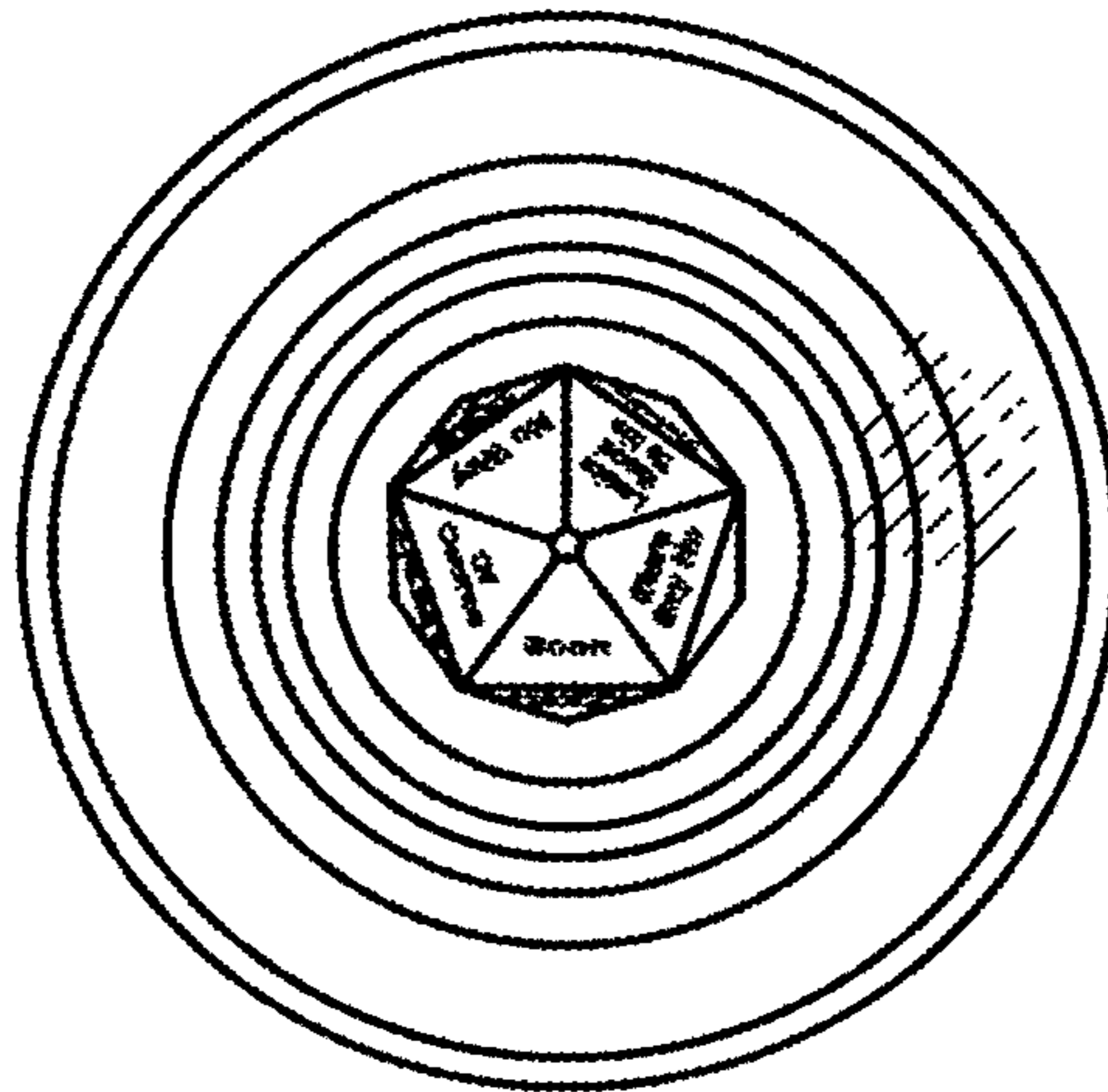

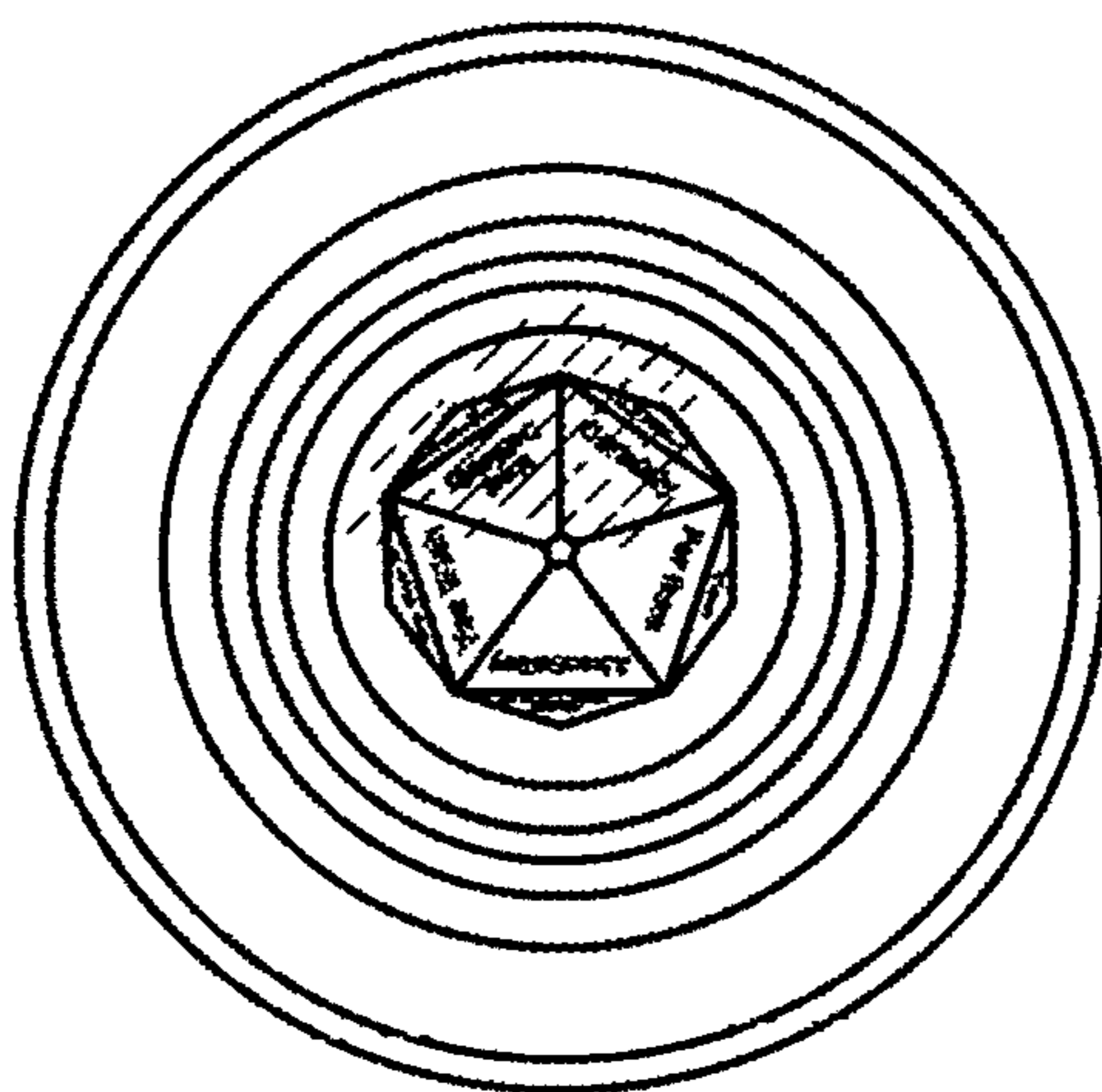
