The ornamental design for a cup for soup, as shown and described.

**DESCRIPTION**

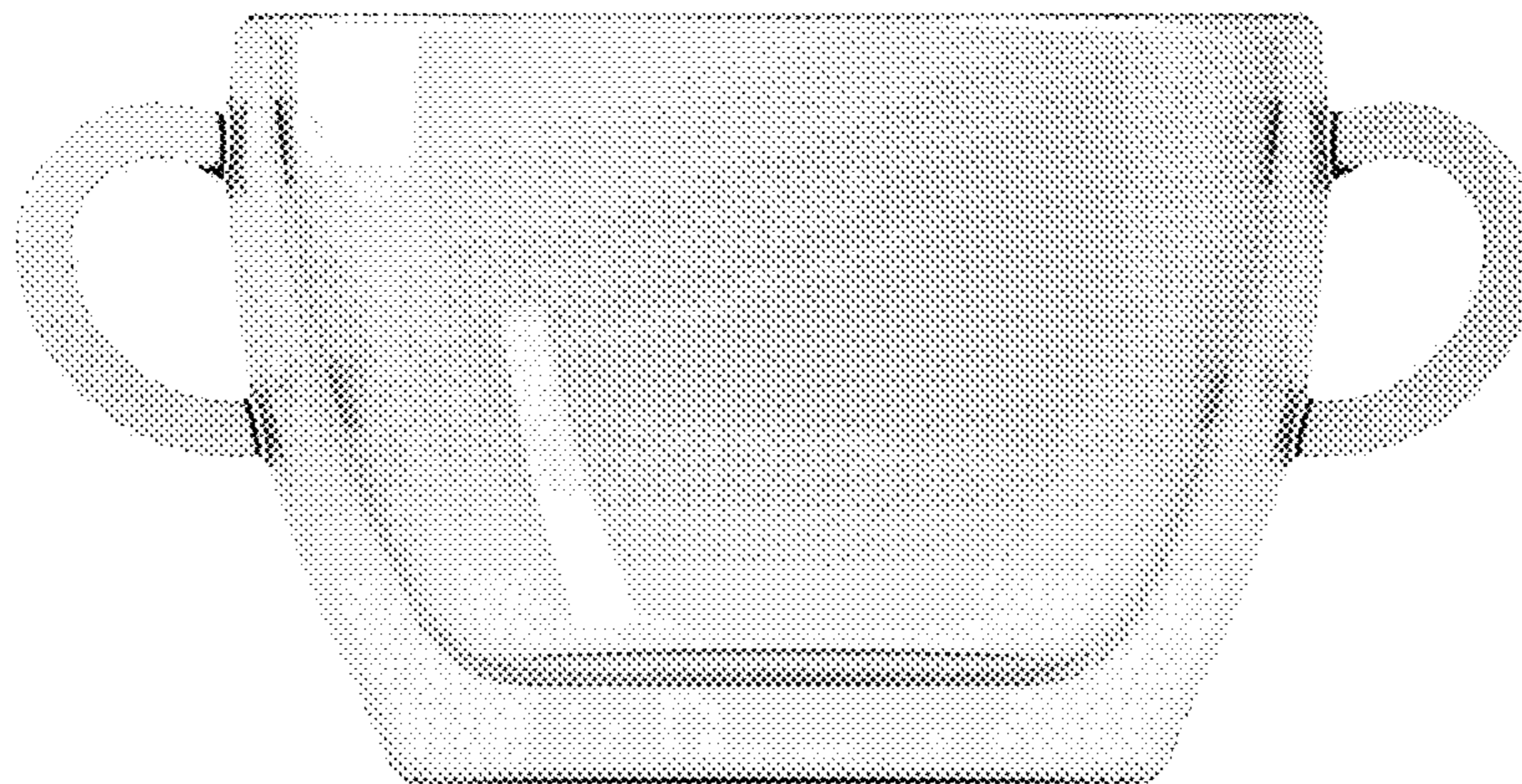

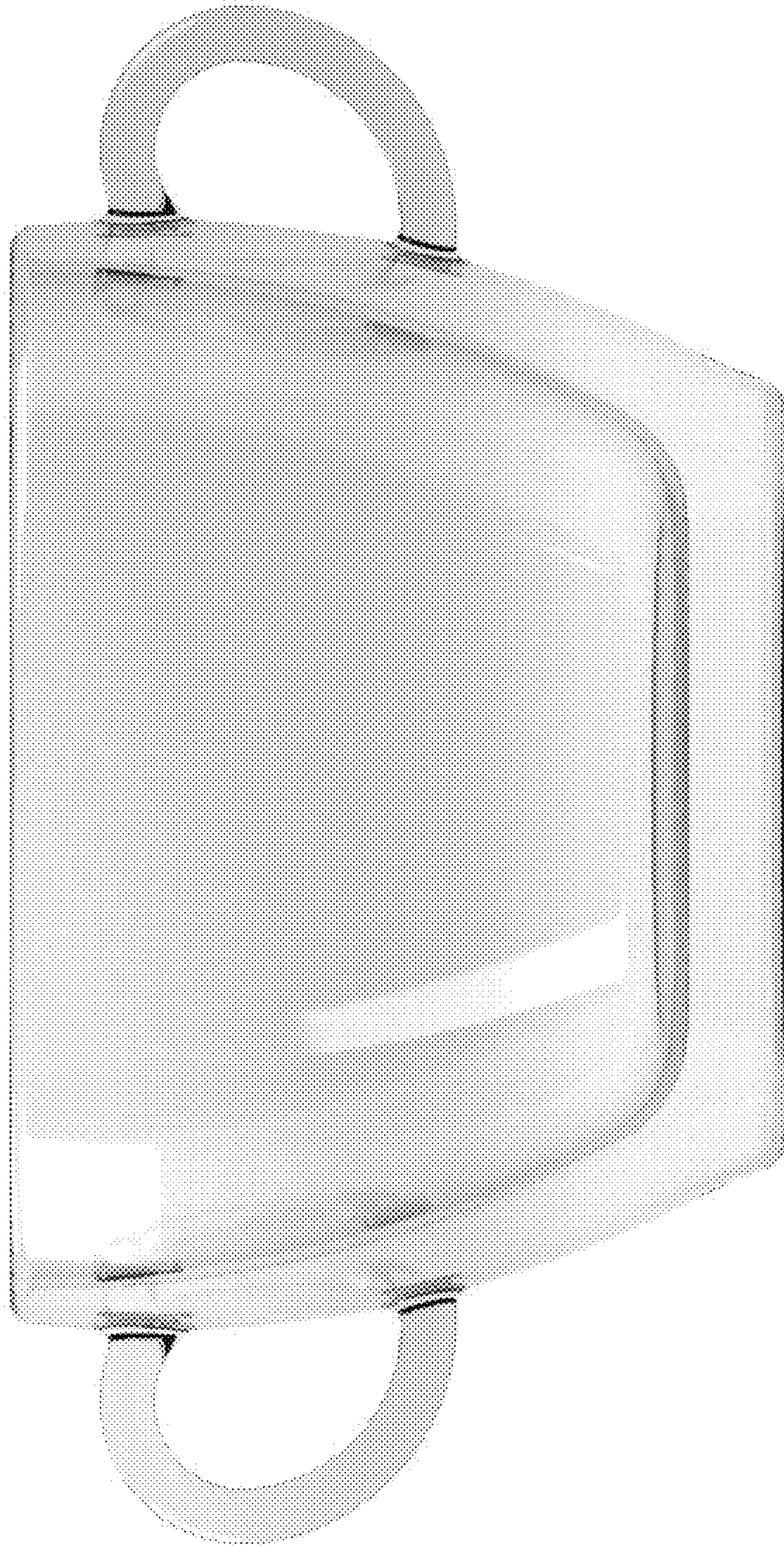

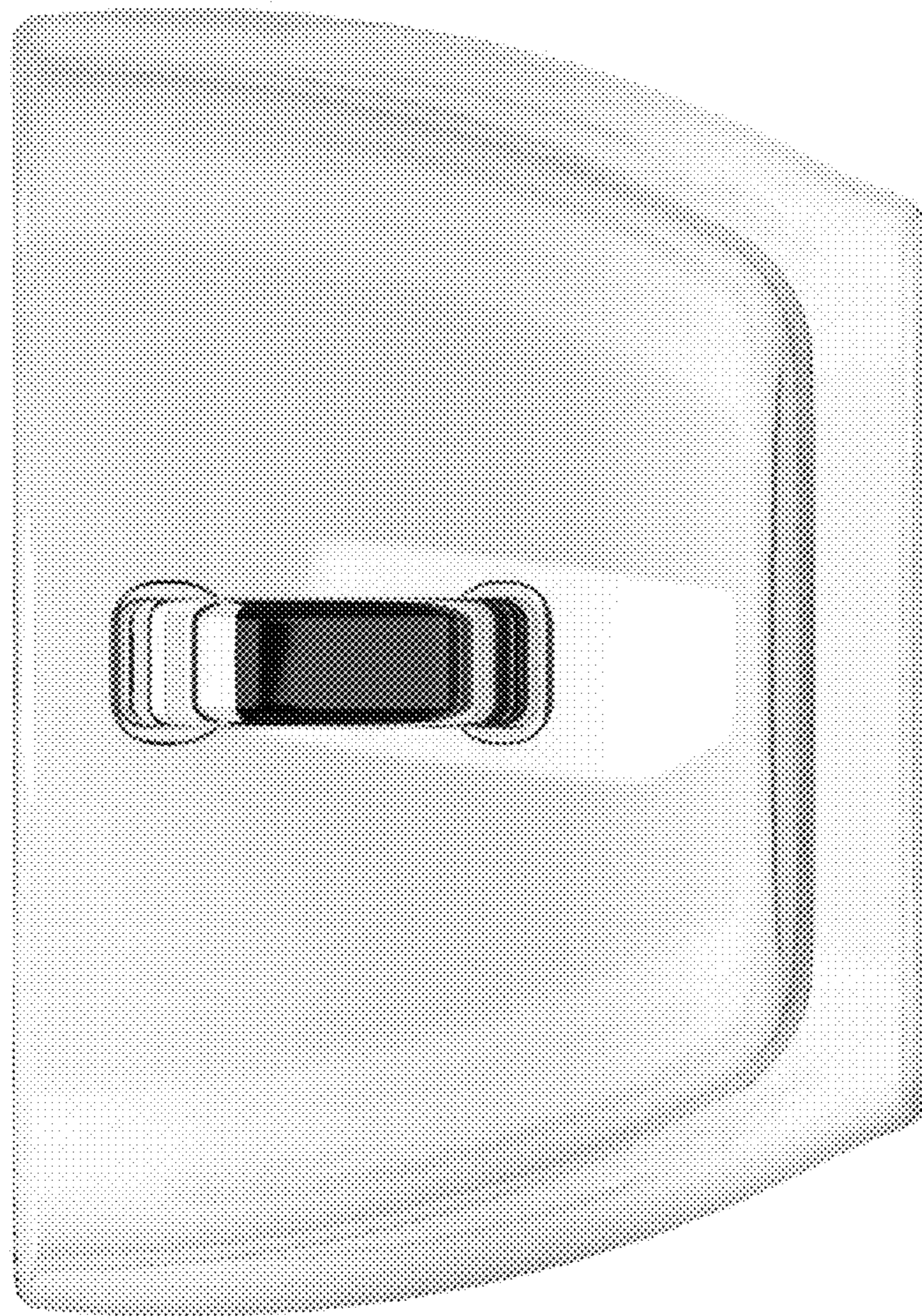

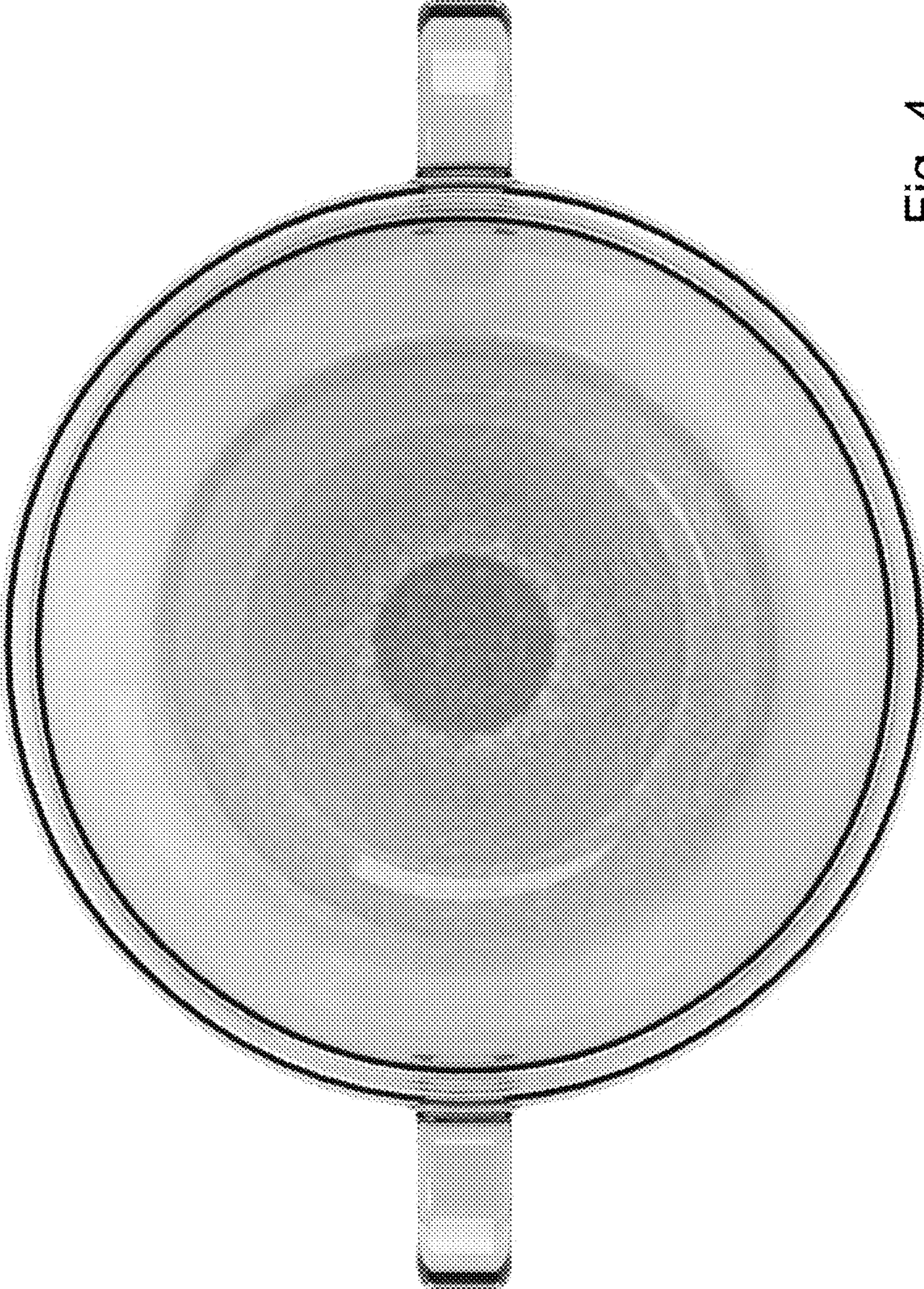
