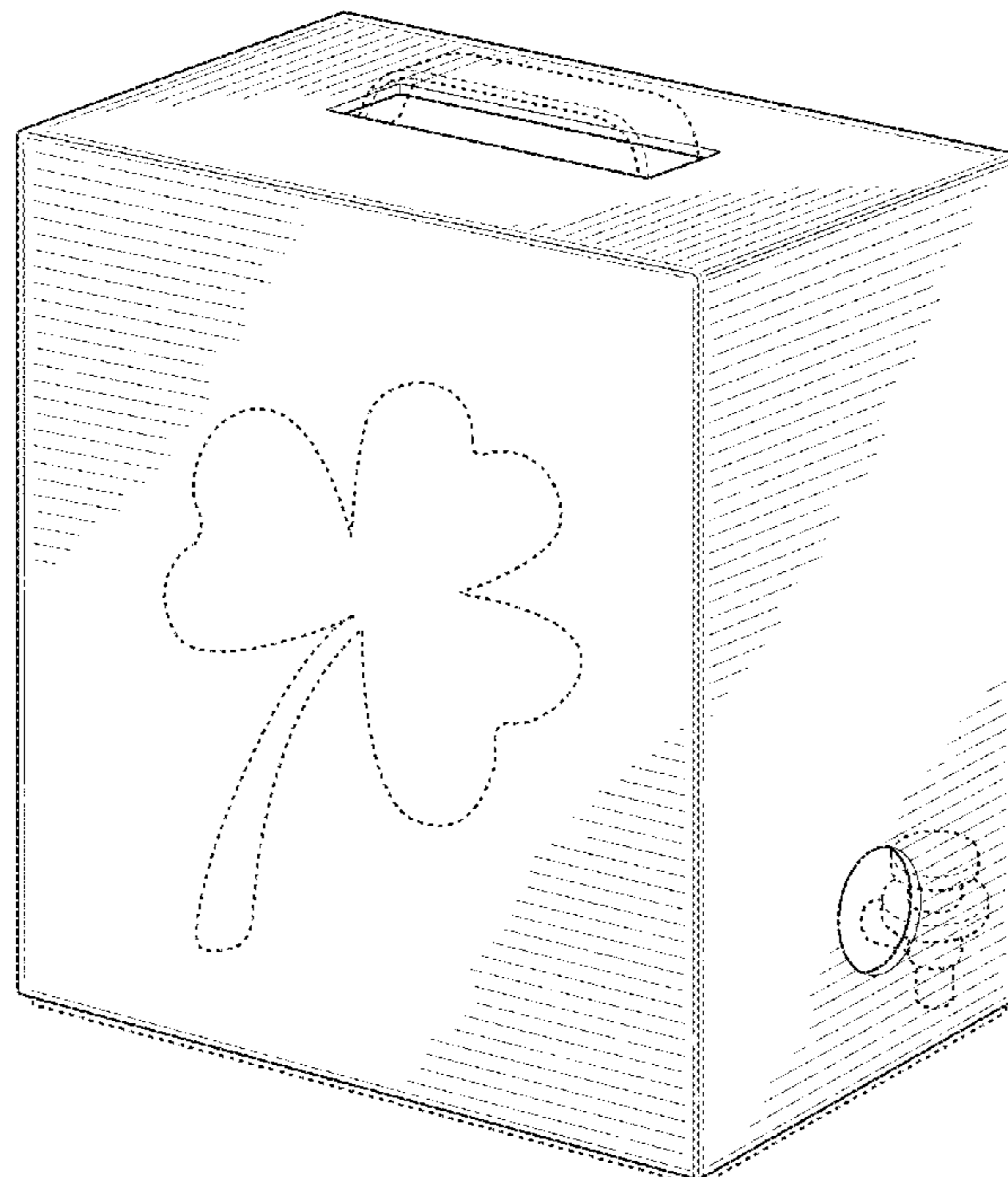
(57) **CLAIM**

The ornamental design for a wine box cover, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of the wine box cover over a wine box, and the wine box cover having an optional decorative design thereon.
FIG. 2 shows a first side view of the wine box cover over a wine box.
FIG. 3 shows a first end view of the wine box cover over a wine box.
FIG. 4 shows a second end view of the wine box cover over a wine box.
FIG. 5 shows an overhead view of the wine box cover over a wine box; and,
FIG. 6 shows an underside view of the wine box cover over a wine box.

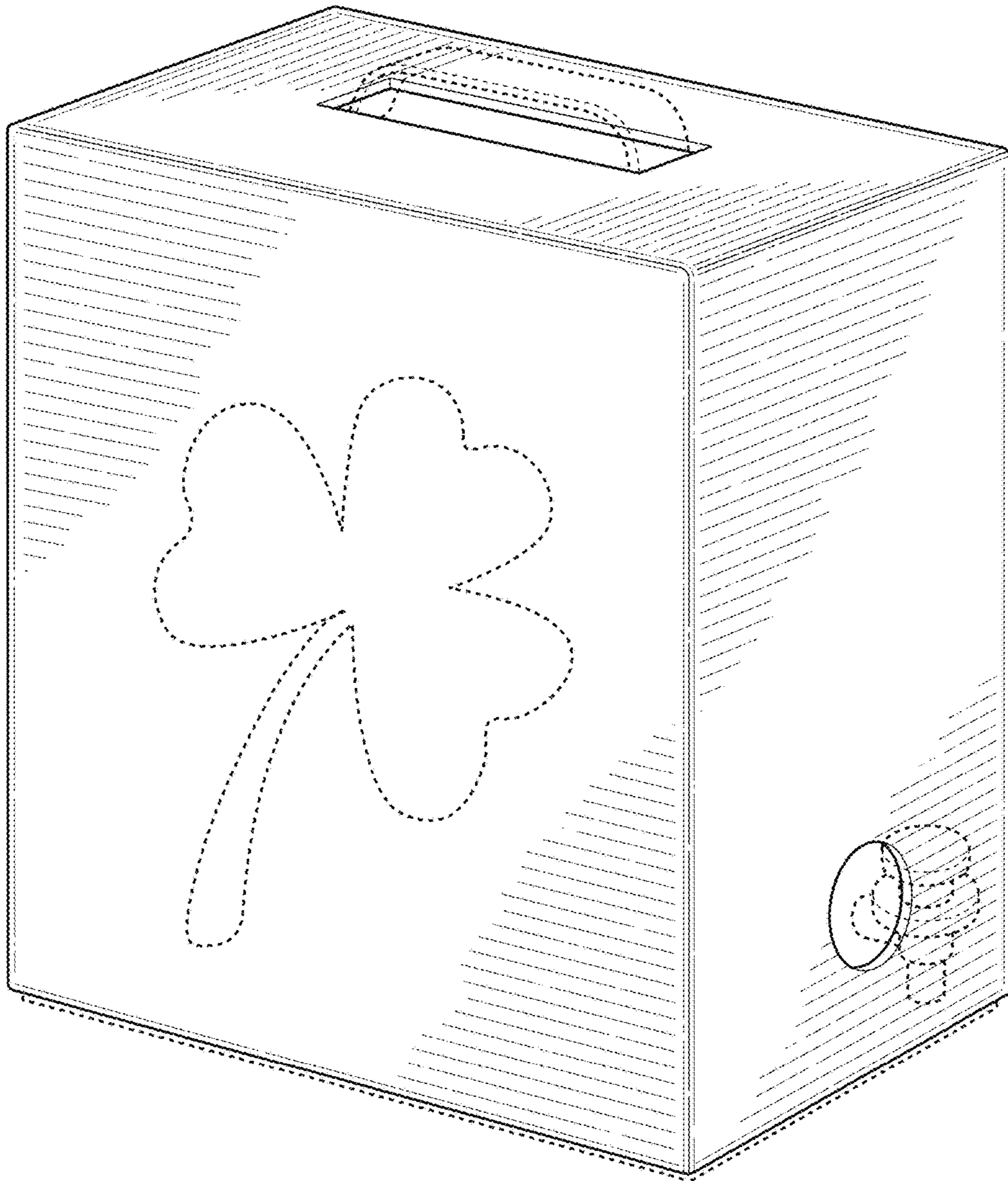

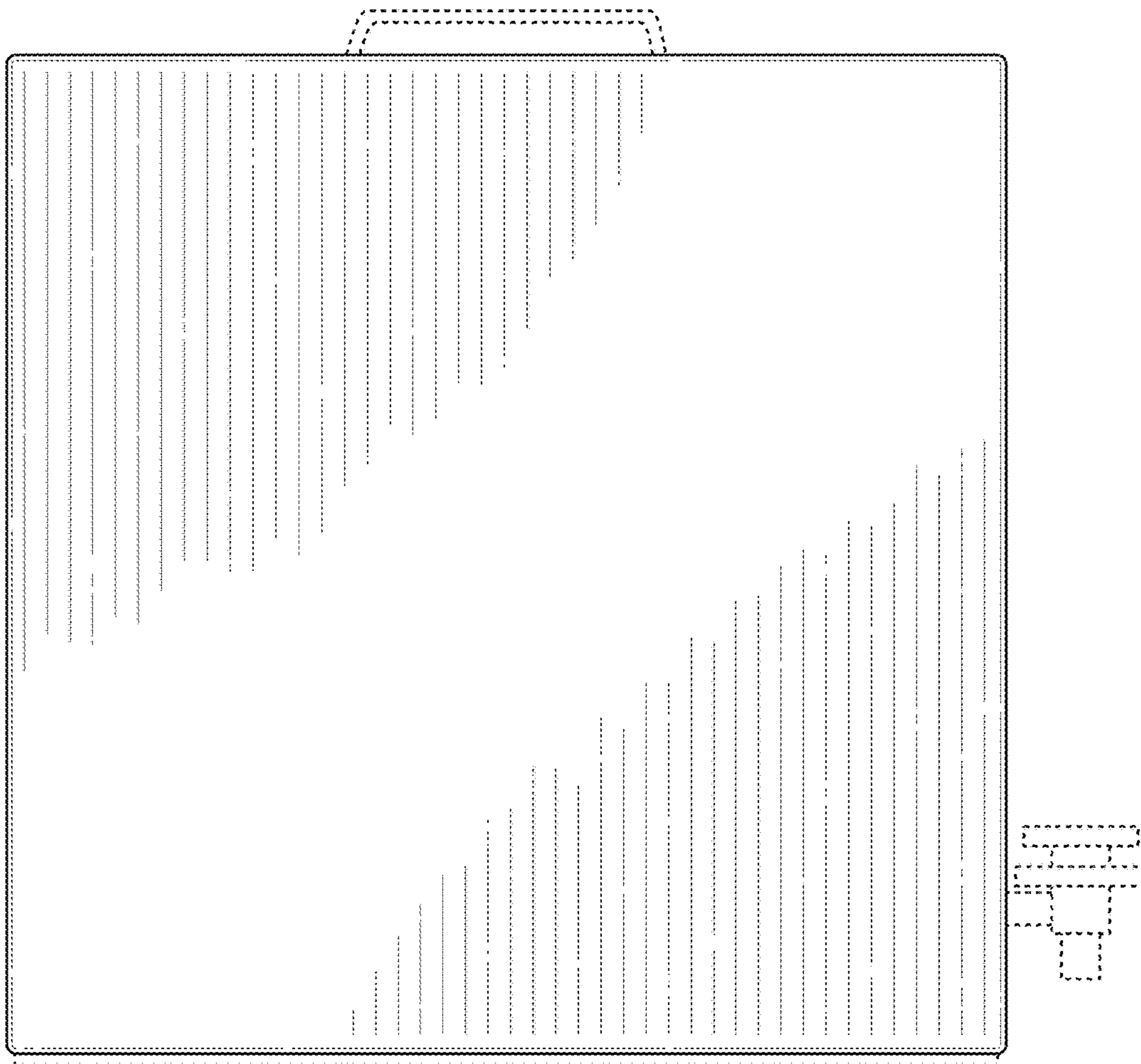

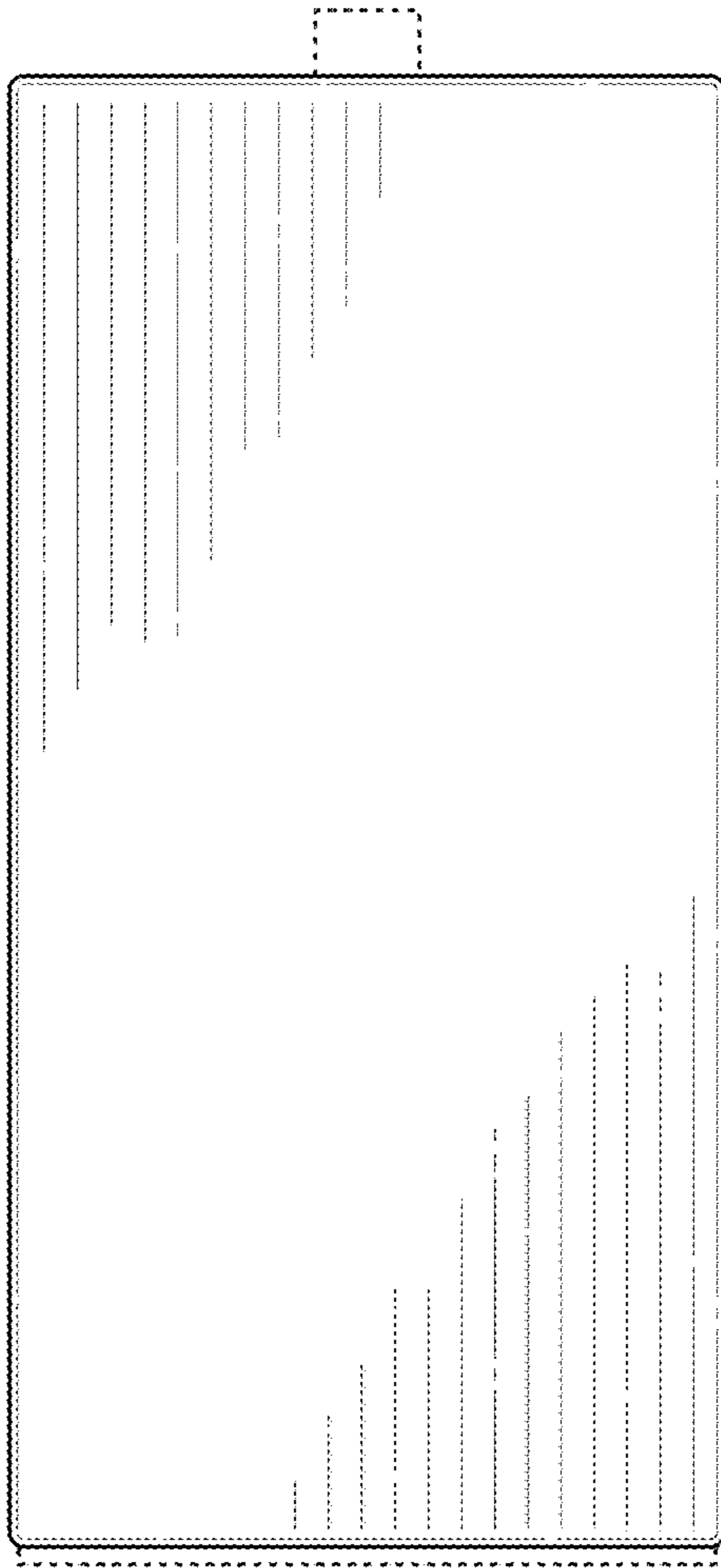

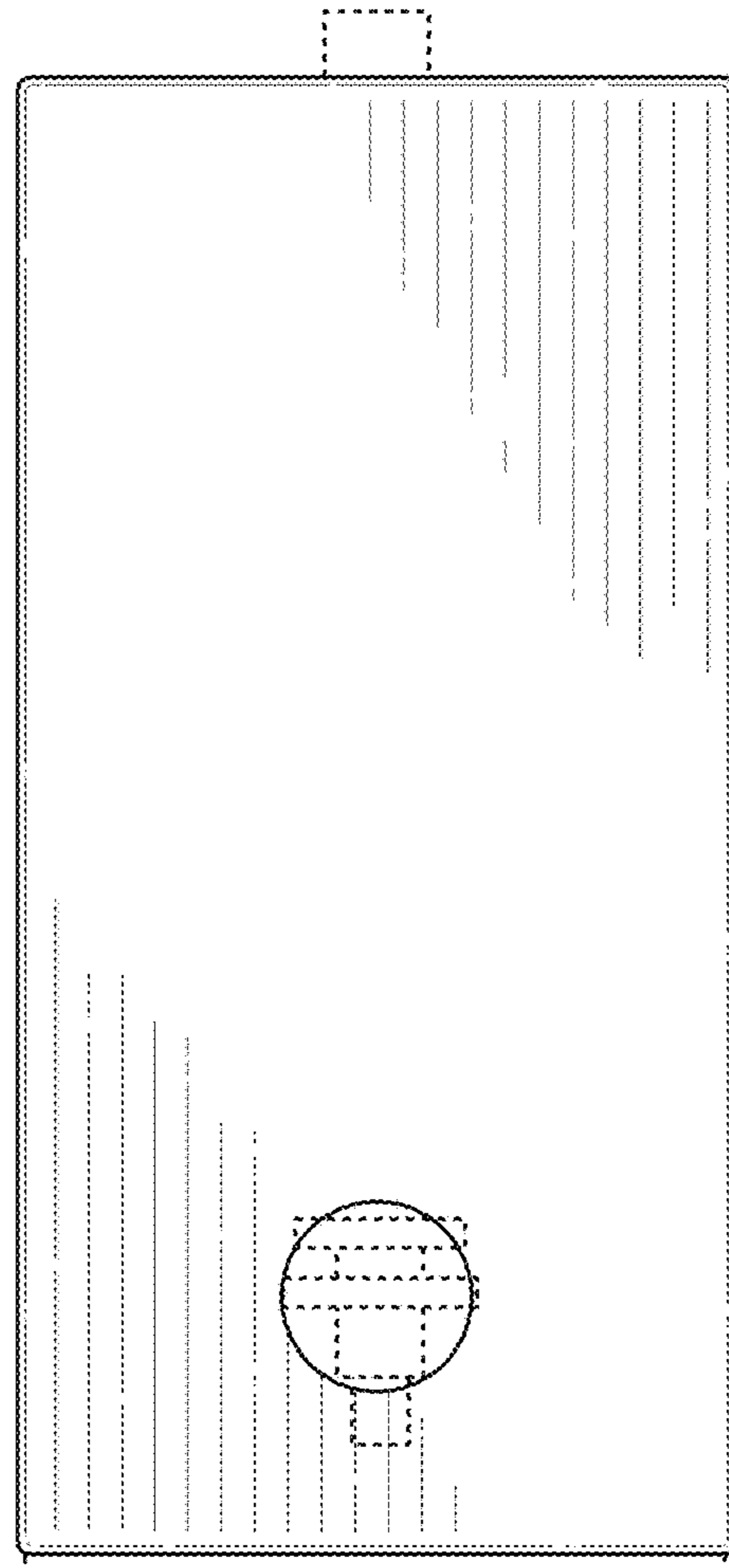

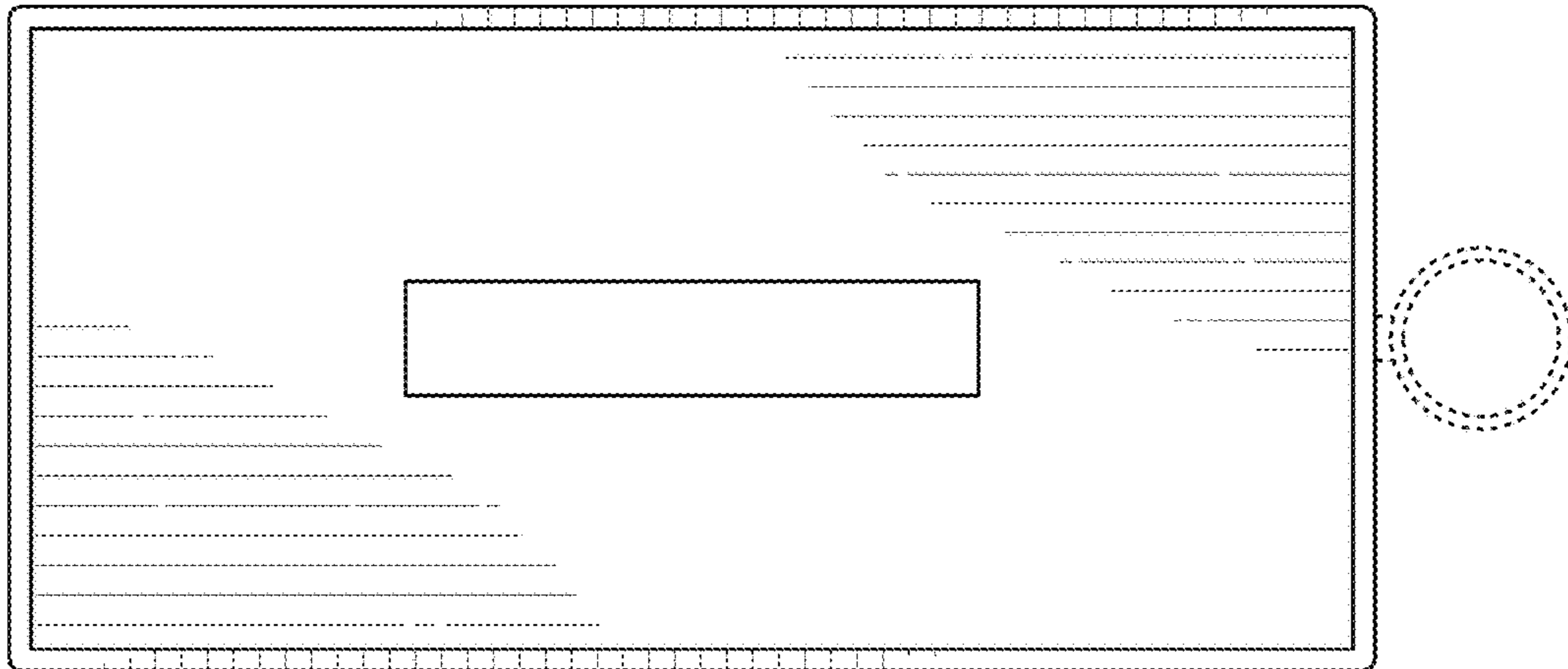

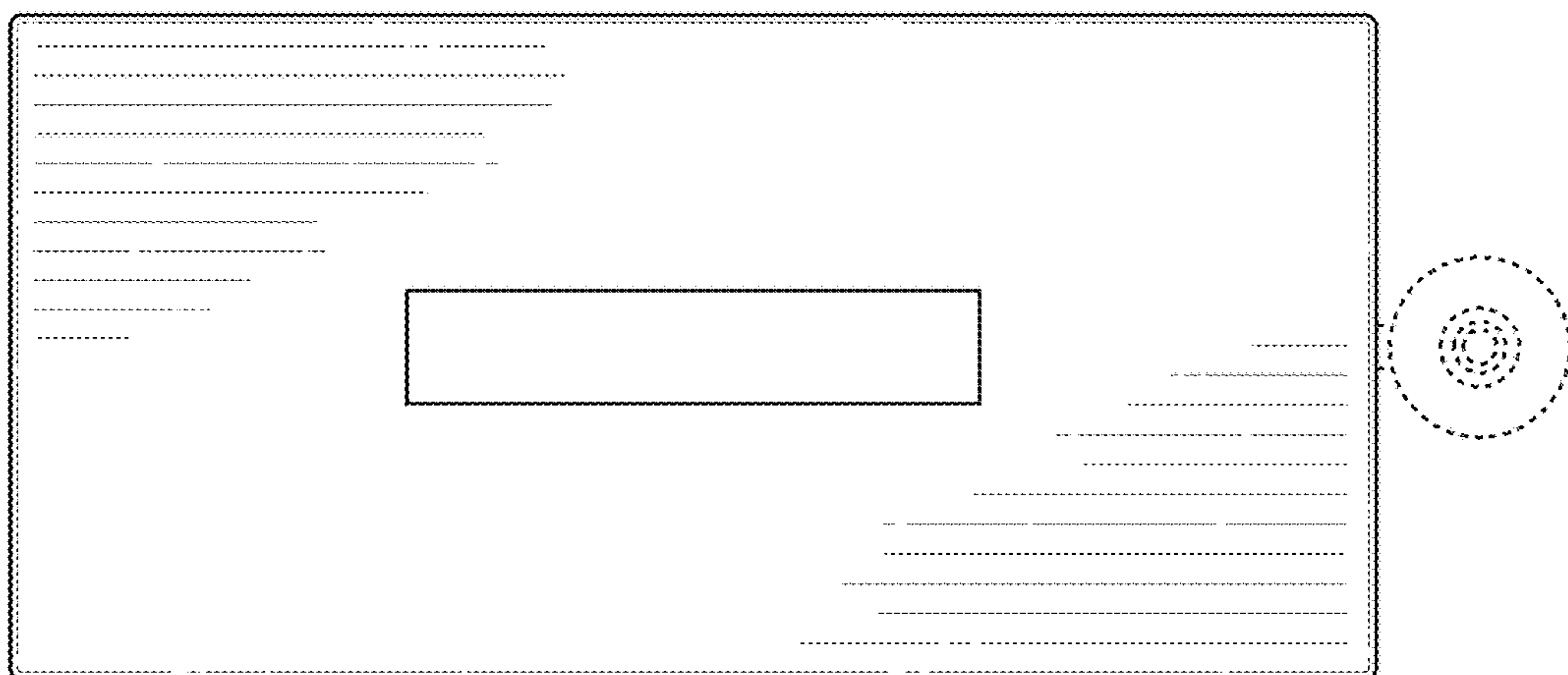
