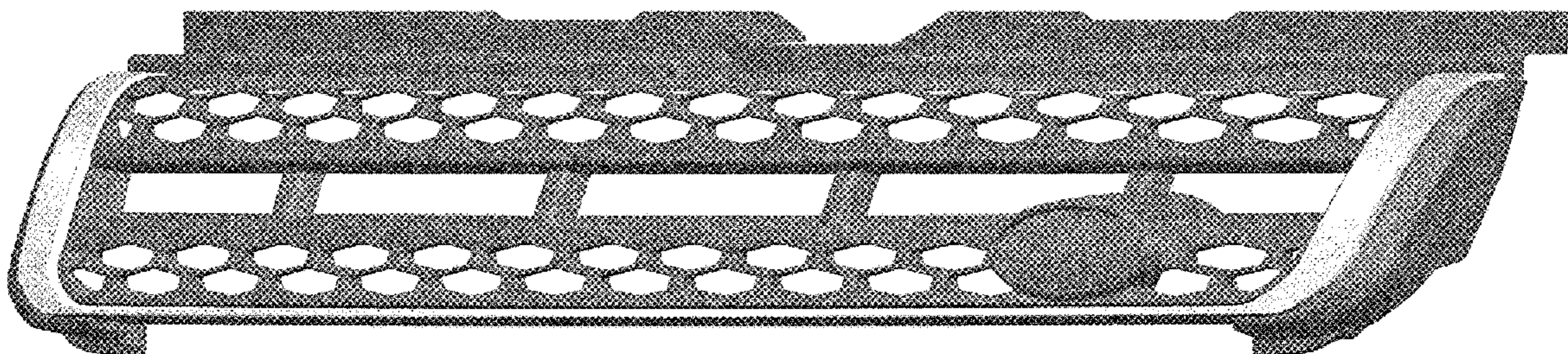
(57) **CLAIM**

The ornamental design for an automobile front grille, as
shown and described.

DESCRIPTION

FIG. 1 is a front and right side perspective view of the
automobile front grille showing my new design;
FIG. 2 is a rear and left side perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a front and right side perspective view thereof,
wherein the automobile front grille is shown installed on
environmental automobile.
In FIG. 8, the overexposed or halftone showing of the
automobile is provided for the purposes of illustrating
environmental structure and forms no part of the claimed
design.

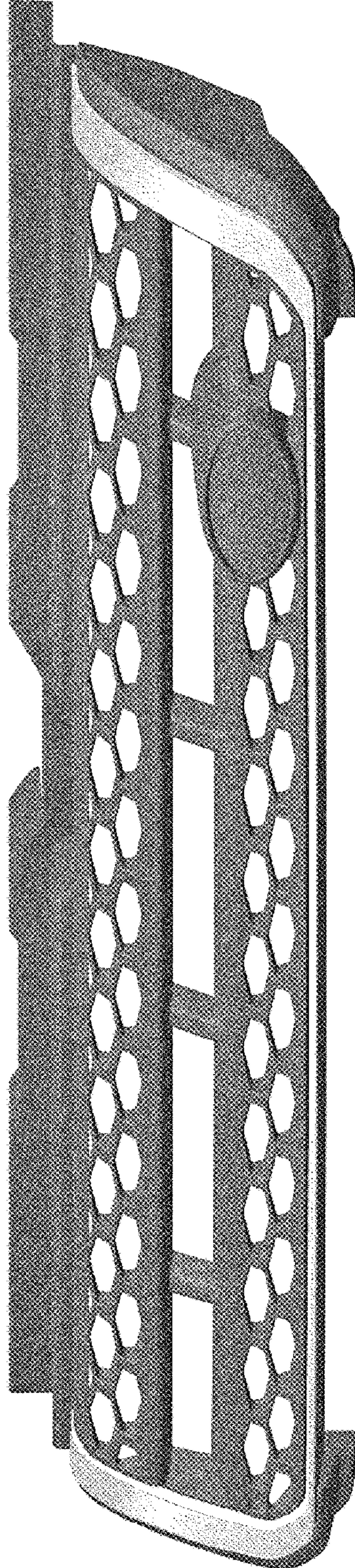

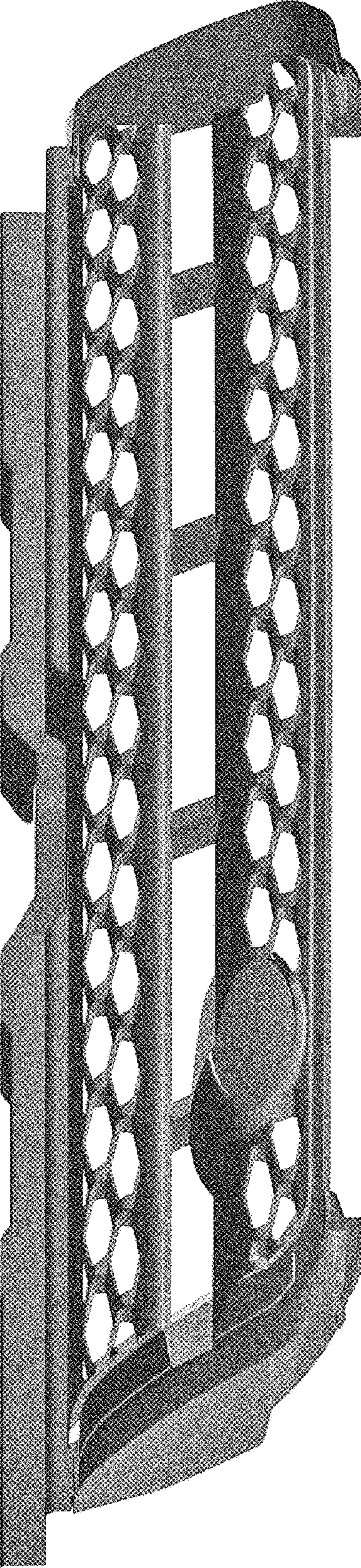

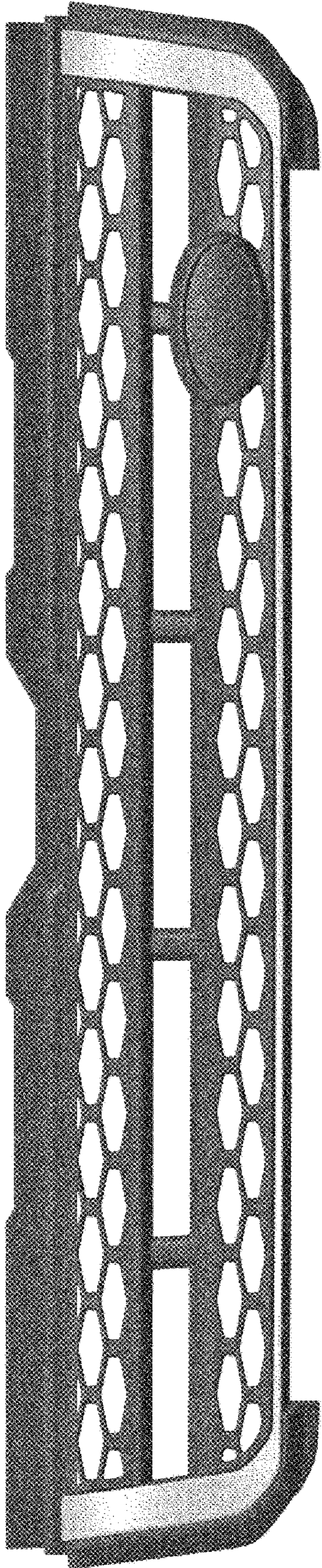

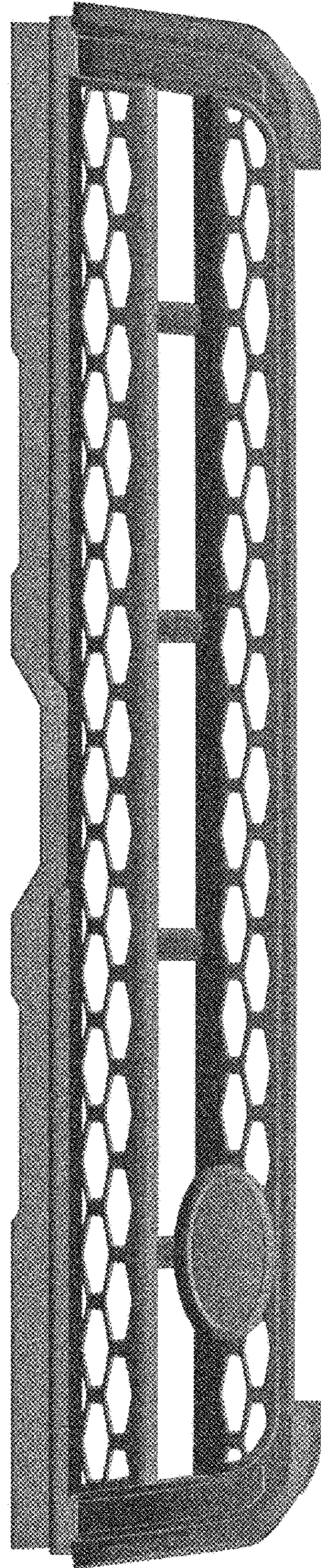

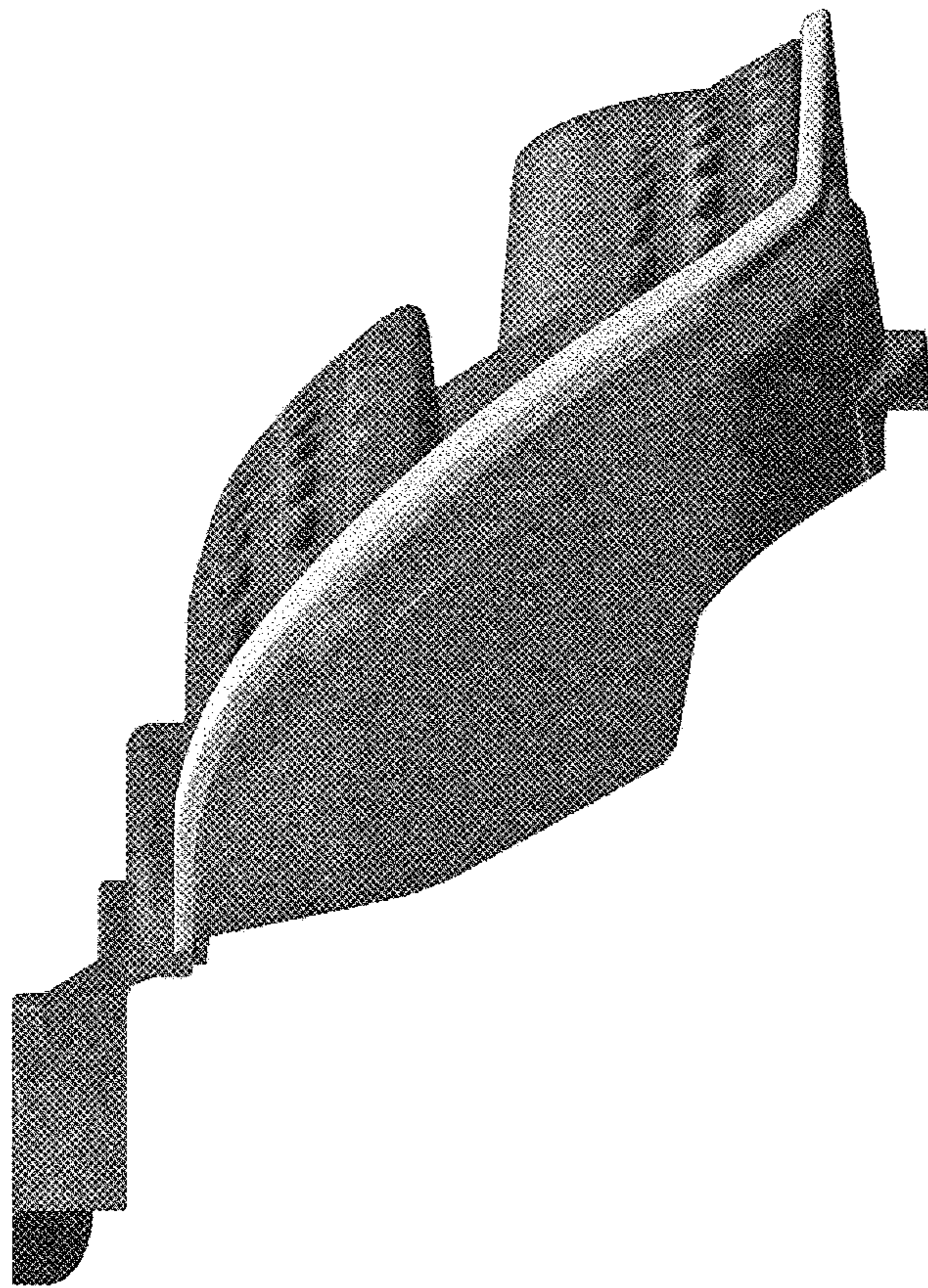

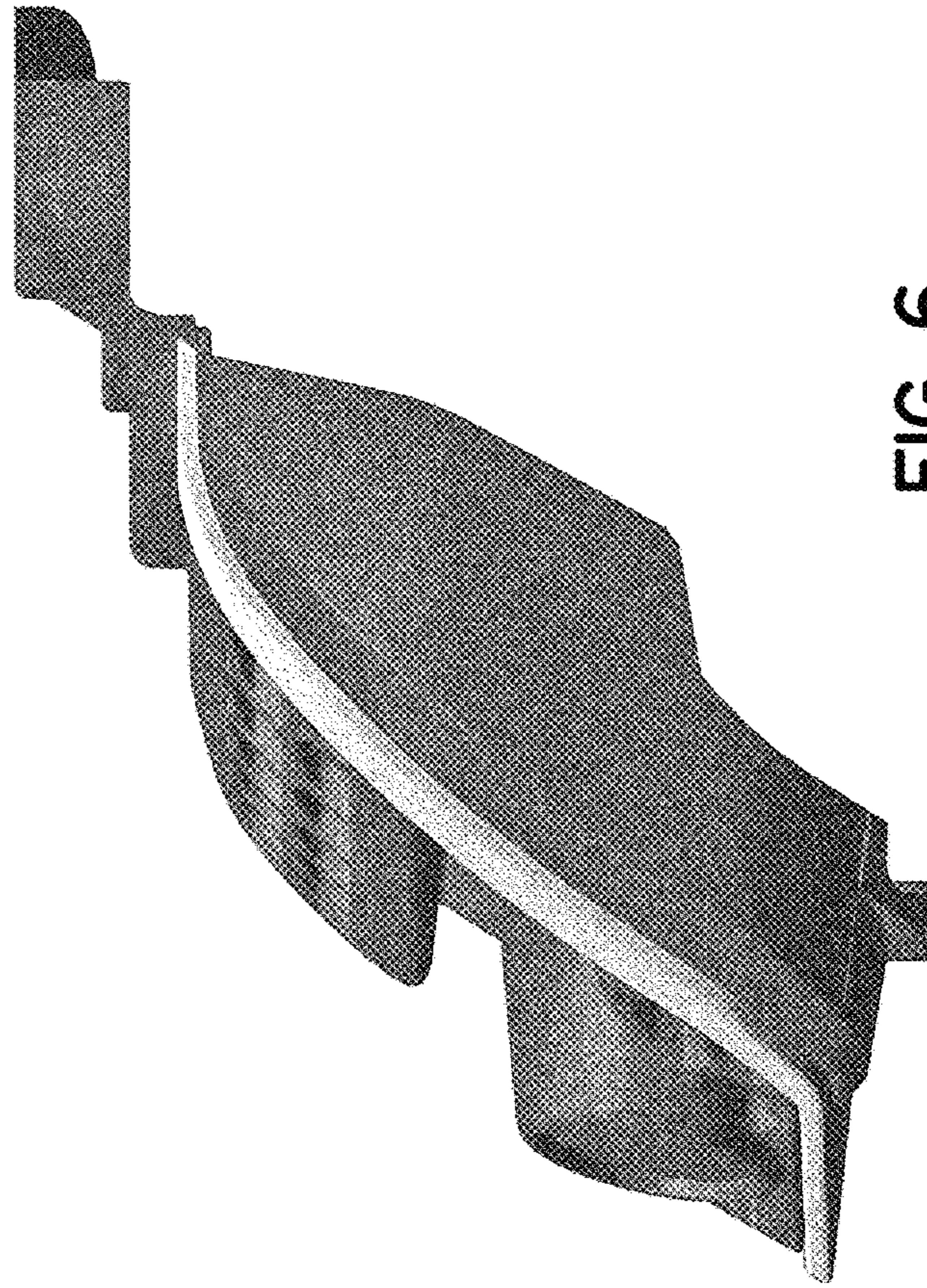

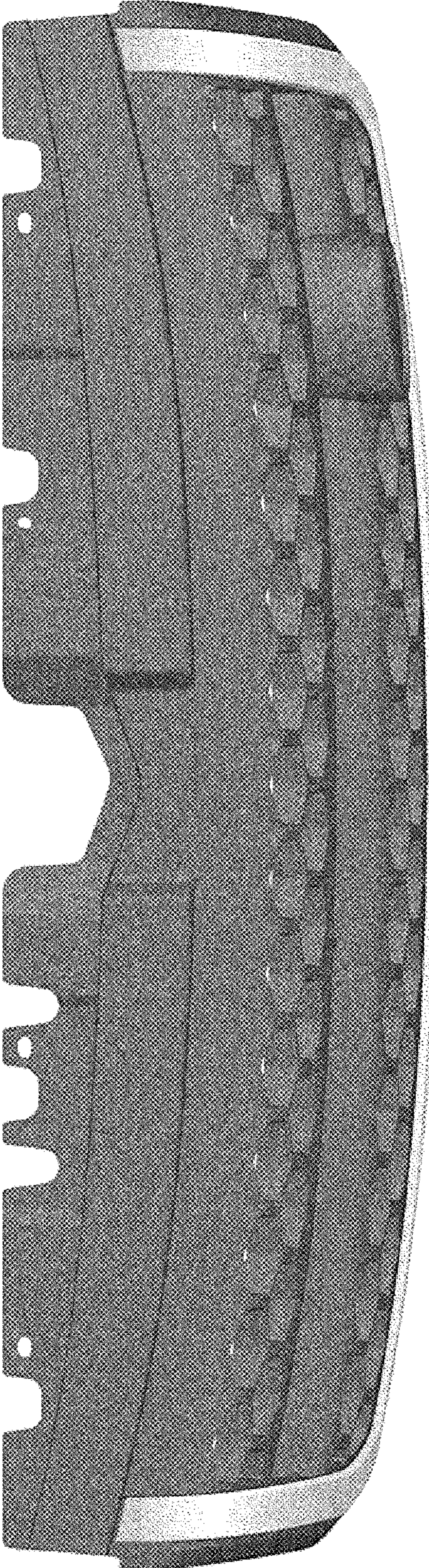

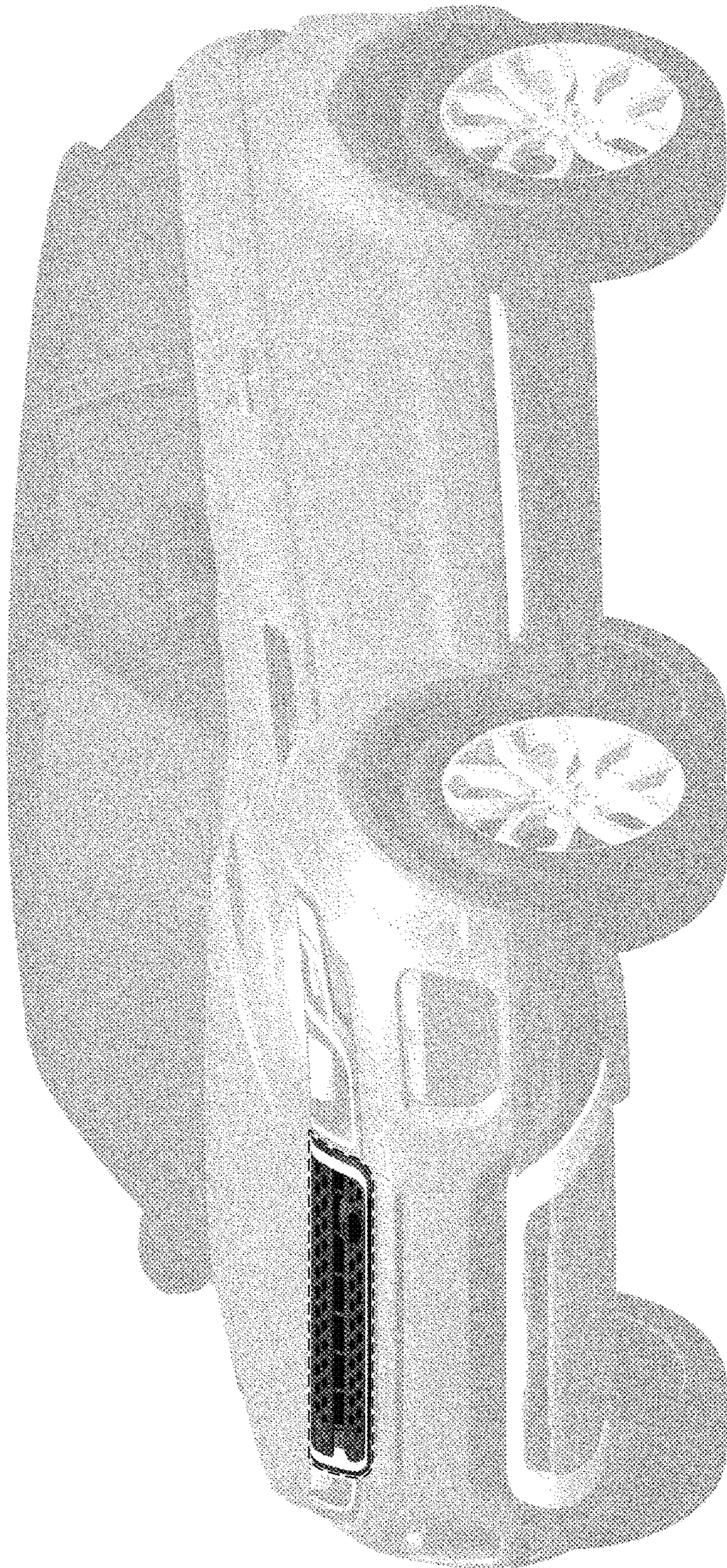
