(57) **CLAIM**

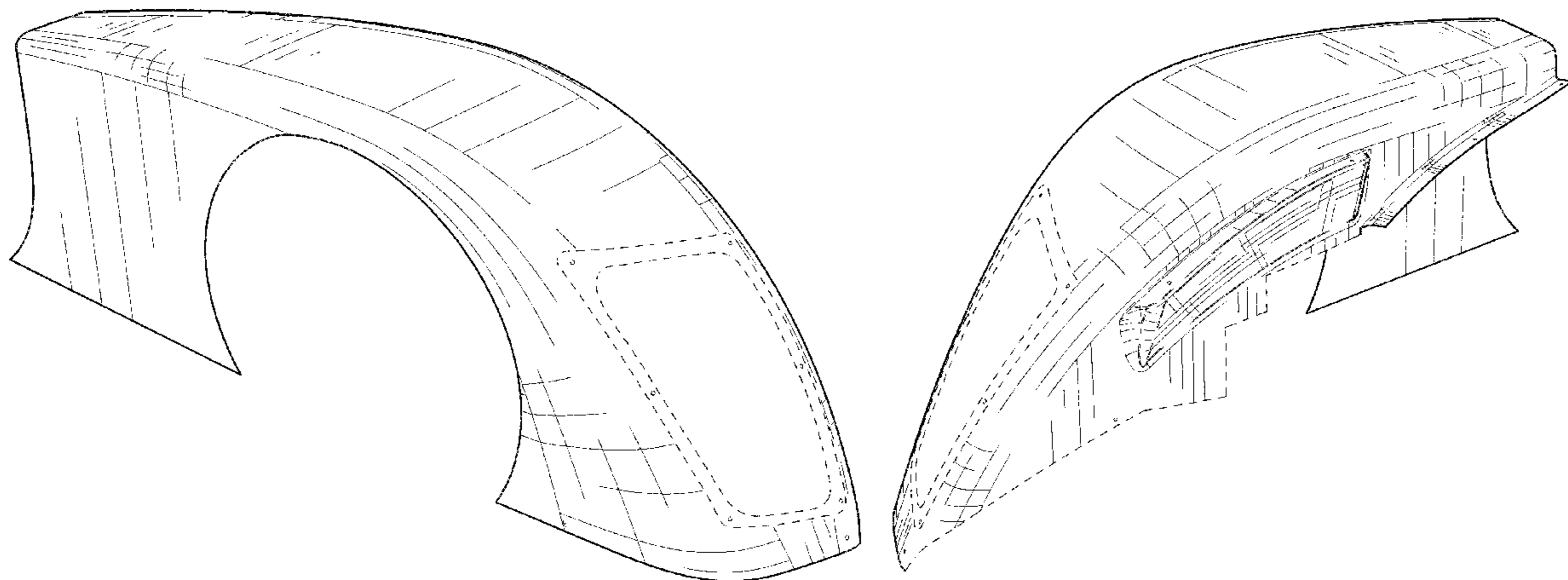
The ornamental design for a right front fender for a car body, as shown and described.

DESCRIPTION

FIG. 1 is a front-left perspective view of the right front fender for a car body, showing my new design; FIG. 2 is a front-right perspective view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a front view thereof; and, FIG. 8 is a rear view thereof.

The broken lines shown in the drawings illustrate portions of the right front fender for a car body that forms no part of the claimed design.

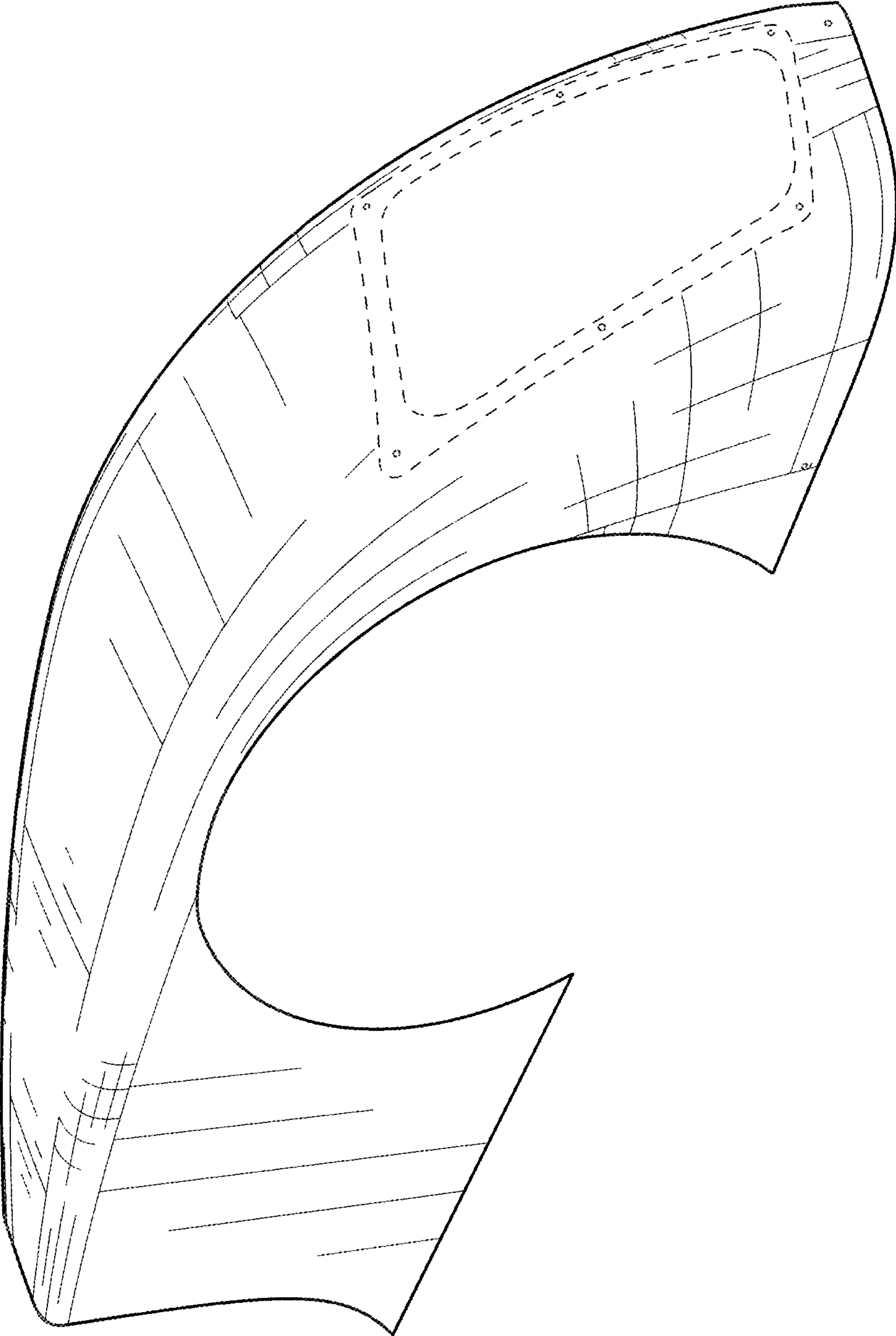

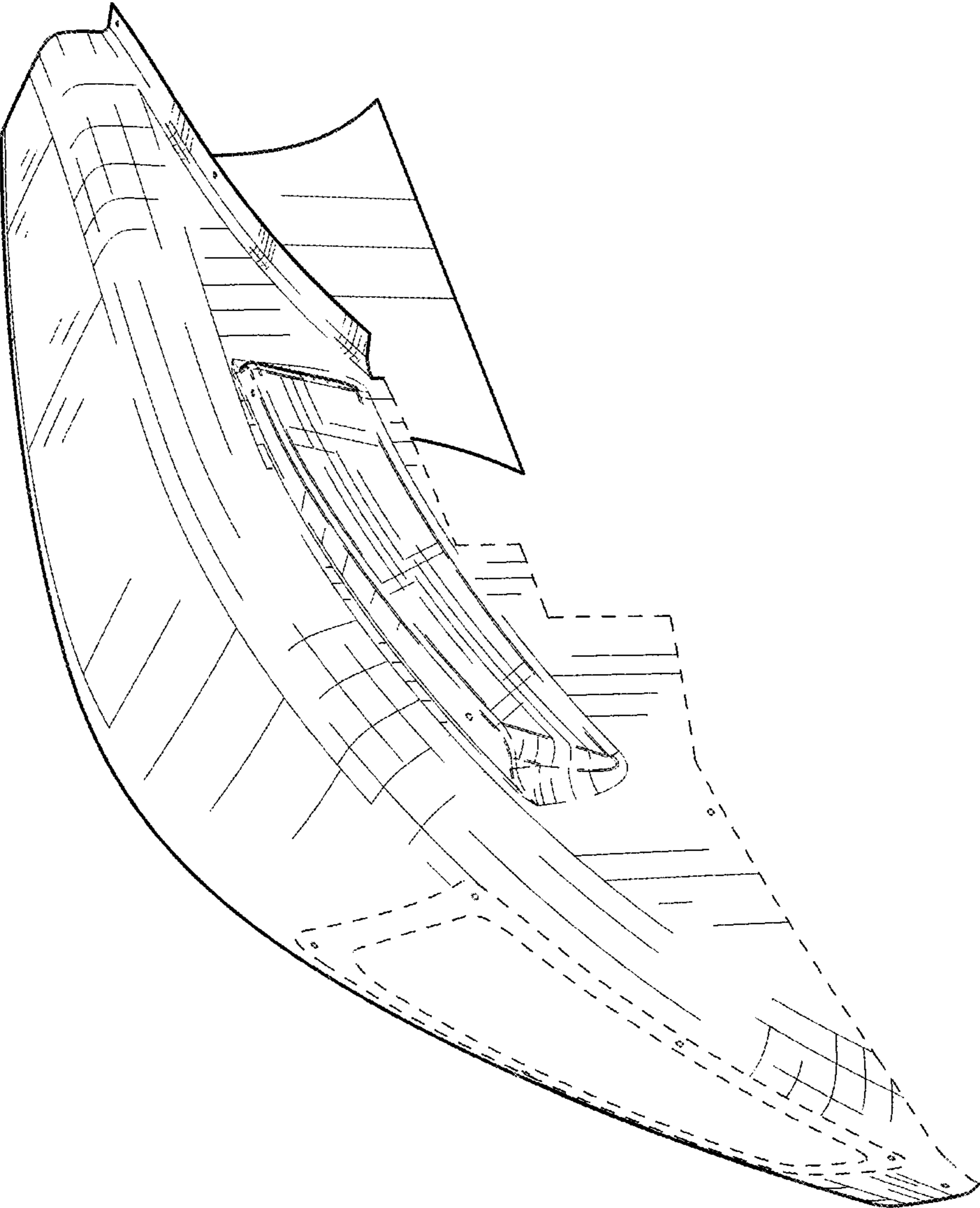

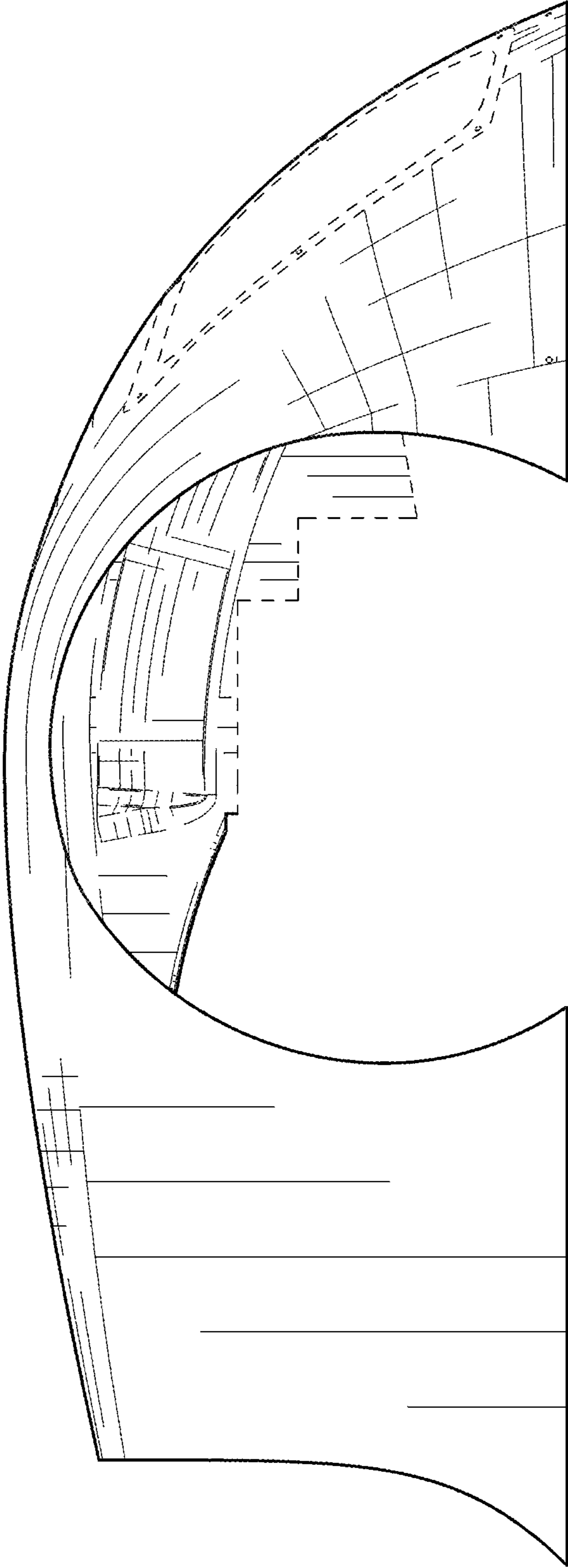

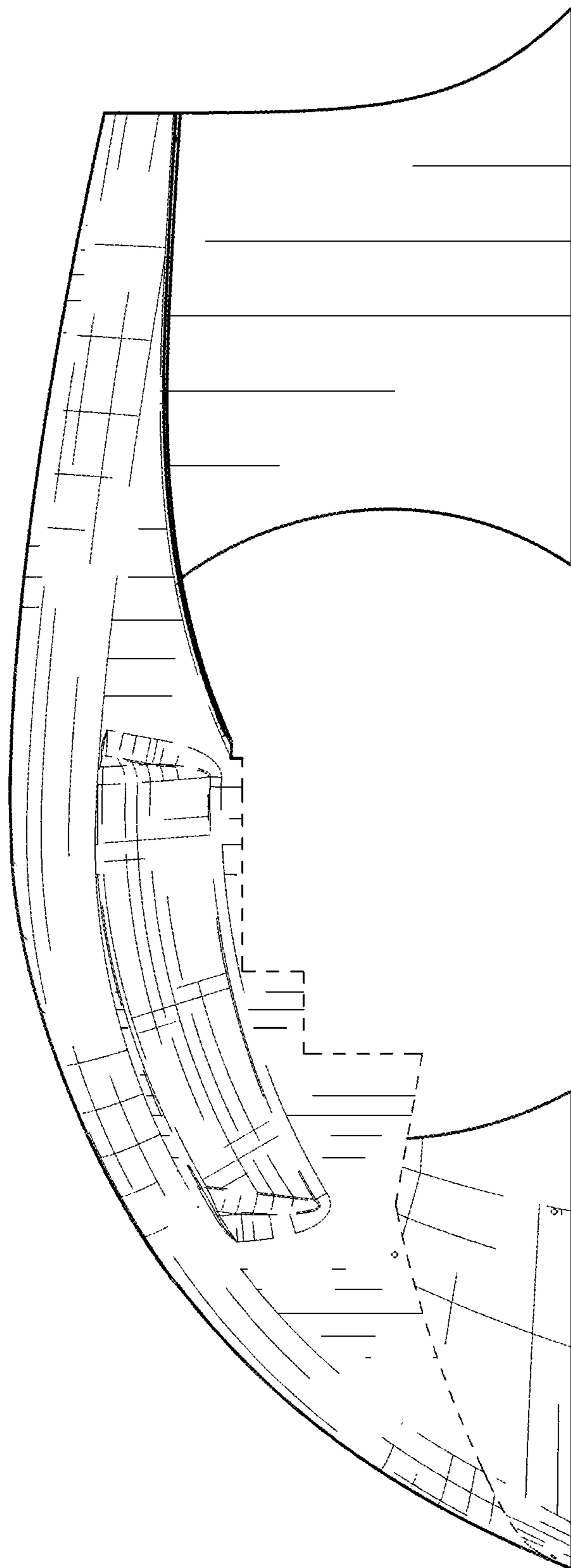

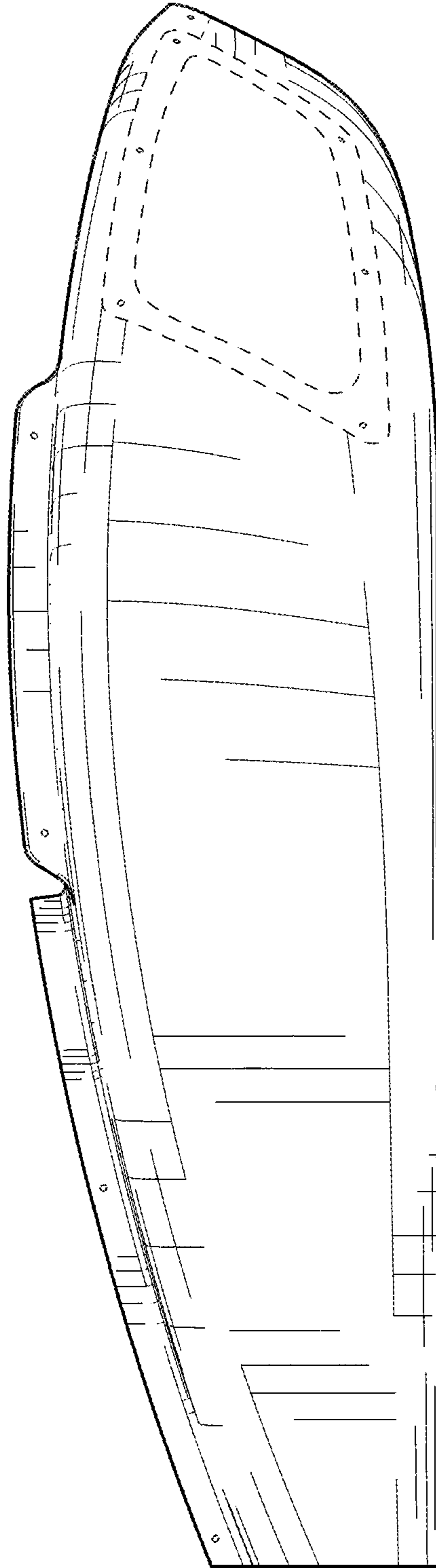

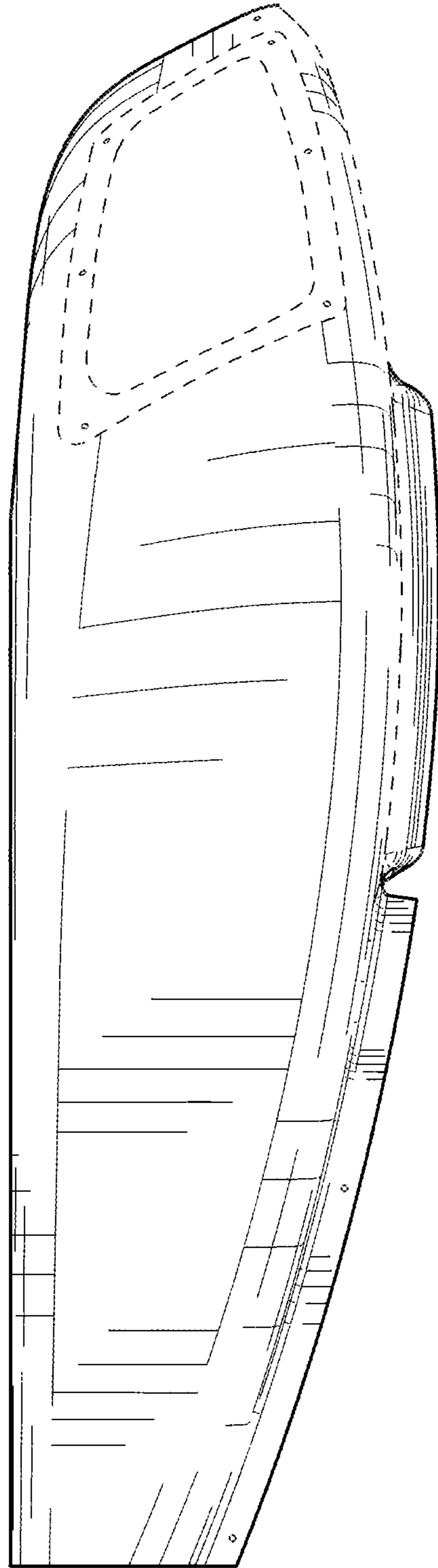

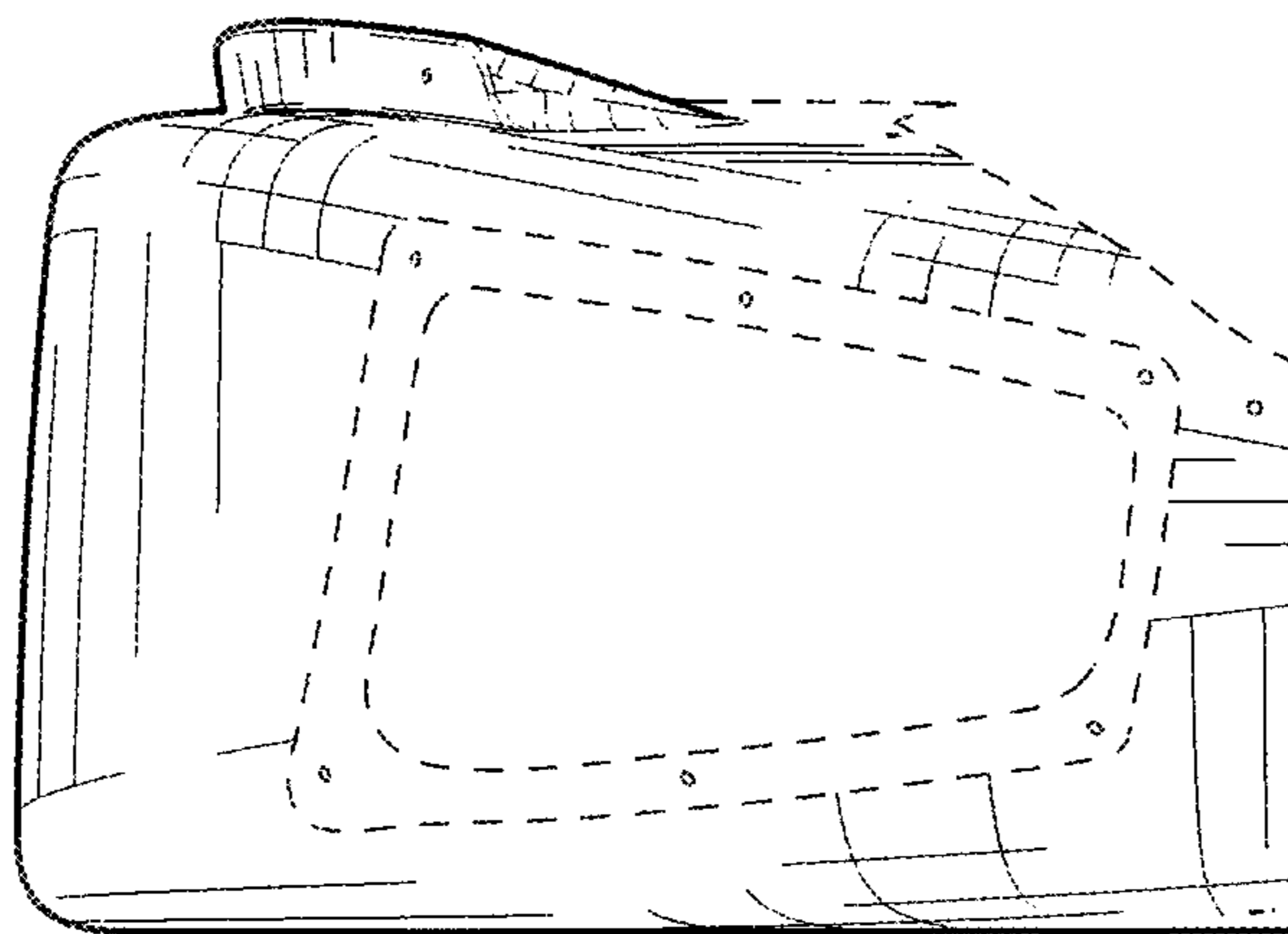

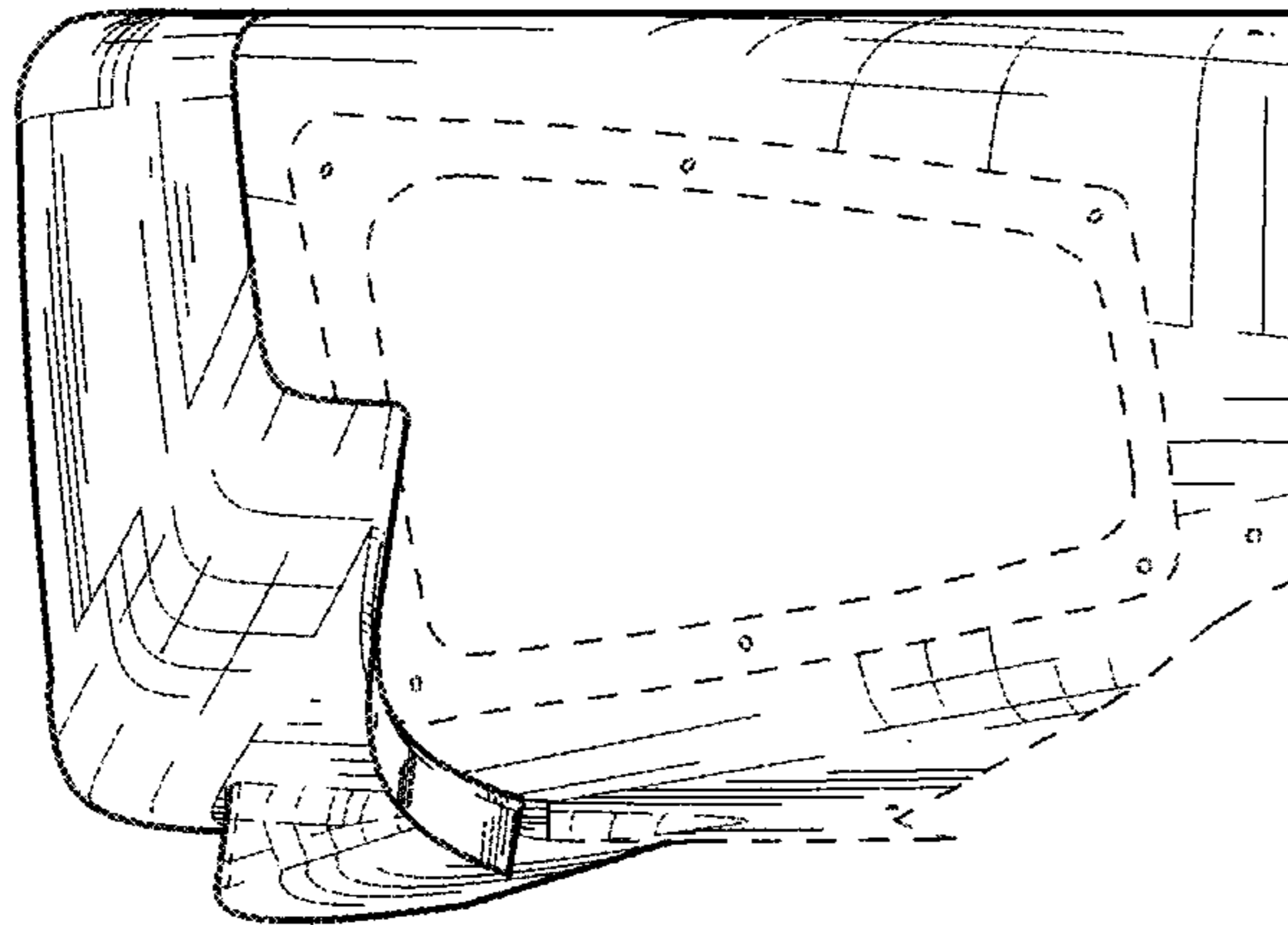
