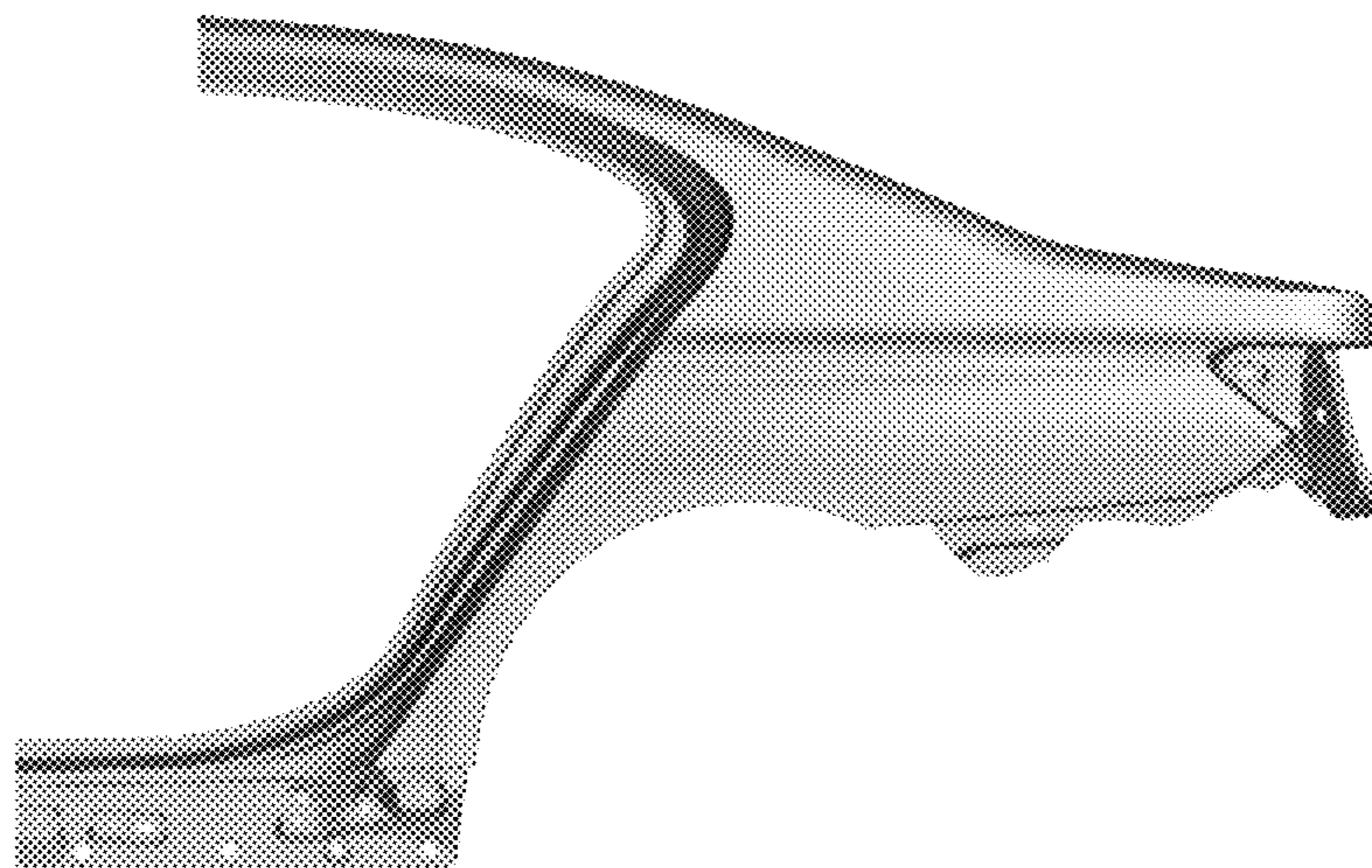
The ornamental design for a rear fender for a vehicle, as shown and described.

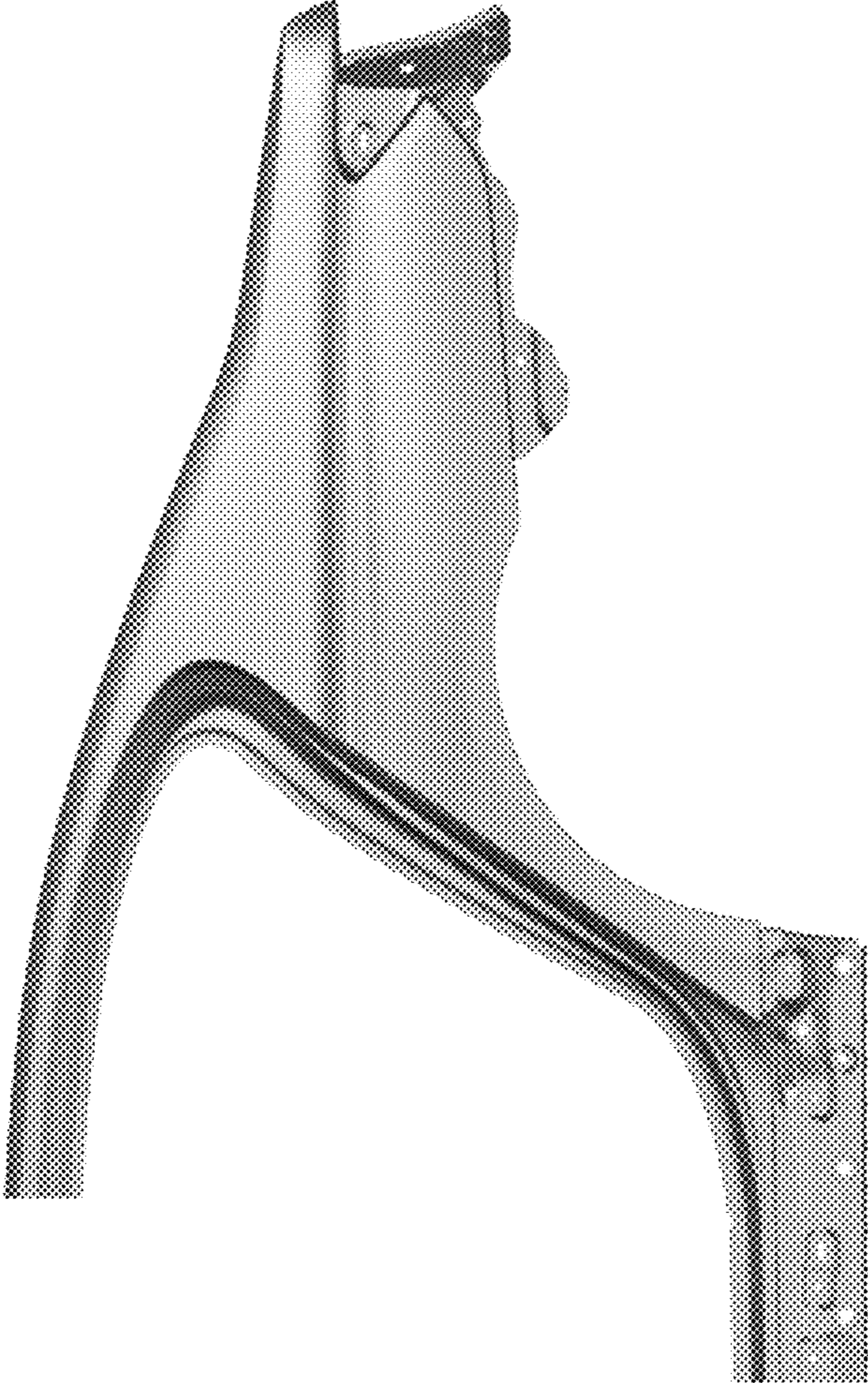

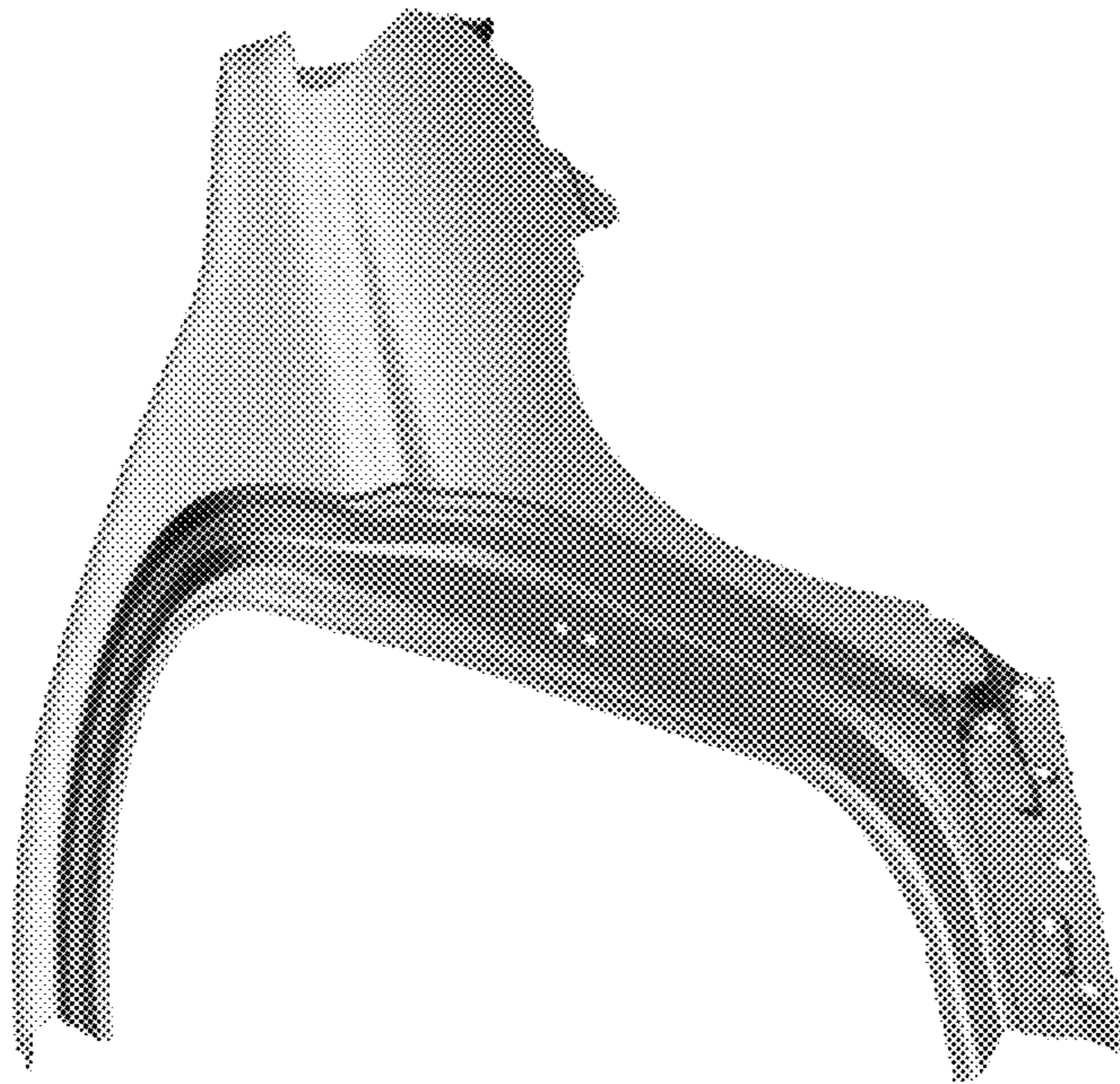

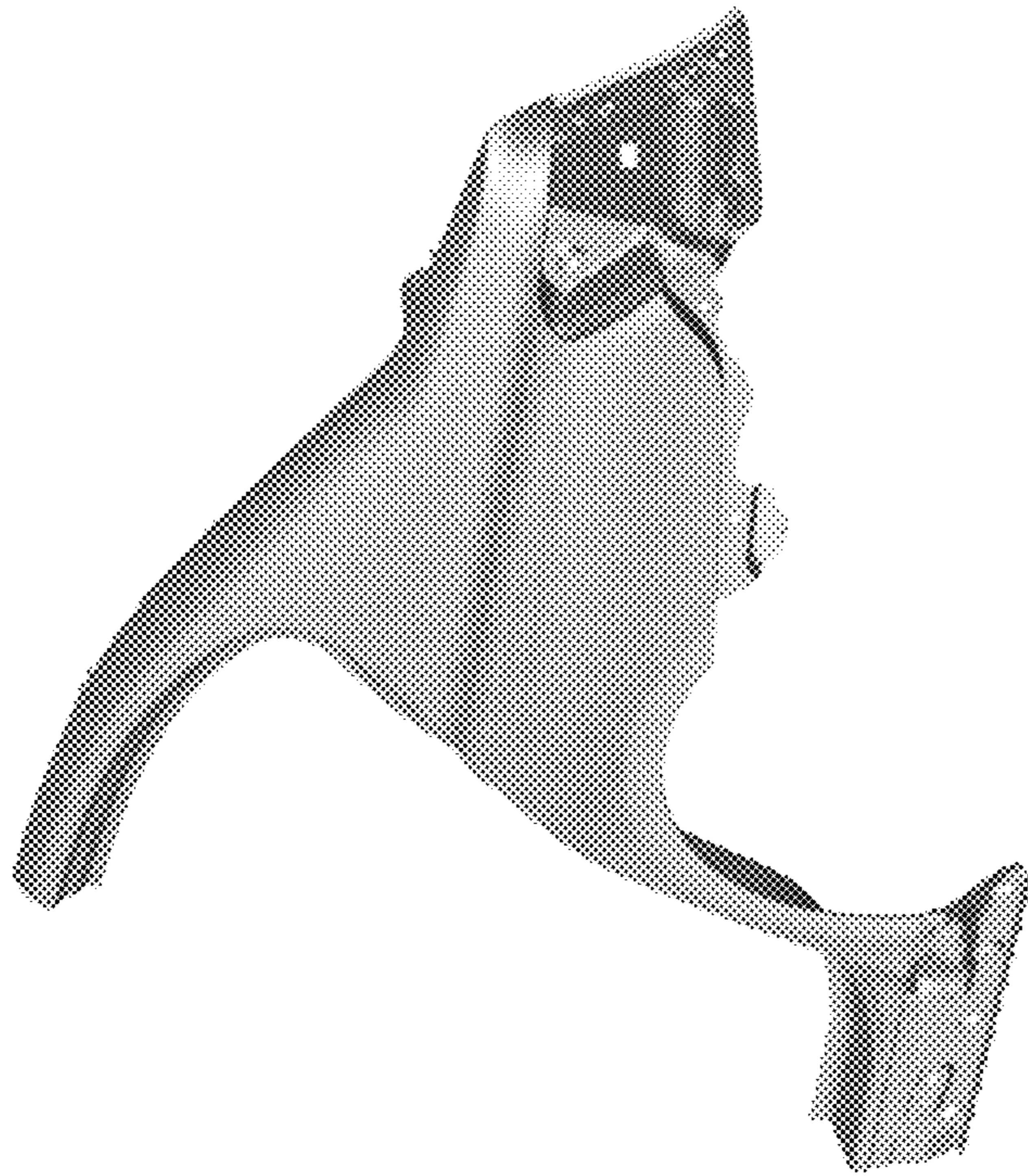

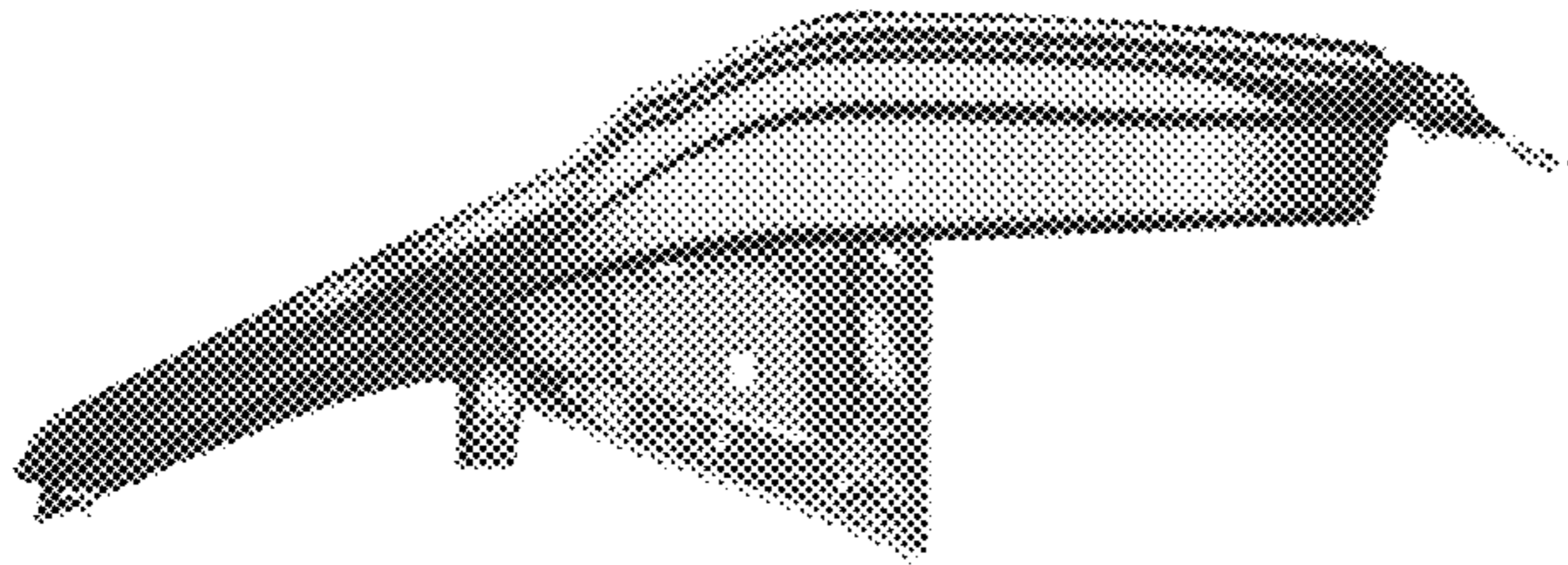

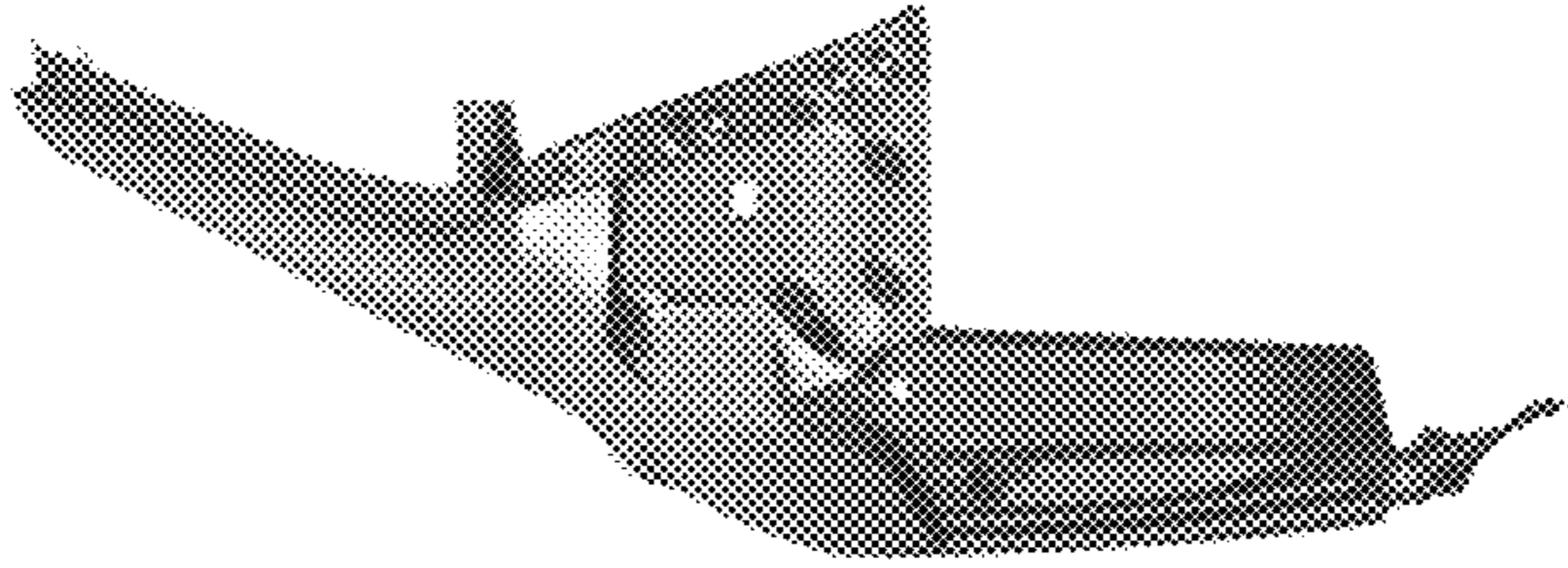

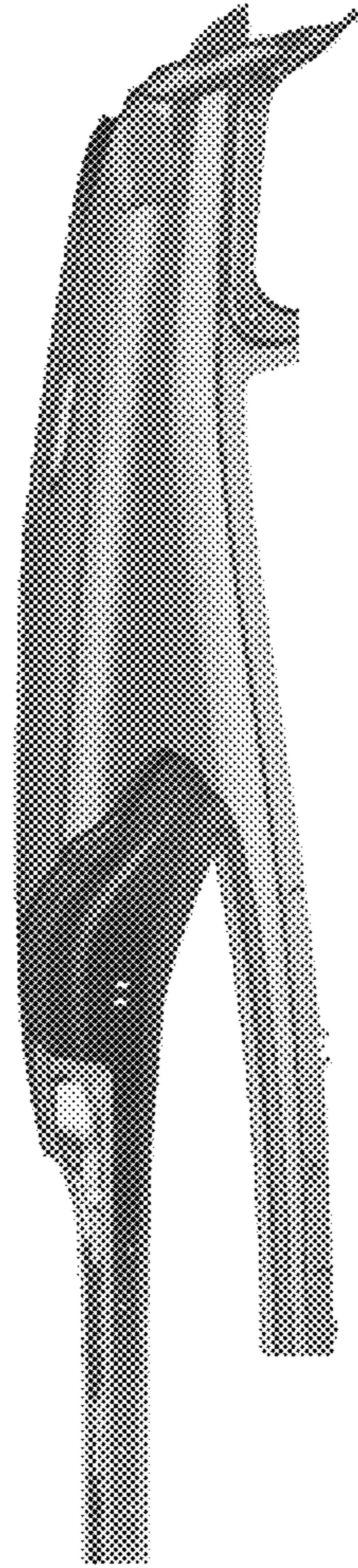

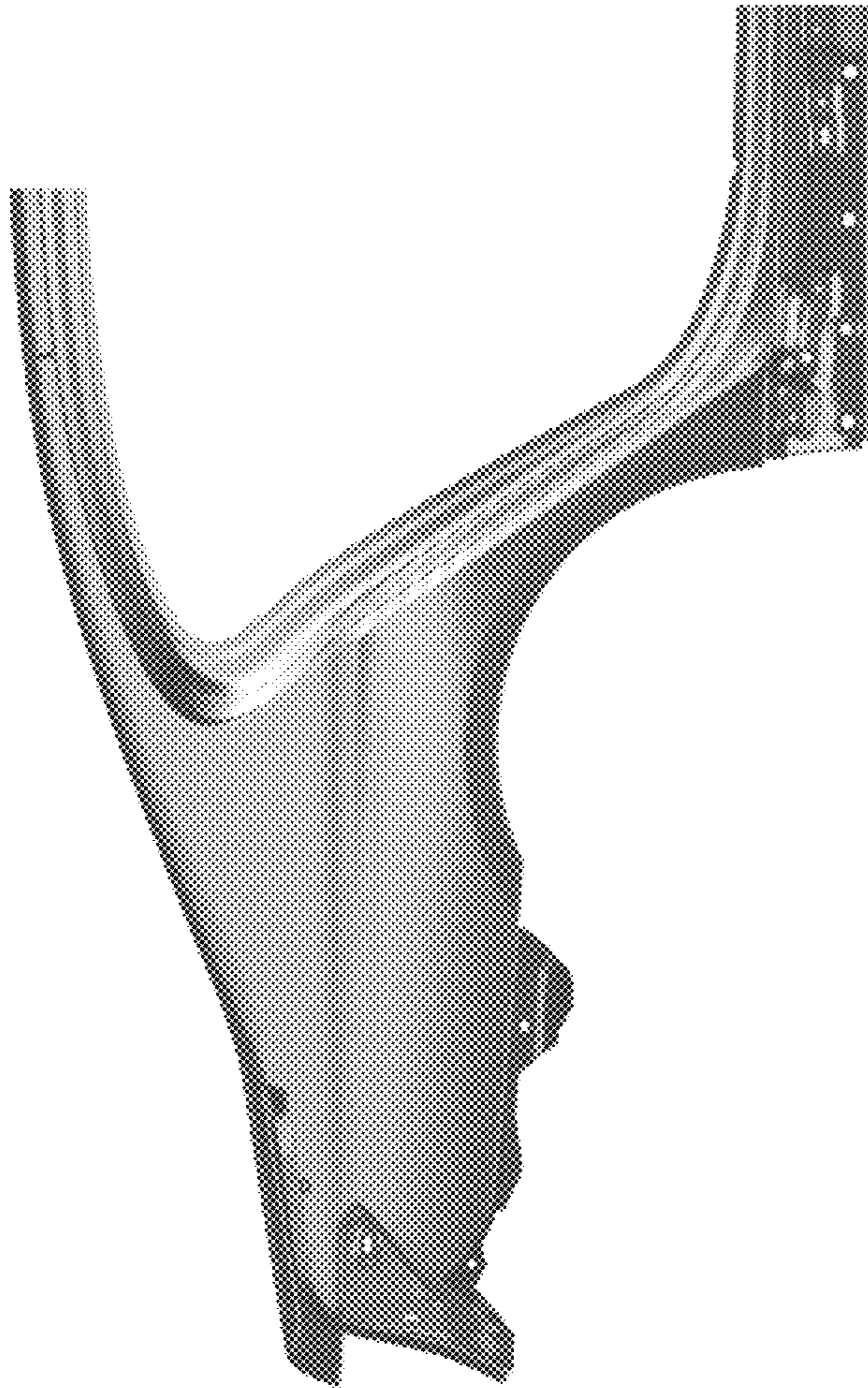
